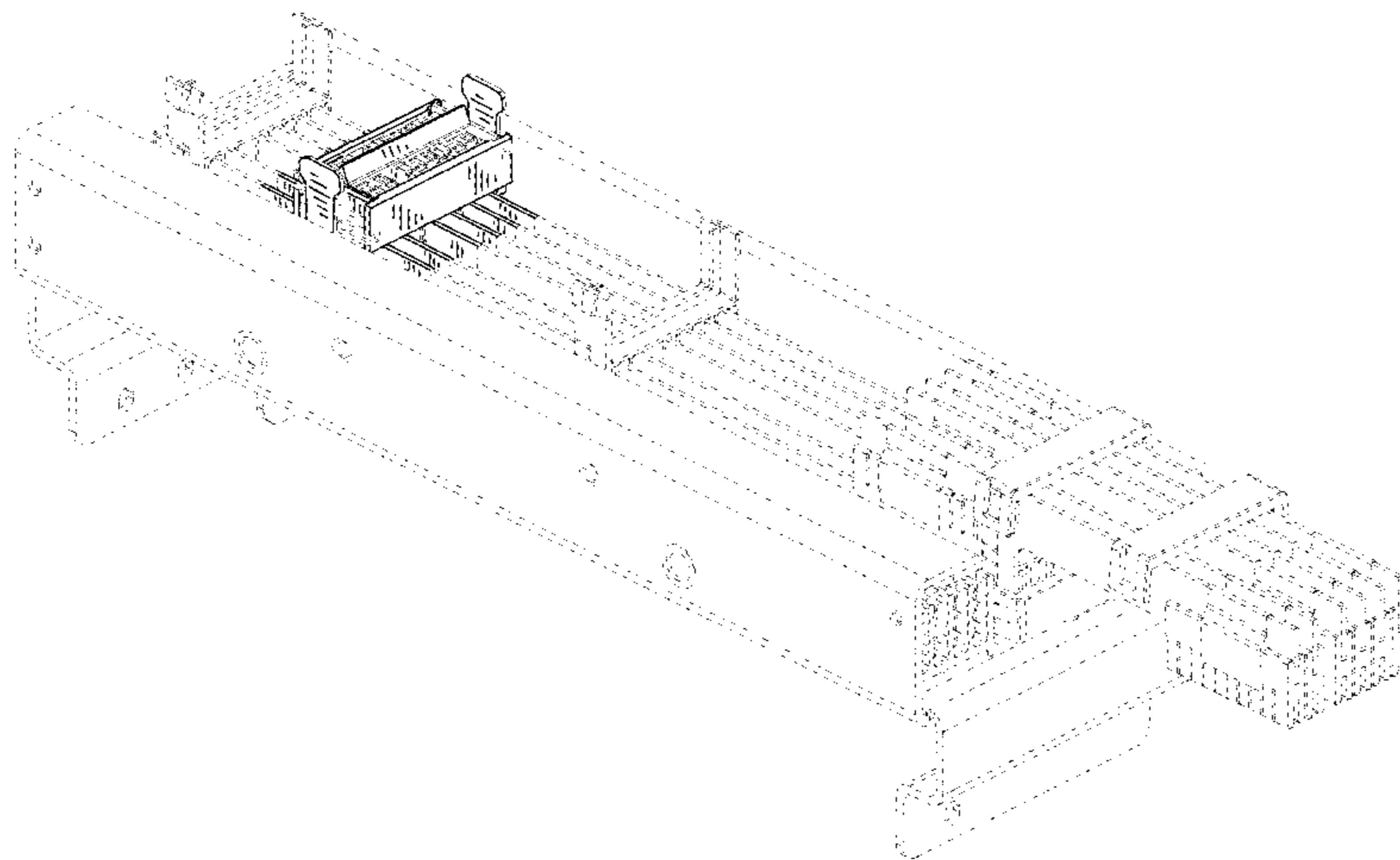
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front top perspective view of a bus connector system;  
FIG. 2 is a top plan view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a left side elevational view thereof;  
FIG. 5 is a right side elevational view thereof;  
FIG. 6 is a rear side elevational view thereof; and,  
FIG. 7 is a front side elevational view thereof.  
The broken lines shown represent portions of the bus connector system that form no part of the design.

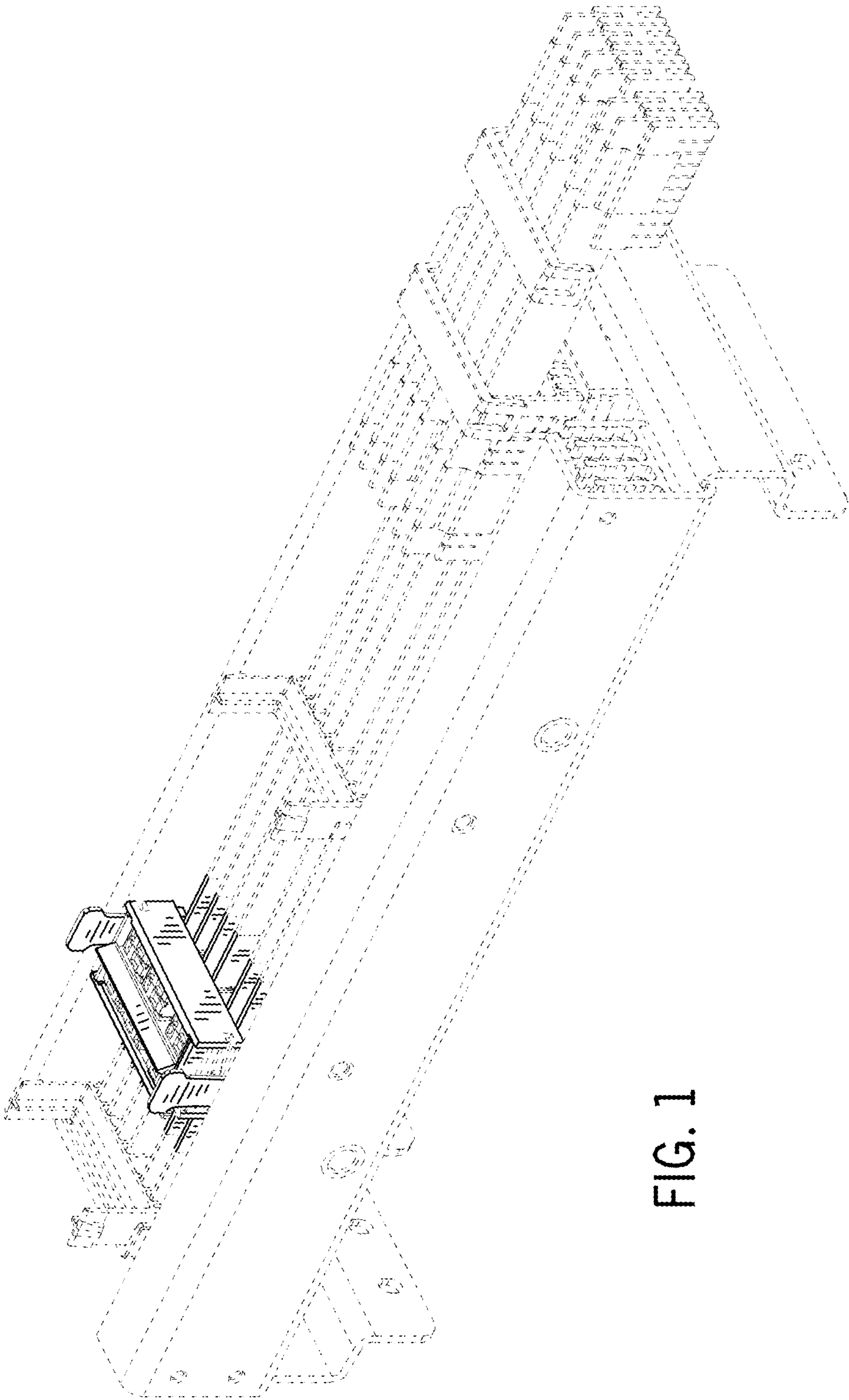

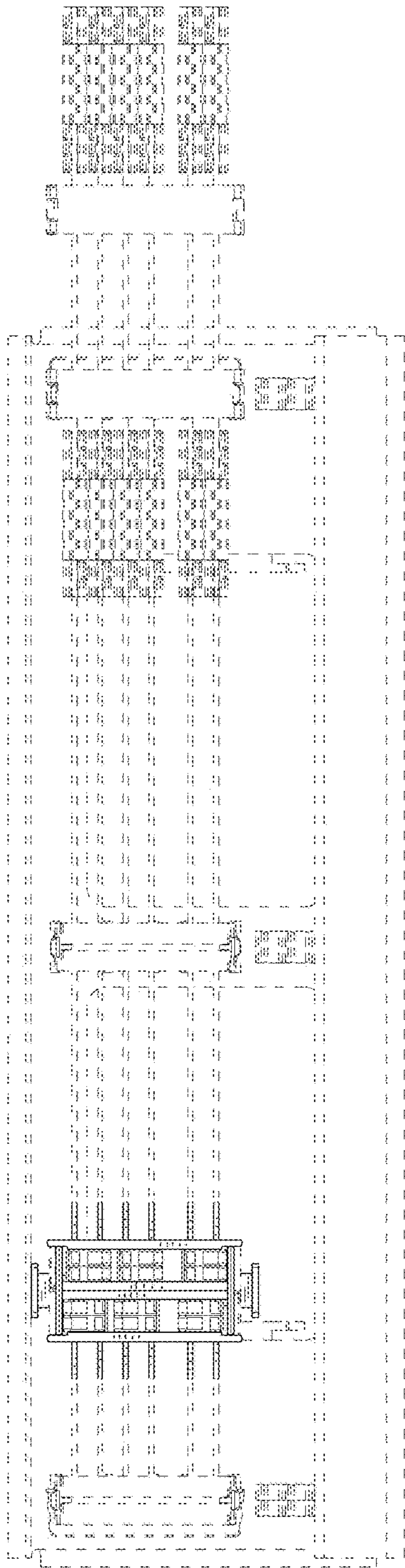

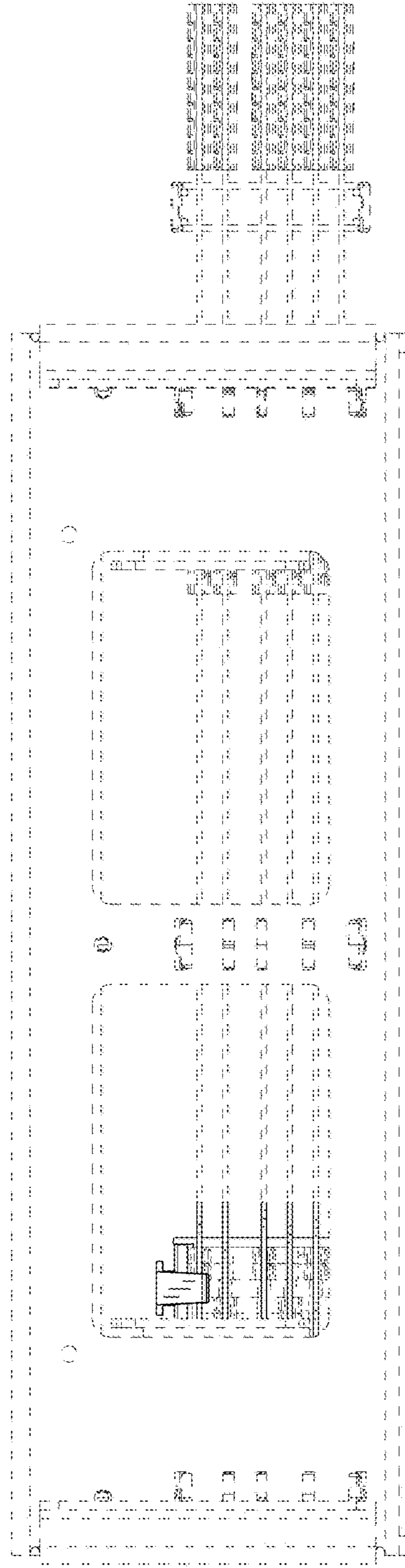

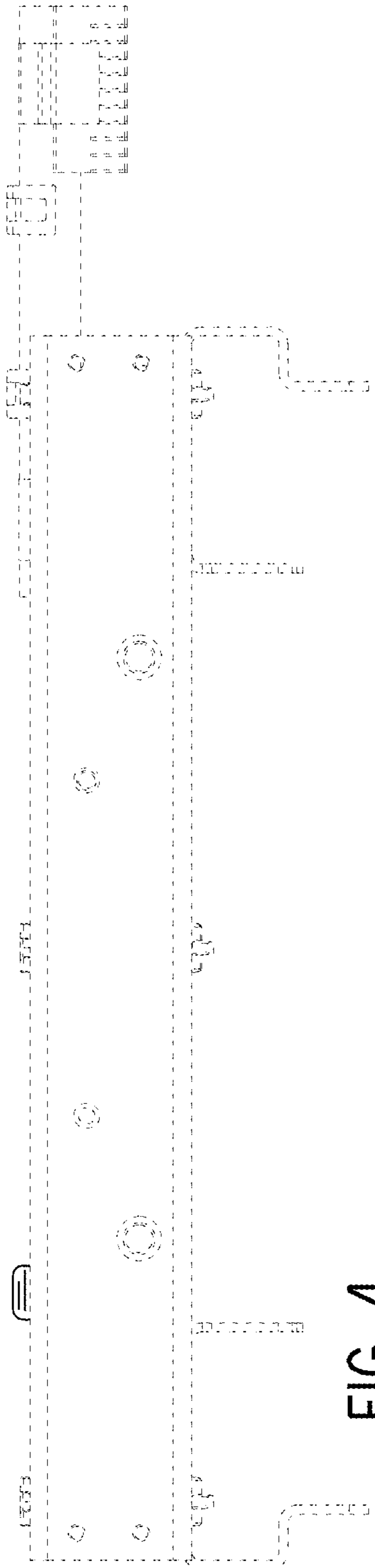

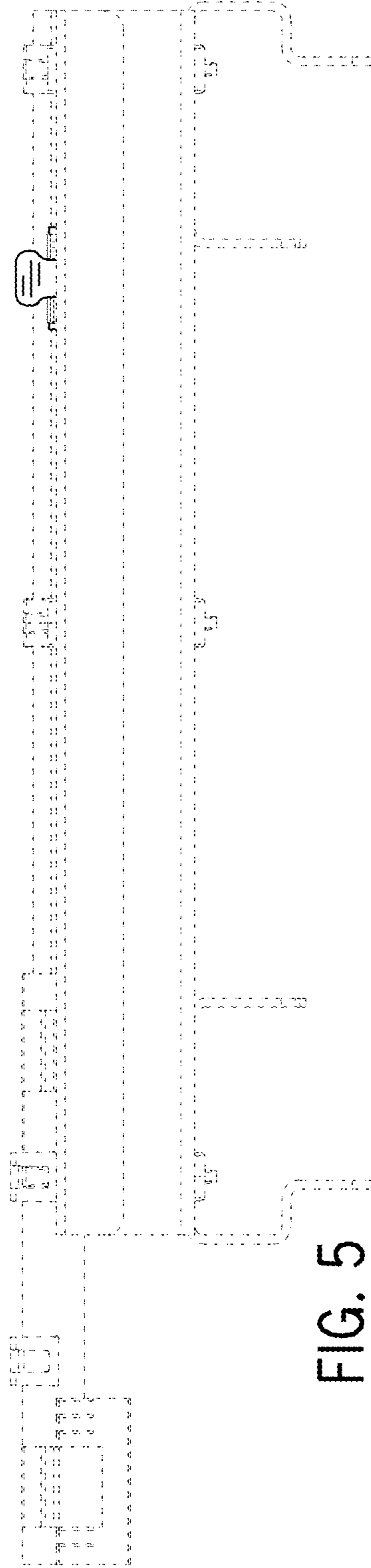

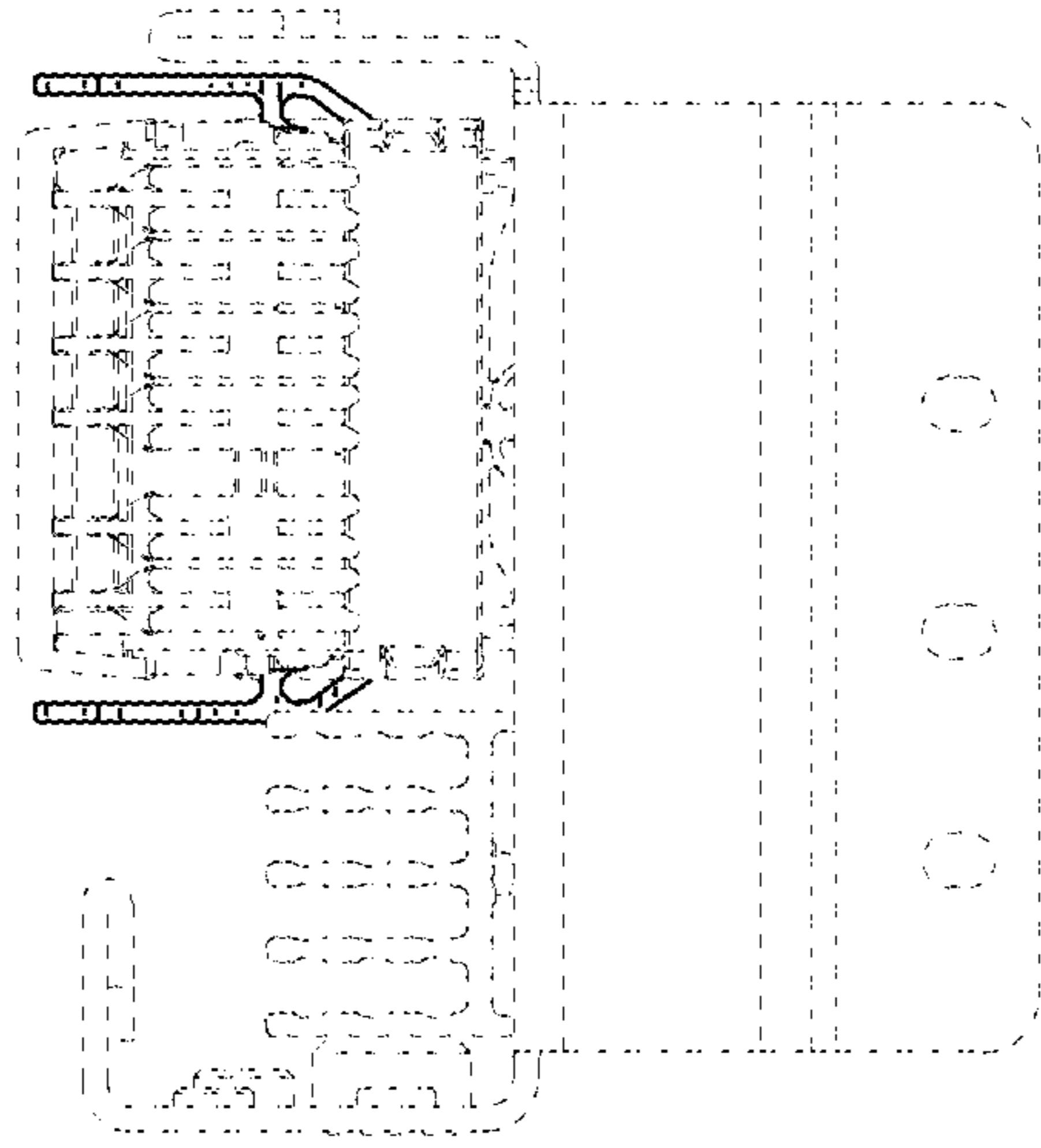

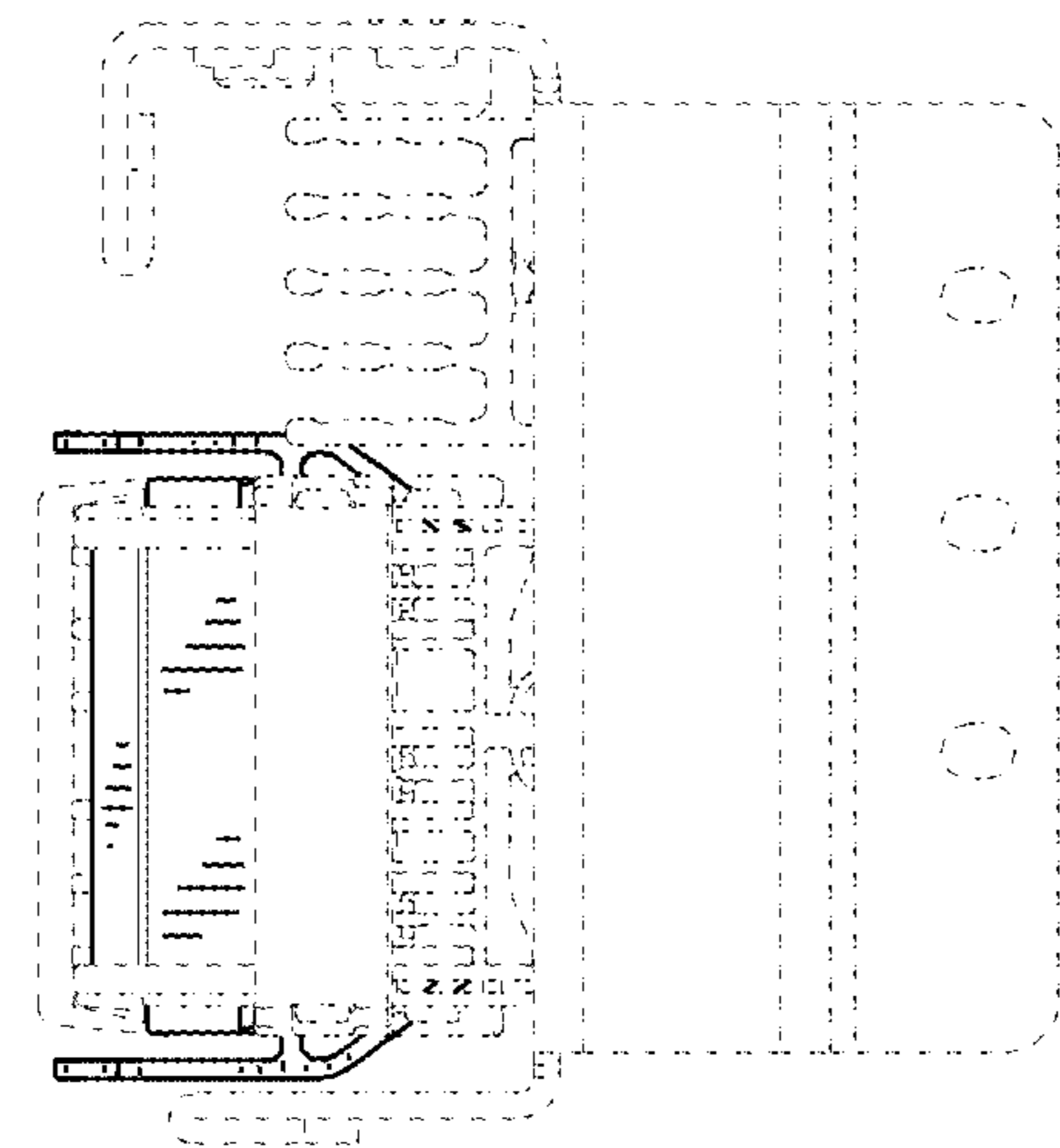
