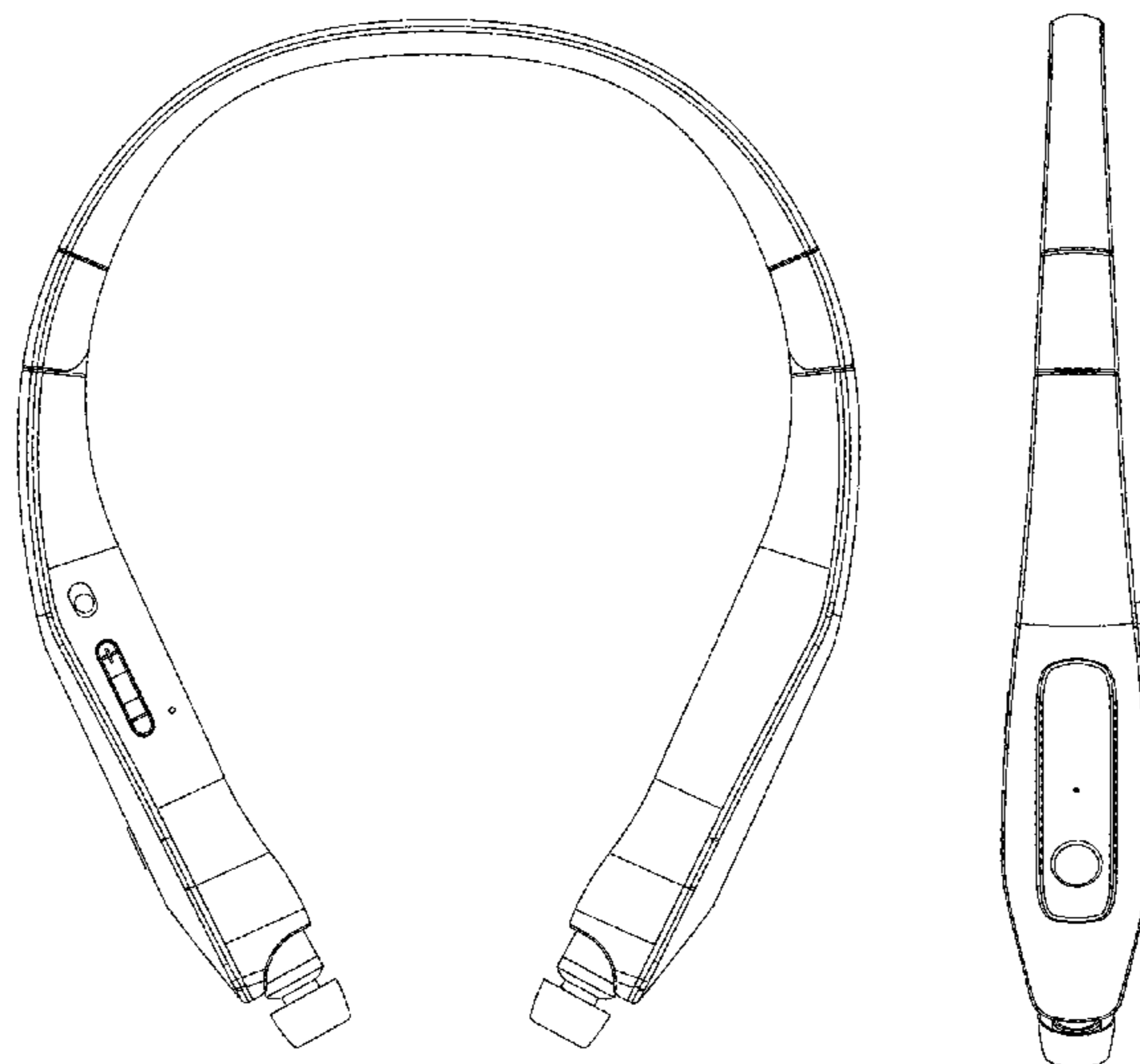
(57) **CLAIM**

The ornamental design for a neck strap wireless headset, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a neck strap wireless headset showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left side view in enlarged scale thereof;
FIG. 4 is a right side view in enlarged scale thereof;
FIG. 5 is a top plan view in enlarged scale thereof;
FIG. 6 is a bottom plan view in enlarged scale thereof;

FIG. 8 is a rear perspective view thereof.

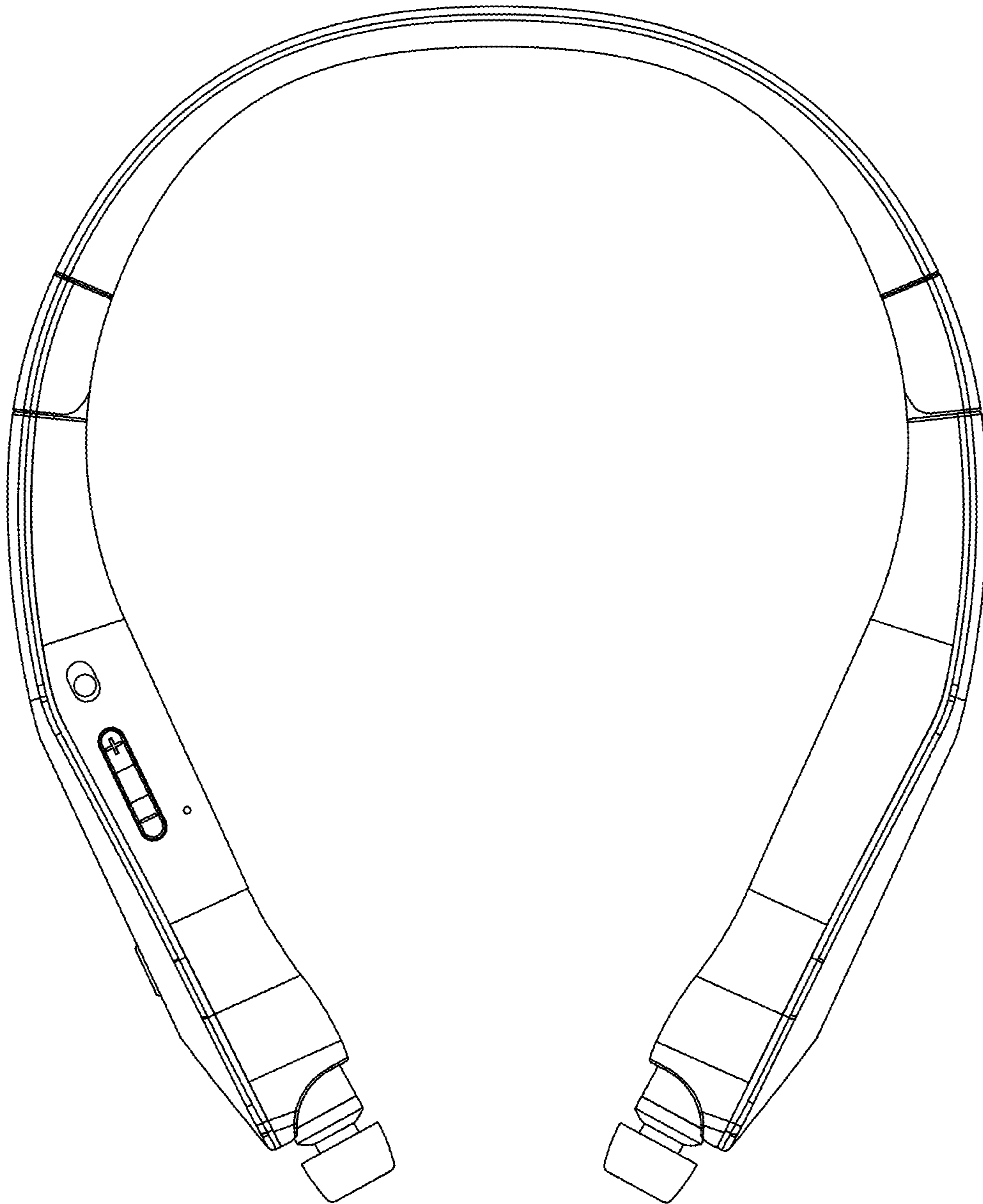

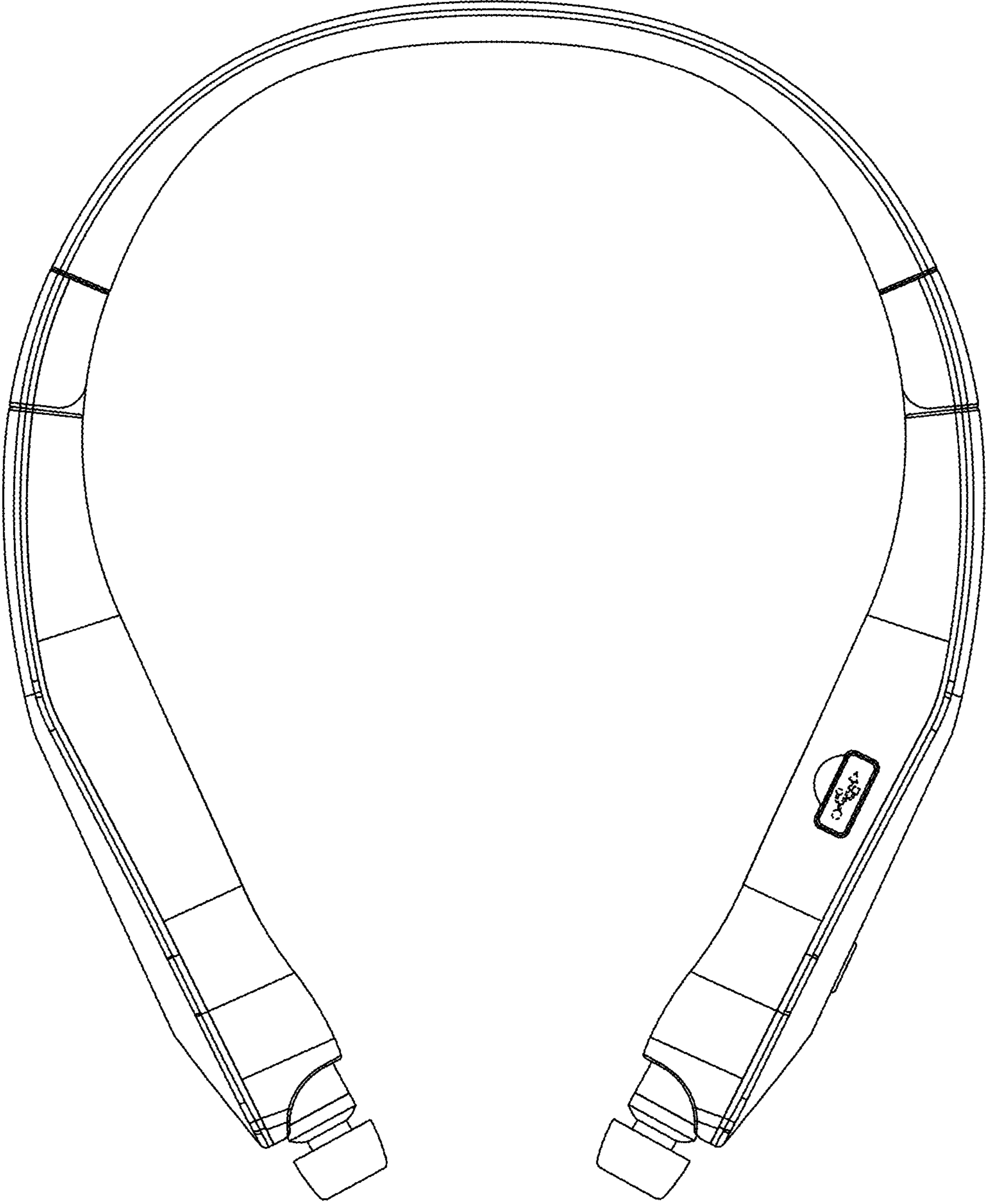

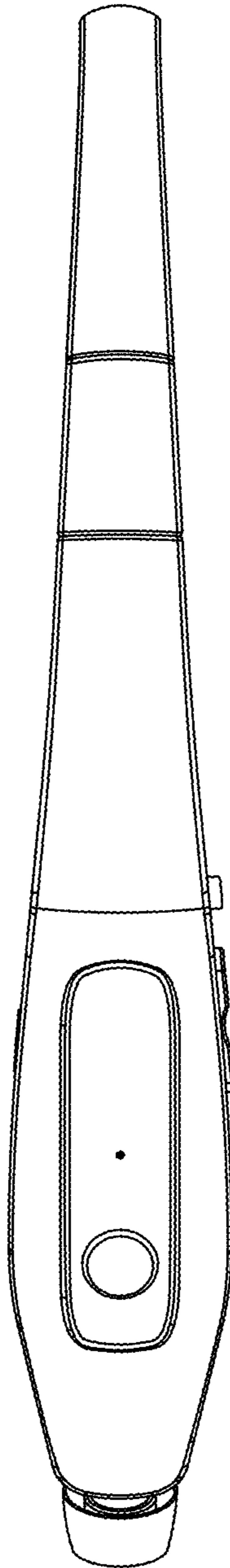

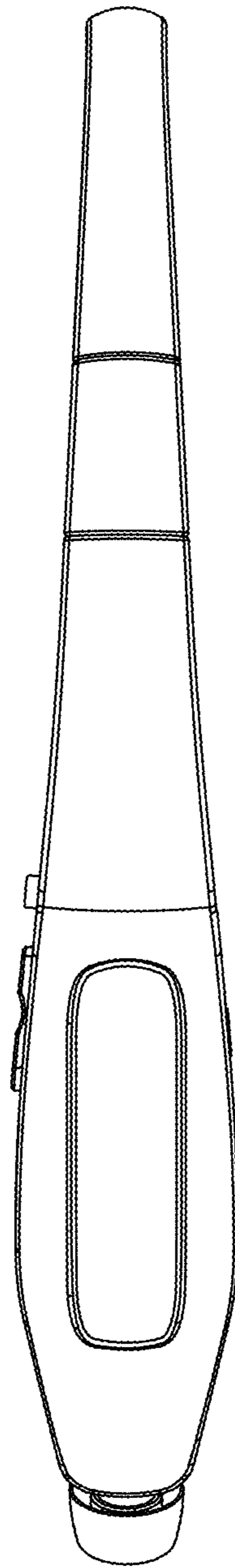

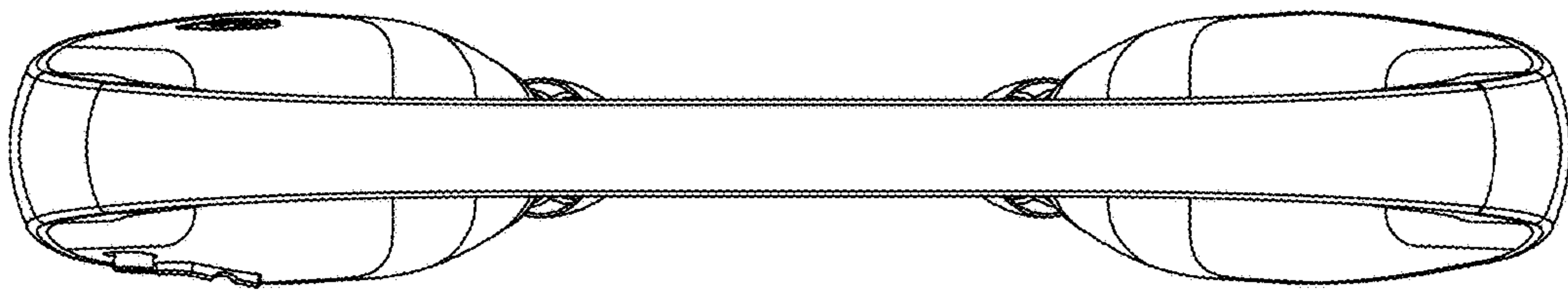

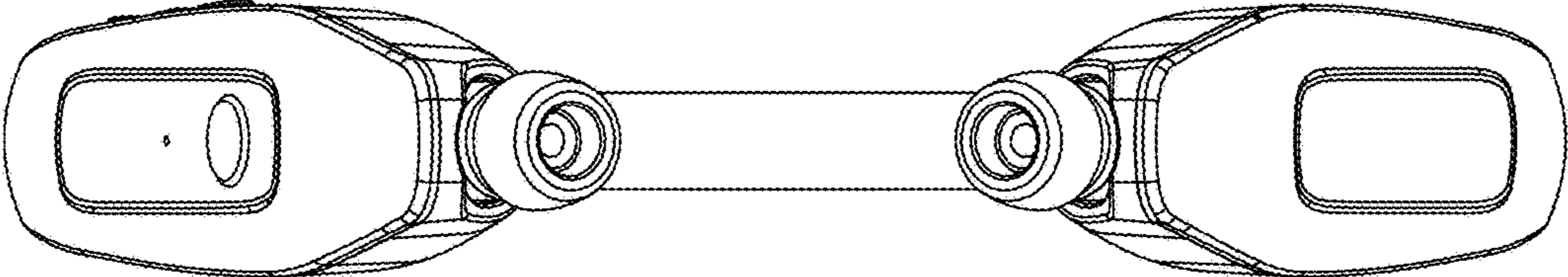

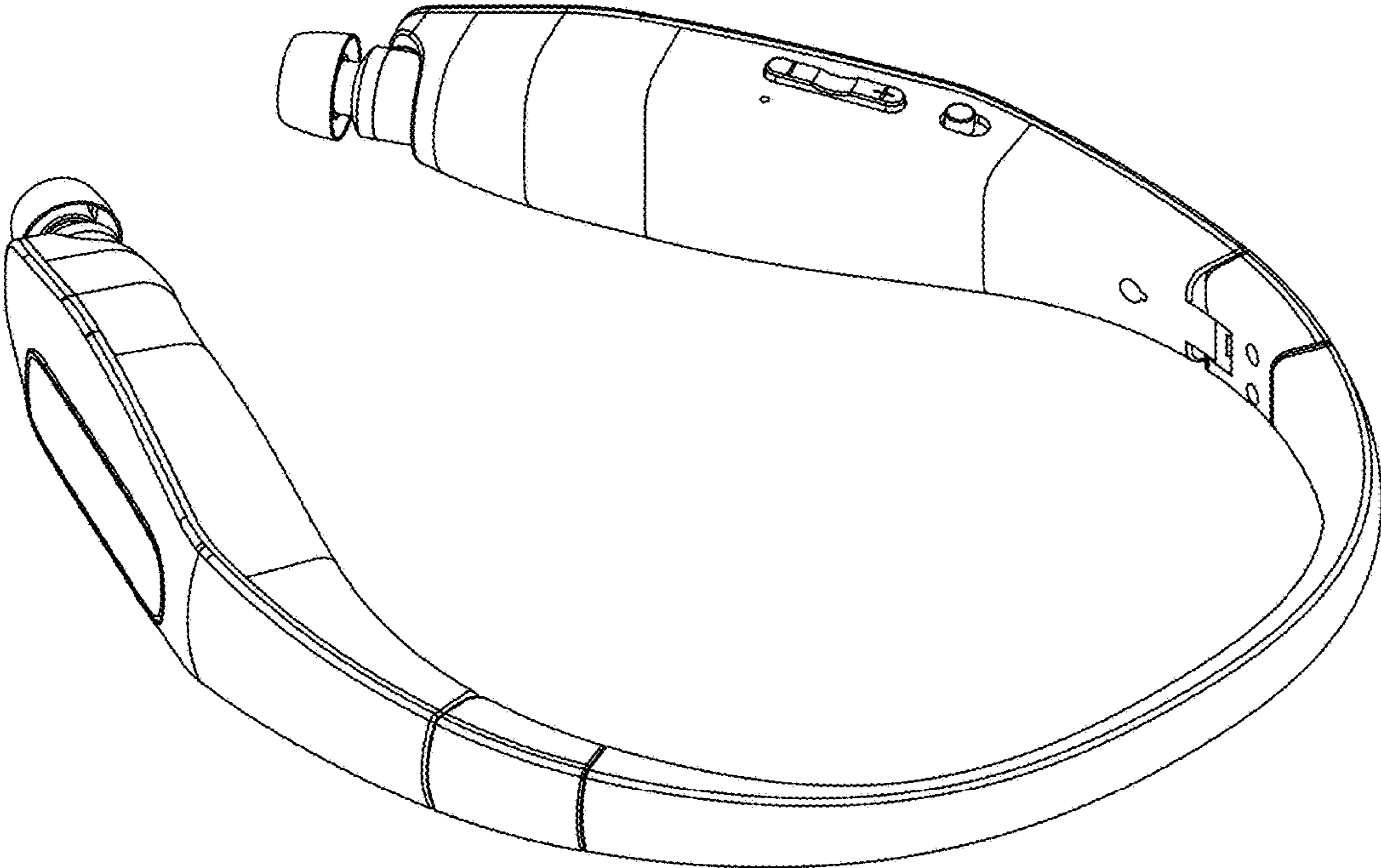

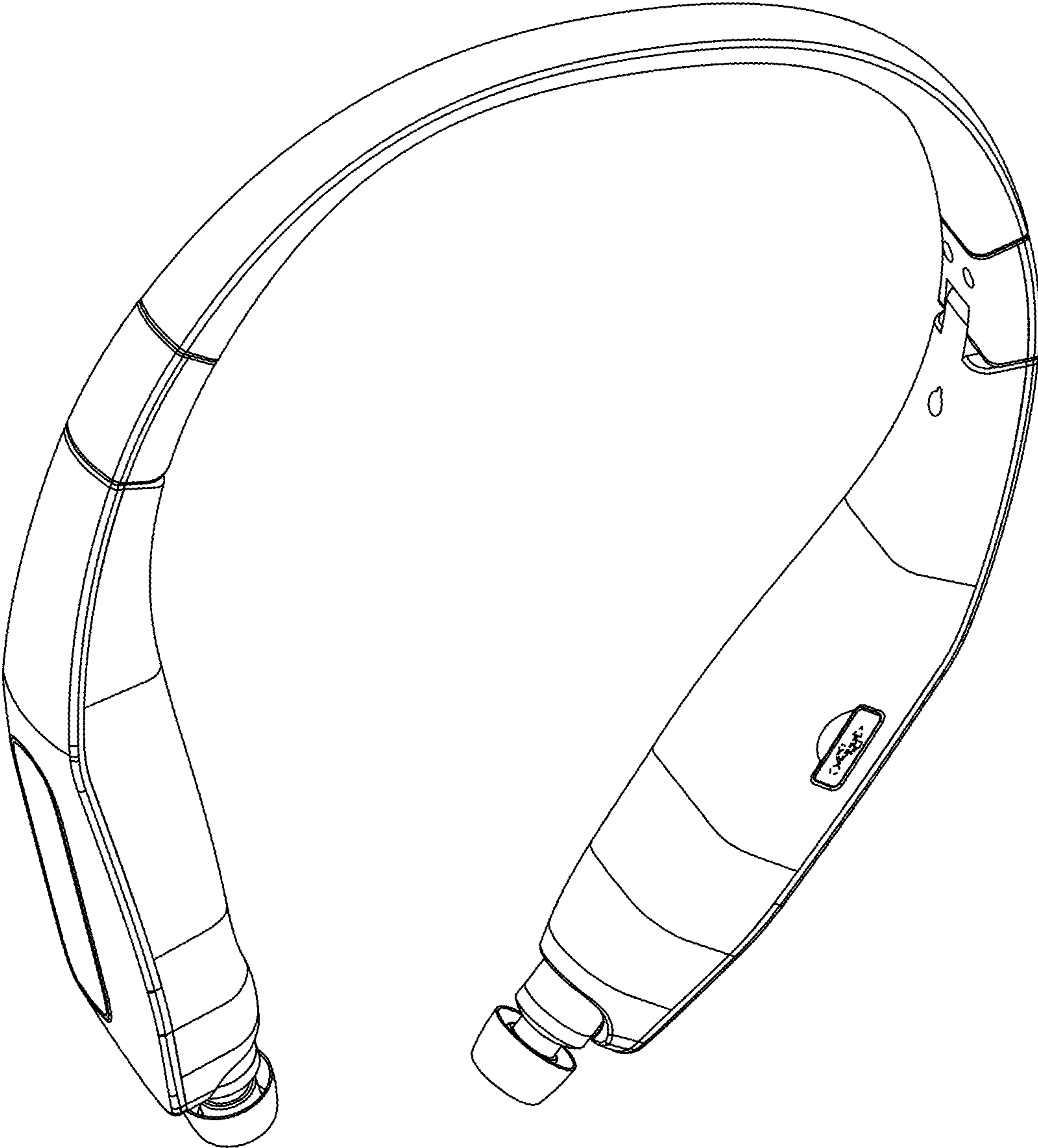
