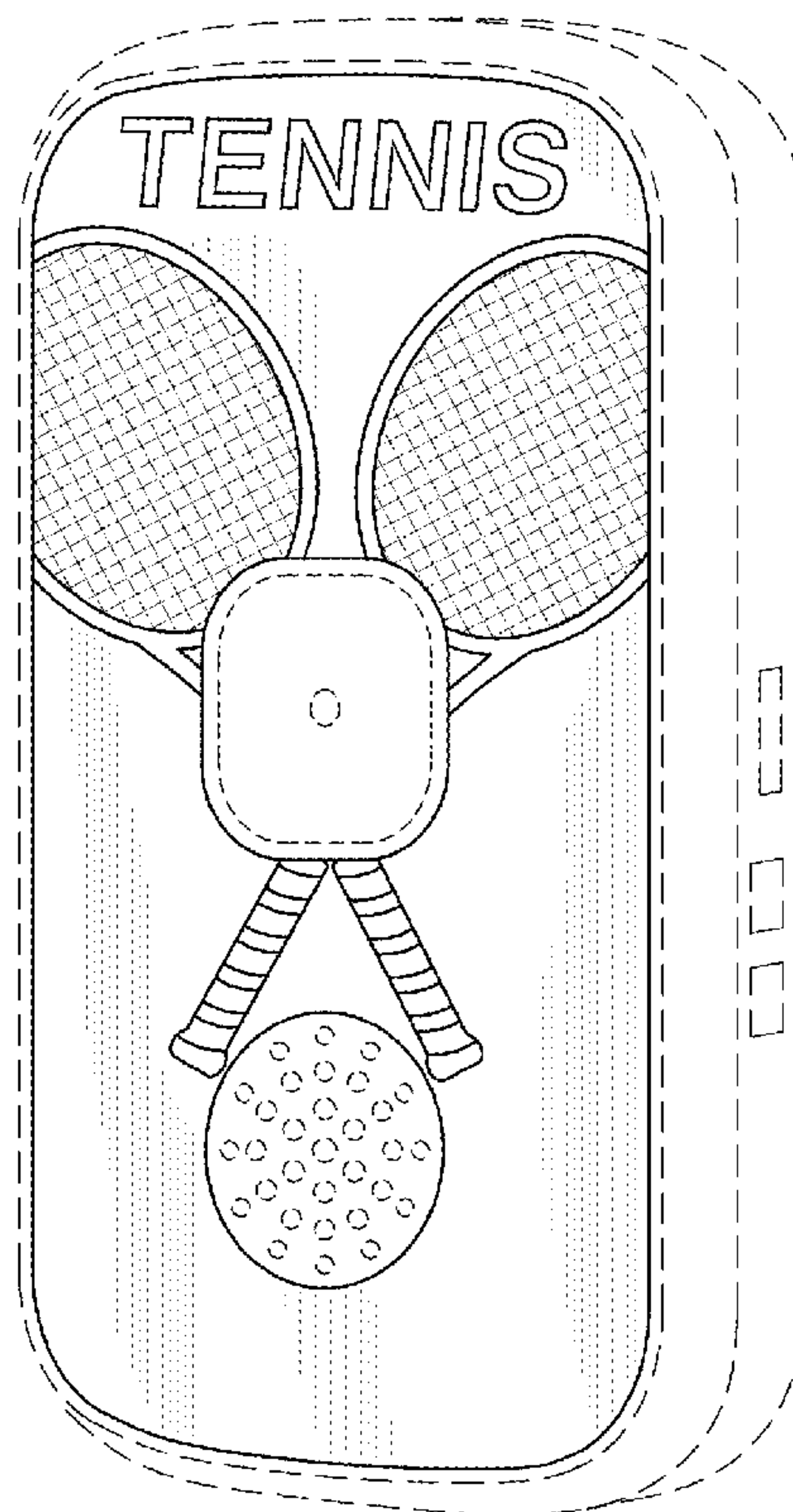
(57) **CLAIM**

The ornamental design for a personal emergency medical alert device cover, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a personal emergency medical alert device cover showing my new design on the front surface of the device;
FIG. 2 is a front elevational view of the cover of FIG. 1;
FIG. 3 is a left view of the cover of FIG. 1;
FIG. 4 is a right view of the cover of FIG. 1;
FIG. 5 is a back view of the cover of FIG. 1;
FIG. 6 is a top view of the cover of FIG. 1; and,
FIG. 7 is a bottom view of the cover of FIG. 1.

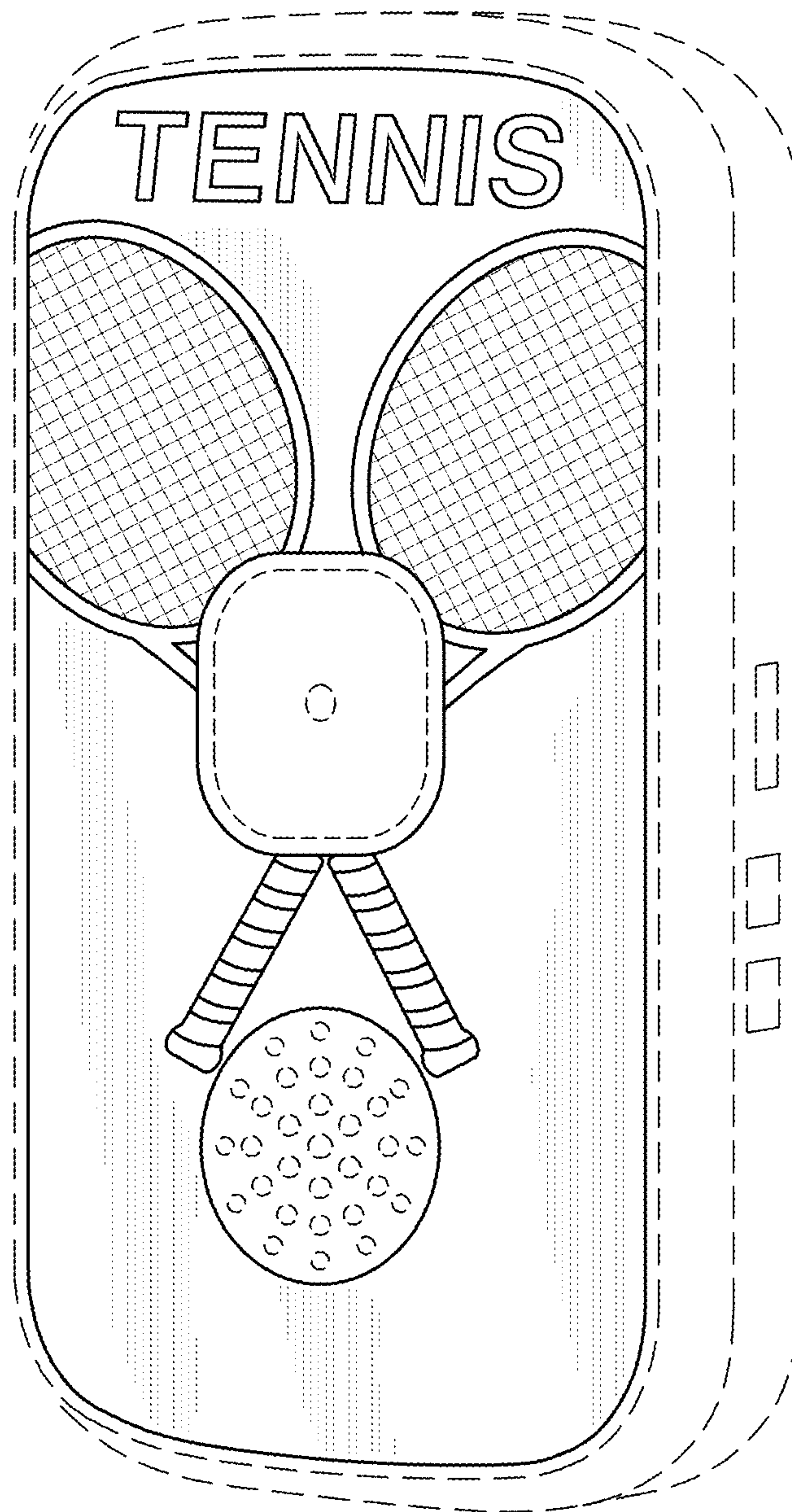

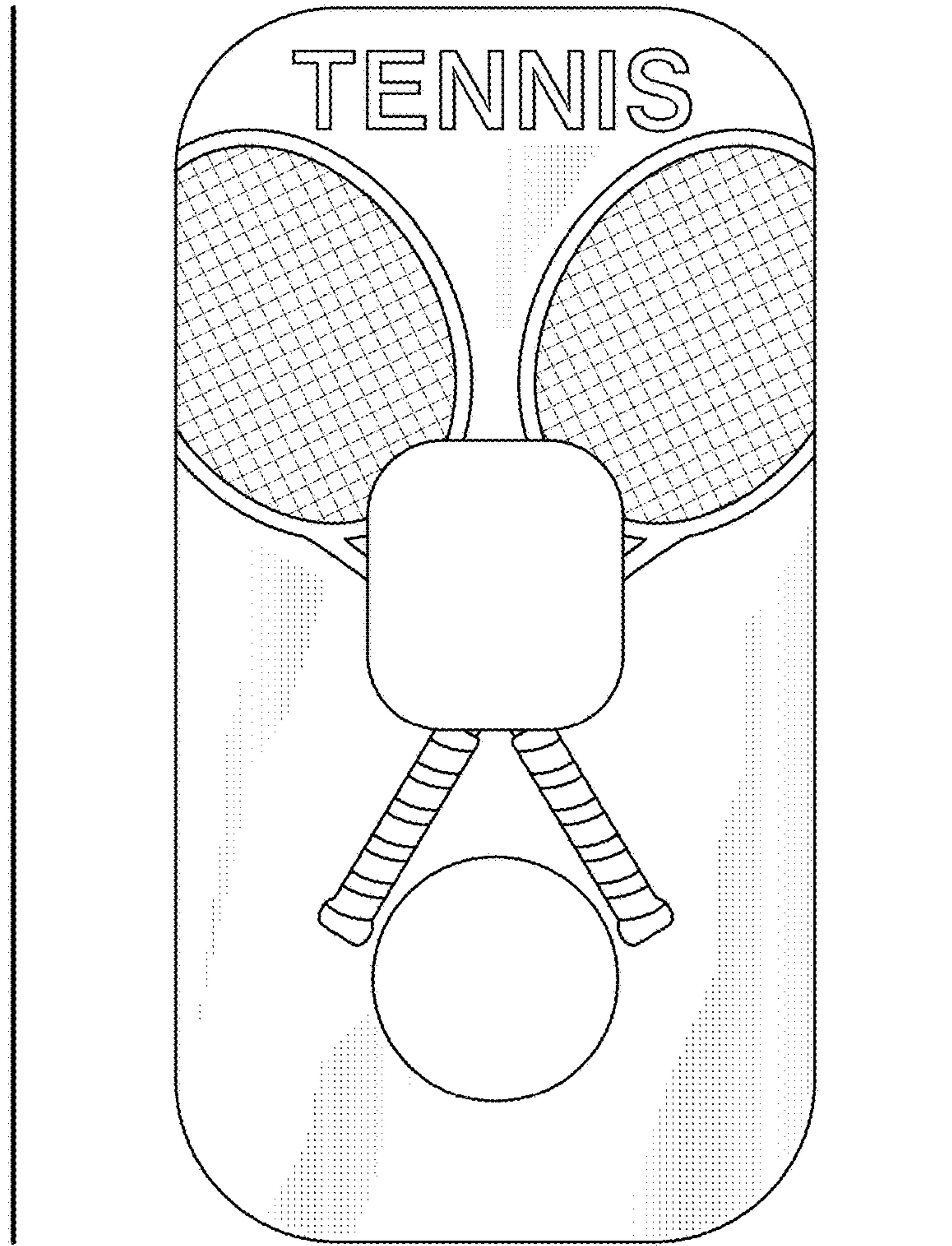

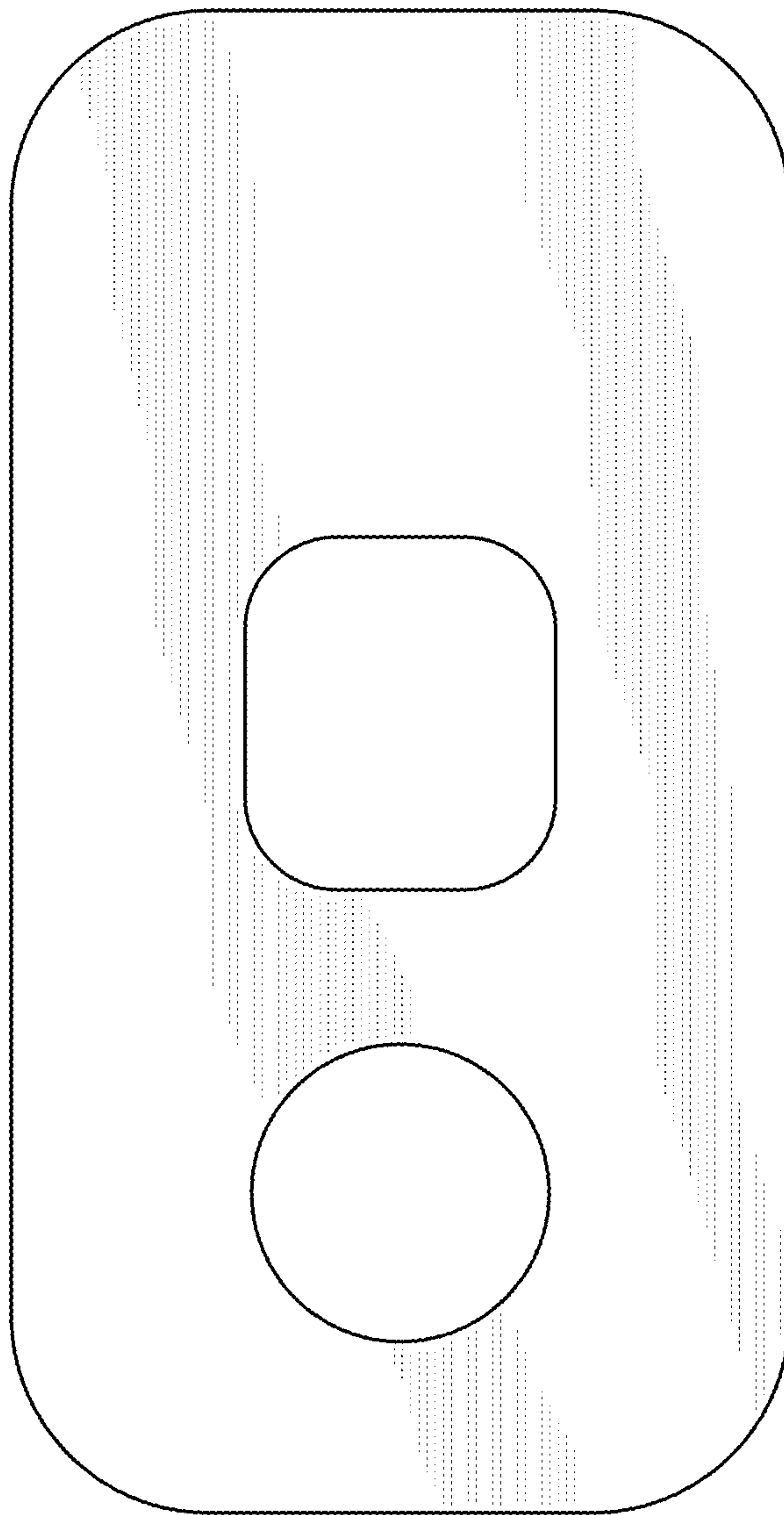
