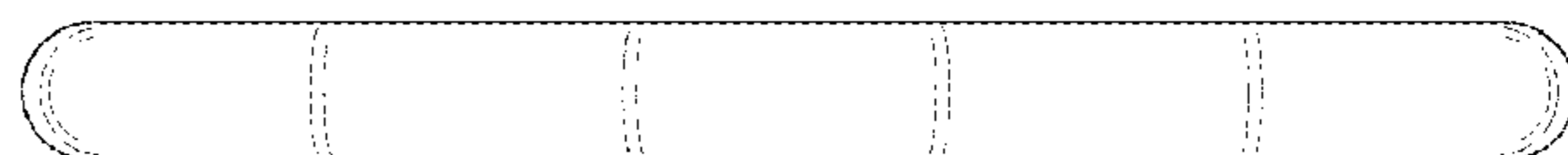
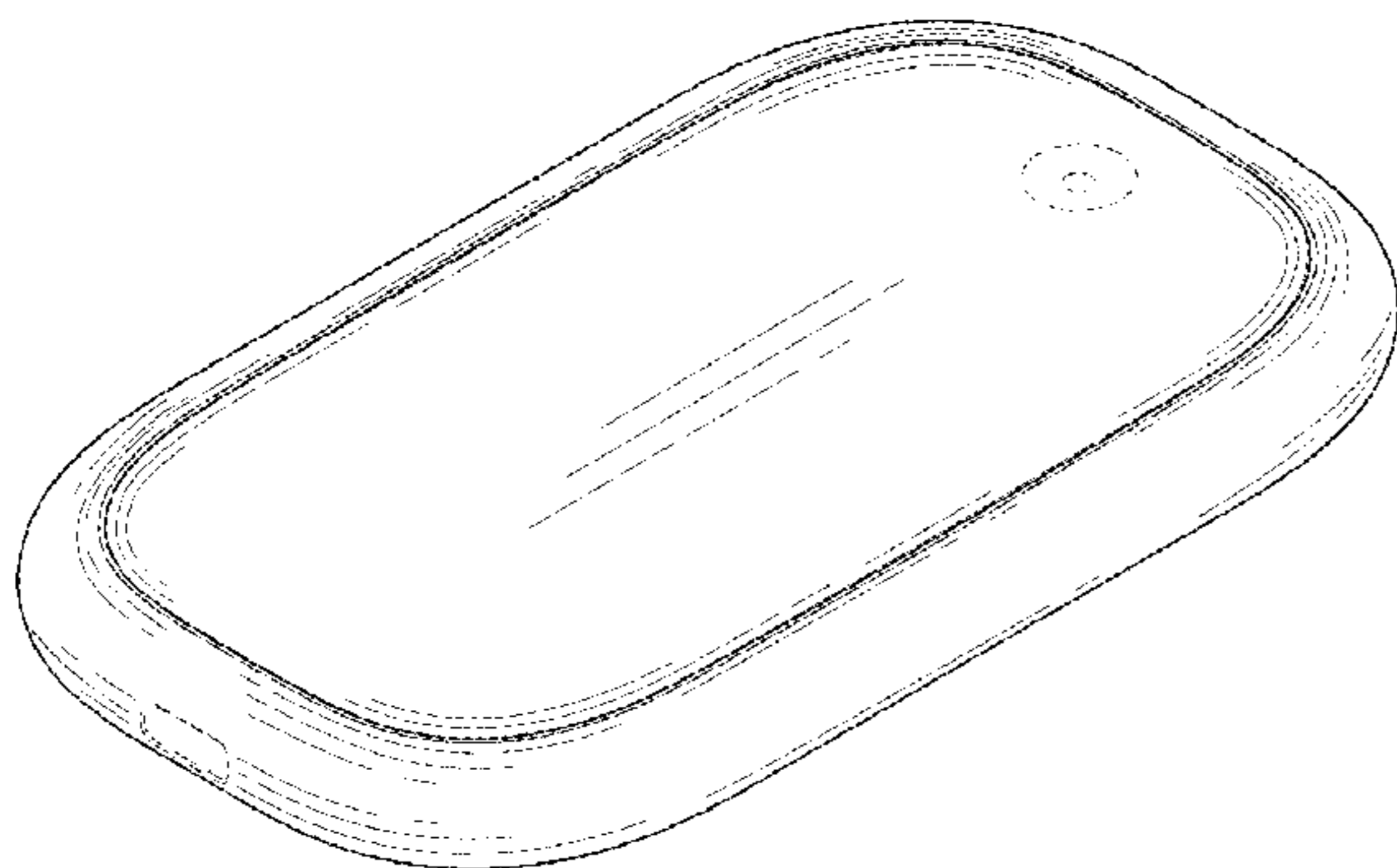
The ornamental design for an external SSD storage device, as shown and described.

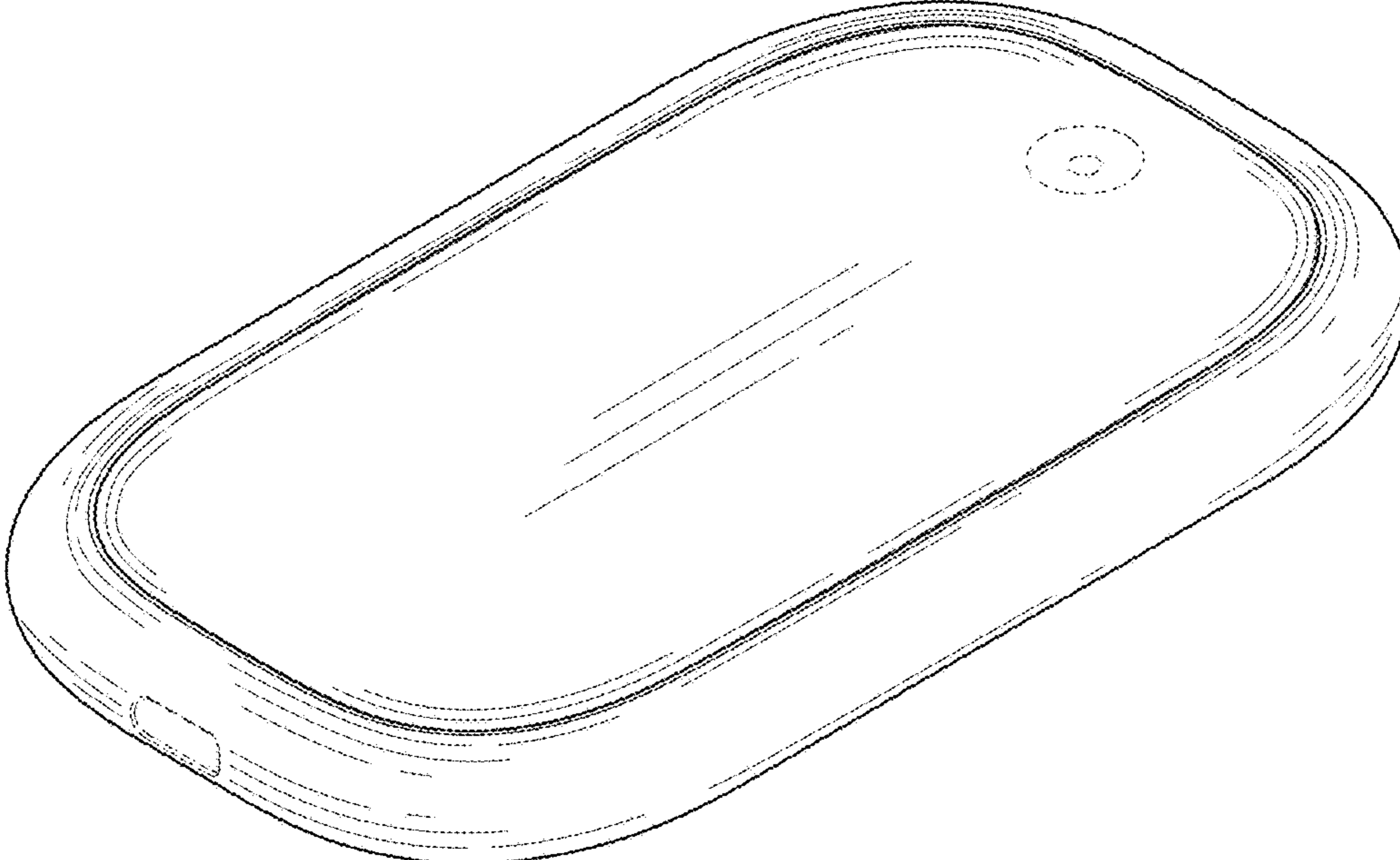

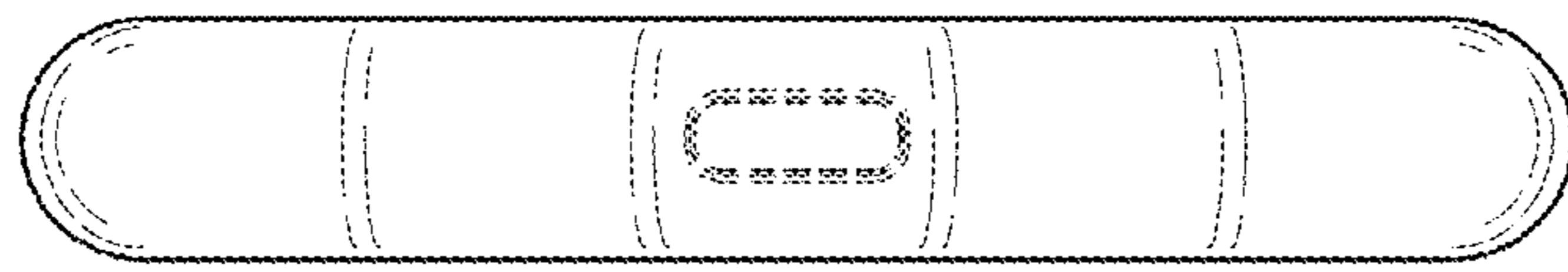

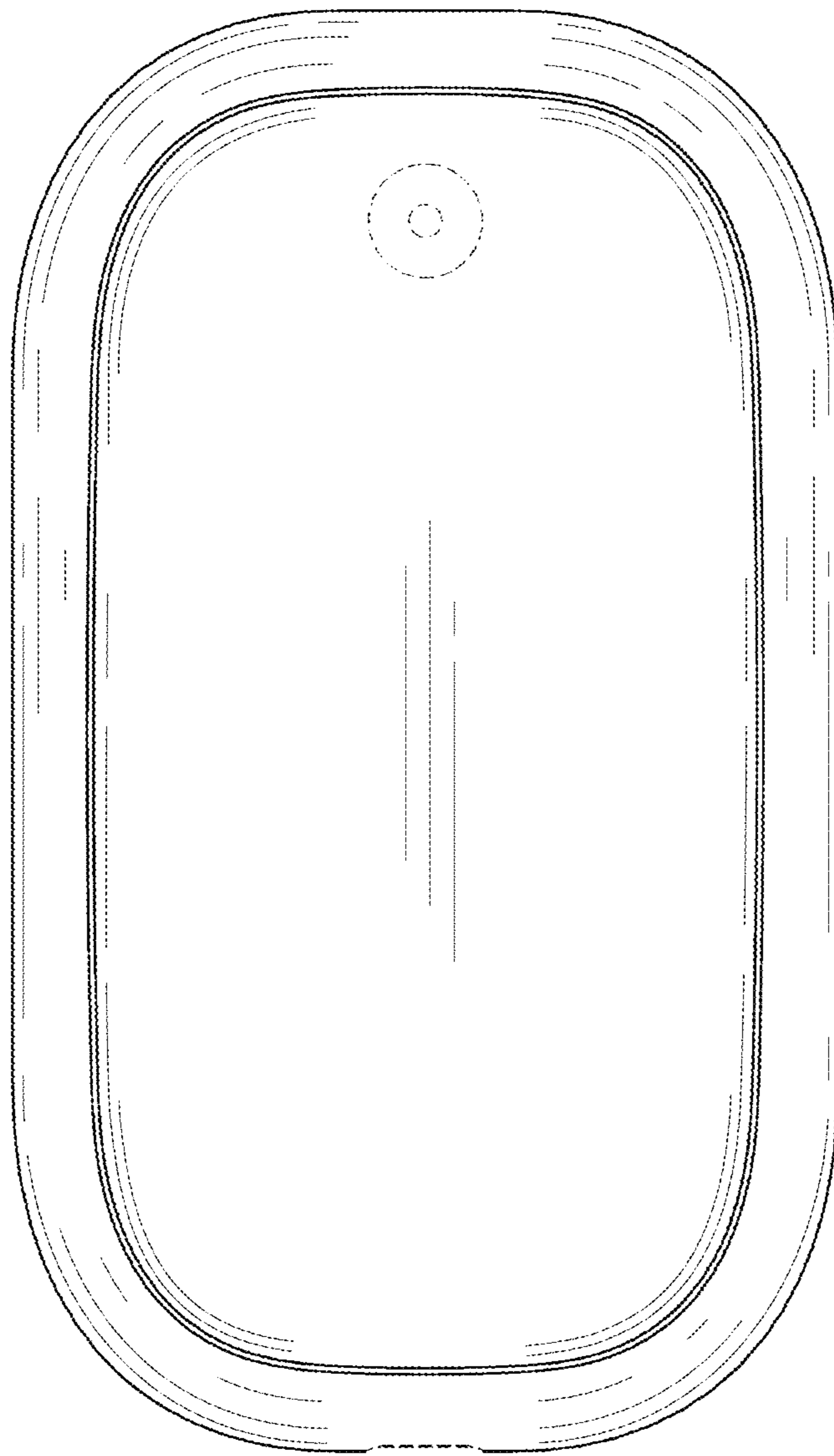

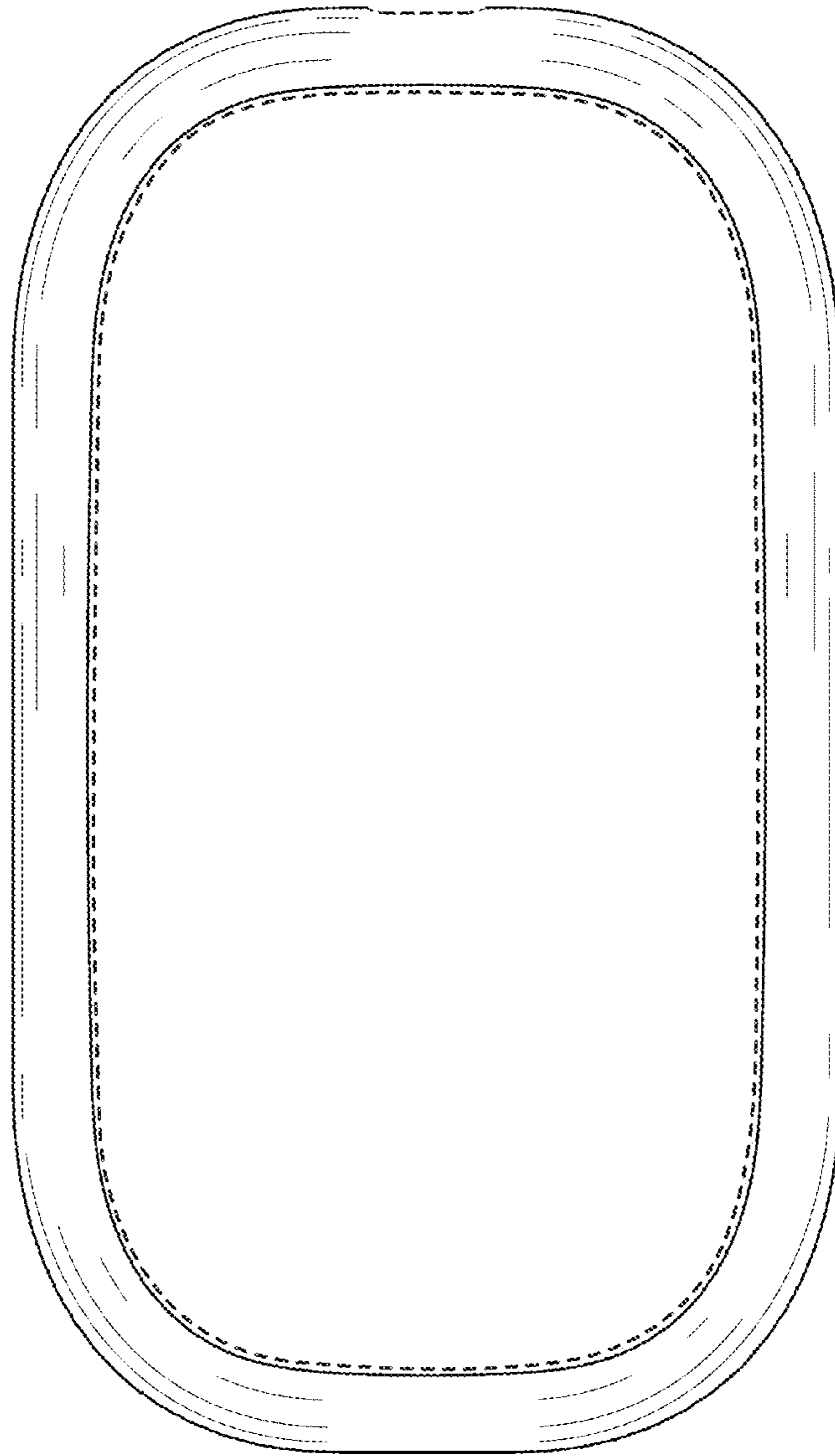
