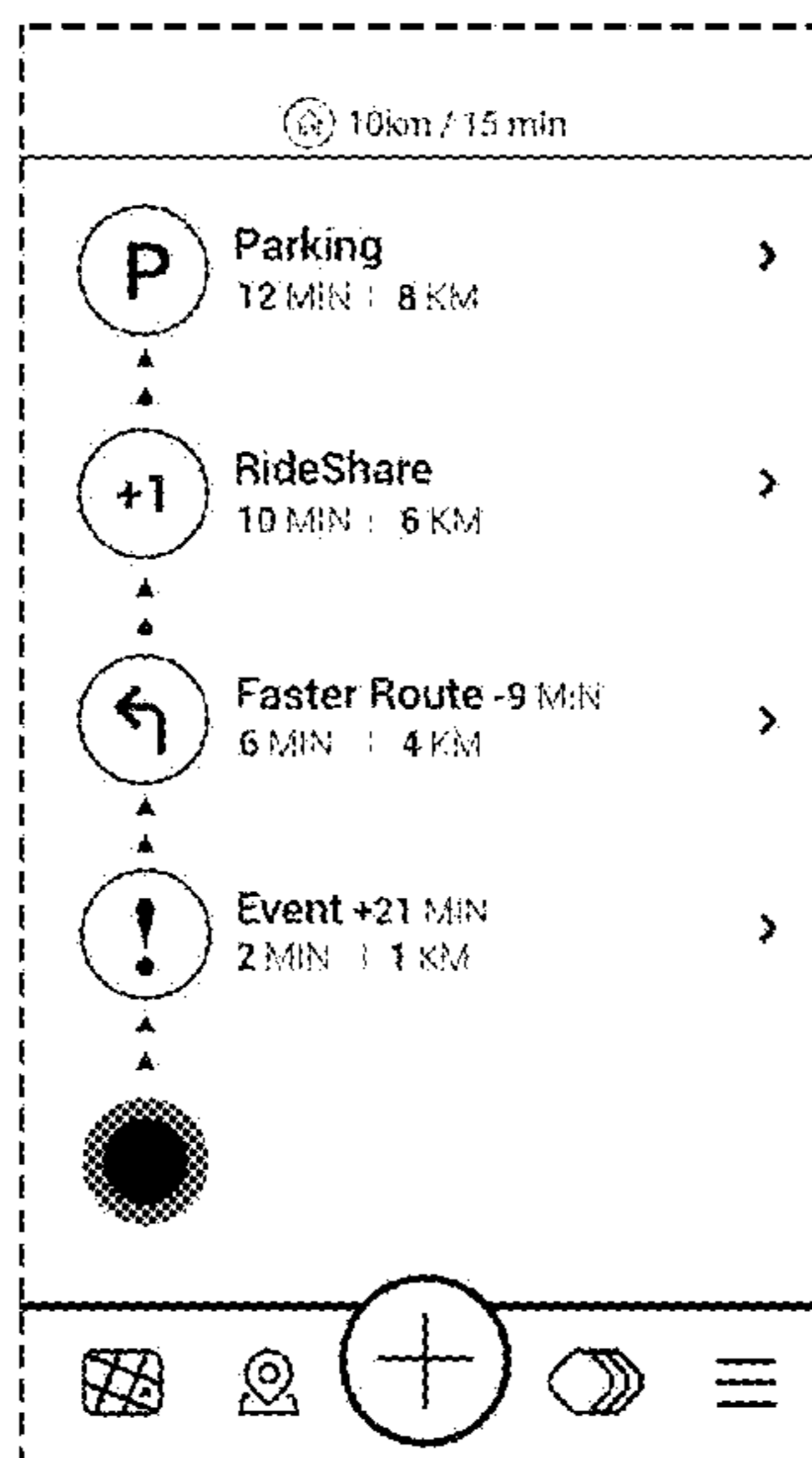

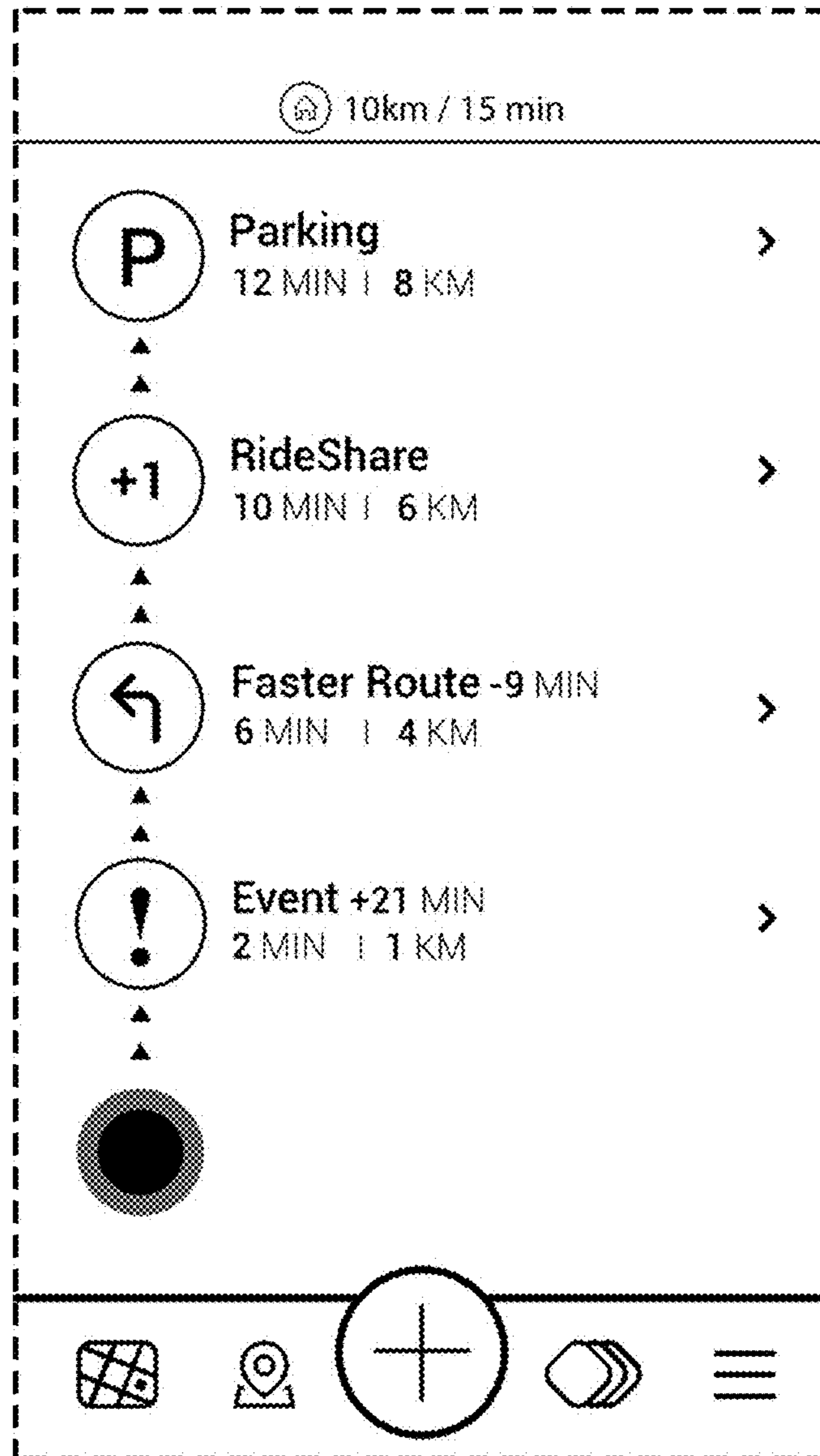
In the reproductions, the broken lines that immediately surrounds the graphical user interface illustrates the computer display screen that forms no part of the claimed design.
