FIG. 4 is a right side of the eyewear.

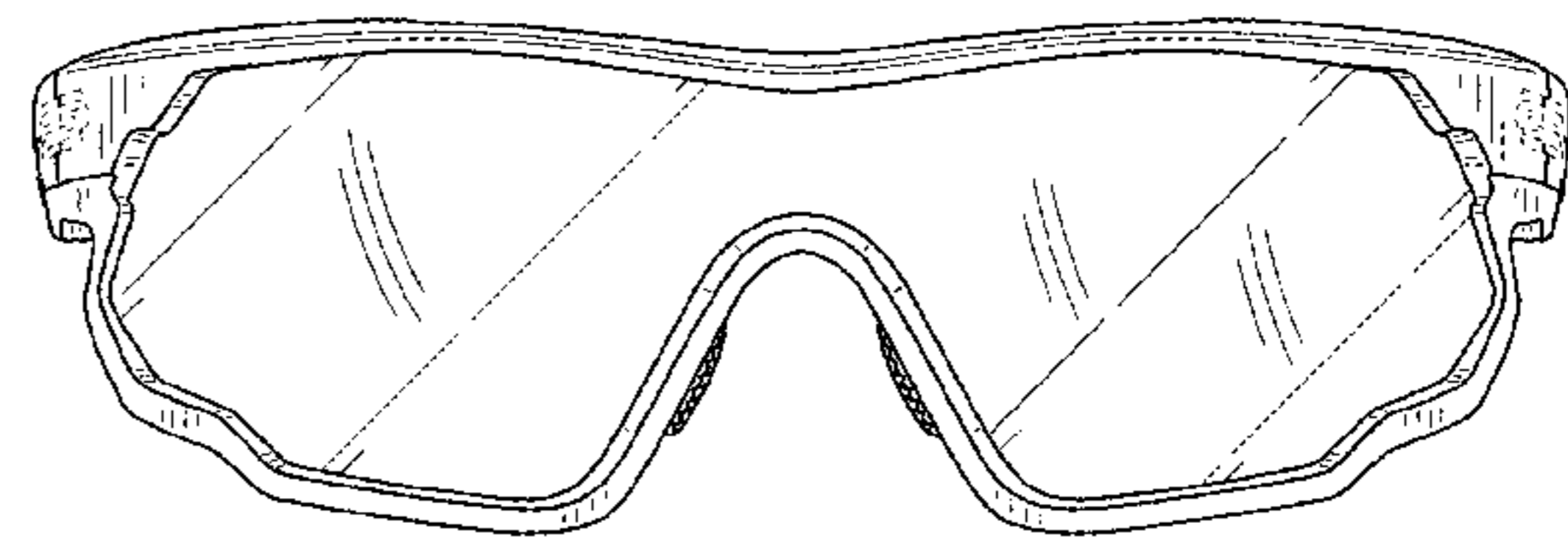
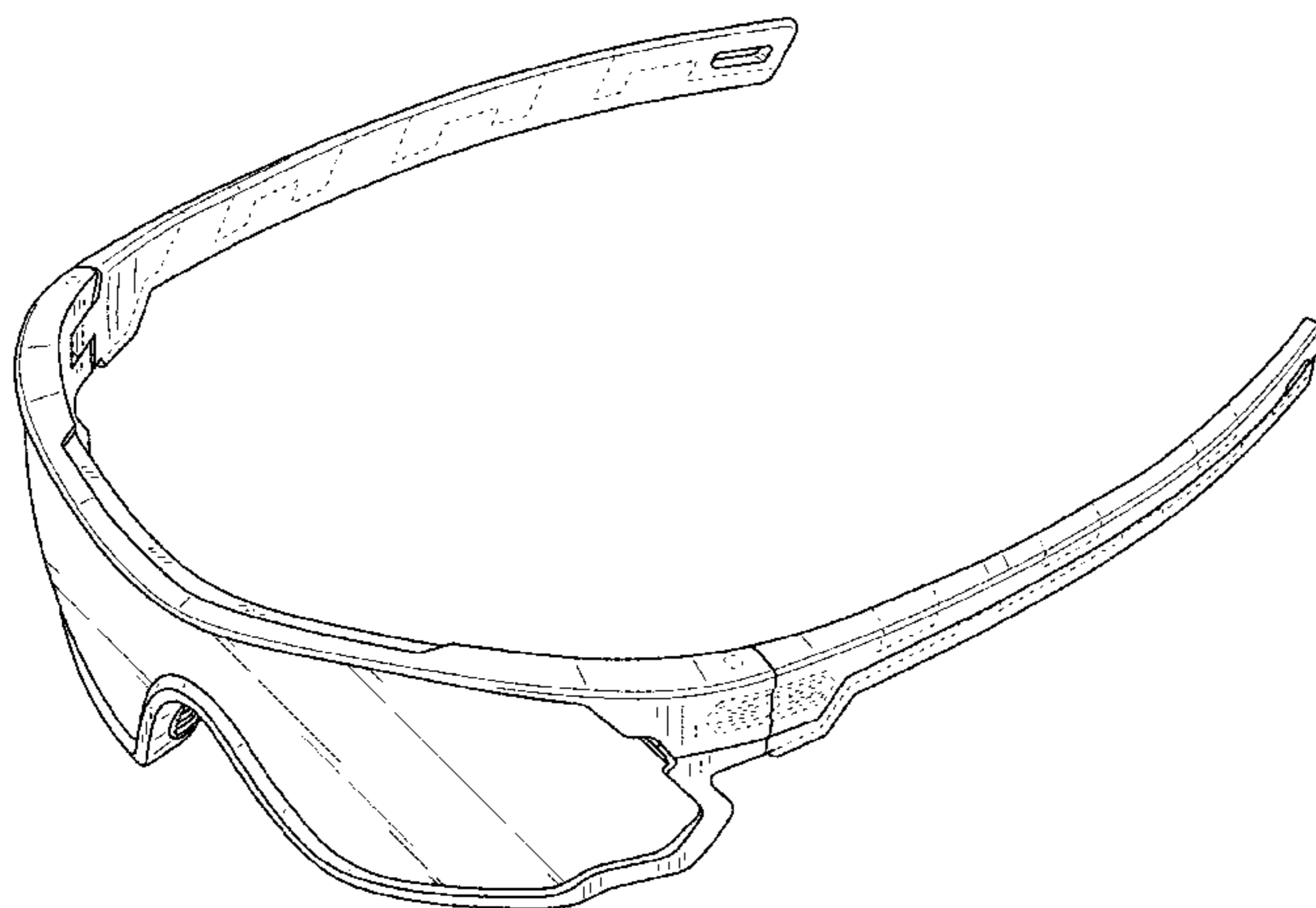
FIG. 5 is a left side of the eyewear.

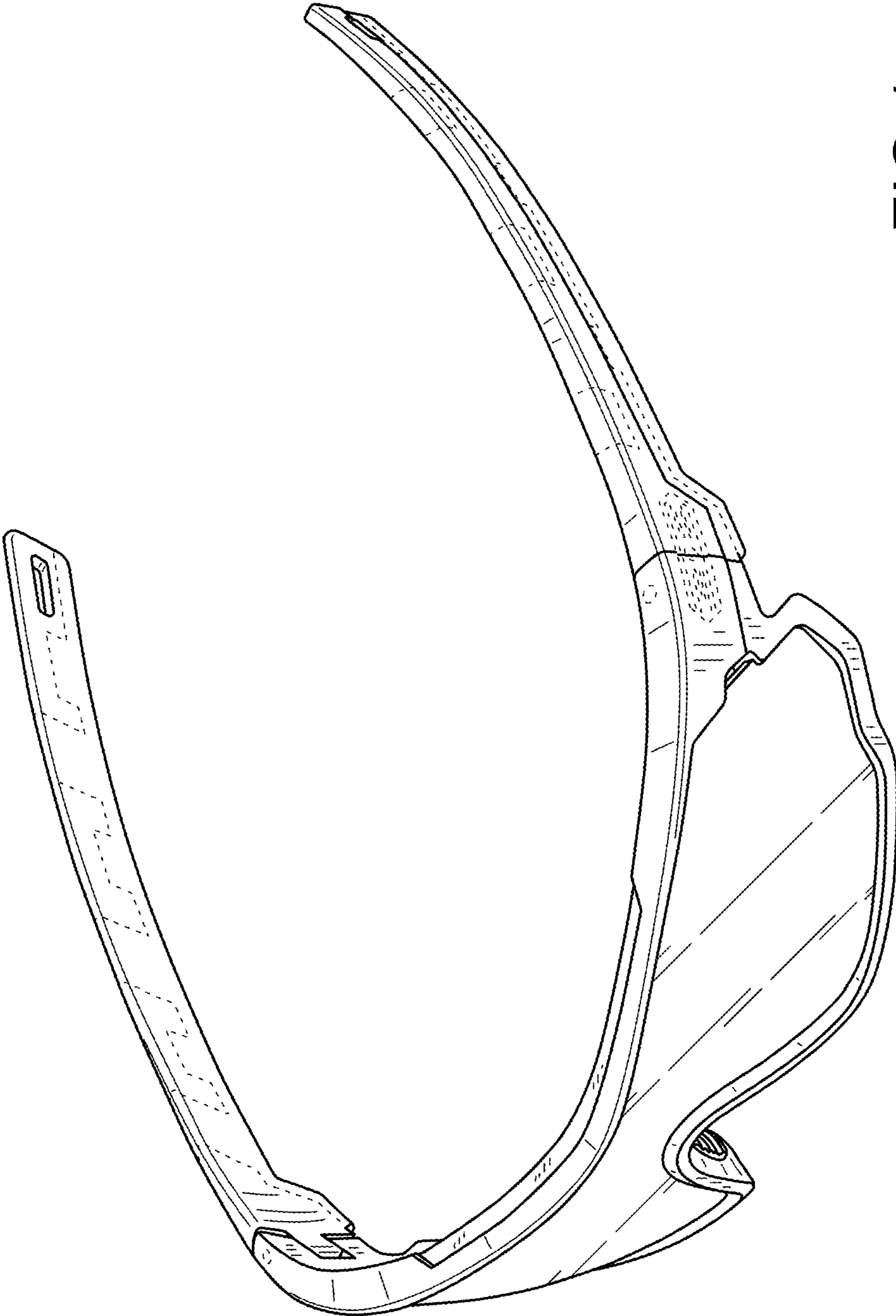

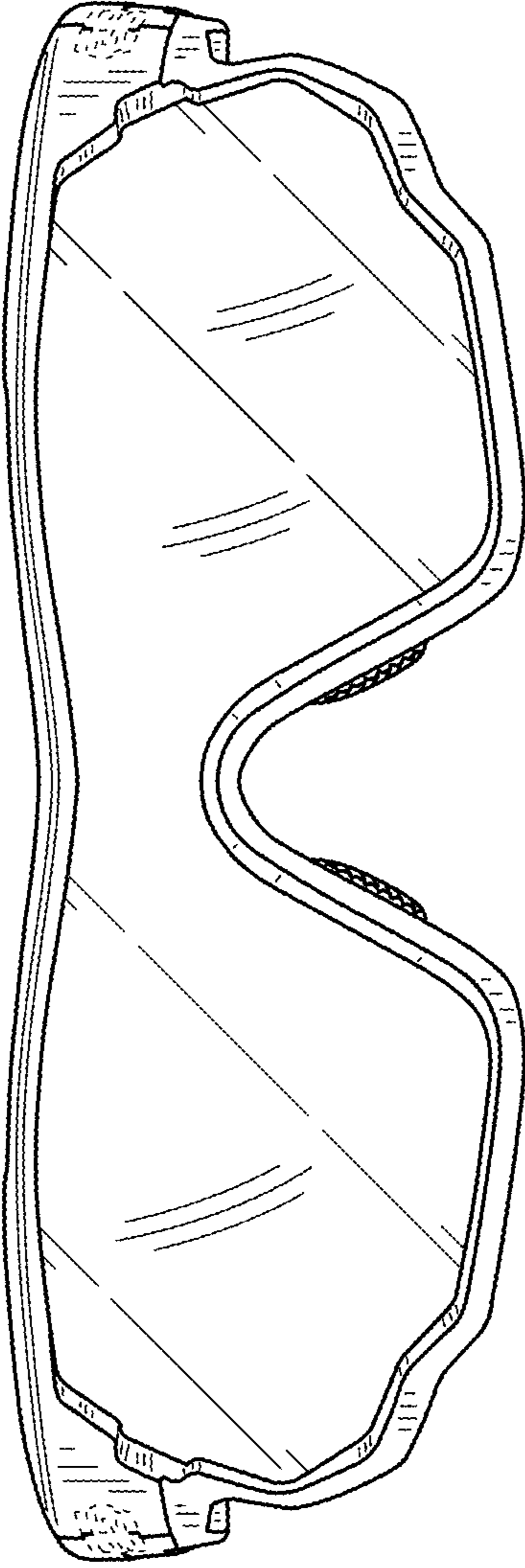

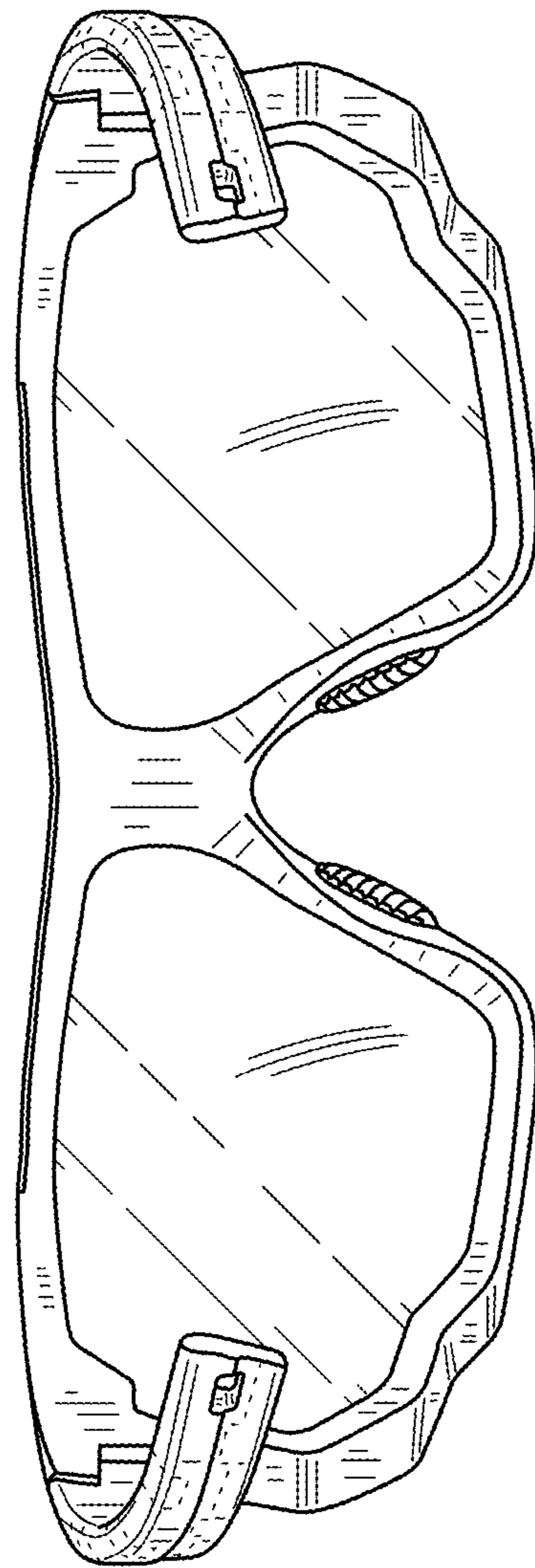

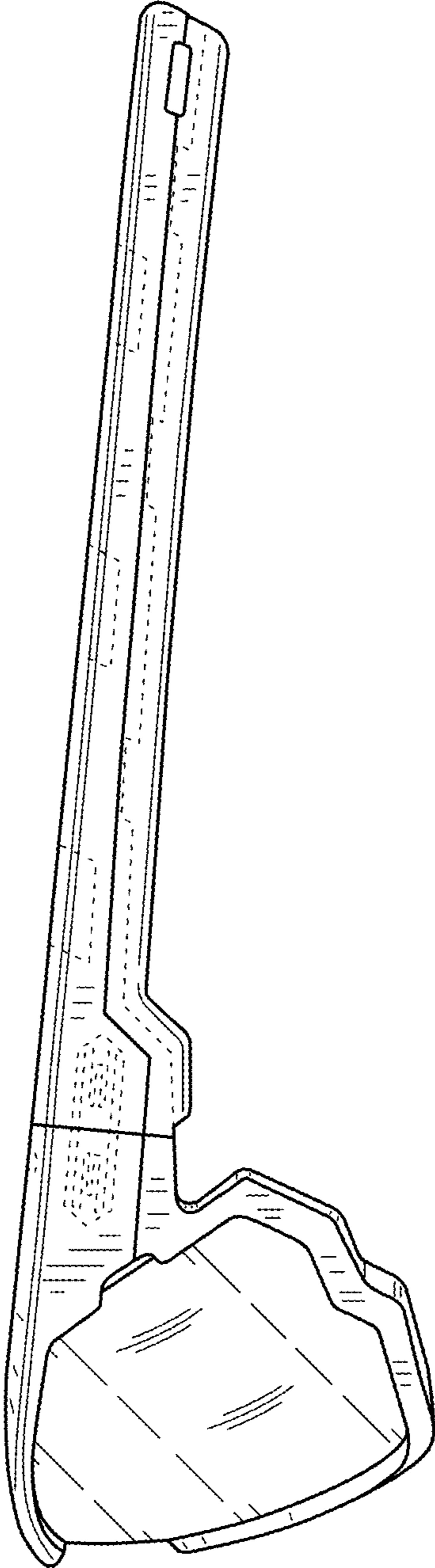

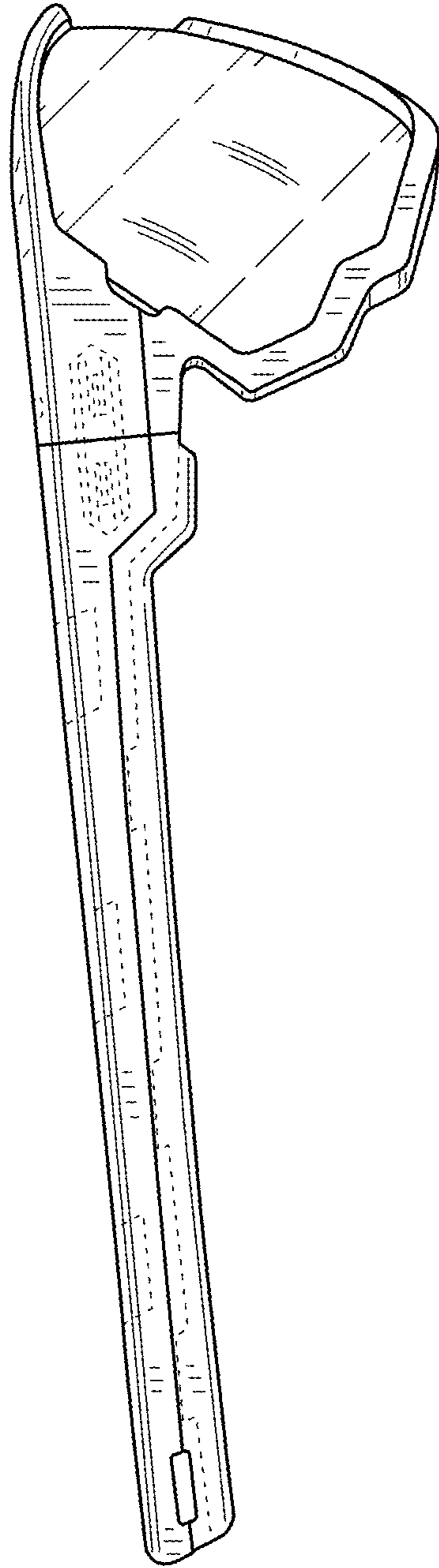

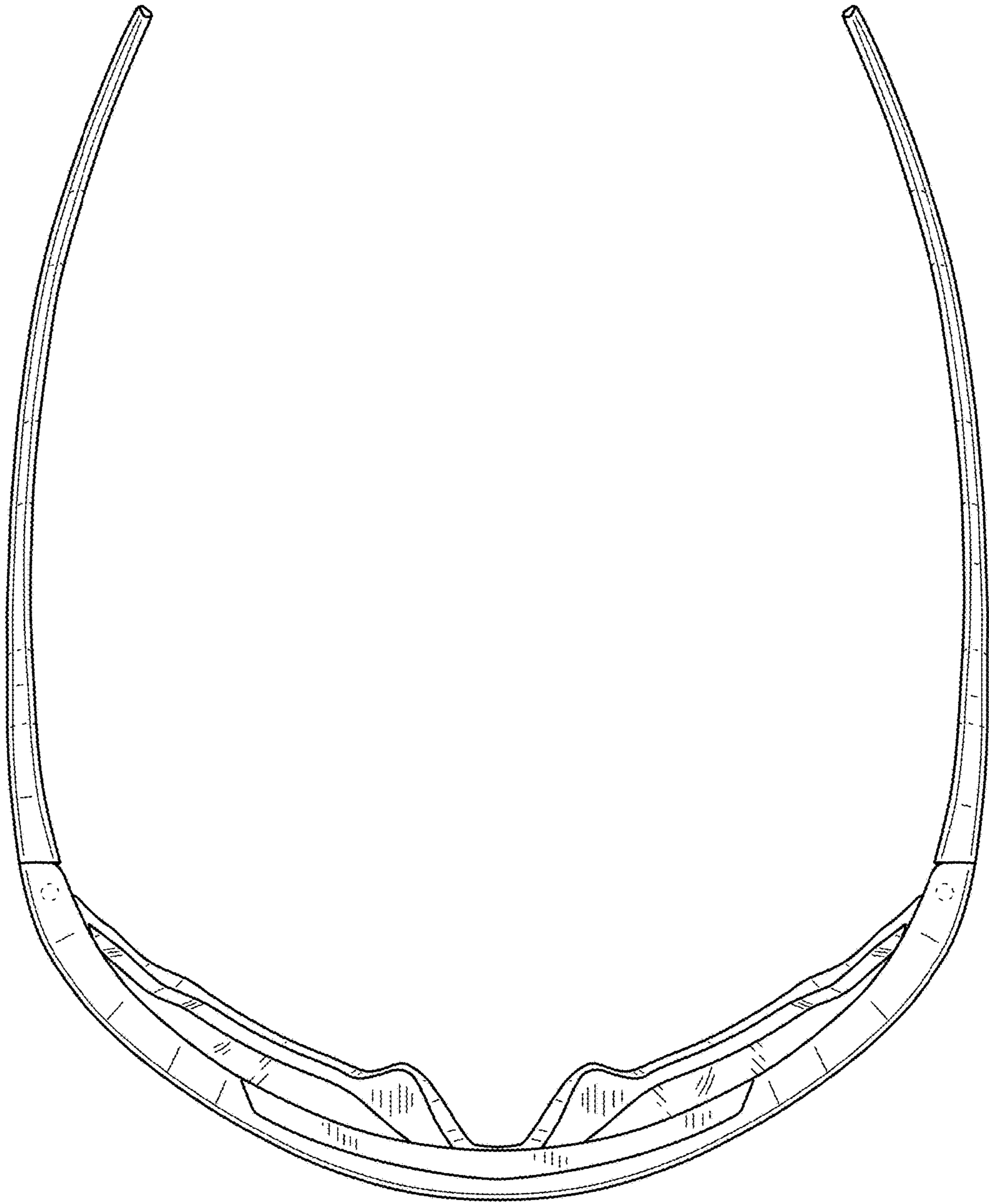

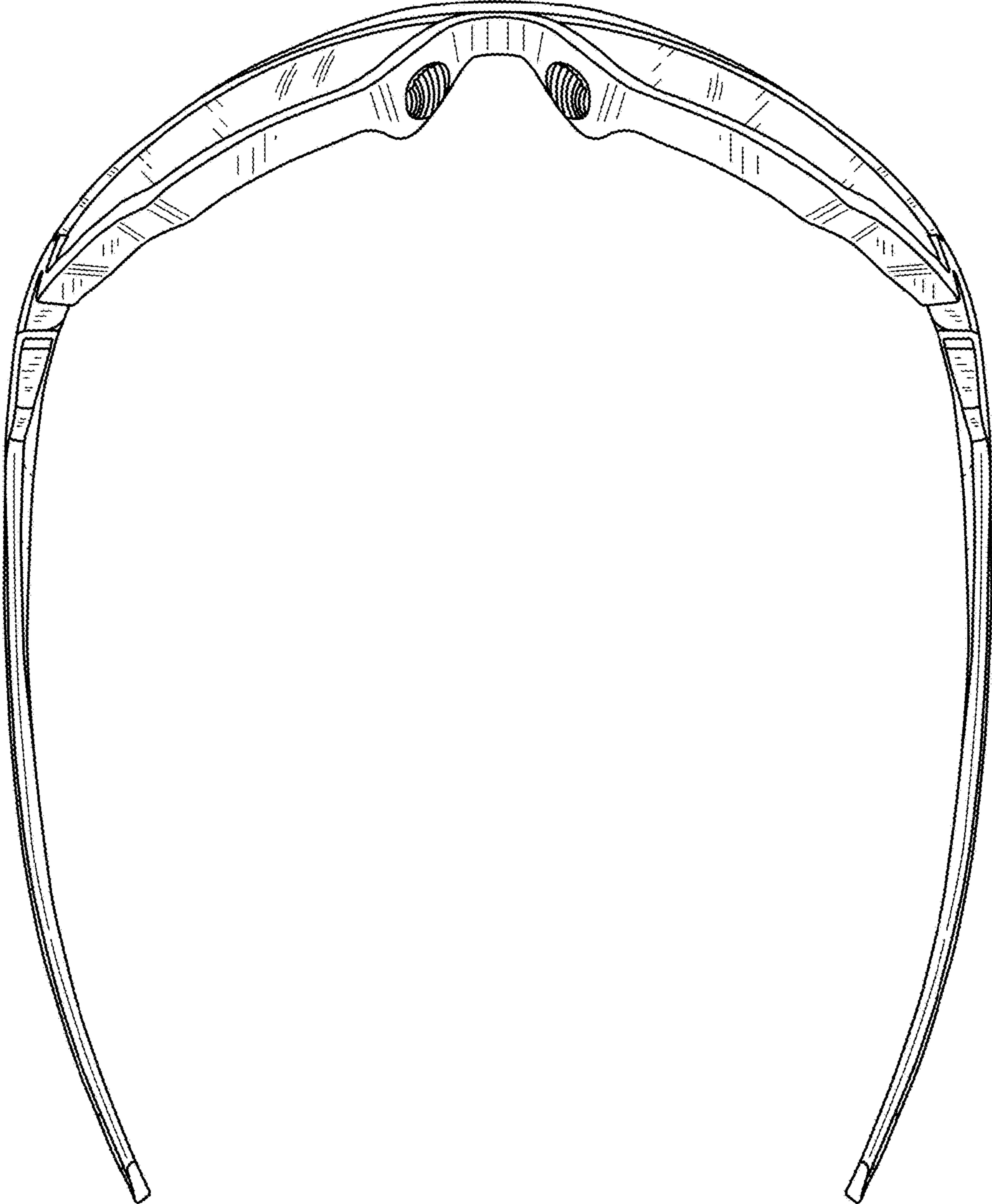
