The ornamental design for a dental scalar, as shown and described.

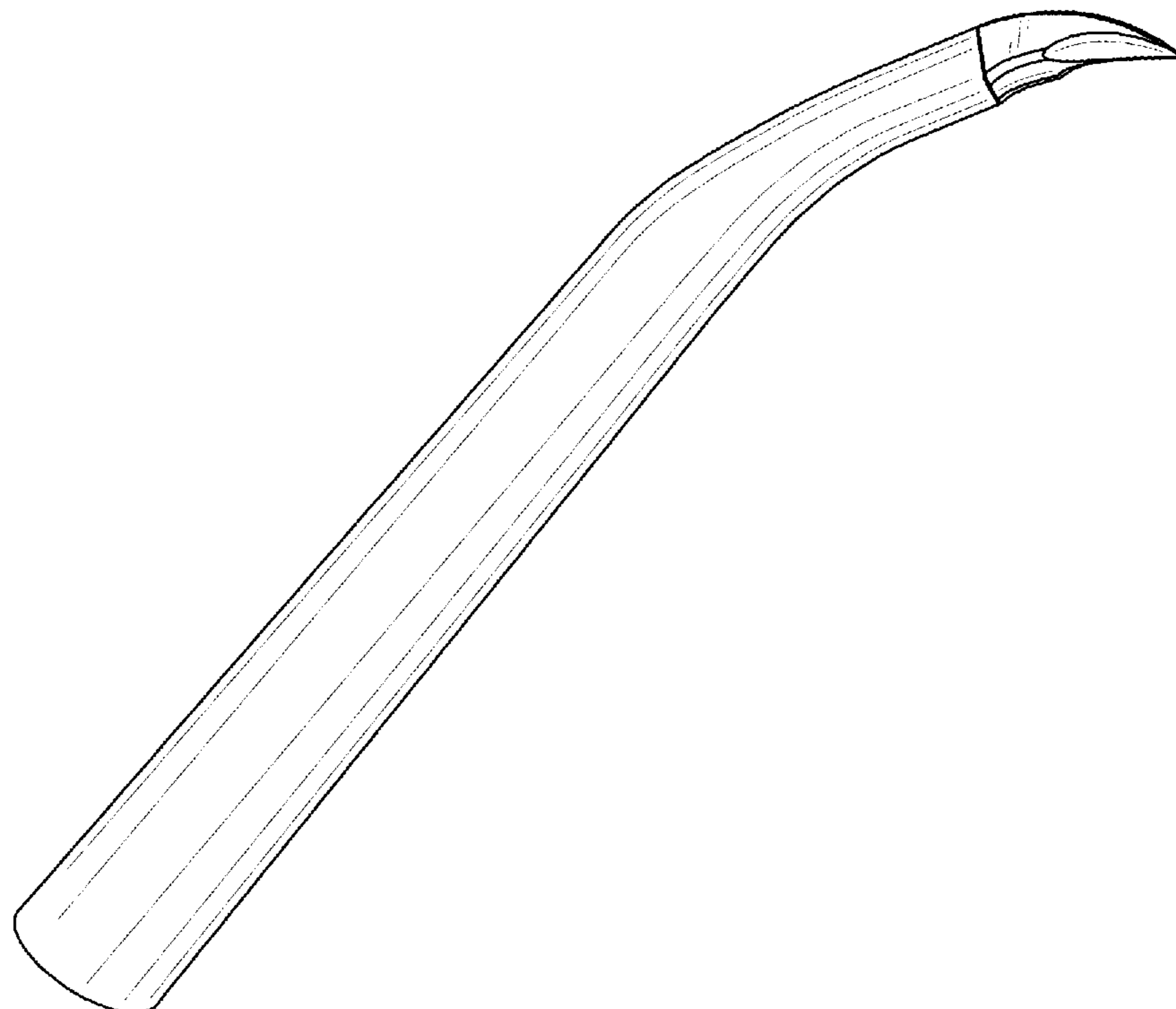
**DESCRIPTION**

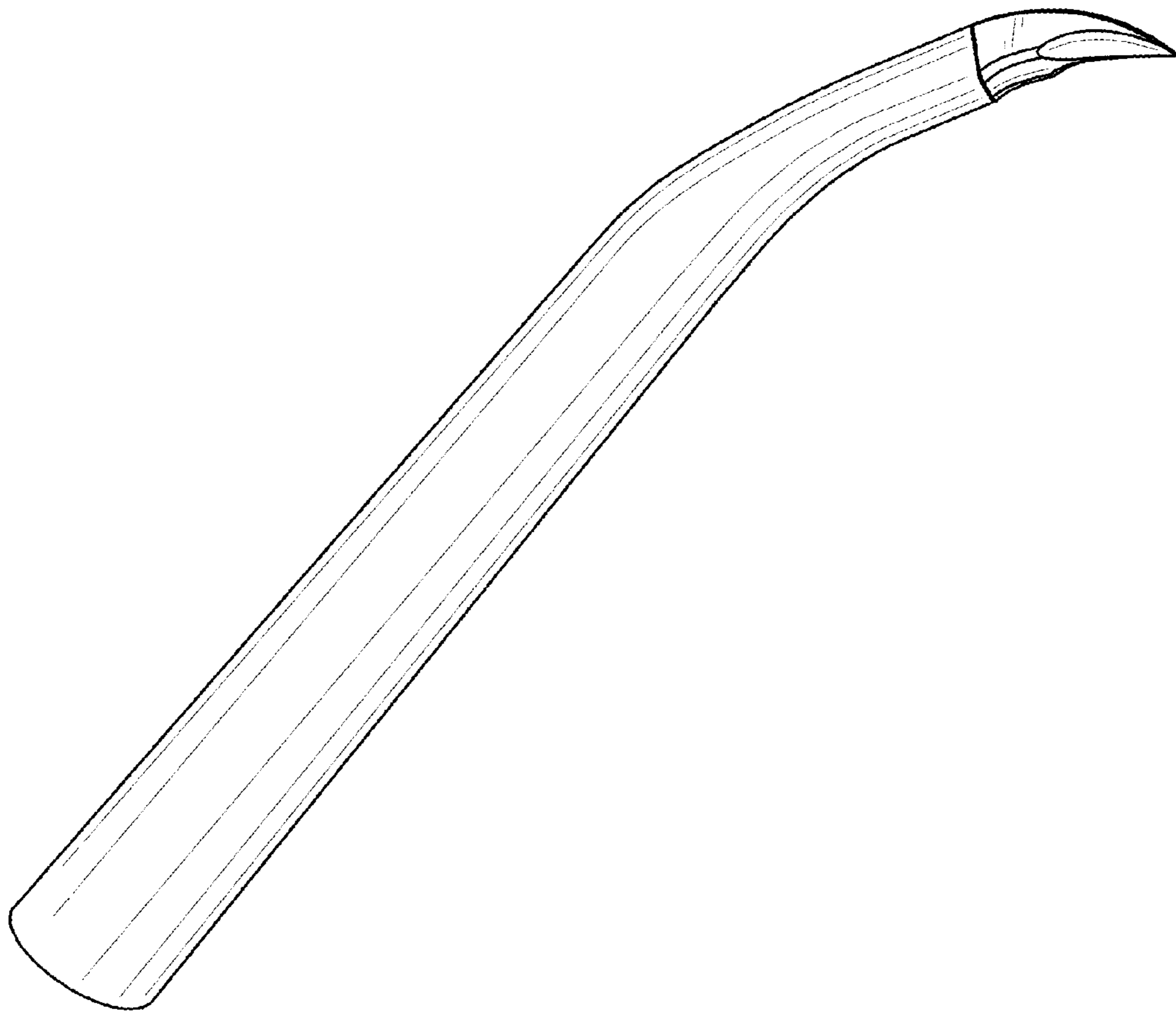

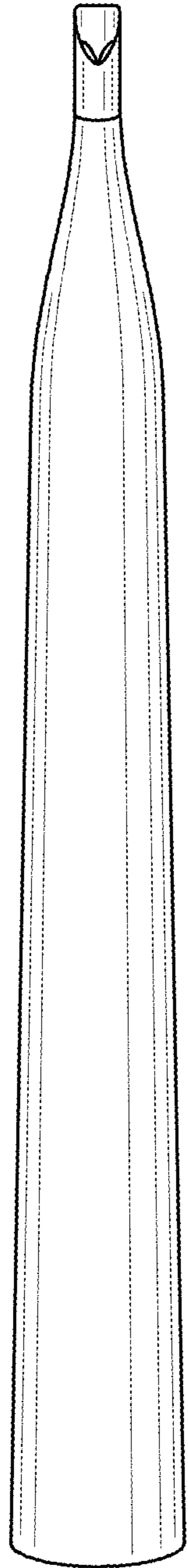

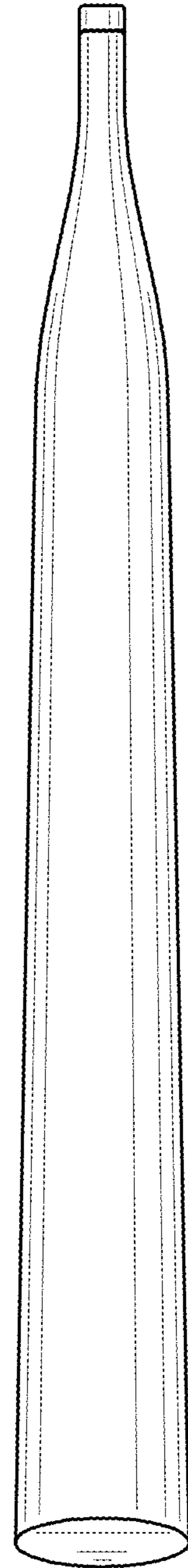

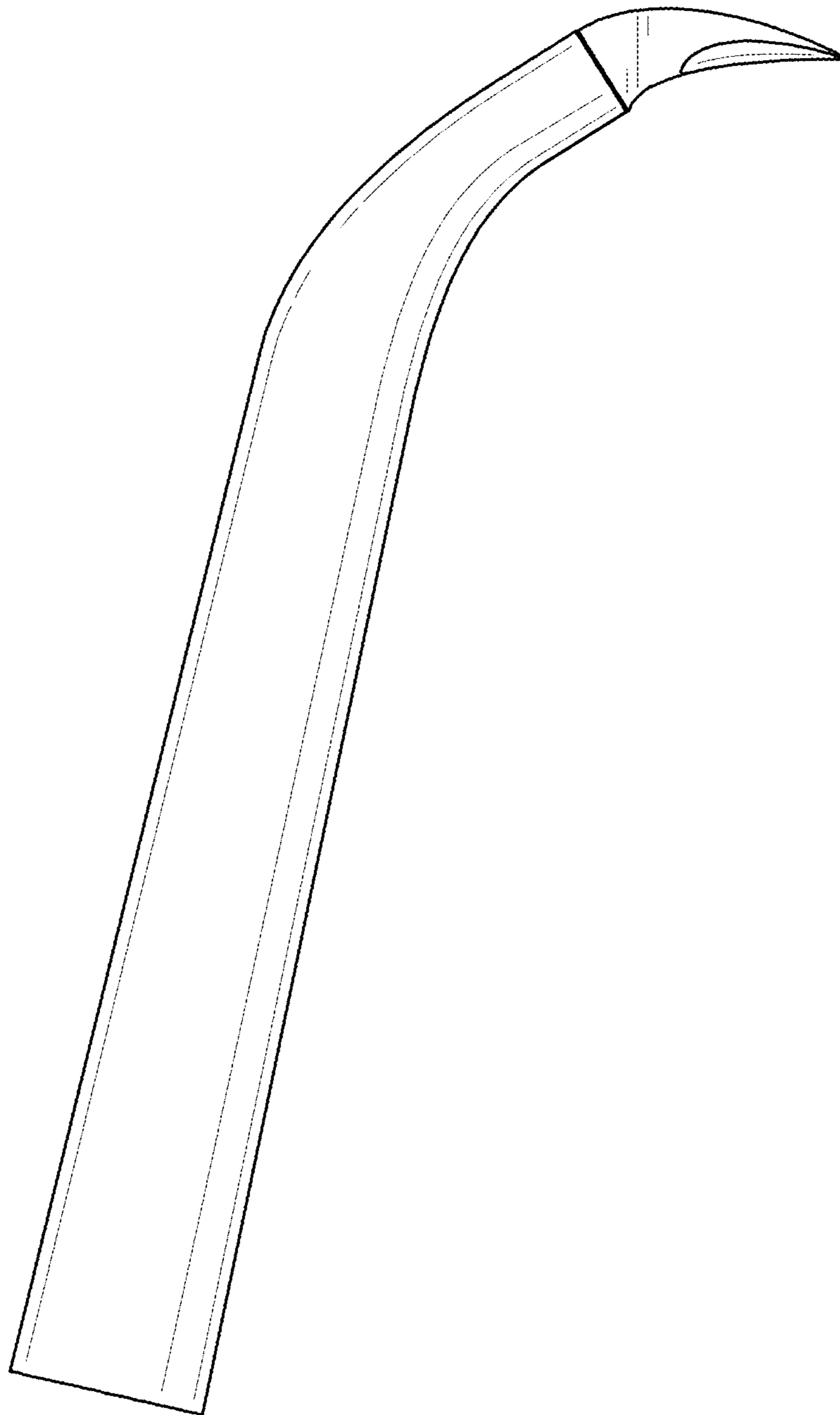

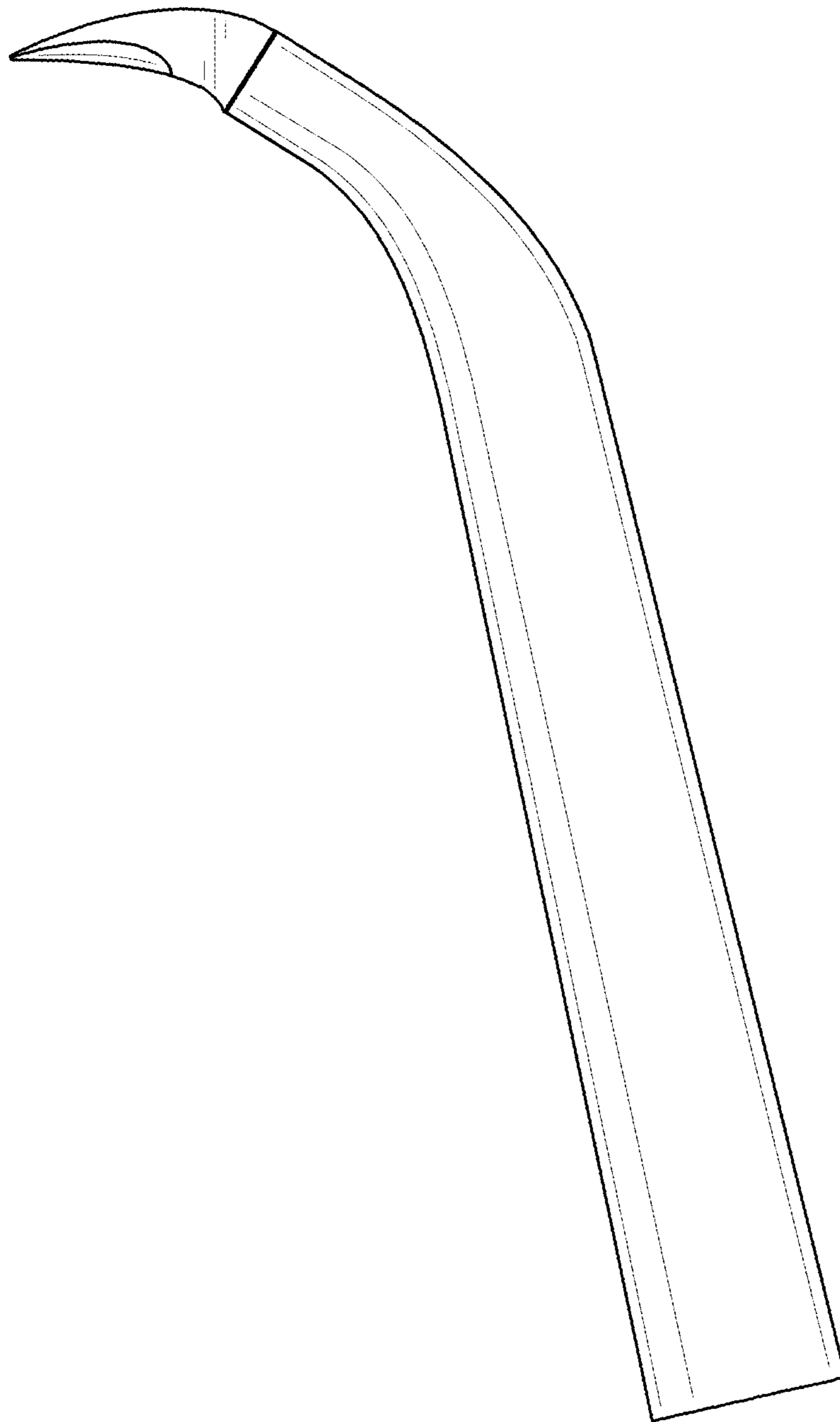

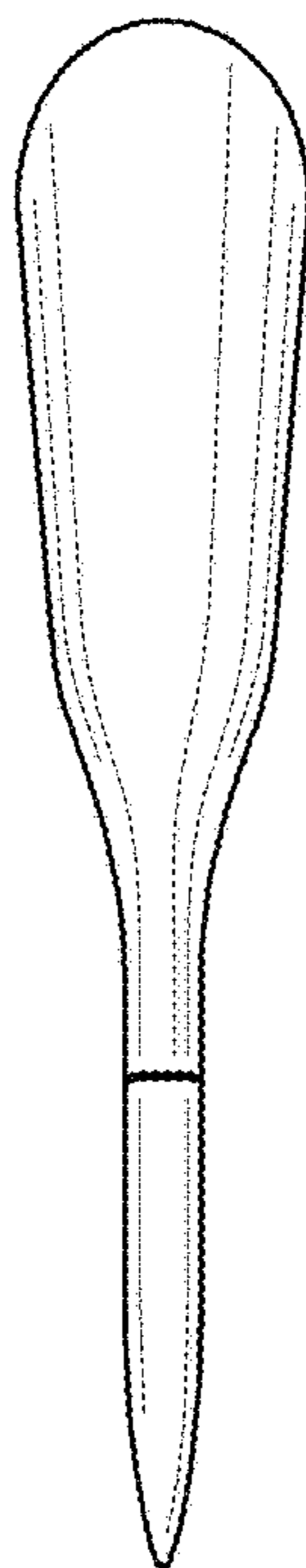

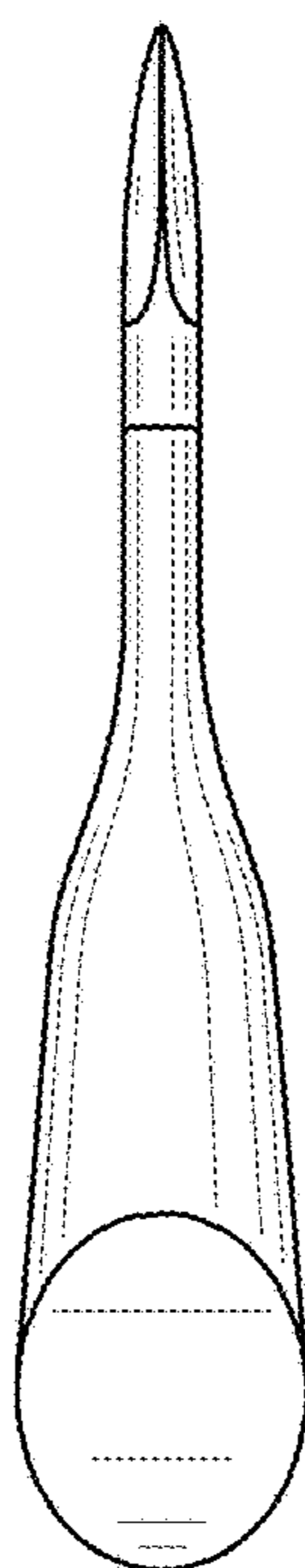
