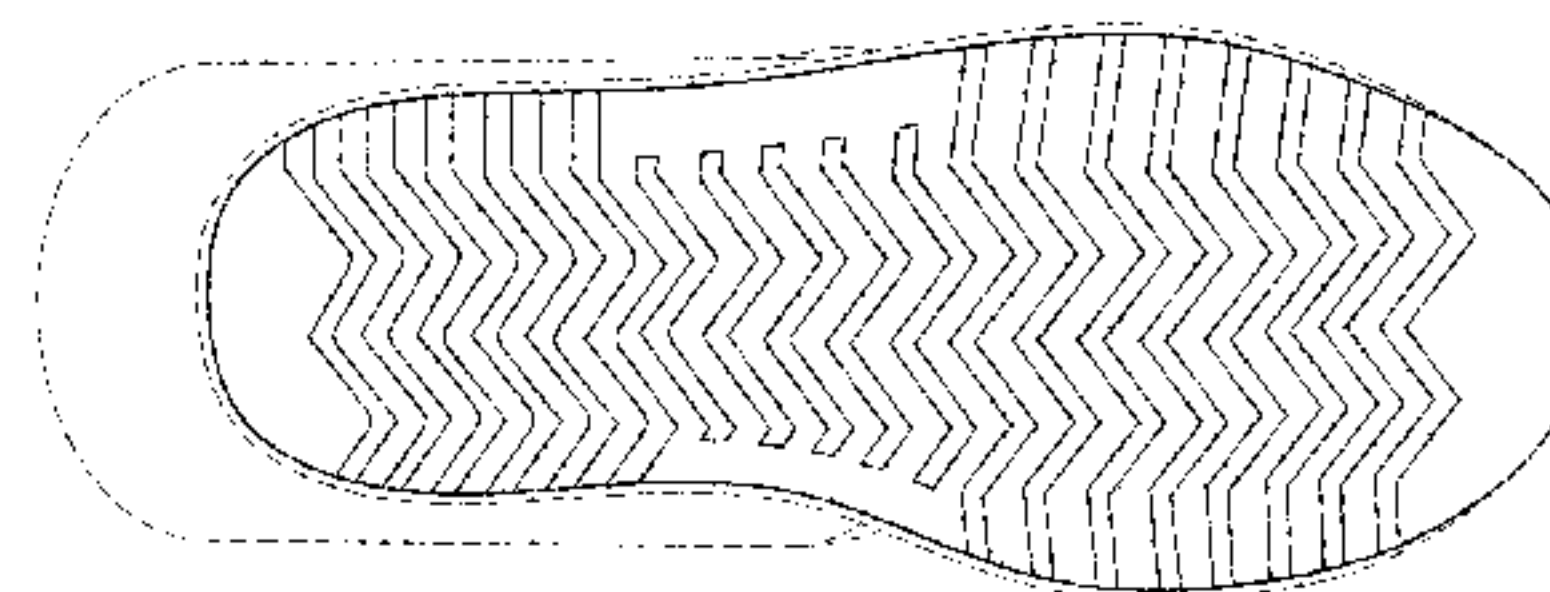
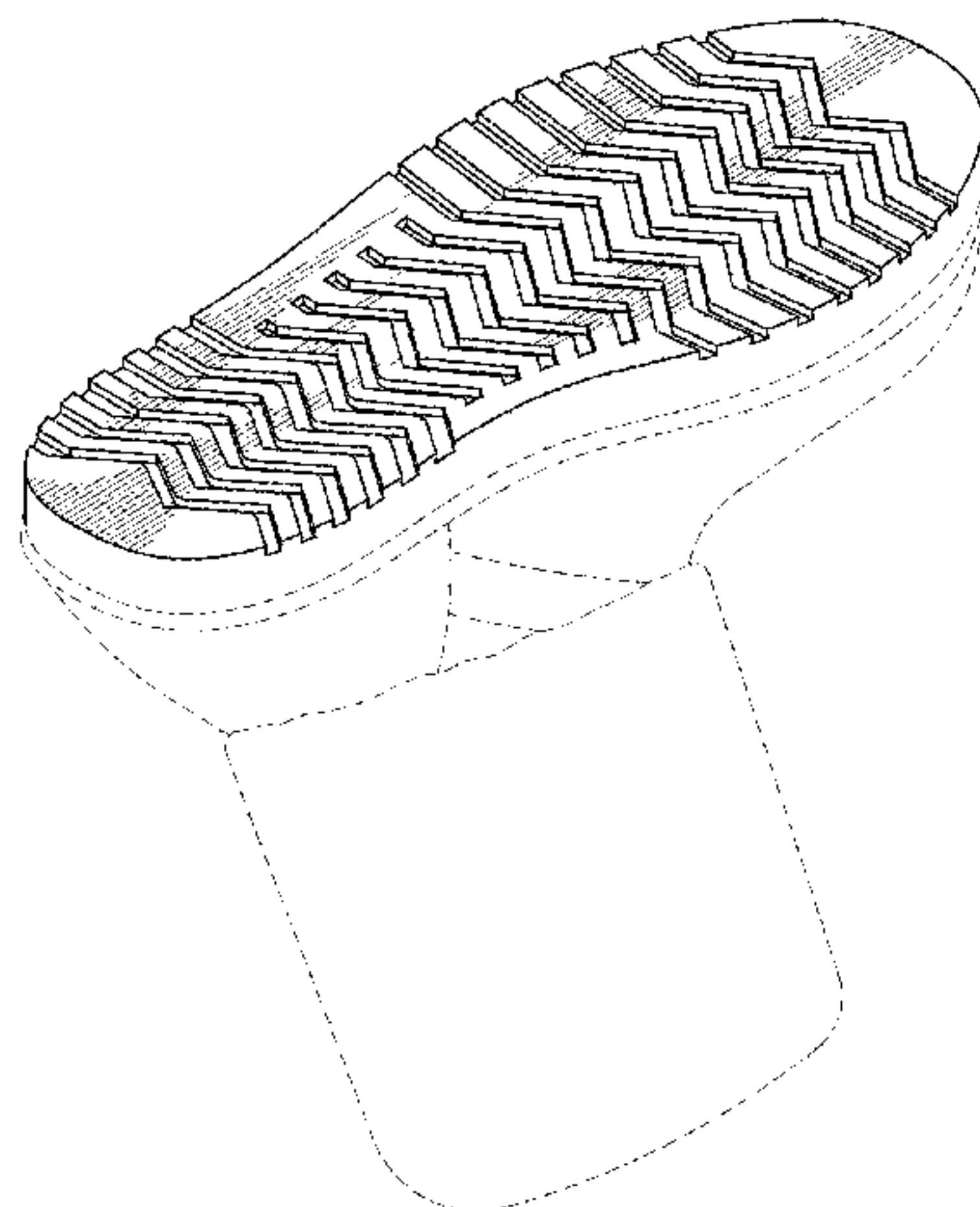
(57) **CLAIM**

The ornamental design for a shoe sole, as shown and described.

DESCRIPTION

FIG. 1 is a front right perspective view of a shoe sole according to the present invention.
 FIG. 2 is a right side elevational view of the shoe sole.
 FIG. 3 is a left side elevational view of the shoe sole.
 FIG. 4 is a rear elevational view of the shoe sole.
 FIG. 5 is a front elevational view of the shoe sole.
 FIG. 6 is a bottom perspective view of the shoe sole; and, FIG. 7 is a bottom plan view of the shoe sole.
 The portions shown in broken lines are solely for the purpose of illustrating context, environment, or other unclaimed areas and form no part of the claimed design. The claimed design is intended to encompass a first embodiment of a shoe sole as illustrated in the drawings, as well as a second embodiment for the opposite matching shoe sole, which is the mirror image of that shown.

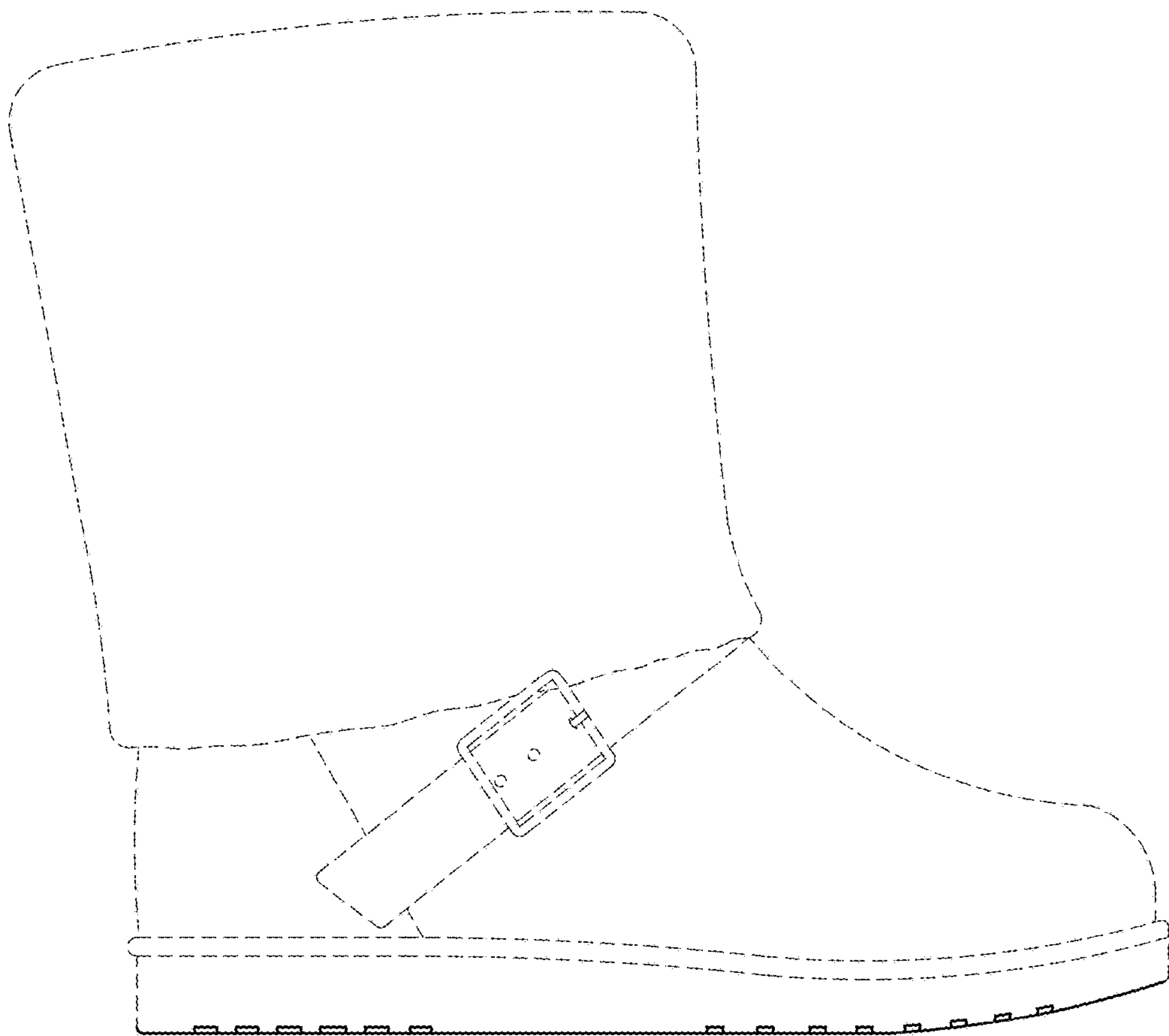

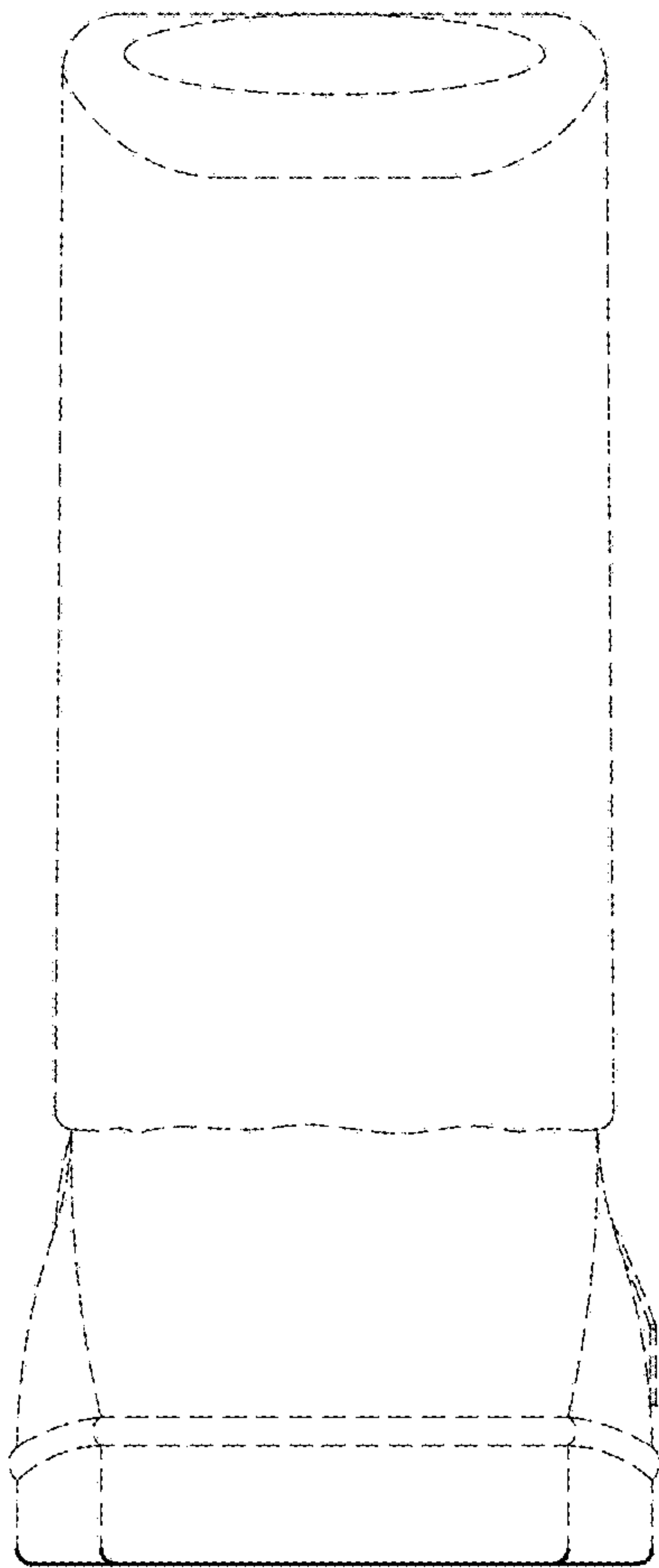

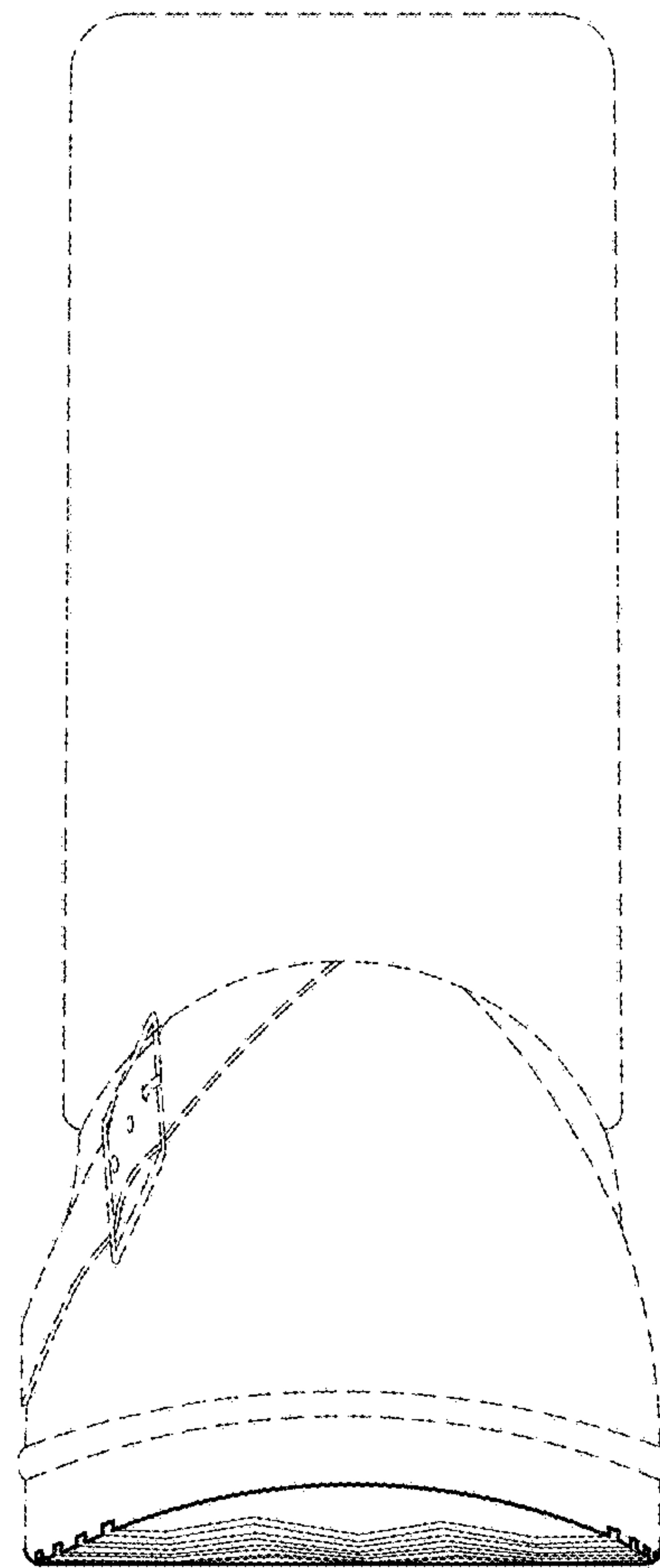
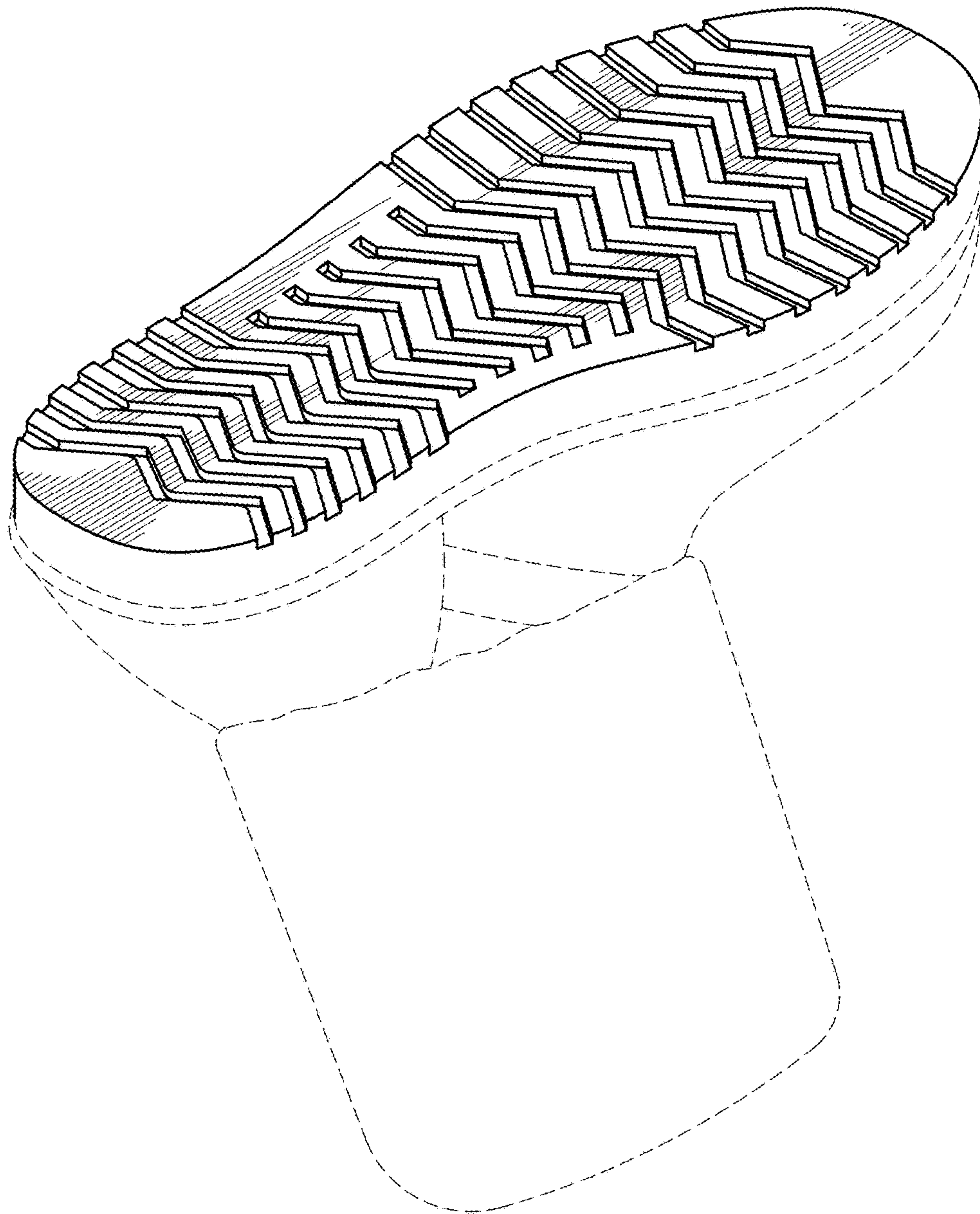

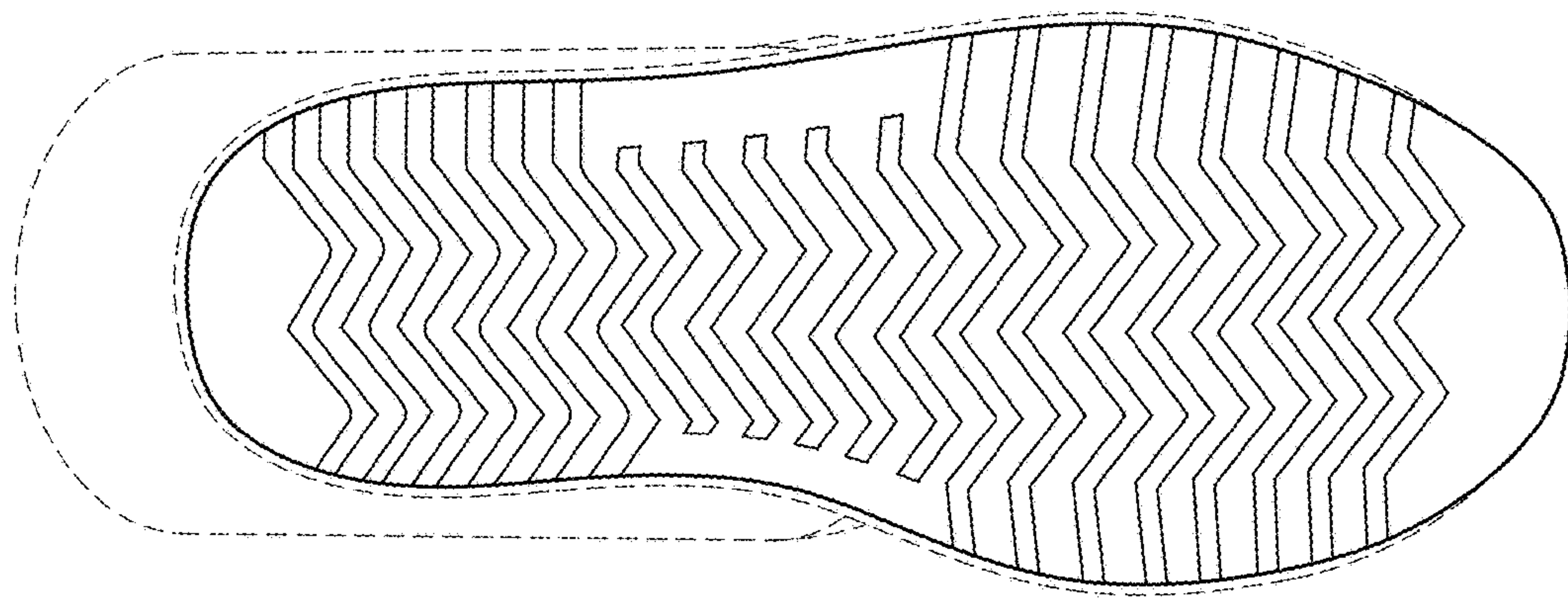
