design.

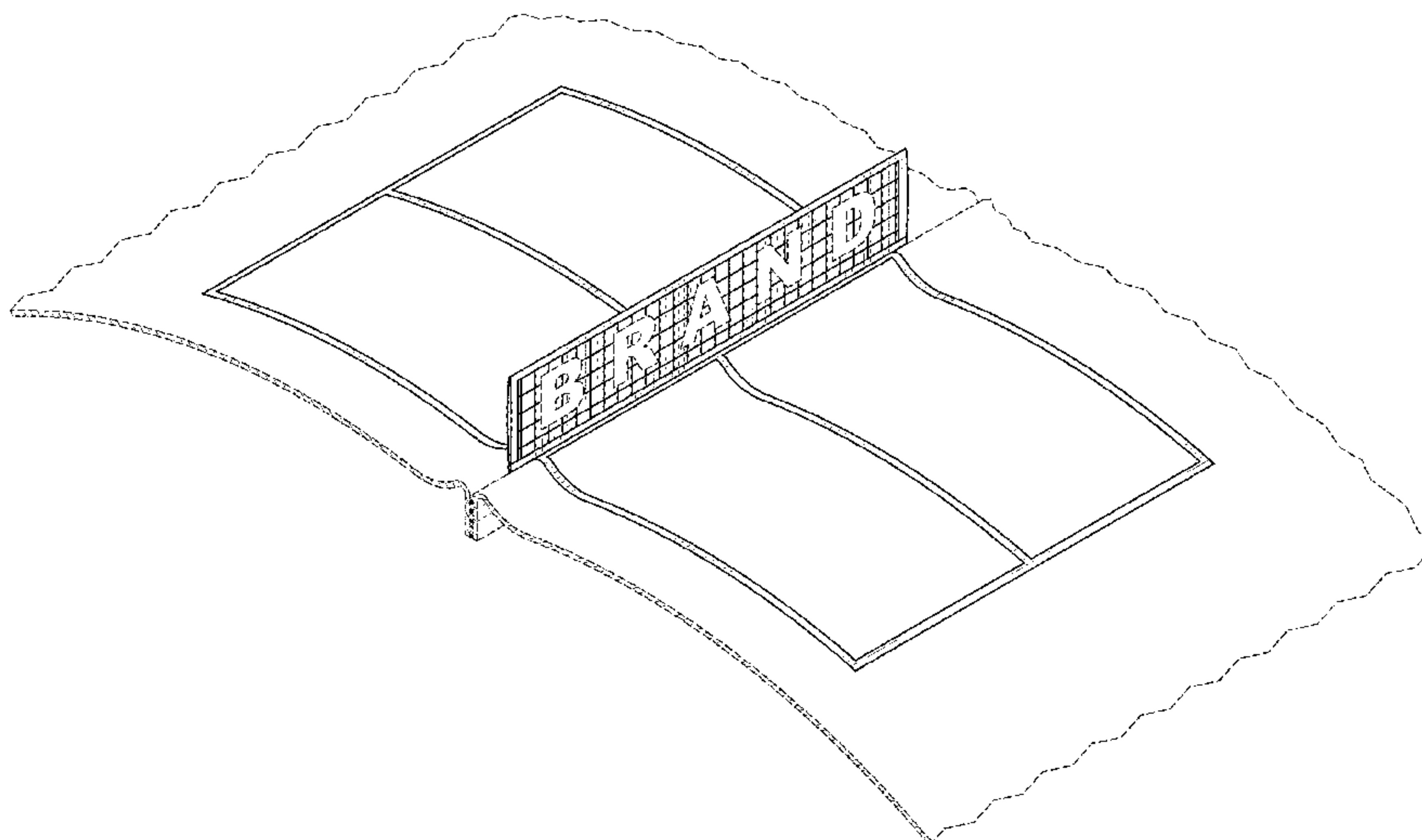
FIG. 4 is a Left side view of the new table tennis court label

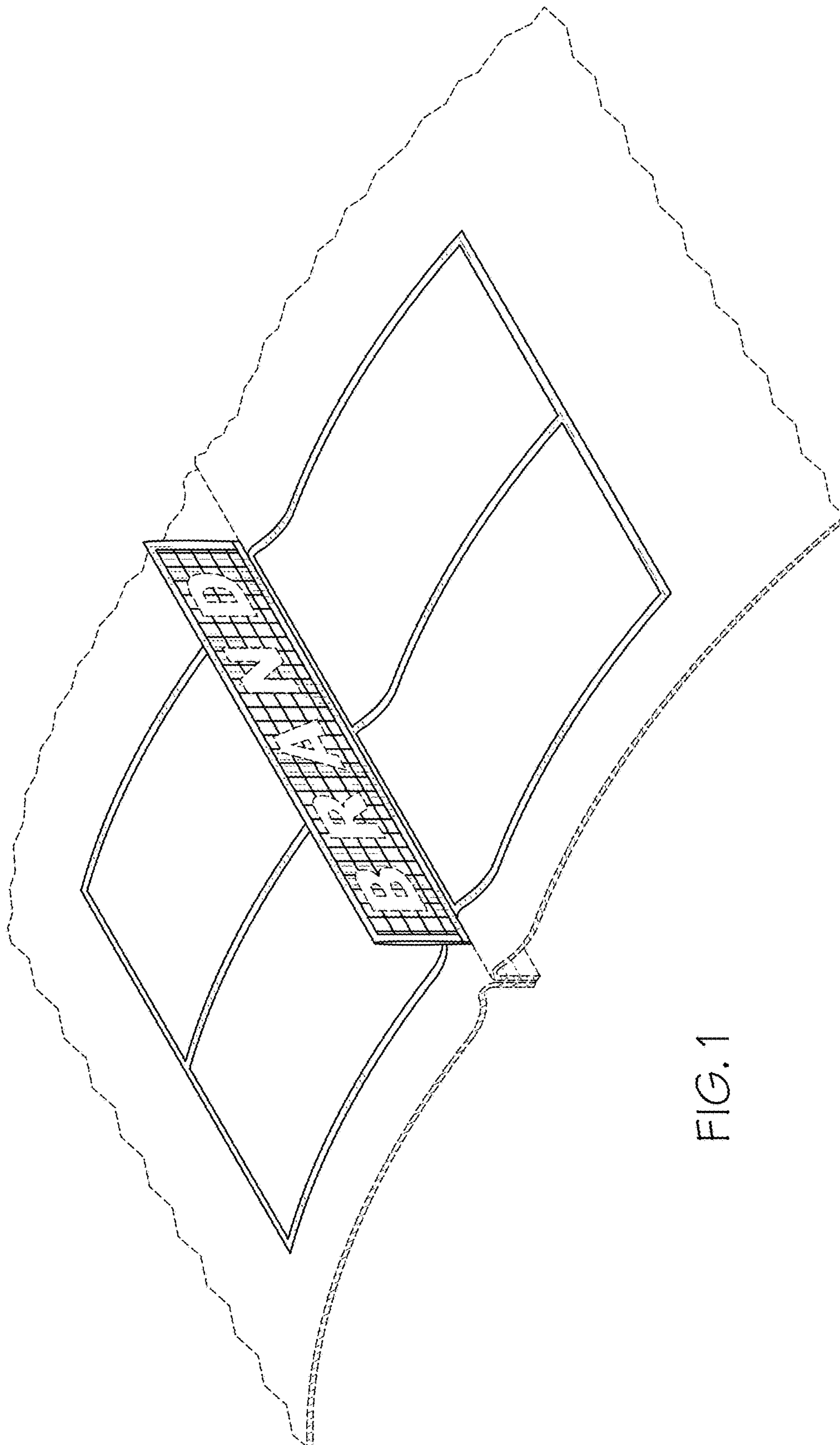

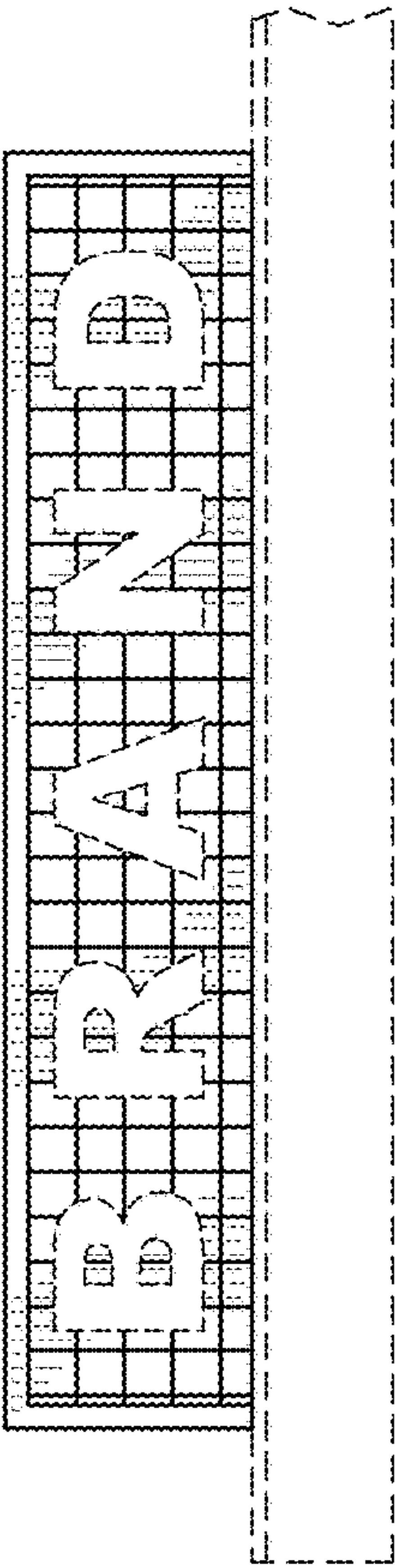

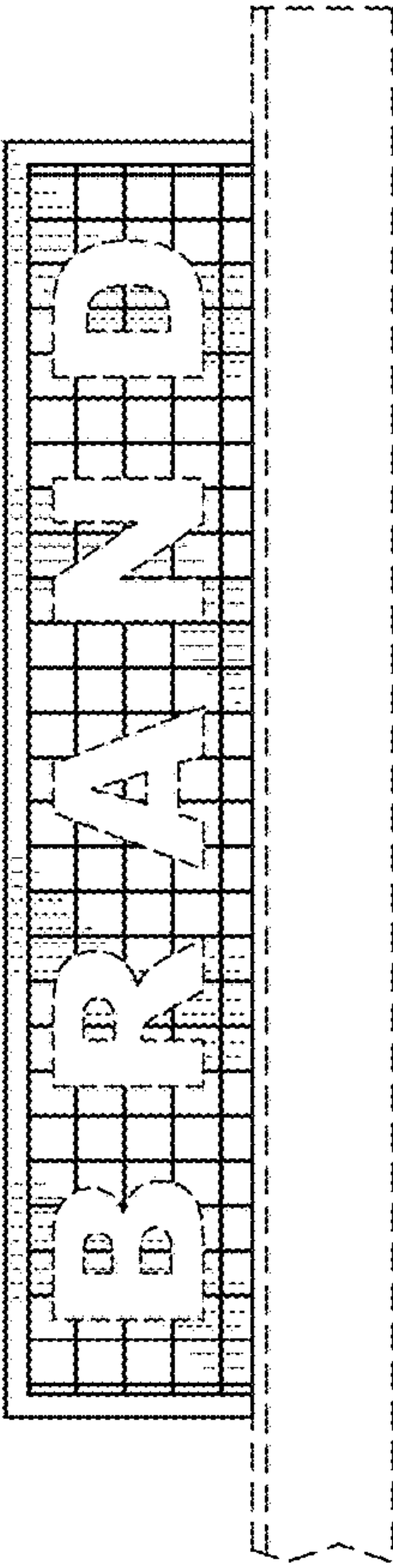

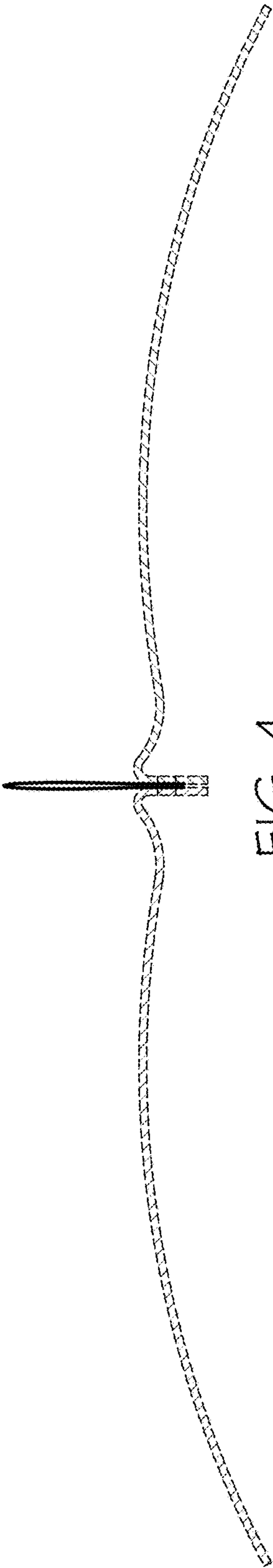

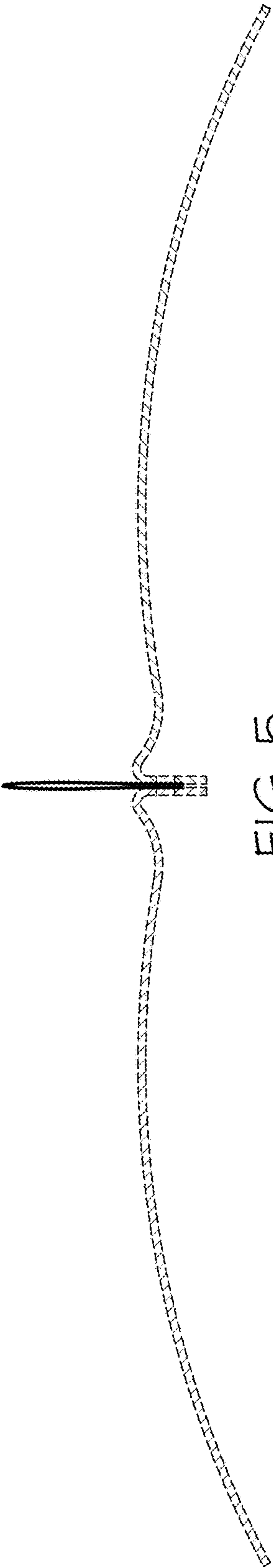

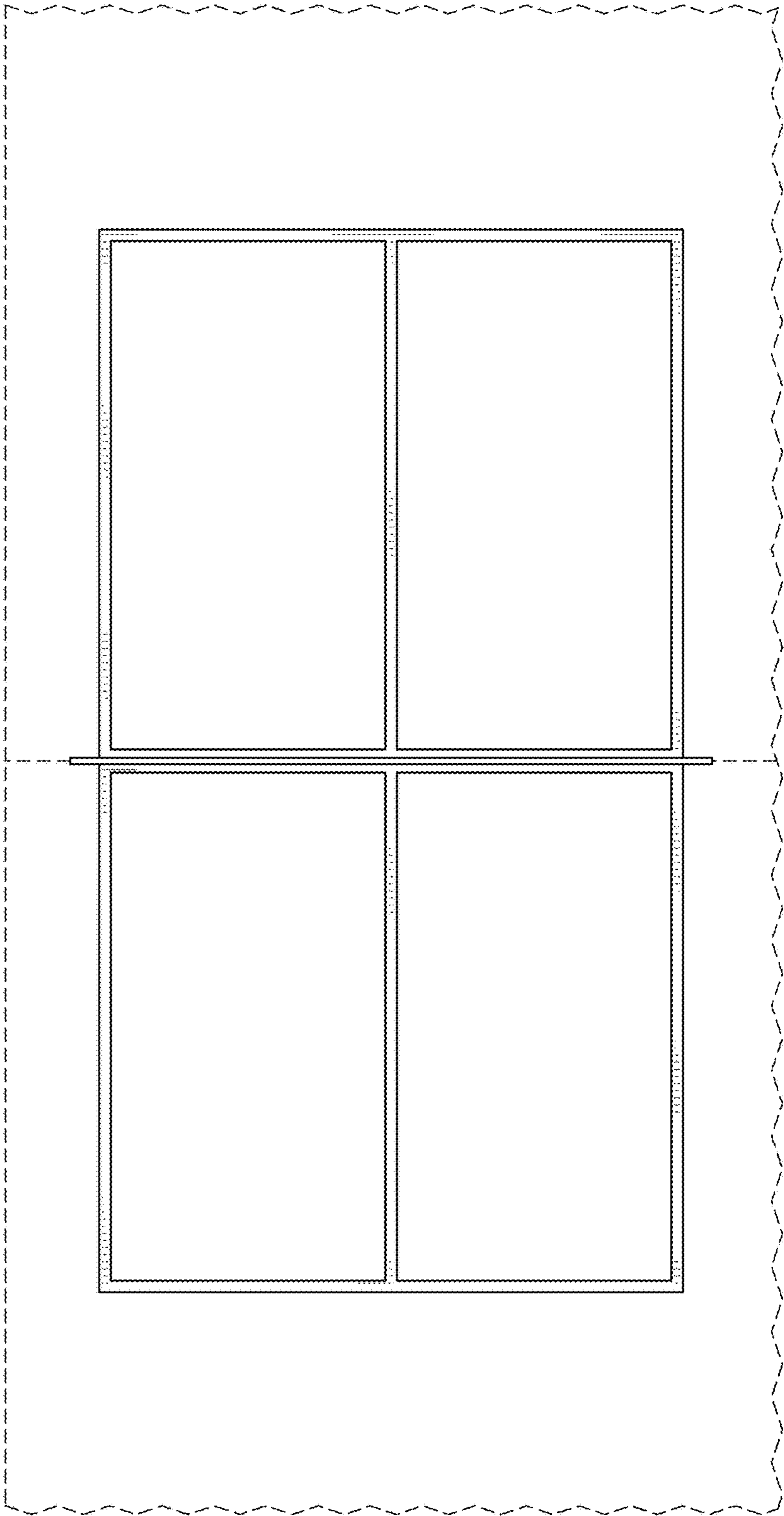
