DESCRIPTION

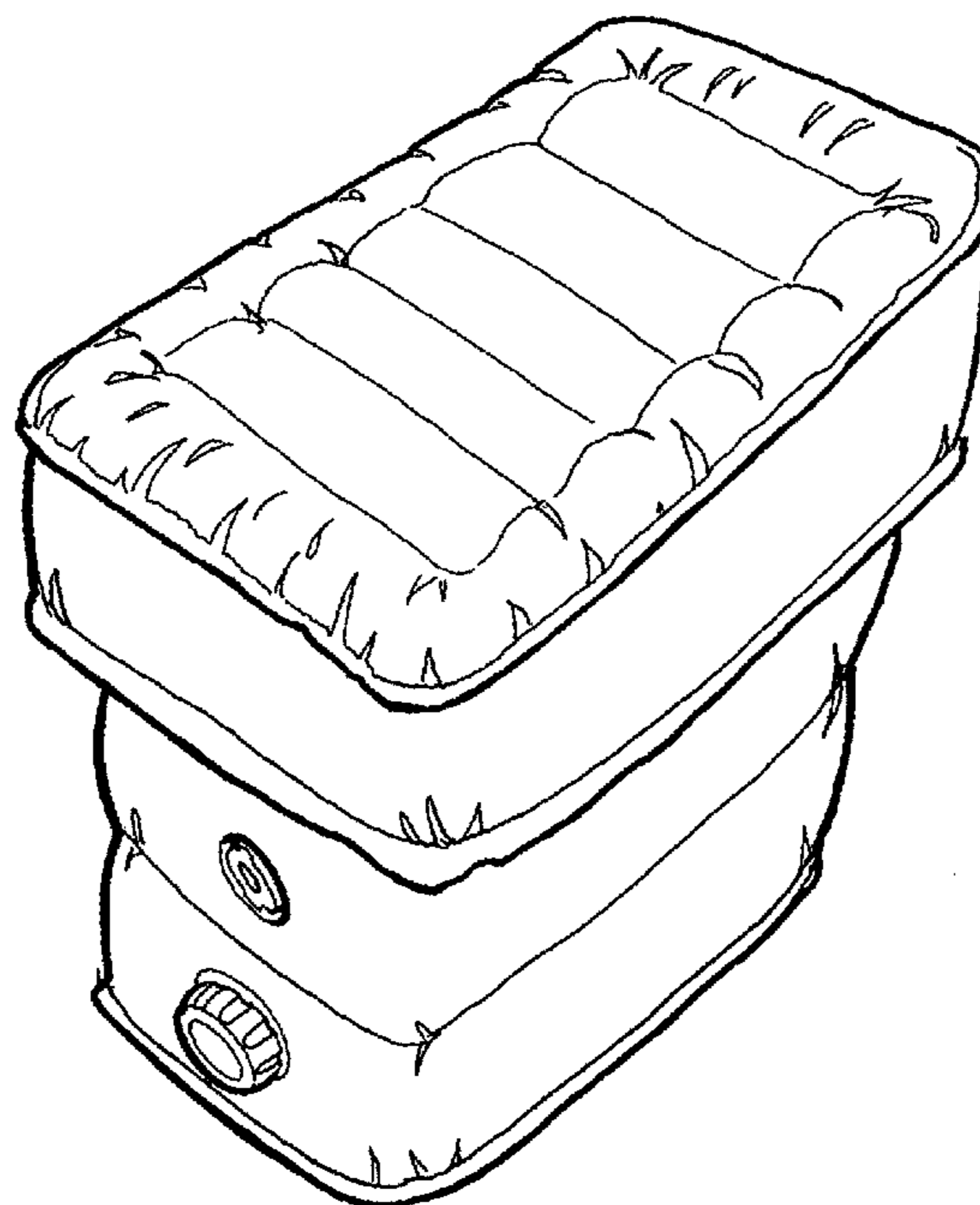
FIG. 1 is a perspective view of an inflatable stool showing my new design;

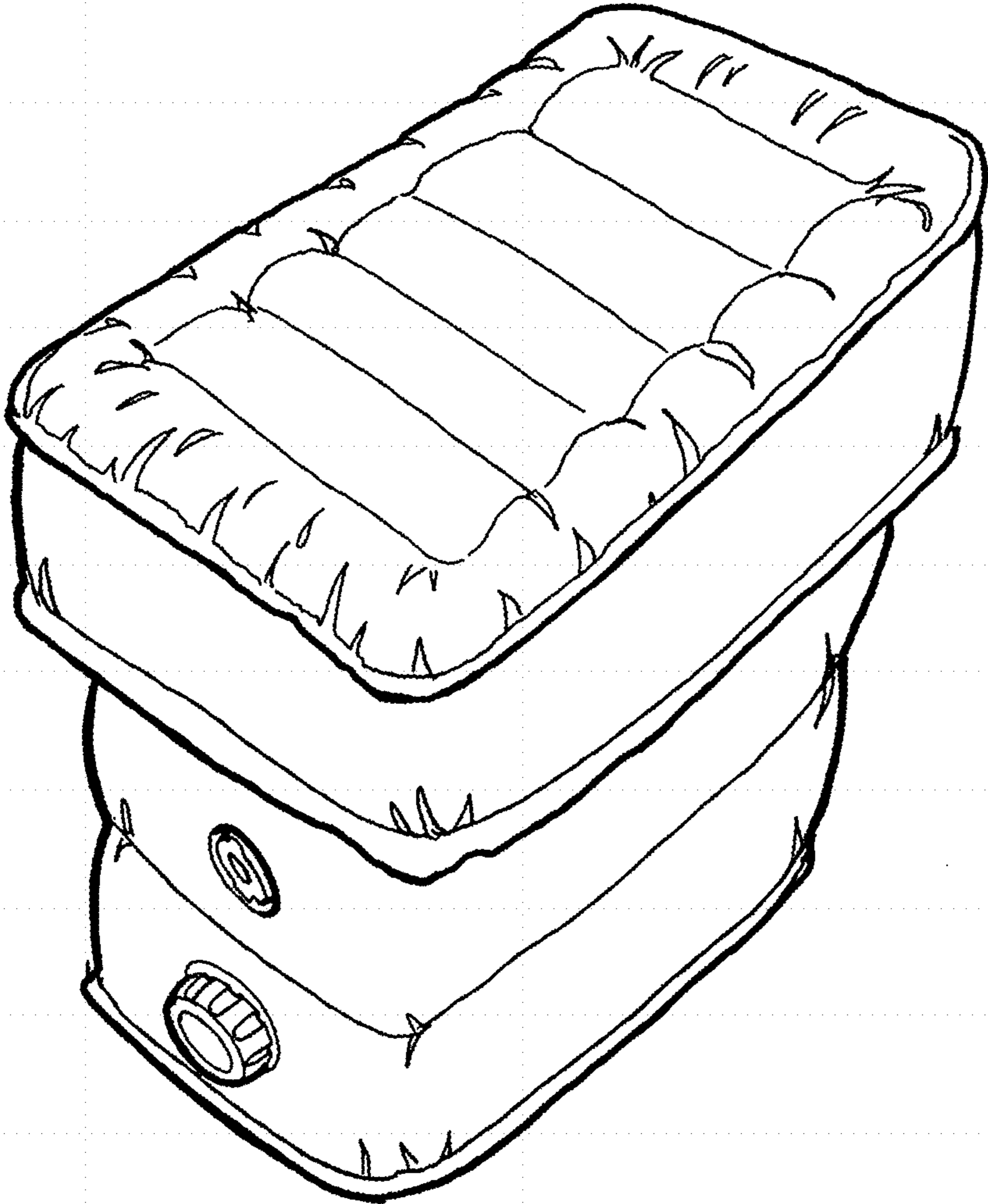

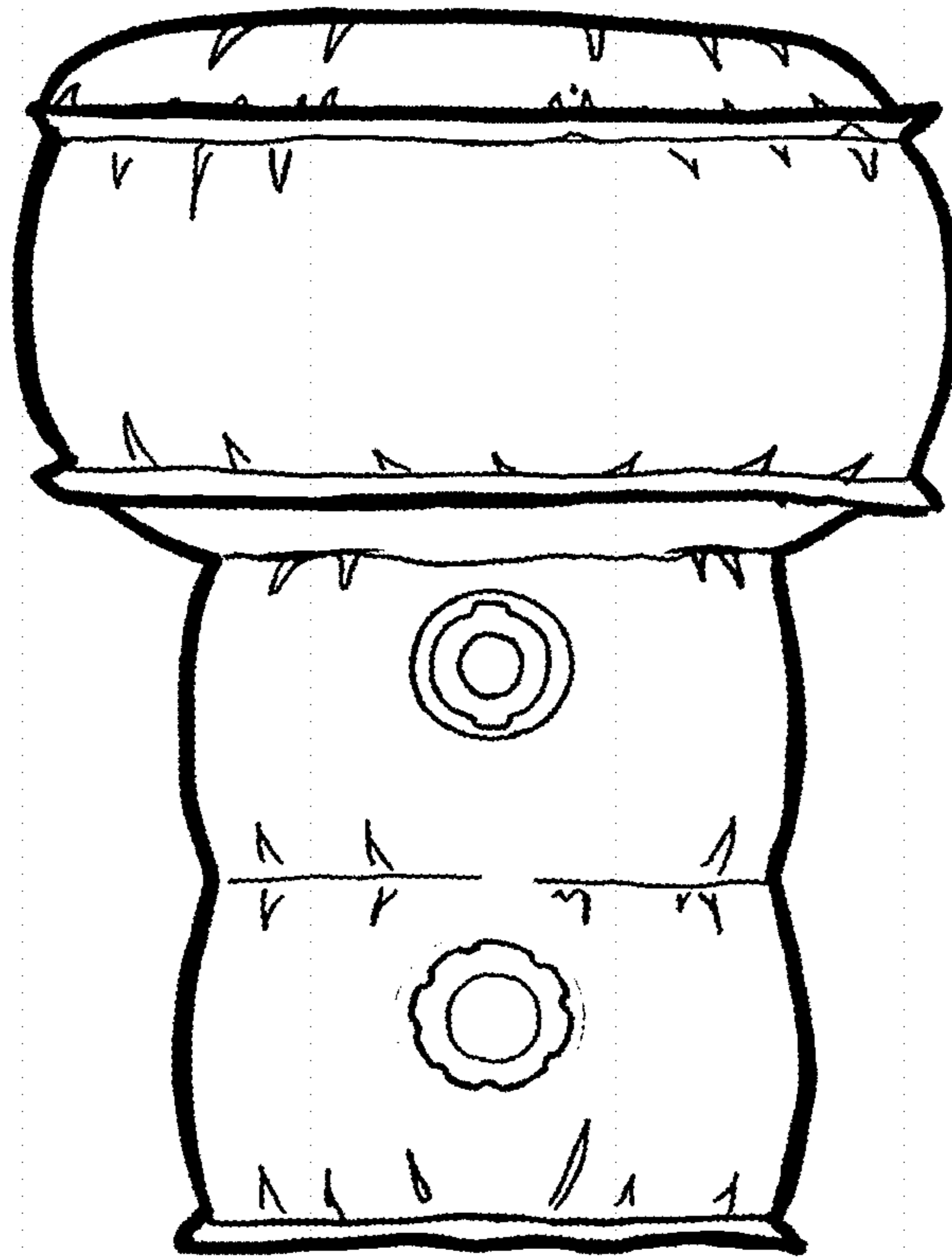

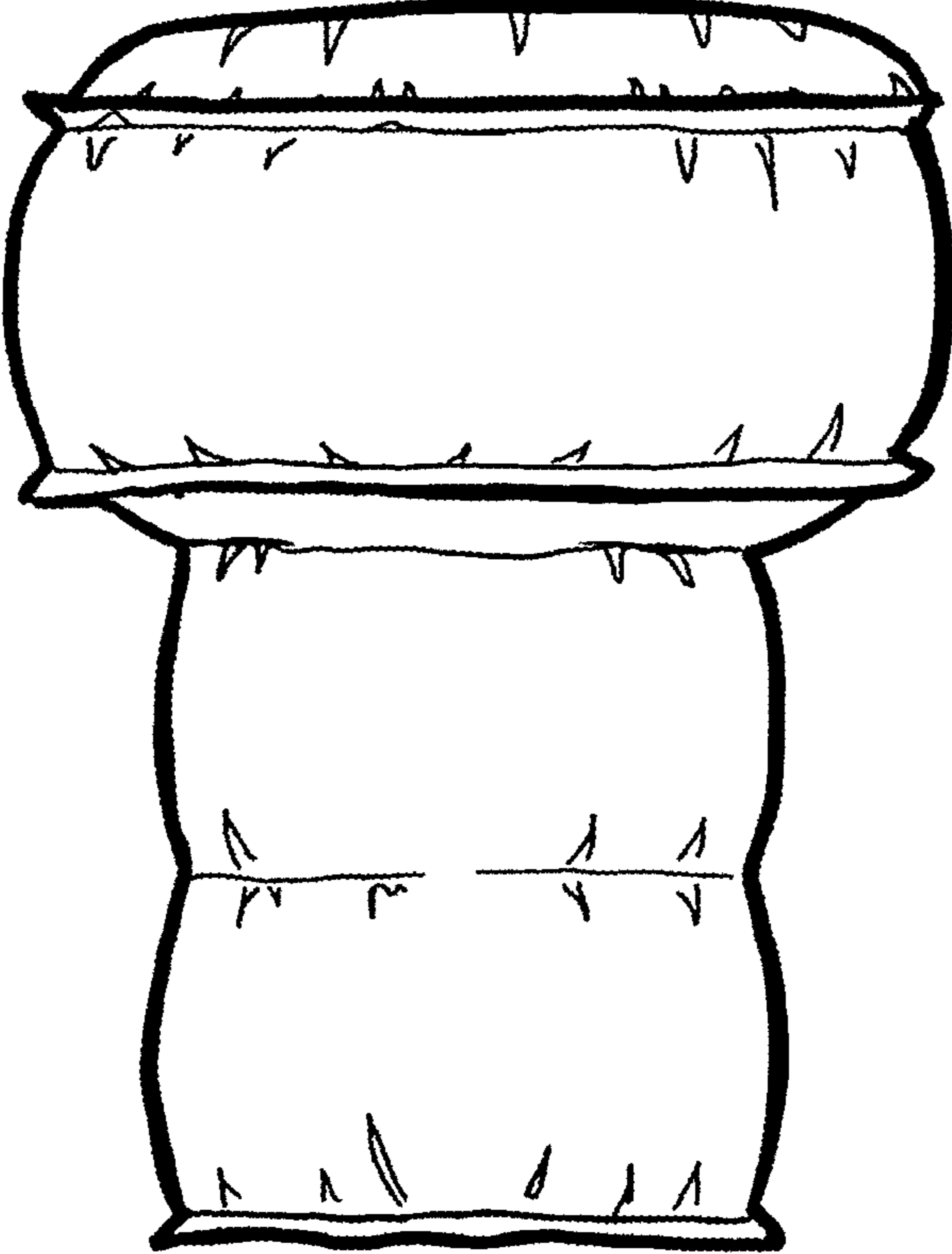

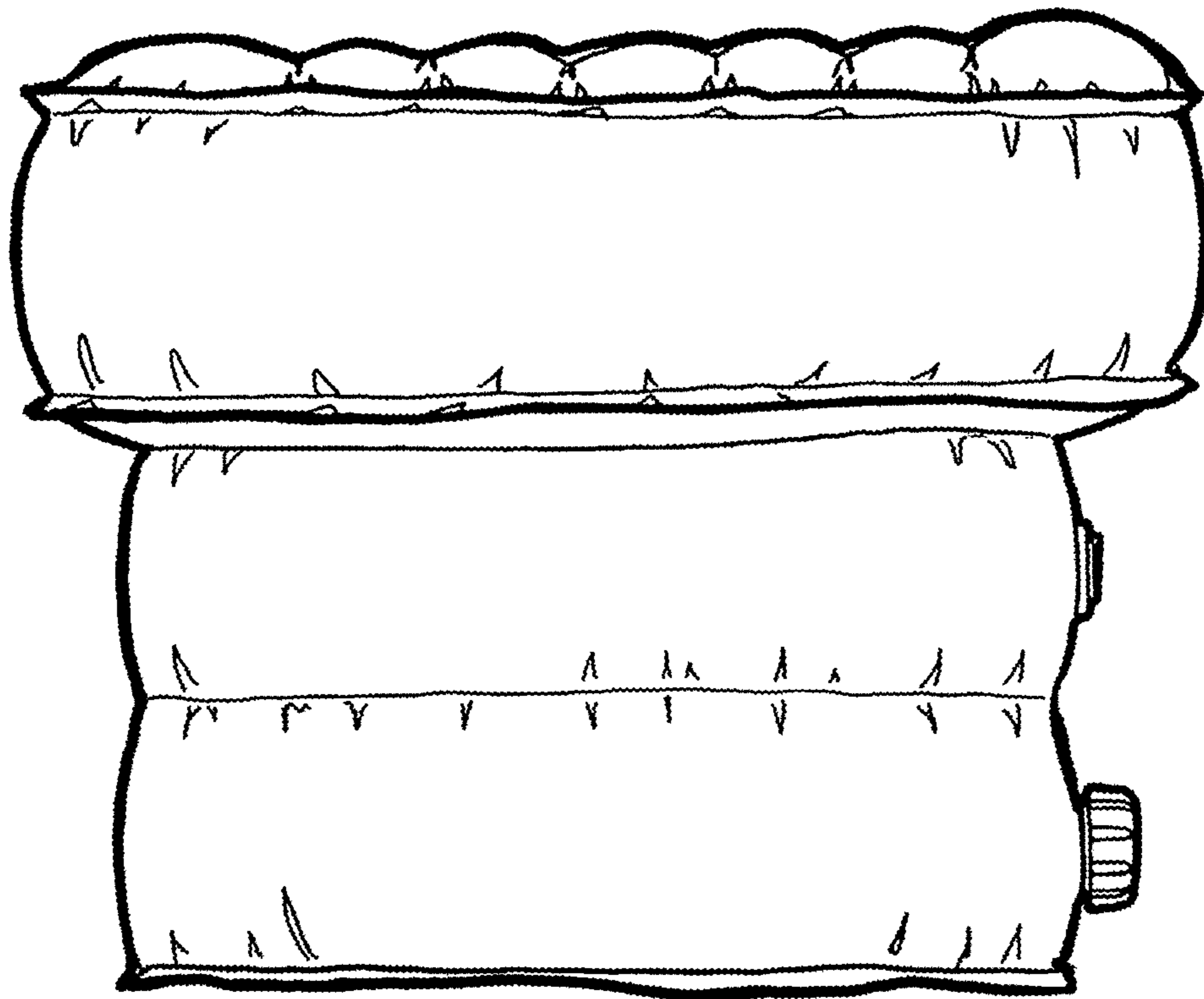

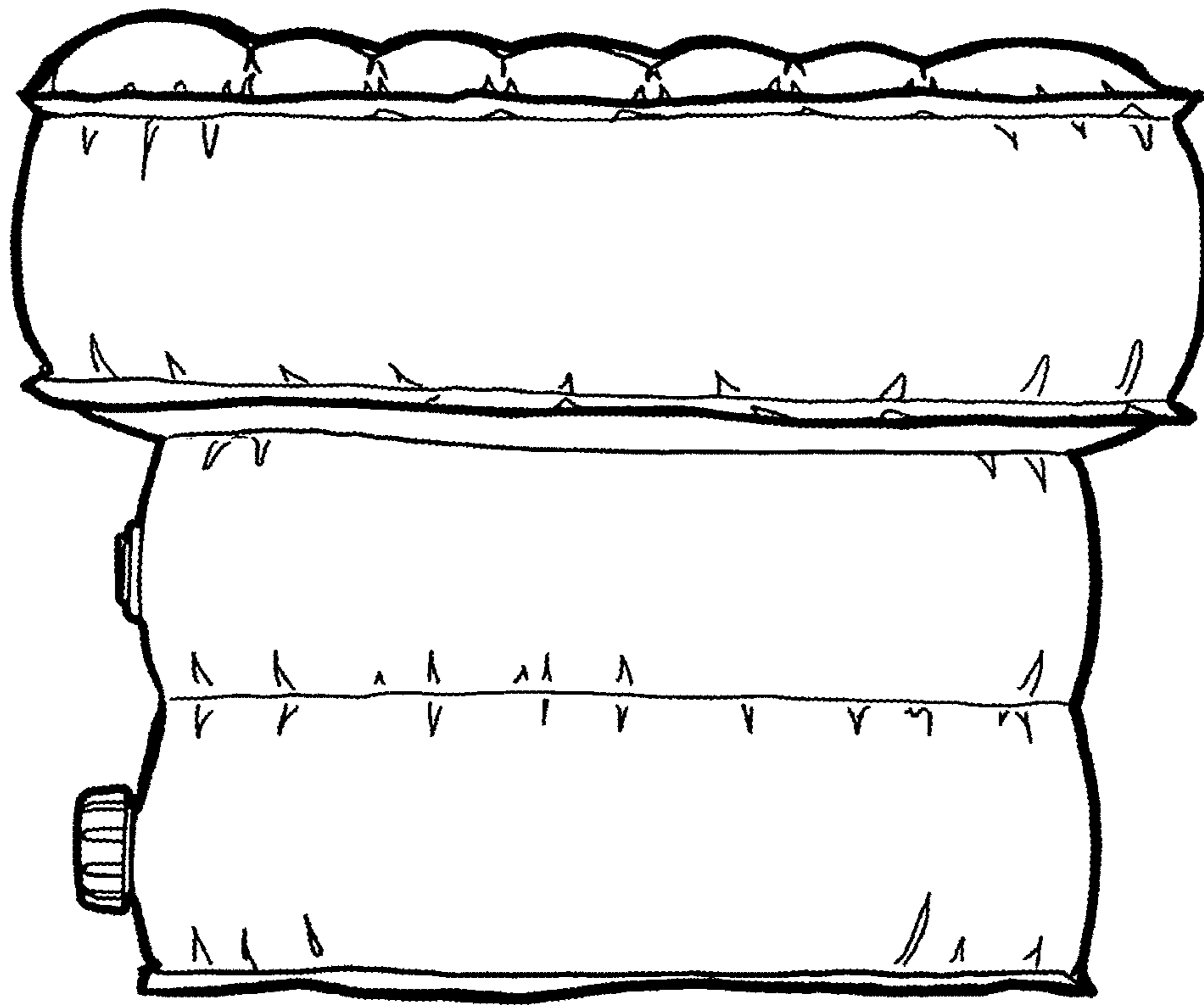

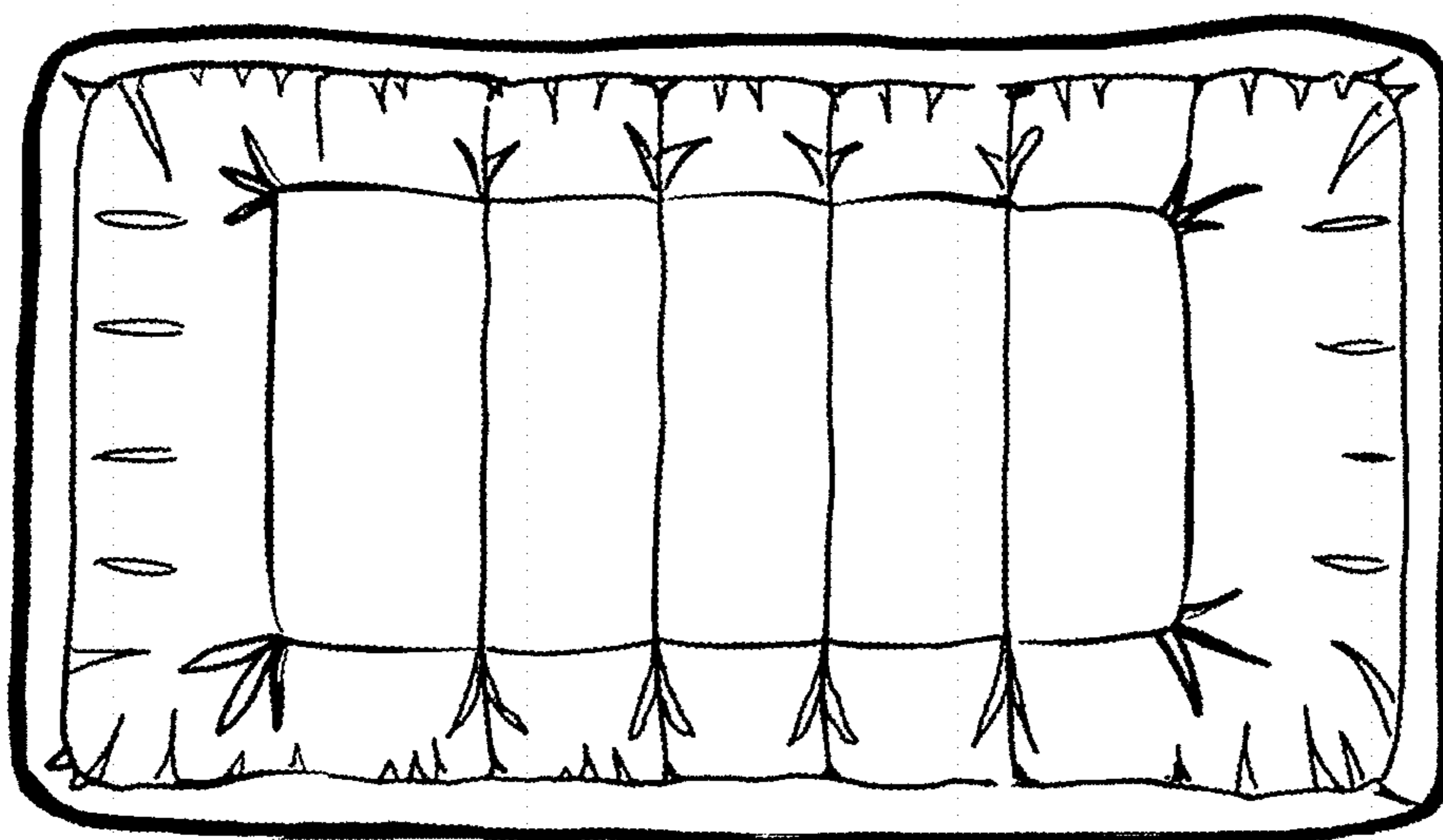
