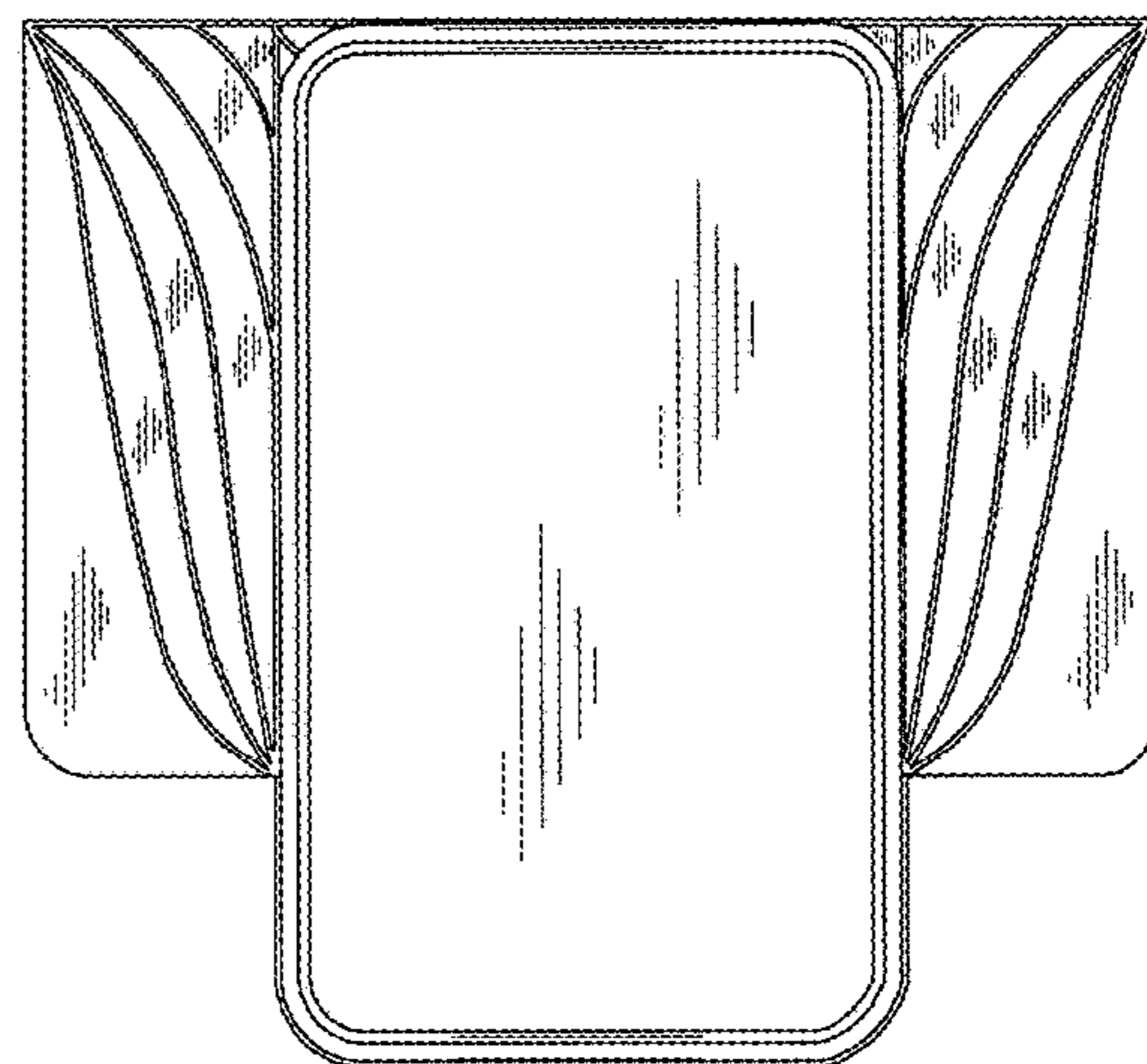
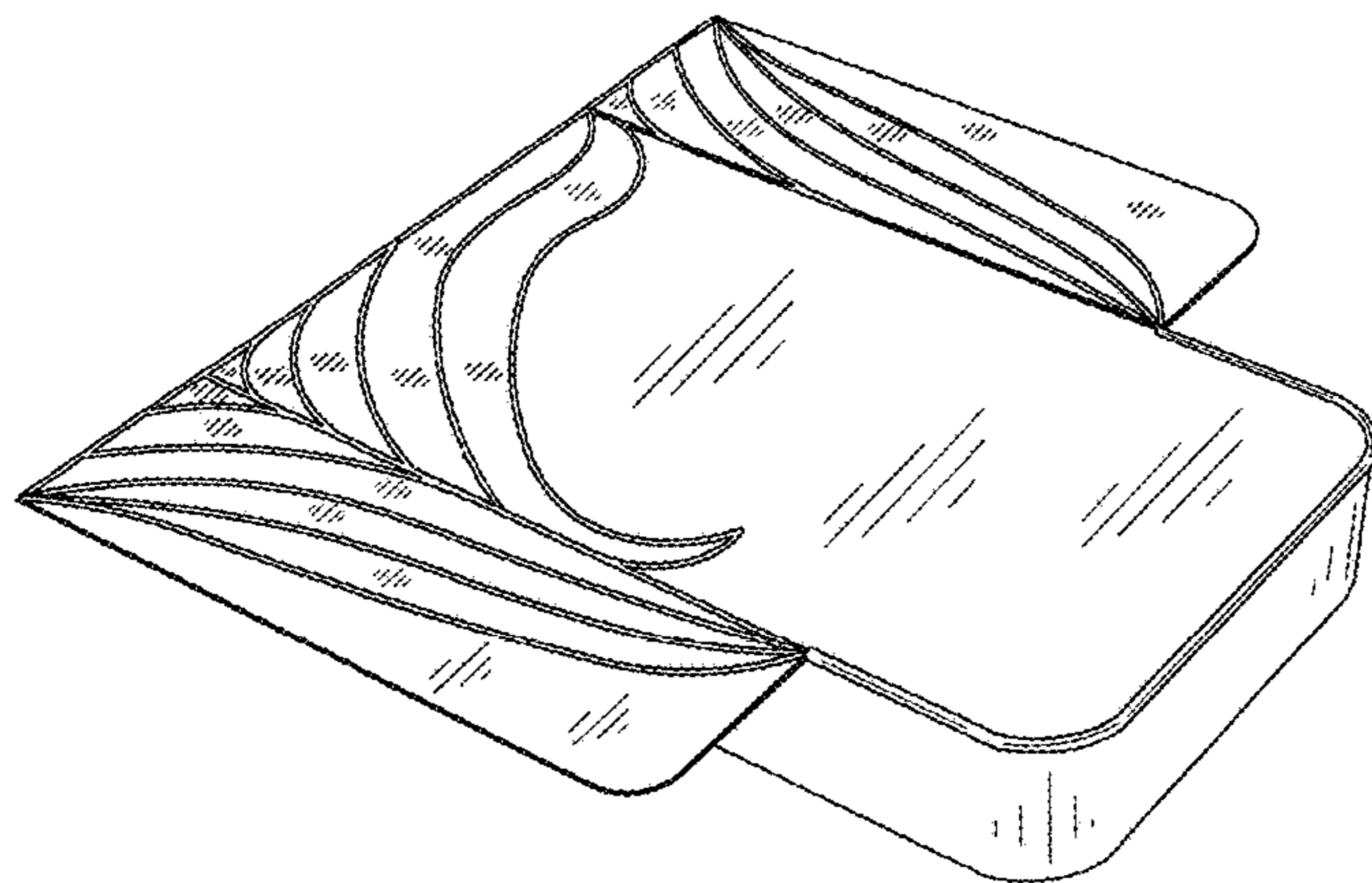
(57) **CLAIM**

The ornamental design for an attached top and bottom sheet set, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an attached top and bottom sheet set with the two opposed wing-like portions of the top sheet in an extended position, showing my new design.  
FIG. 2 is a top view thereof.  
FIG. 3 is a bottom view thereof.  
FIG. 4 is a right side elevational view thereof.  
FIG. 5 is a left side elevational view thereof.  
FIG. 6 is a front elevational view thereof; and,

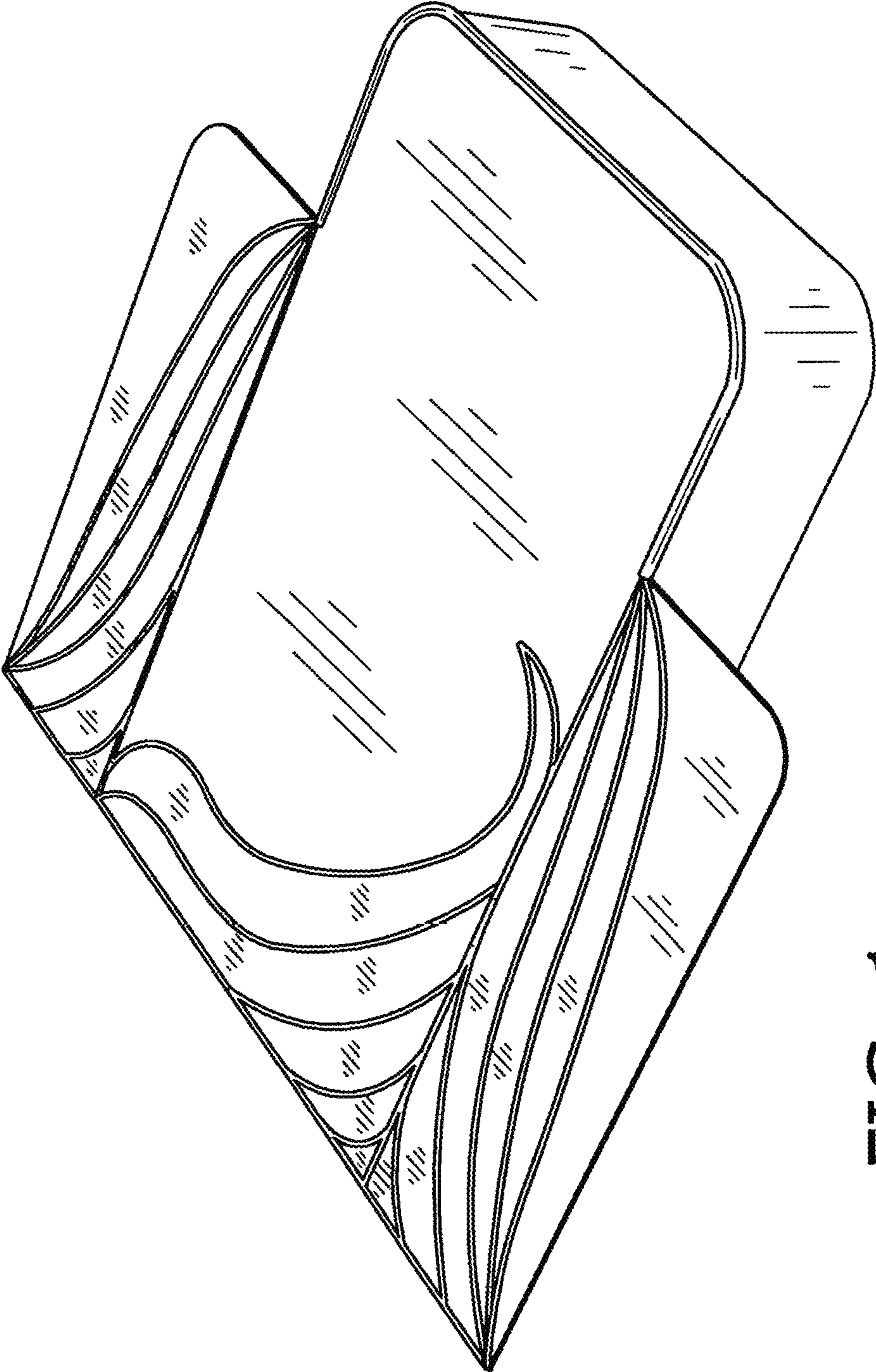

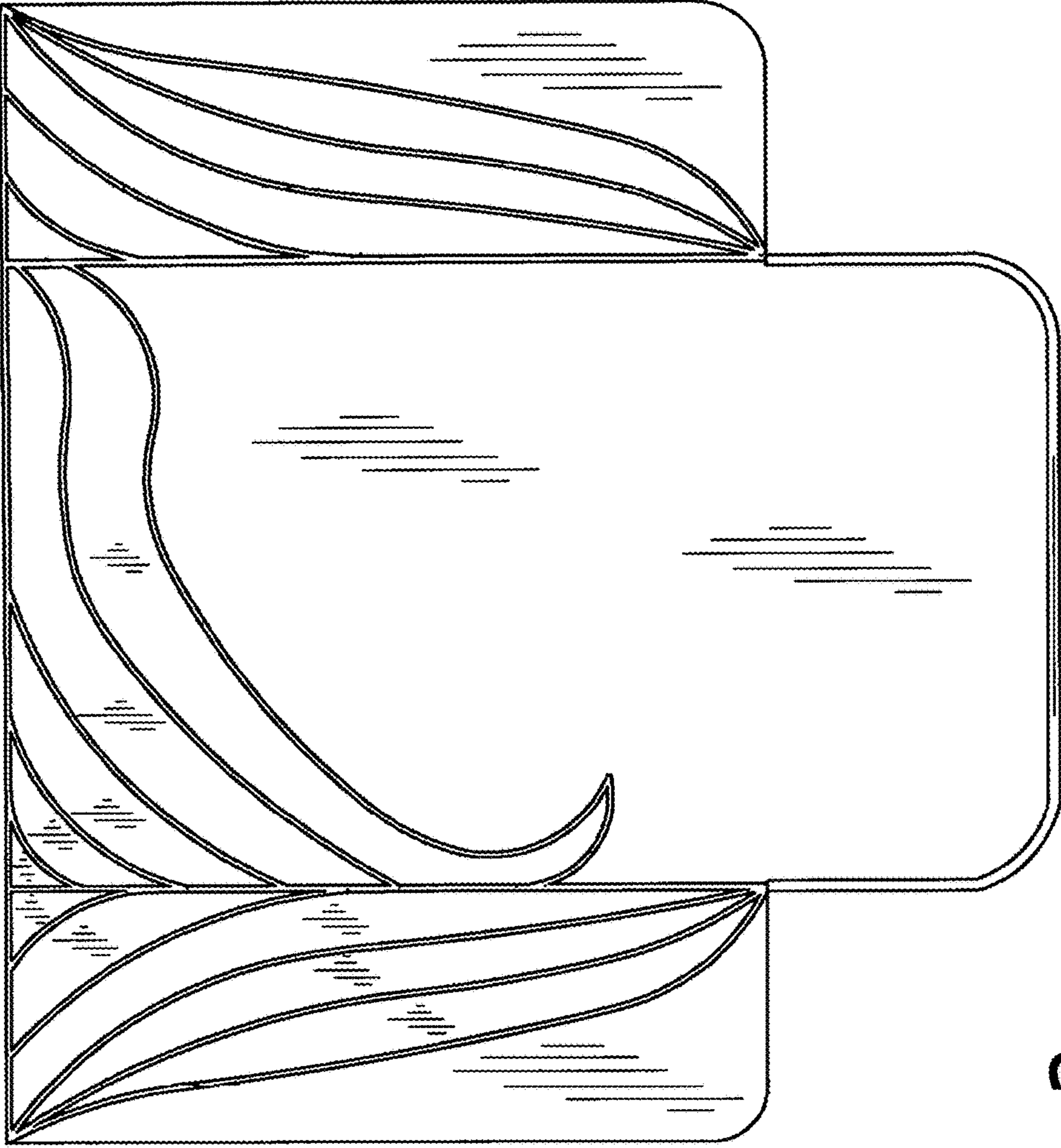

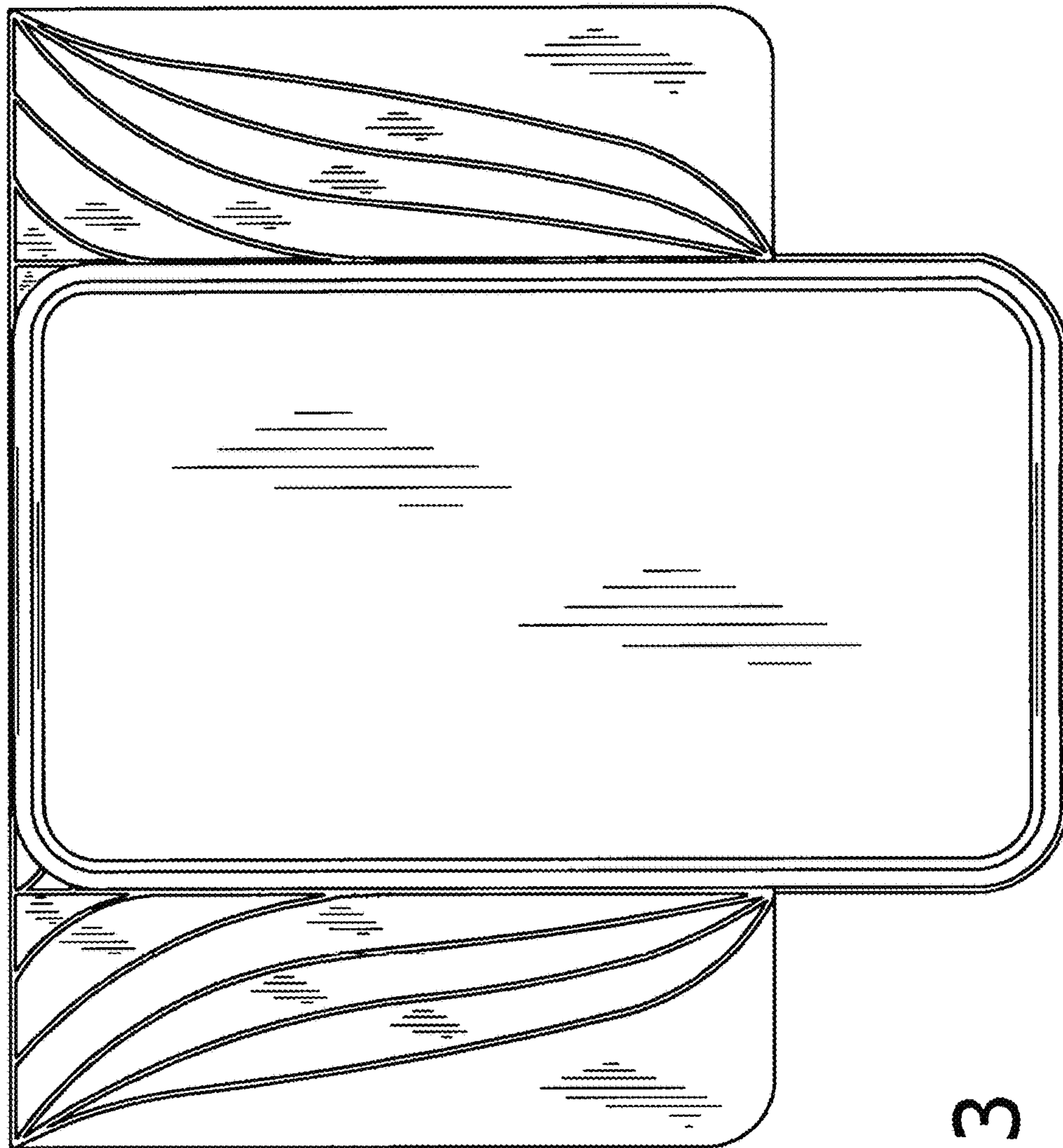

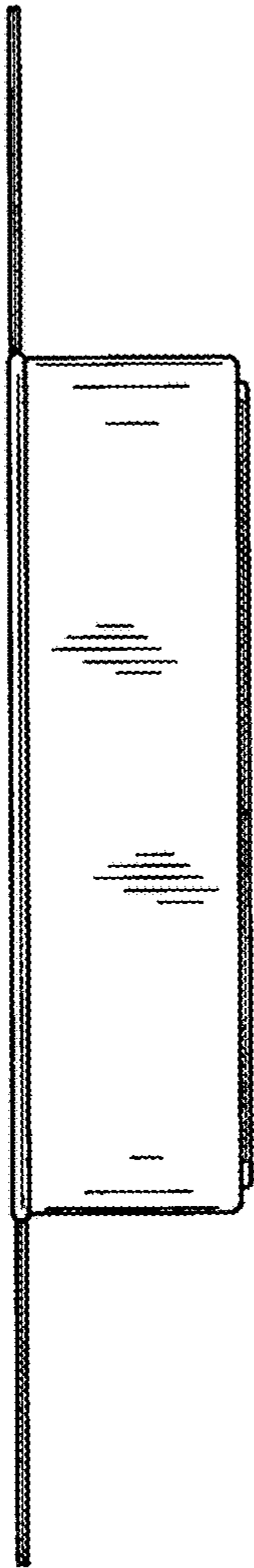

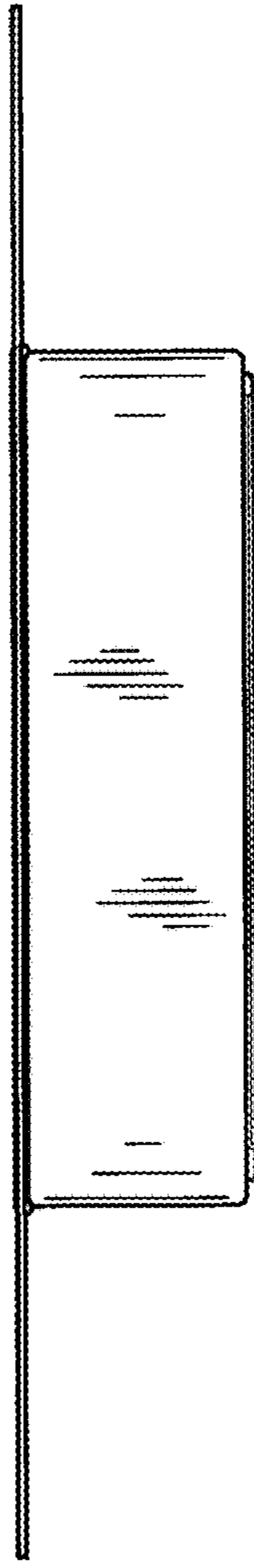

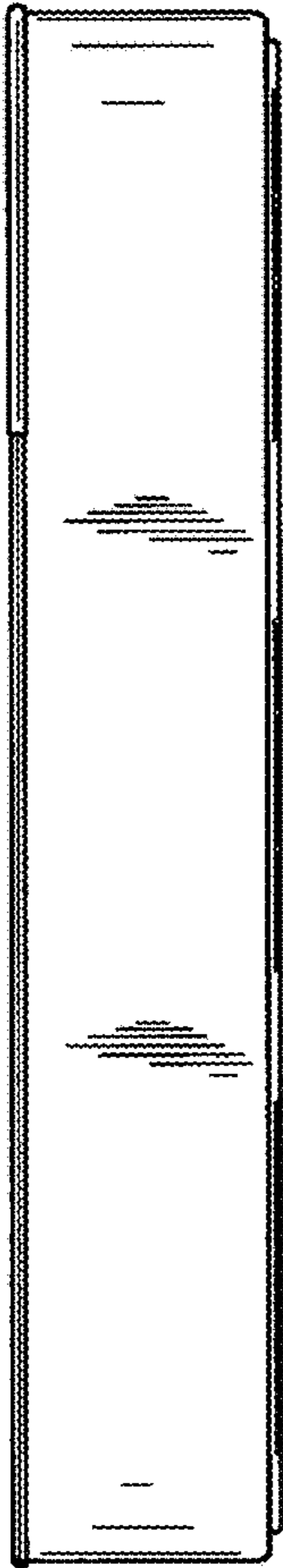

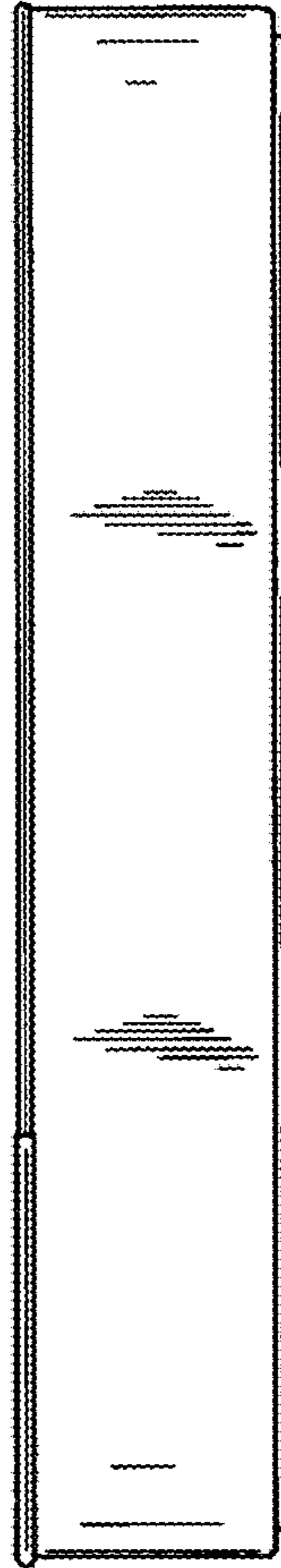
