(57) **CLAIM**

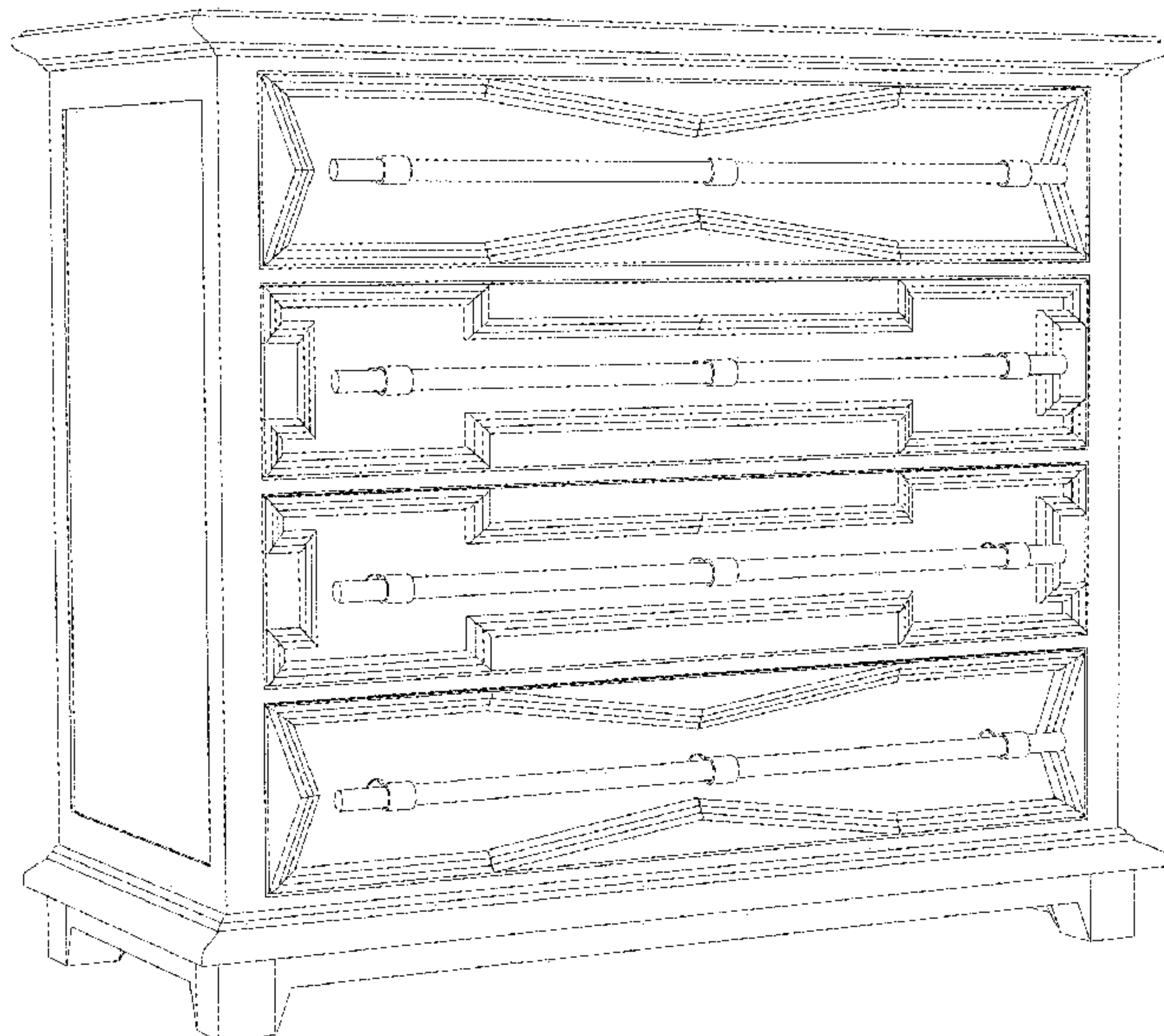
The ornamental design for a chest, substantially as shown and described.

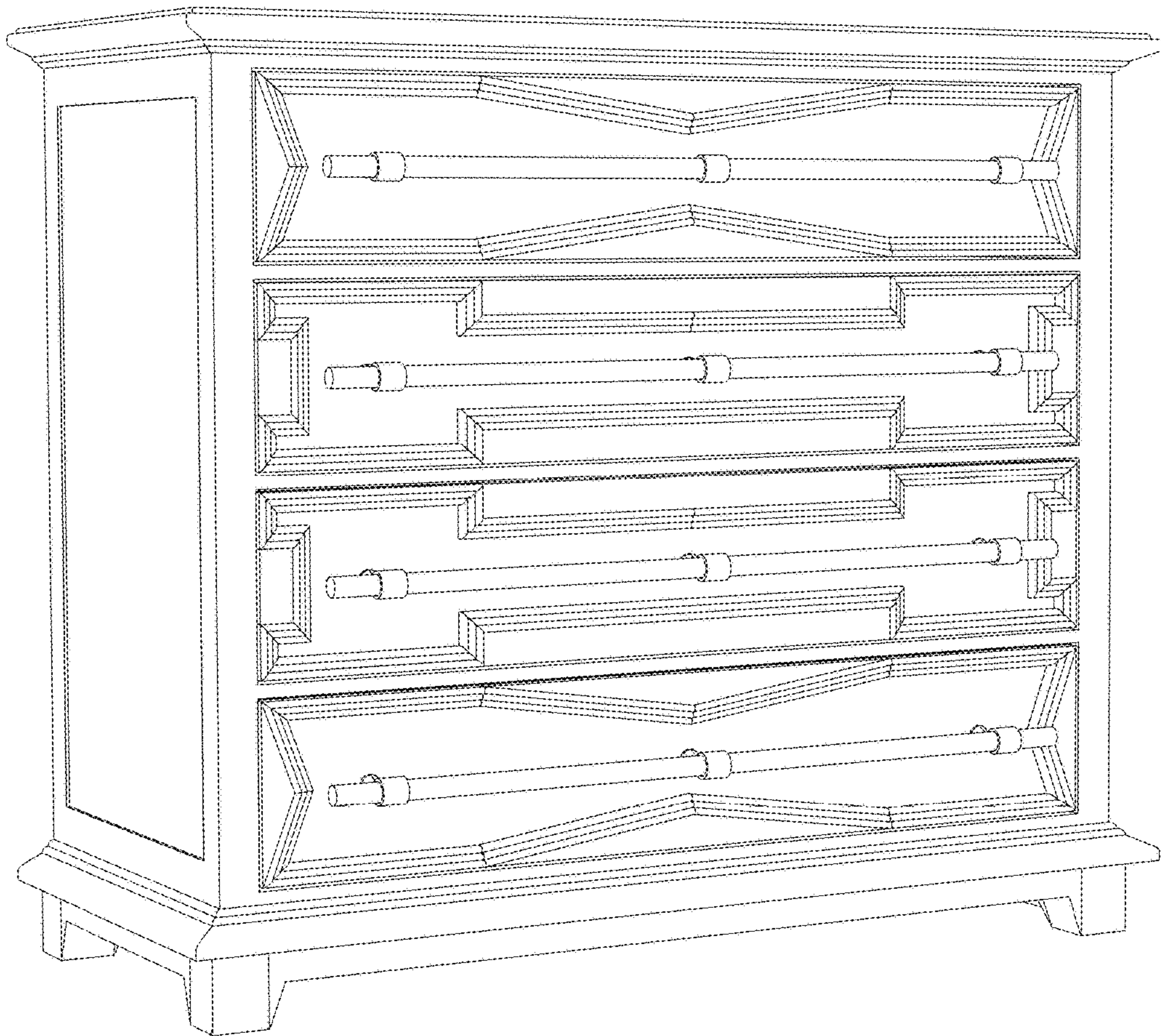

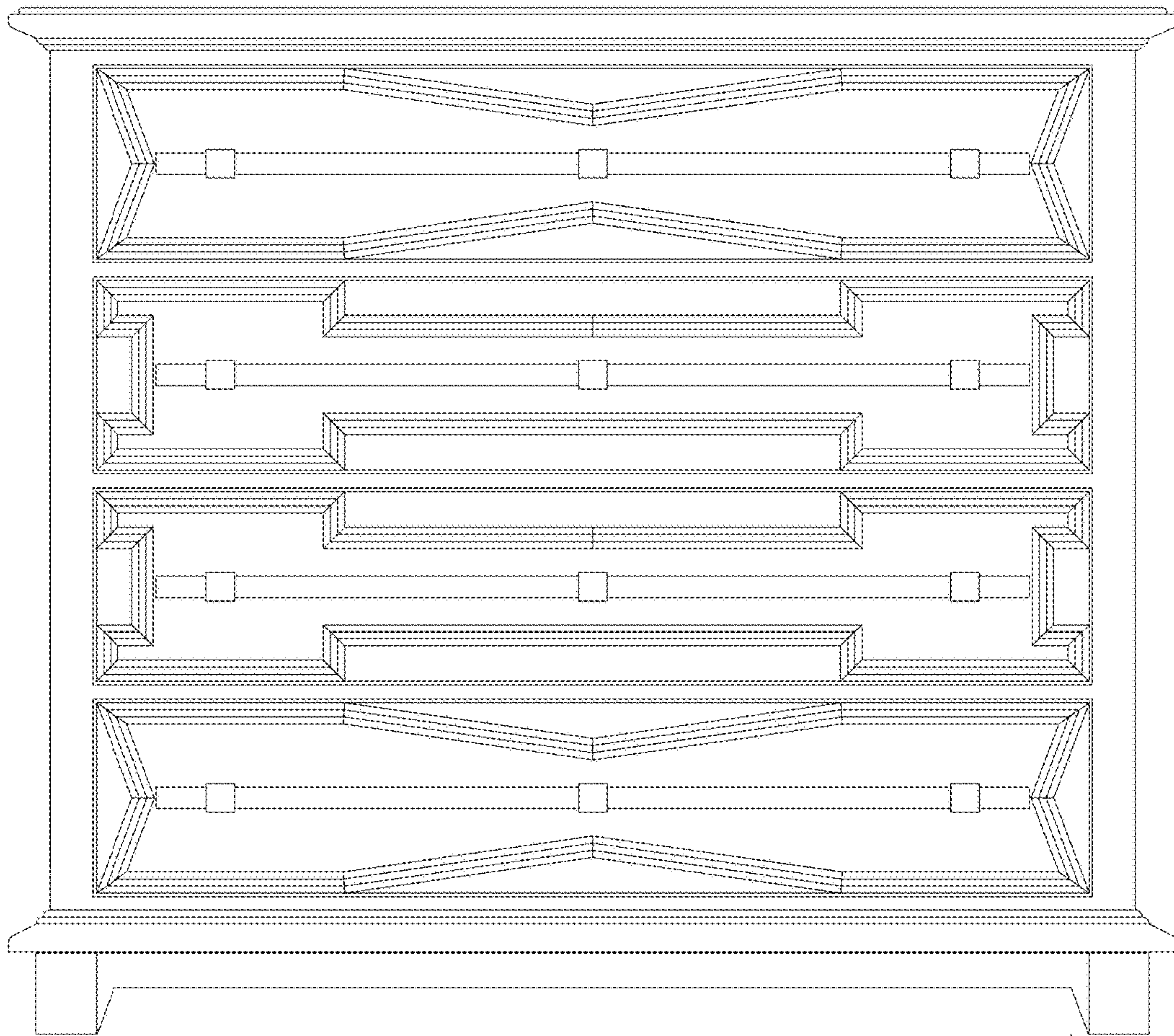

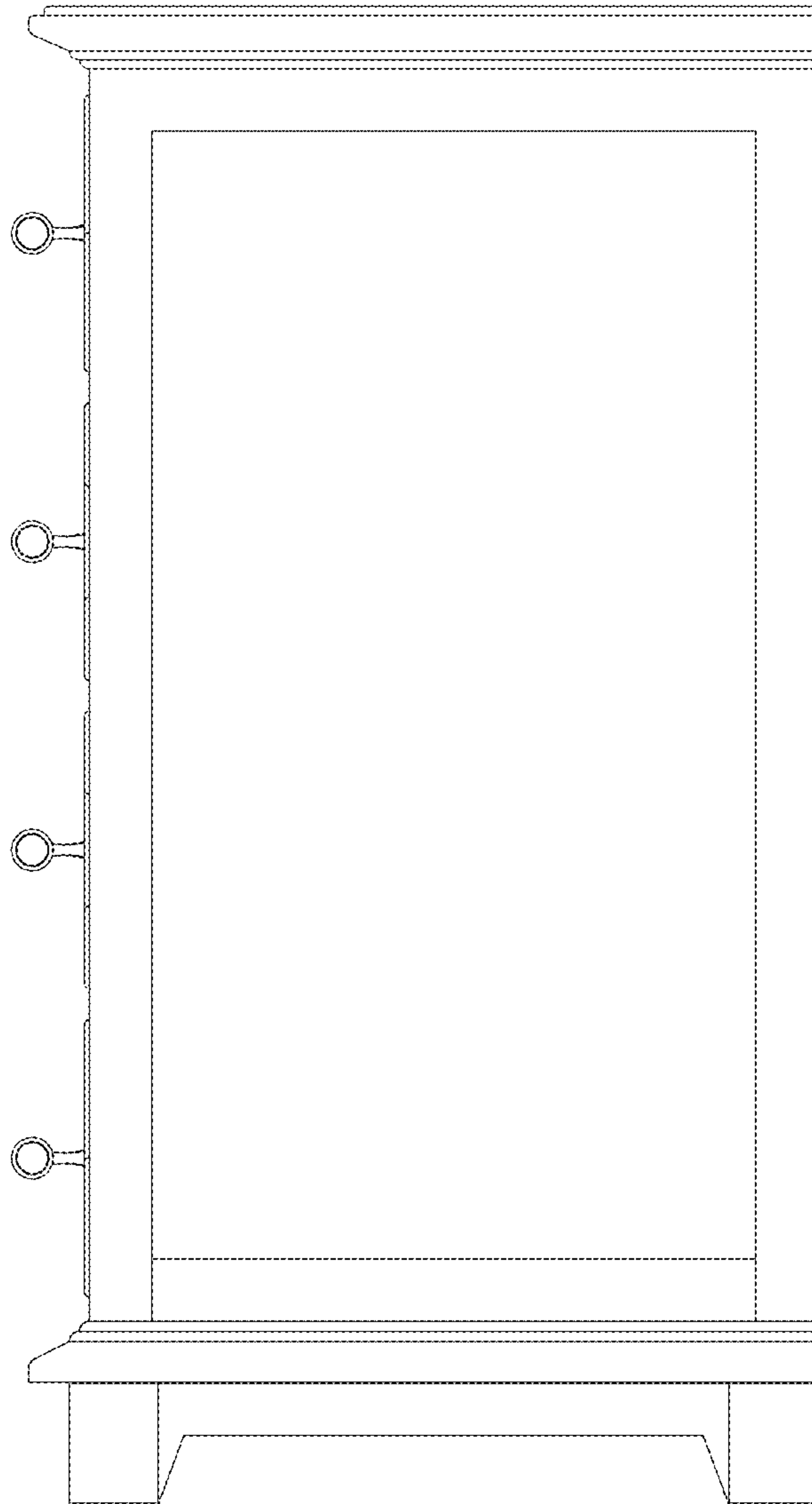

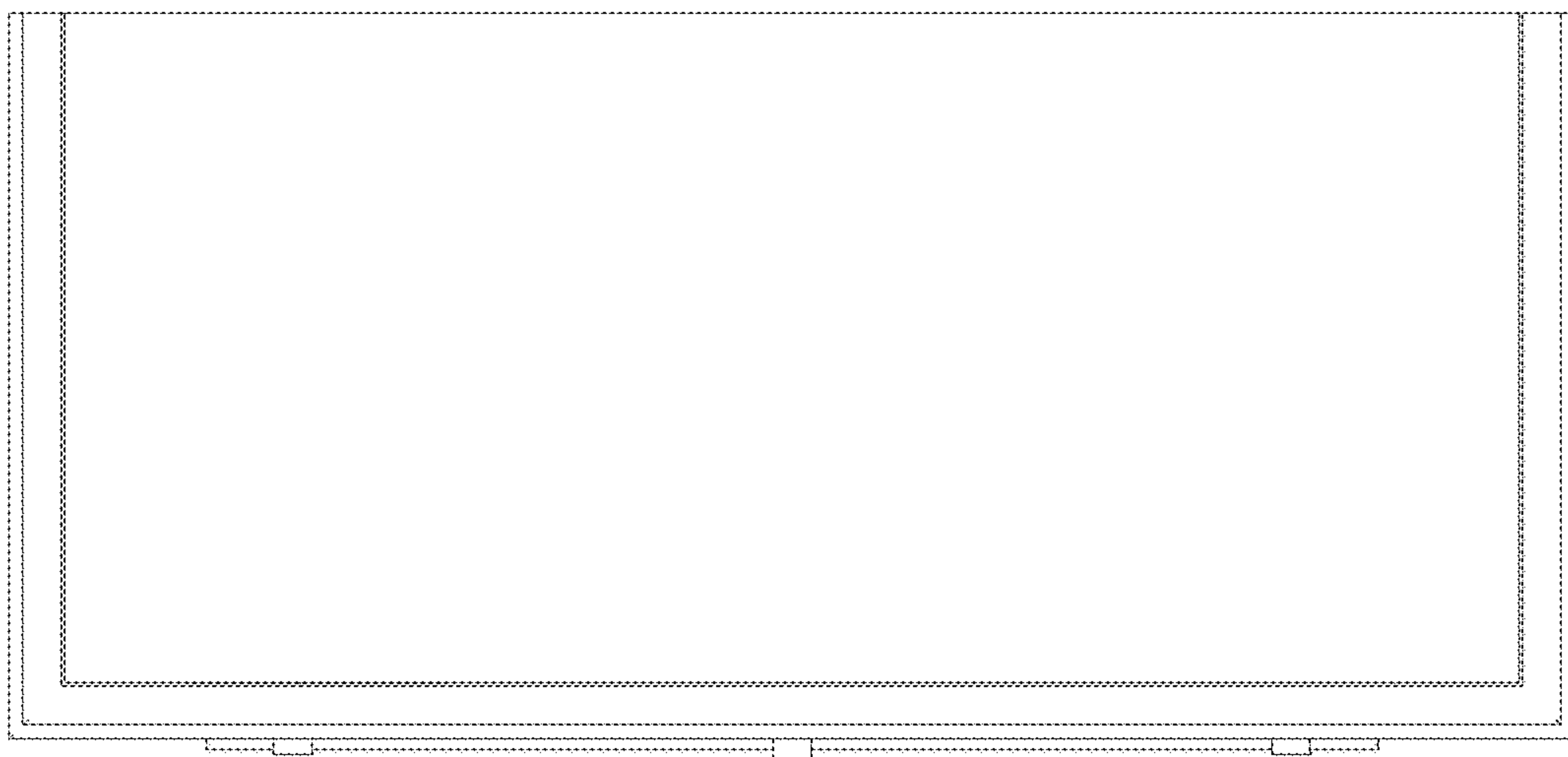
