The ornamental design for a decorative table top, as shown and described.

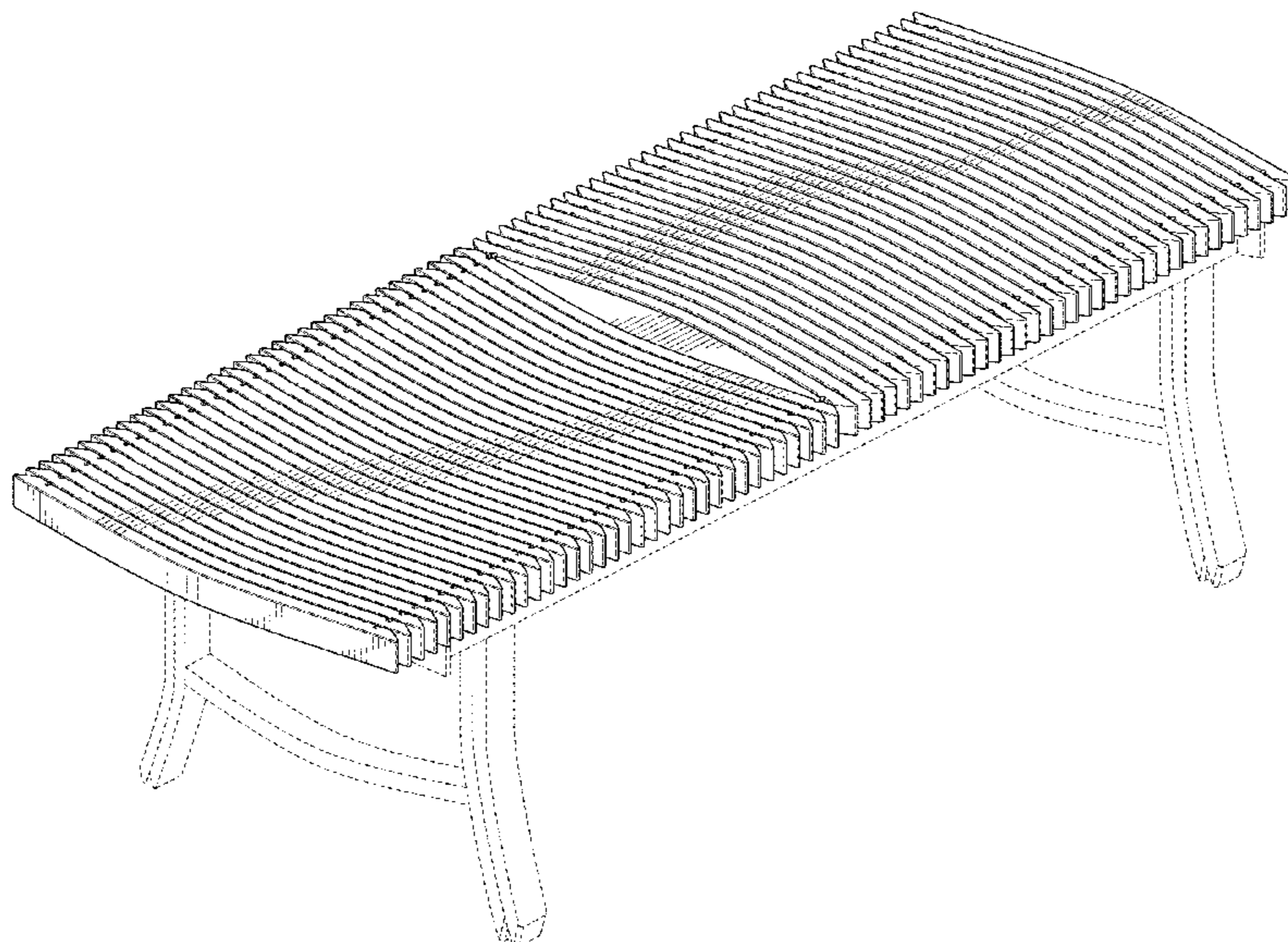
**DESCRIPTION**

FIG. 1 is a perspective view of a first embodiment of the decorative table top; showing my new design; FIG. 2 is a right side elevation view thereof; FIG. 3 is a left side elevation view thereof; FIG. 4 is a front side elevation view thereof; FIG. 5 is a rear side elevation view thereof; FIG. 6 is a top plan view thereof; FIG. 7 is a bottom plan view thereof; FIG. 8 is a perspective view of a second embodiment of the decorative table top; showing my new design; FIG. 9 is a right side elevation view thereof; FIG. 10 is a left side elevation view thereof; FIG. 11 is a front side elevation view thereof; FIG. 12 is a rear side elevation view thereof; FIG. 13 is a top plan view thereof; and, FIG. 14 is a bottom plan view thereof.

The broken lines in FIGS. 1-5, 7-12 and 14 are for illustrative purposes only, depicting the environment of the new design, forming no part thereof as claimed.

The table top is shown in FIGS. 8-14 with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

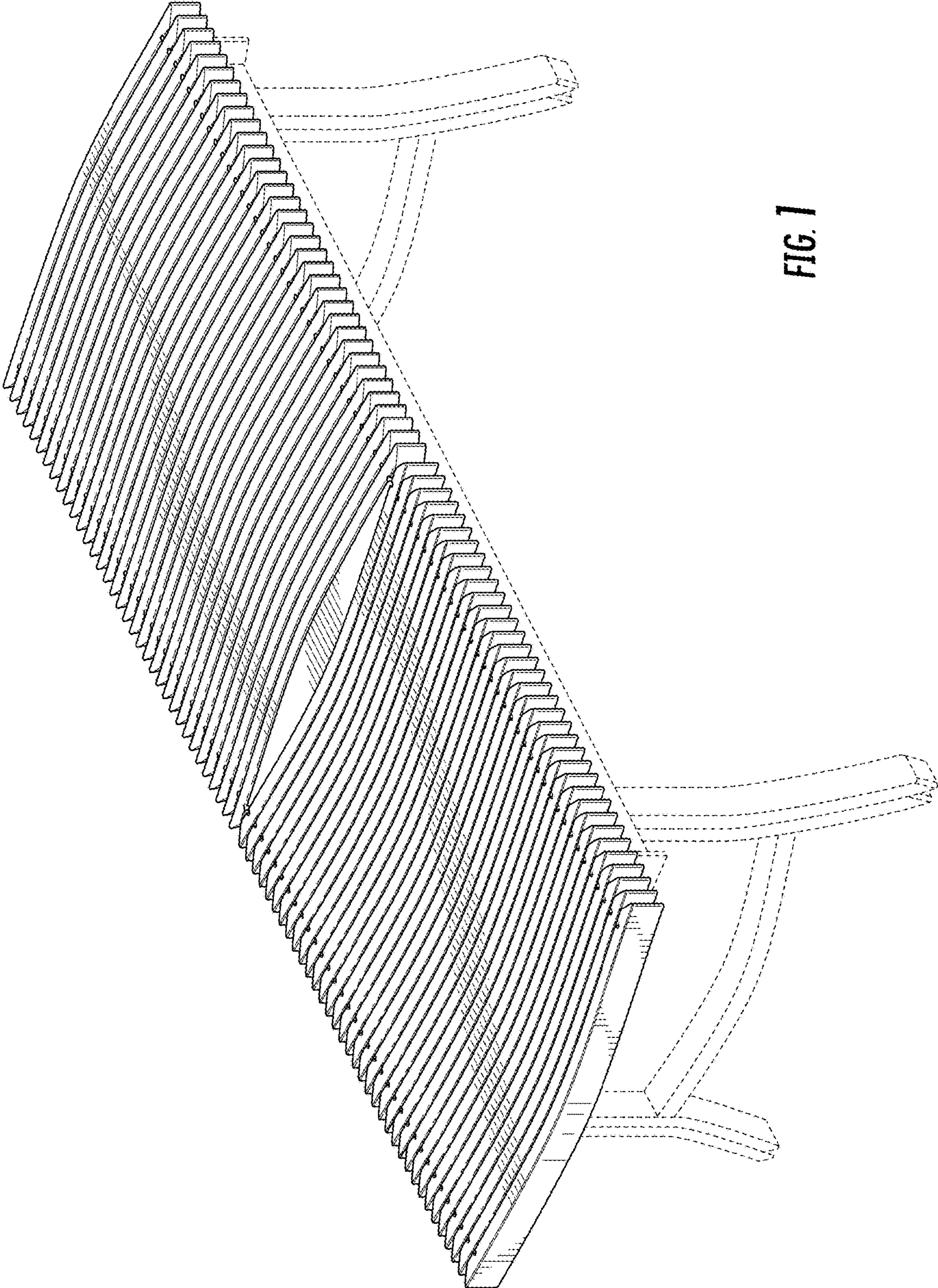
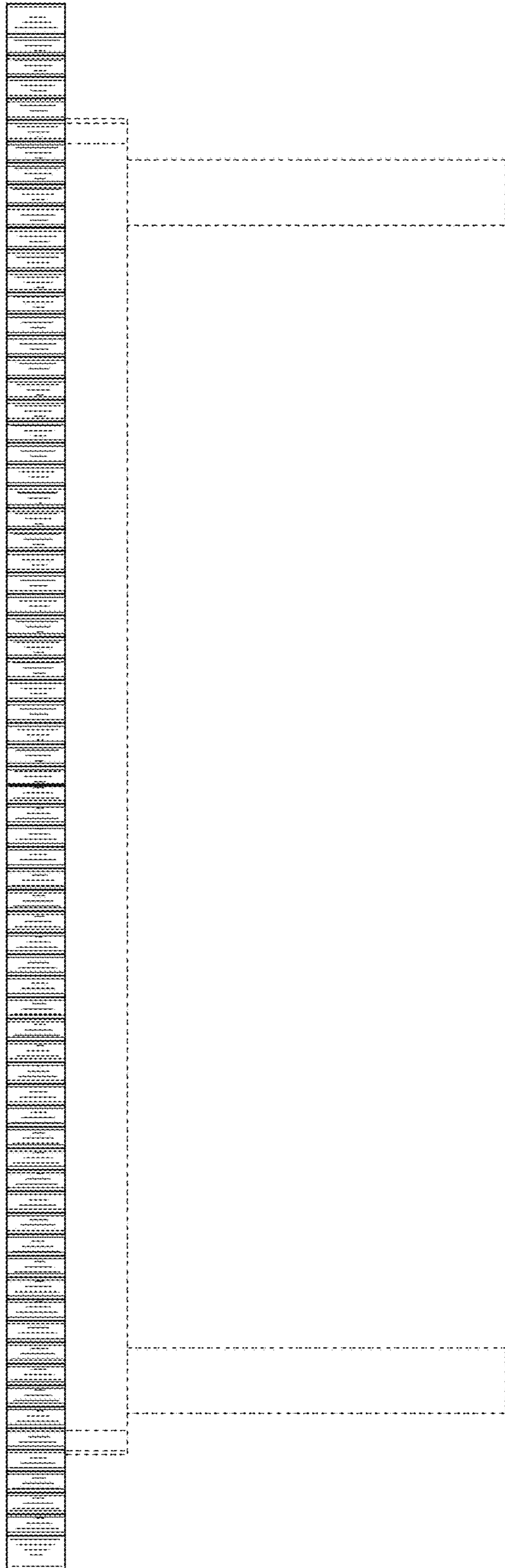

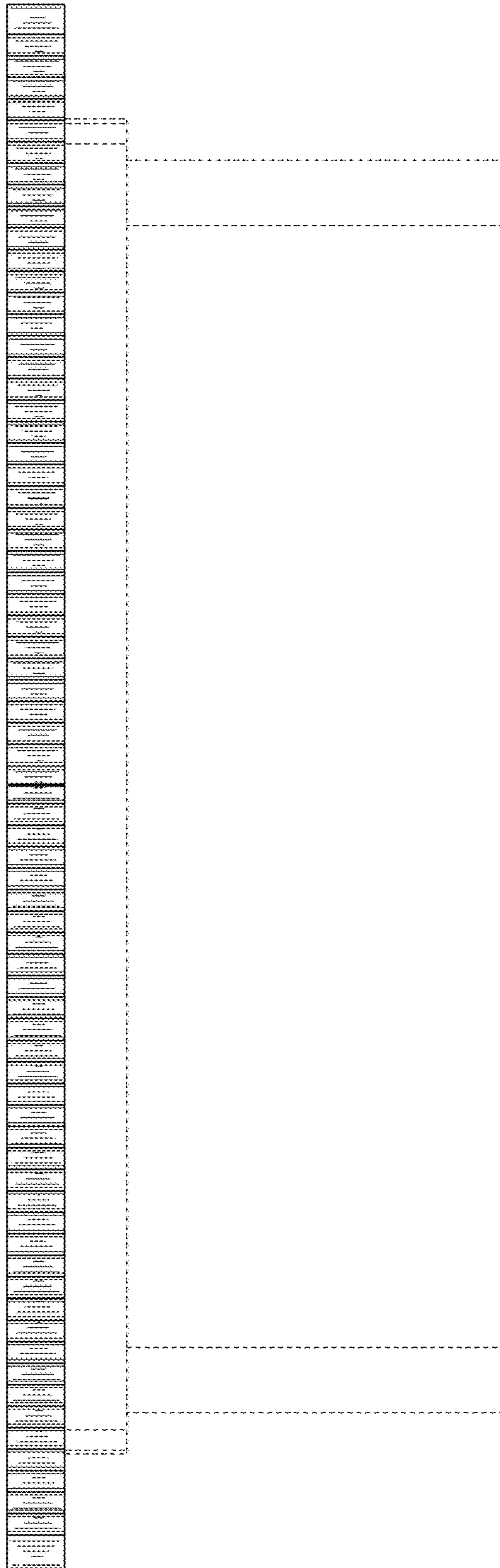
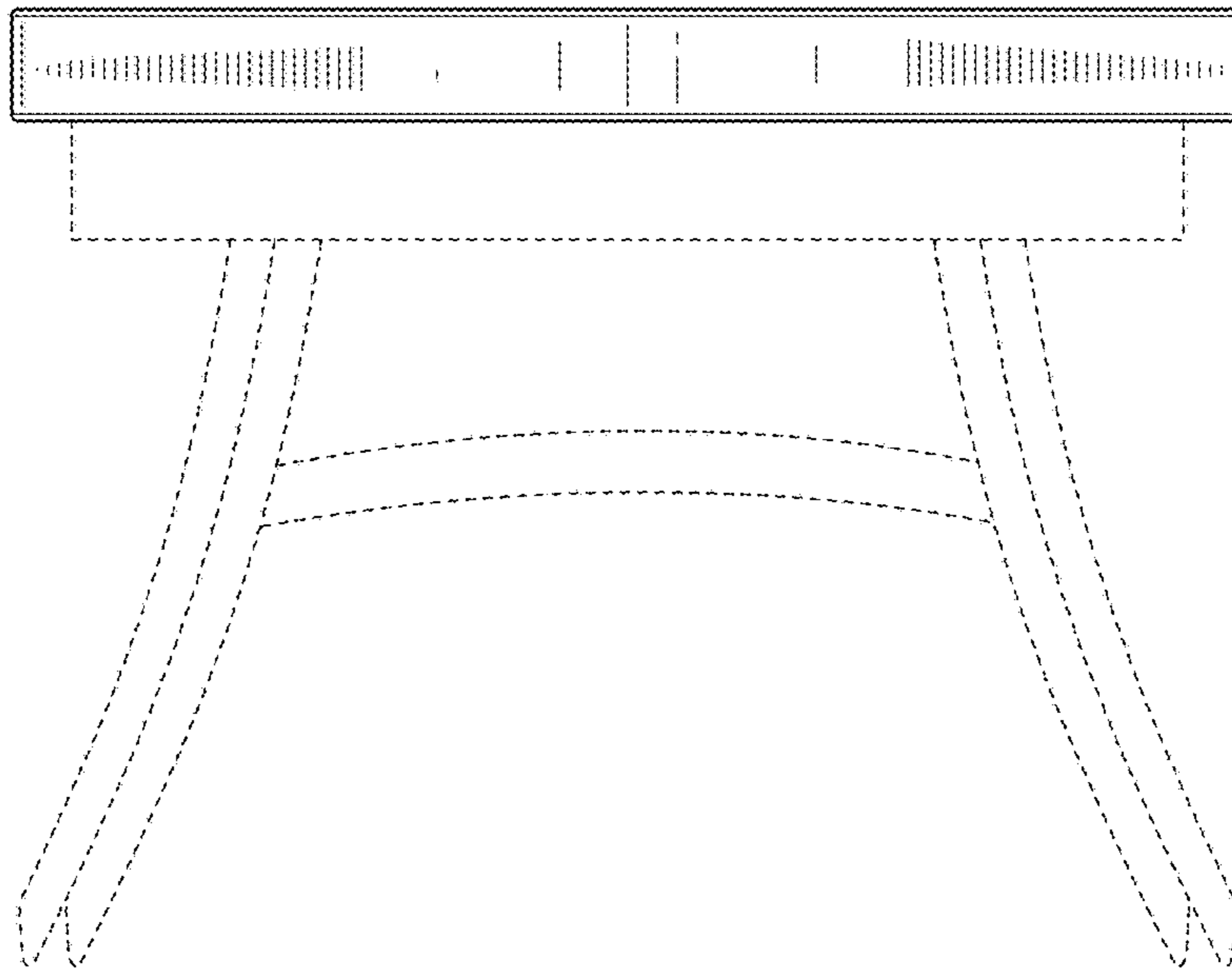
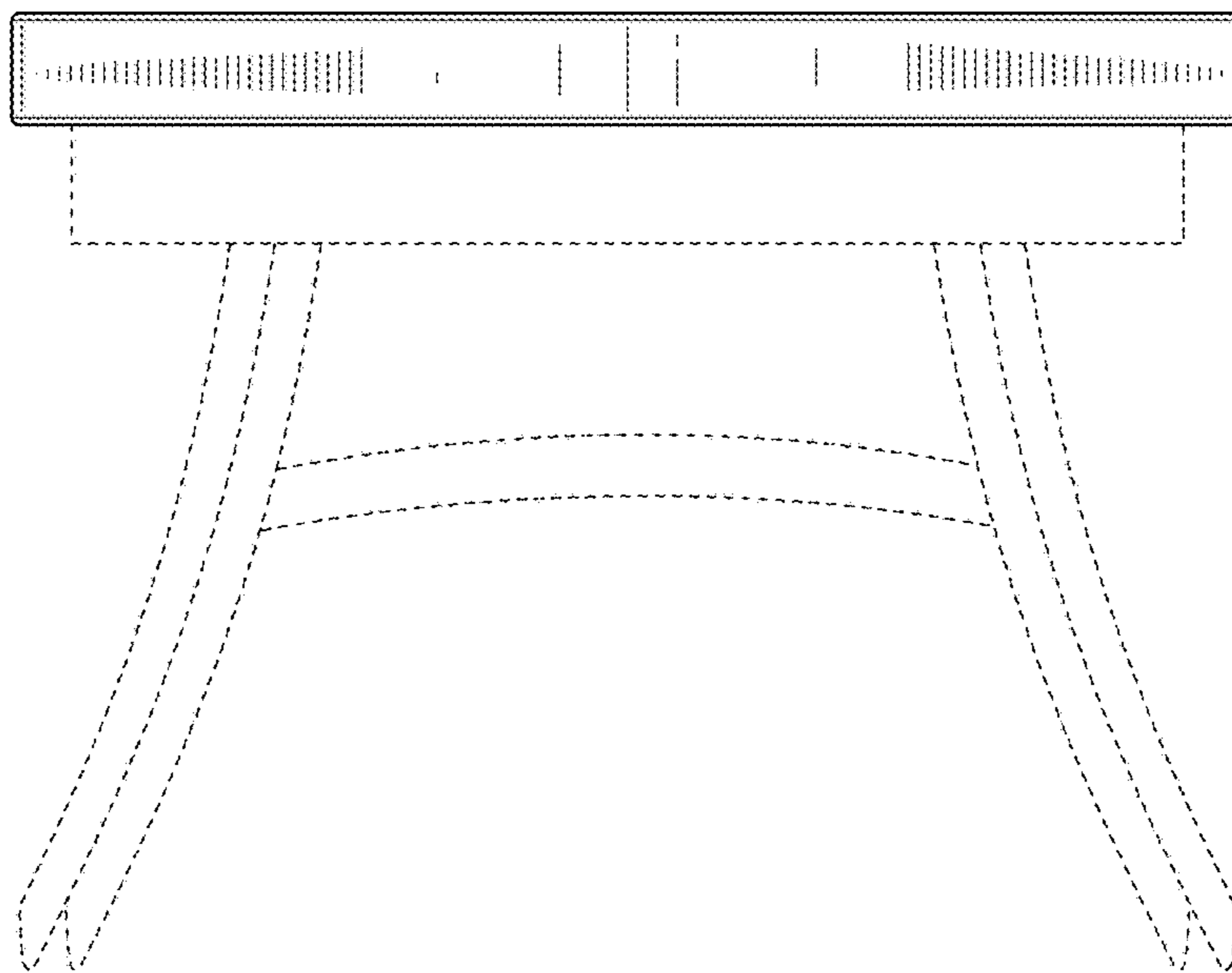

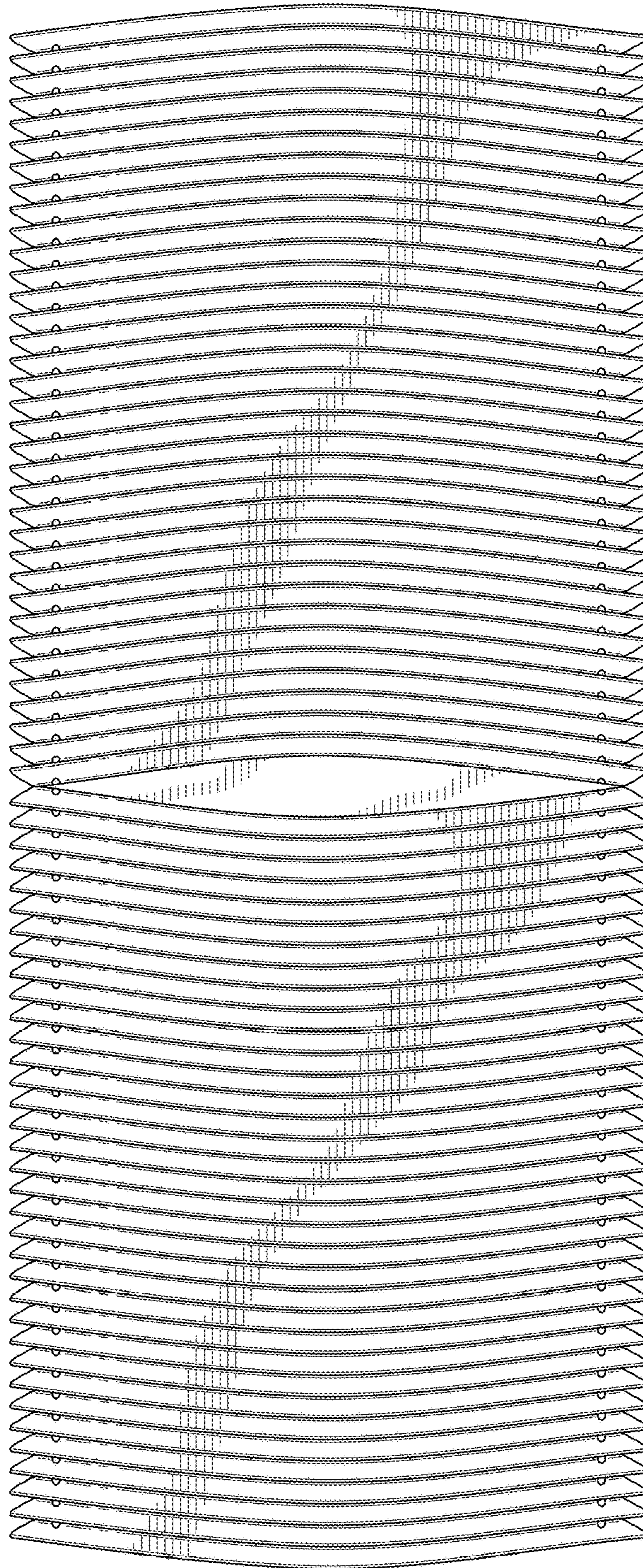

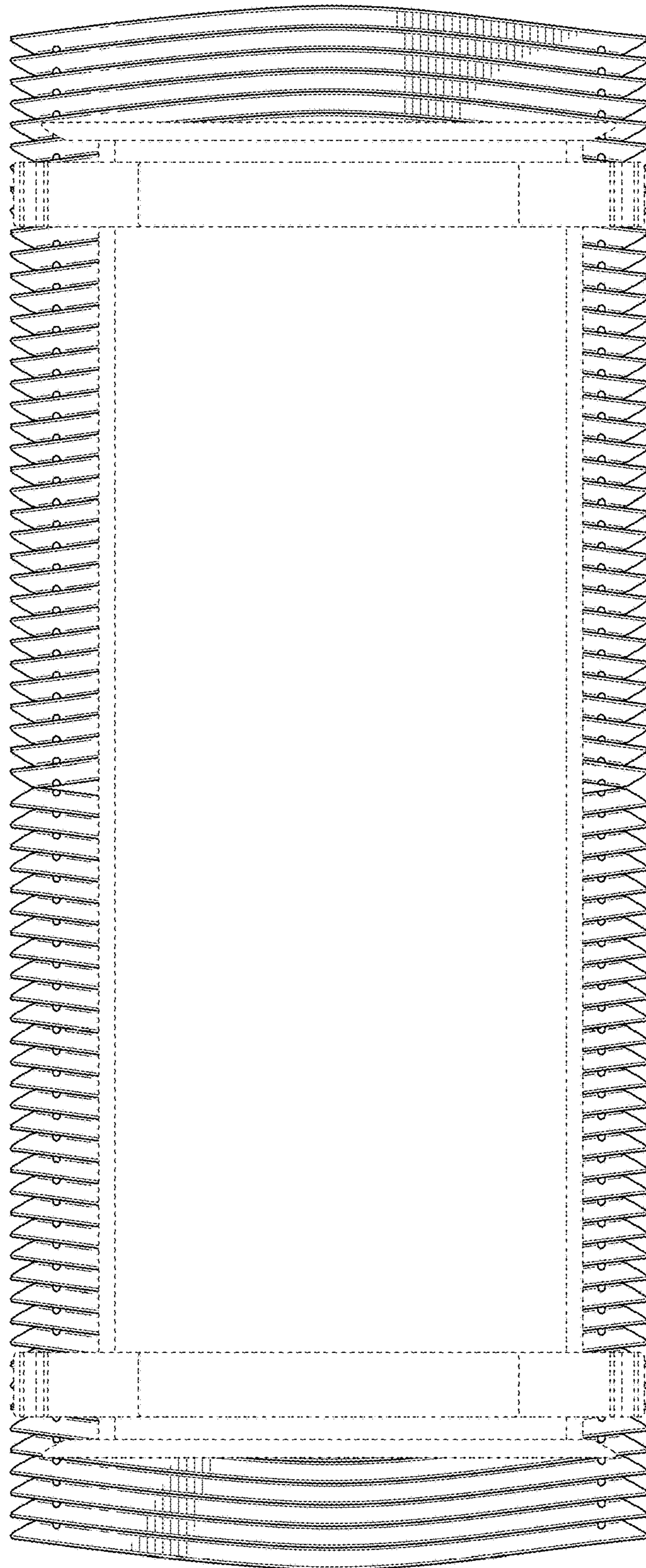

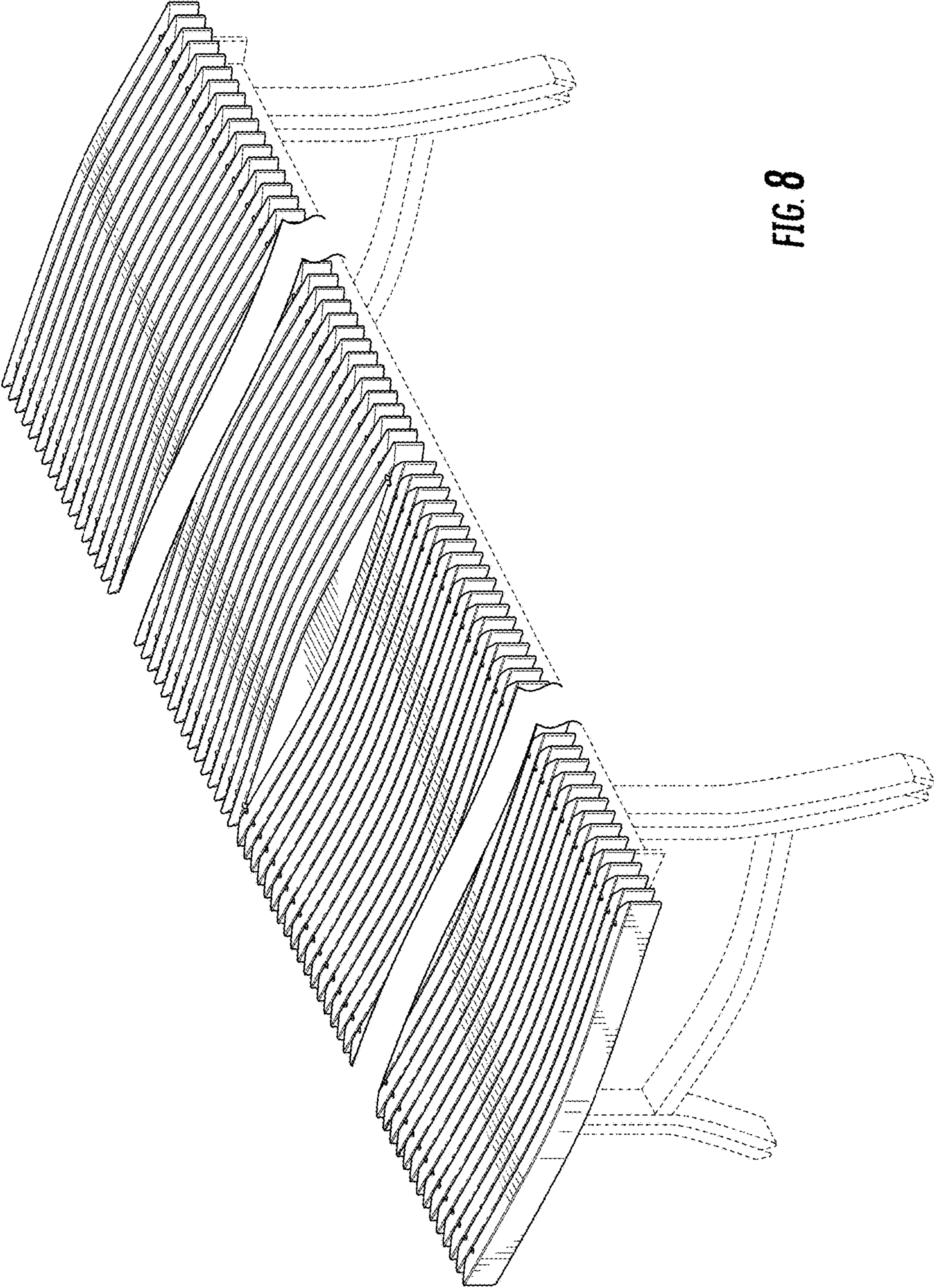

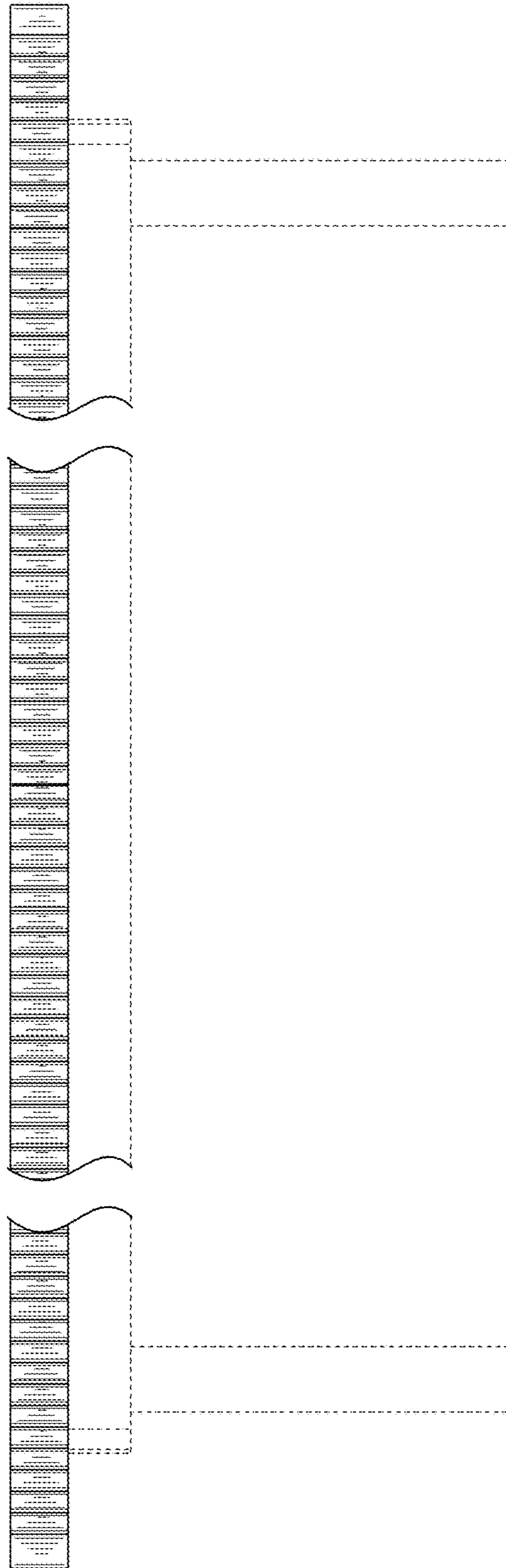

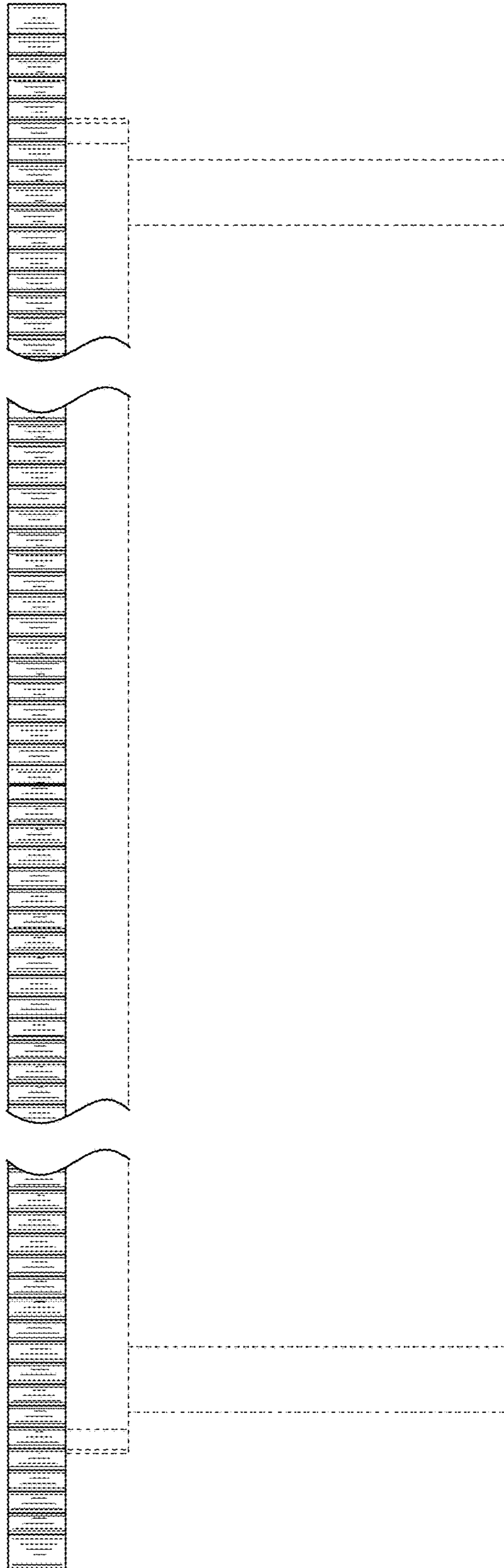
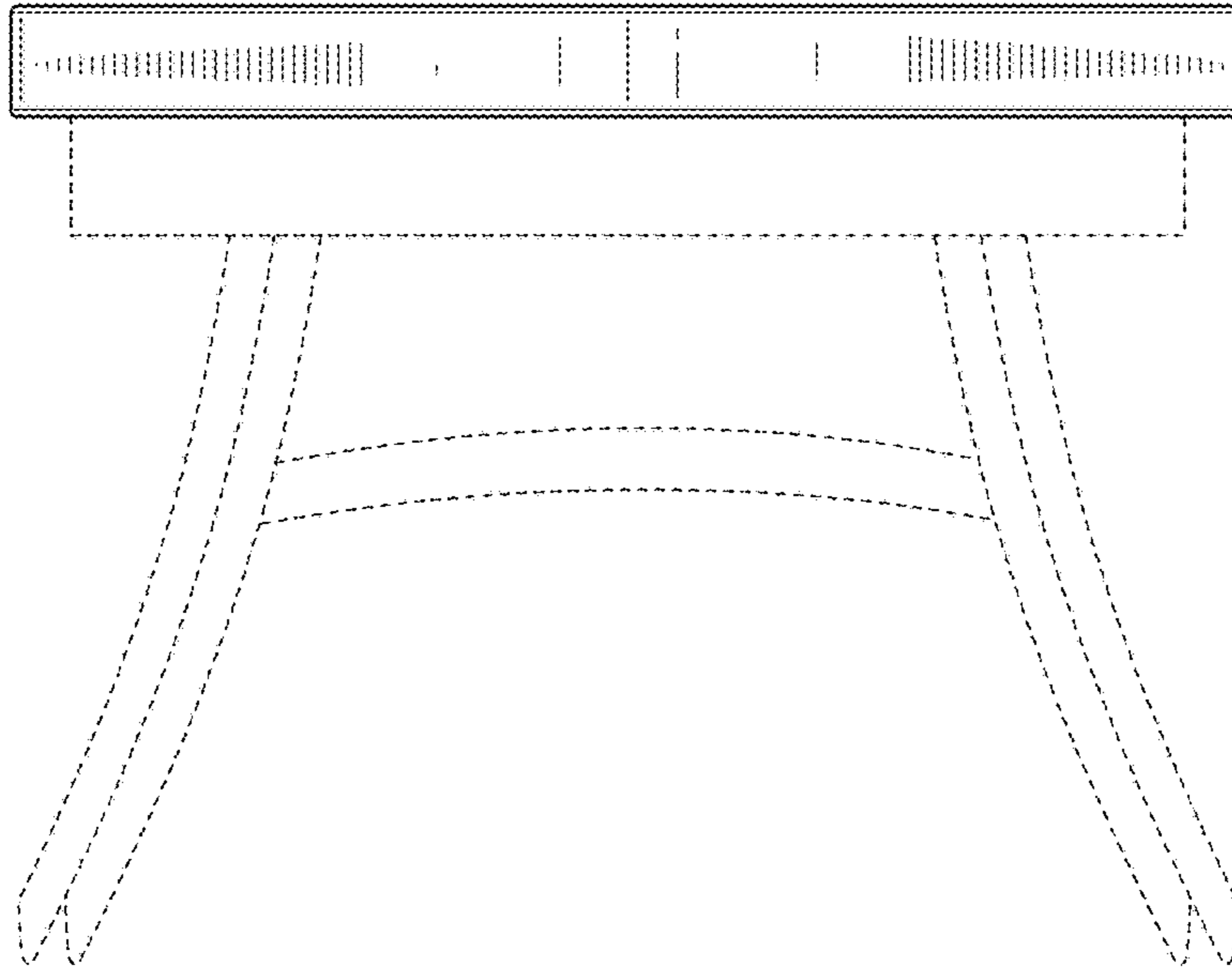
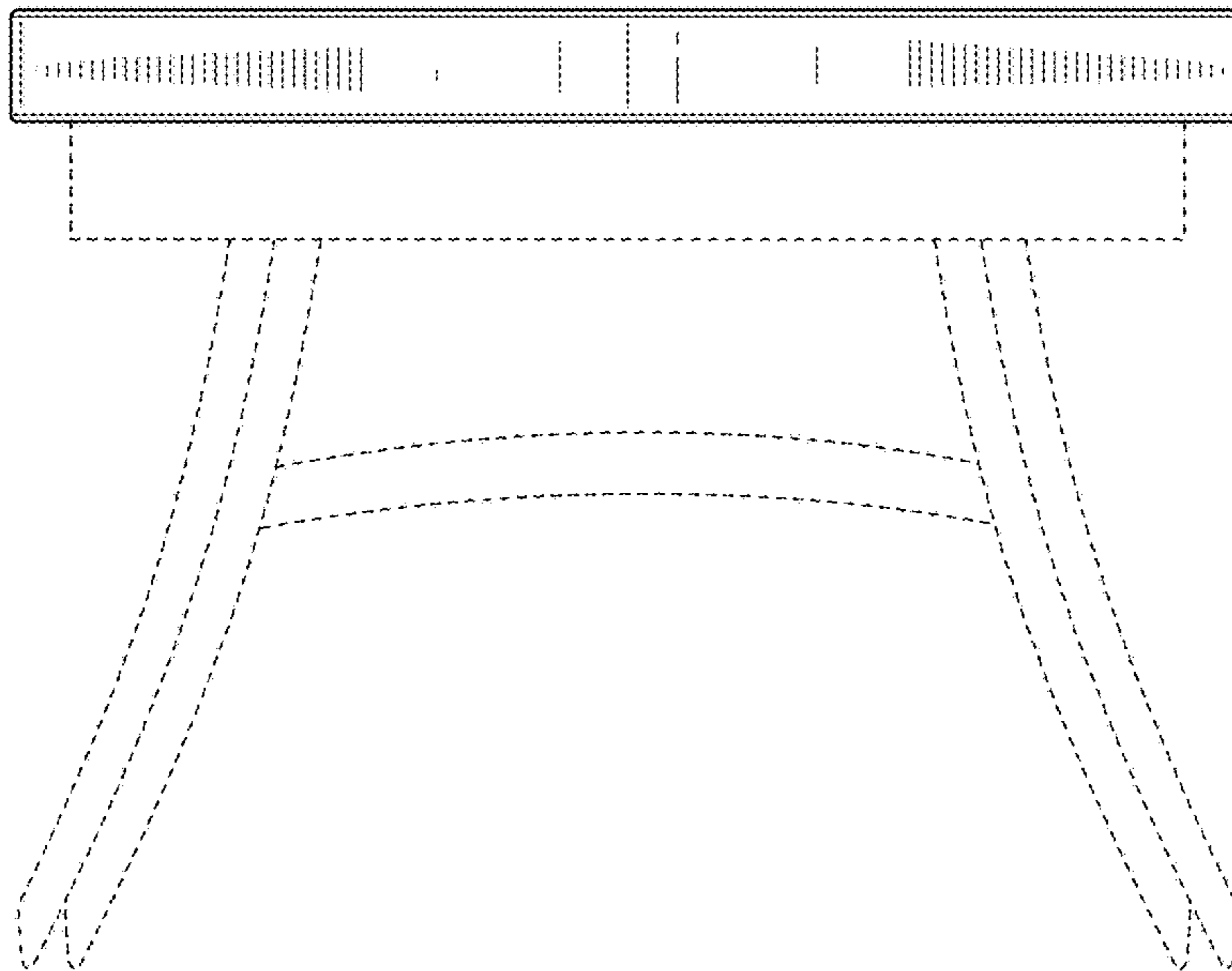

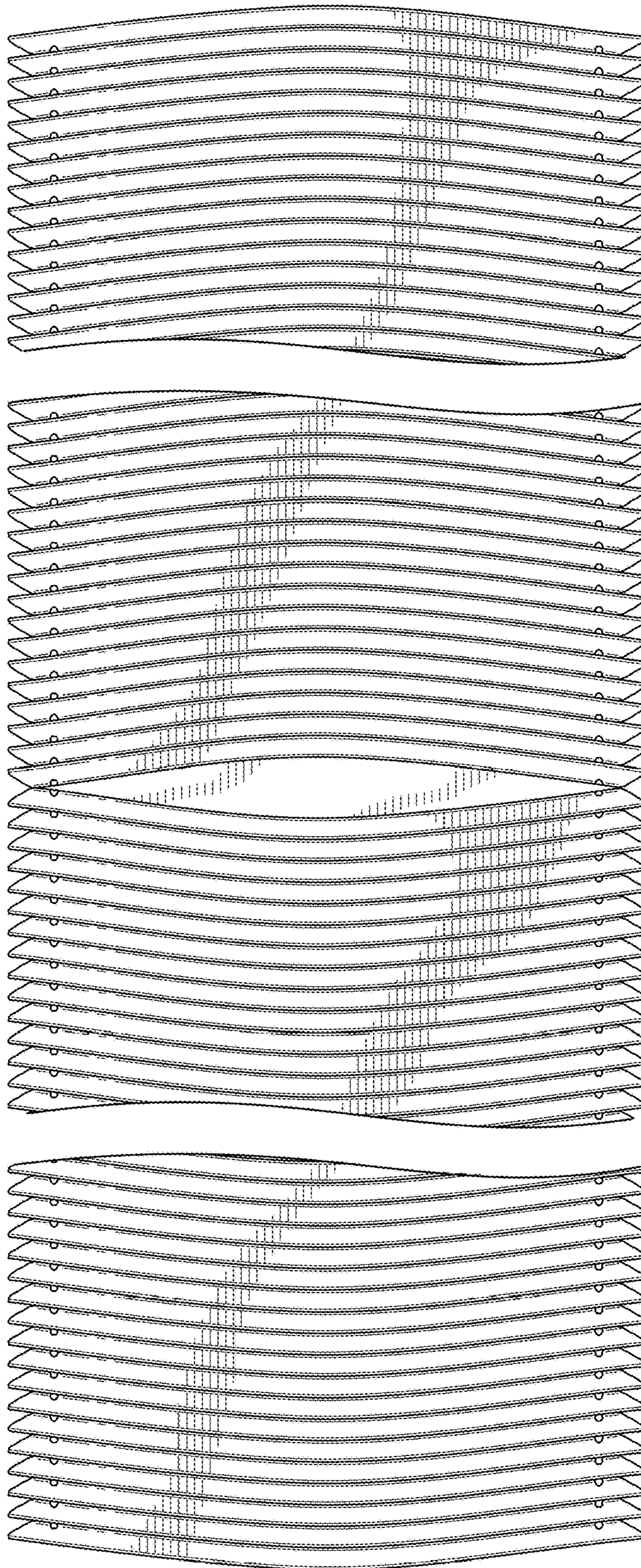

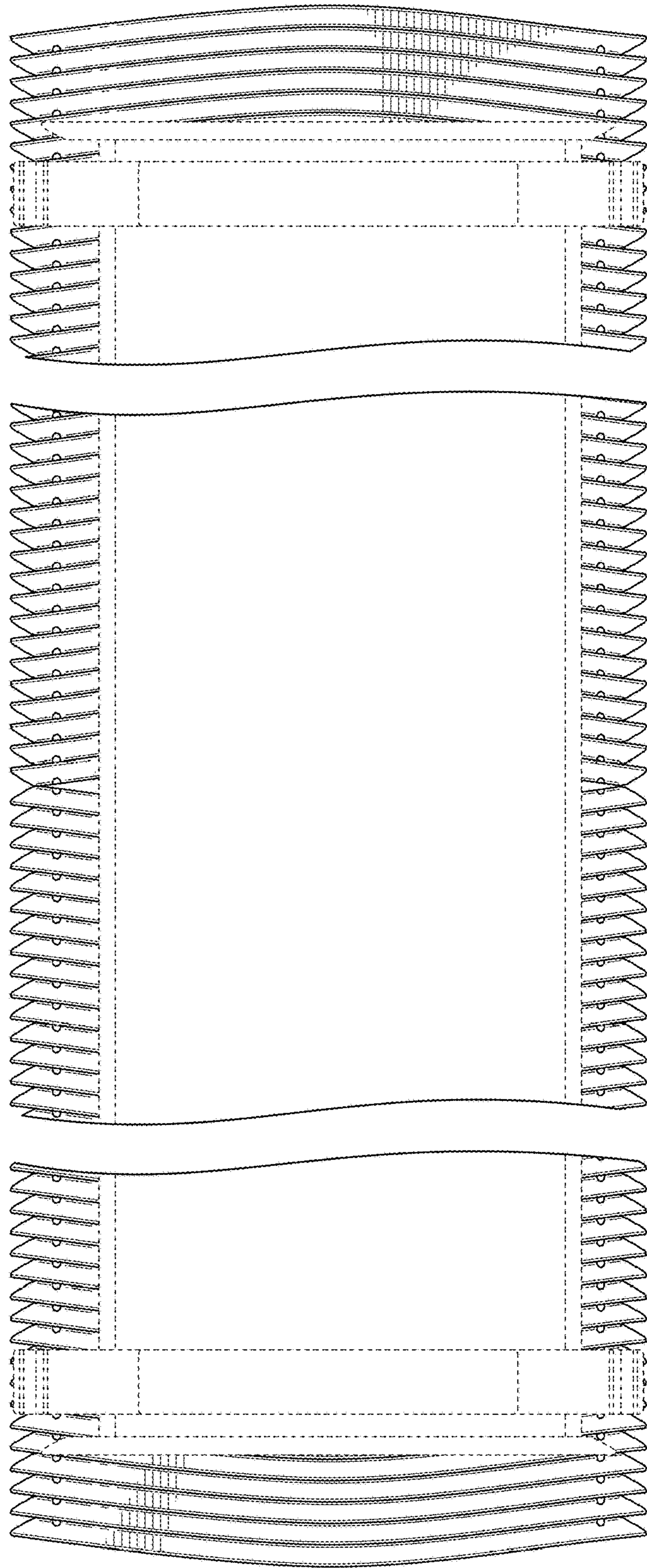
