I claim the ornamental design for a handle for cookware, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a handle for cookware according to the present invention;

FIG. 2 is a left side elevational view thereof;

FIG. 4 is a front elevational view thereof;

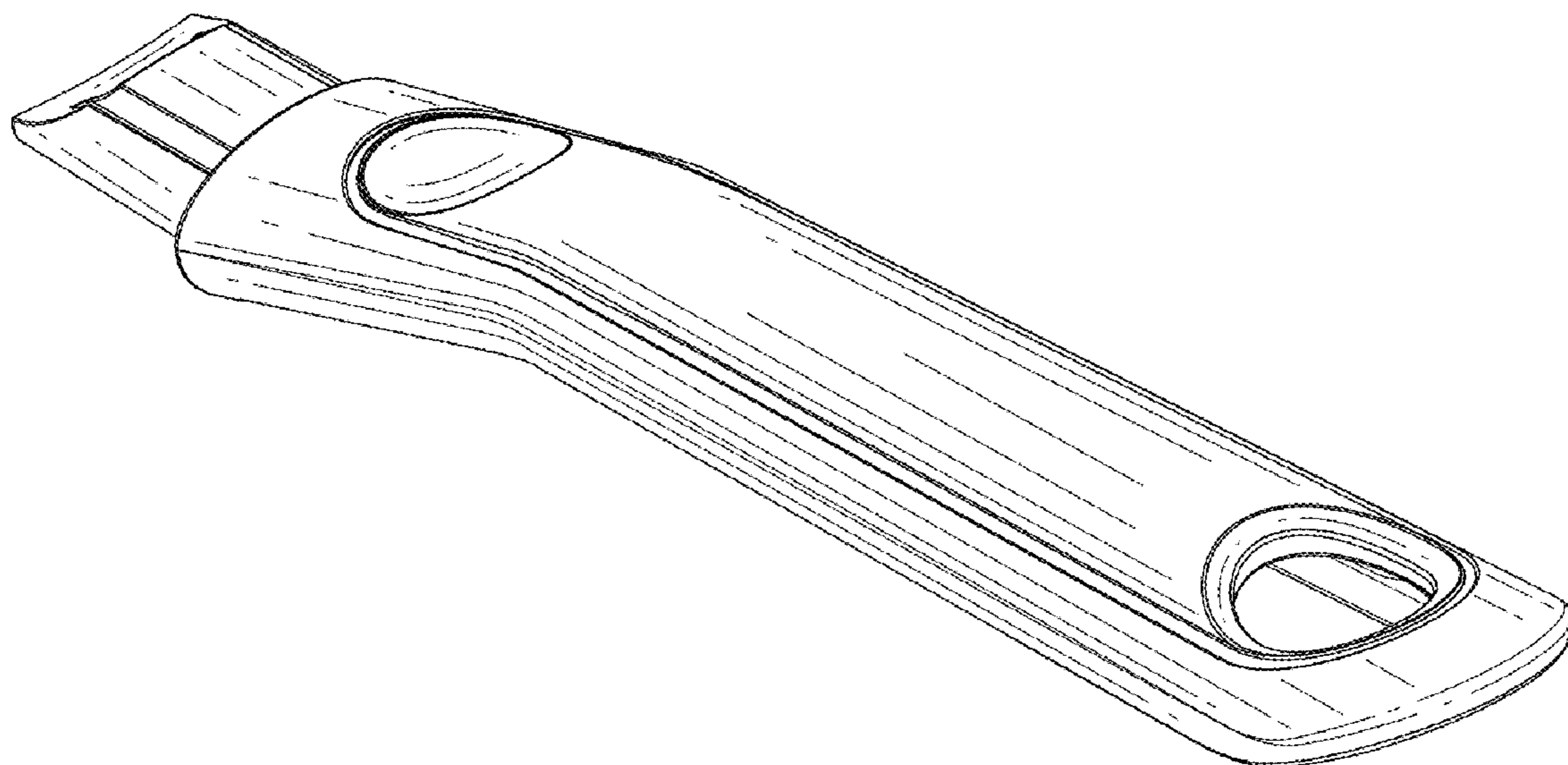
FIG. 5 is a rear elevational view thereof;

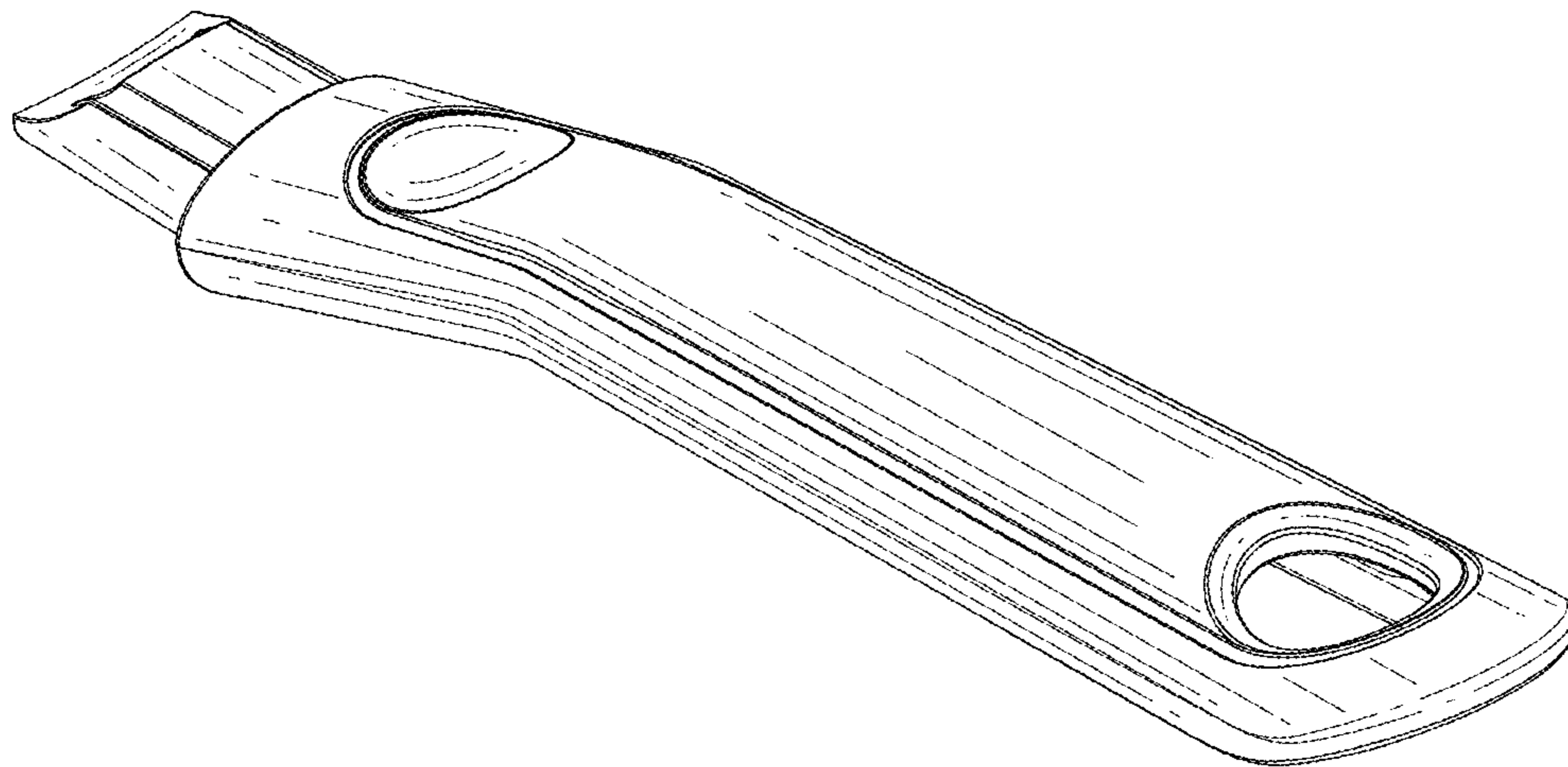

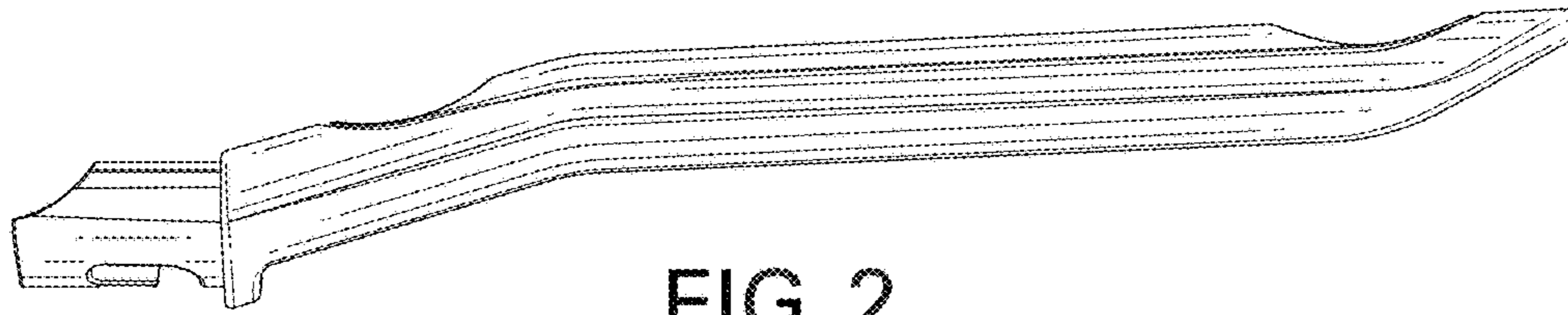

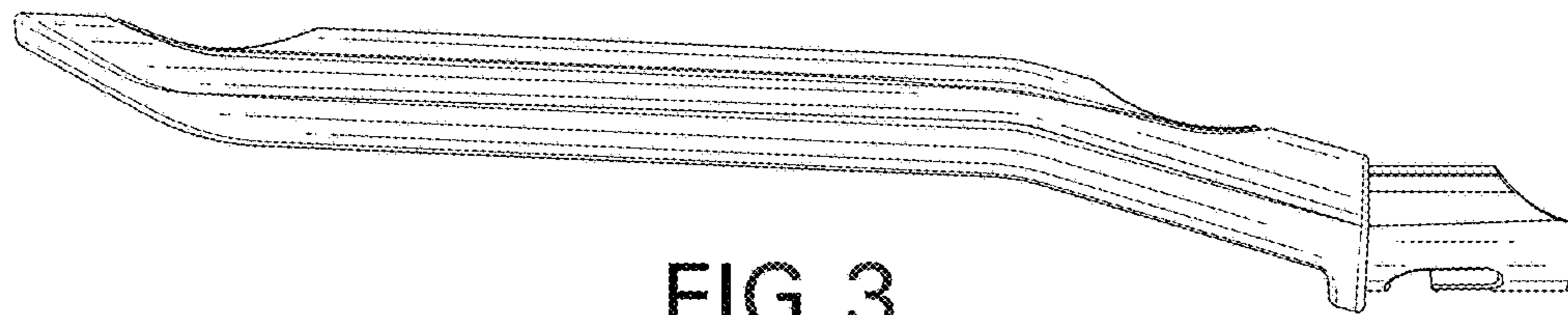

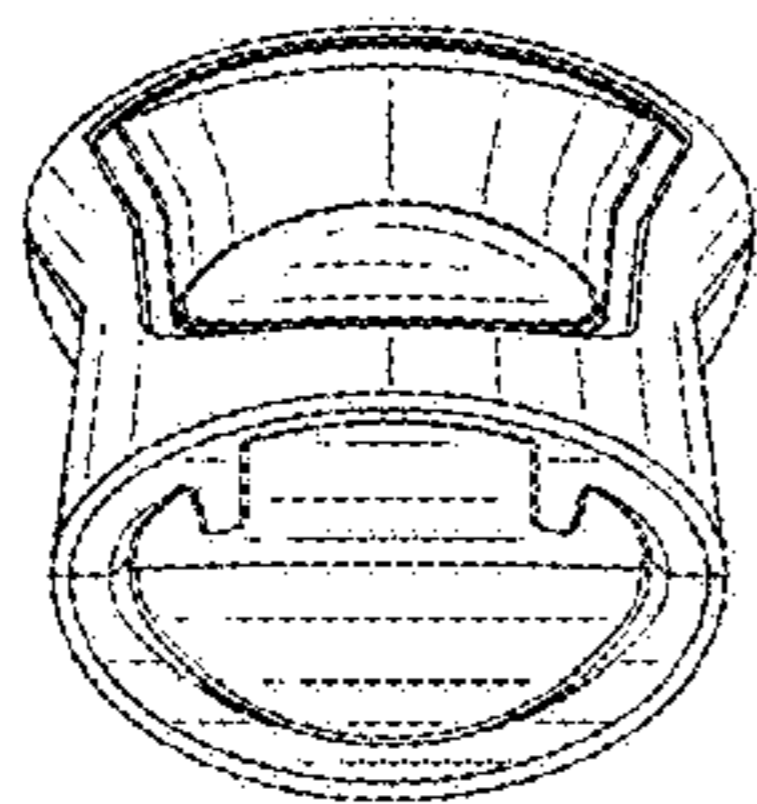

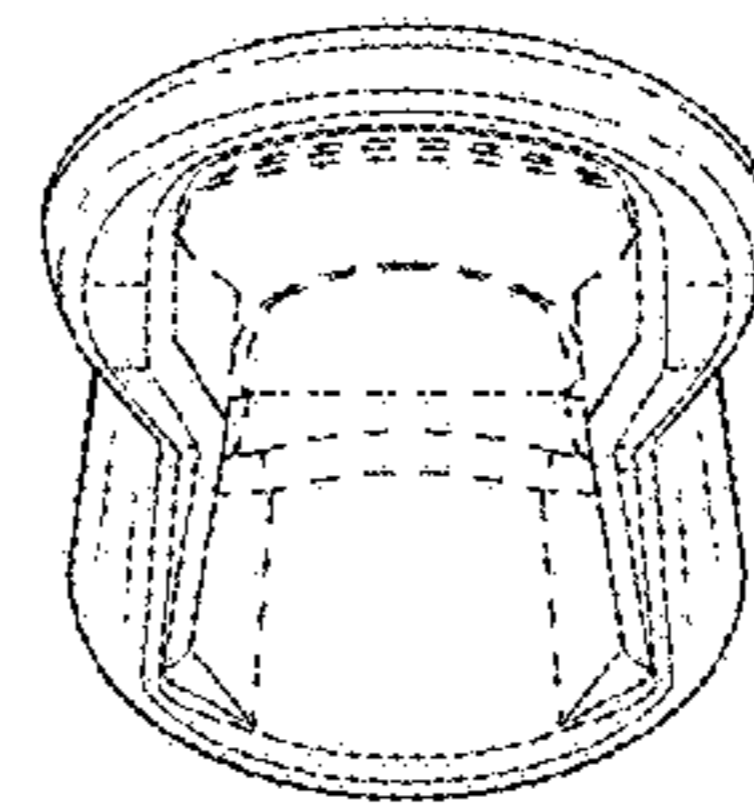

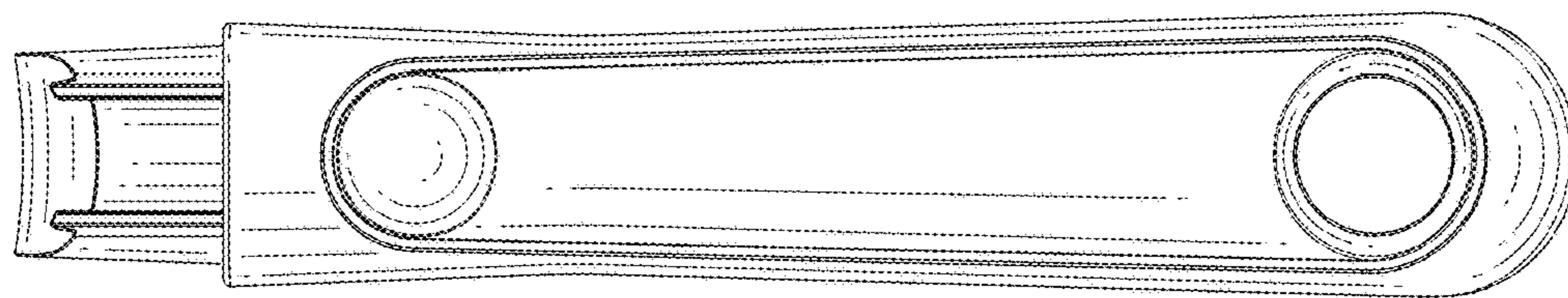

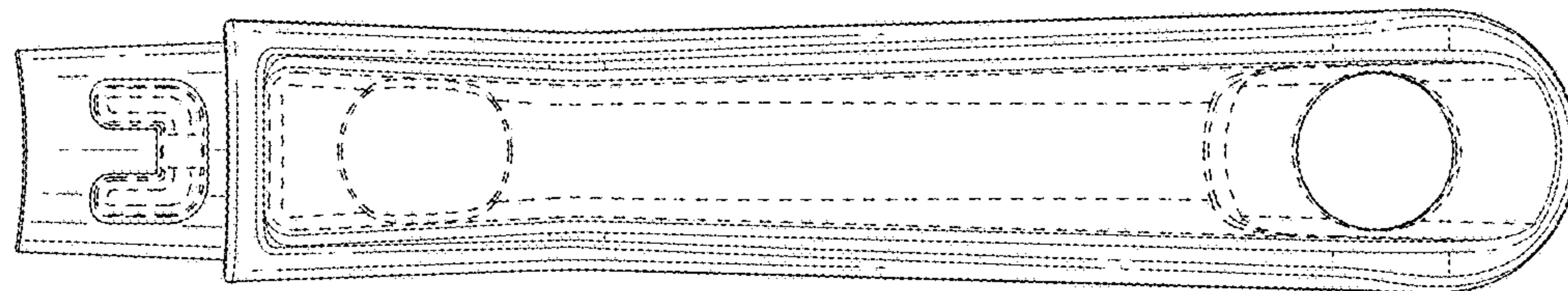
