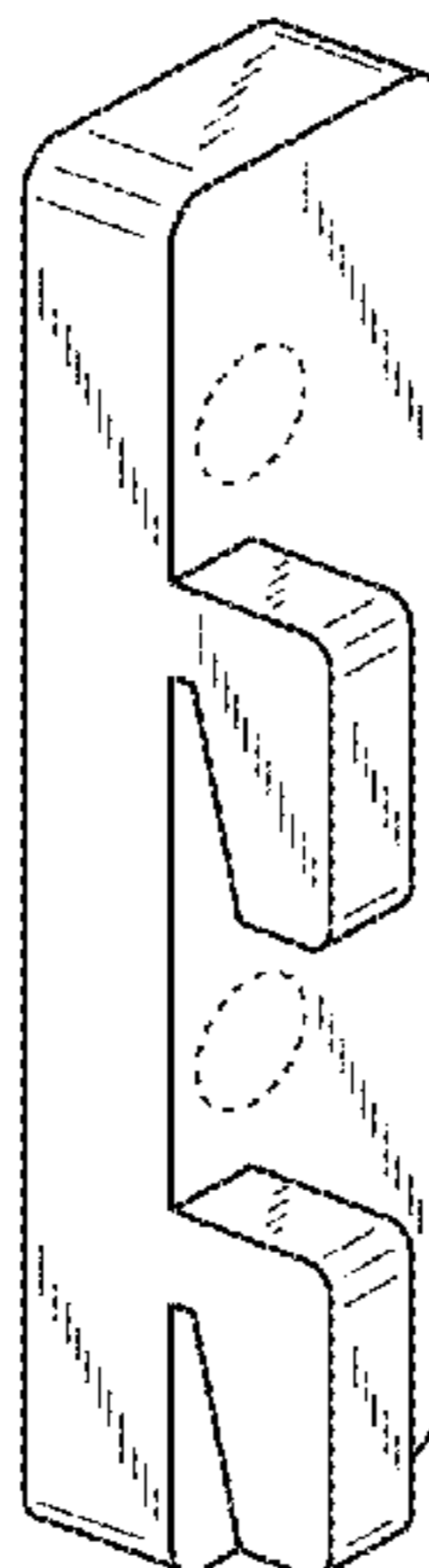
(57) **CLAIM**

The ornamental design for a mounting bracket, as shown and described.

DESCRIPTION

FIG. 1 is a top and rear perspective view of a mounting bracket showing a first embodiment of our new design; FIG. 2 is a front view thereof; FIG. 3 is a rear view thereof; FIG. 4 is a right side view thereof; FIG. 5 is a left side view thereof; FIG. 6 is a top view thereof; and FIG. 7 is a bottom view thereof. FIG. 8 is a top and rear perspective view of a mounting bracket showing a second embodiment of our new design; FIG. 9 is a front view thereof; FIG. 10 is a rear view thereof; FIG. 11 is a right side view thereof; FIG. 12 is a left side view thereof; FIG. 13 is a top view thereof; and FIG. 14 is a bottom view thereof. FIG. 15 is a top and rear perspective view of a mounting bracket showing a third embodiment of our new design; FIG. 16 is a front view thereof; FIG. 17 is a rear view thereof; FIG. 18 is a right side view thereof; FIG. 19 is a left side view thereof; FIG. 20 is a top view thereof; and FIG. 21 is a bottom view thereof. 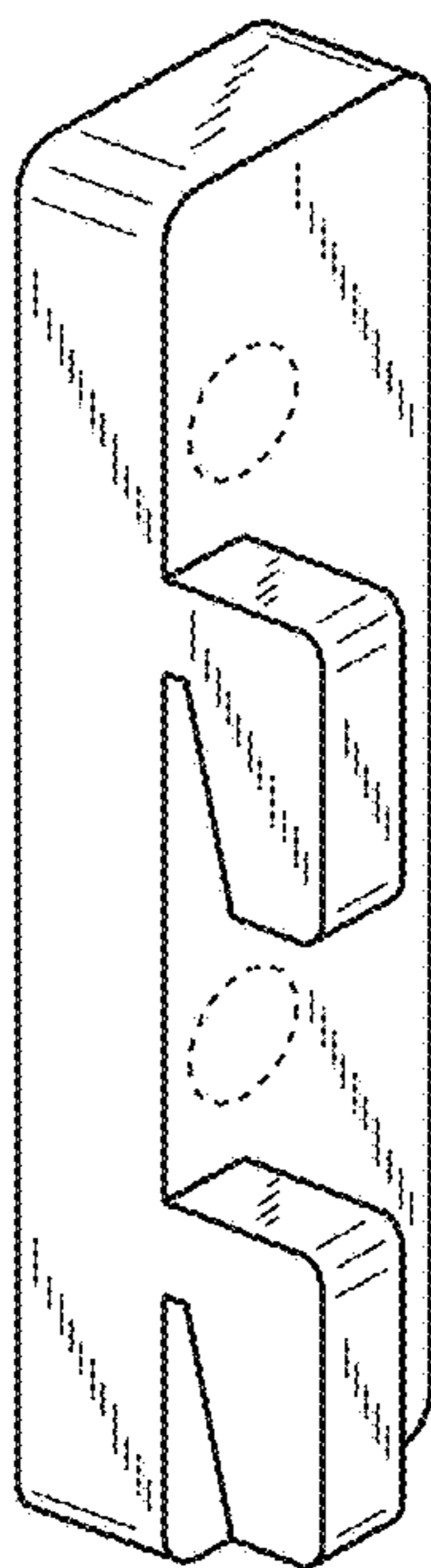

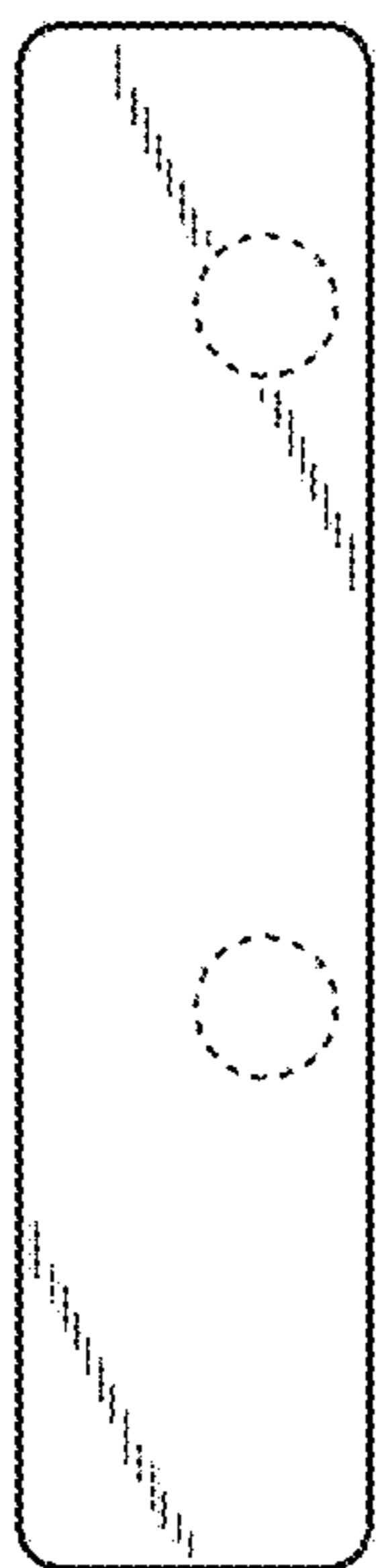

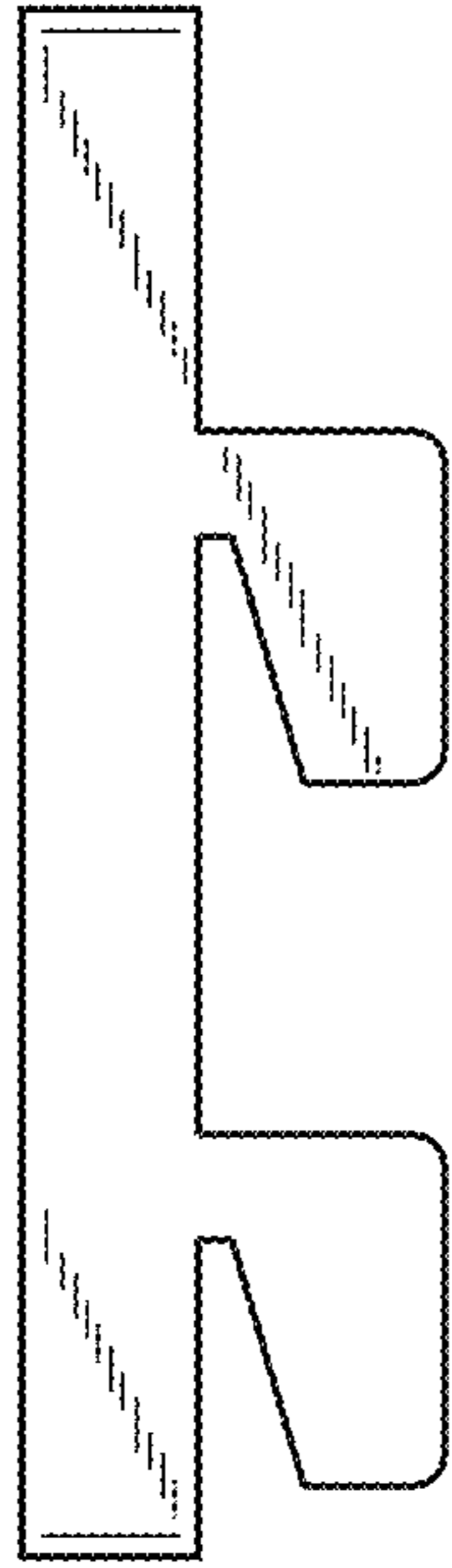

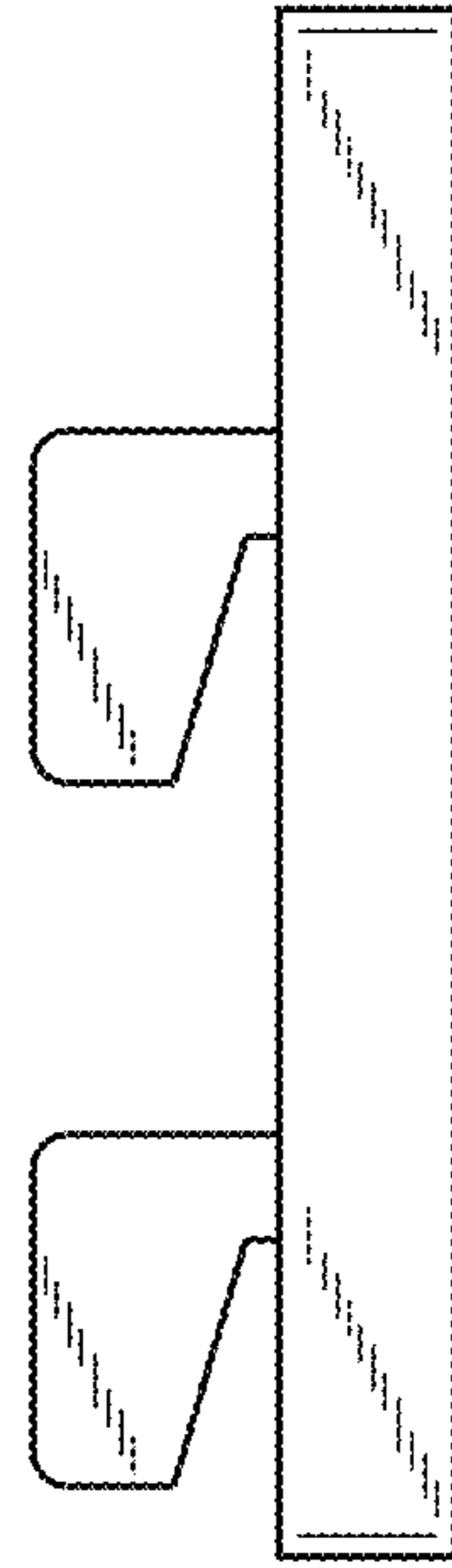

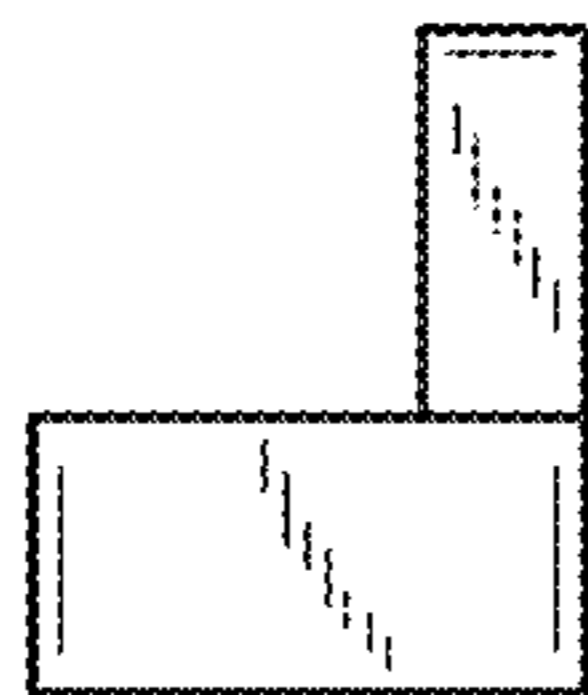

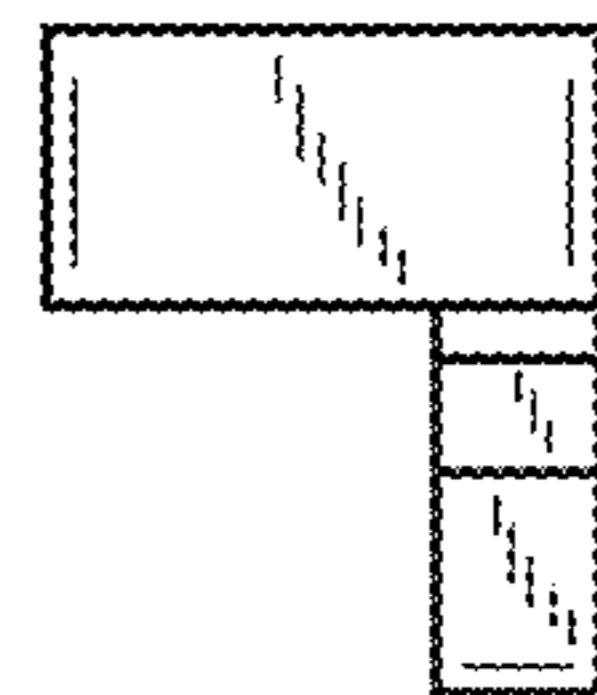

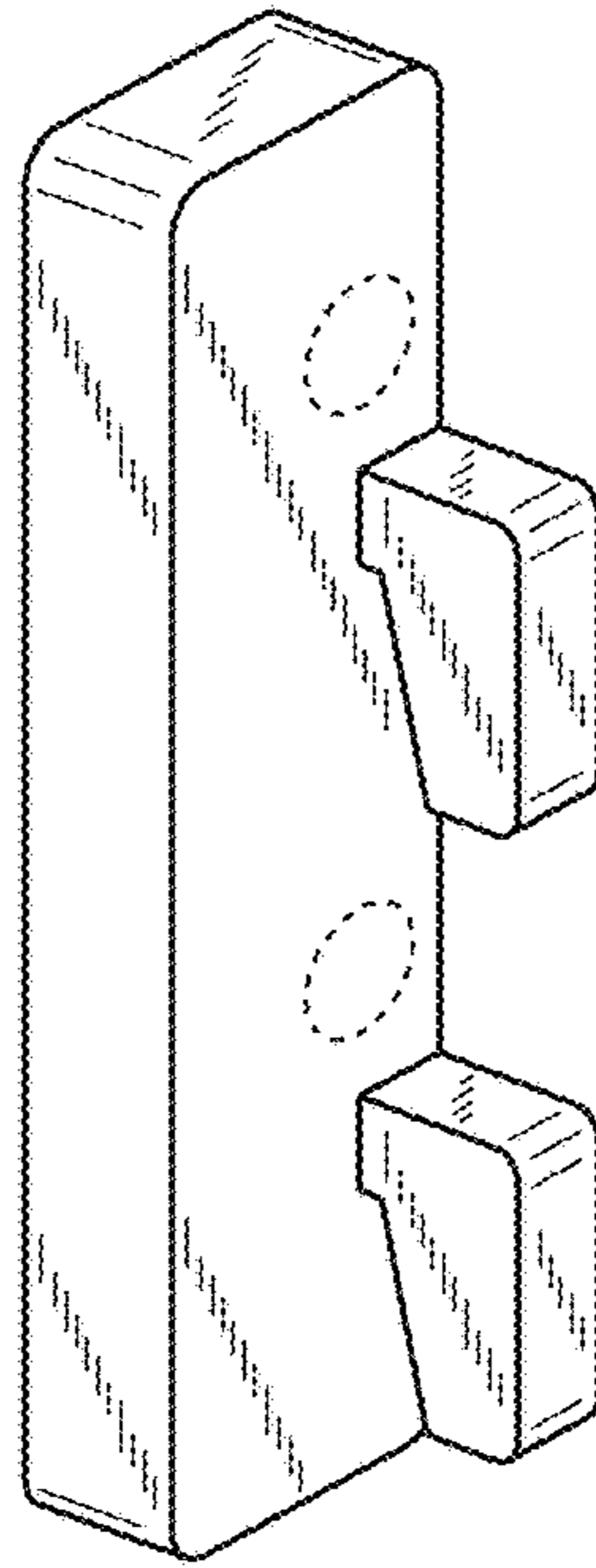

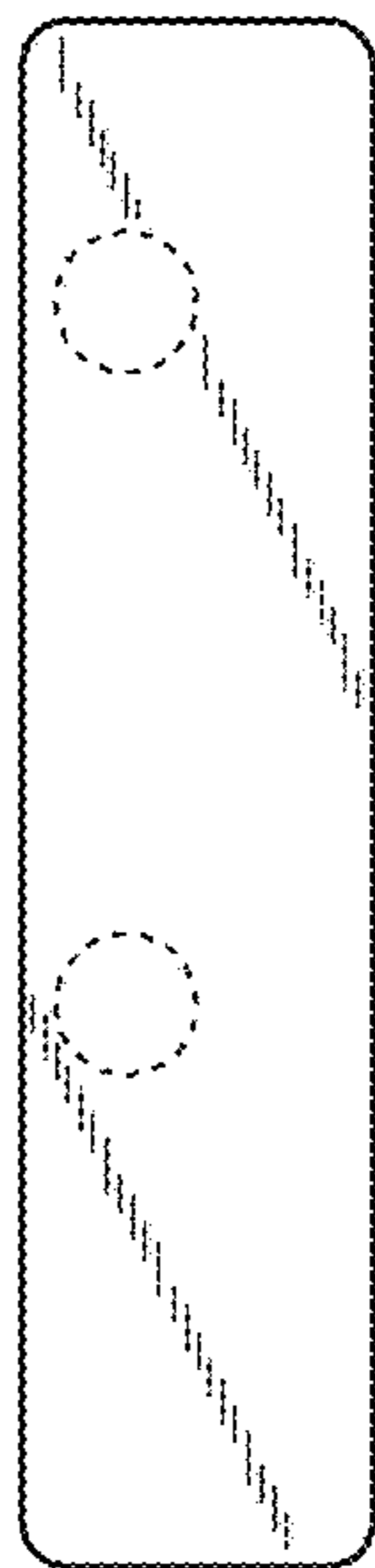

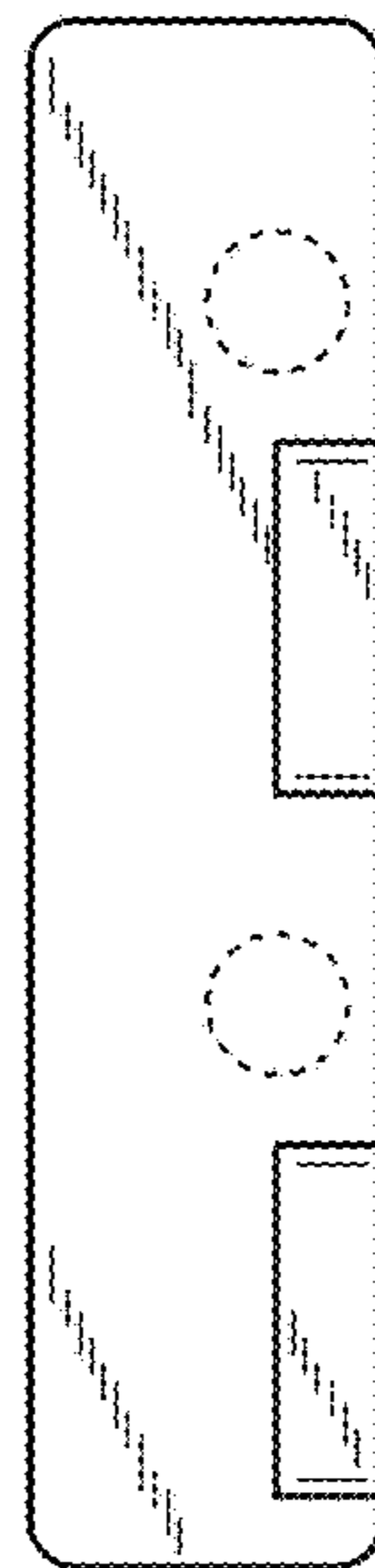

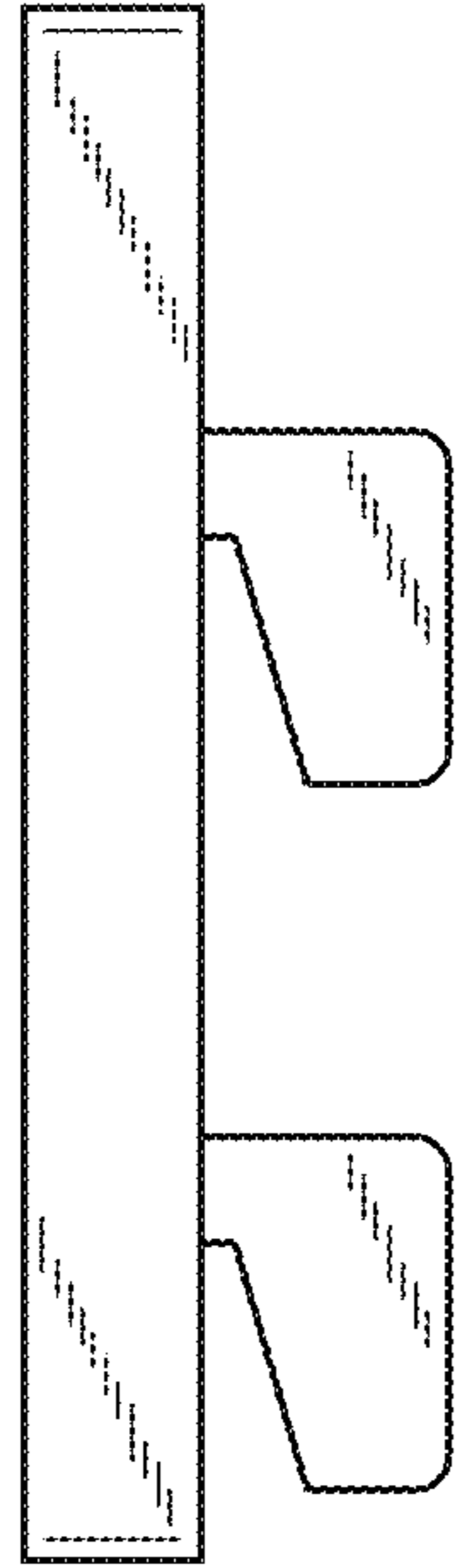

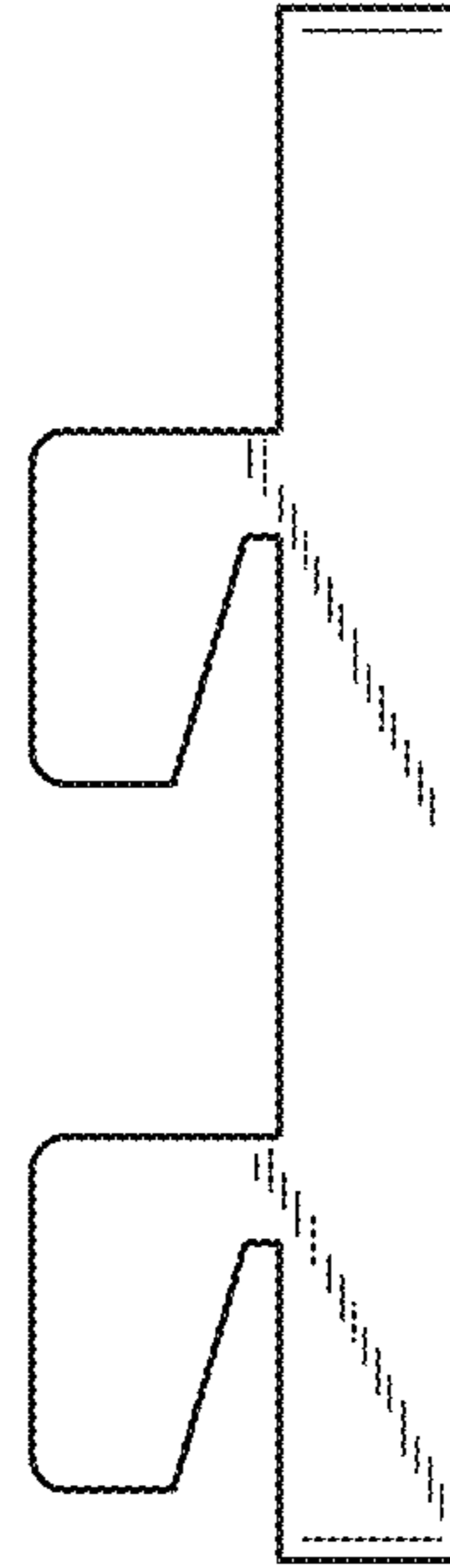

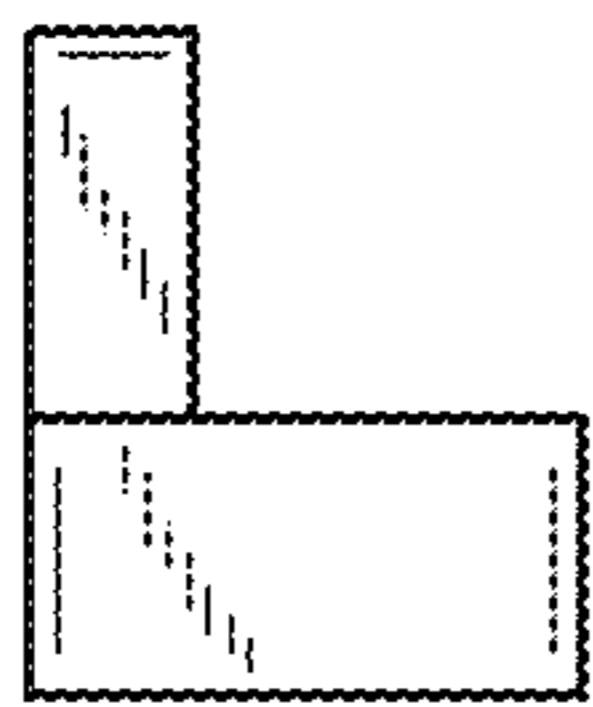

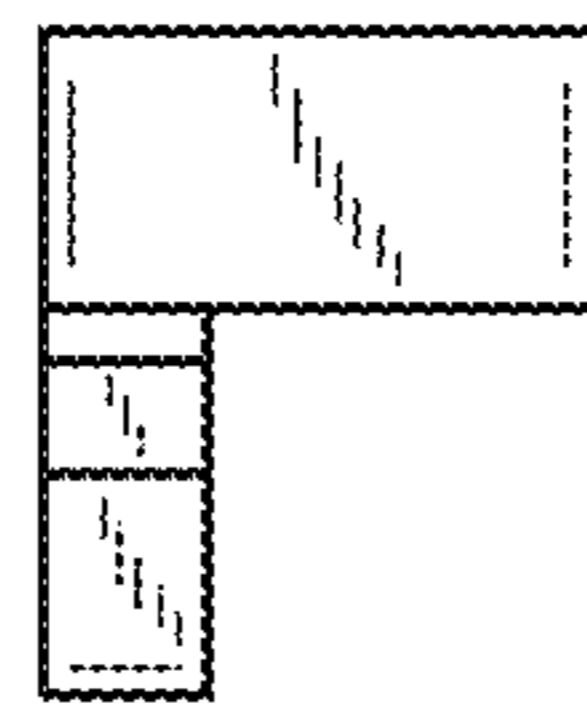

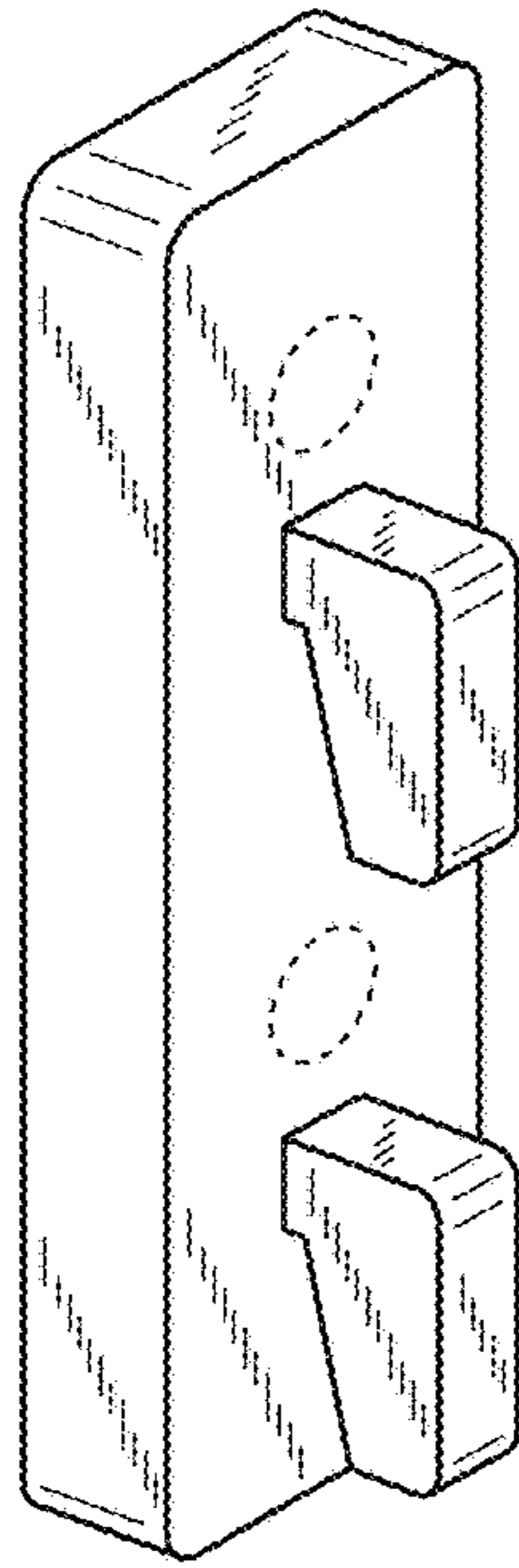

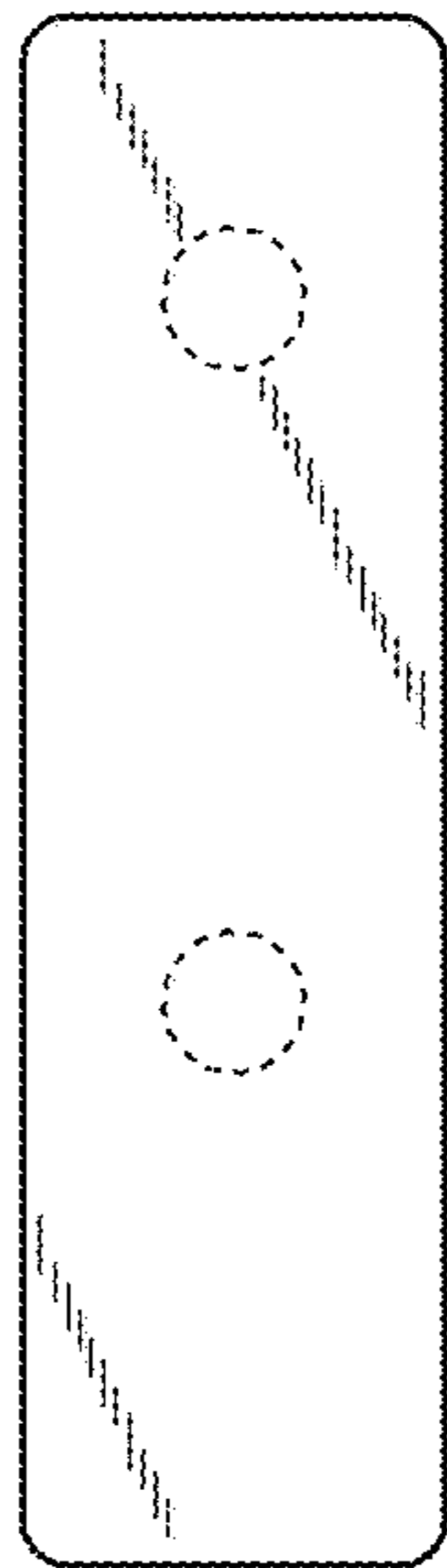

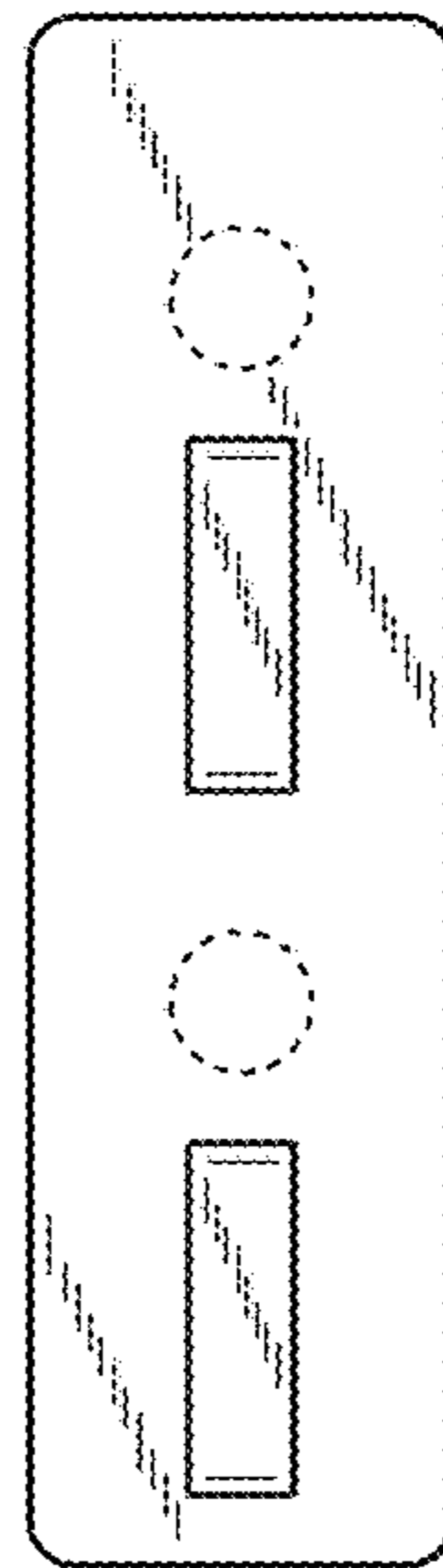

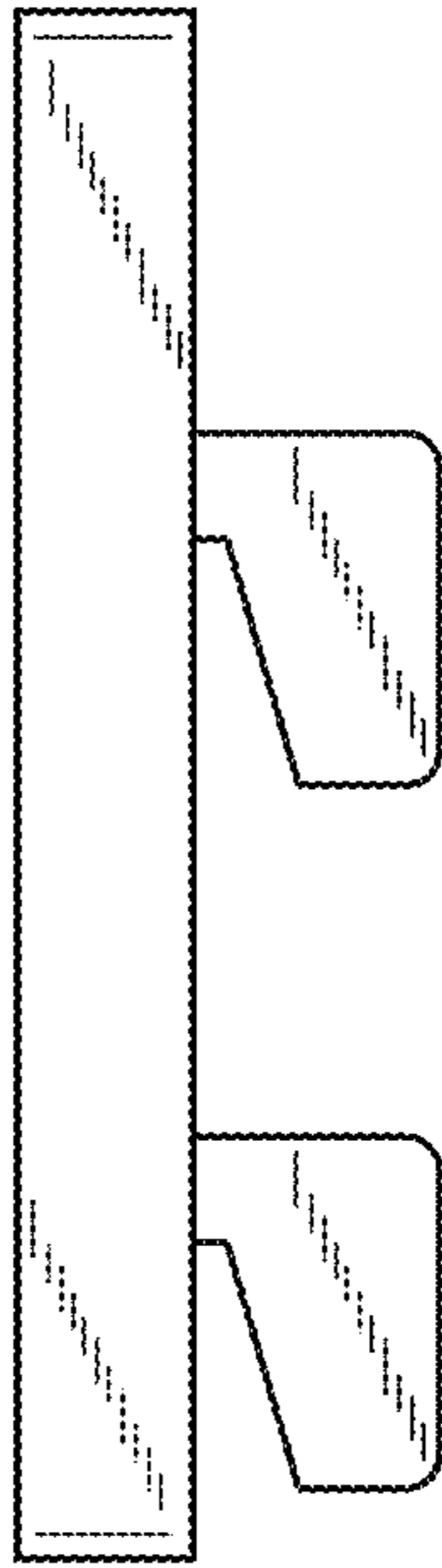

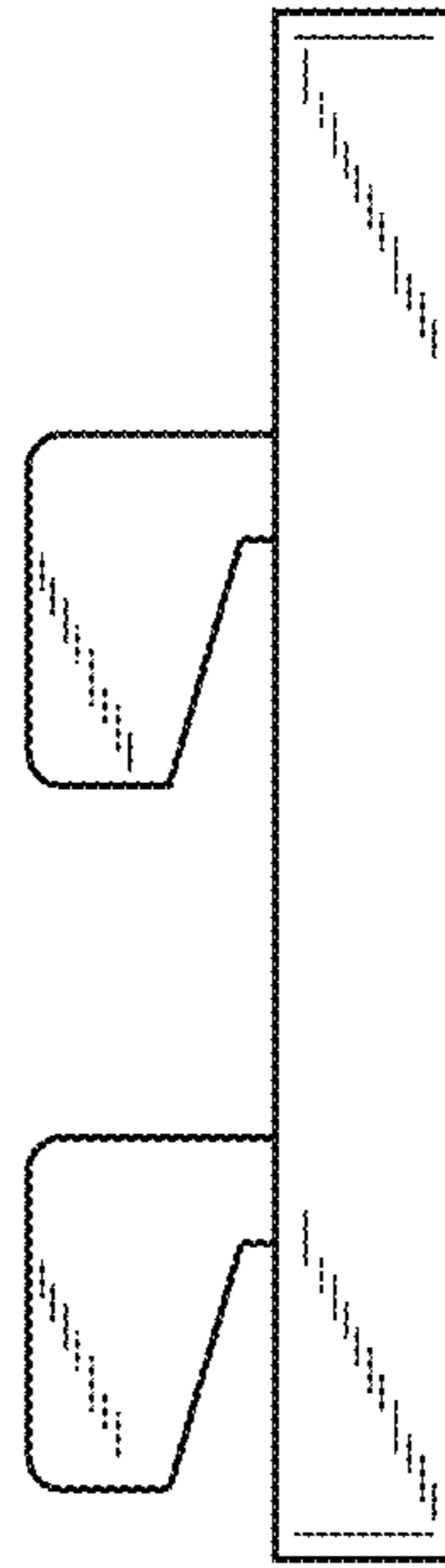

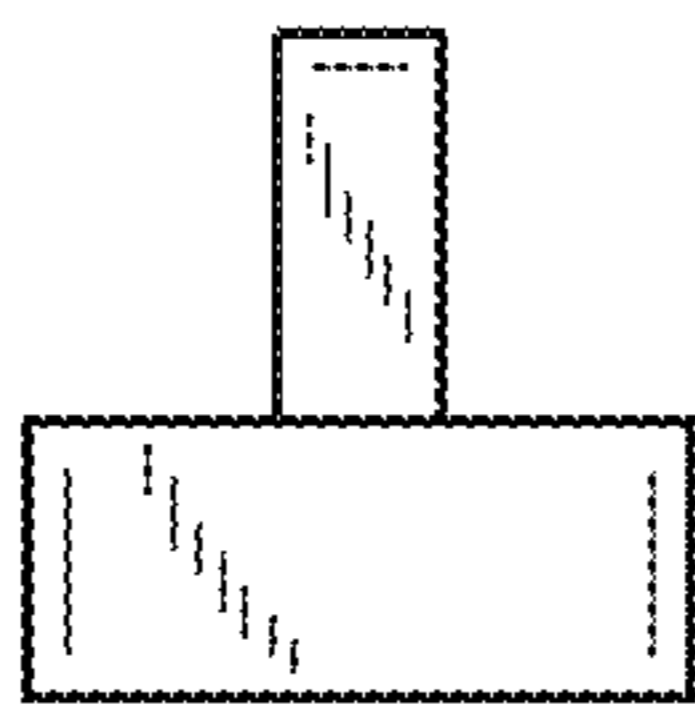

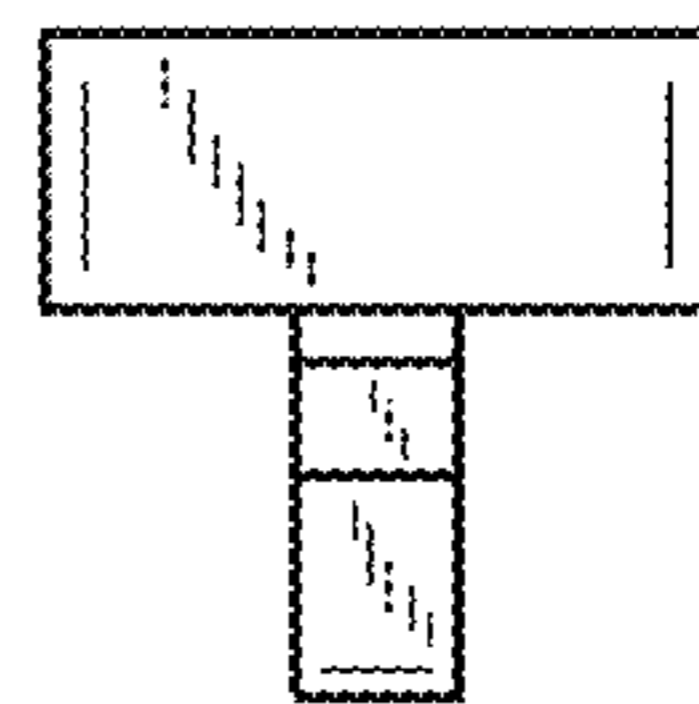
