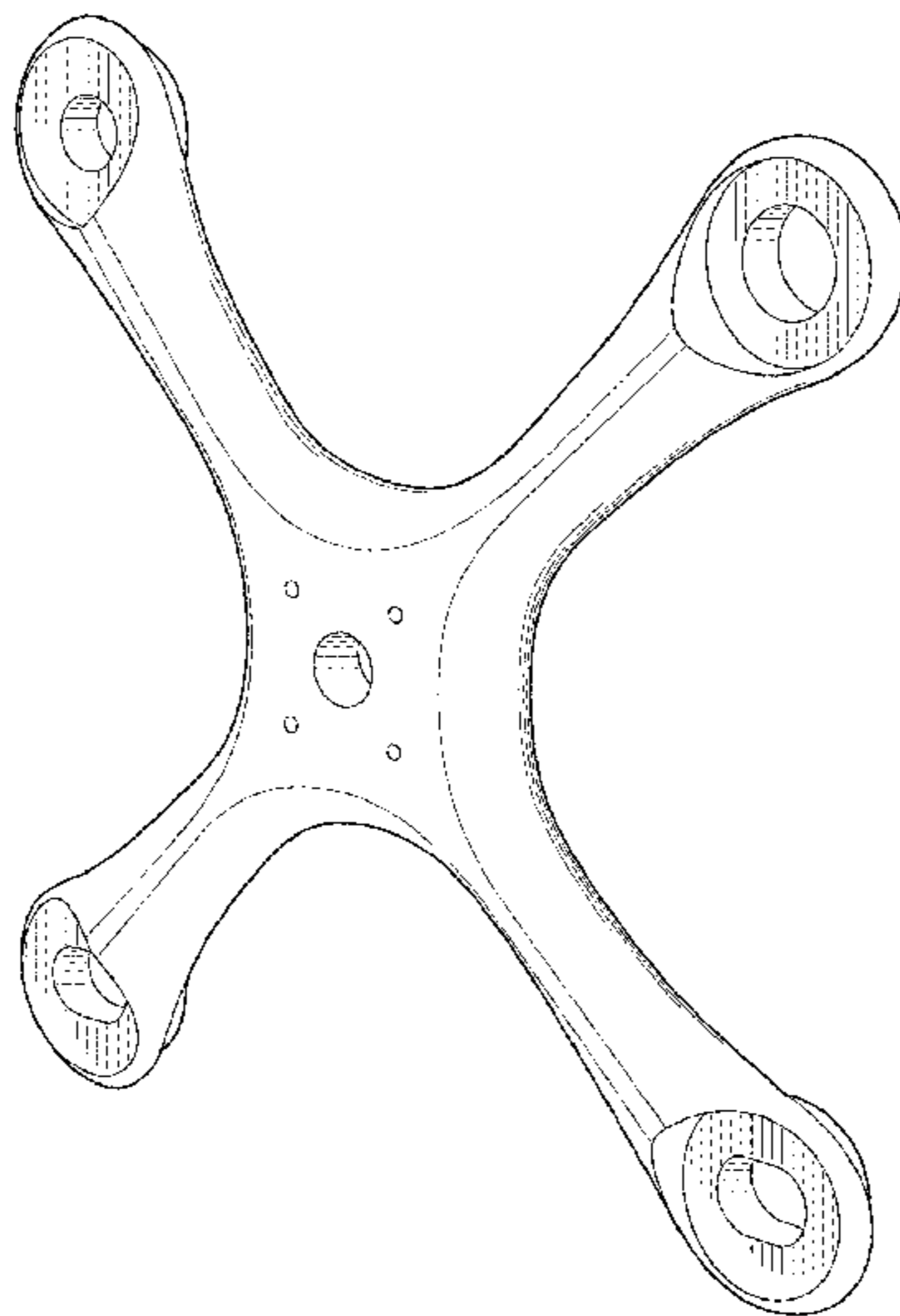
(57) **CLAIM**

We claim the ornamental design for an element for fastening of glass panels, as shown and described.

DESCRIPTION

FIG. 1 is a front elevation view of an element for fastening of glass panels according to our new design;
FIG. 2 is a right side elevation view thereof, a left side elevation view being a mirror image of the right side elevation view;
FIG. 3 is a back top perspective view thereof;
FIG. 4 is a top plan view thereof, a bottom plan view being a mirror image of the top plan view;
FIG. 5 is back elevation view thereof; and,
FIG. 6 is a right side perspective view thereof.

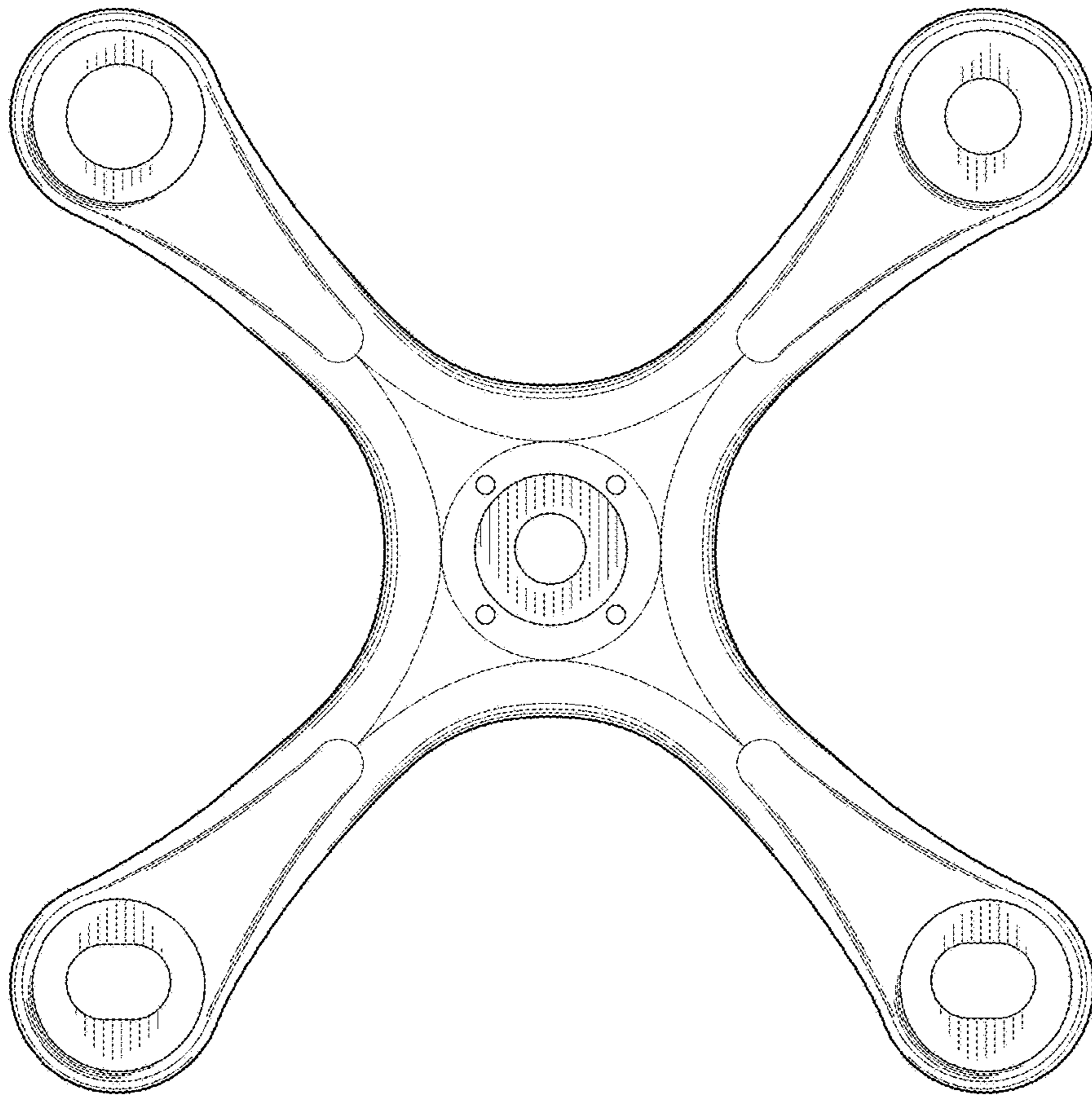

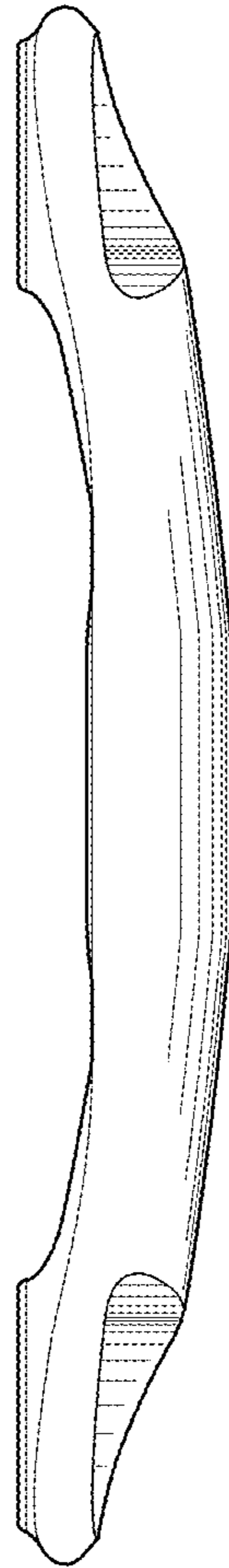

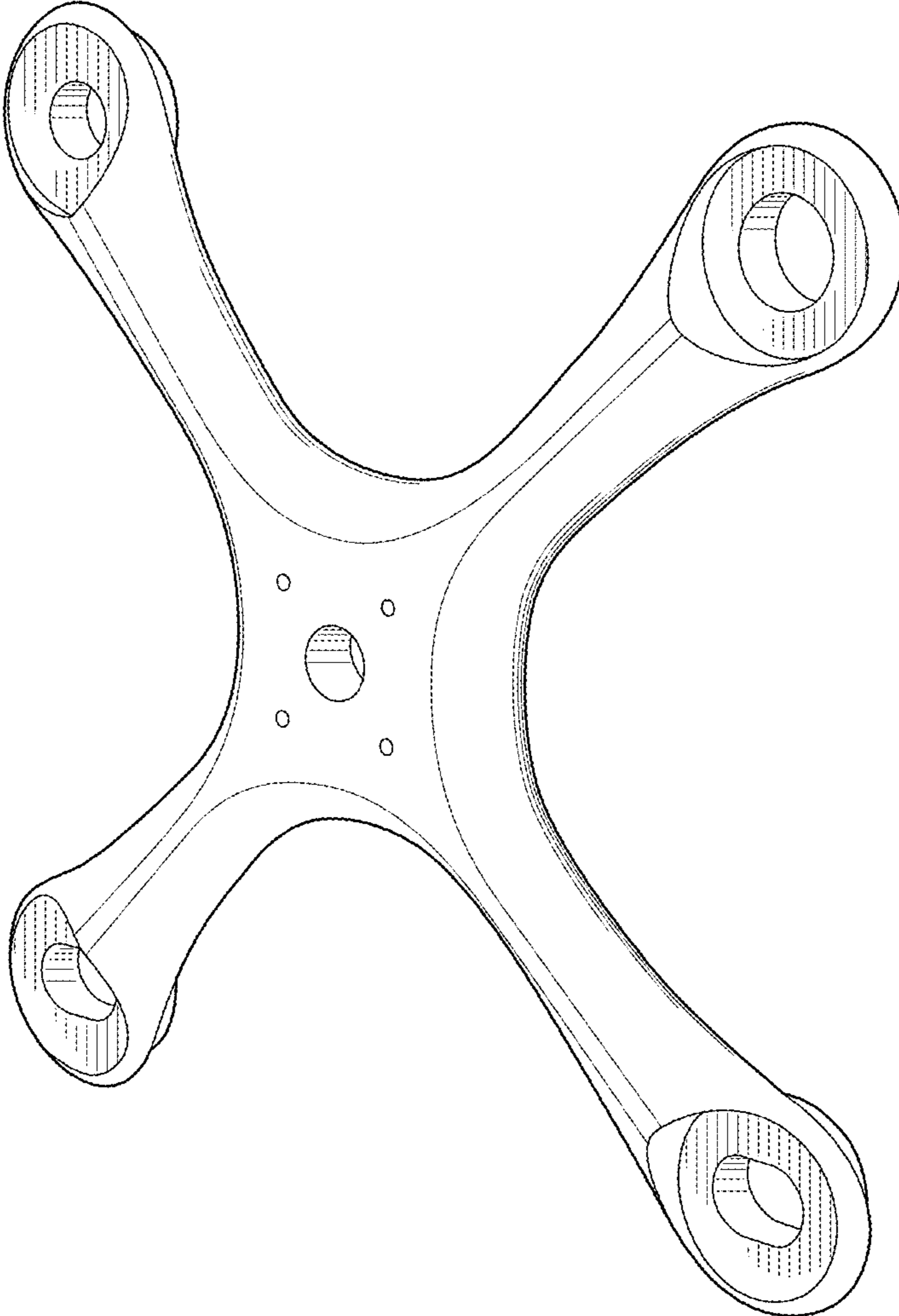

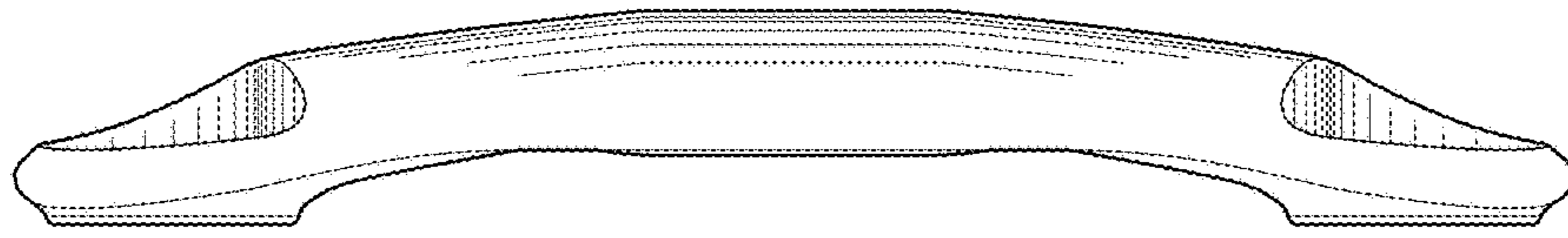

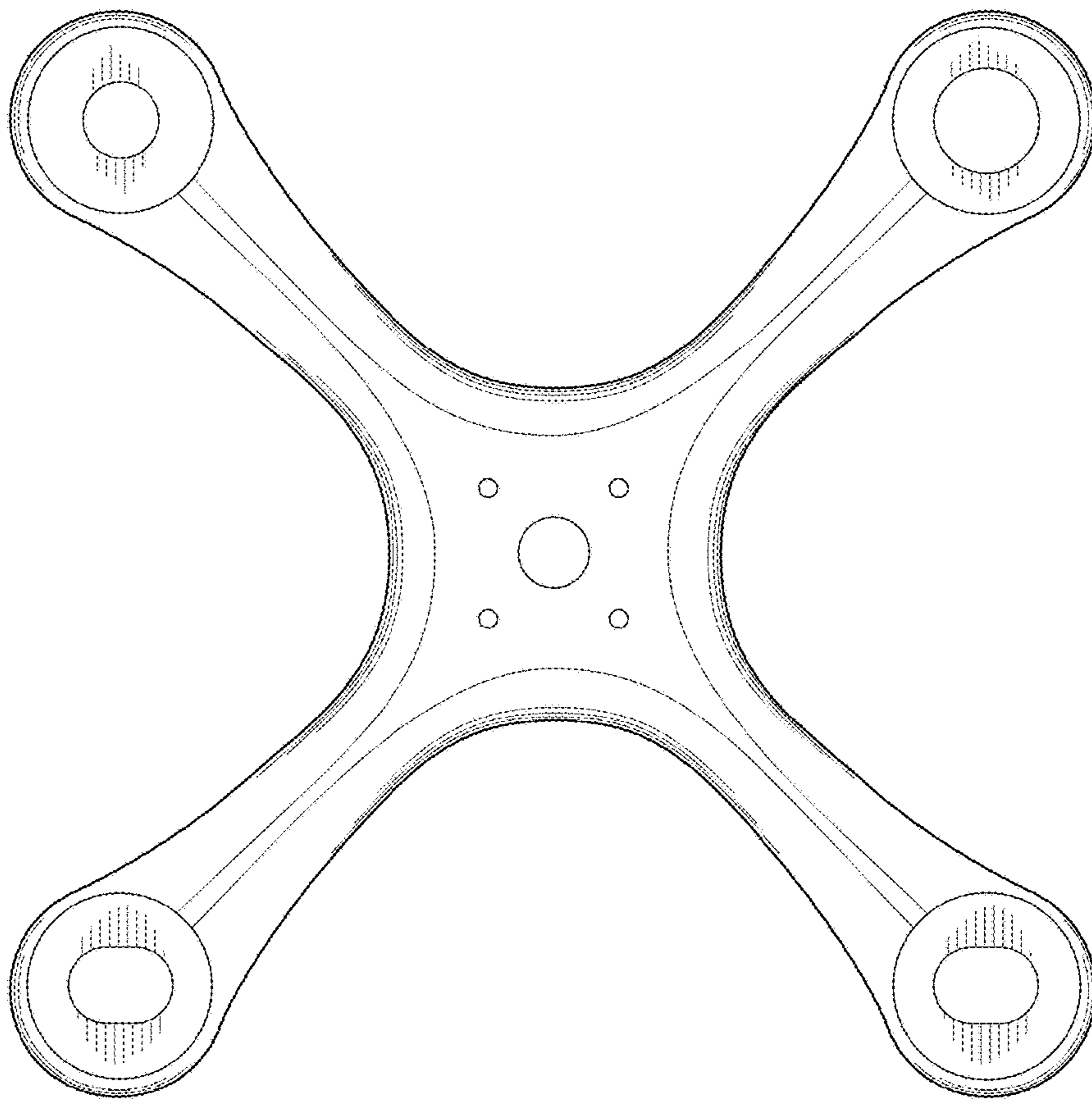

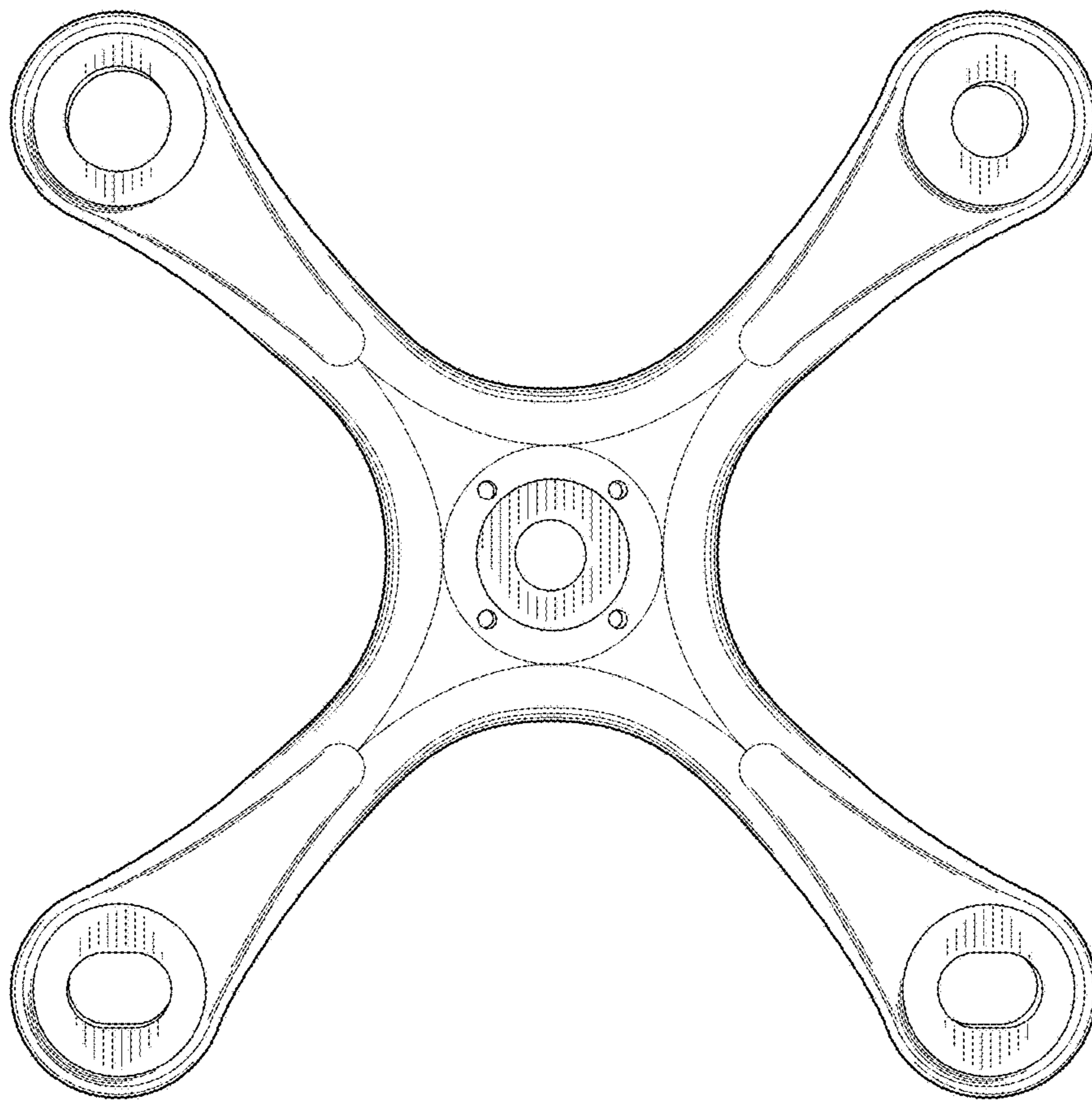
