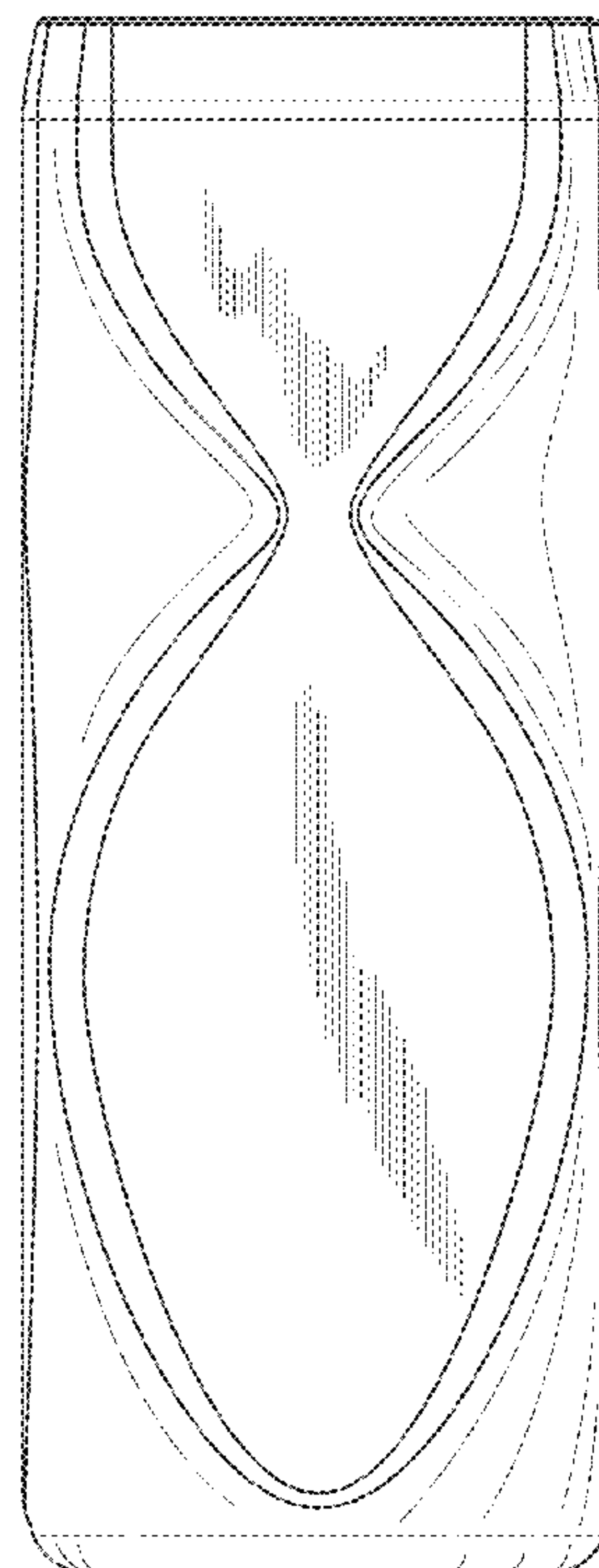
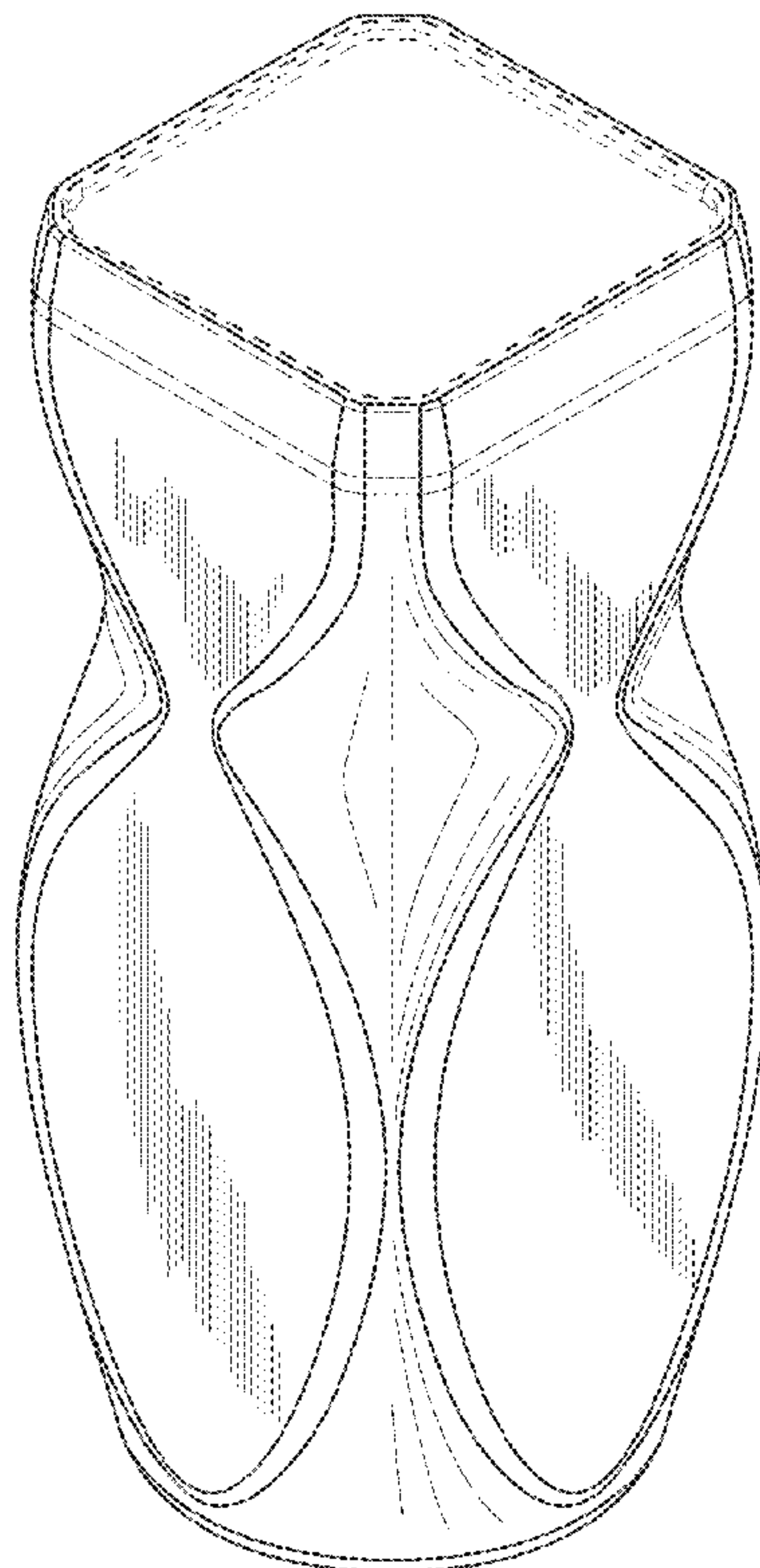
(57) **CLAIM**

The ornamental design for a plastic container, as shown and described.

DESCRIPTION

FIG. 1 is an isometric view of a plastic container;
FIG. 2 is a front view of the plastic container, the back view,
left view and right view being identical thereto;
FIG. 3 is a top view of the plastic container; and,
FIG. 4 is a bottom view of the plastic container.
The broken lines showing a portion of the top inner surface
and bottom surface is for the purpose of illustrating structure

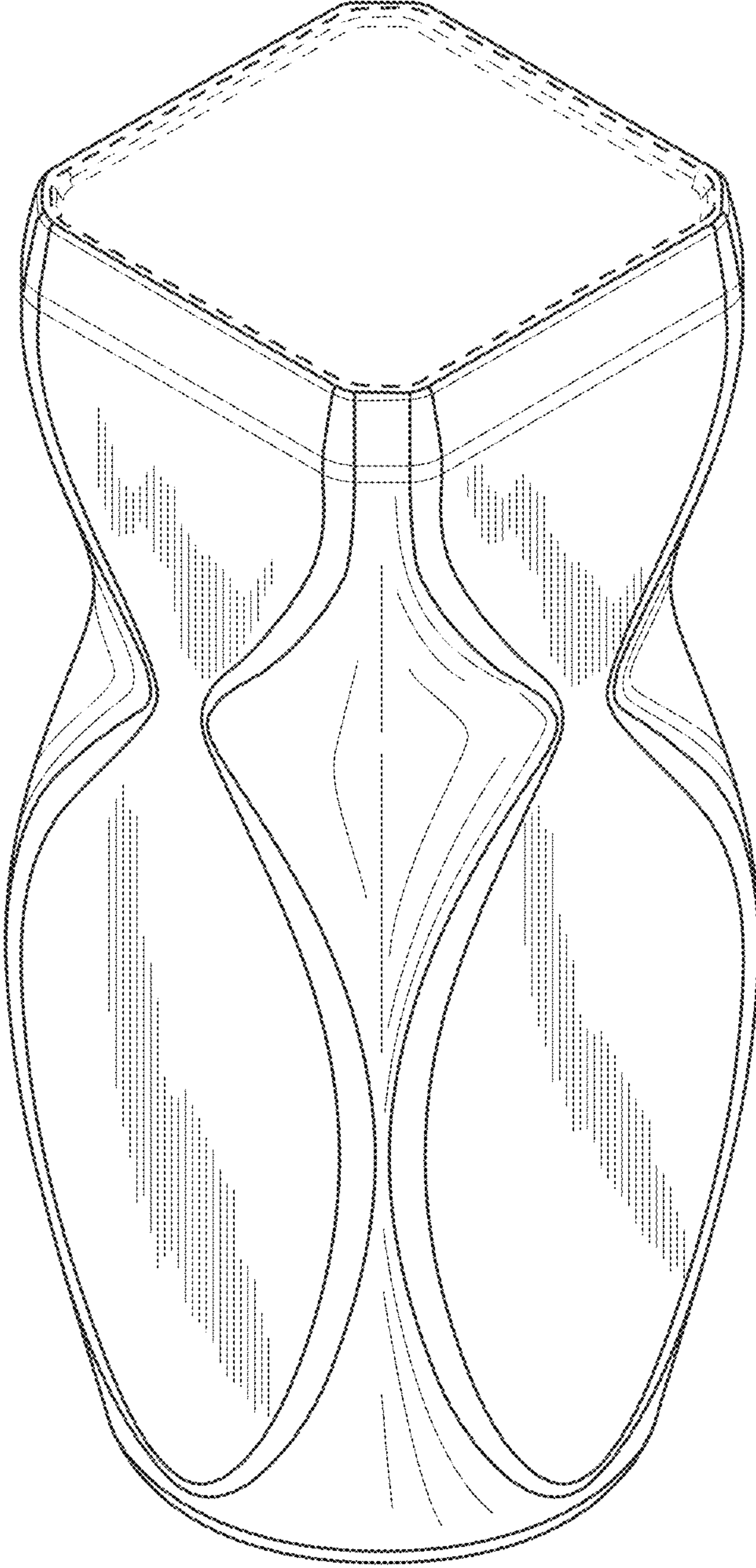

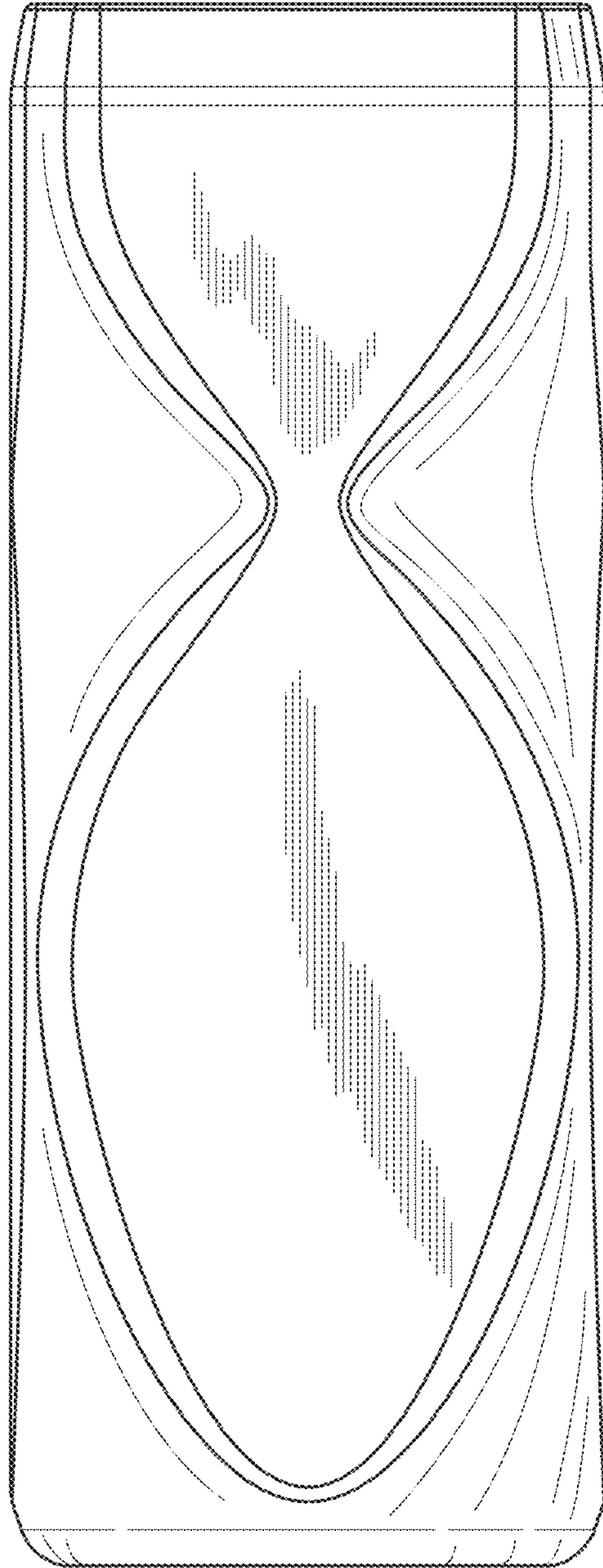

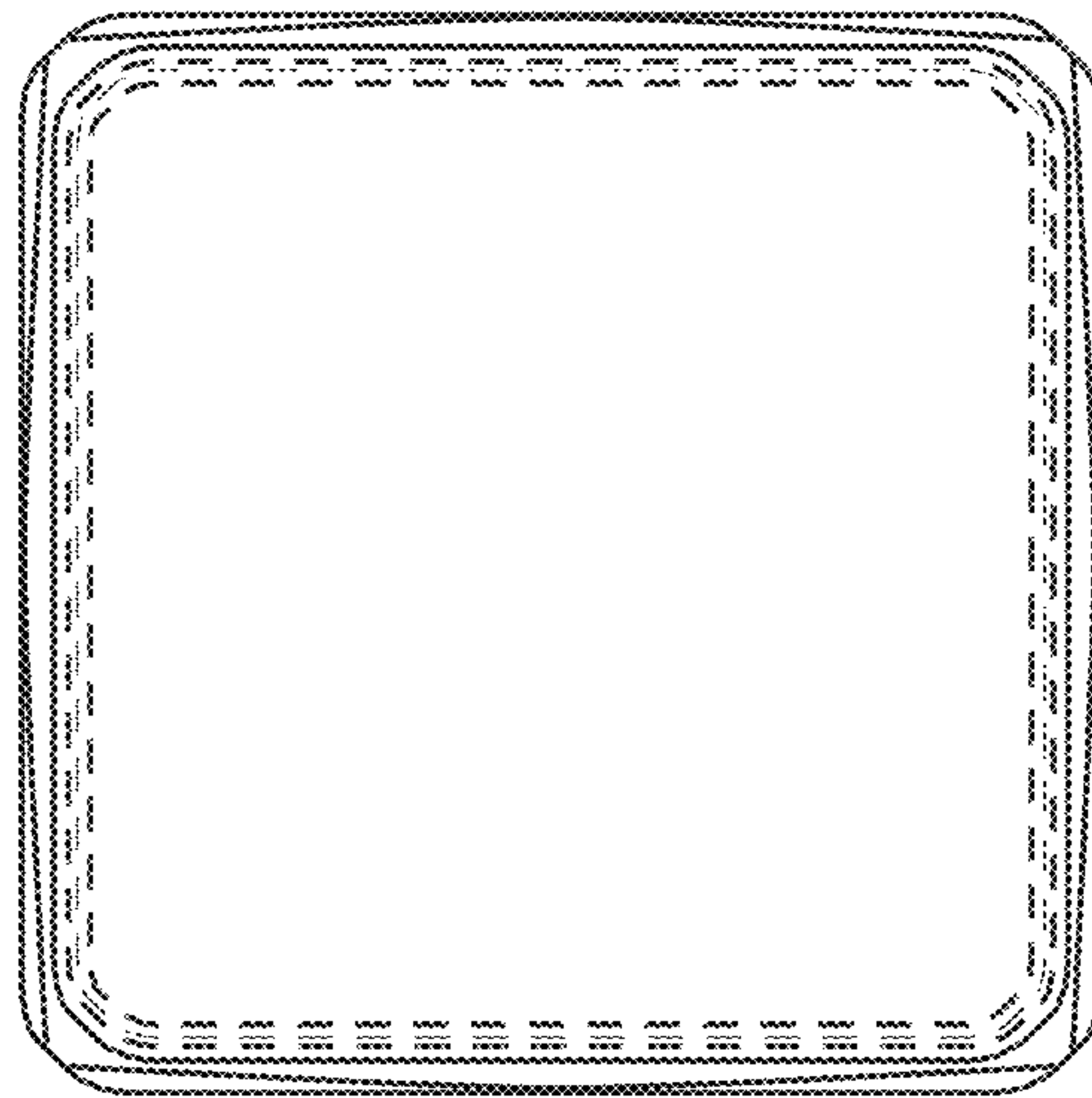

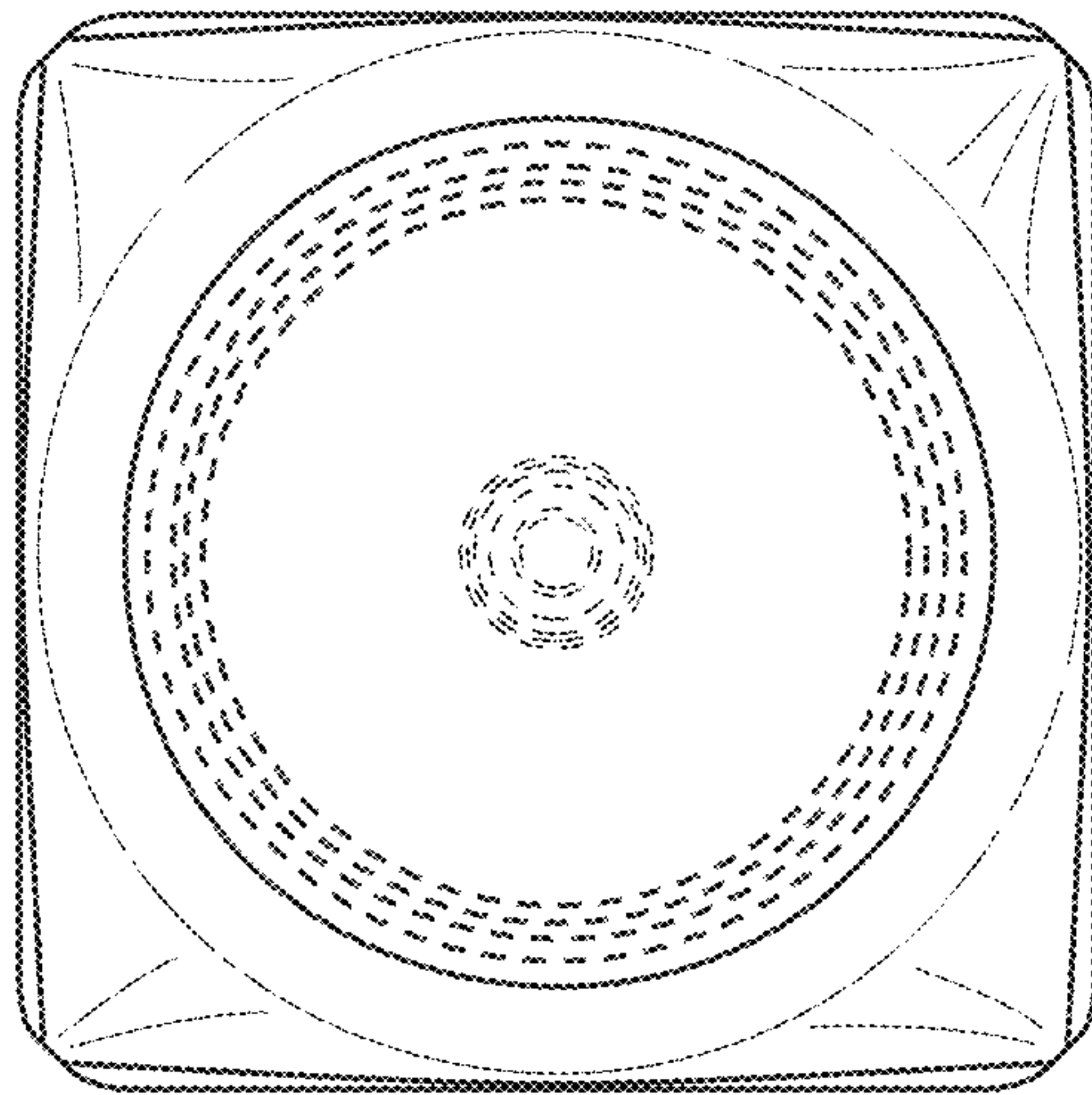
