FIG. 4 is a back view of the bottle of FIG. 1;

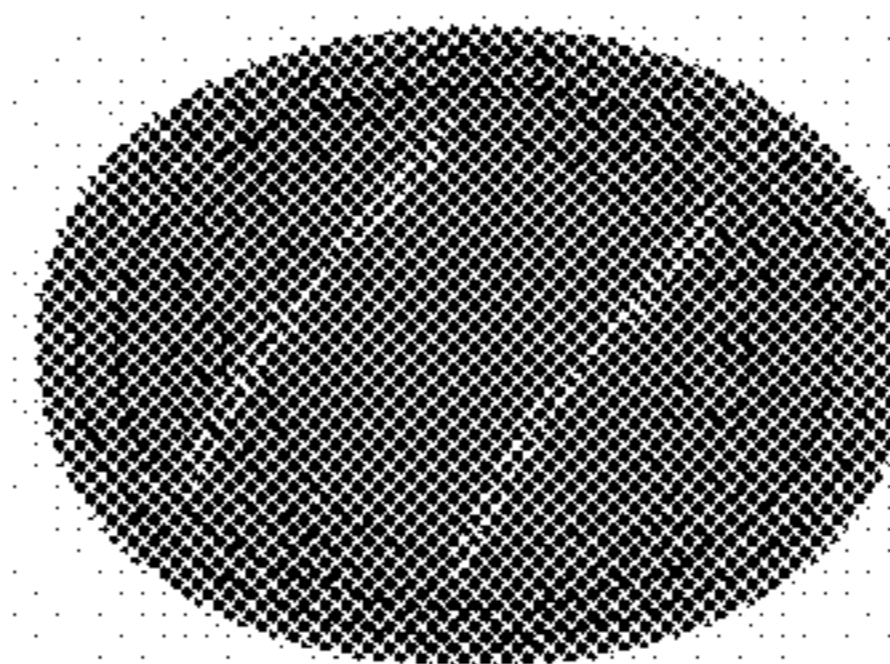
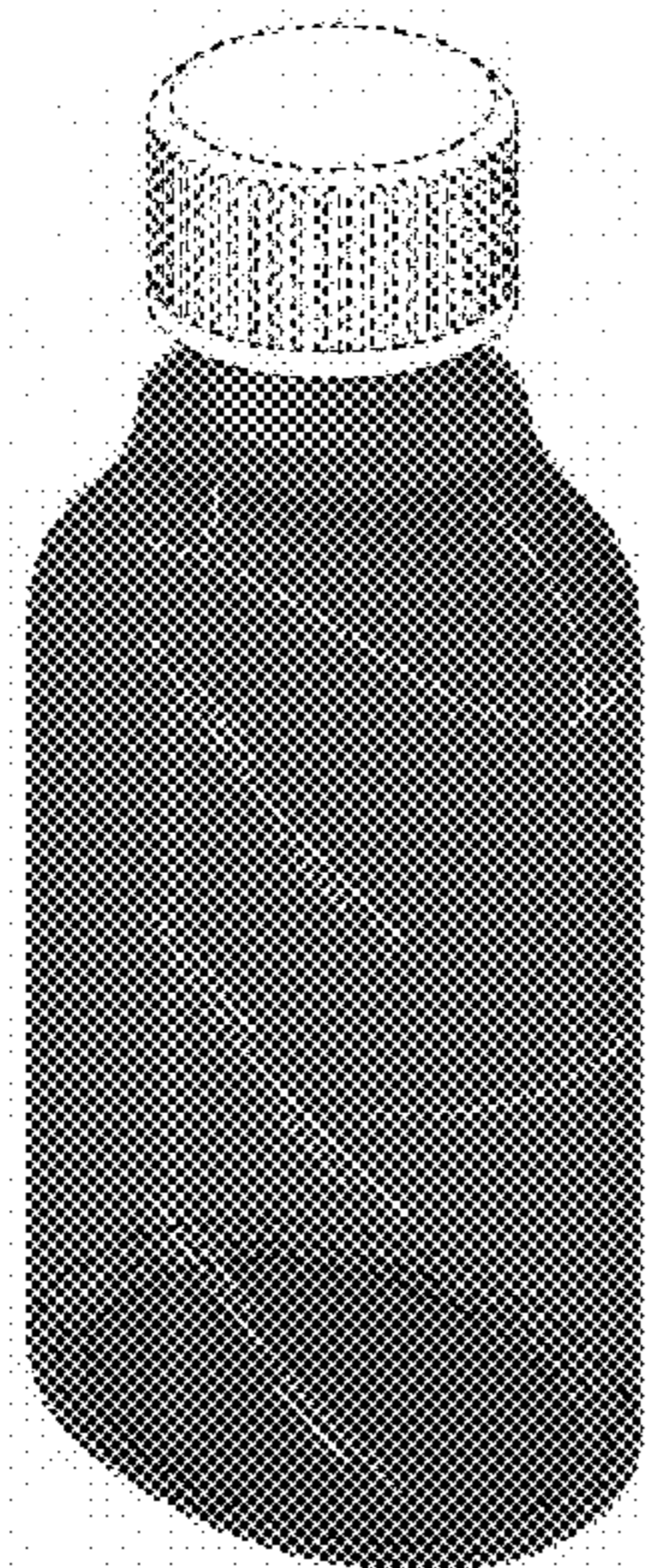
FIG. 5 is the other side view of the bottle of FIG. 1;

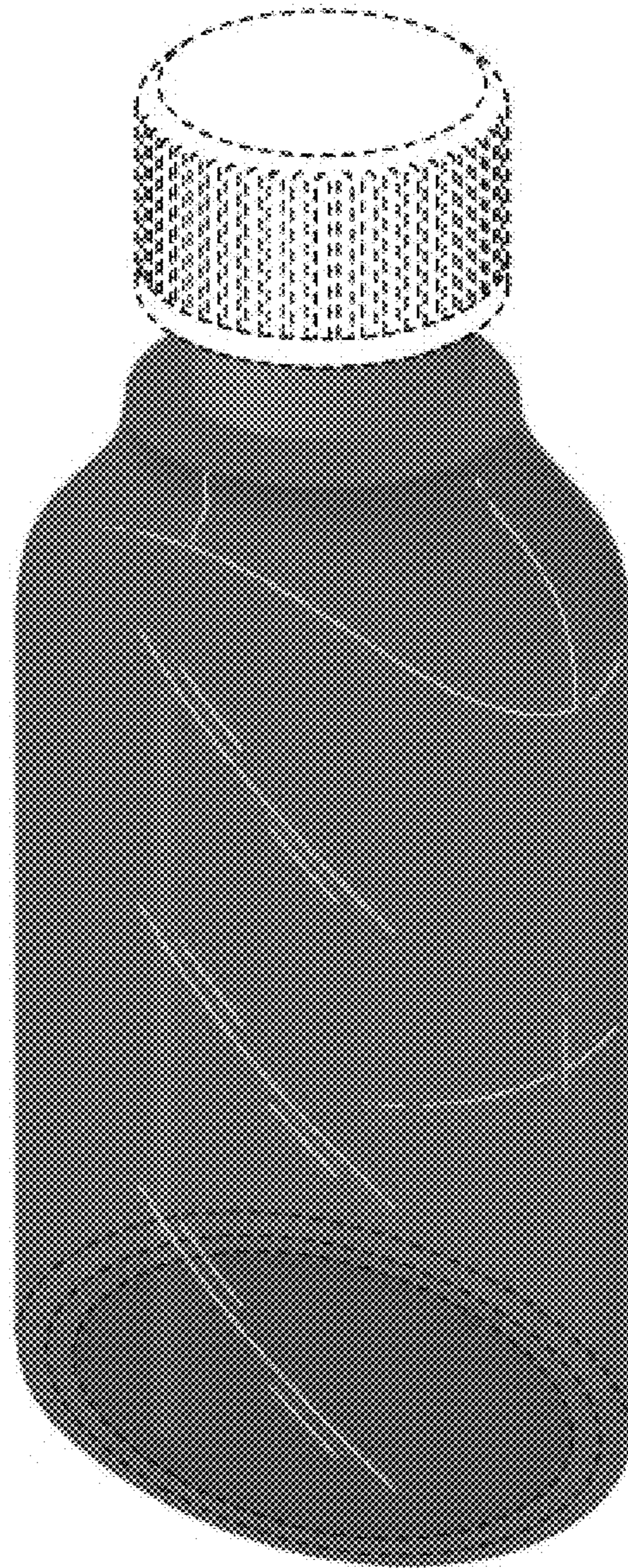

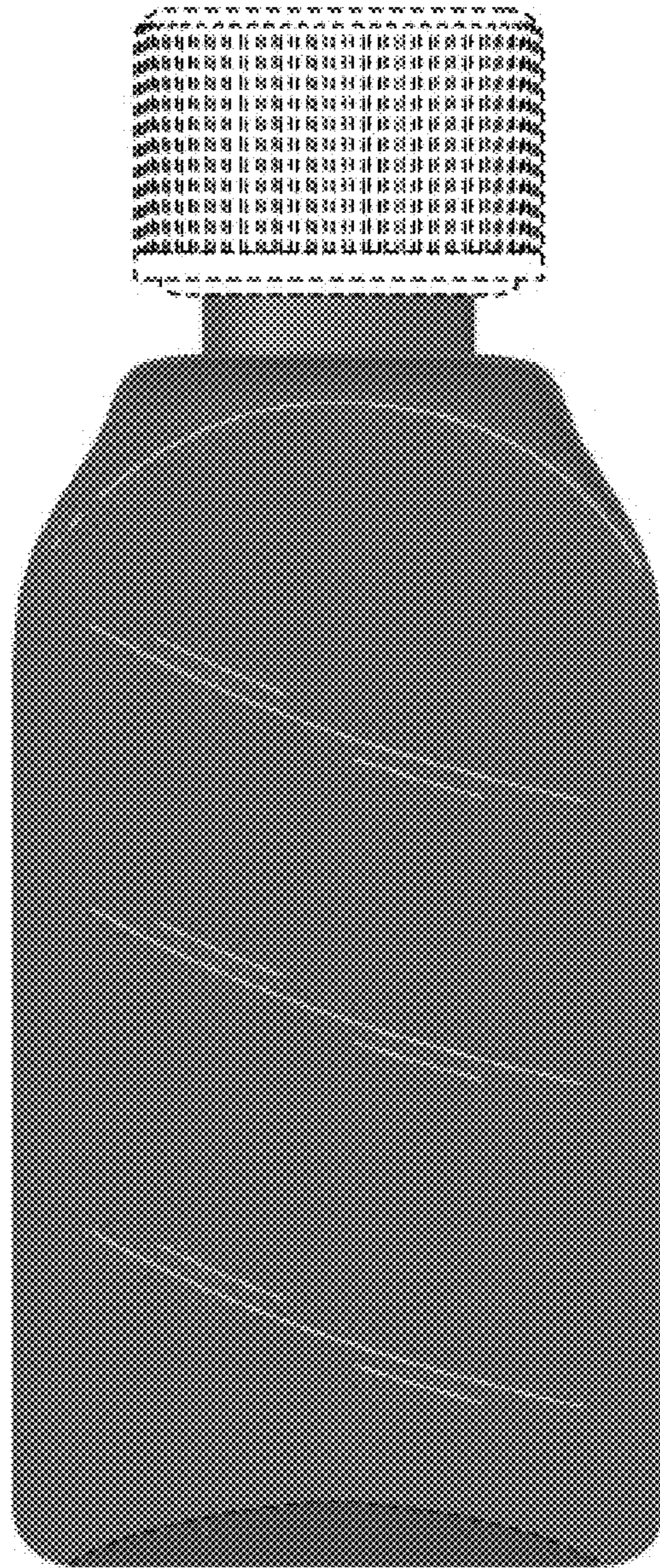

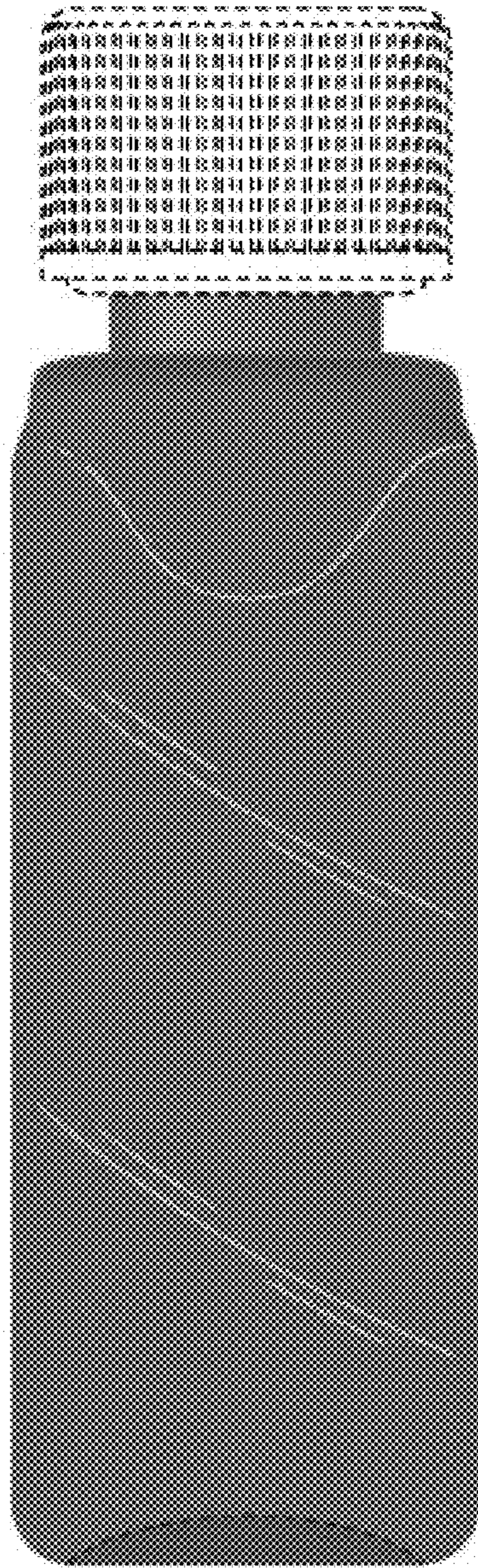

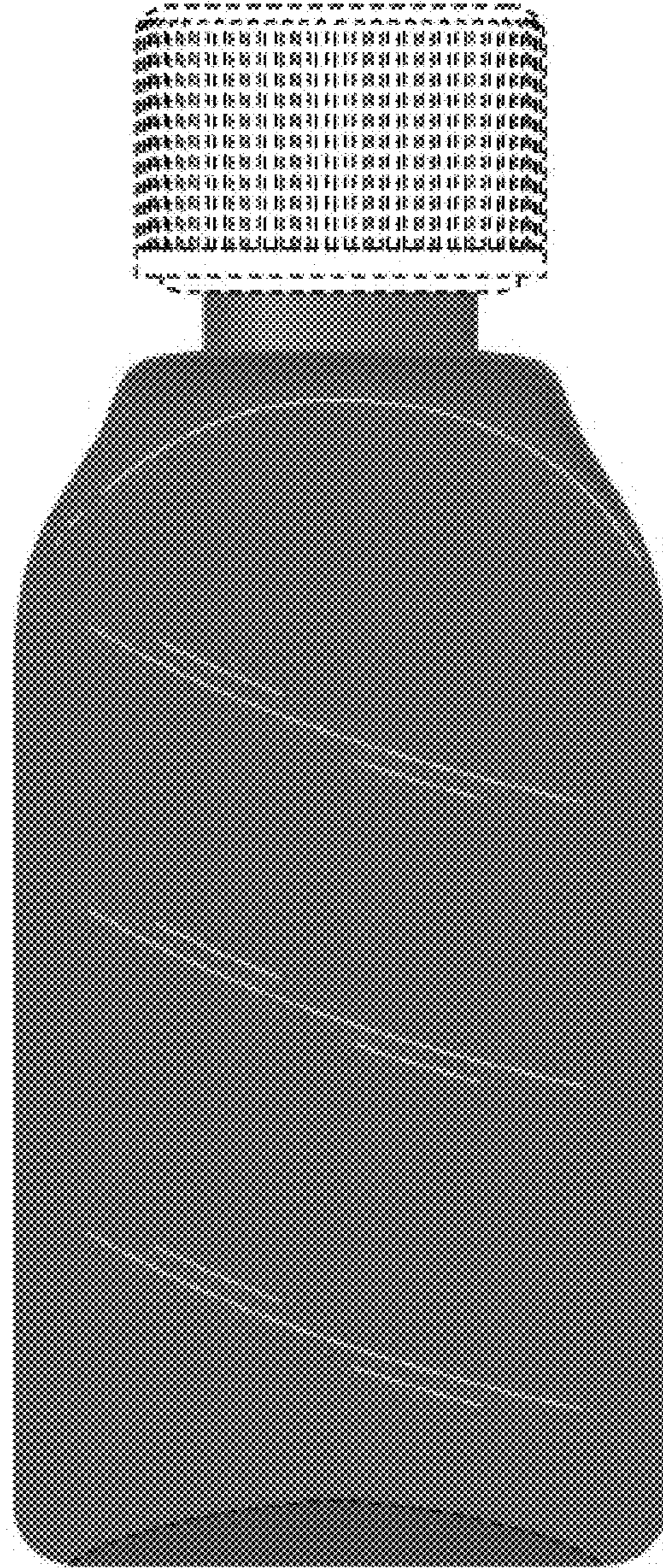

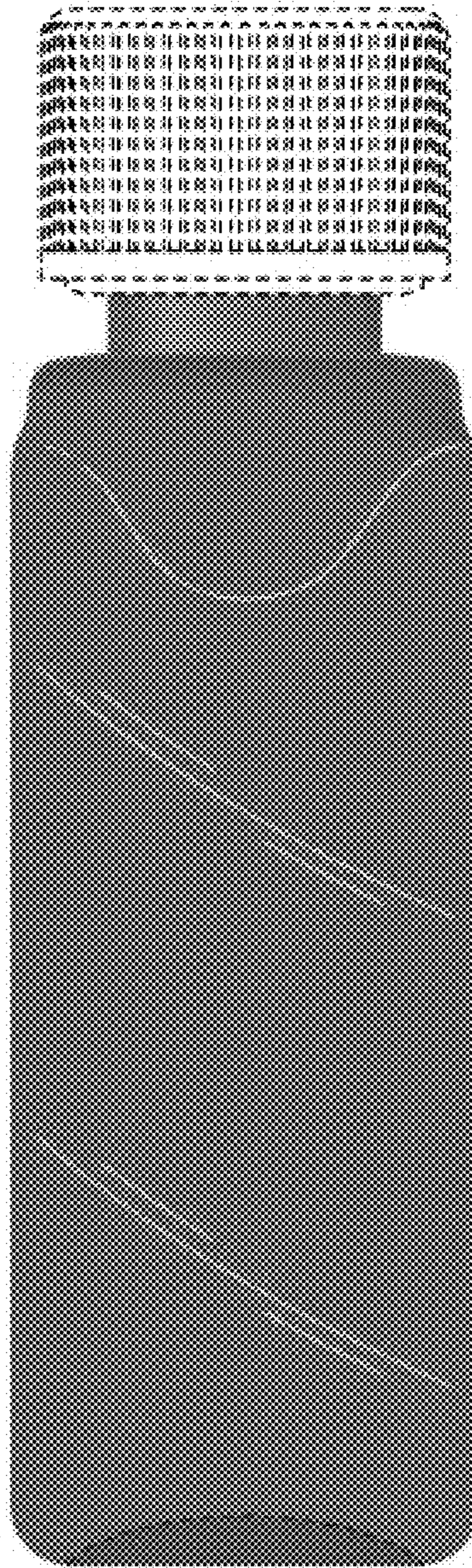

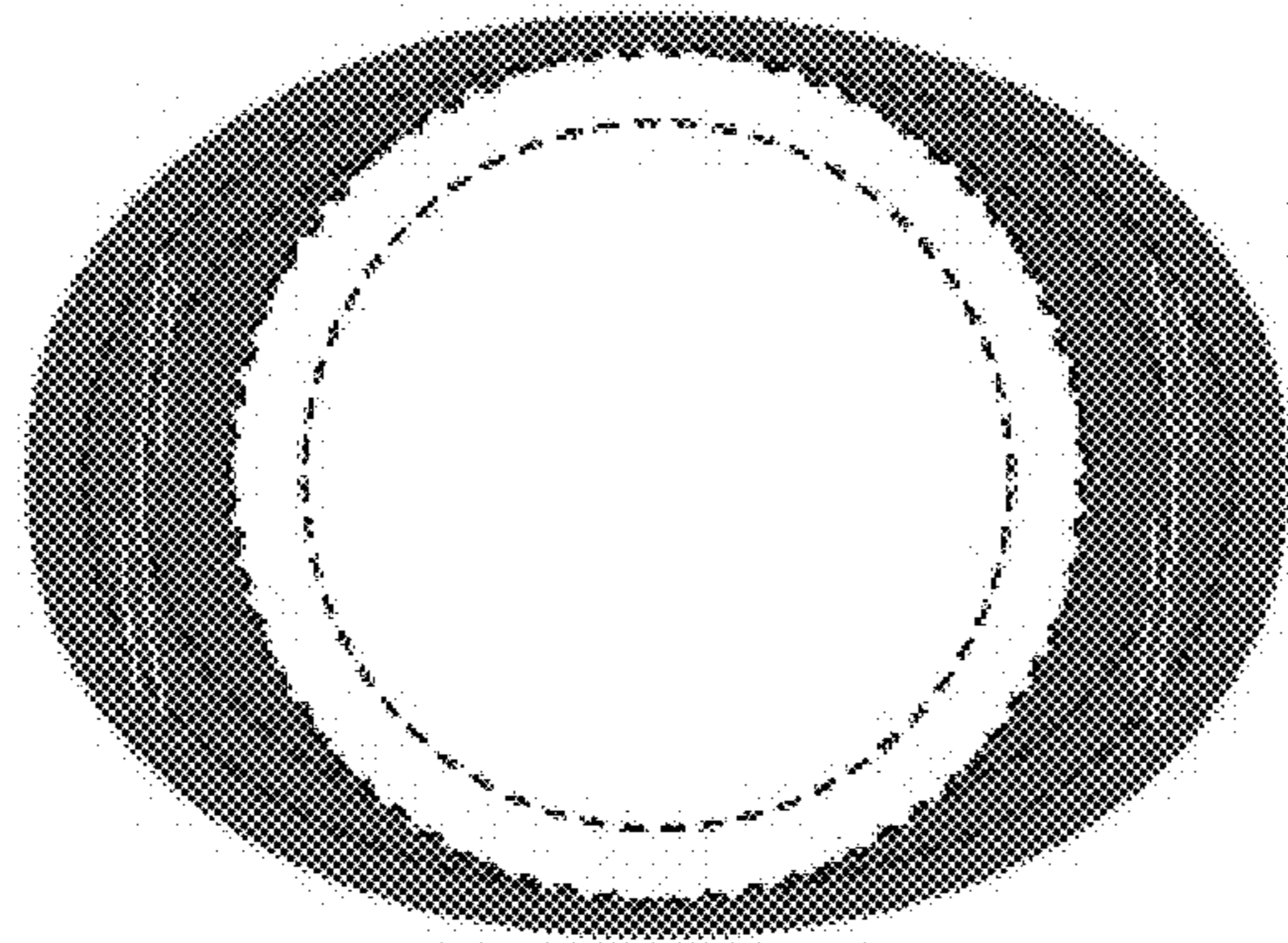

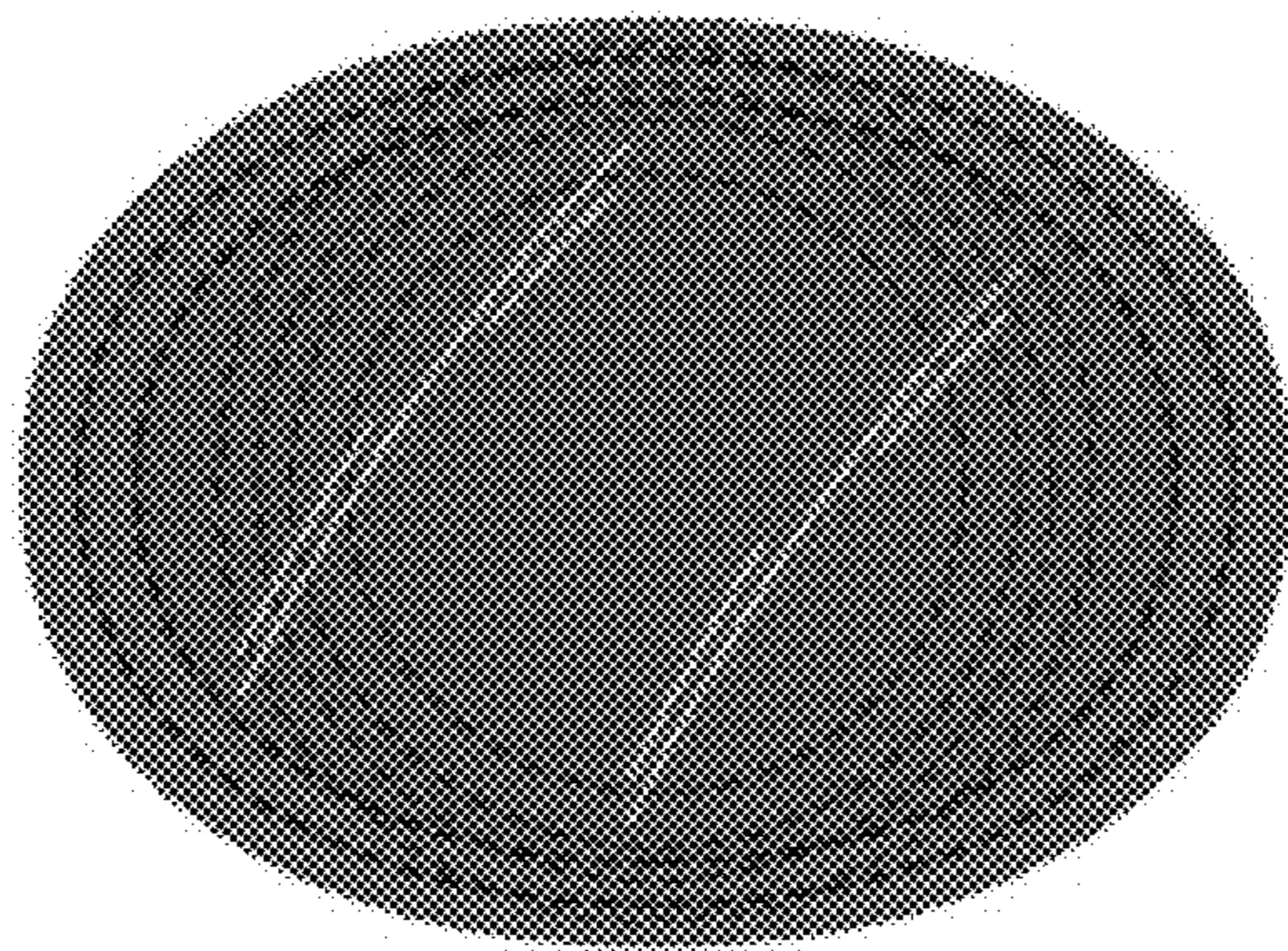
