(57) **CLAIM**

The ornamental design for a vehicle exterior, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left side perspective view of a vehicle exterior showing our new design; FIG. 2 is a top, rear and left side perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left side elevational view thereof; FIG. 6 is a right side elevational view thereof; and, FIG. 7 is a top plan view thereof.

The bottom left side of the vehicle front upper grille within broken lines and lighter gray scale in FIGS. 1 and 3 depict environmental subject matter only, and forms no part of the claimed design.

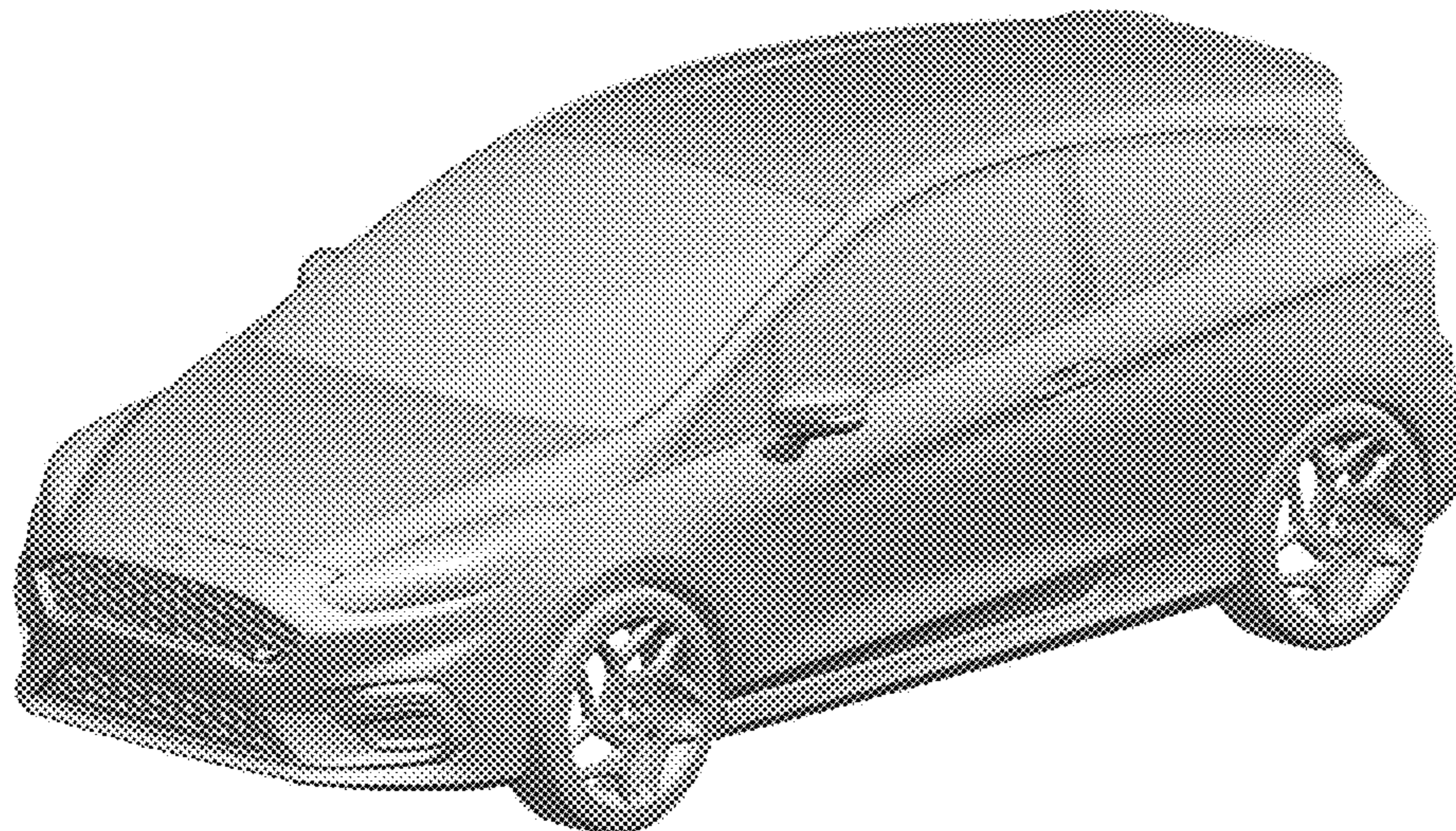

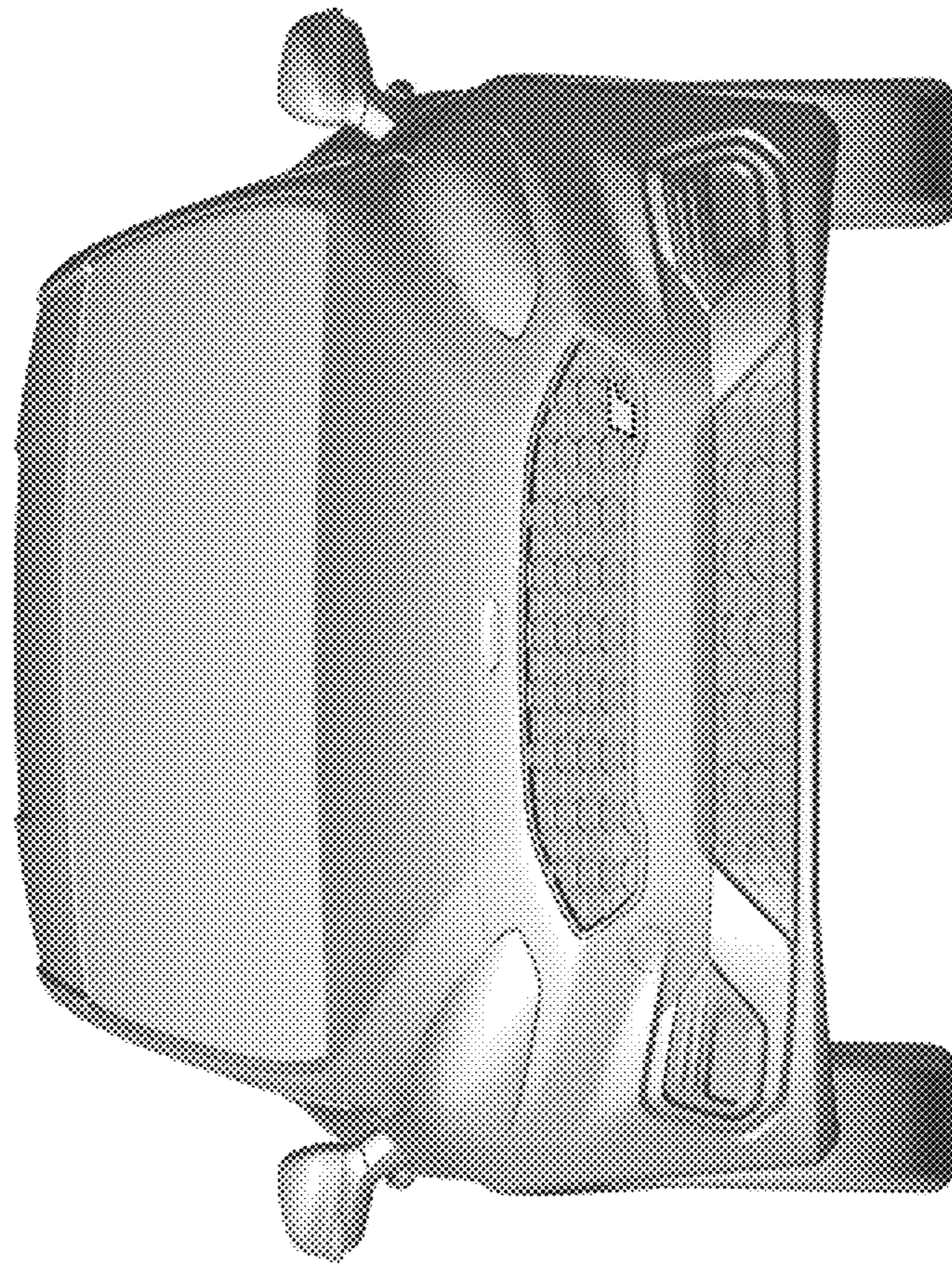

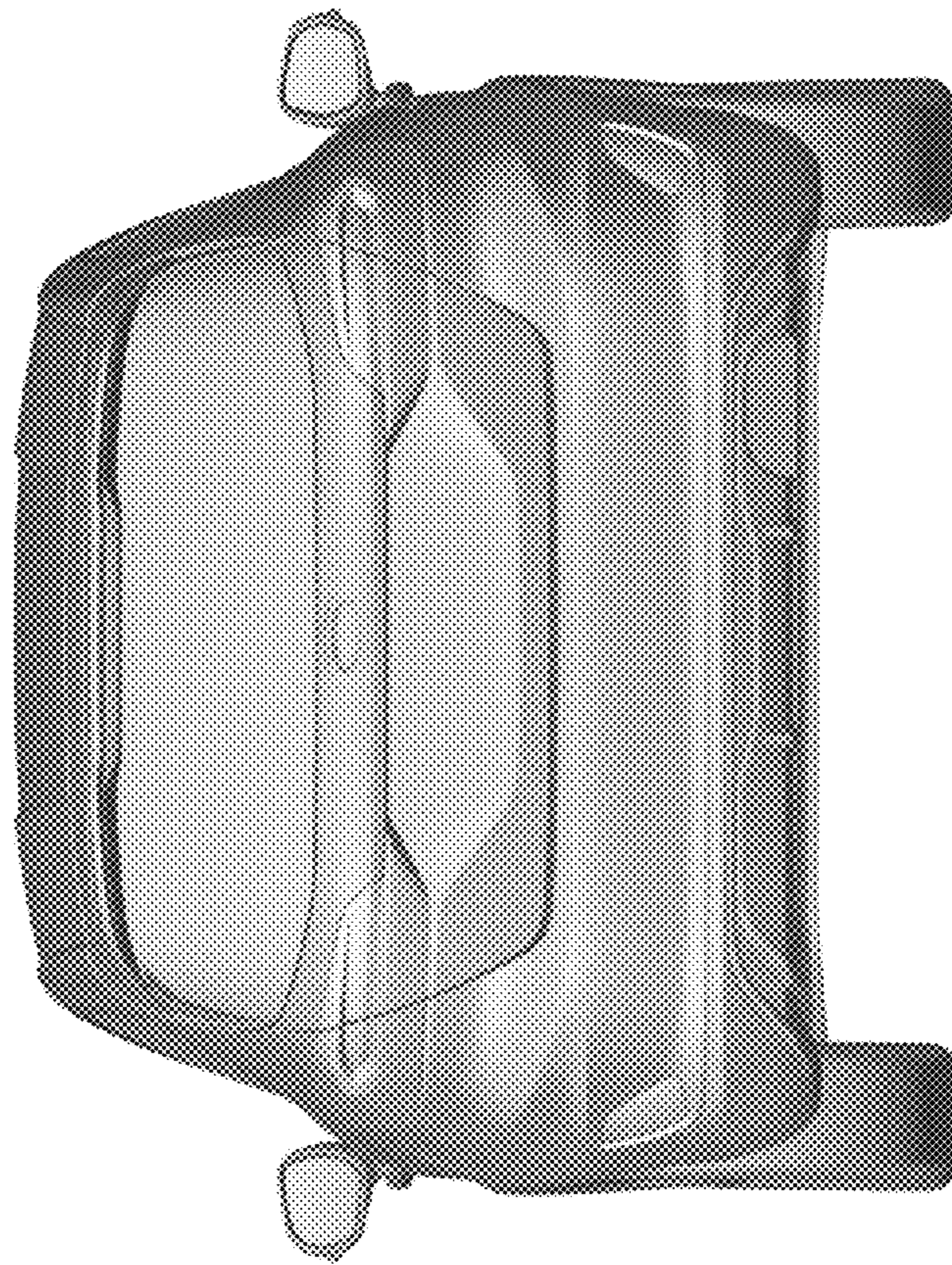
