FIG. 4 is a rear view thereof.

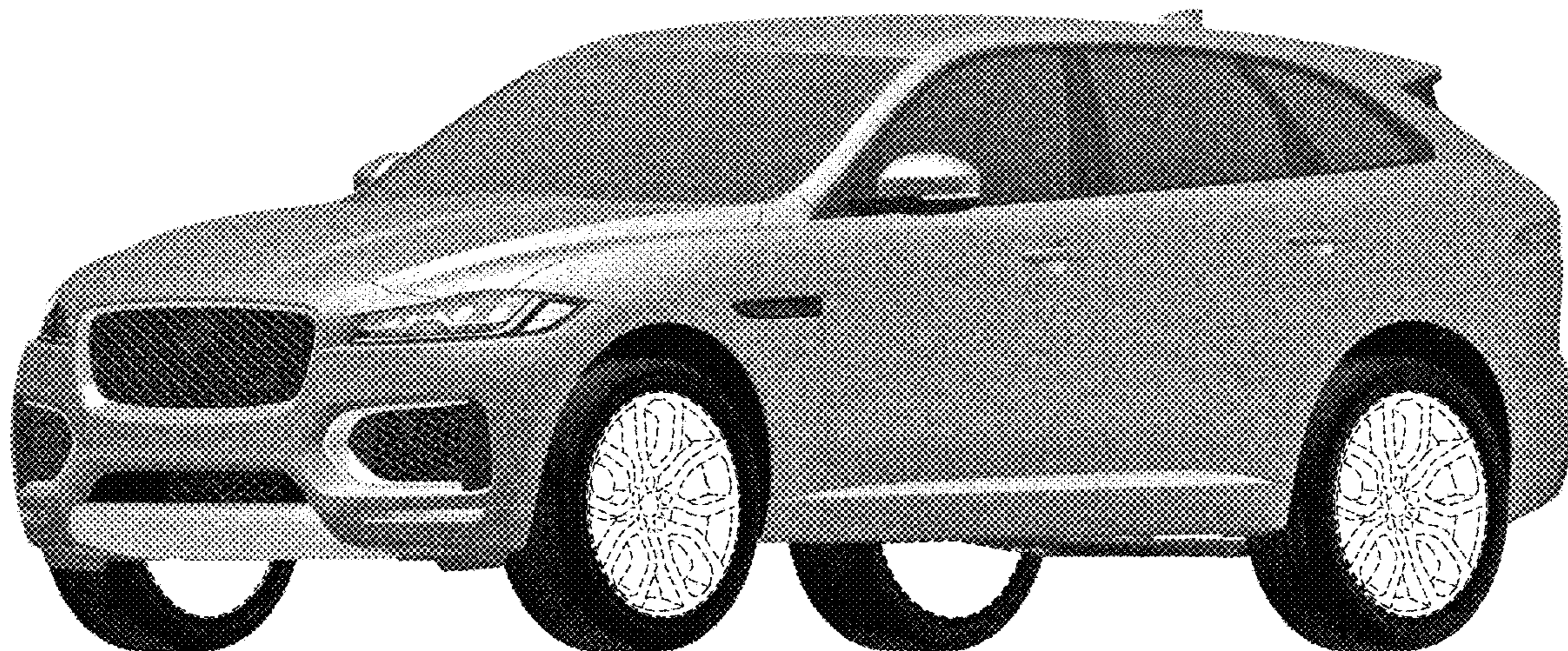
FIG. 5 is left side view thereof.

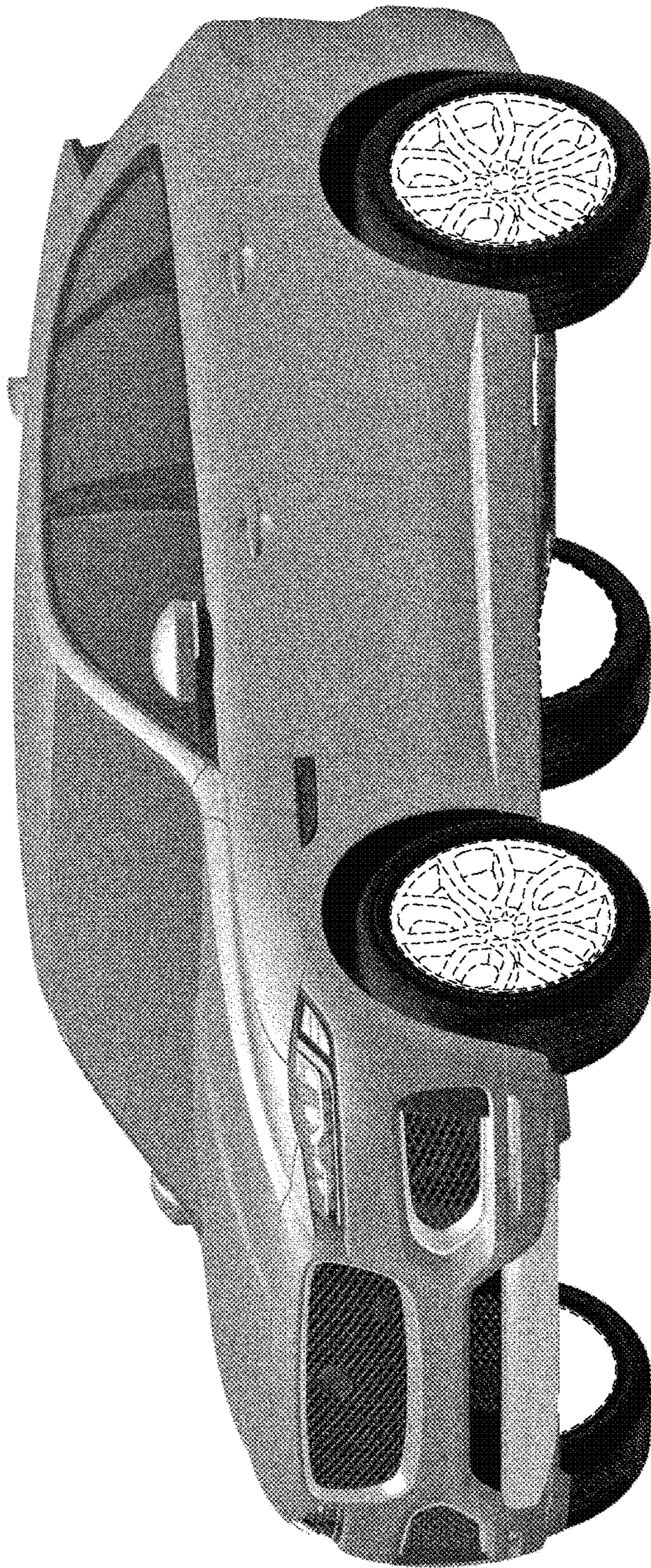

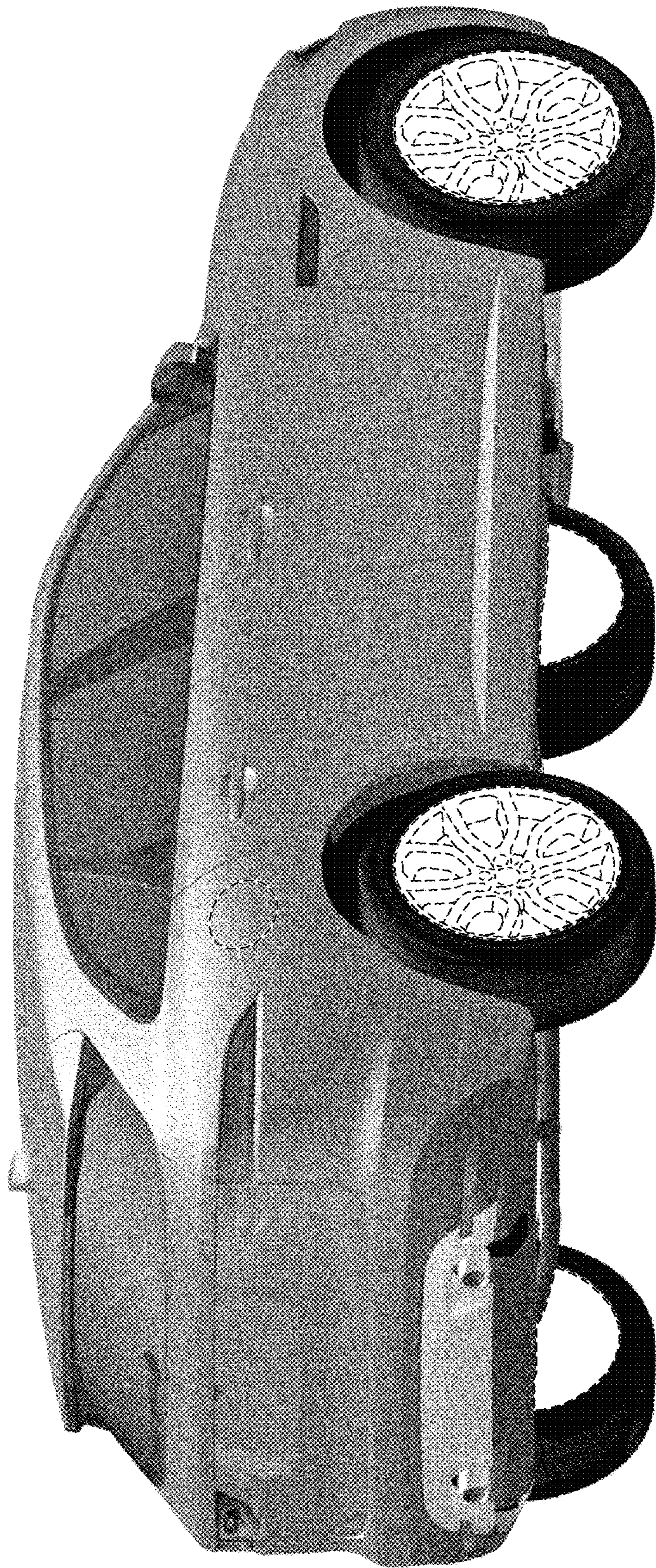

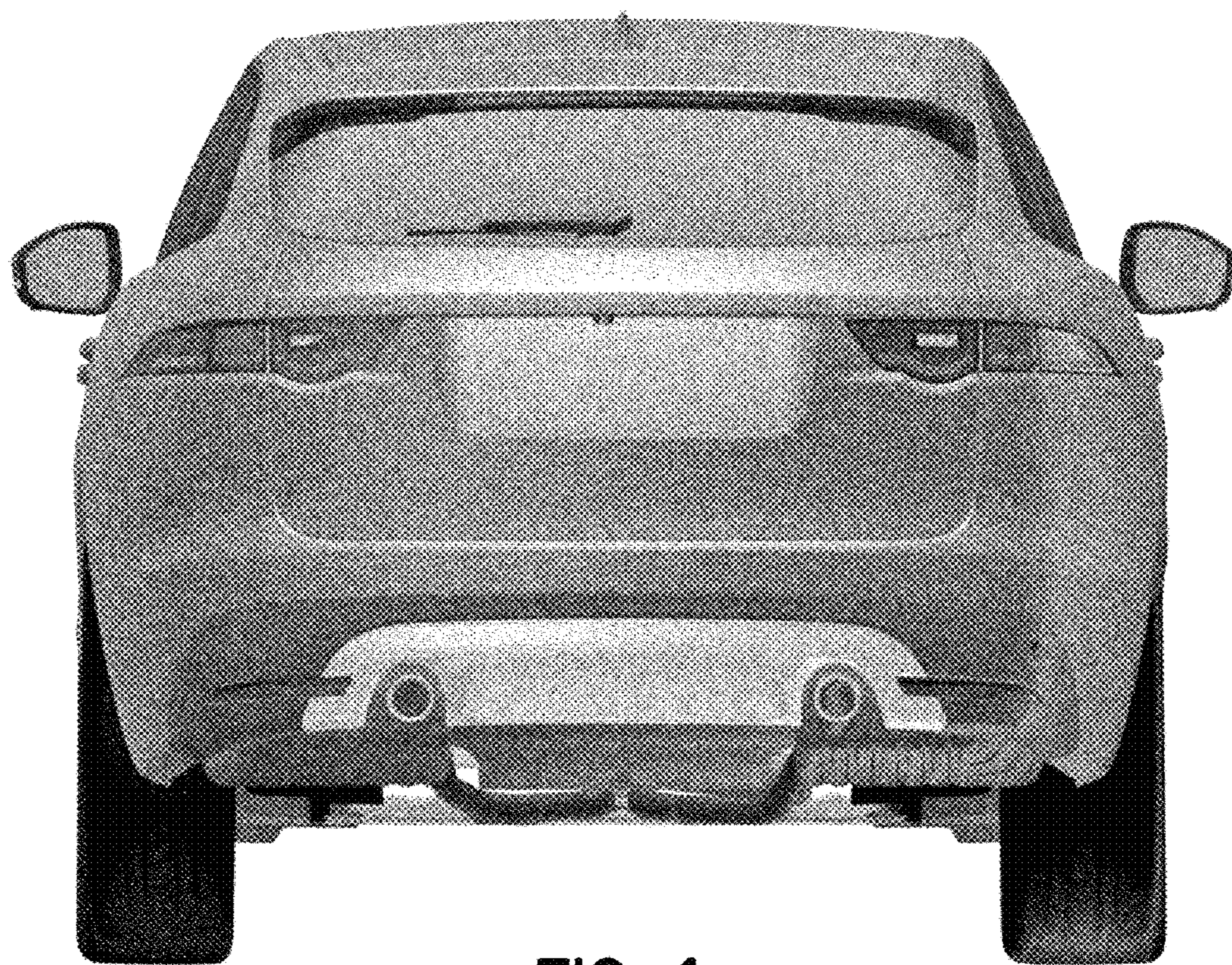

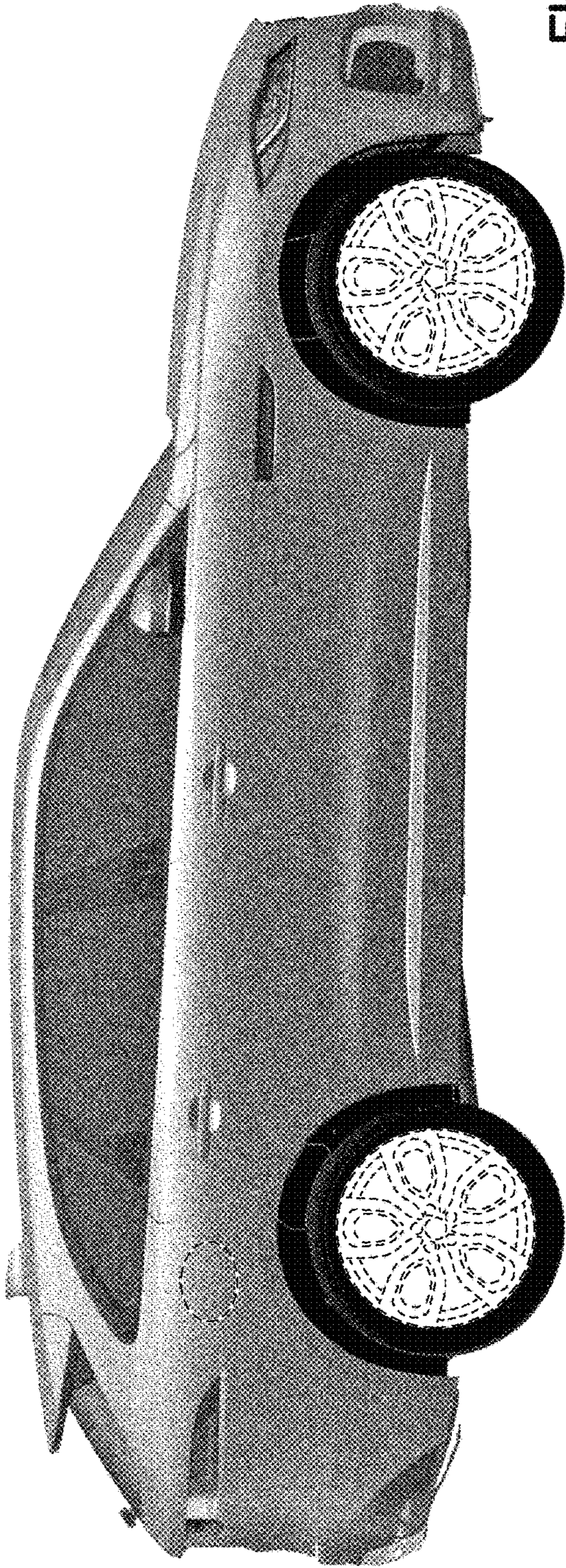

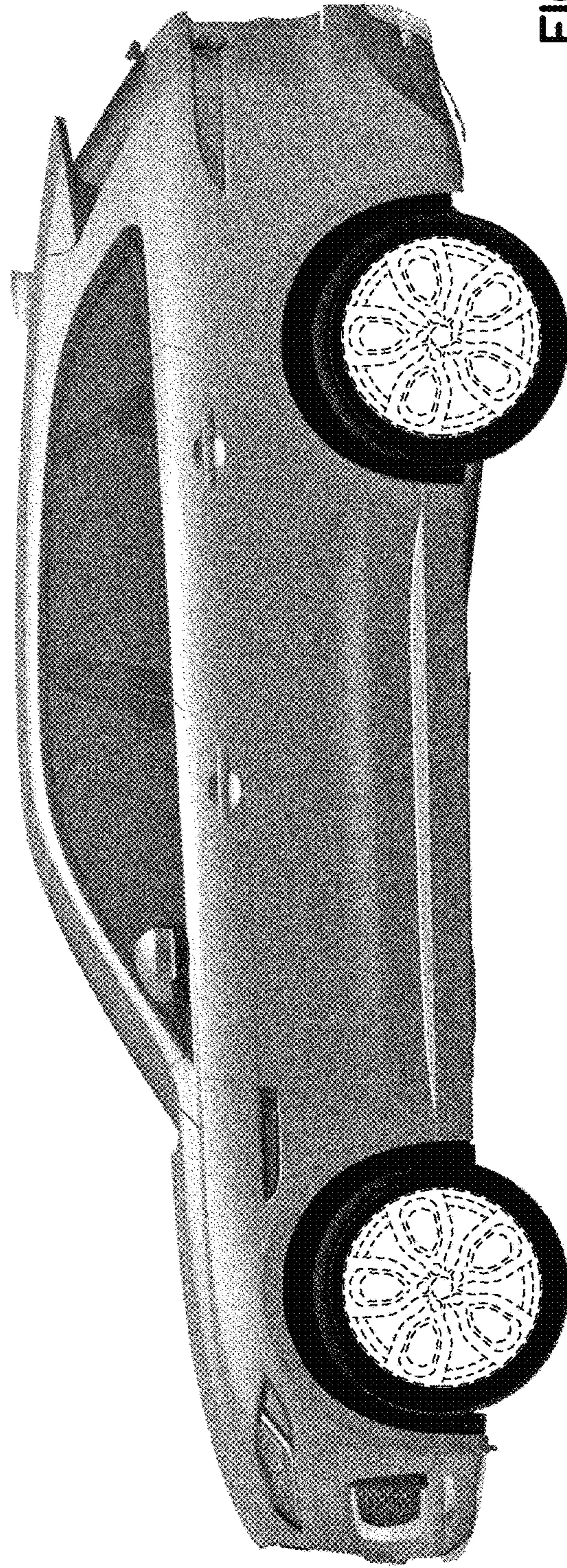

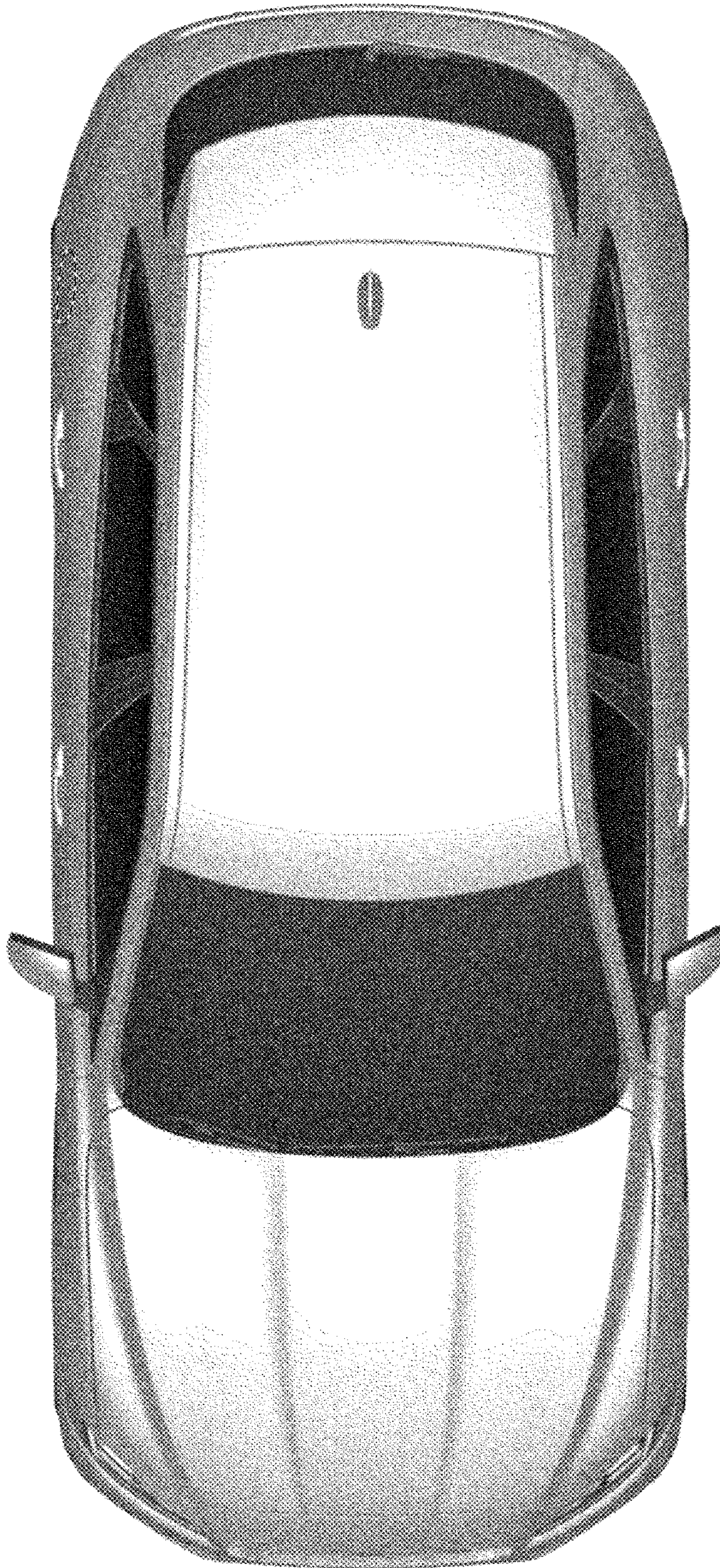
