(57) **CLAIM**

The ornamental design for a wheel, as shown and described.

DESCRIPTION

FIG. 1 is a front left perspective view of a wheel for a vehicle according to the present invention.

FIG. 2 is a front view of the wheel shown in FIG. 1.

FIG. 3 is a left side view thereof, the right side view being a mirror image thereof.

FIG. 4 is a rear view thereof; and,

FIG. 5 is a rear right perspective view thereof.

The broken line showing of the valve stem and the valve stem hole are included for the purpose of illustrating environment and form no part of the claimed design.

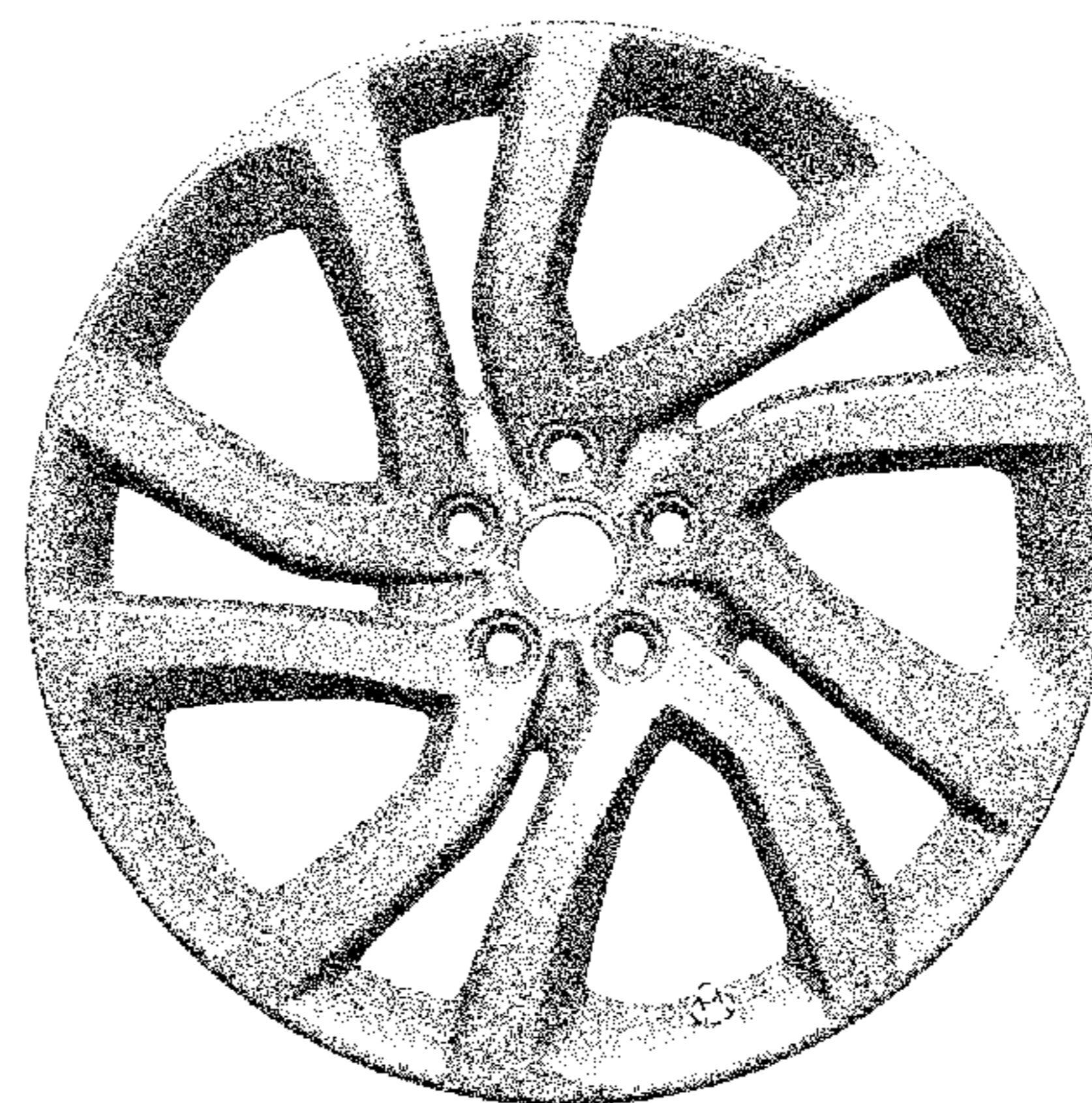

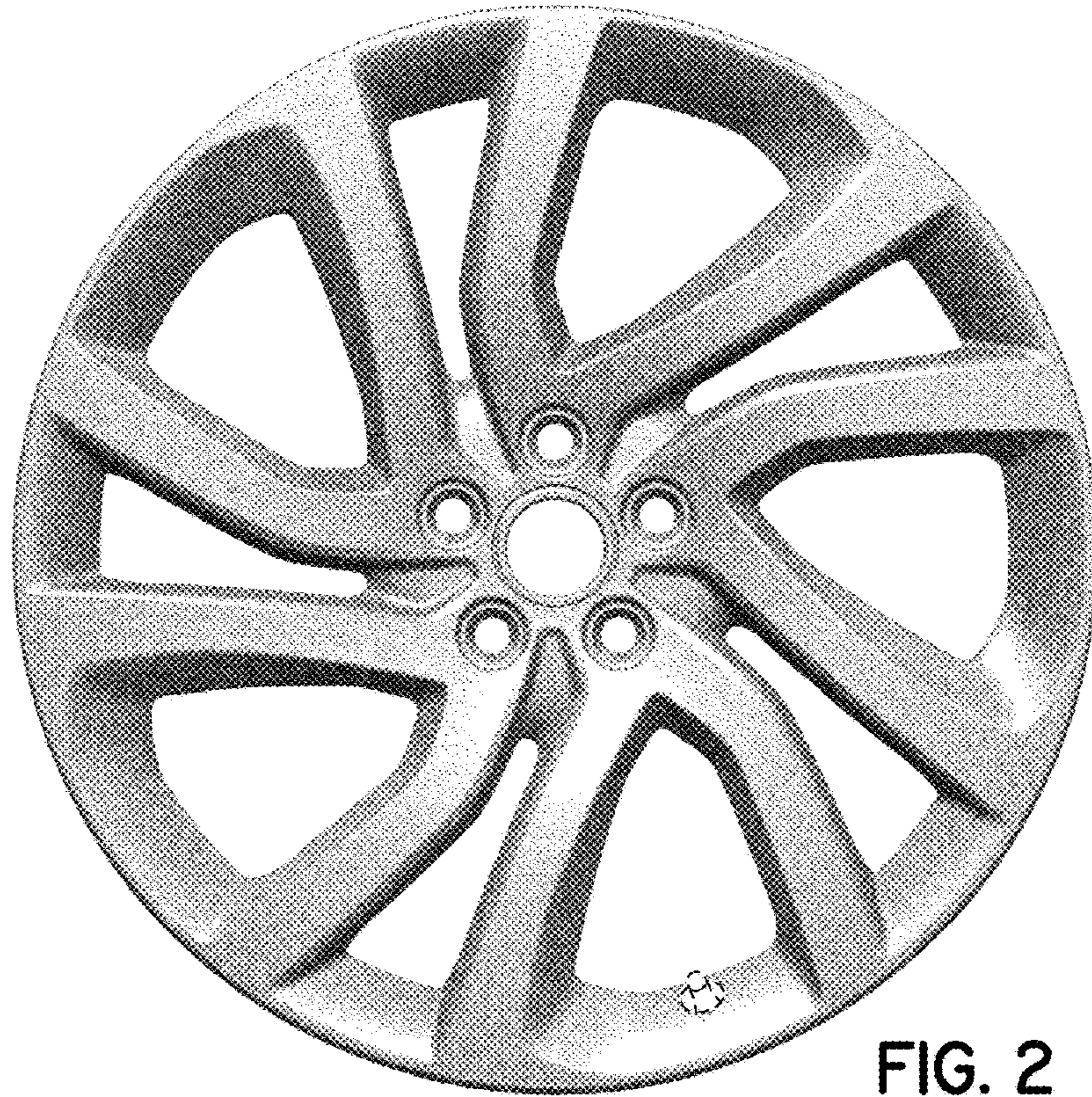

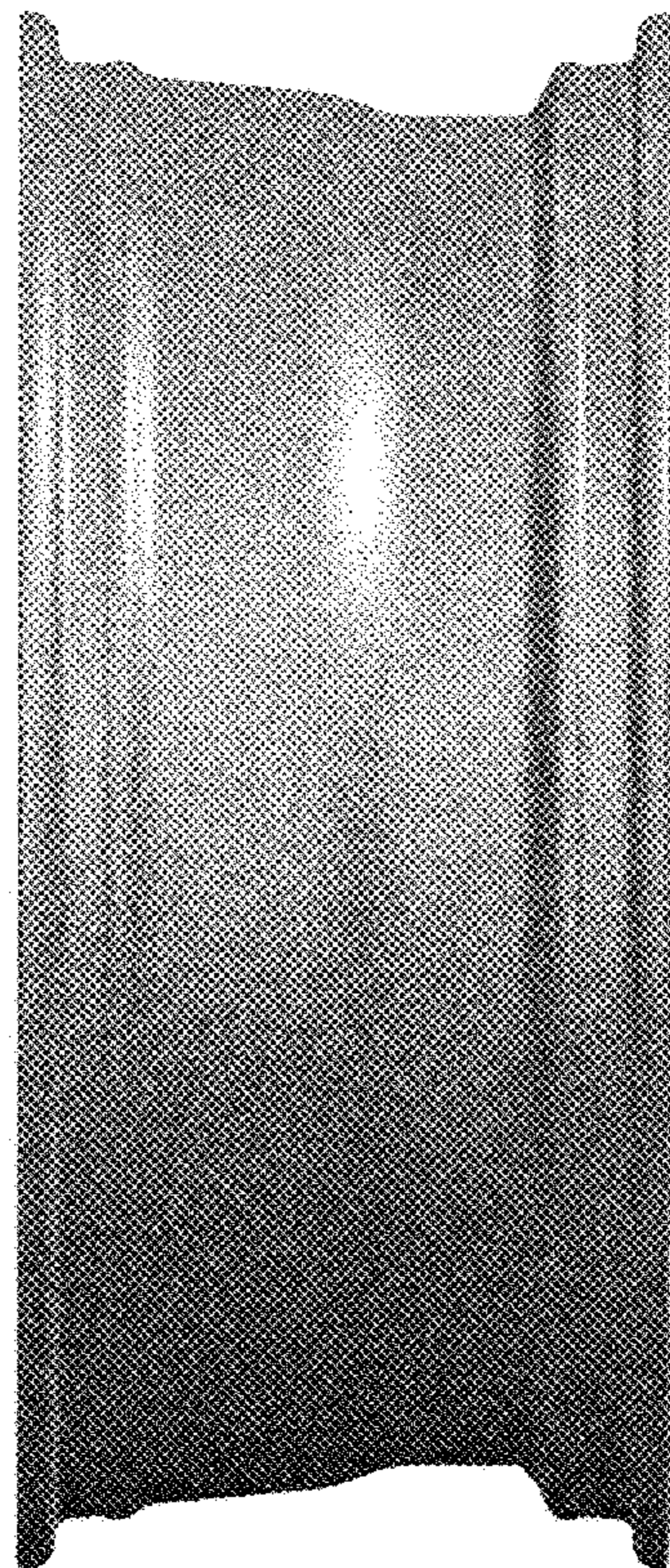

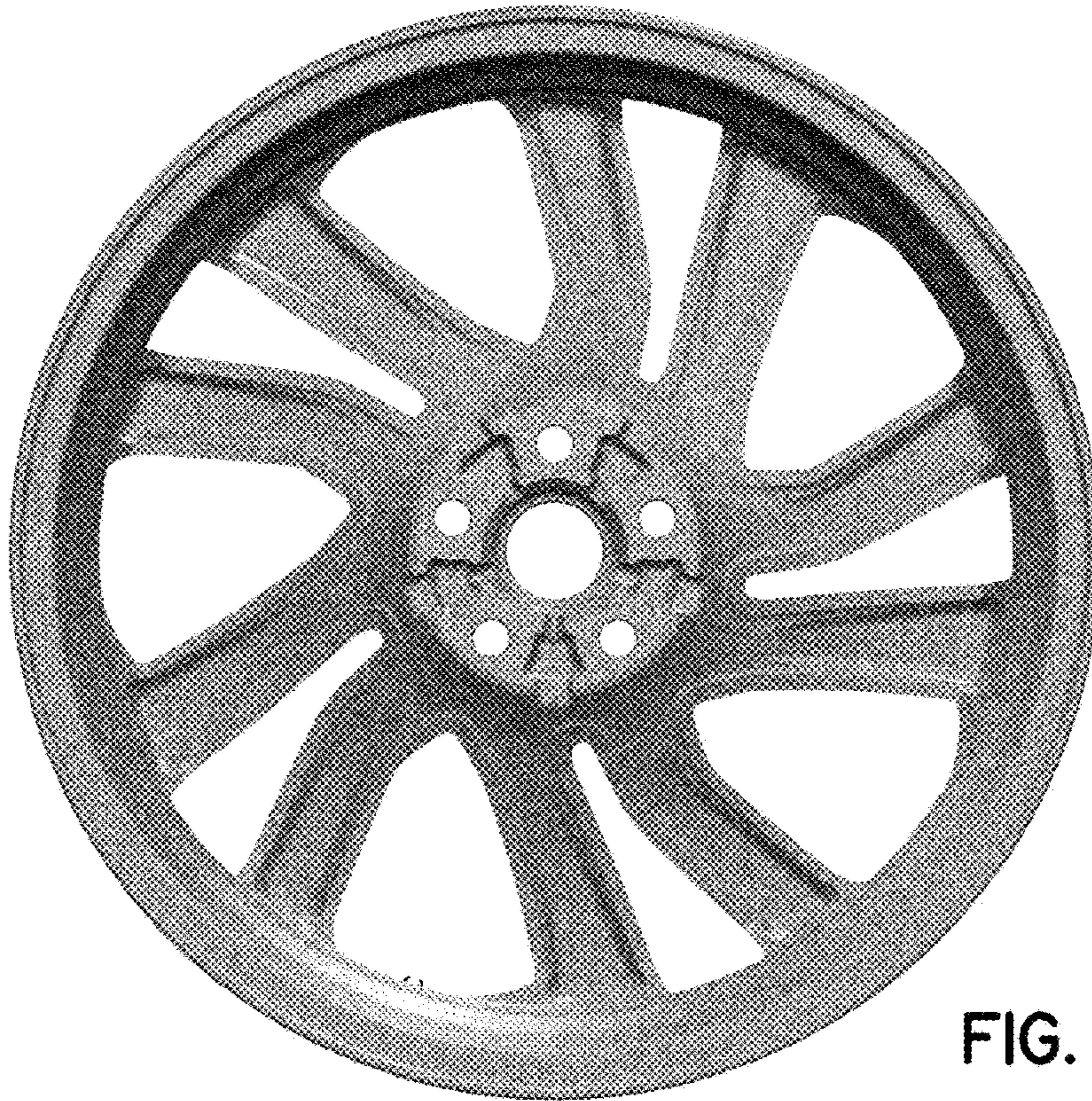
