(57) **CLAIM**

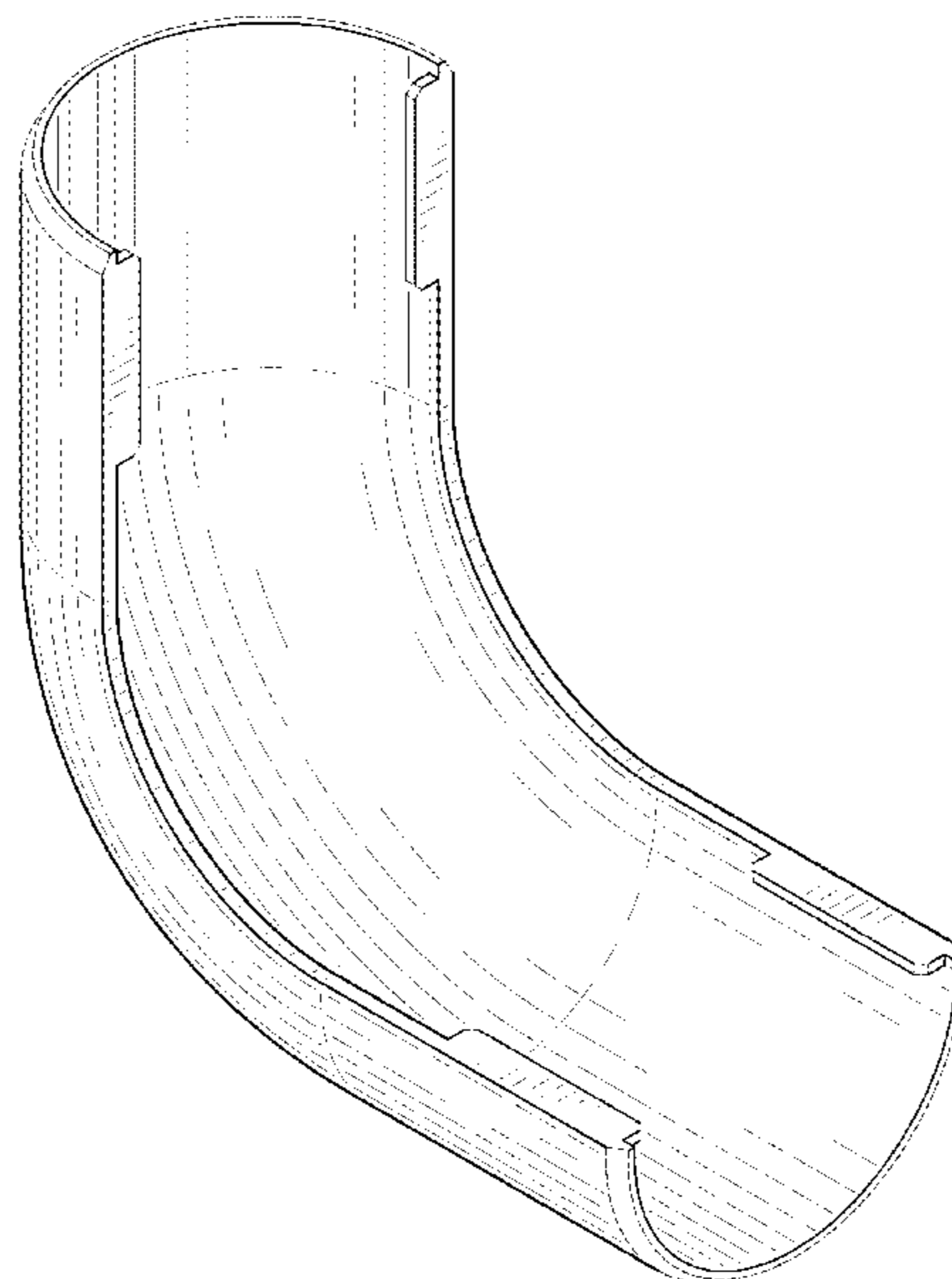
I claim the ornamental design for a corner cable conduit, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a corner cable conduit showing my design;  
FIG. 2 is a left side view thereof;  
FIG. 3 is a right side view thereof;  
FIG. 4 is a top plan view thereof;  
FIG. 5 is a bottom plan view thereof;  
FIG. 6 is a front elevational view thereof; and,  
FIG. 7 is a rear elevational view thereof.  
The broken lines shown in the Figures represent portions of the corner cable conduit that form no part of the claimed design.

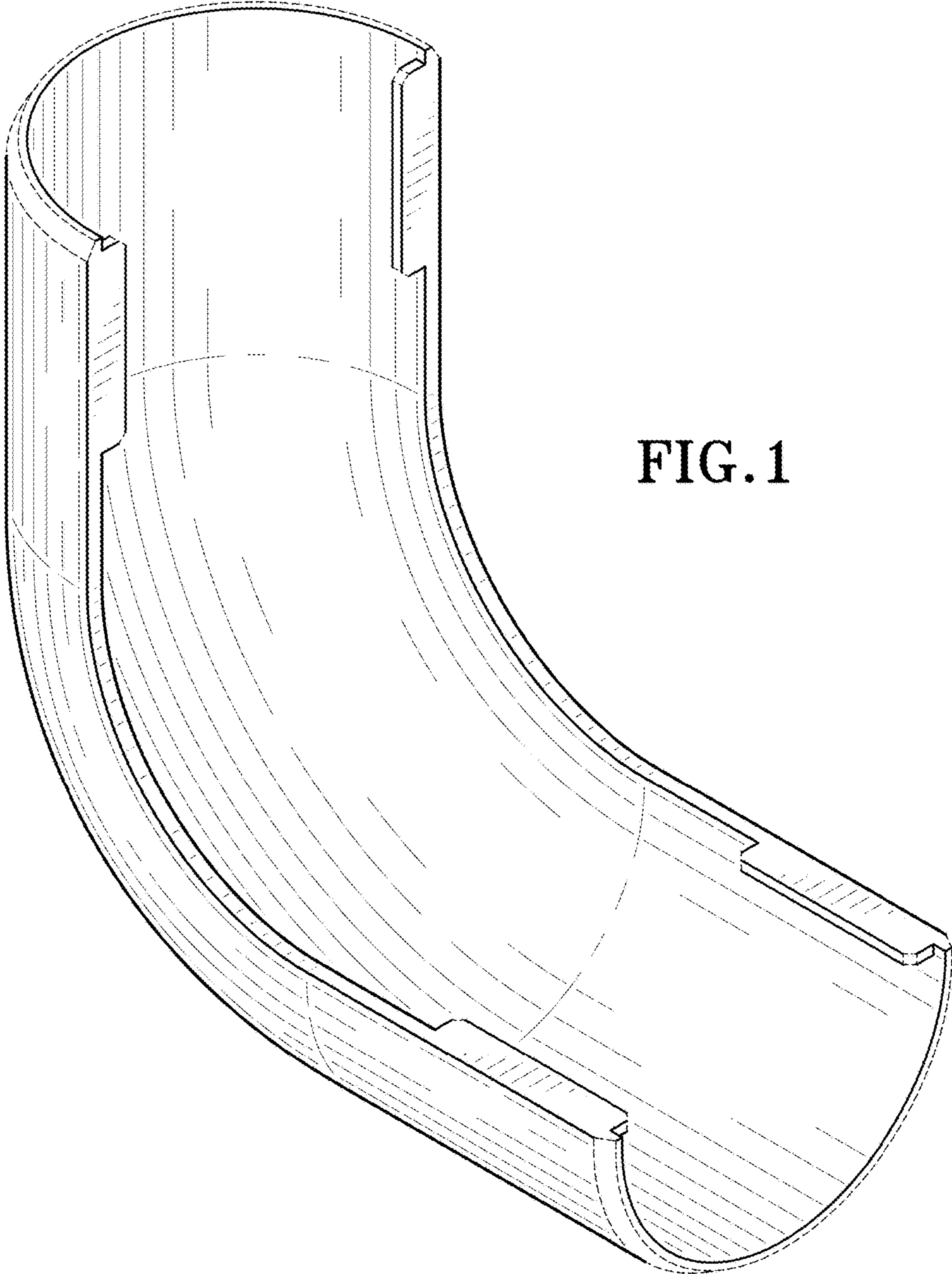

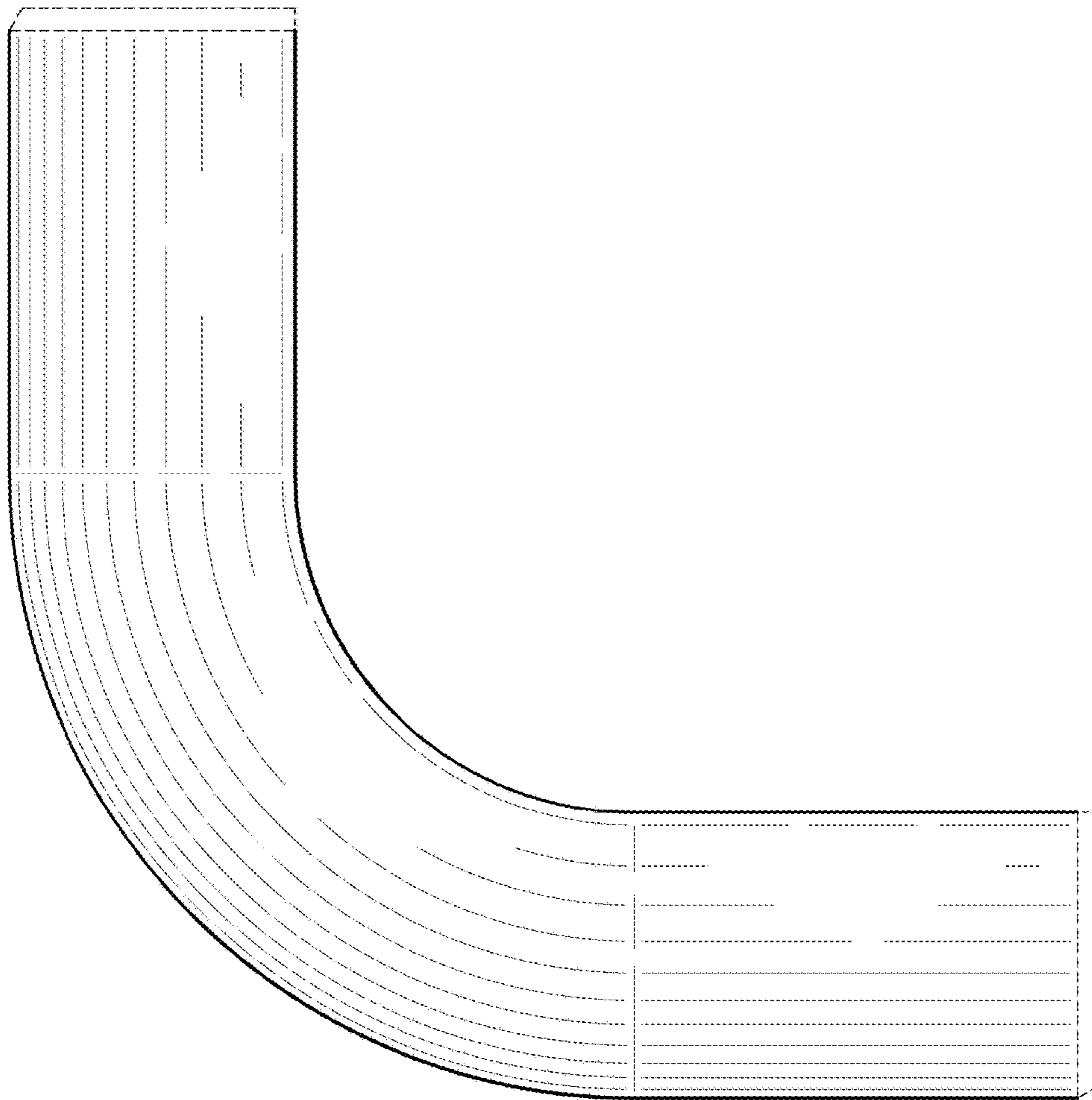

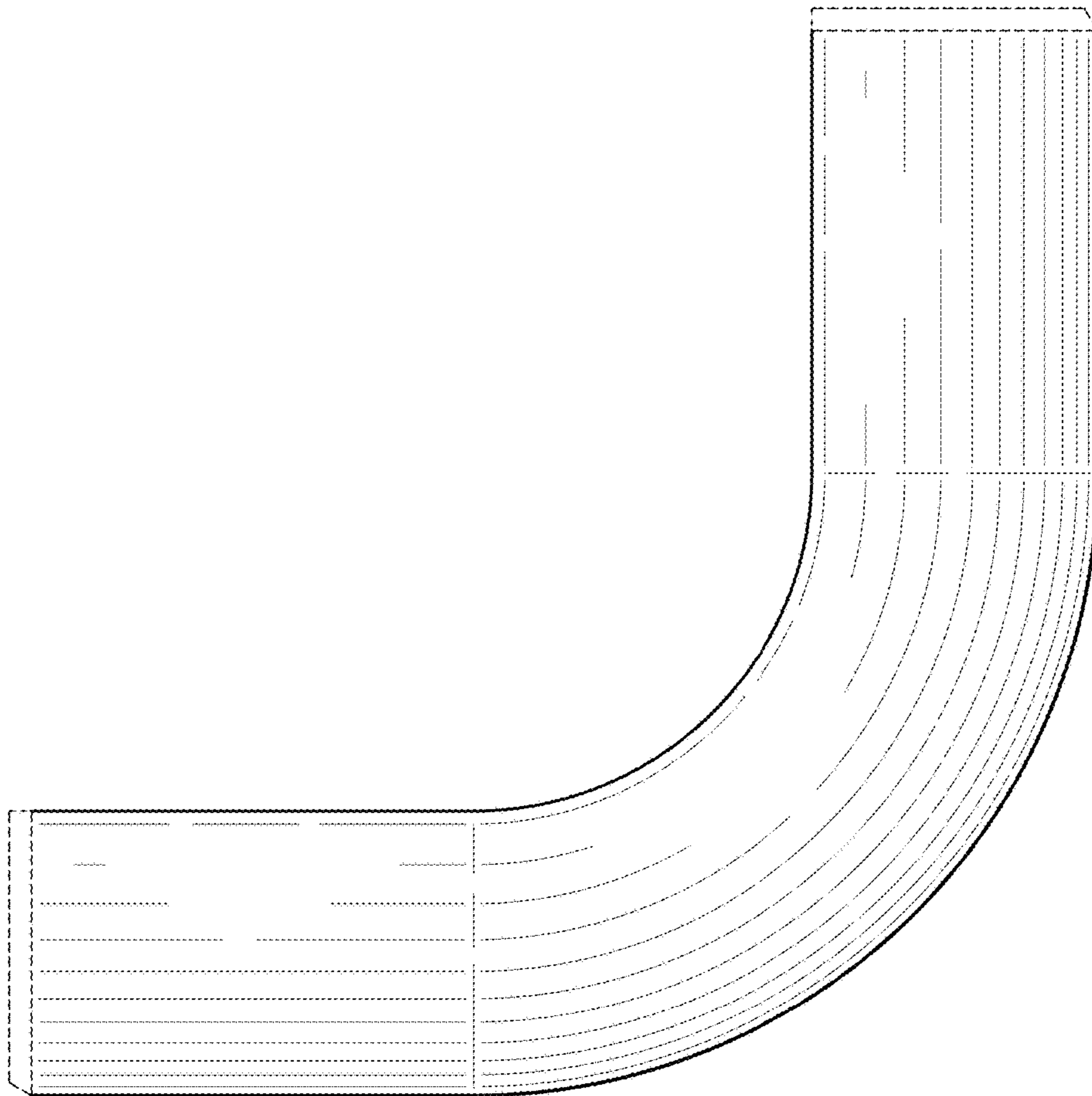

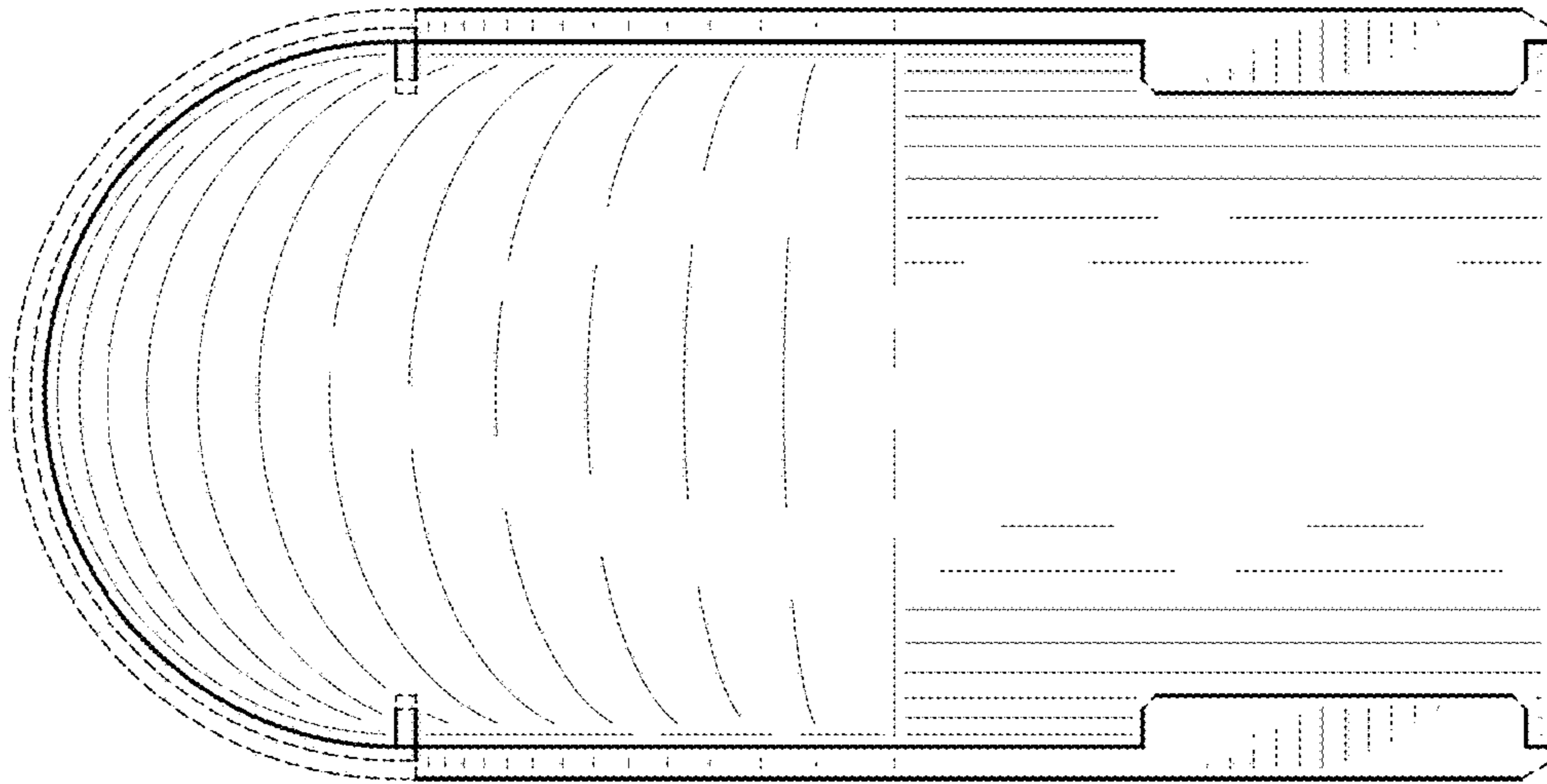

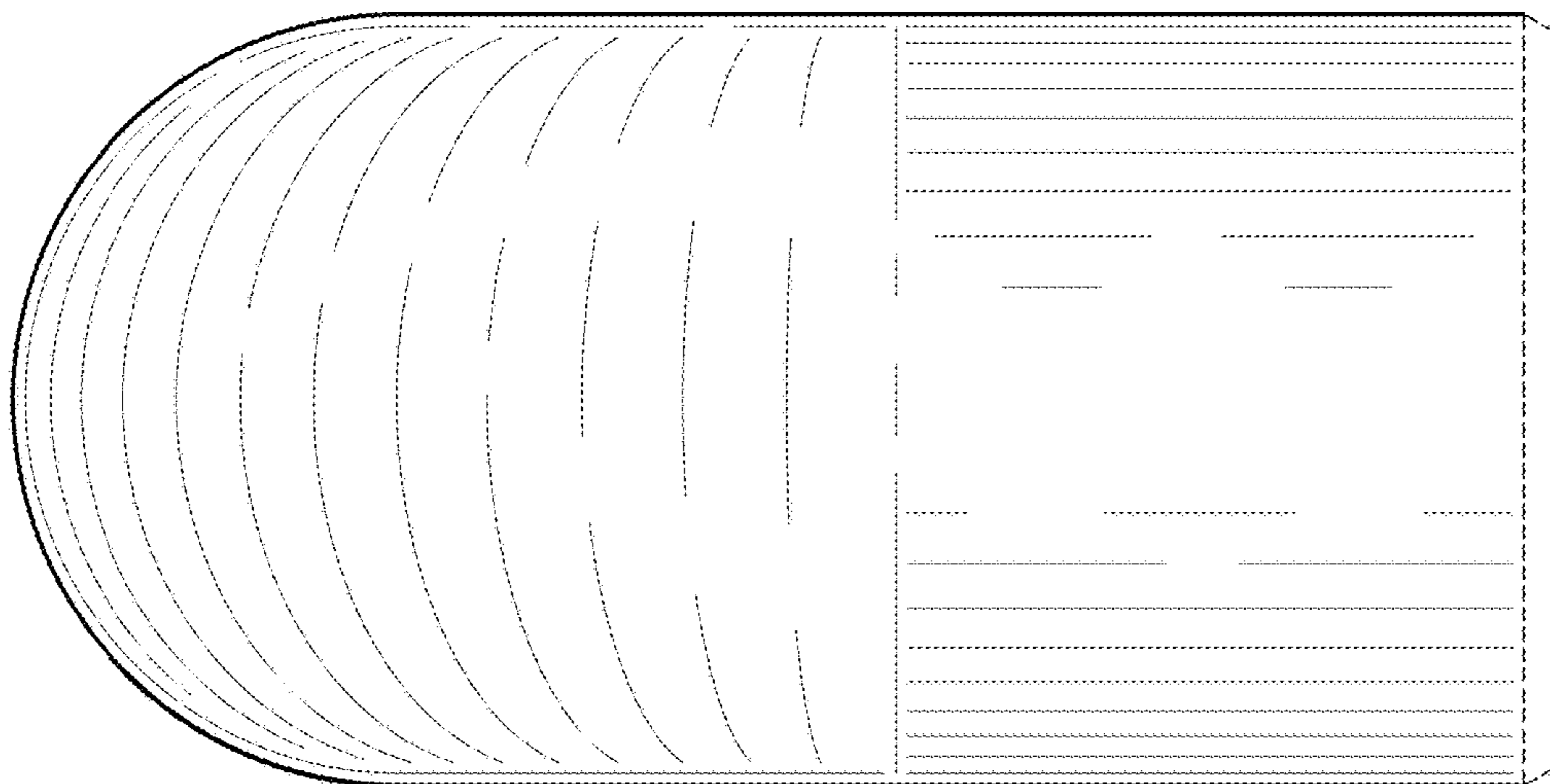

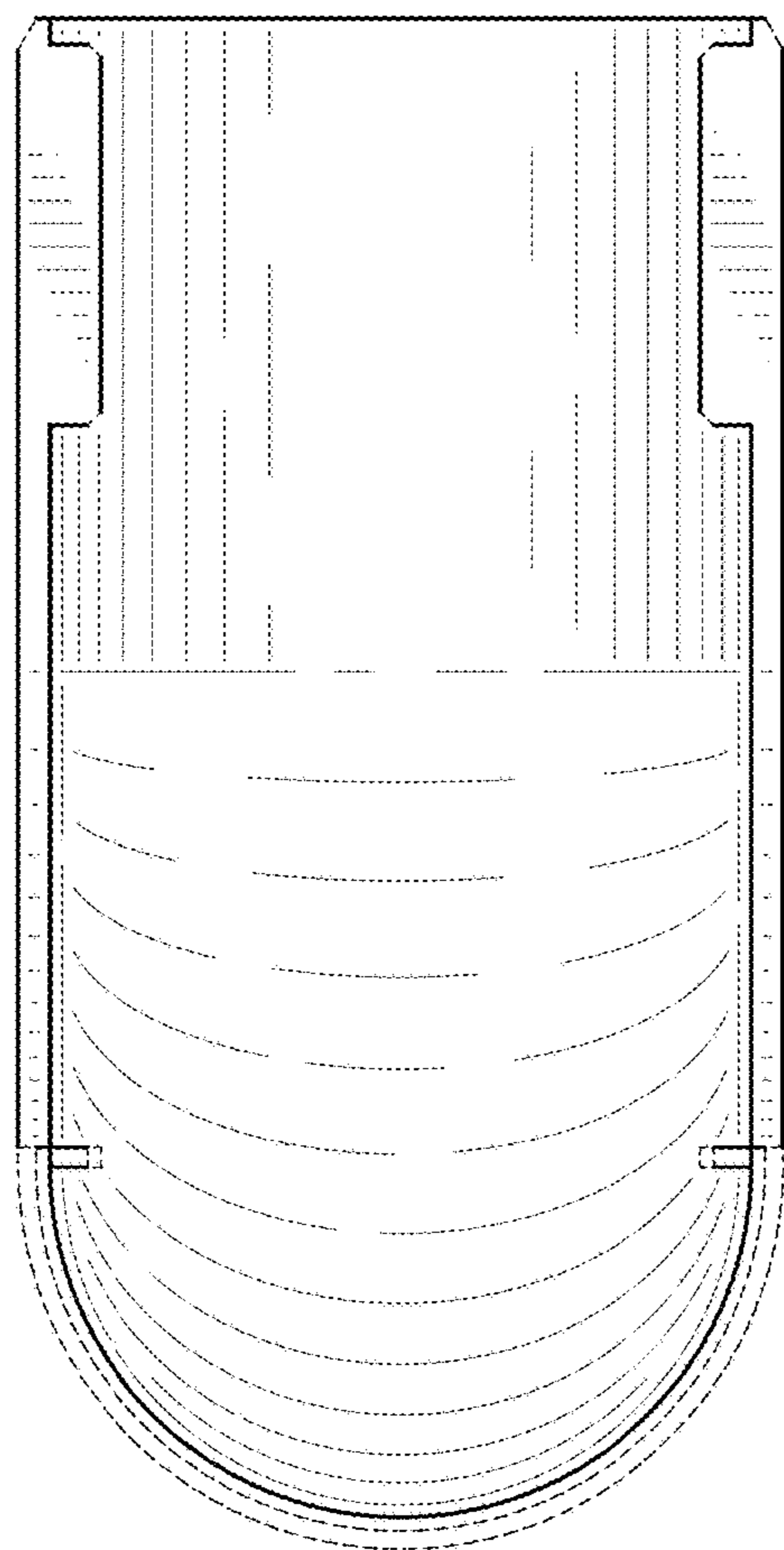

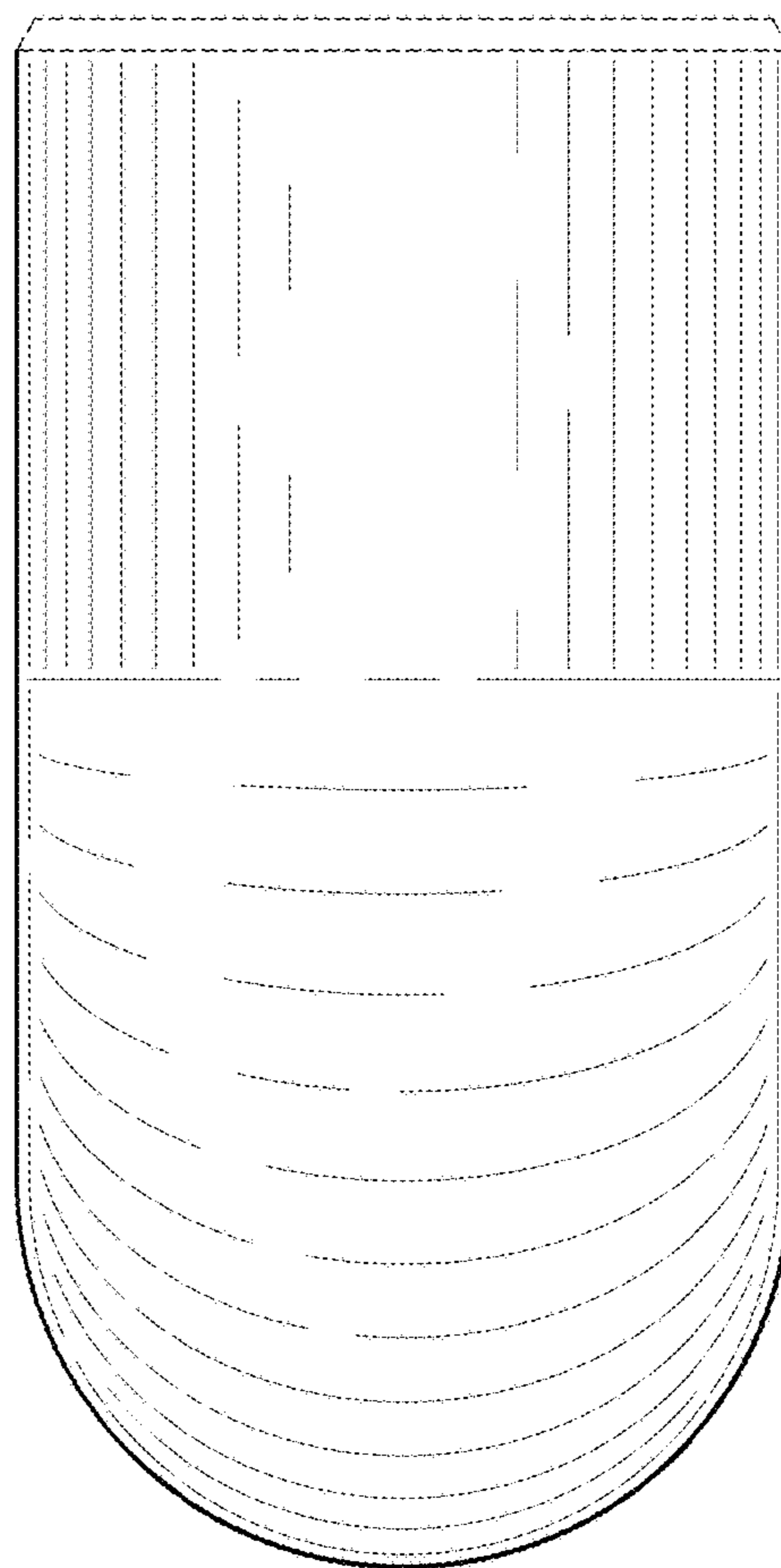
