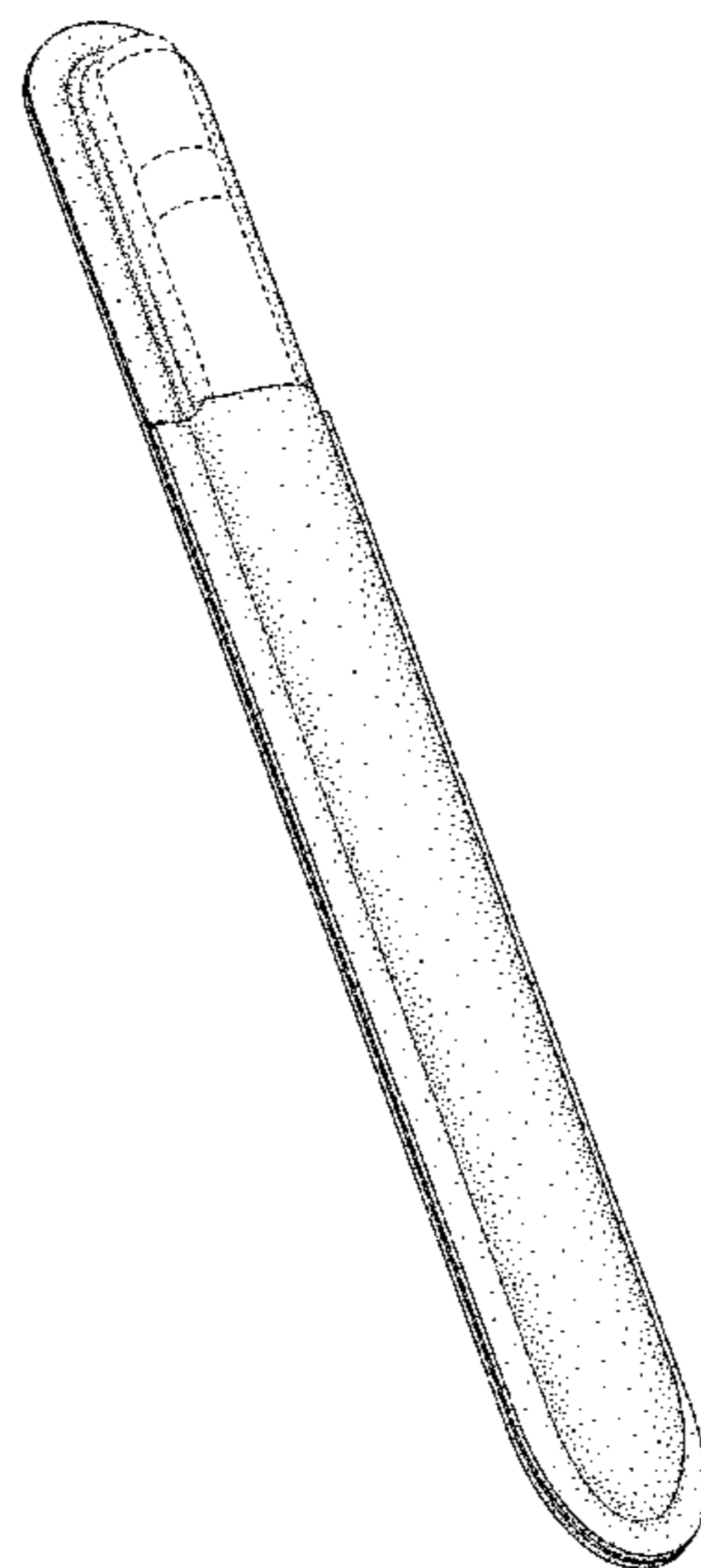

**DESCRIPTION**

FIG. 1 is a perspective view of a stylus holder, illustrating my new design;  
FIG. 2 is a front elevational view of the stylus holder of FIG. 1;  
FIG. 3 is a rear elevational view of the stylus holder of FIG. 1;  
FIG. 4 is a side elevational view of one side of the stylus holder of FIG. 1;  
FIG. 5 is a top plan view of the stylus holder of FIG. 1; and, FIG. 6 is a bottom plan view of the stylus holder of FIG. 1. The broken lines are directed to environment and are for illustrative purposes only; the broken lines form no part of the claimed design.

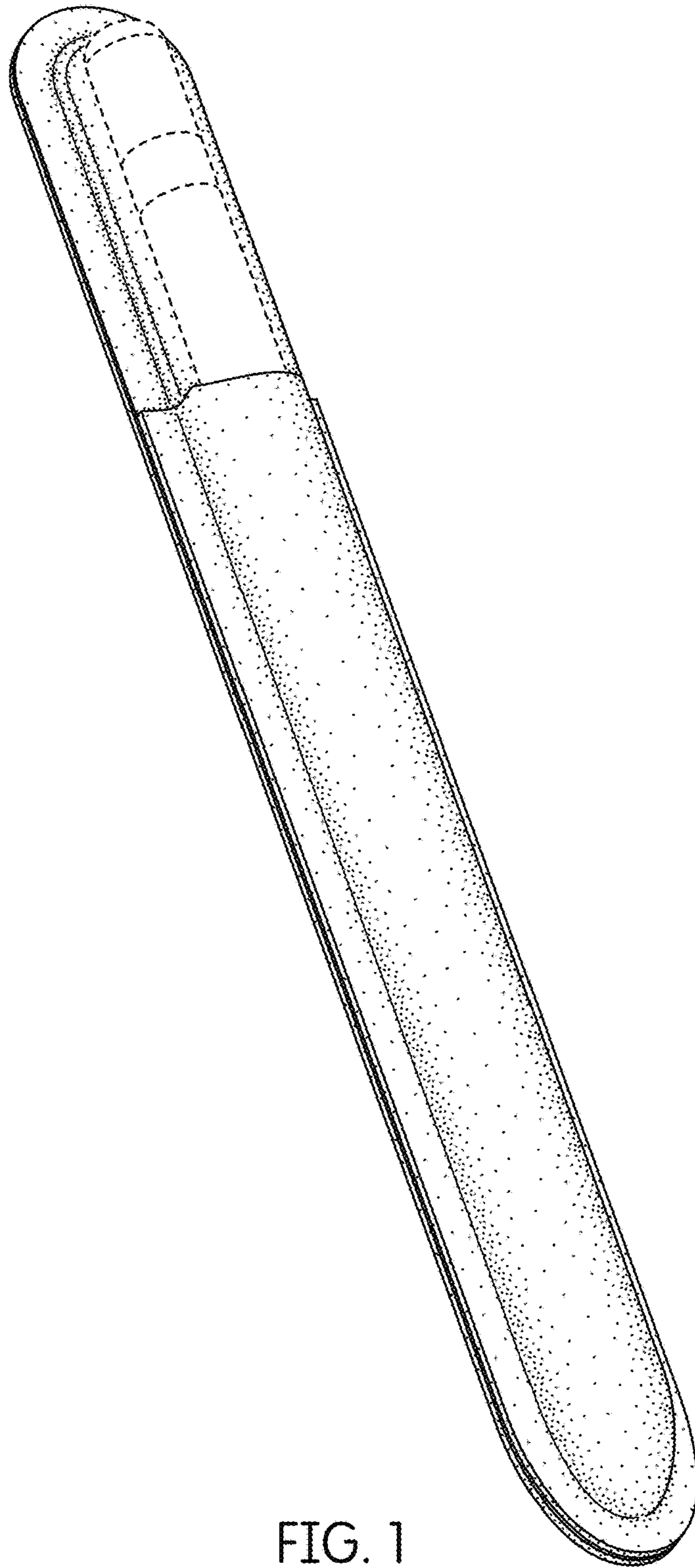

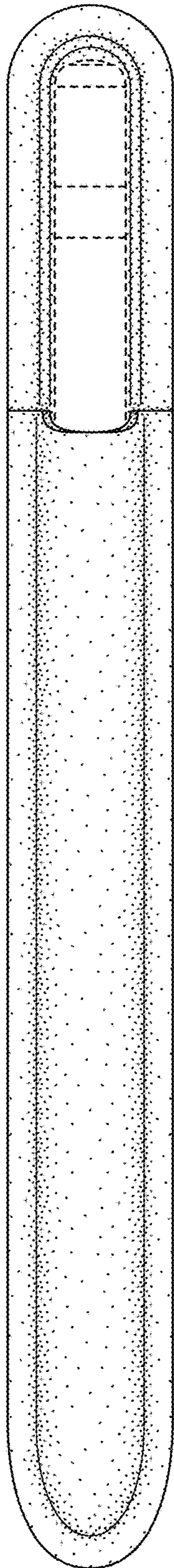

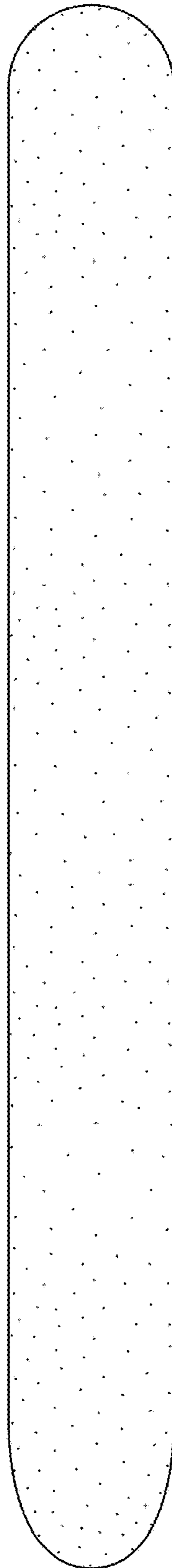

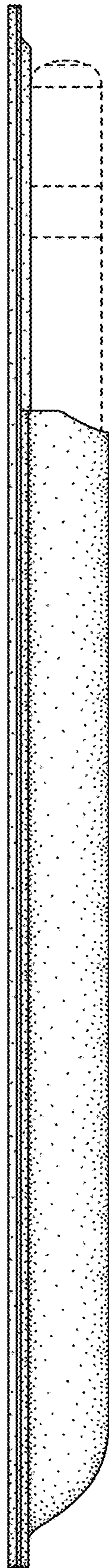

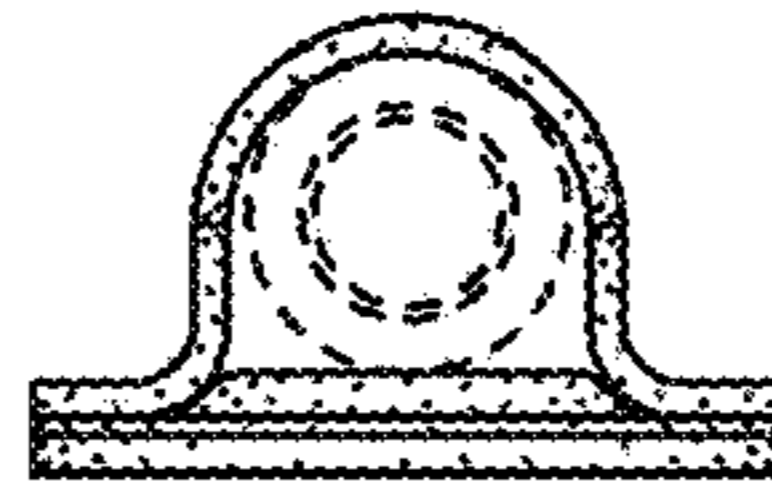

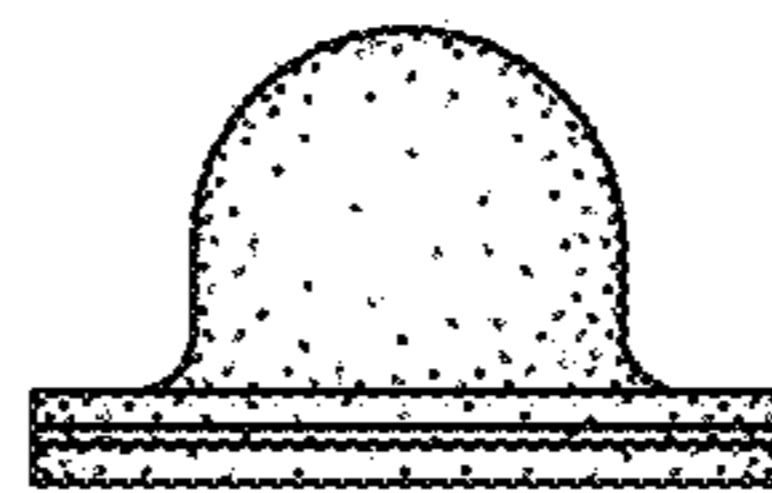
