(57) **CLAIM**

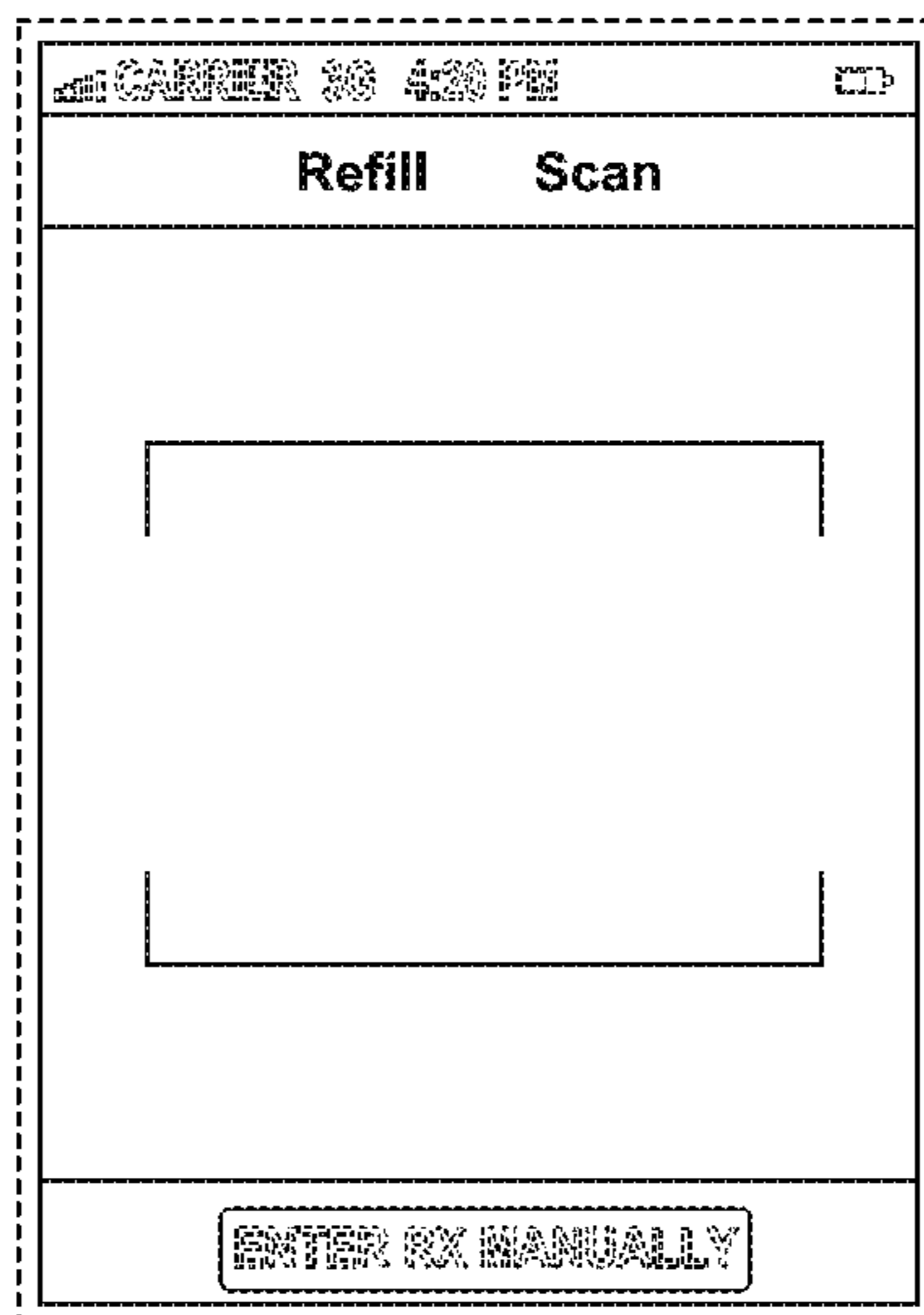
The ornamental design for a portion of a display panel with graphical user interface for refilling prescription medications, as shown and described.

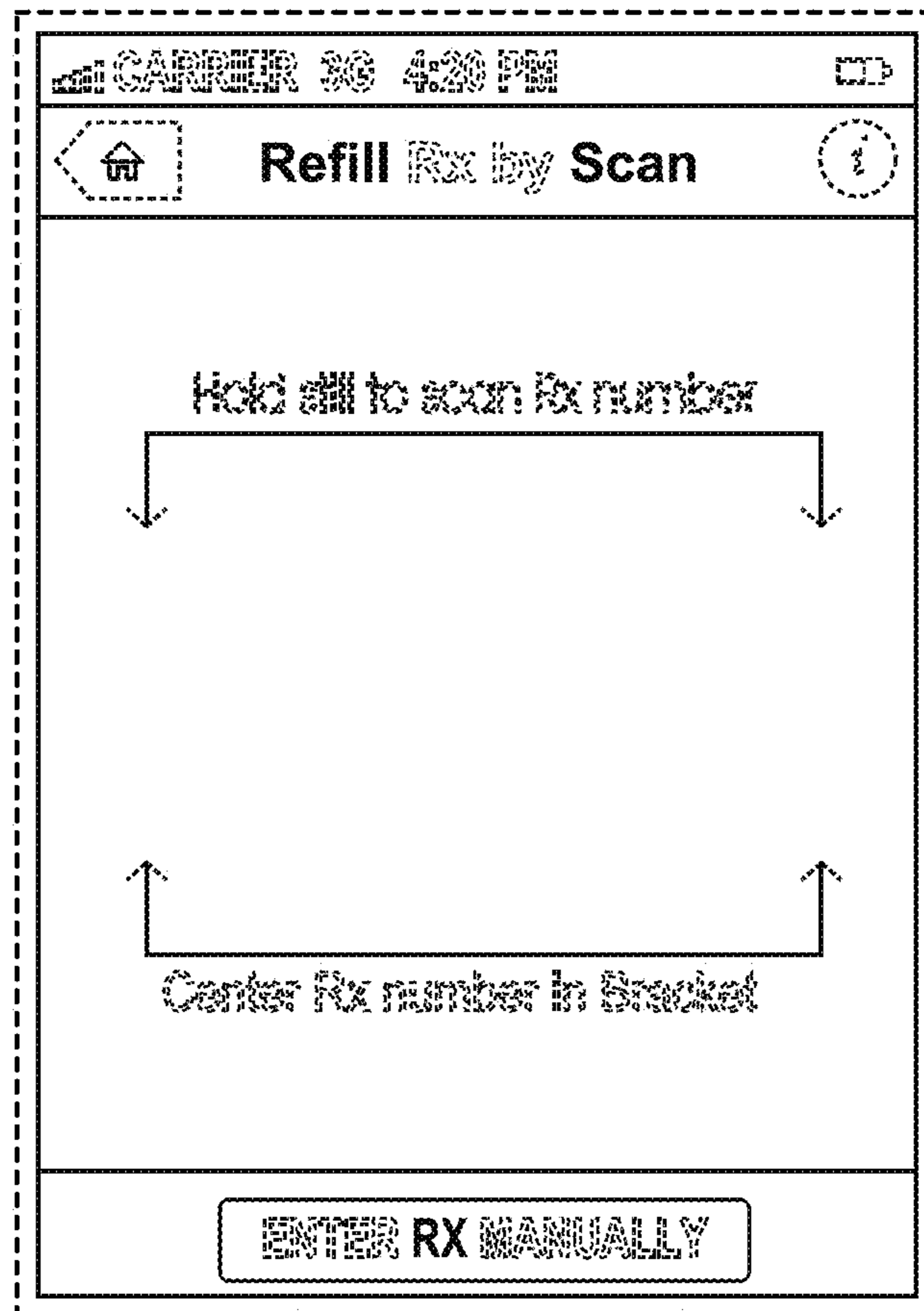

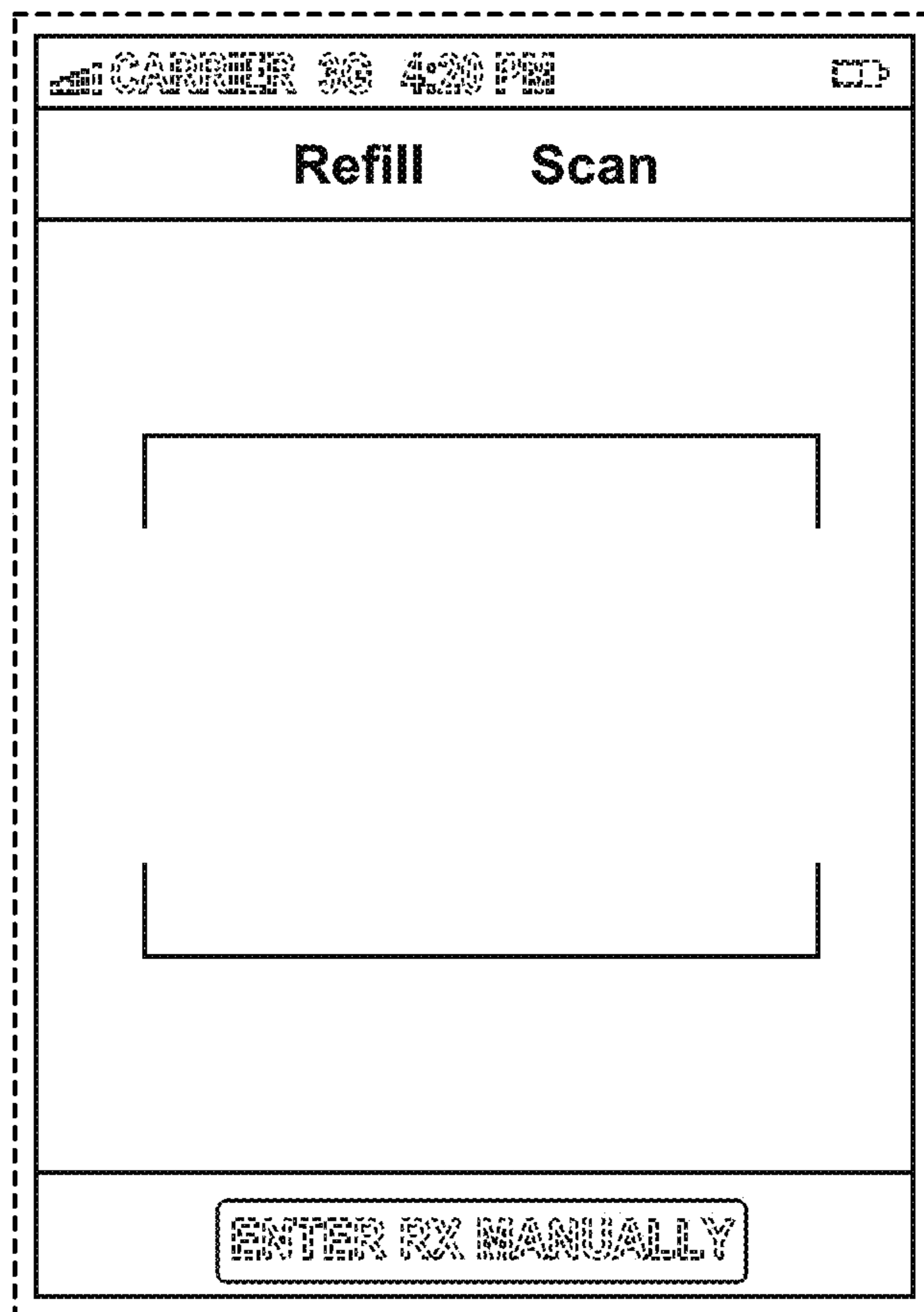
