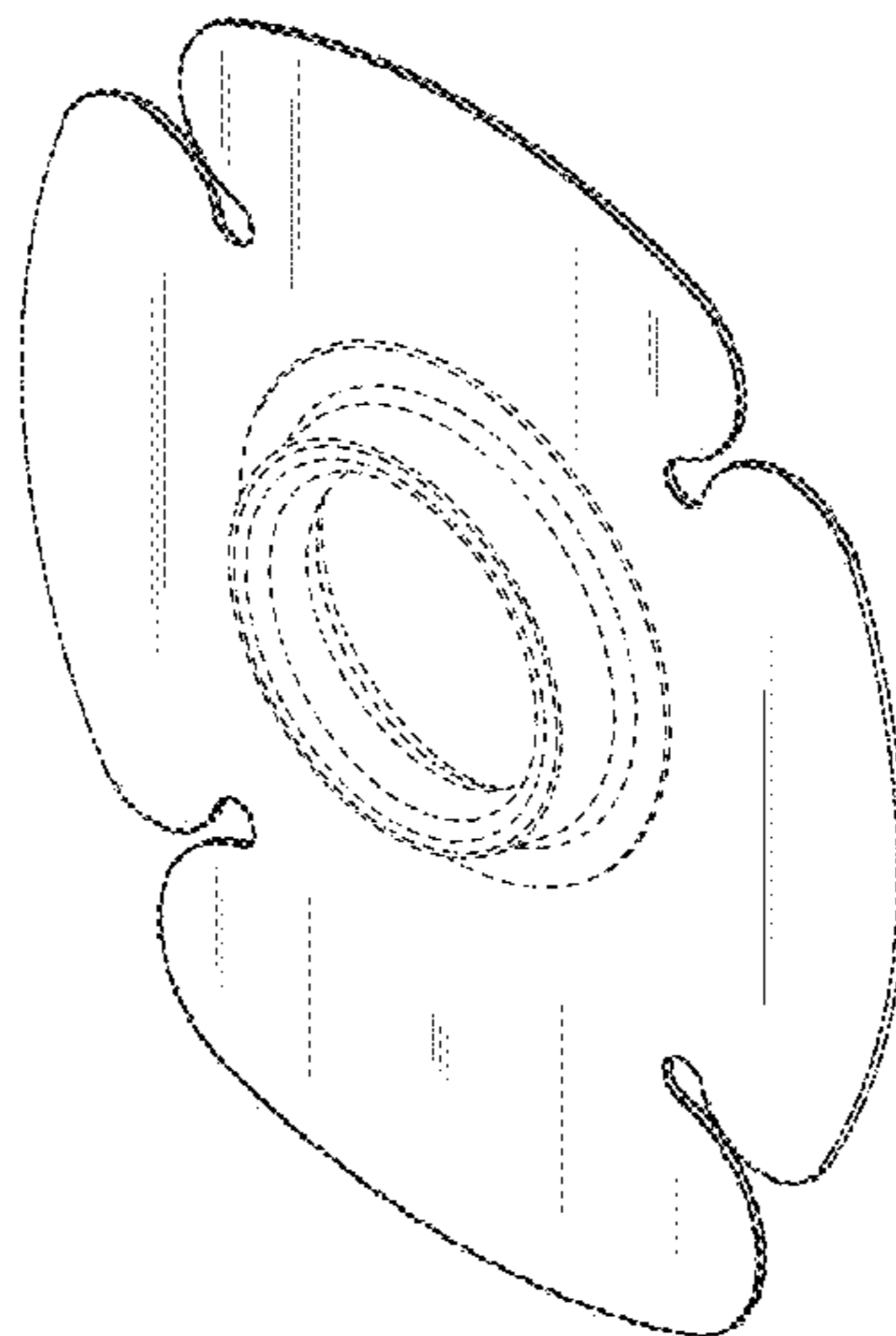
The ornamental design for a heat and moisture exchanger base plate, as shown and described.

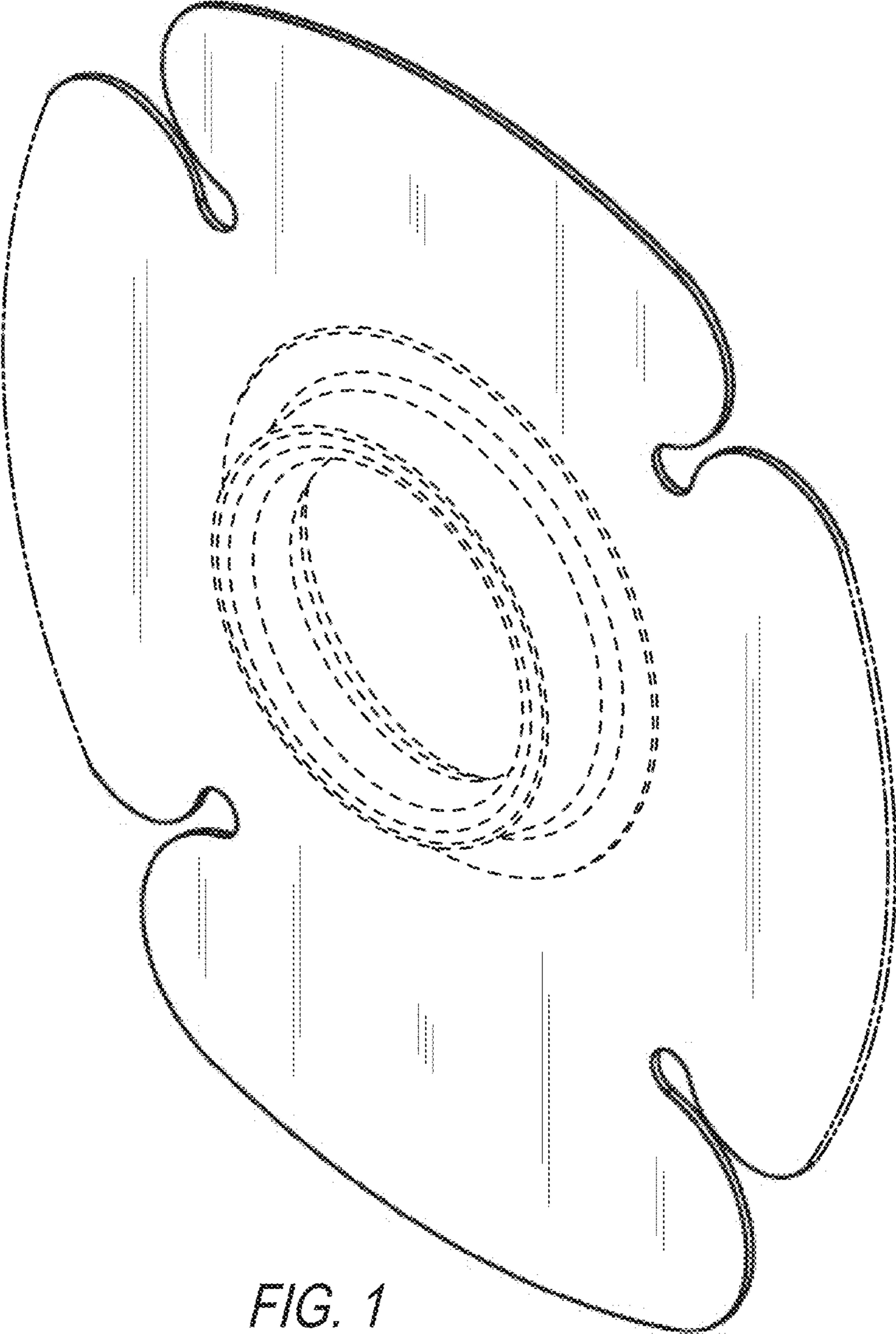

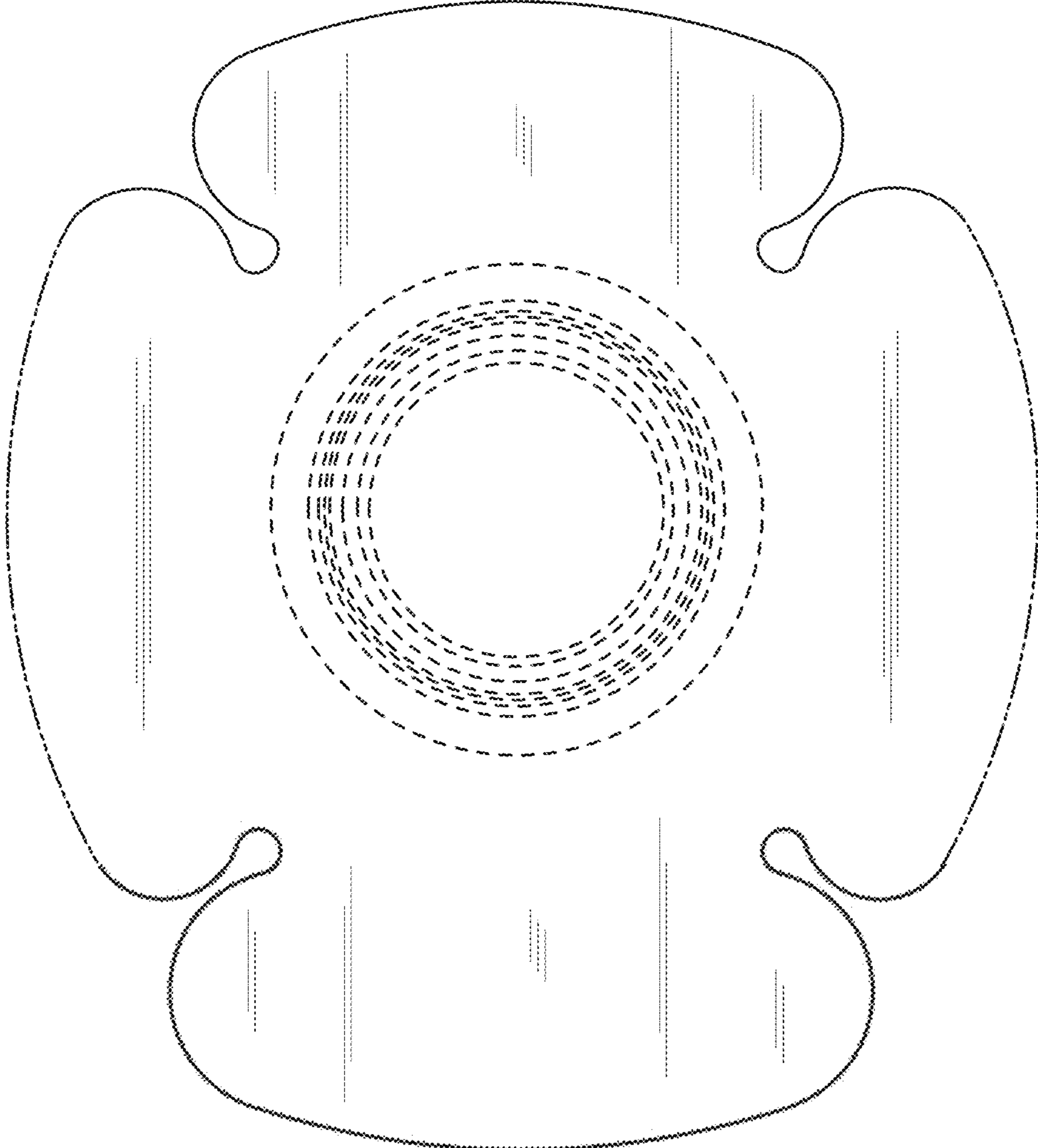

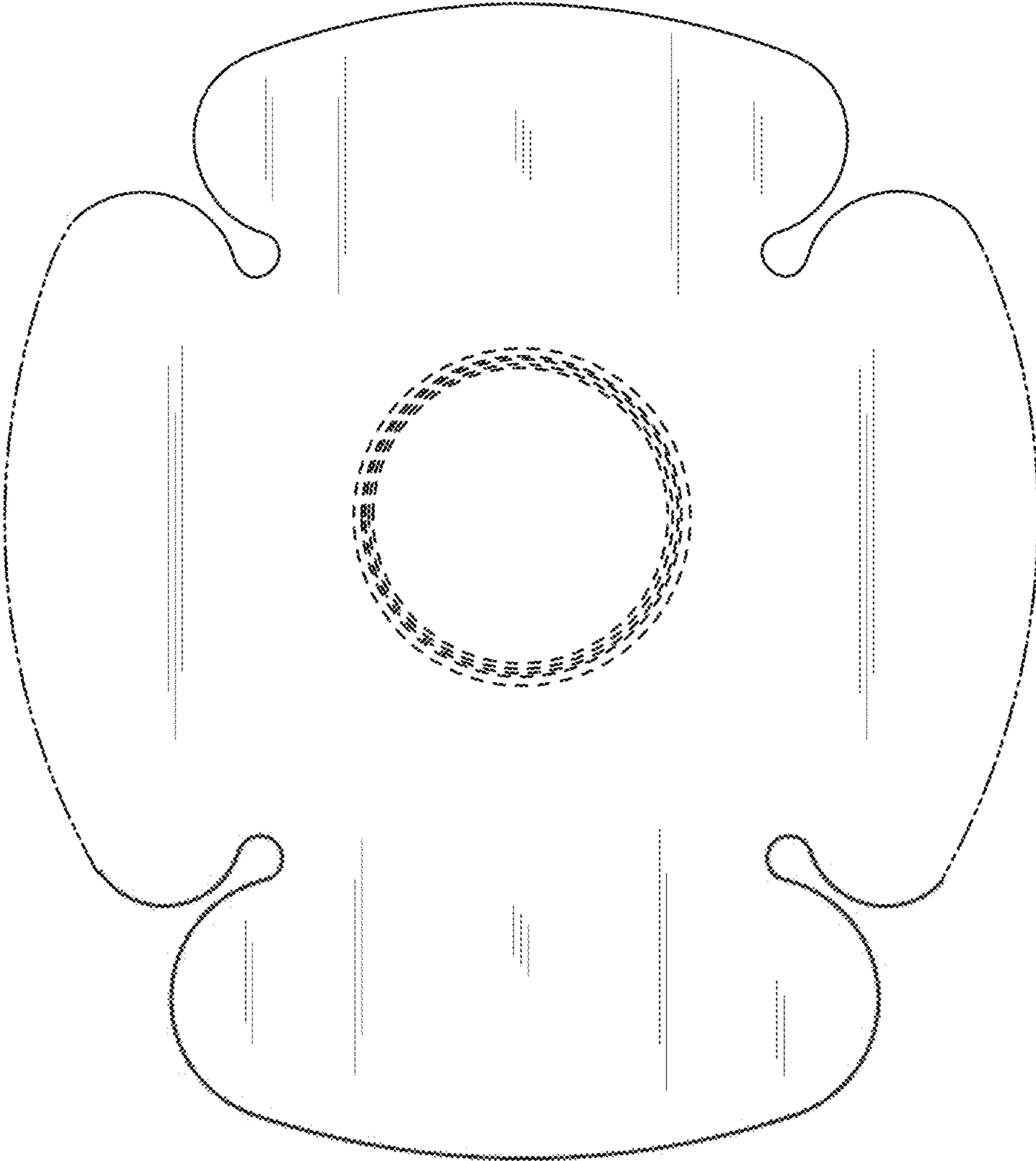

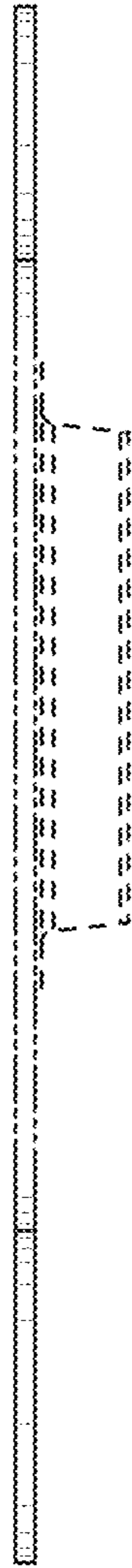

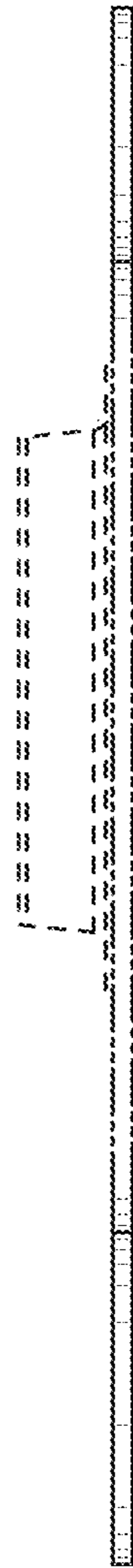

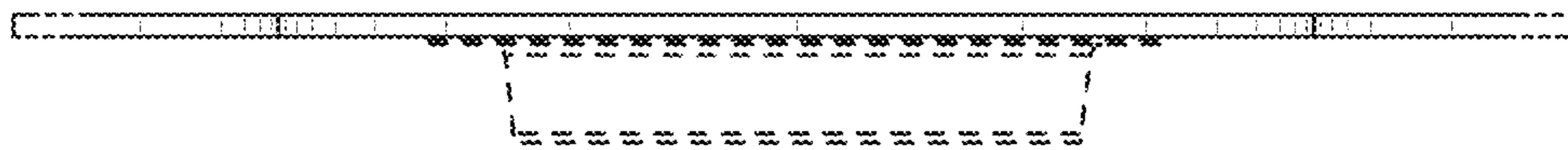

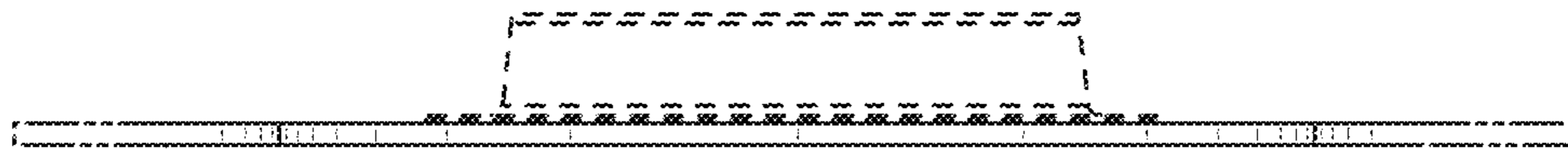

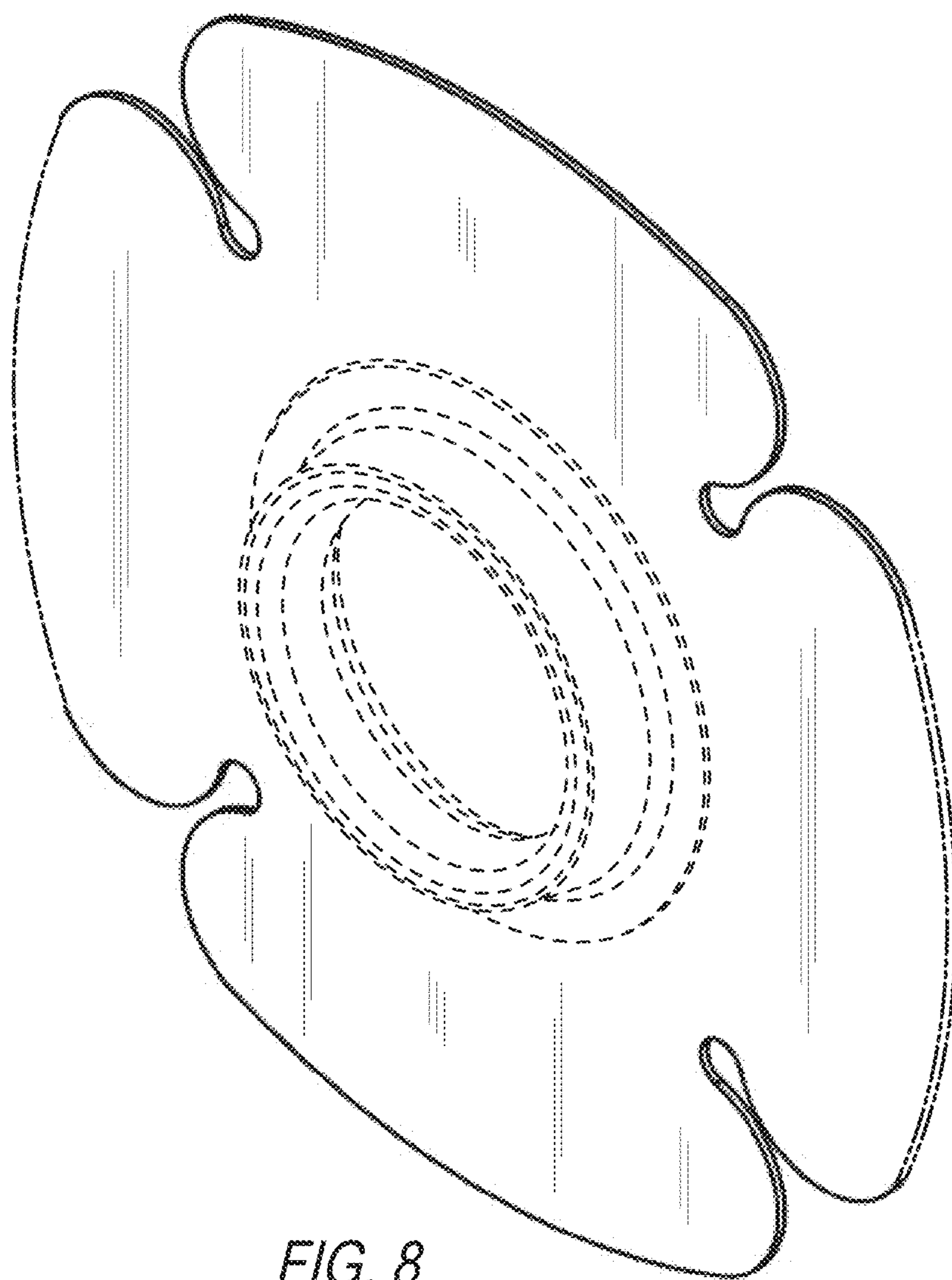

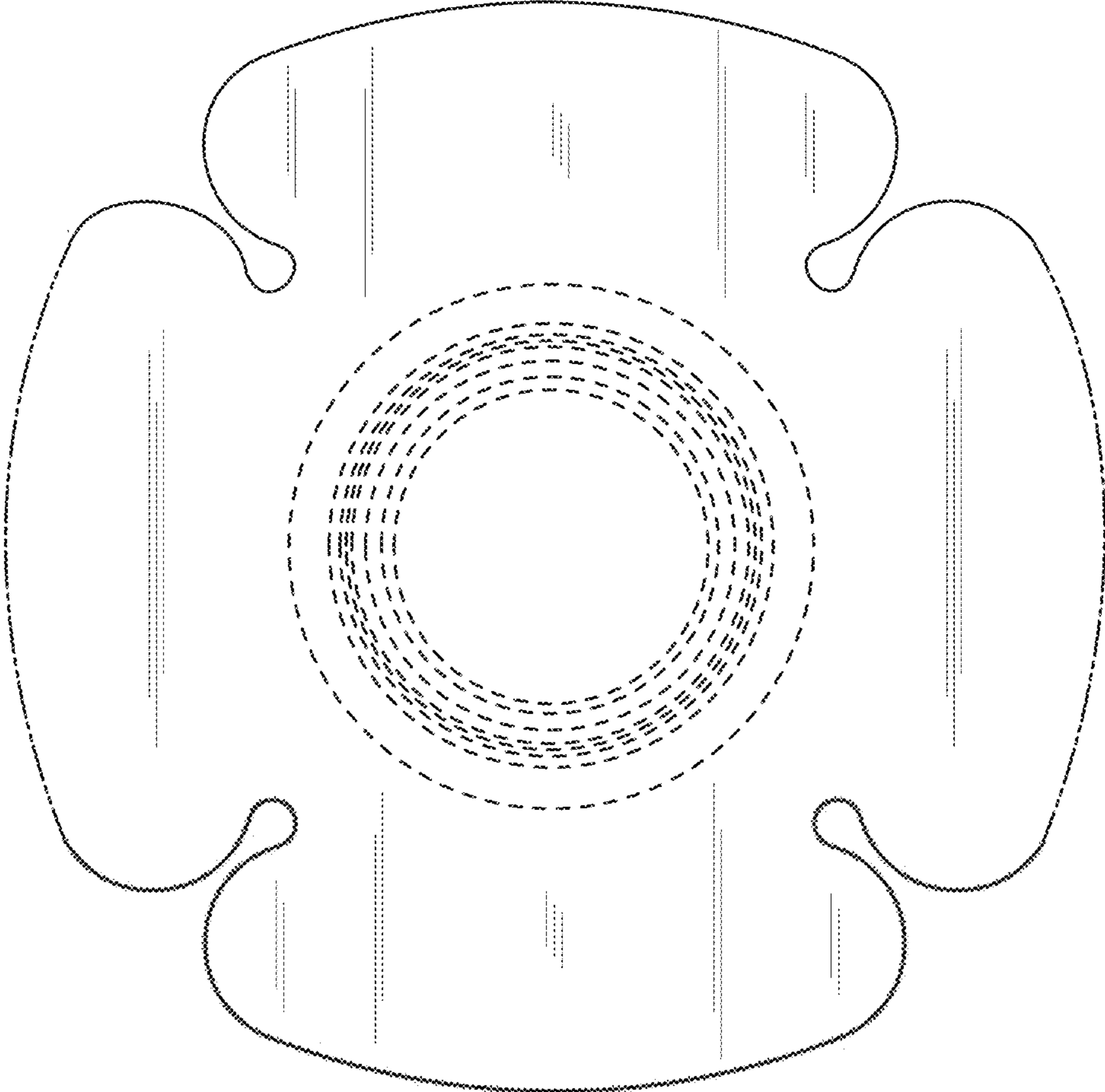

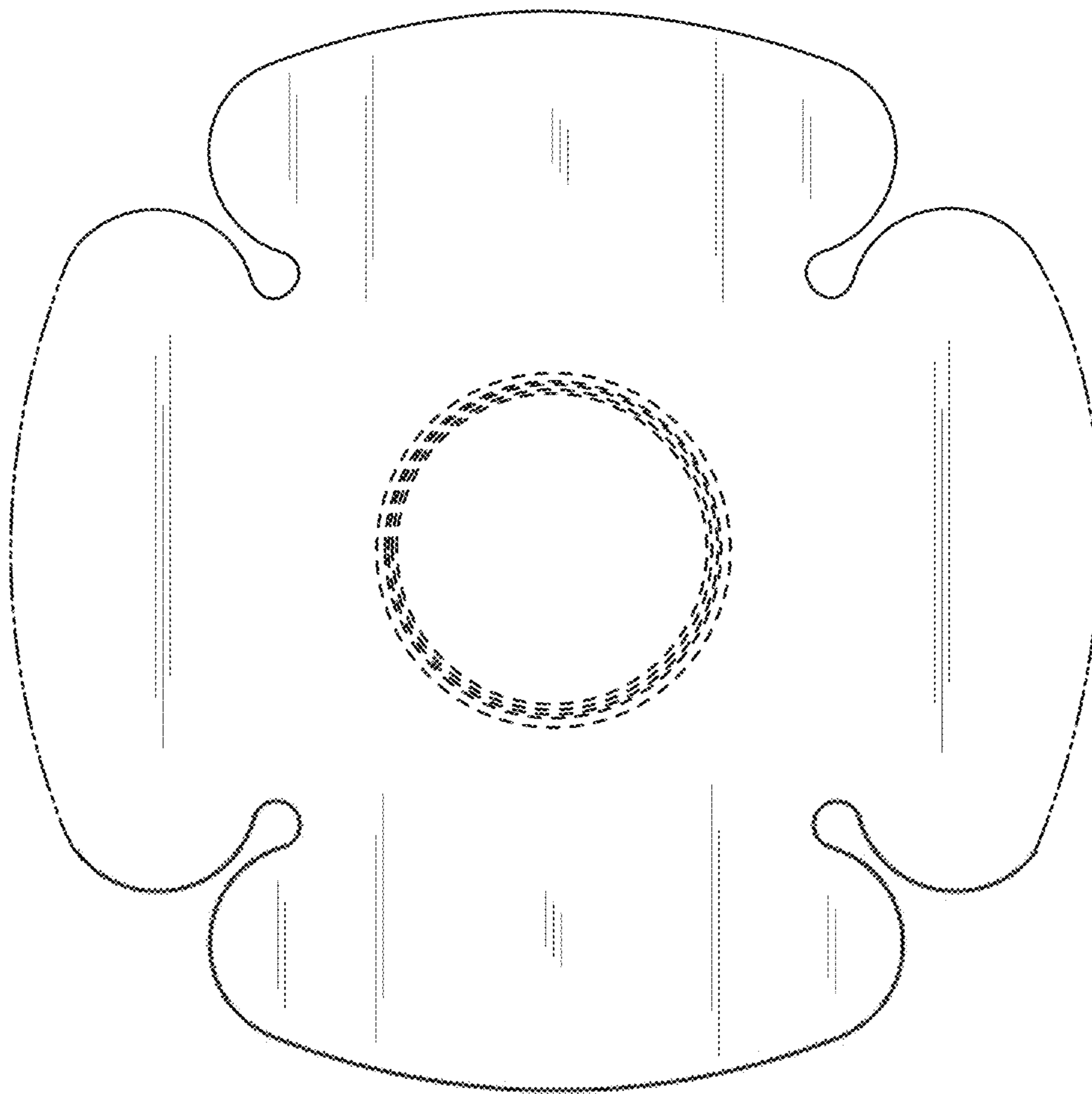

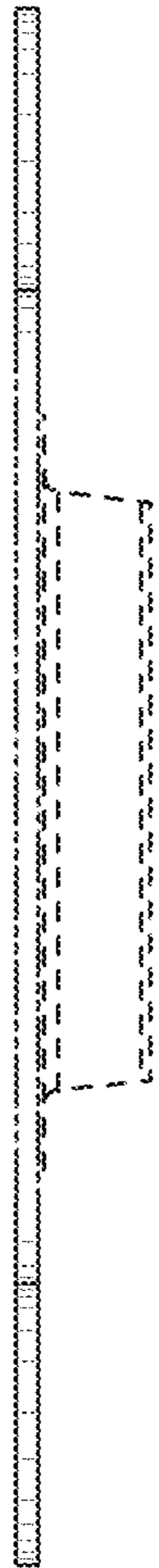

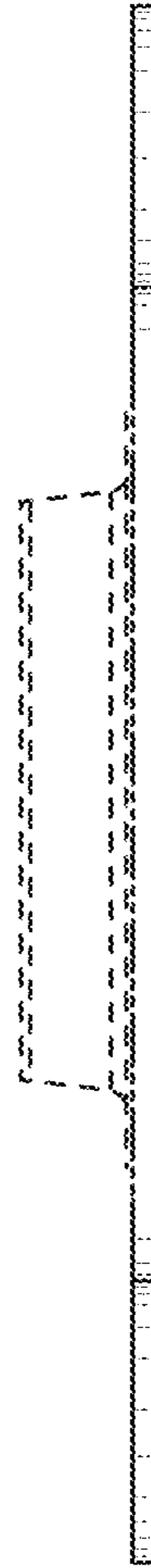

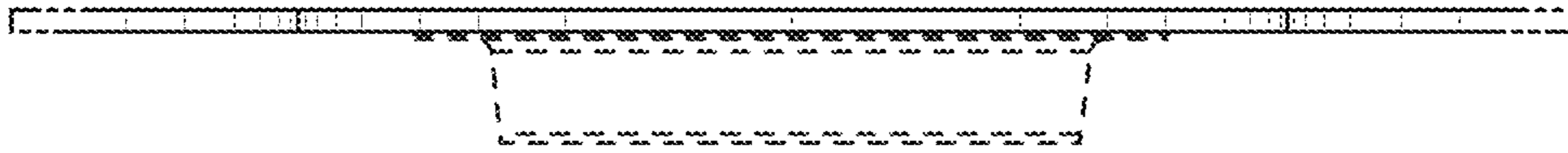

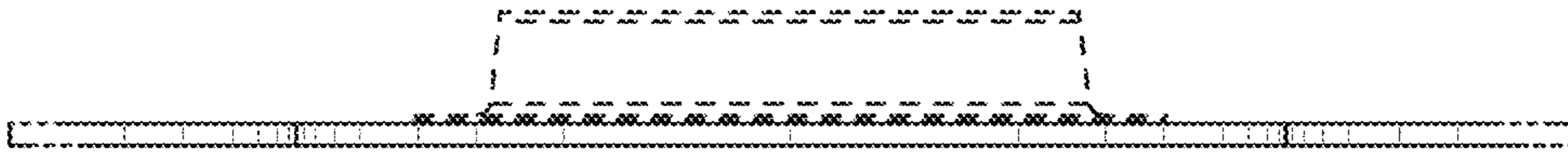

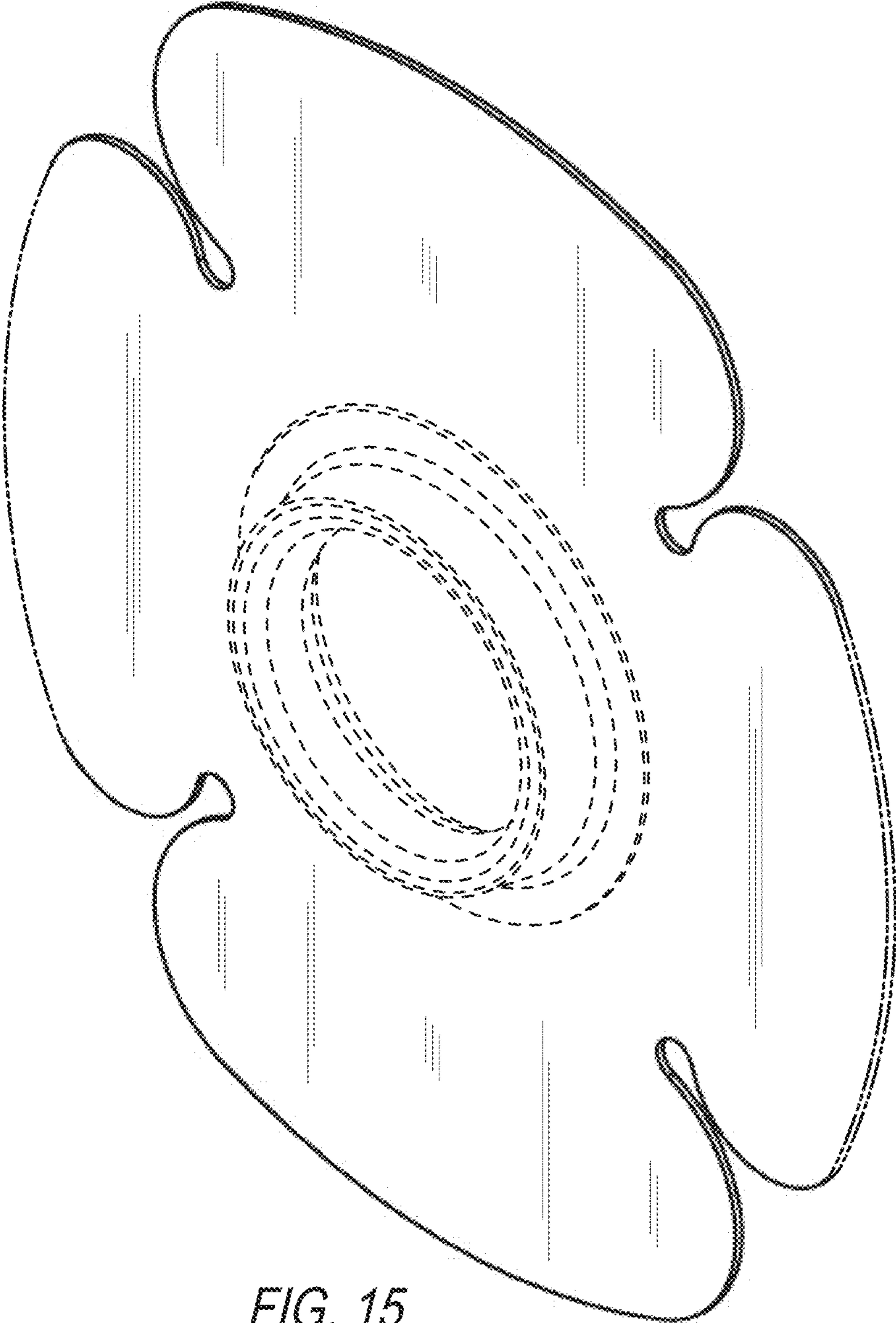

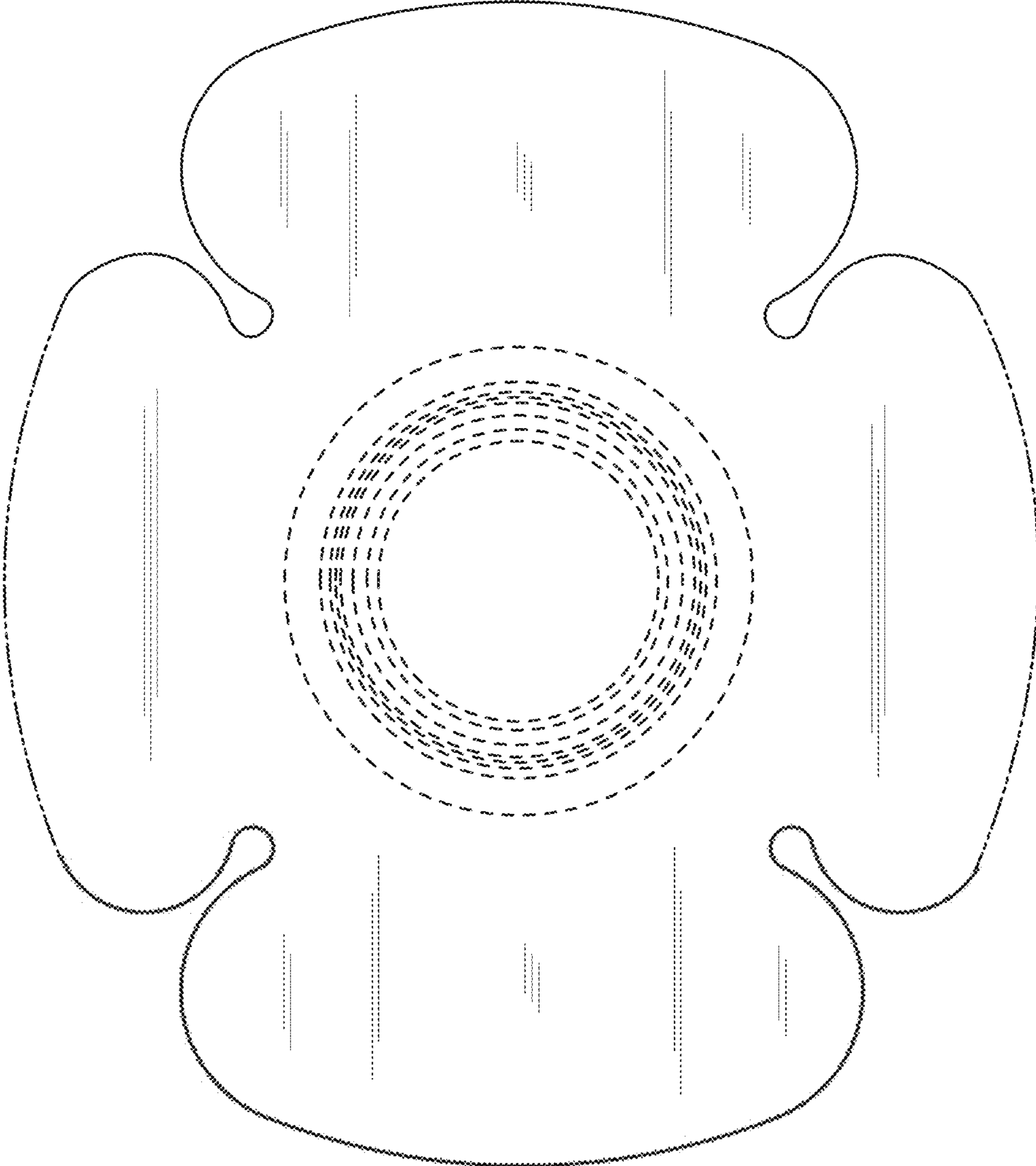

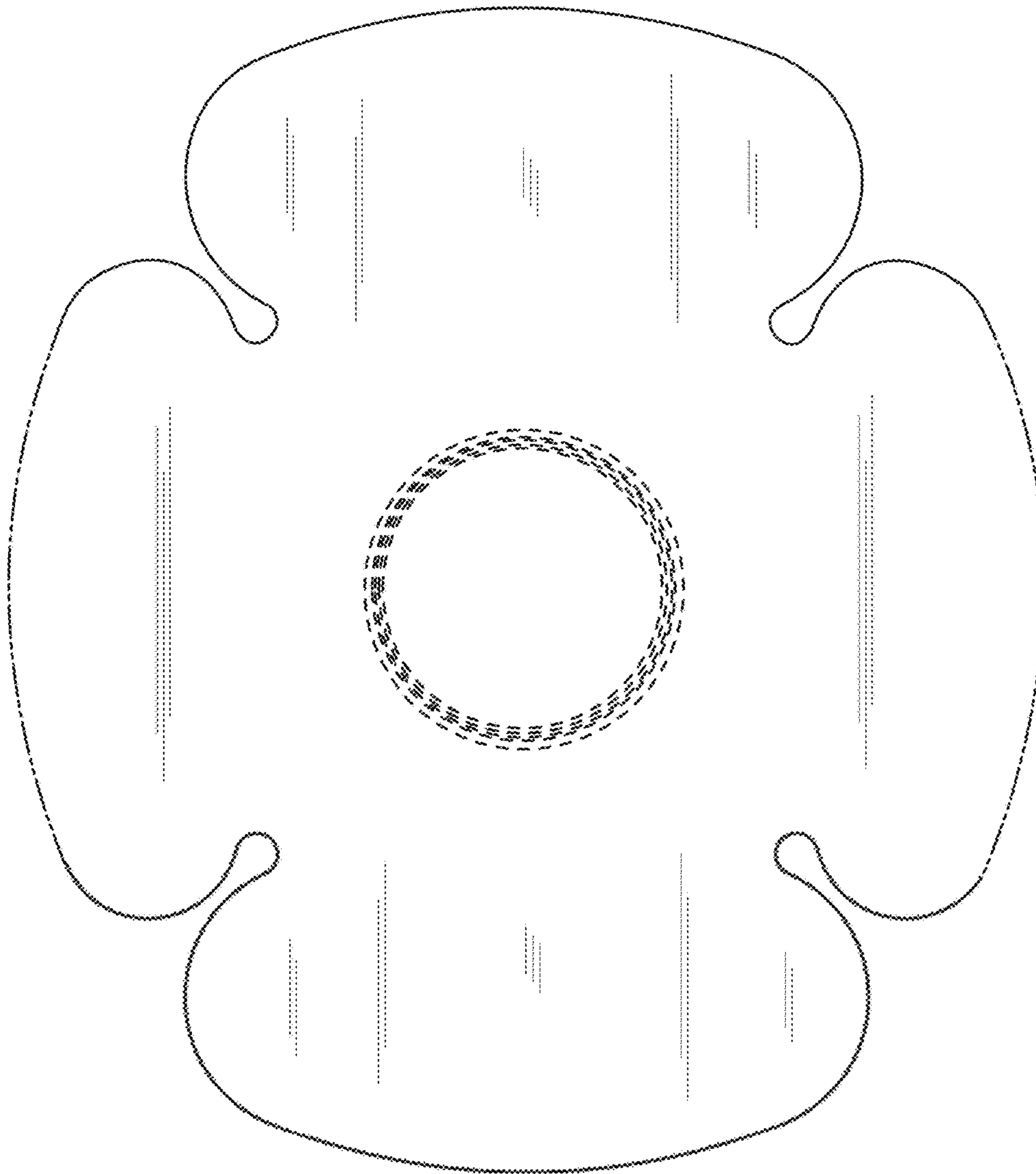

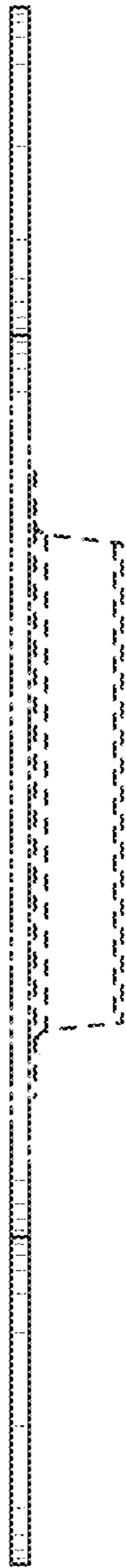

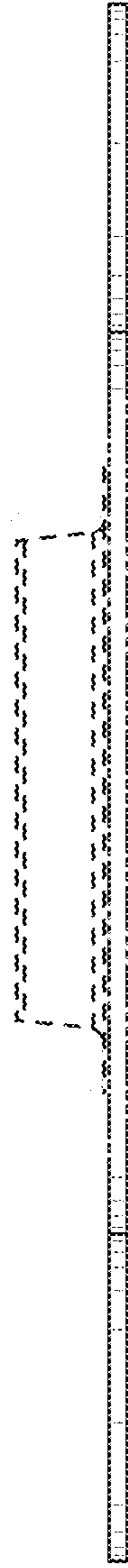

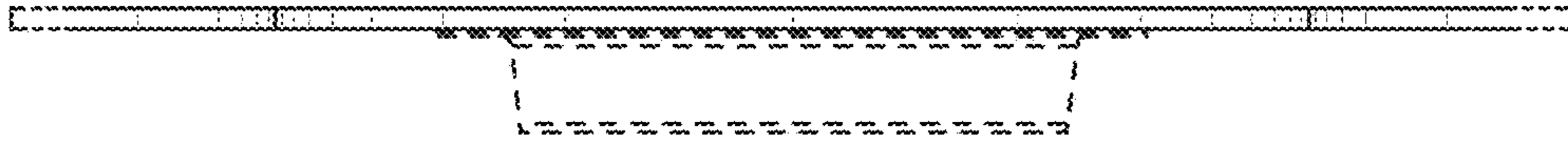

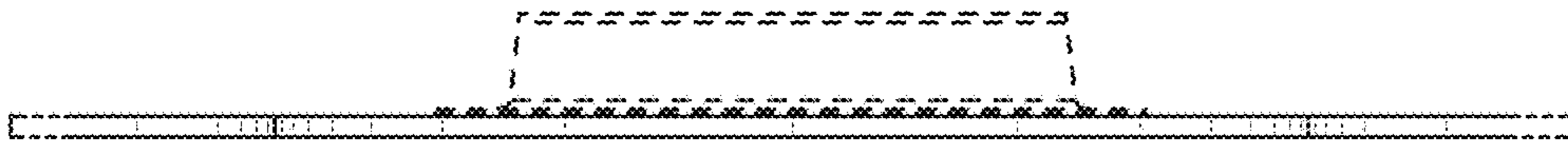
