The ornamental design for a lighting unit for a vehicle, as shown and described.

DESCRIPTION

FIG. 1 is a front side perspective view of a lighting unit for a vehicle showing my new design;

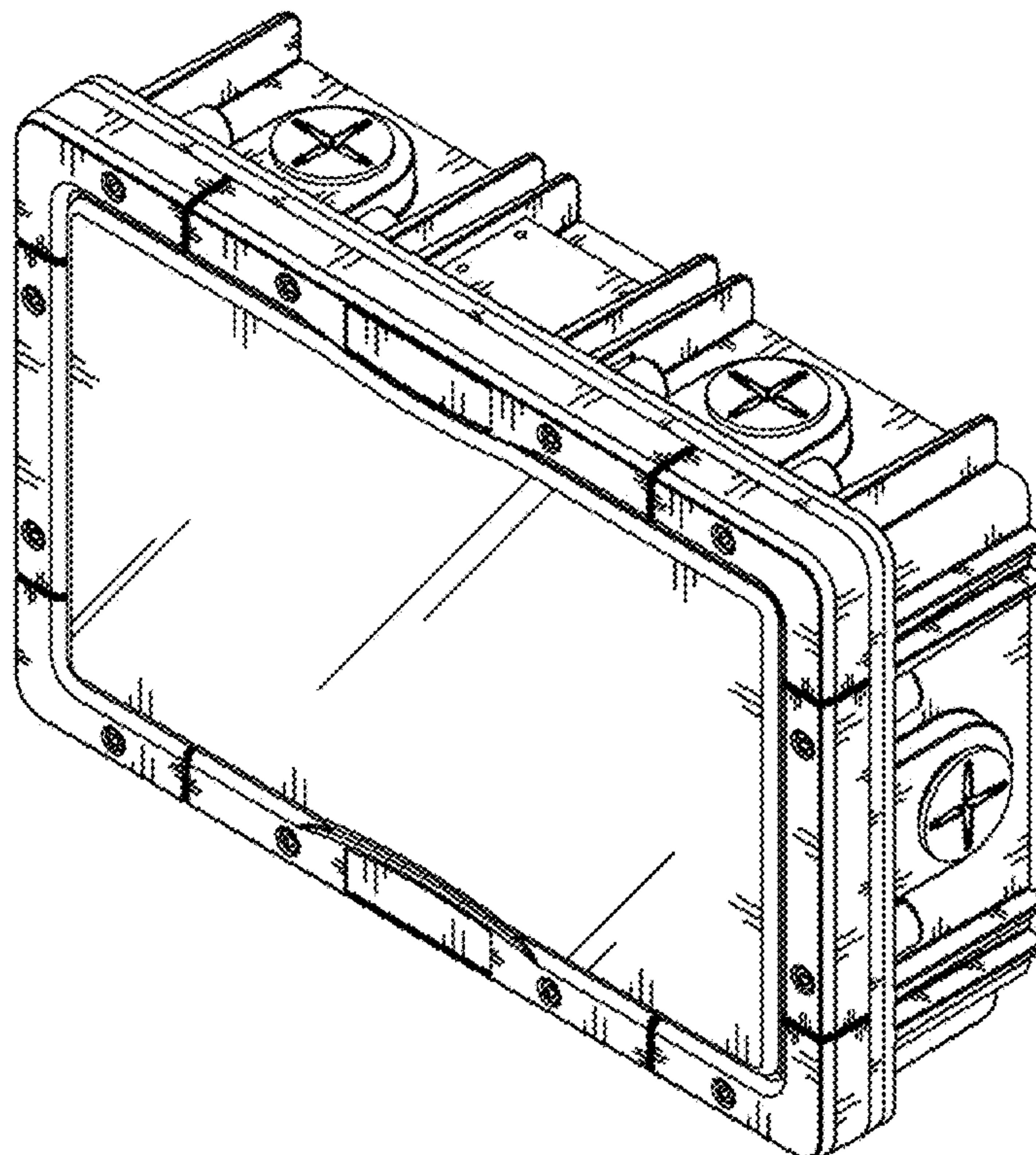

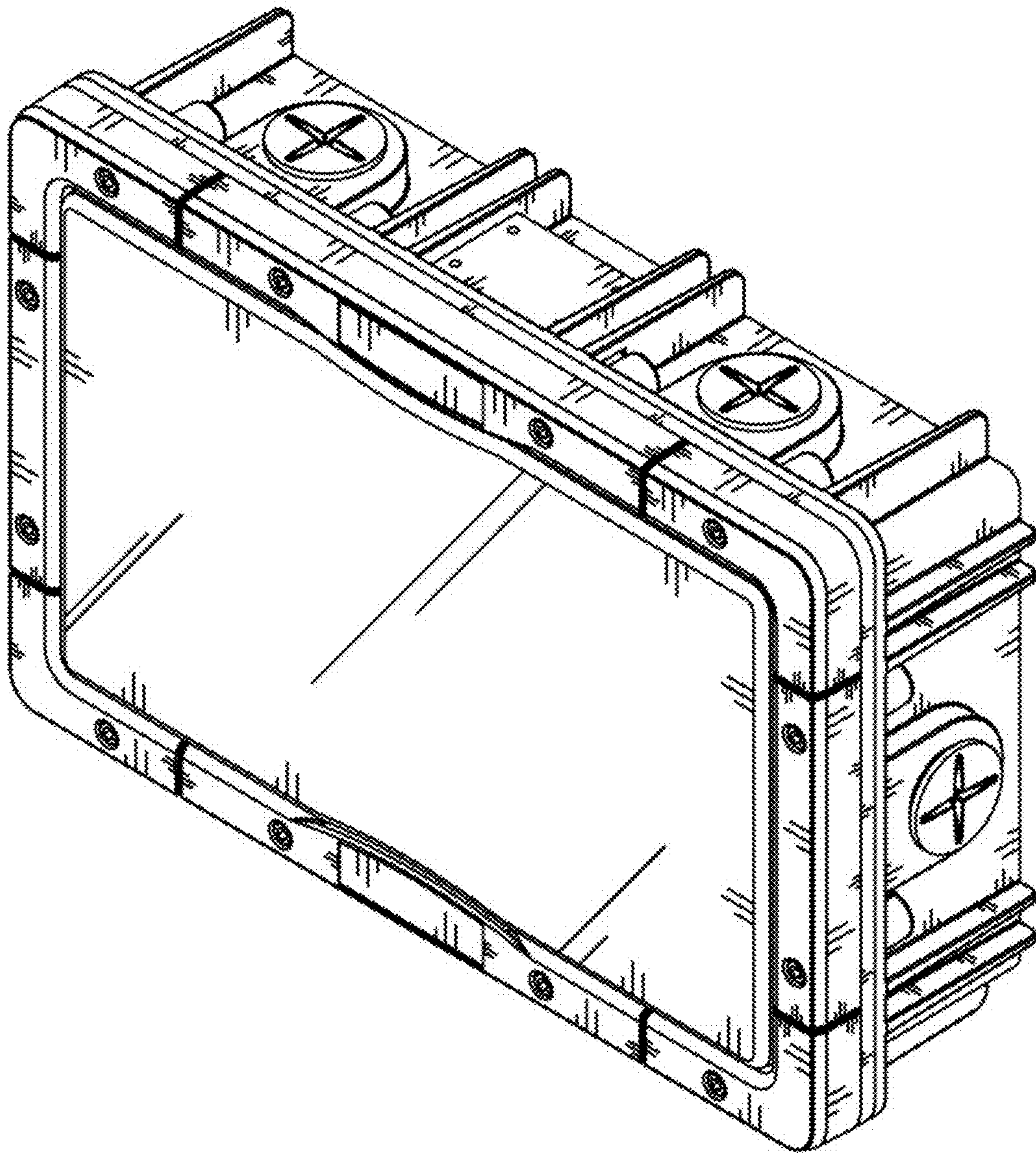

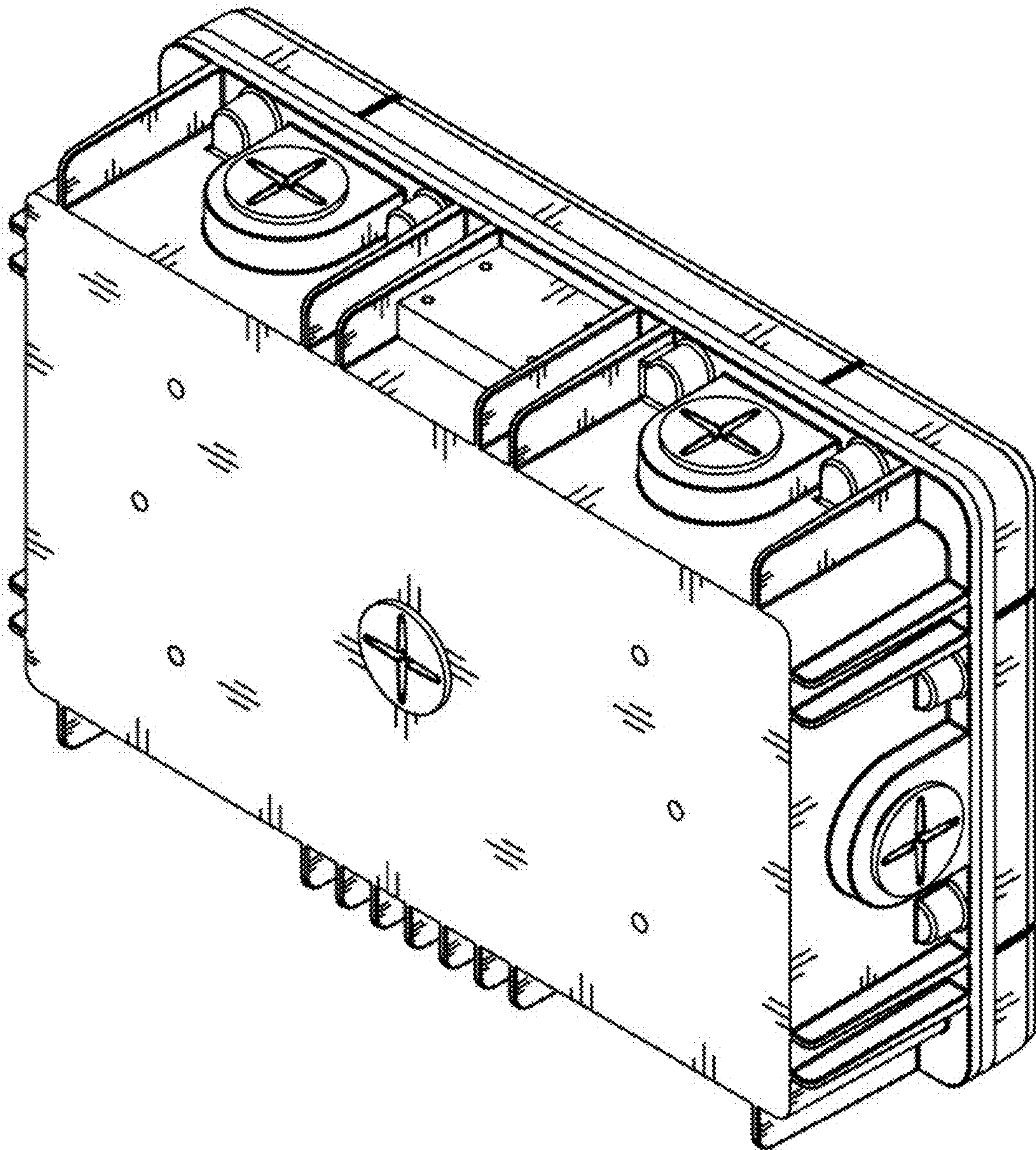

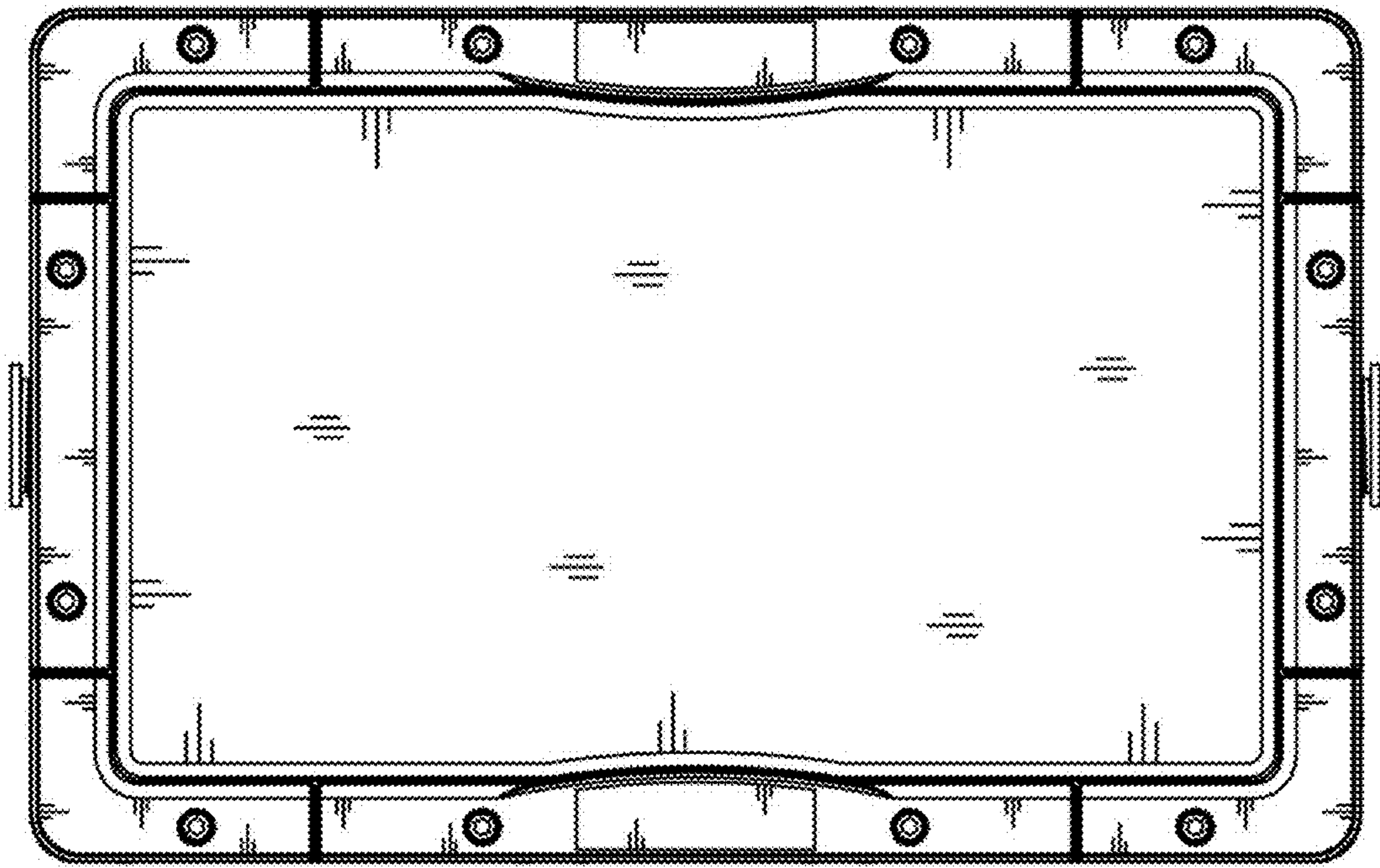

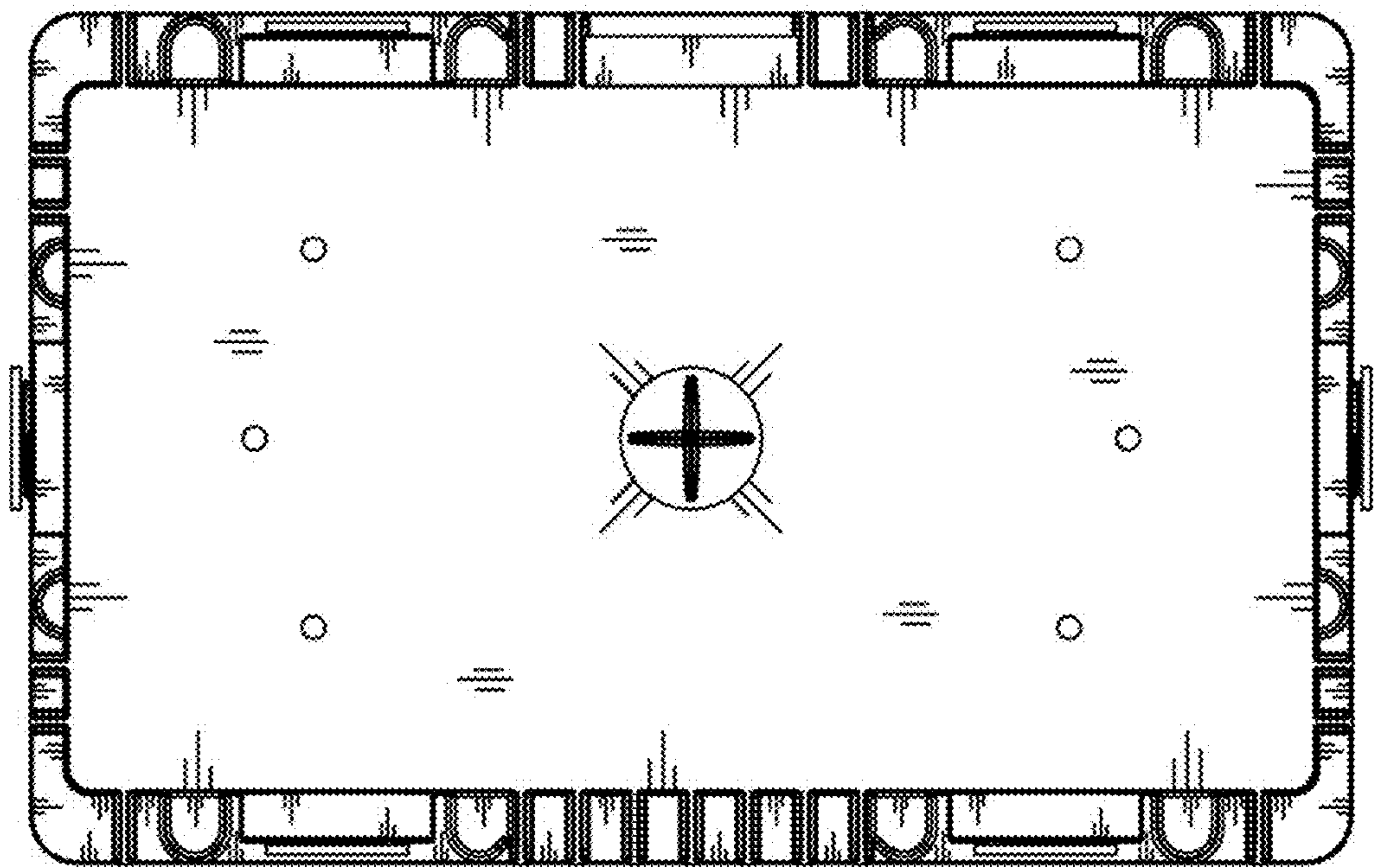

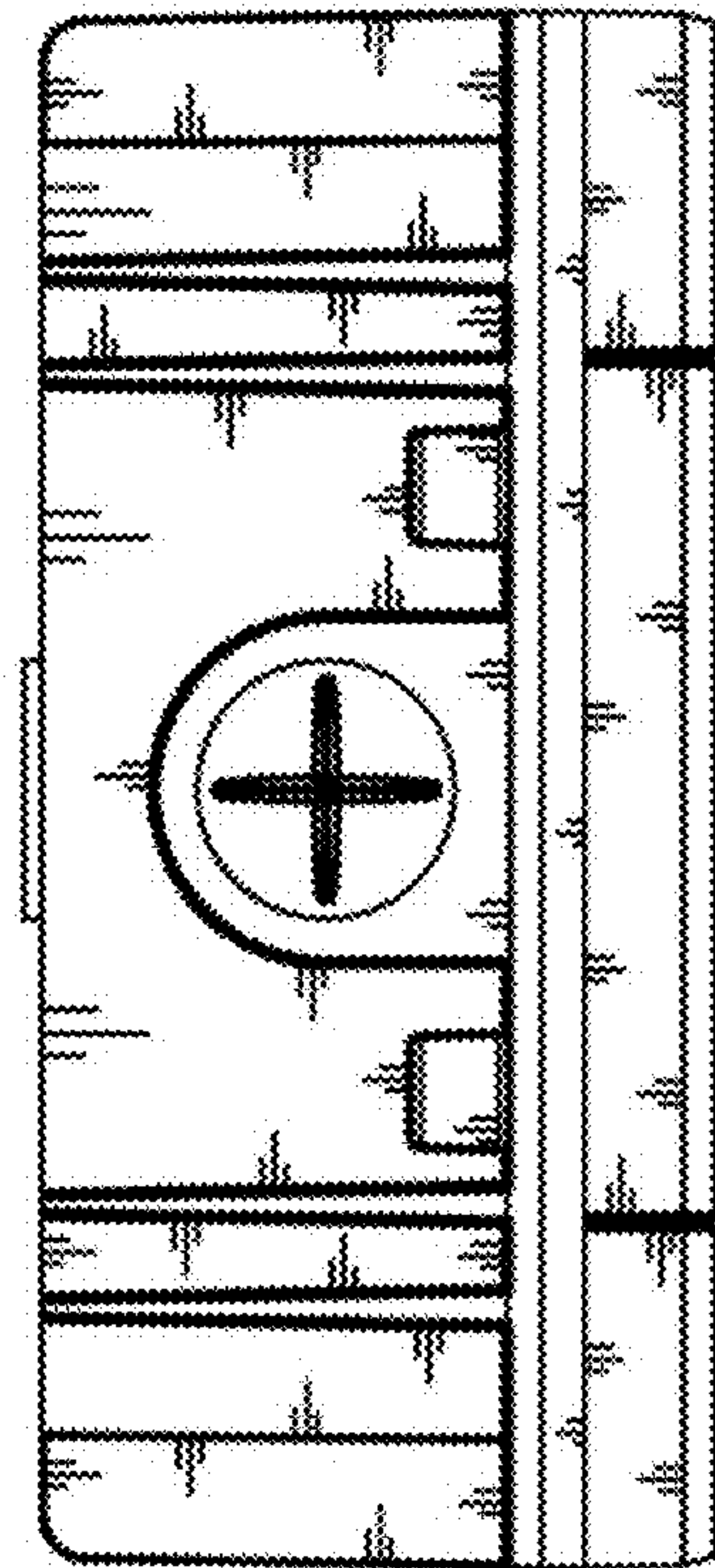

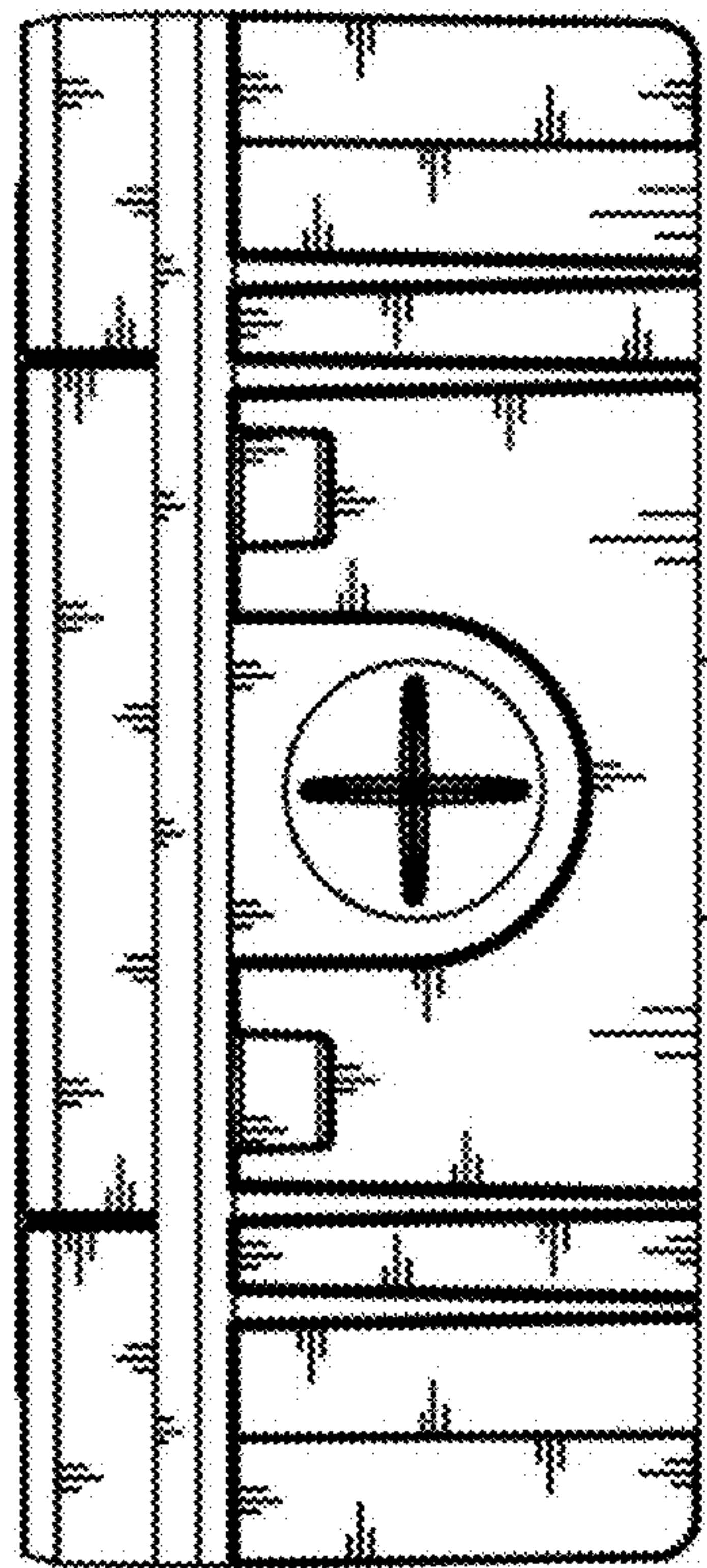

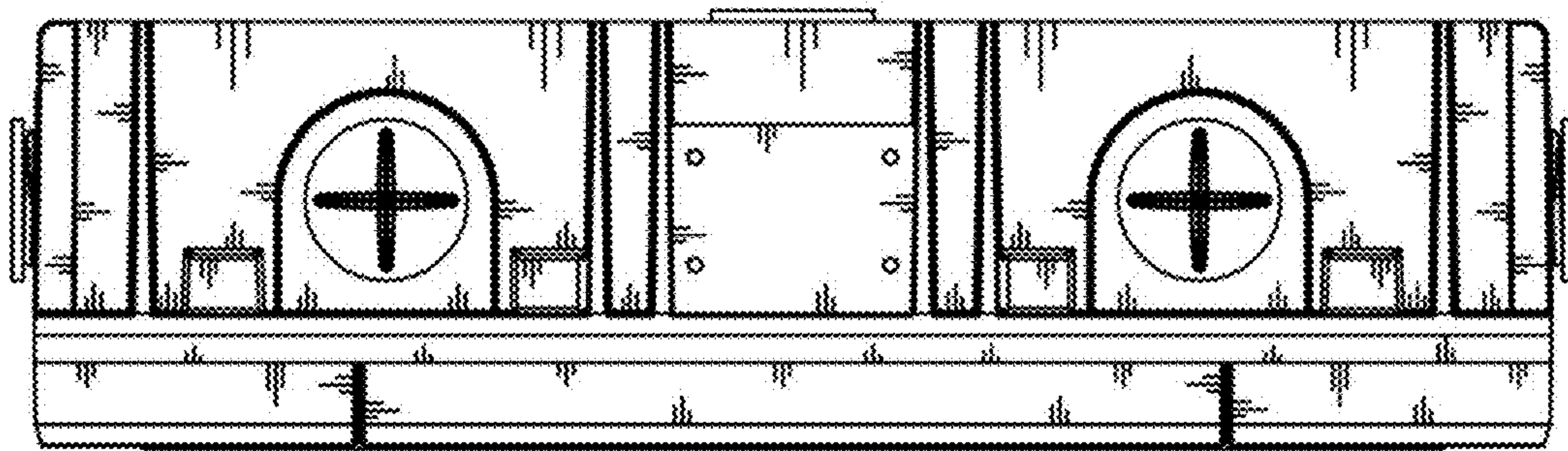
