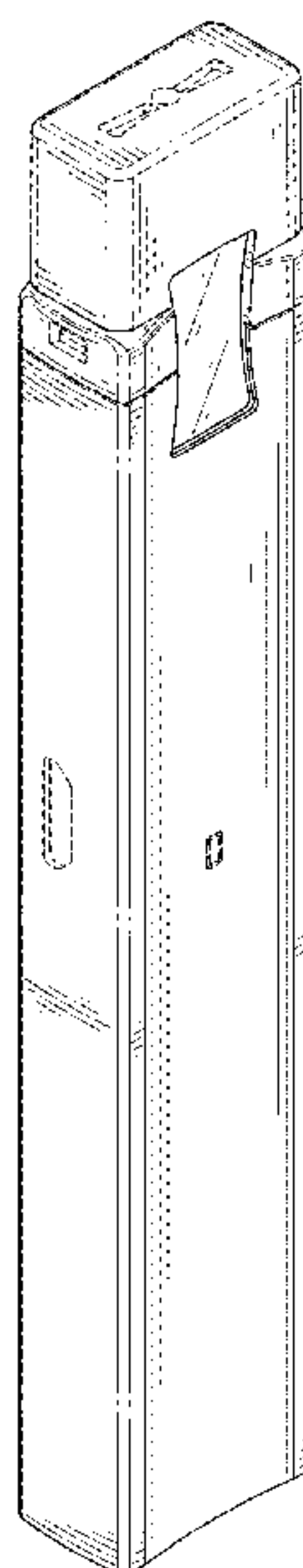
FIG. 1 is a top, front, left side perspective view of an electronic cigarette, showing my new design;

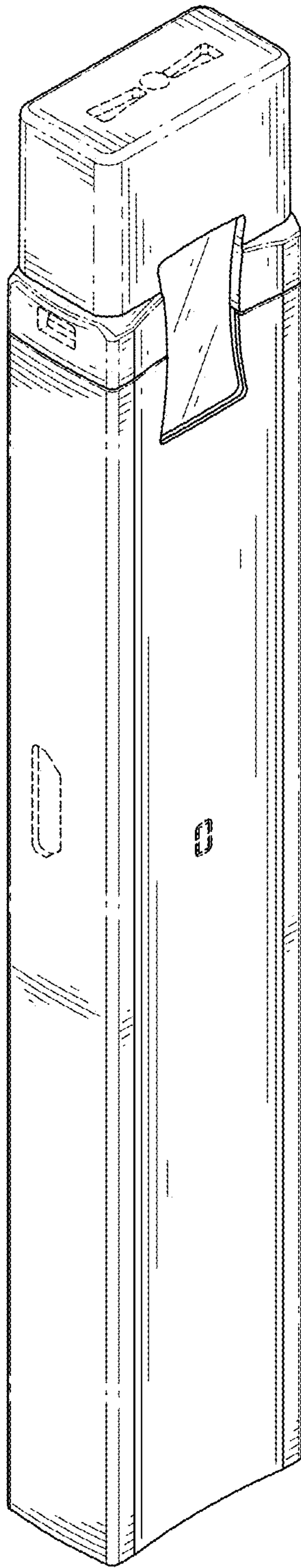

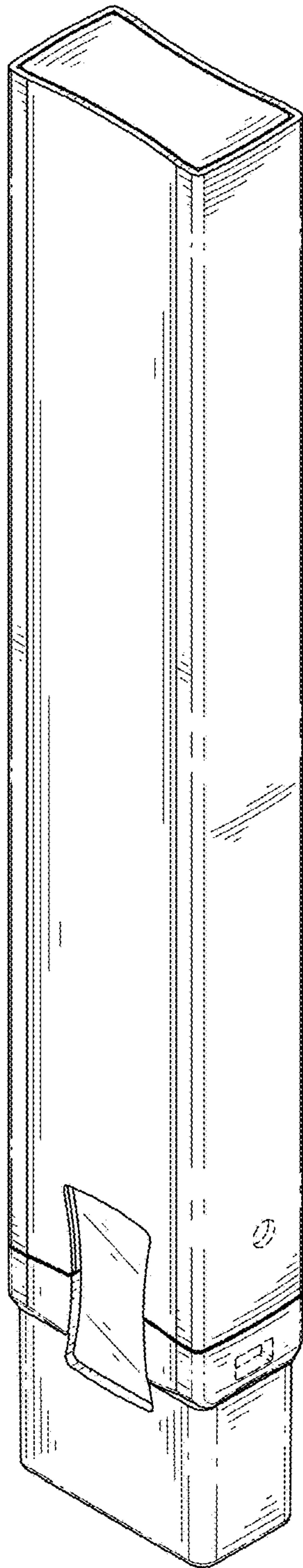

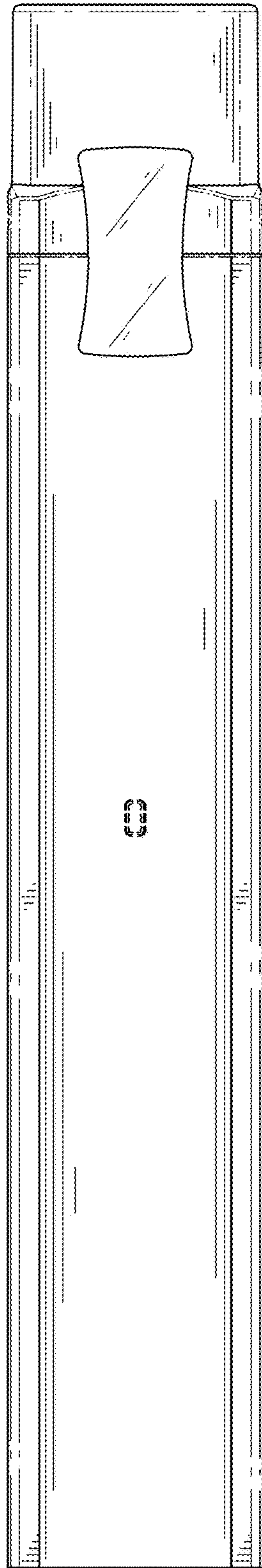

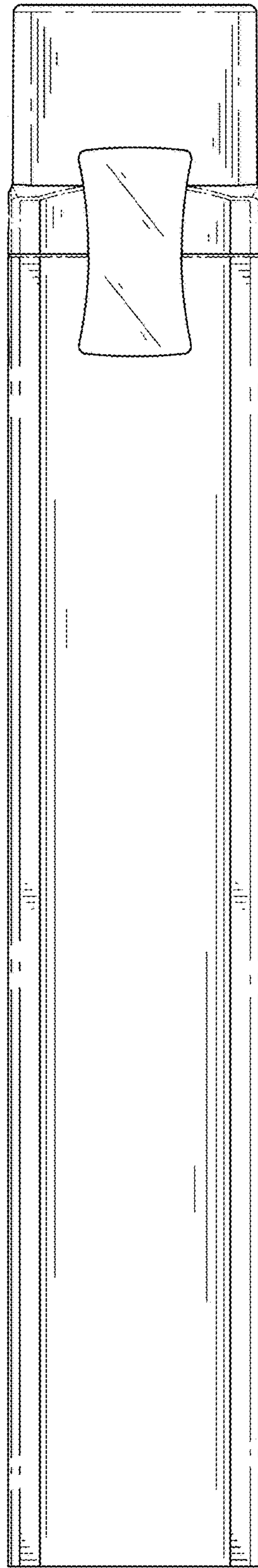

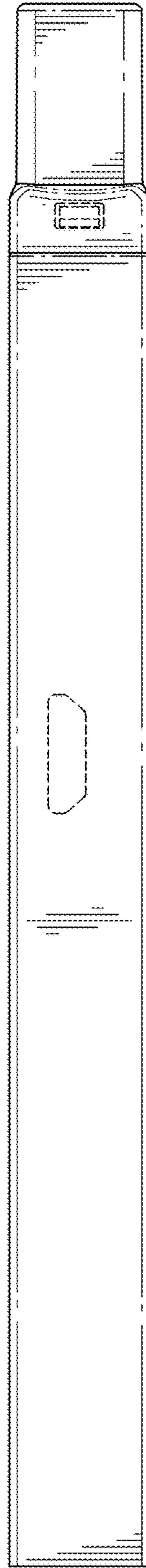

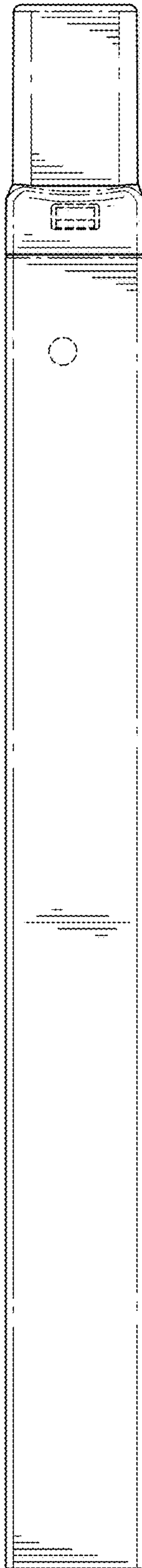

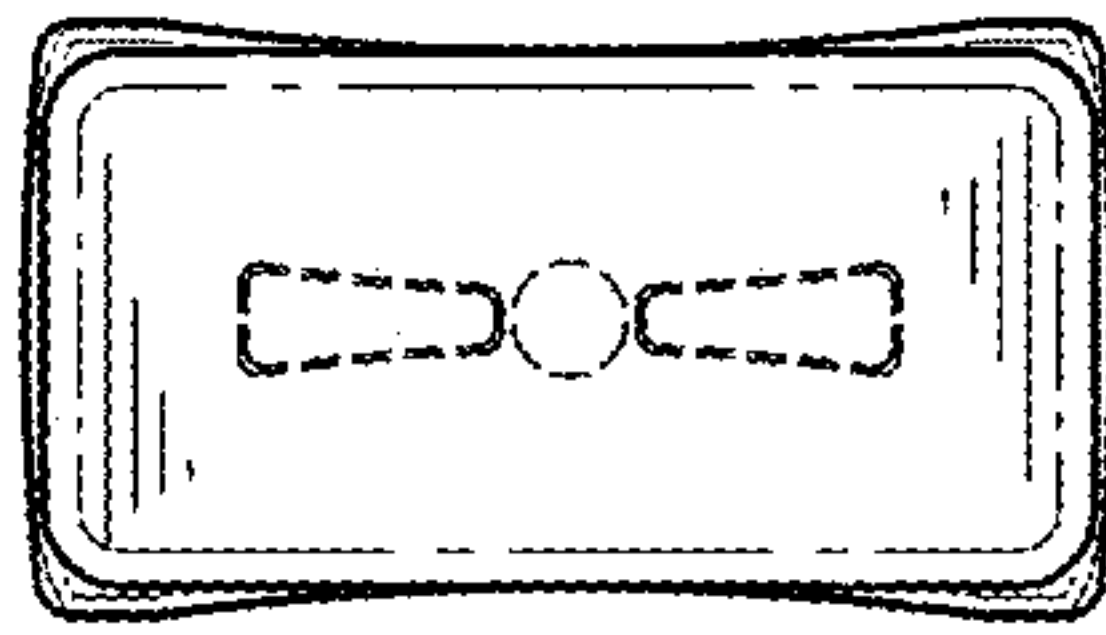

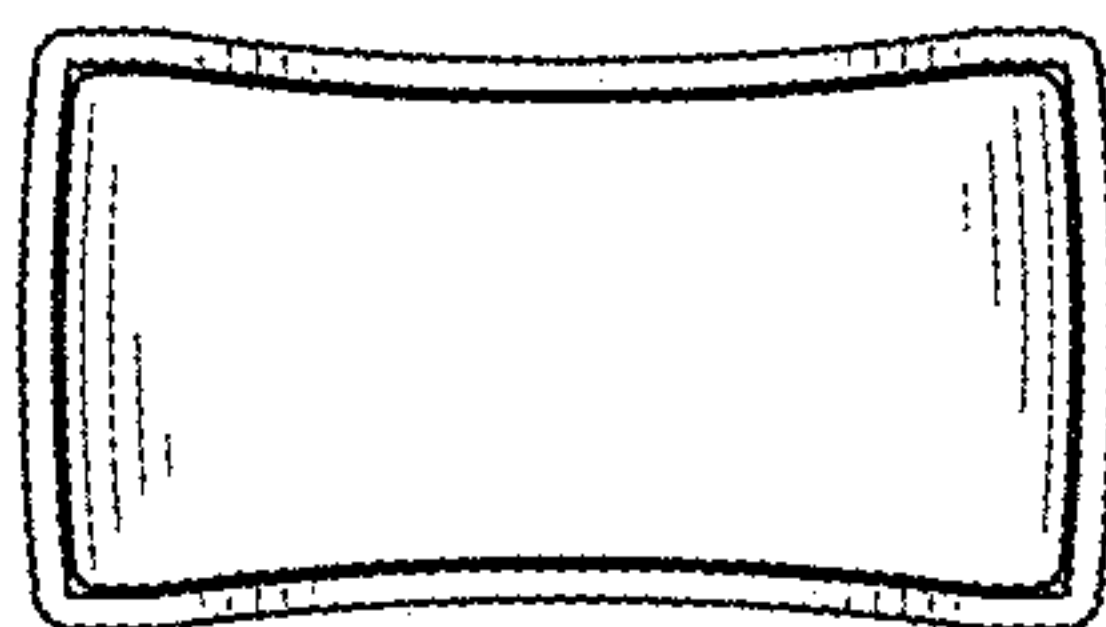
