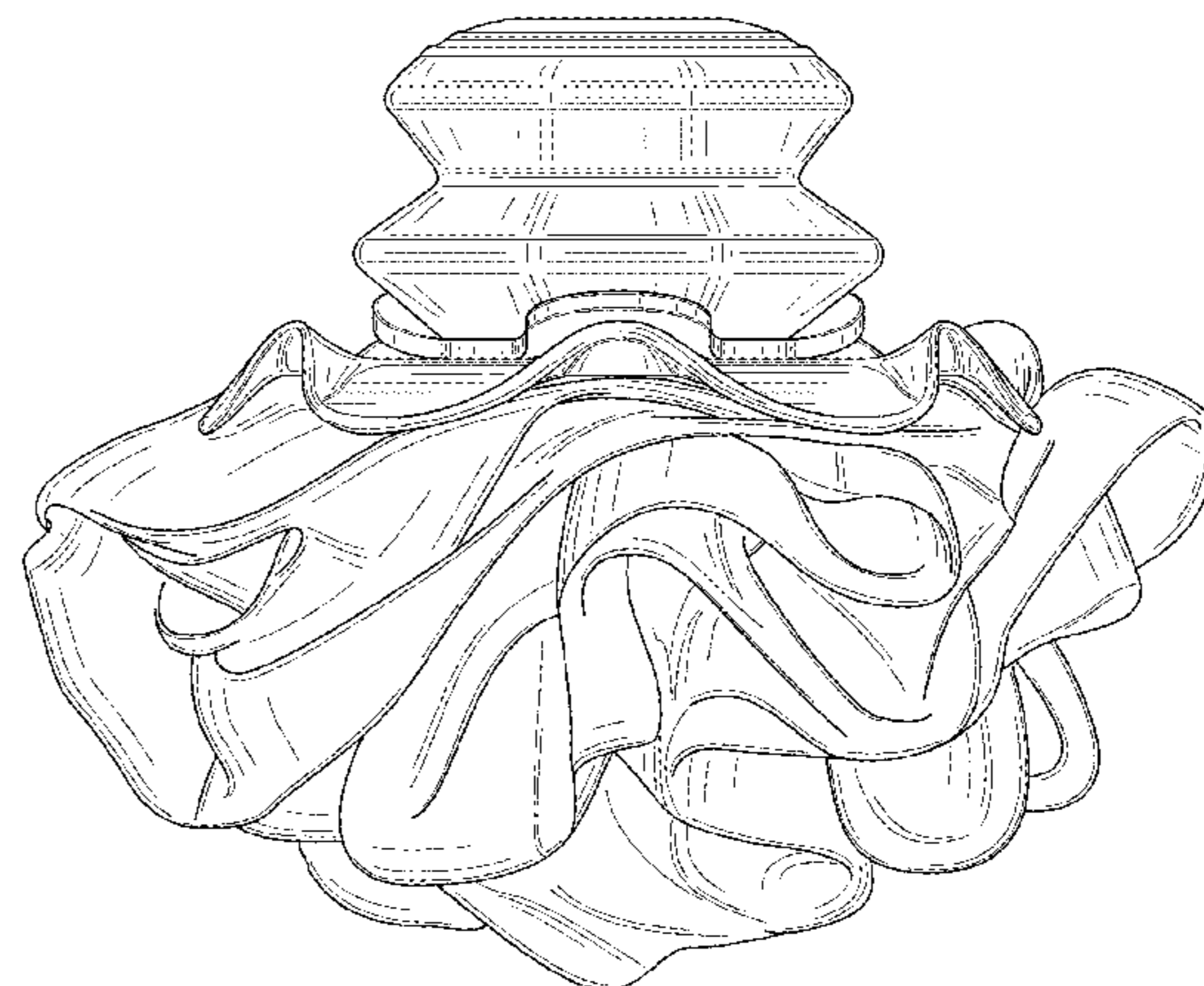
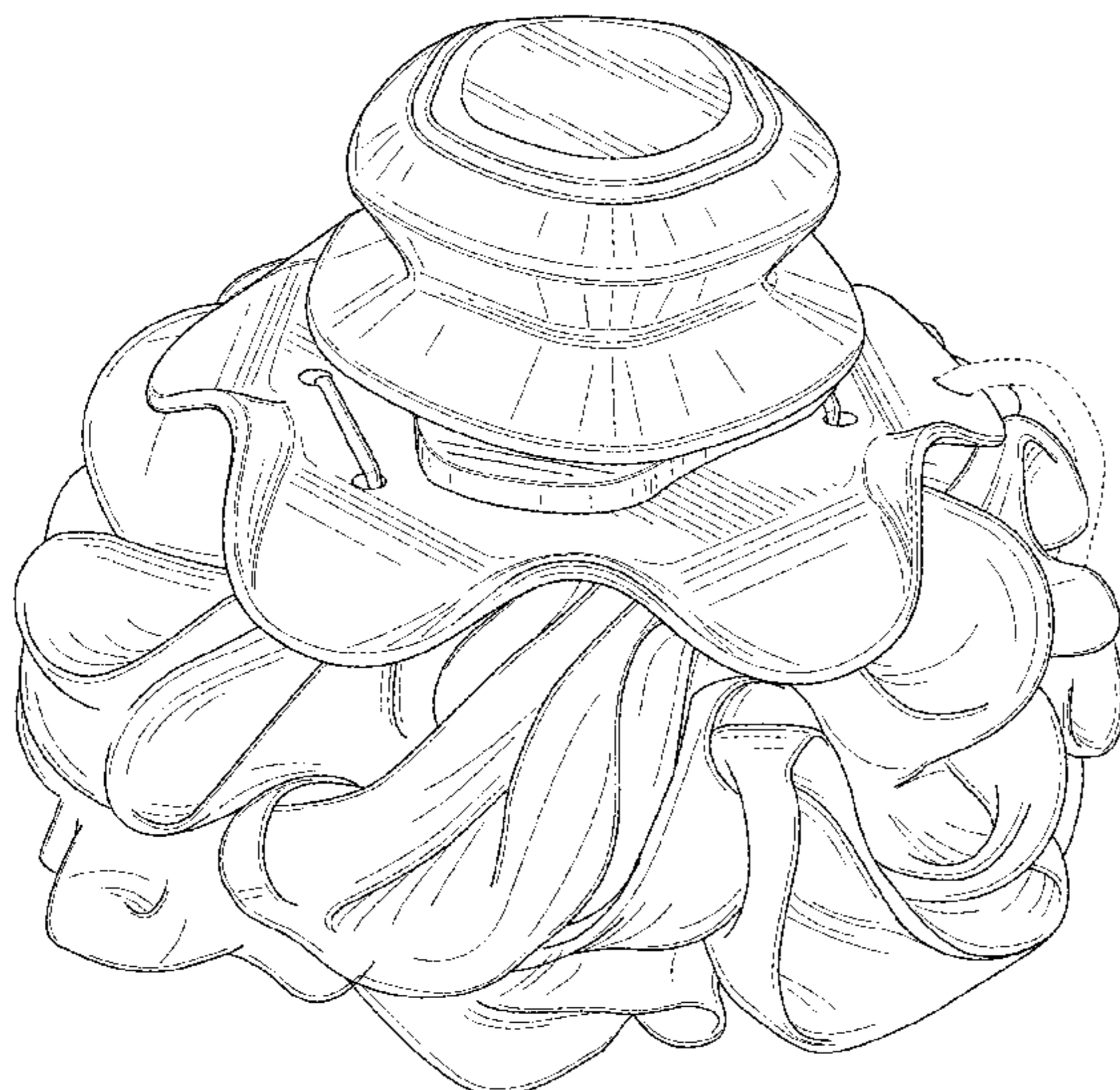
(57) **CLAIM**

The ornamental design for a mesh ball with soap reservoir, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a mesh ball with soap reservoir in accordance with my new design; FIG. 2 is a front elevation view thereof; FIG. 3 is a rear elevation view thereof; FIG. 4 is a left side elevation view thereof; FIG. 5 is a right side elevation view thereof; FIG. 6 is a top plan view thereof; and, FIG. 7 is a bottom plan view thereof. The broken lines shown in all of the figures illustrate features of the article of manufacture and form no part of the claimed design.

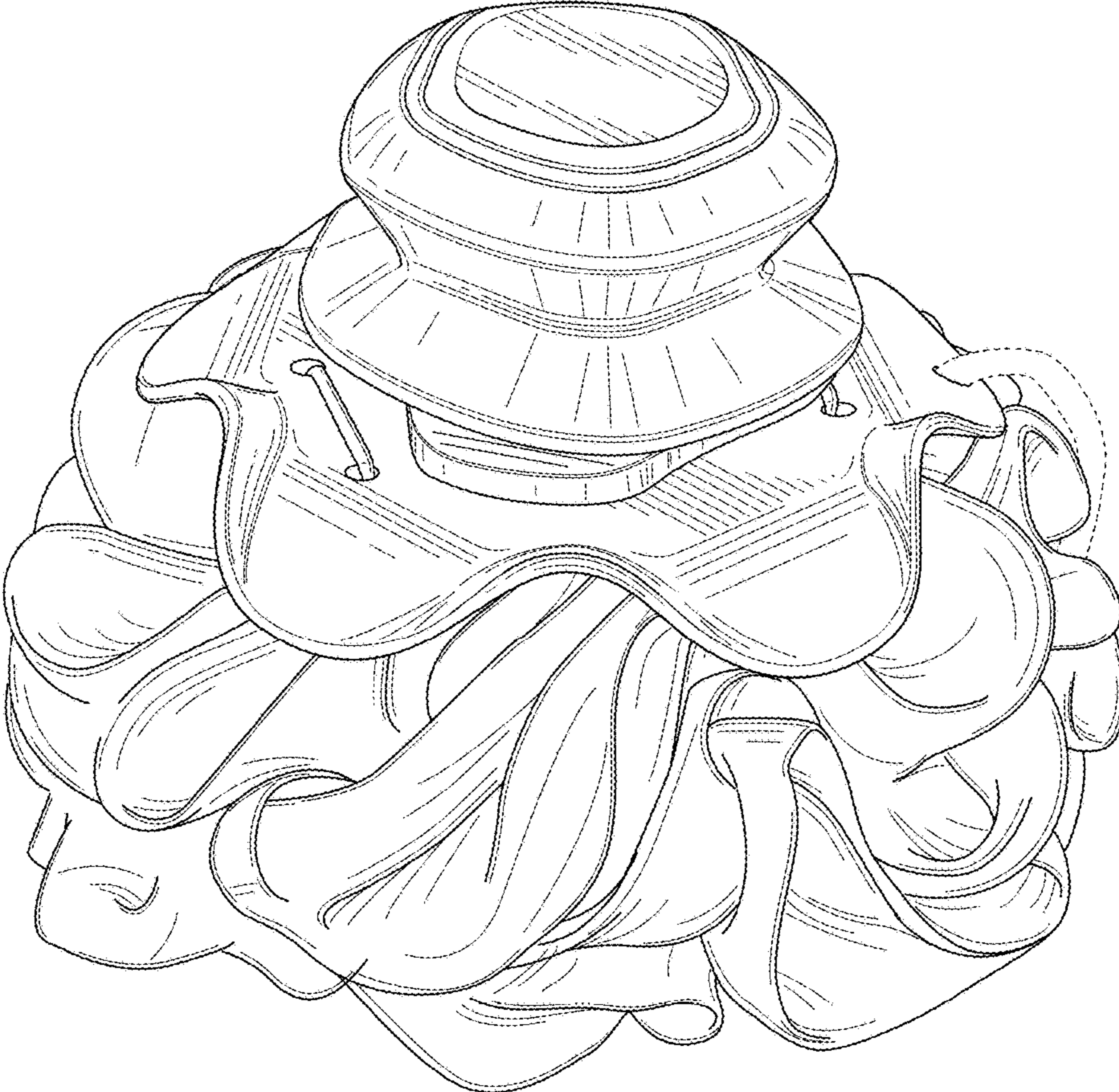

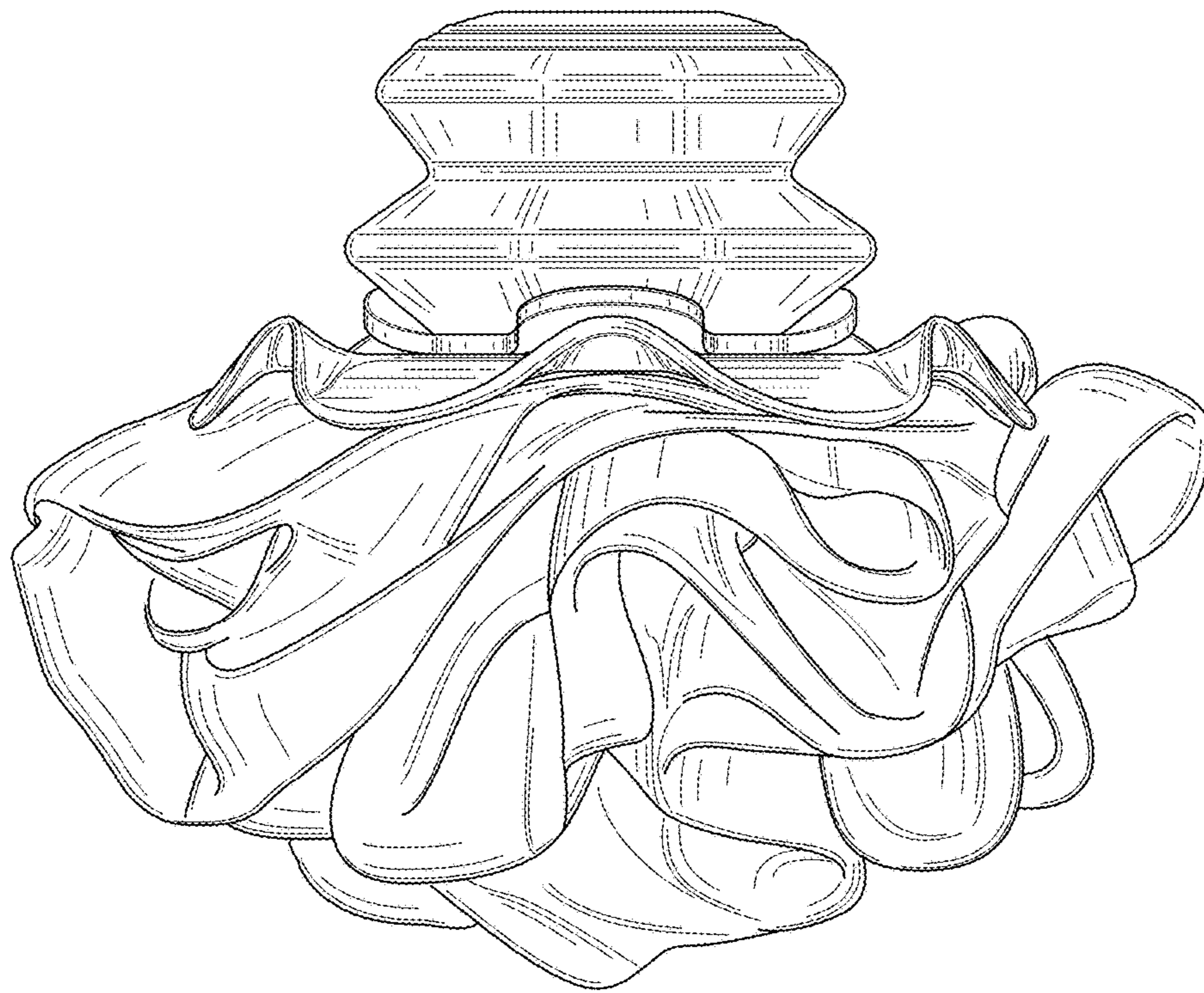

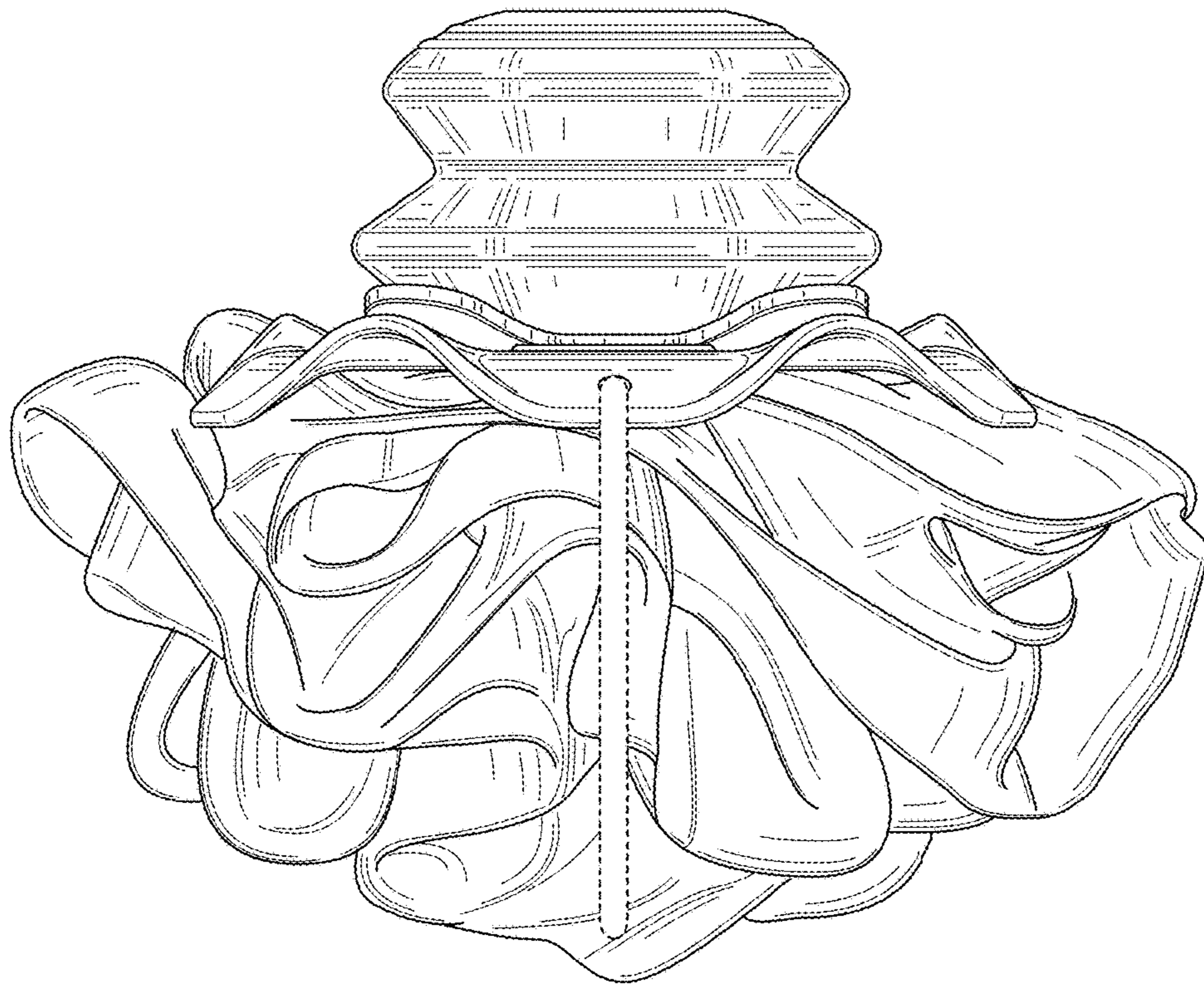

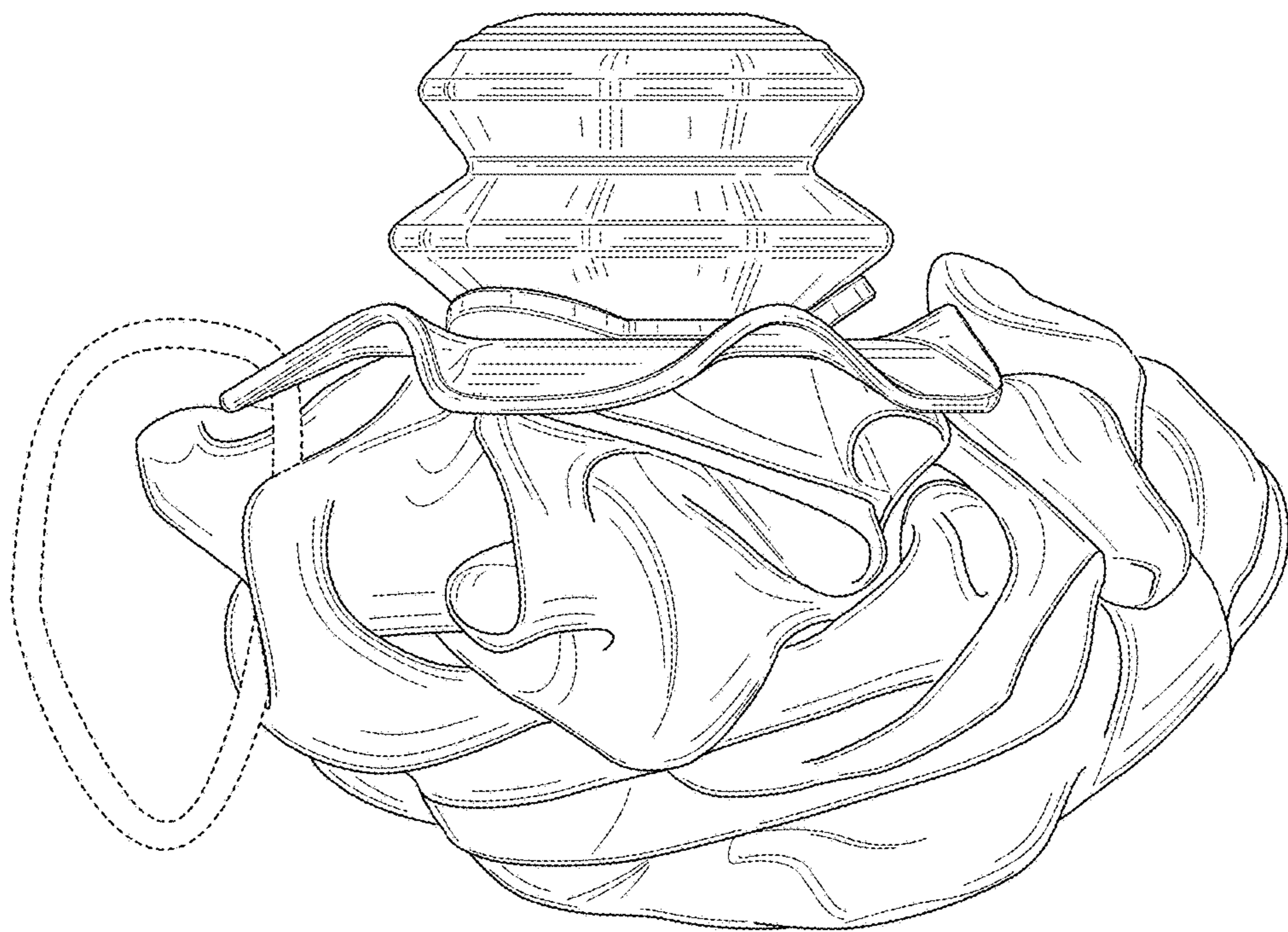

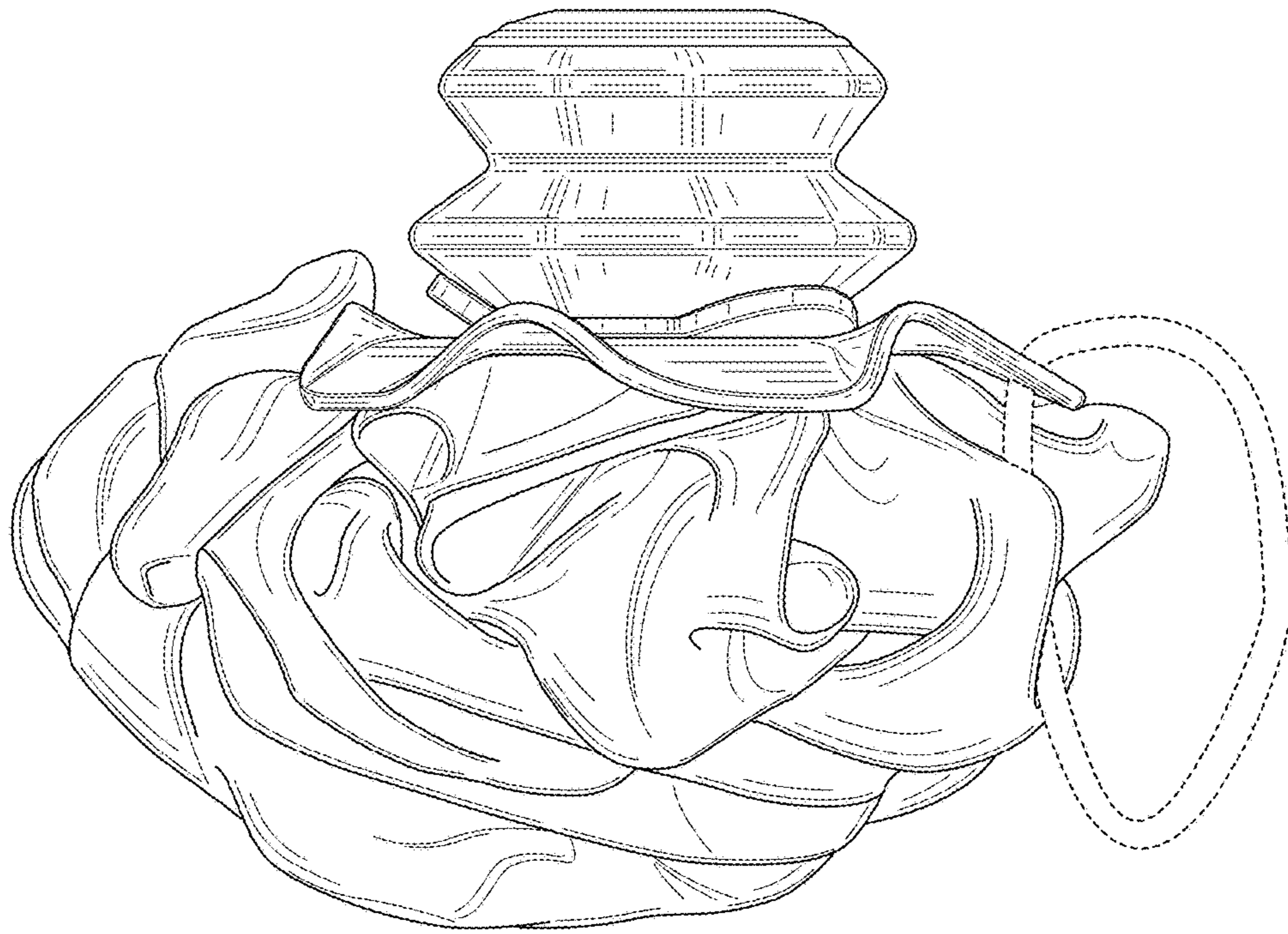

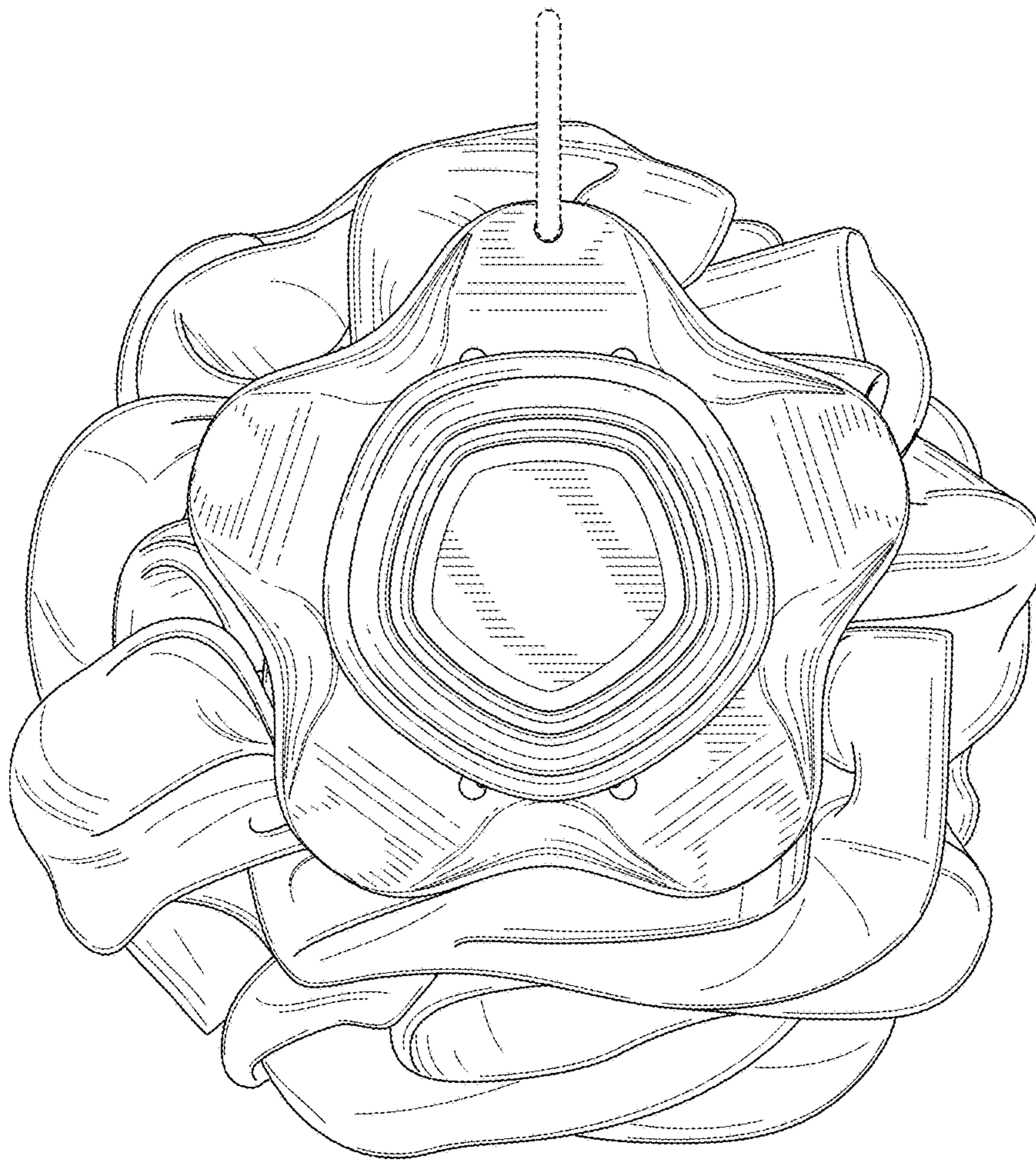

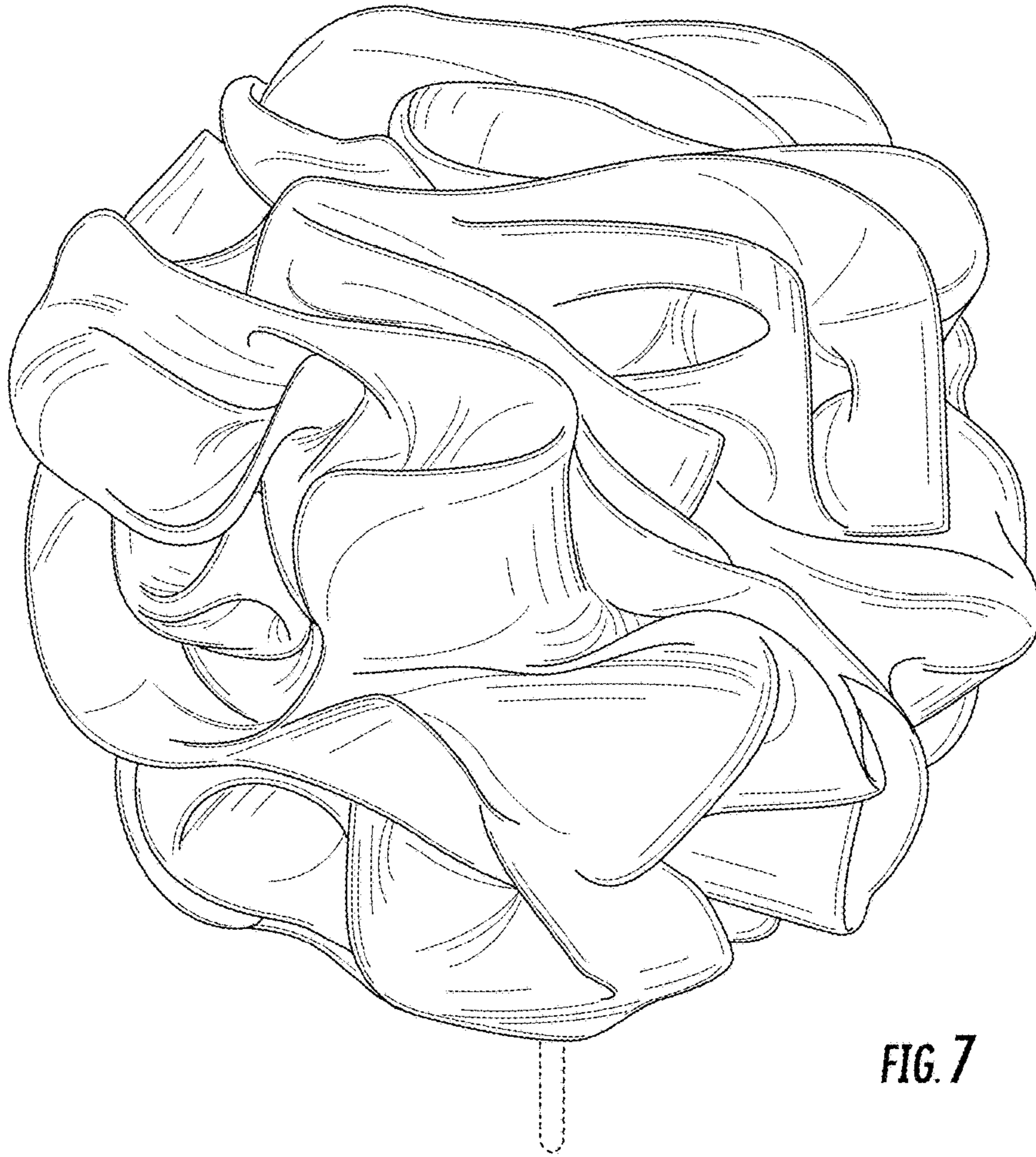
