(57) **CLAIM**

The ornamental design for a mascara container with retractable wand, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and side perspective view of a first embodiment showing a mascara container with retractable wand embodying my new design, with a mascara brush of the retractable mascara wand fully extended.

FIG. 32 is a left side view thereof.

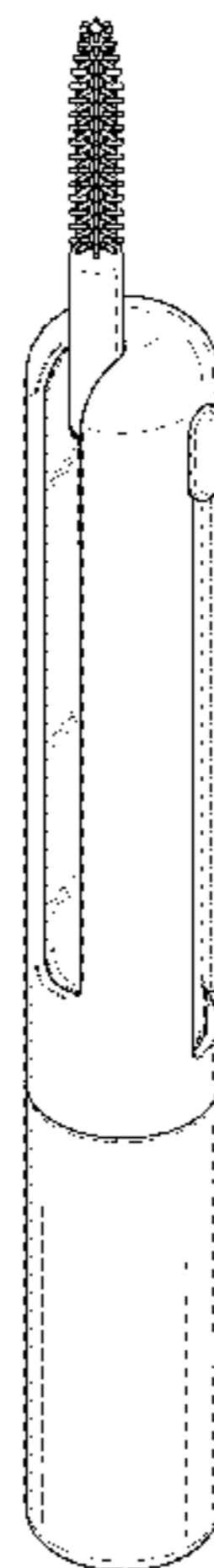
FIG. 33 is a right side view thereof.

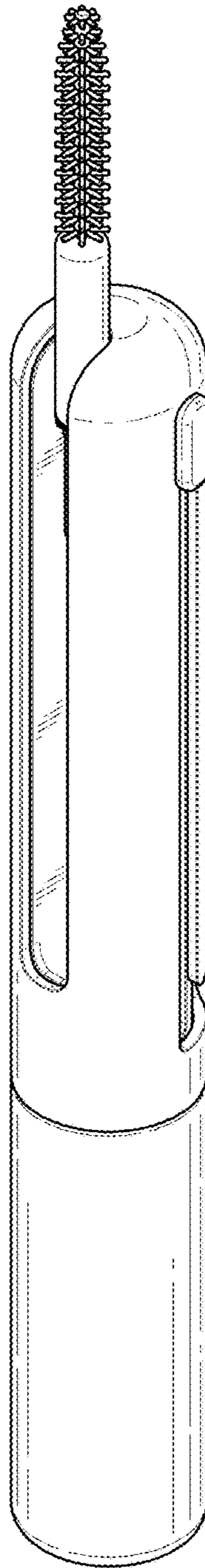

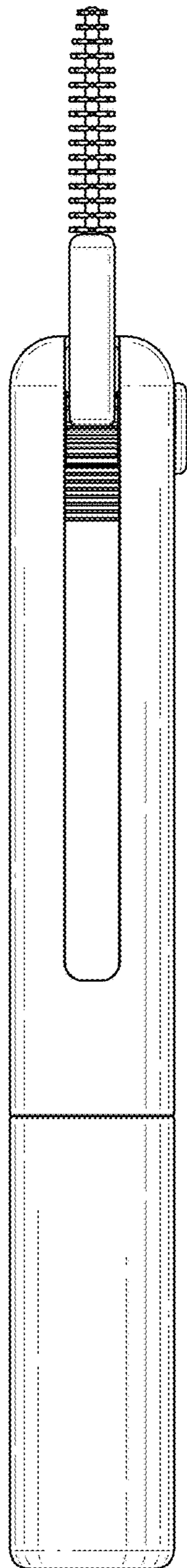

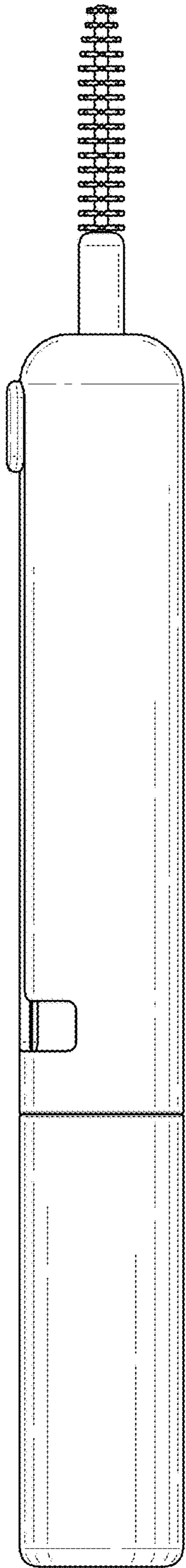

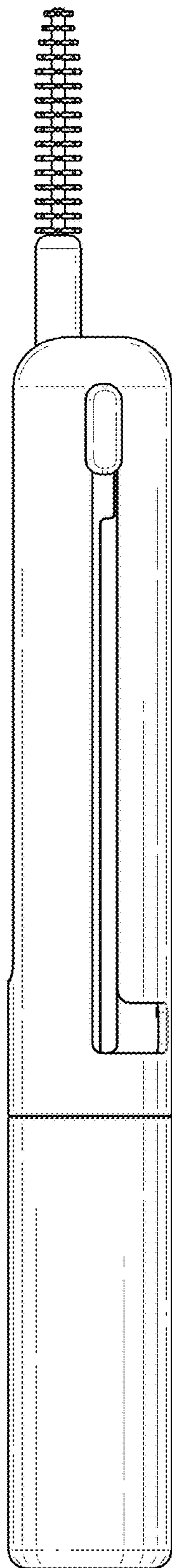

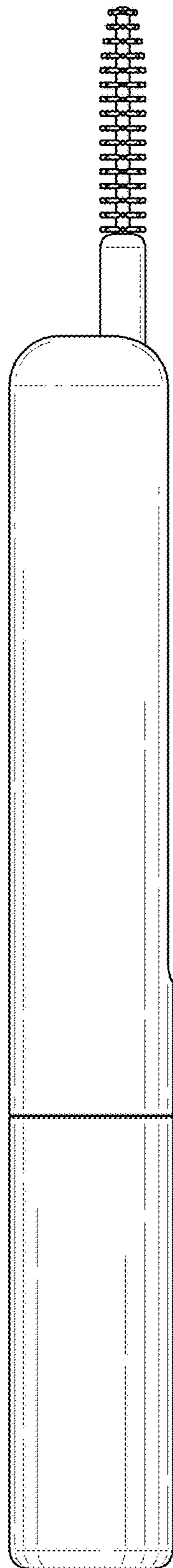

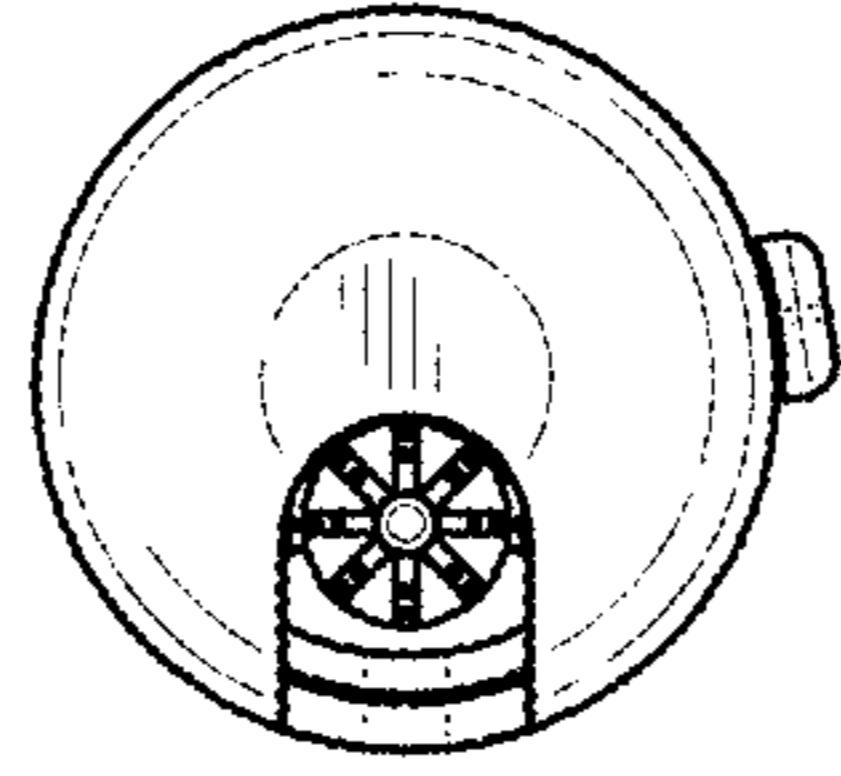

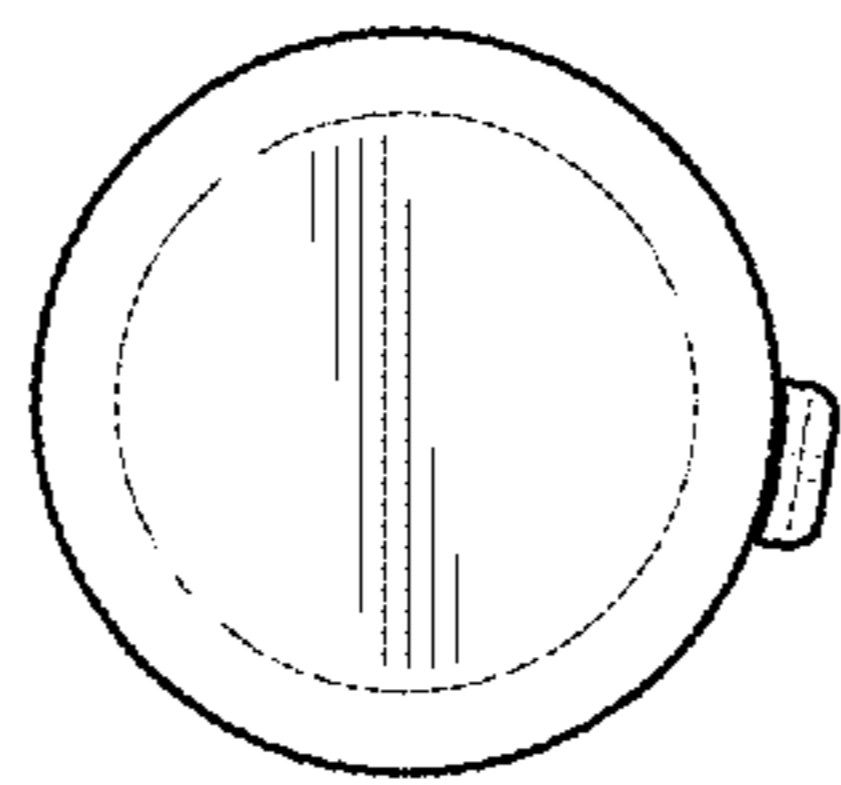

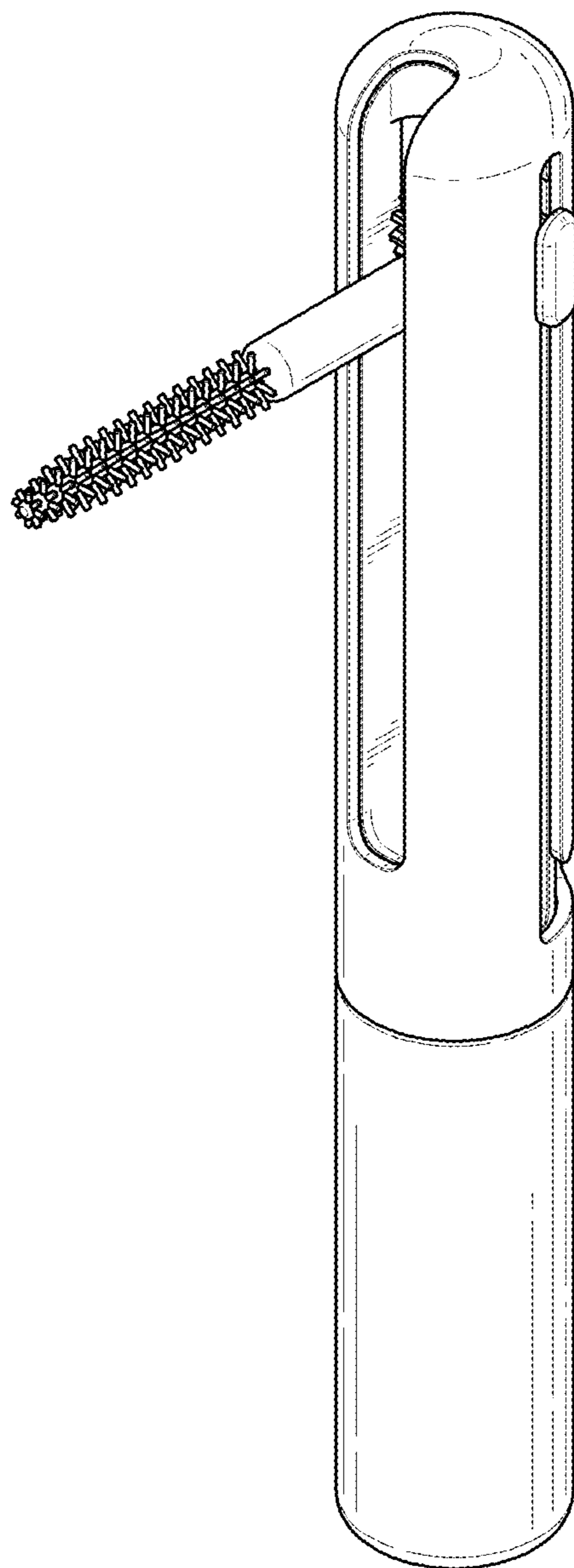

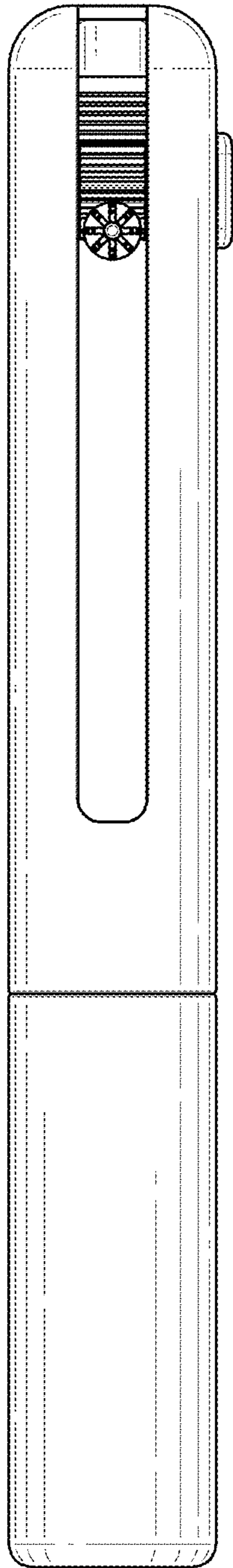

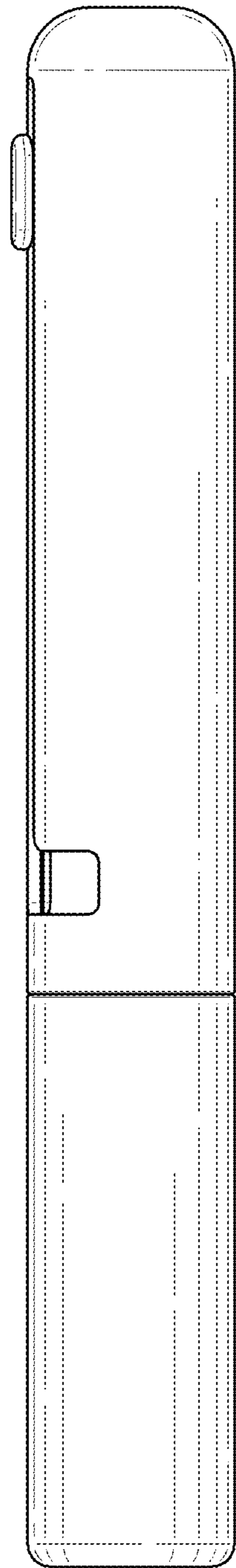

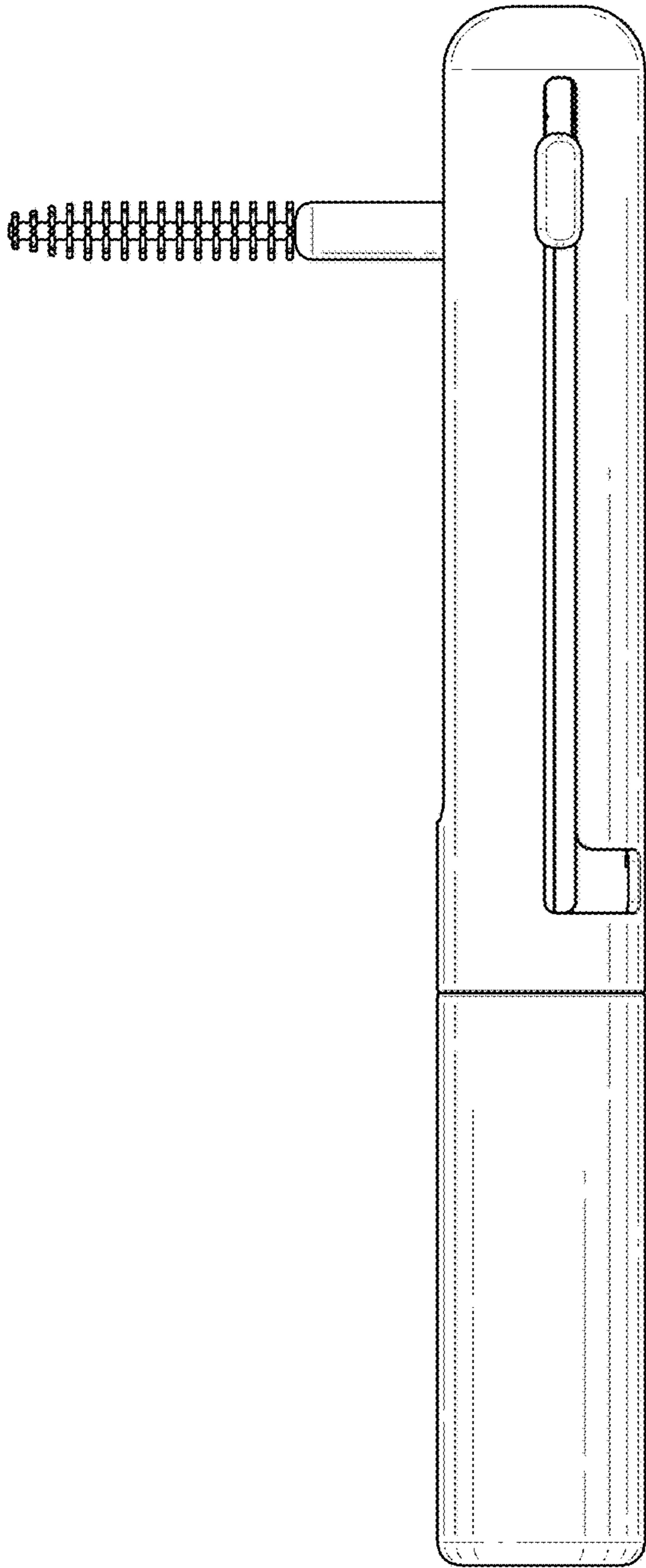

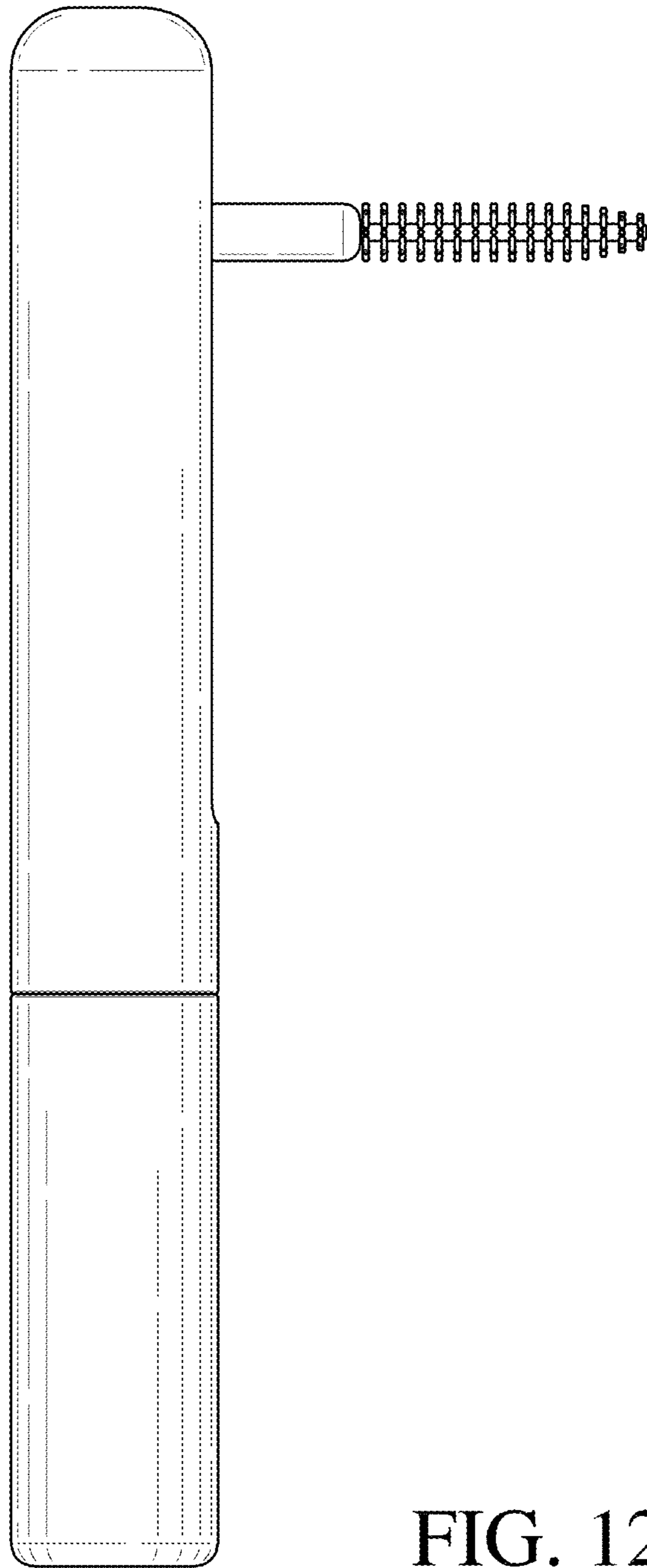

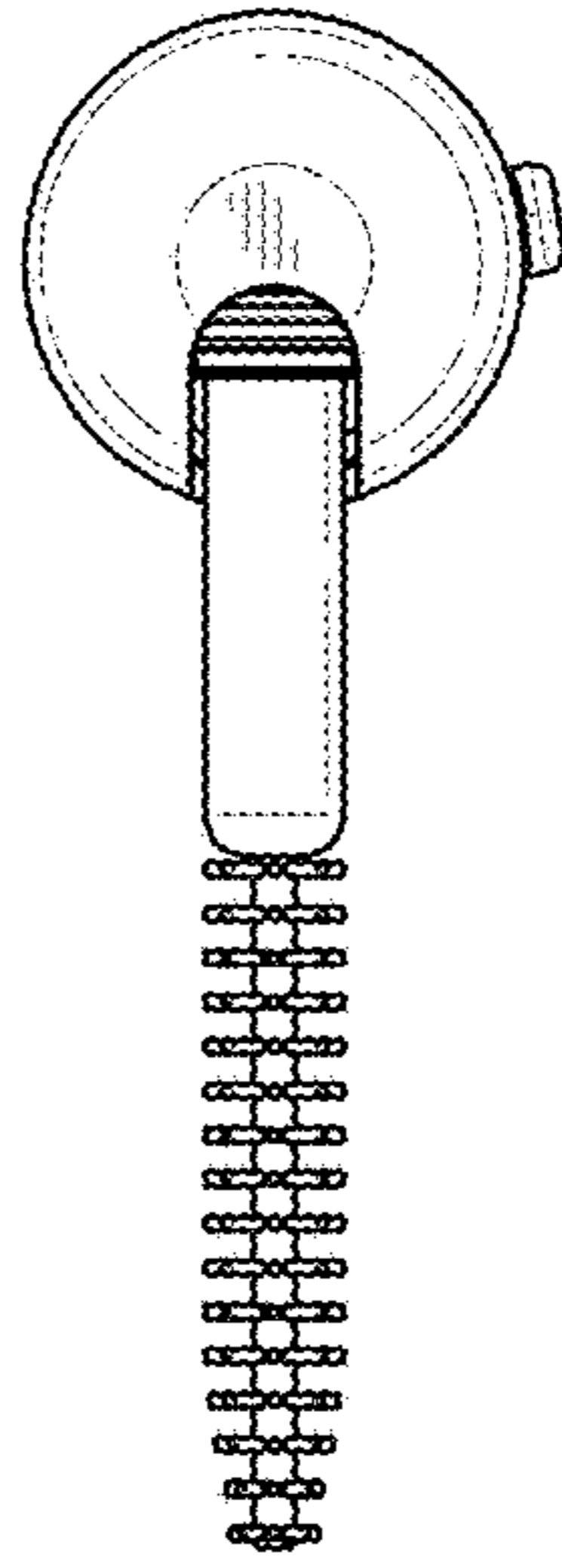

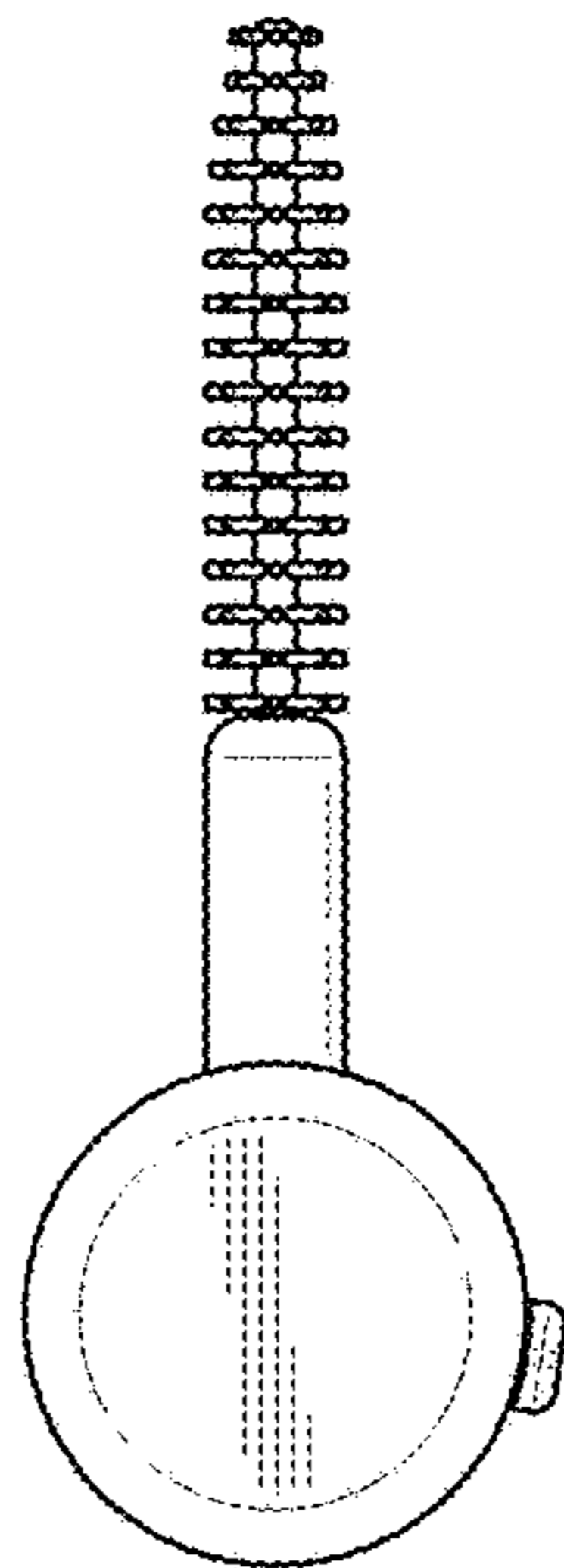

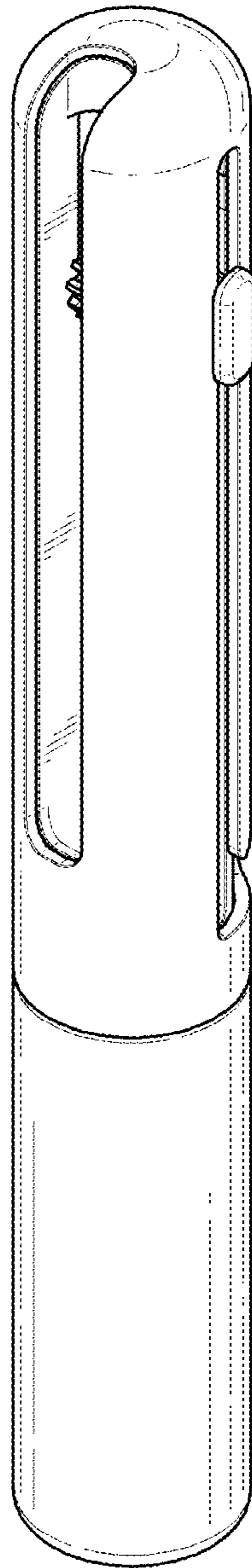

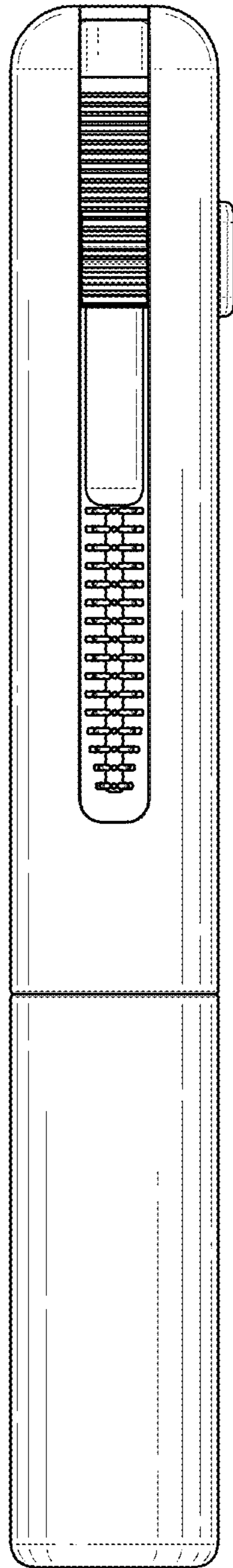

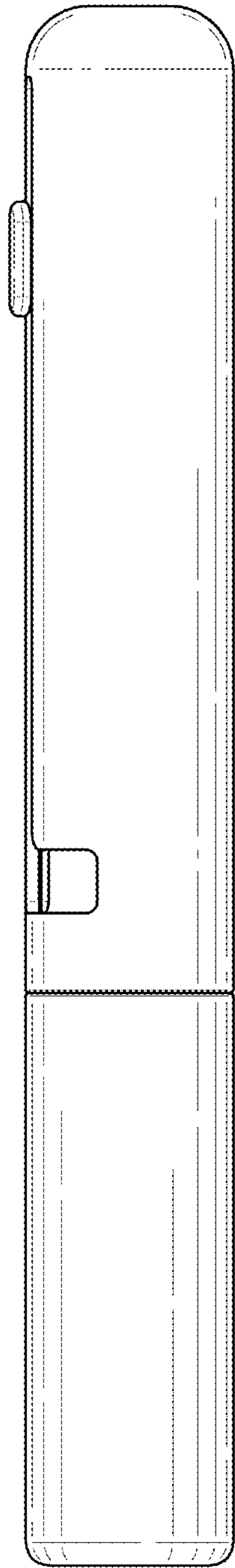

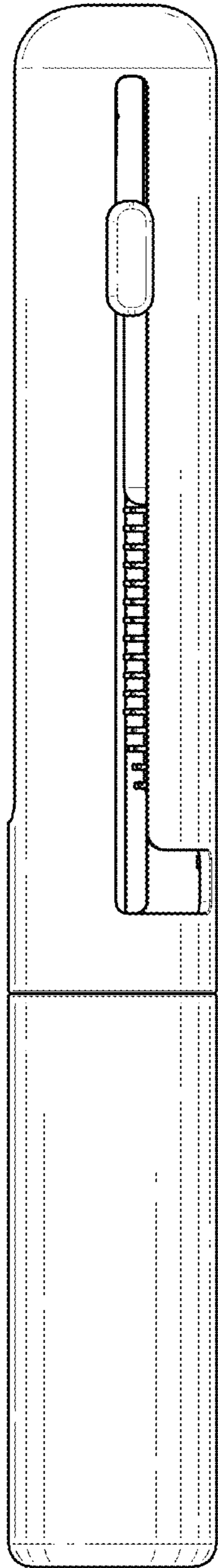

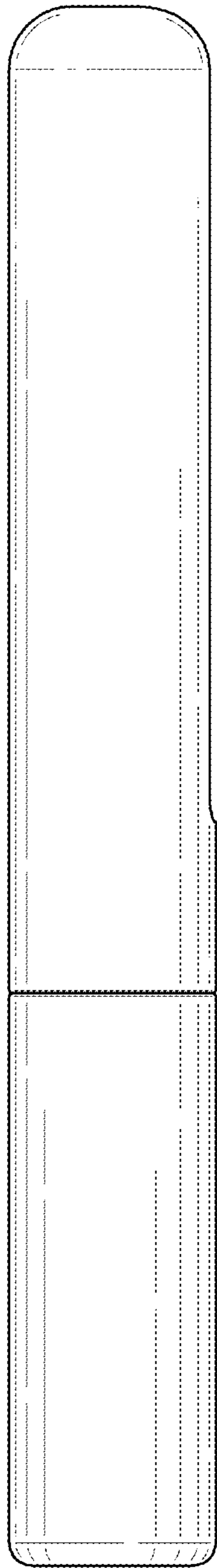

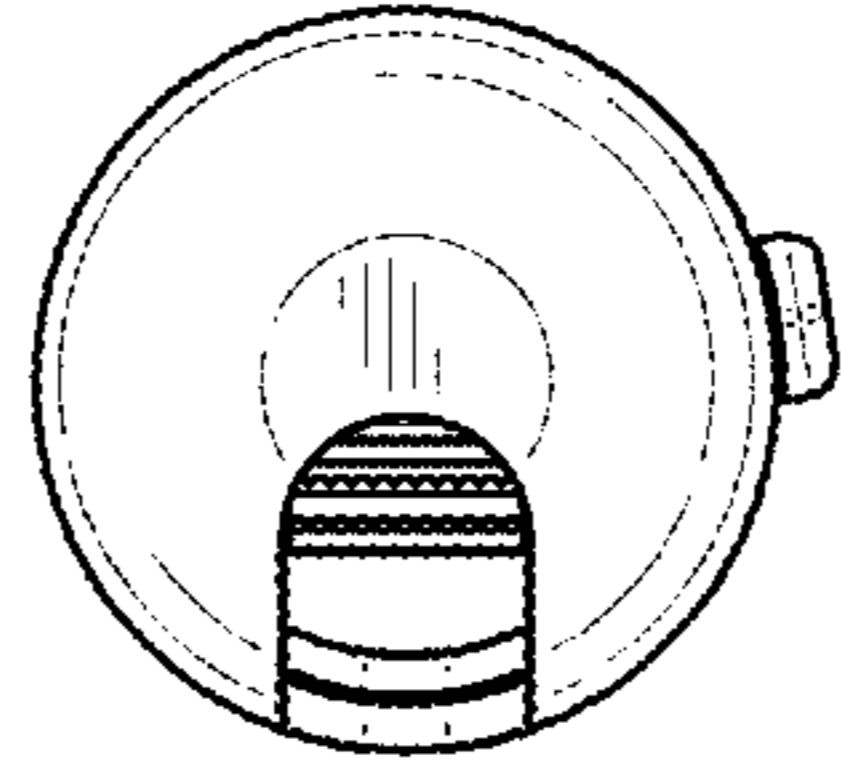

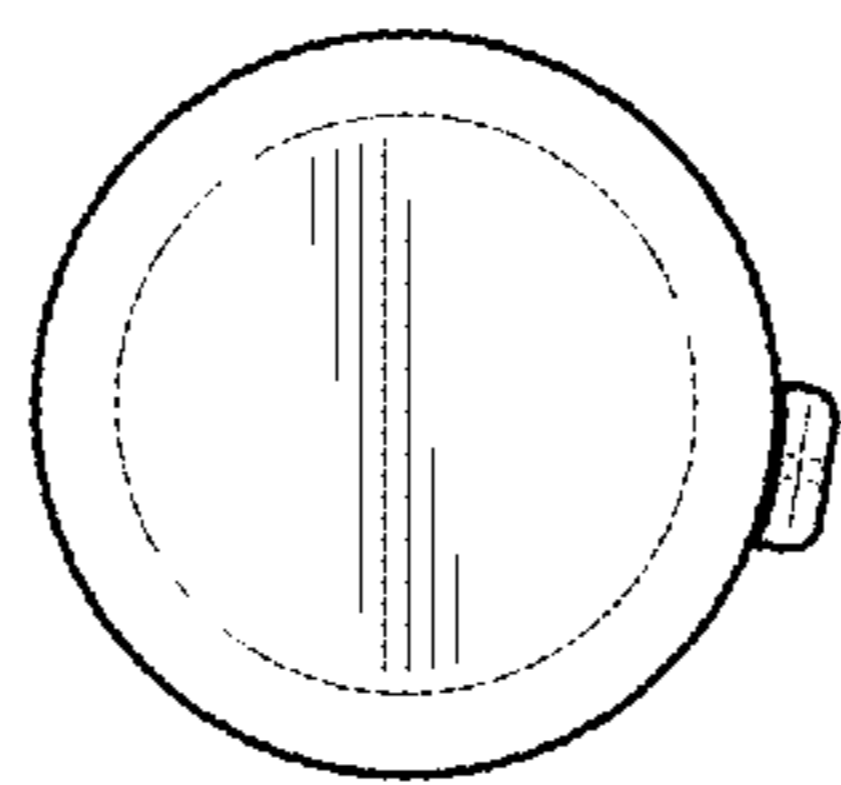

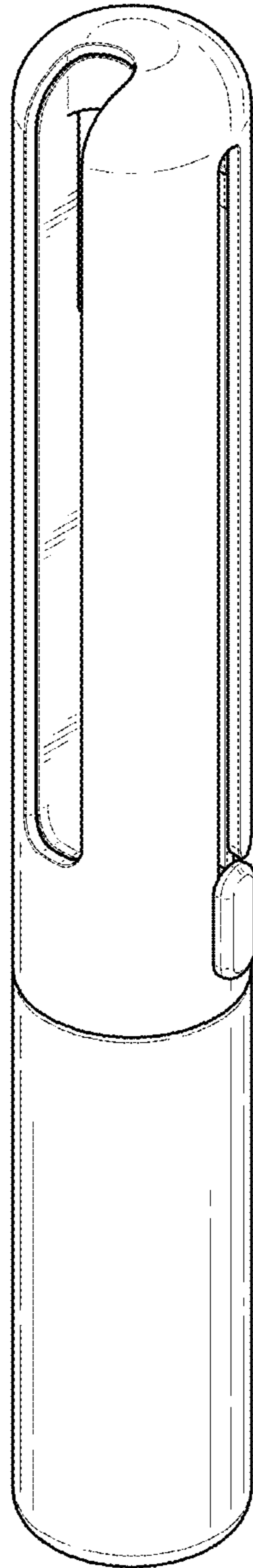

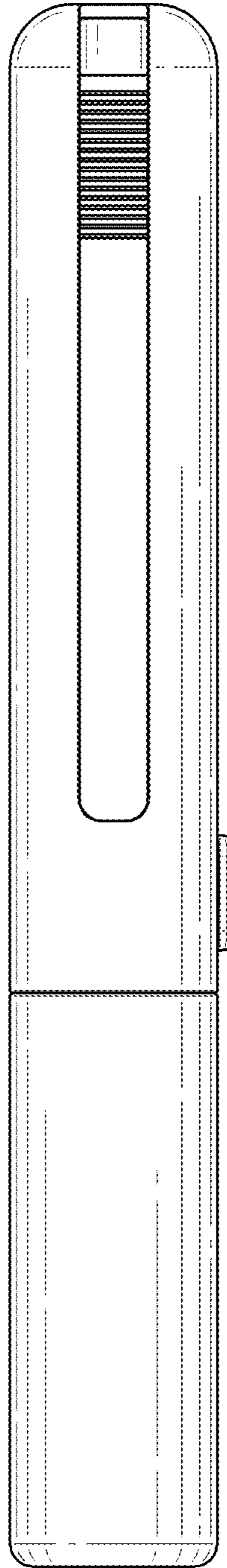

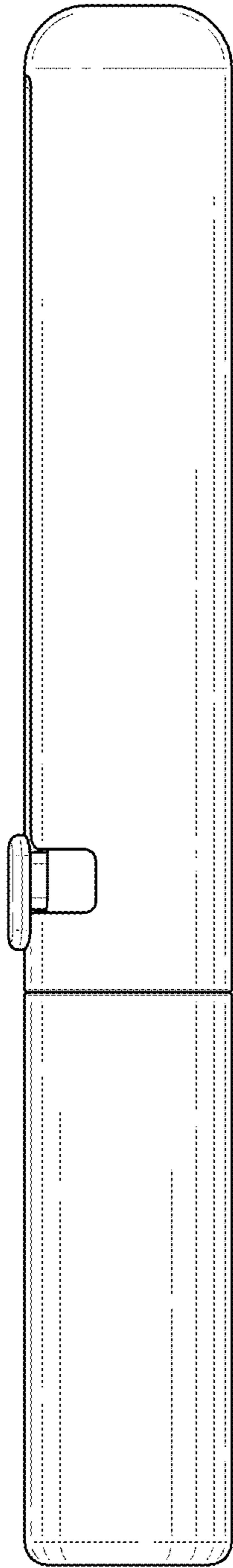

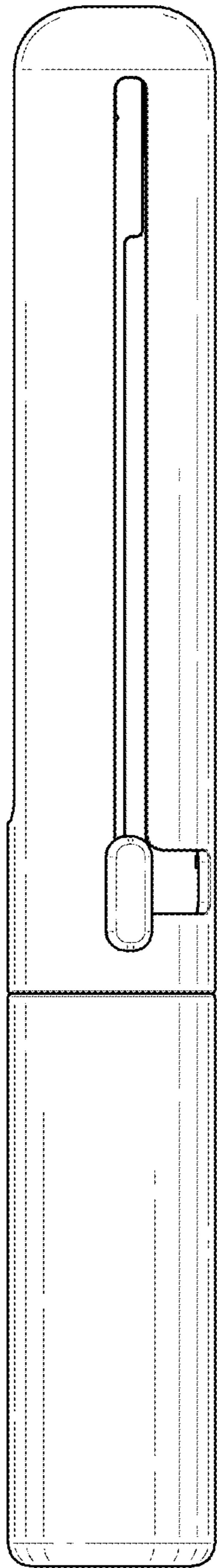

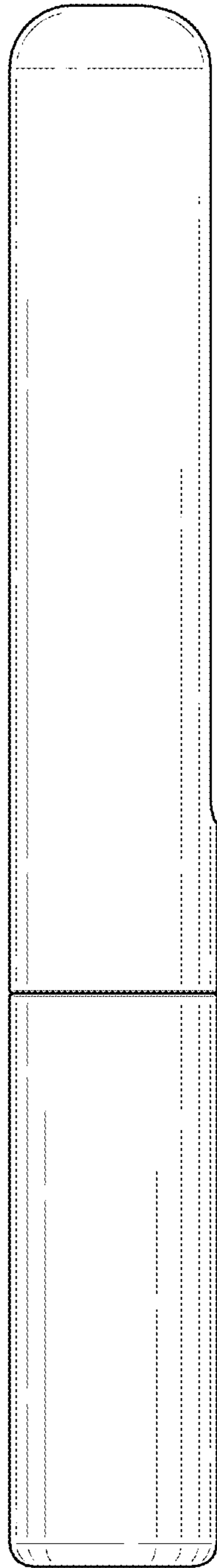

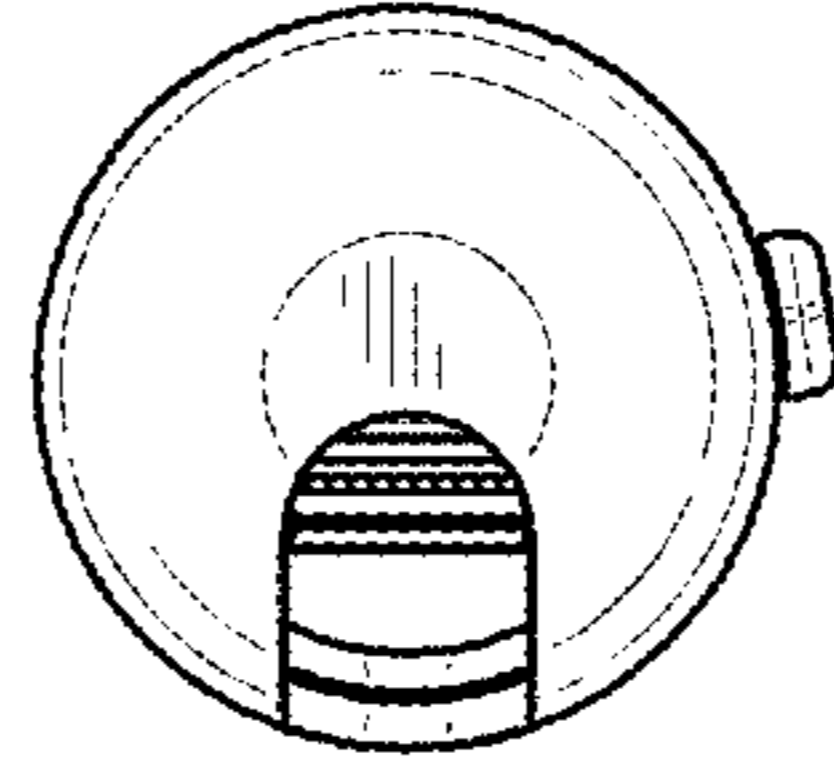

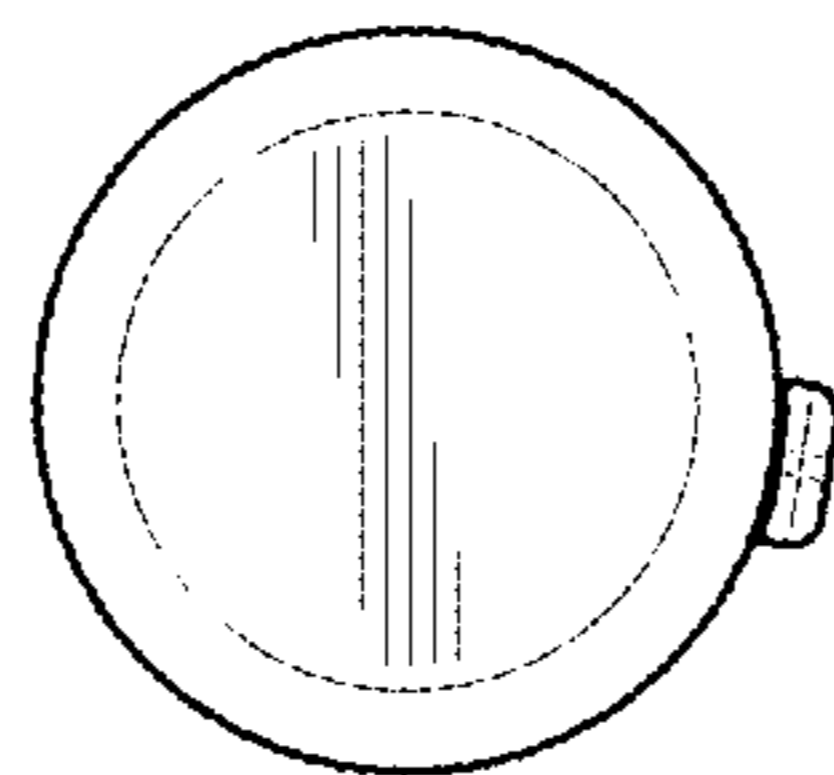

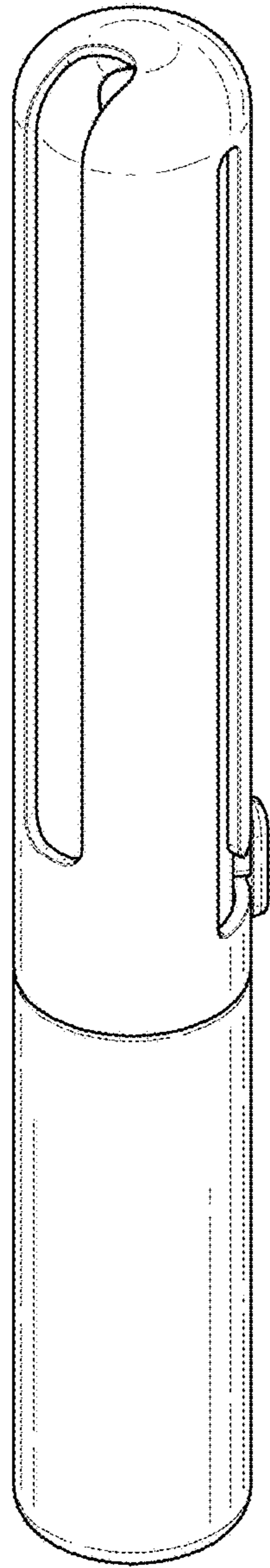

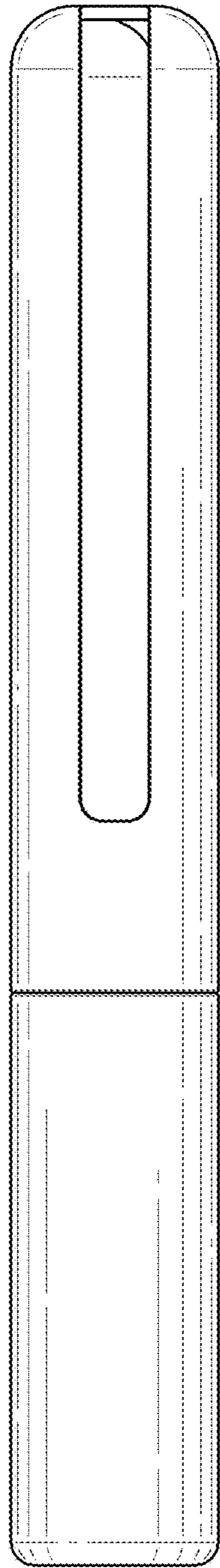

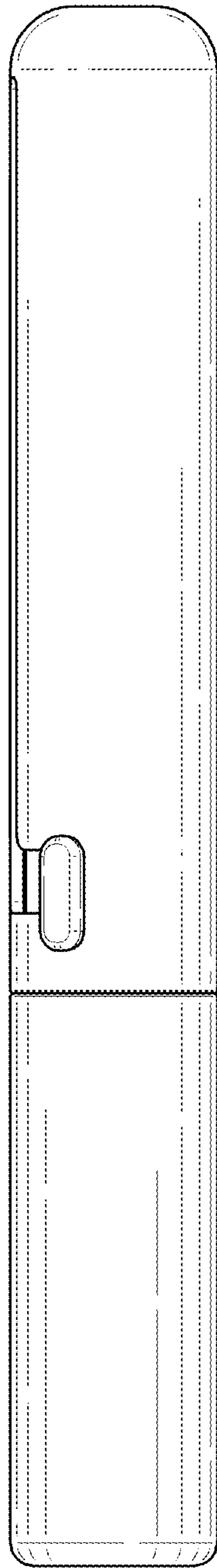

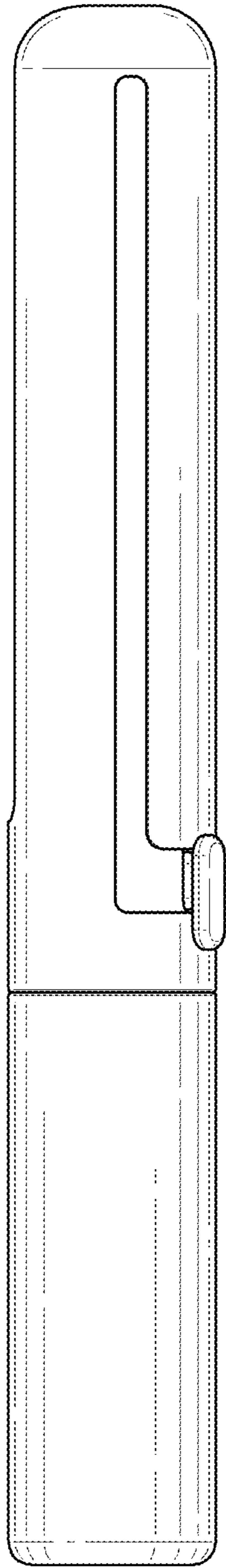

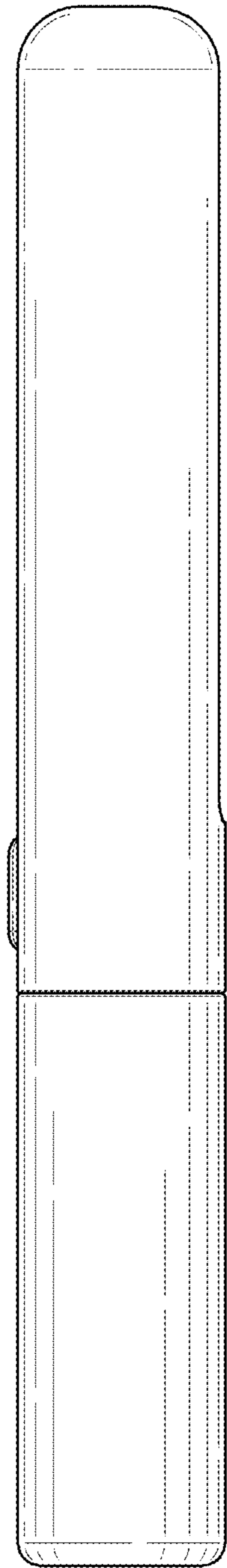

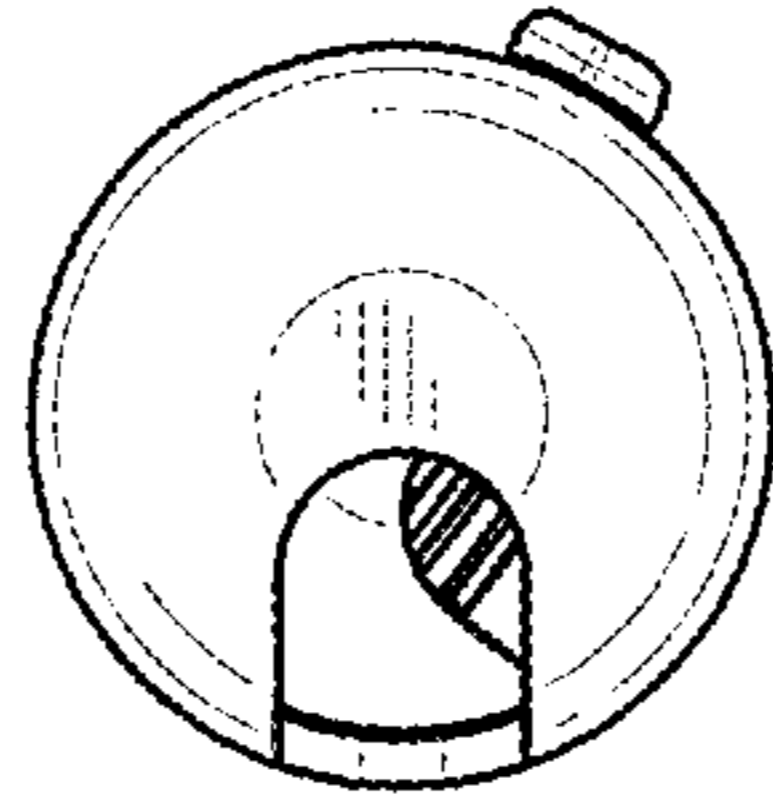

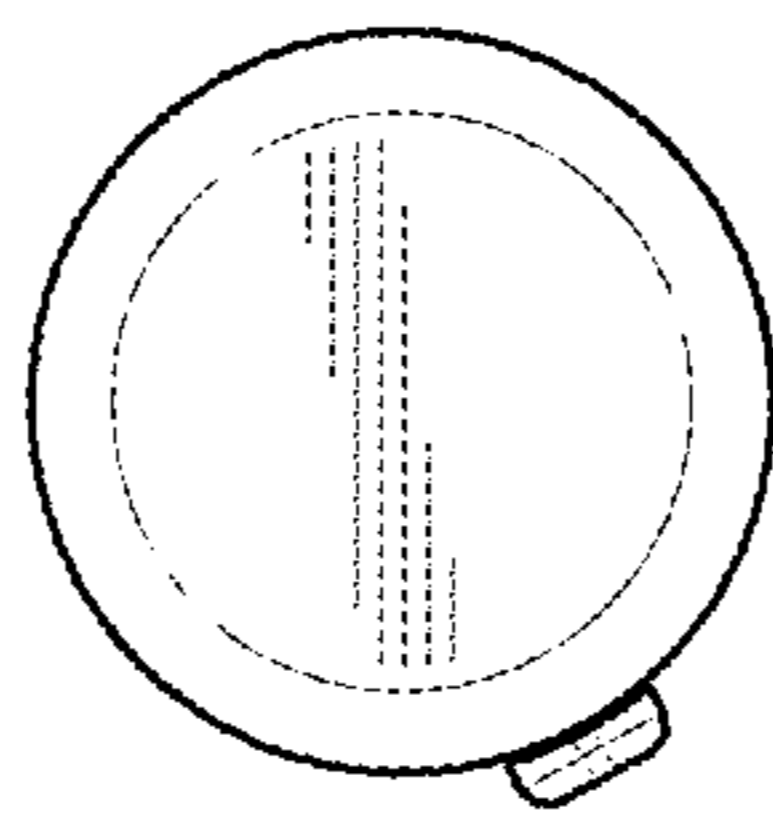
