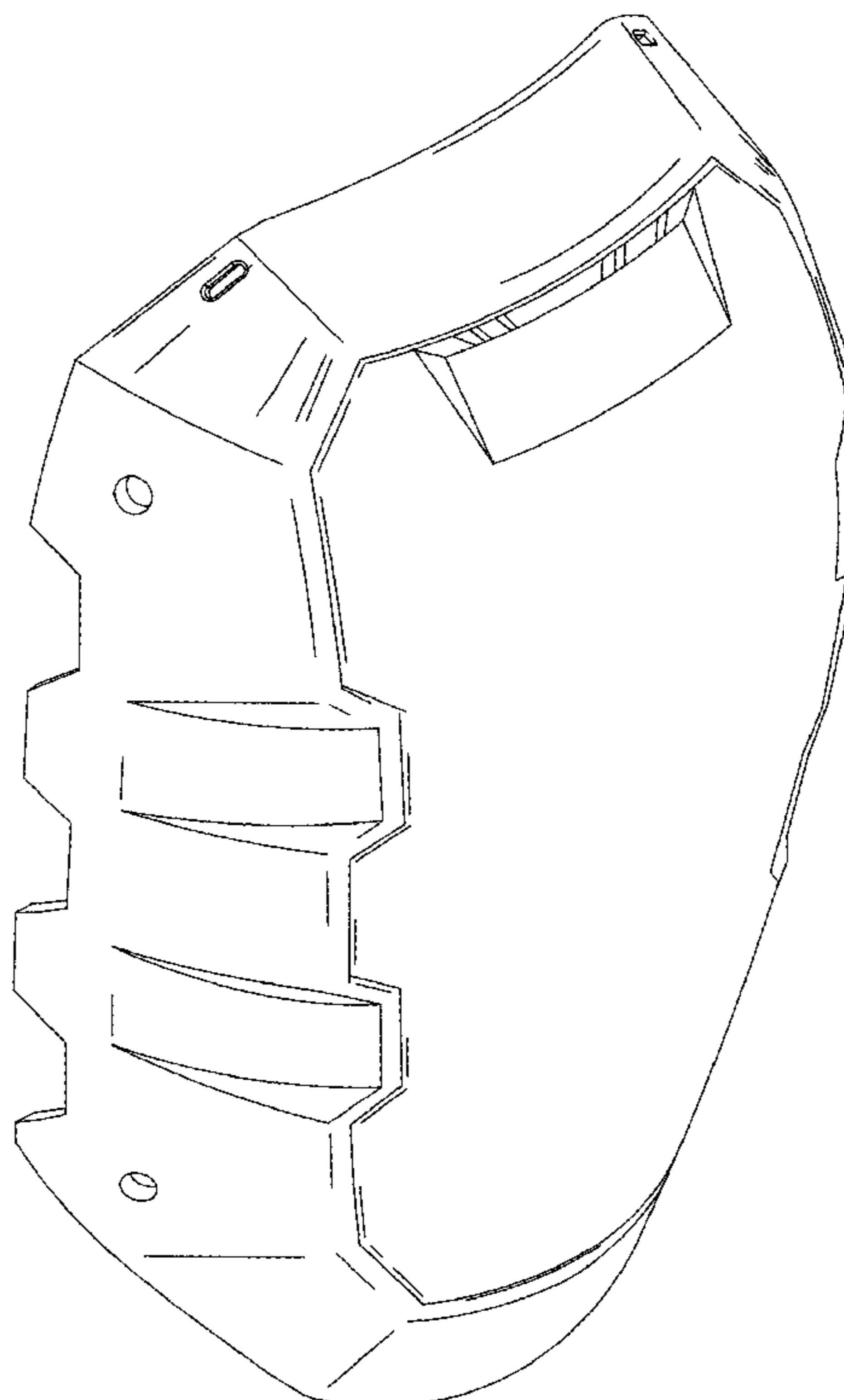
(57) **CLAIM**

The ornamental design for a kneepad, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a kneepad;
FIG. 2 is a right side view of the kneepad;
FIG. 3 is a left side view of the kneepad;
FIG. 4 is a front view of the kneepad;
FIG. 5 is a back view of the kneepad;
FIG. 6 is a top view of the kneepad;
FIG. 7 is a bottom view of the kneepad; and,
FIG. 8 is a second perspective view of the kneepad.

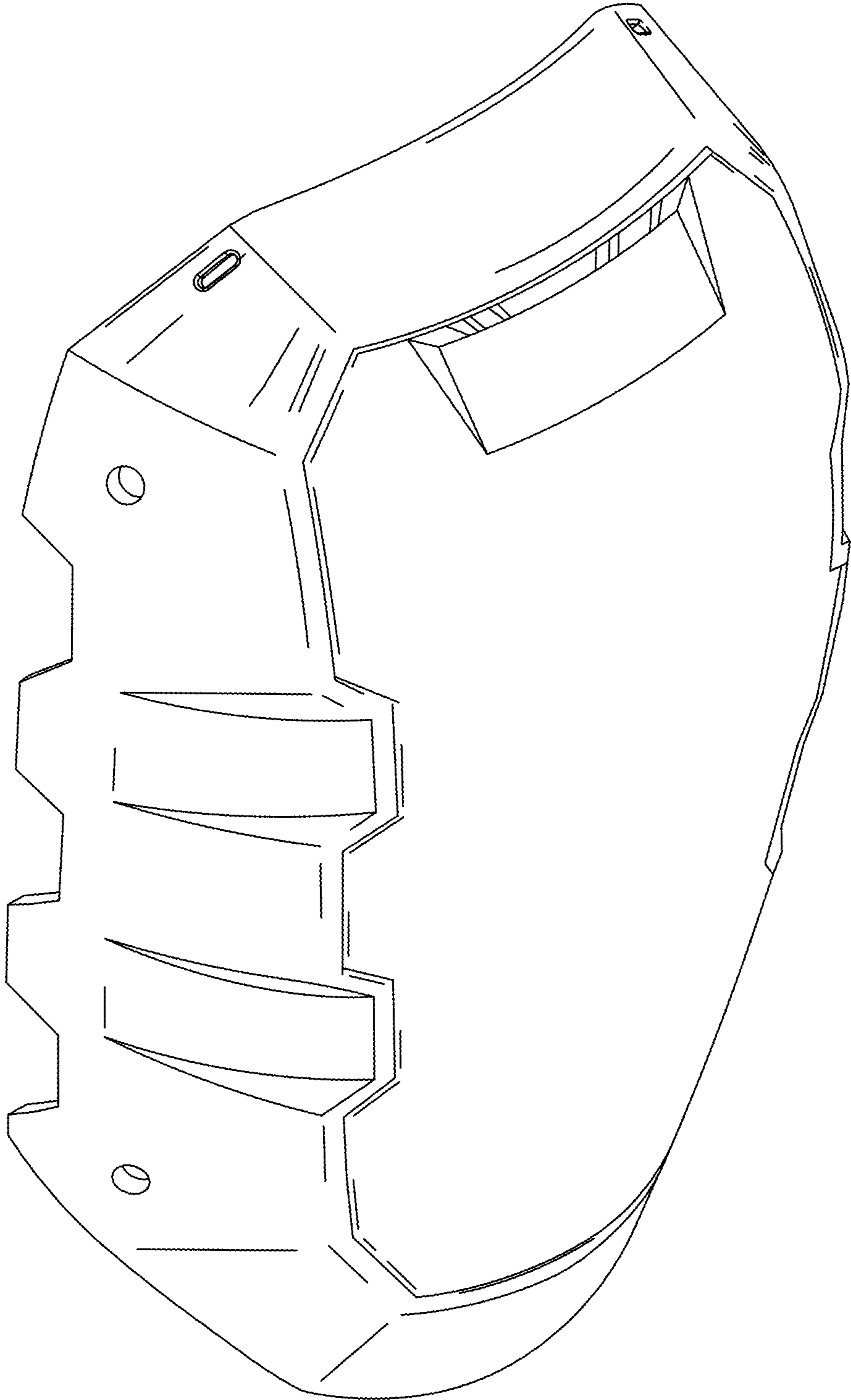

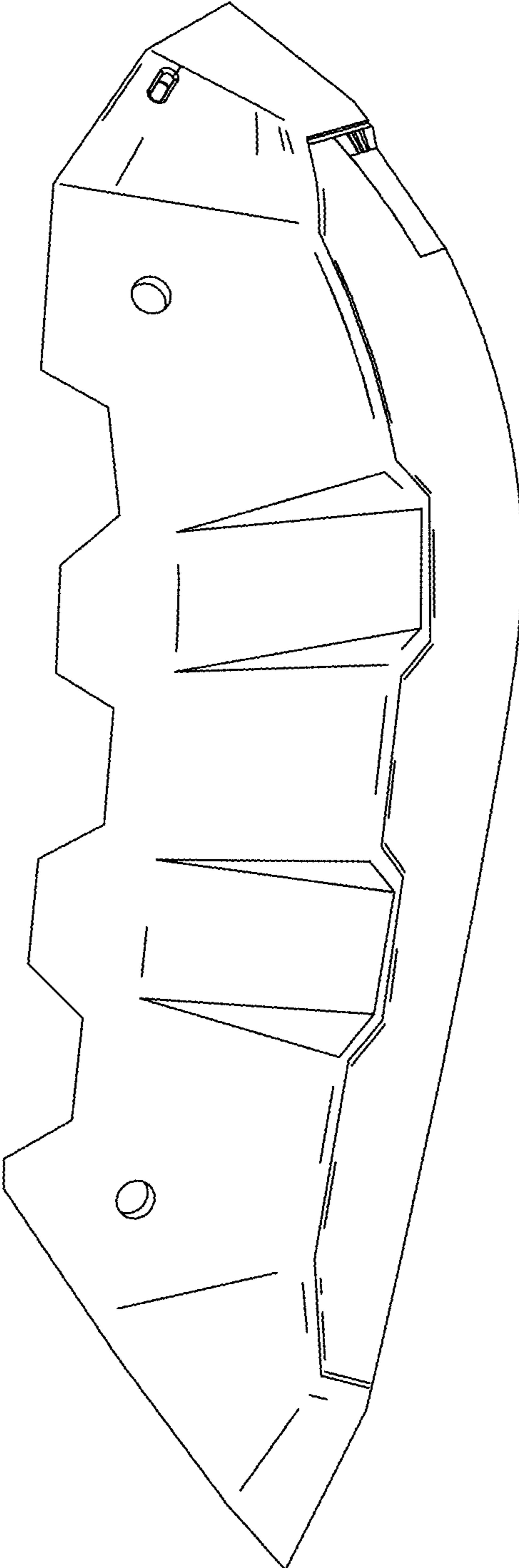

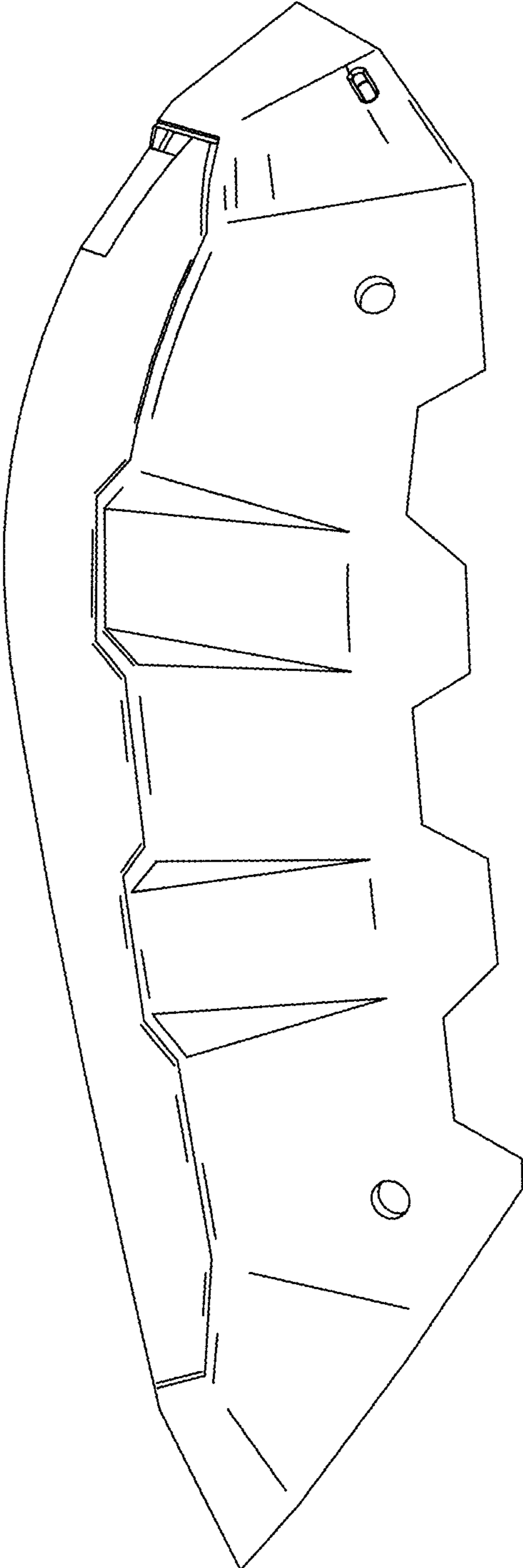

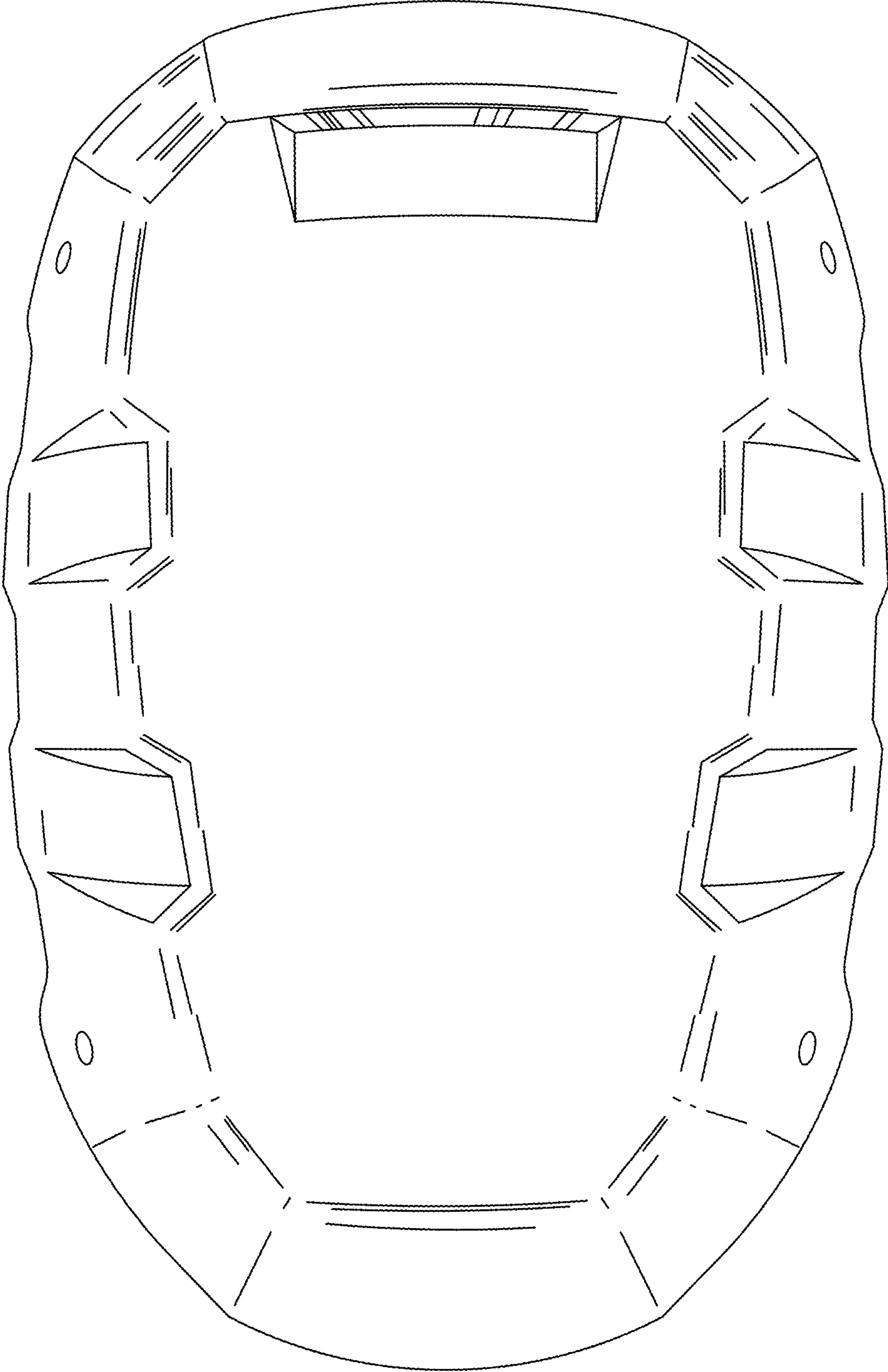

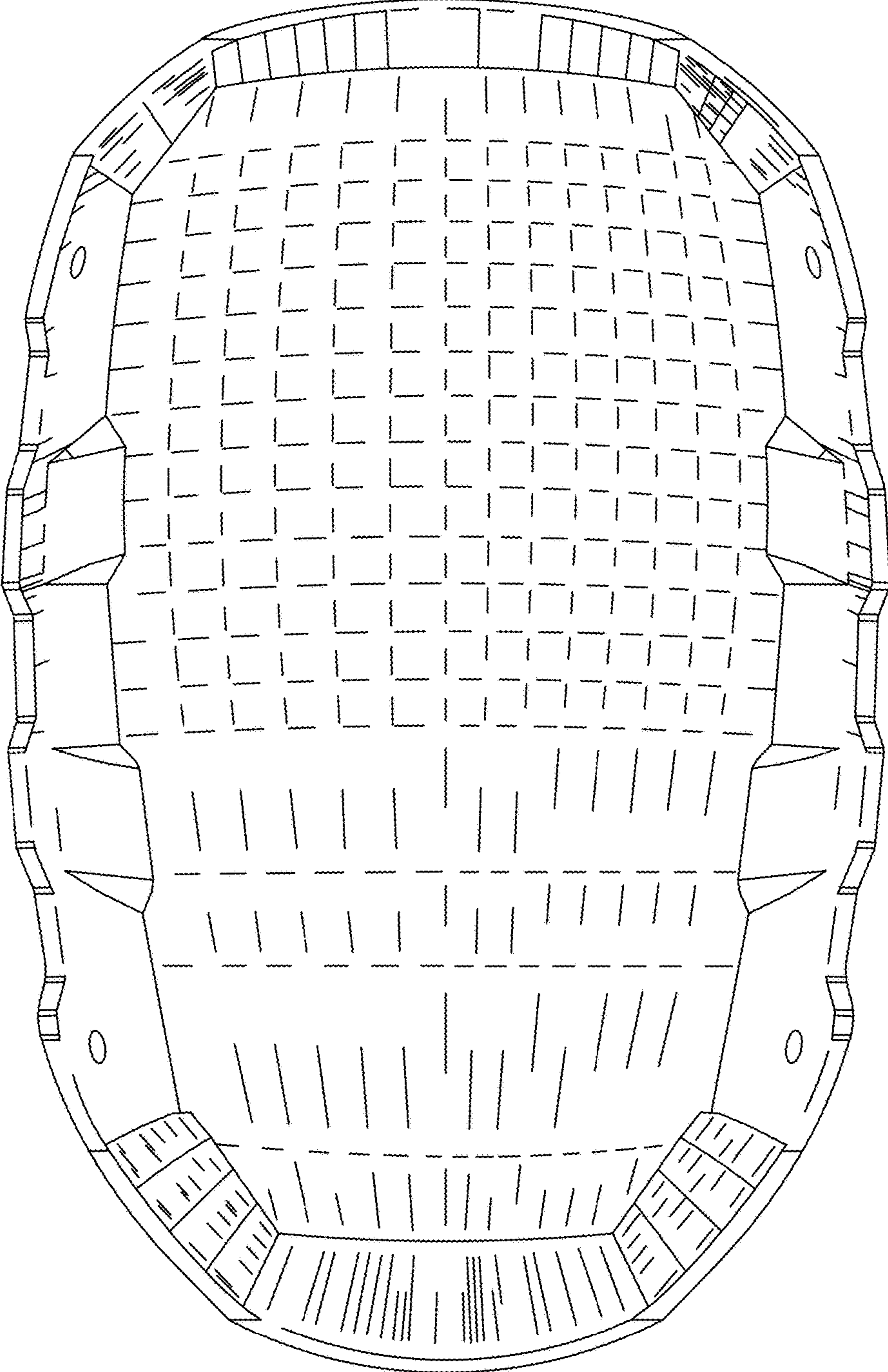

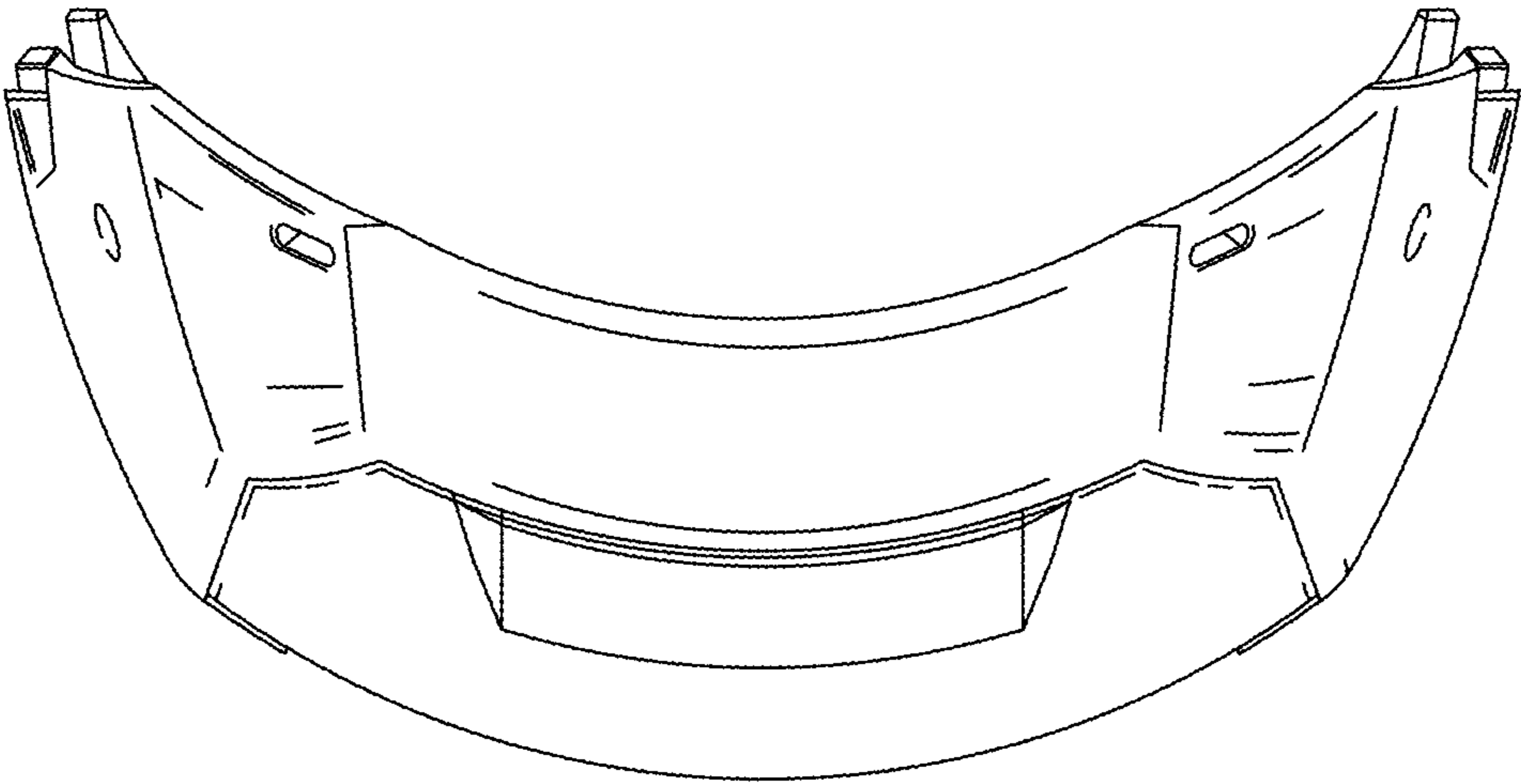

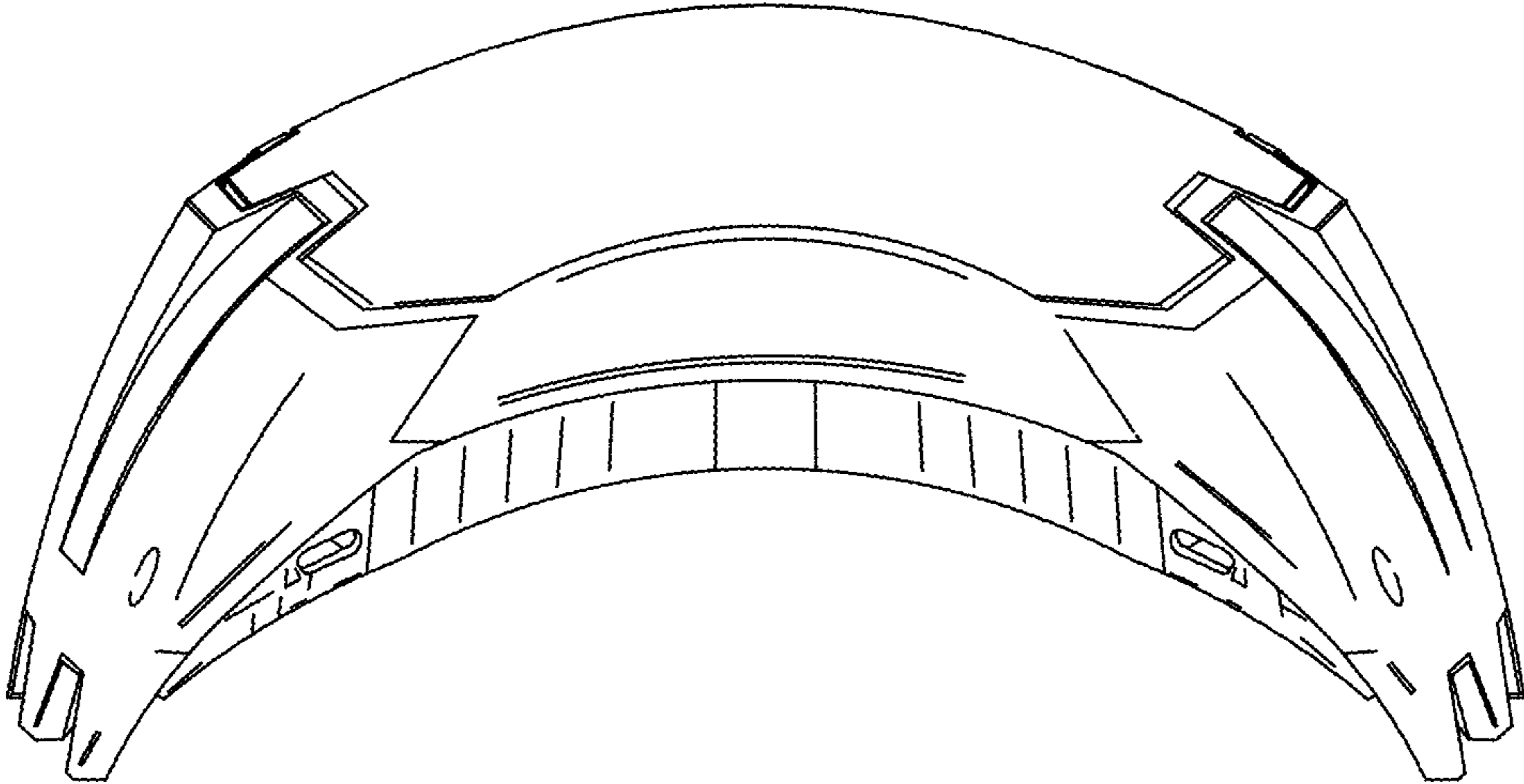

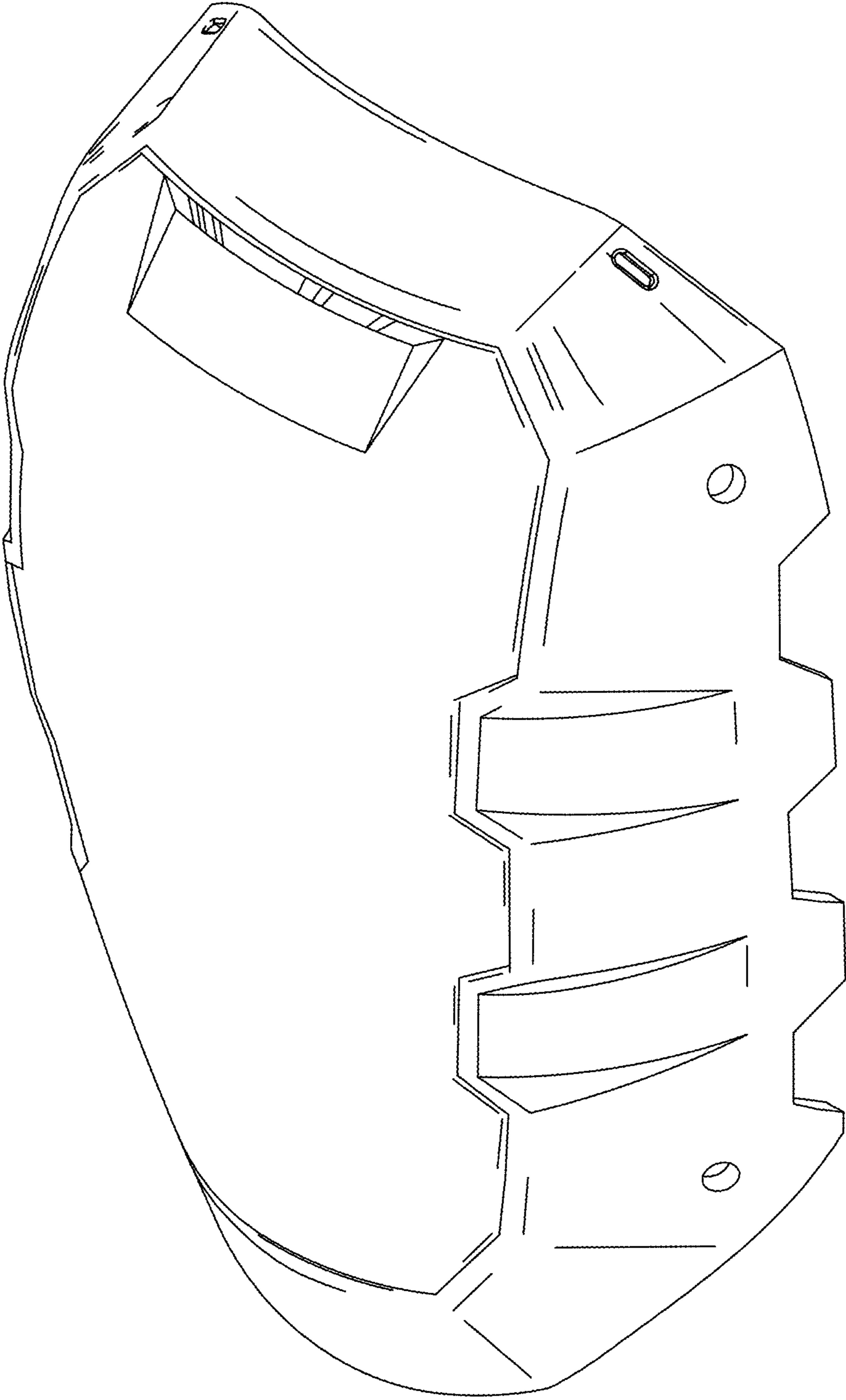
