(57) **CLAIM**

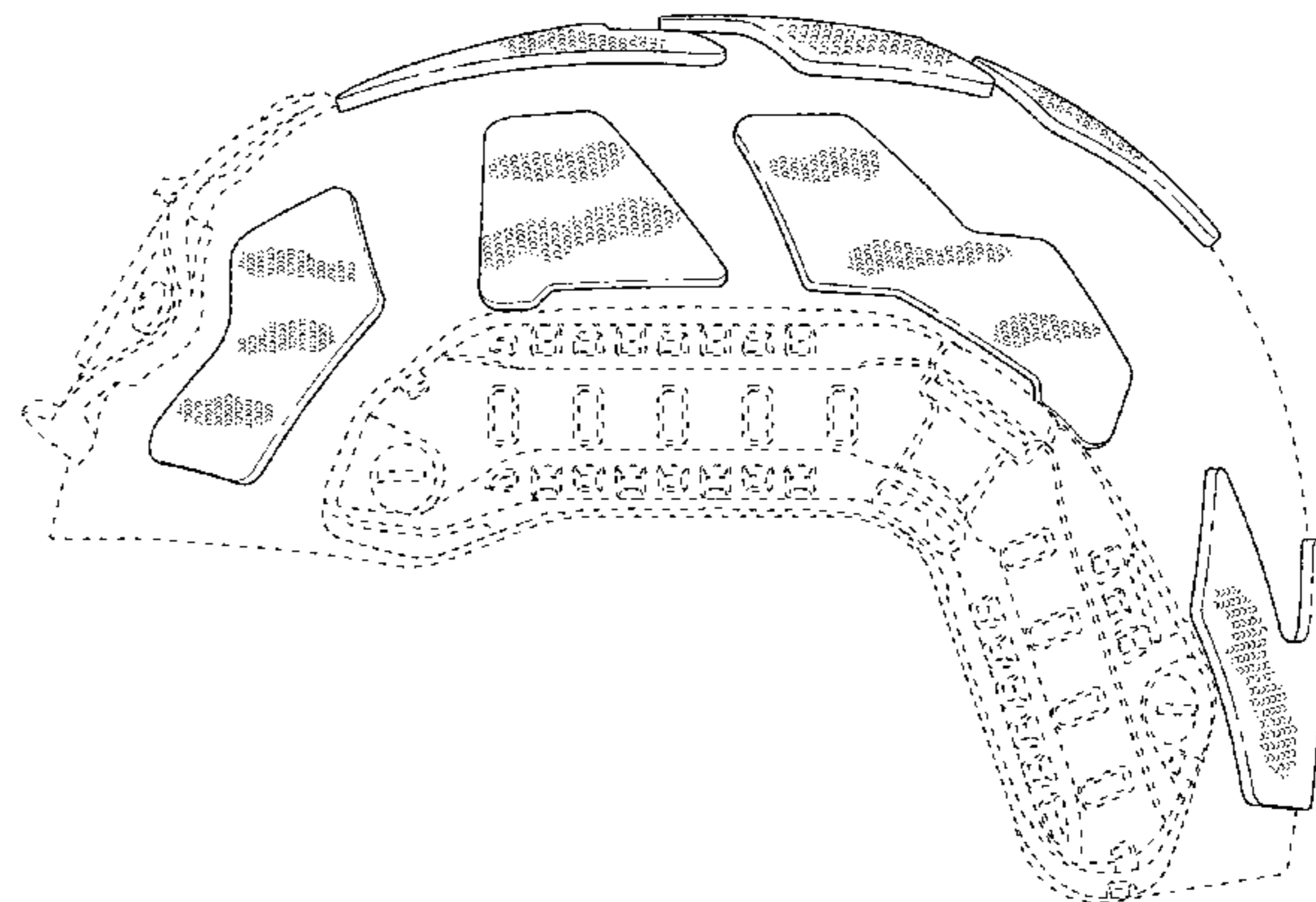
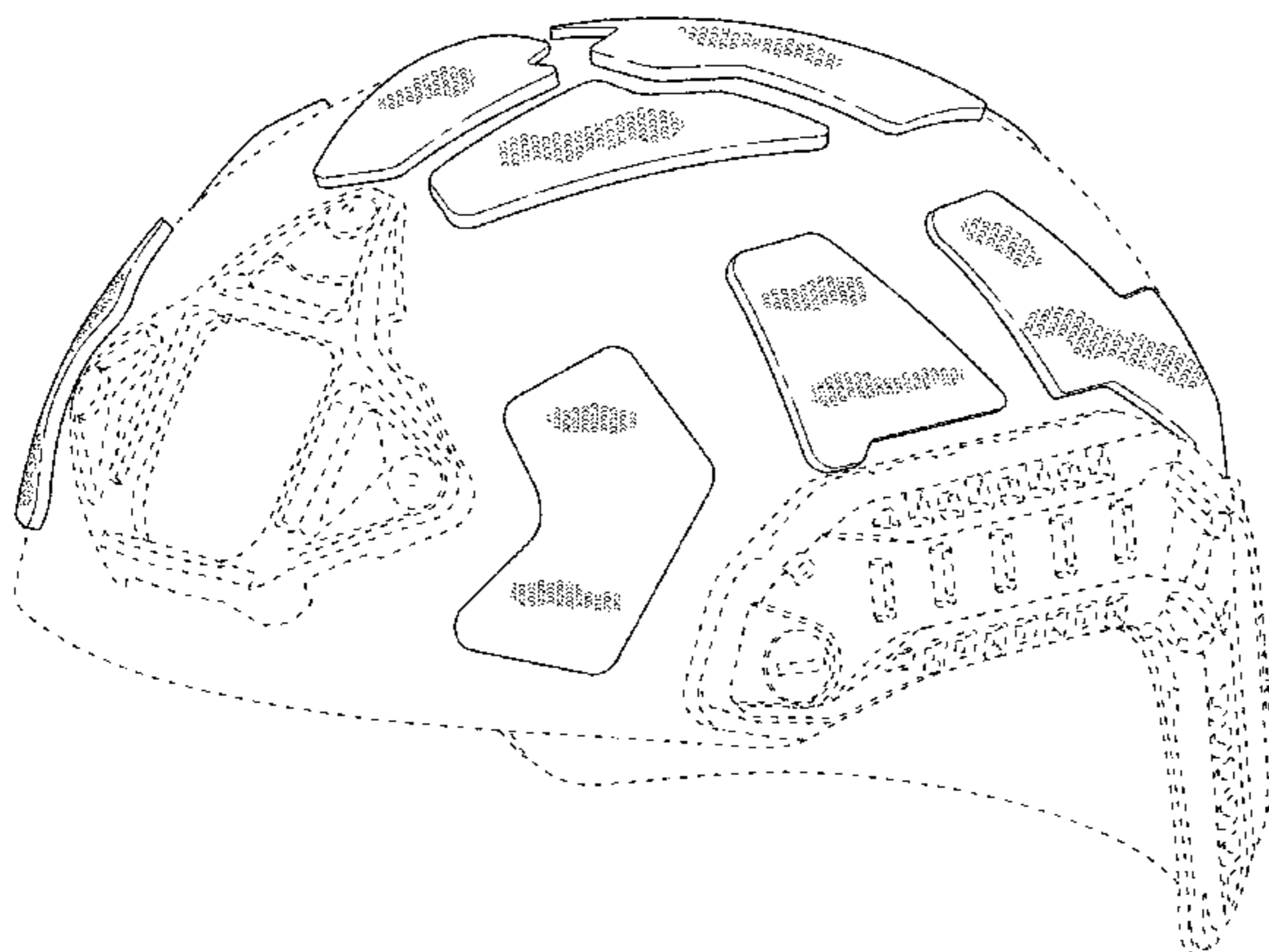
The ornamental design for a hook and loop fastener patch pattern, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a hook and loop fastener patch pattern showing our new design; FIG. 2 is a rear perspective view thereof; FIG. 3 is a front elevational view thereof; FIG. 4 is a rear elevational view thereof; FIG. 5 is a left-side elevational view thereof; FIG. 6 is a right-side elevational view thereof; FIG. 7 is a top plan view thereof; FIG. 8 is a bottom plan view thereof; and, FIG. 9 is an enlarged side view of the hook and loop pattern thereof.

The details shown in broken lines form no part of the claimed design. The loop pattern shown in the drawings is understood to repeat within the claimed areas.

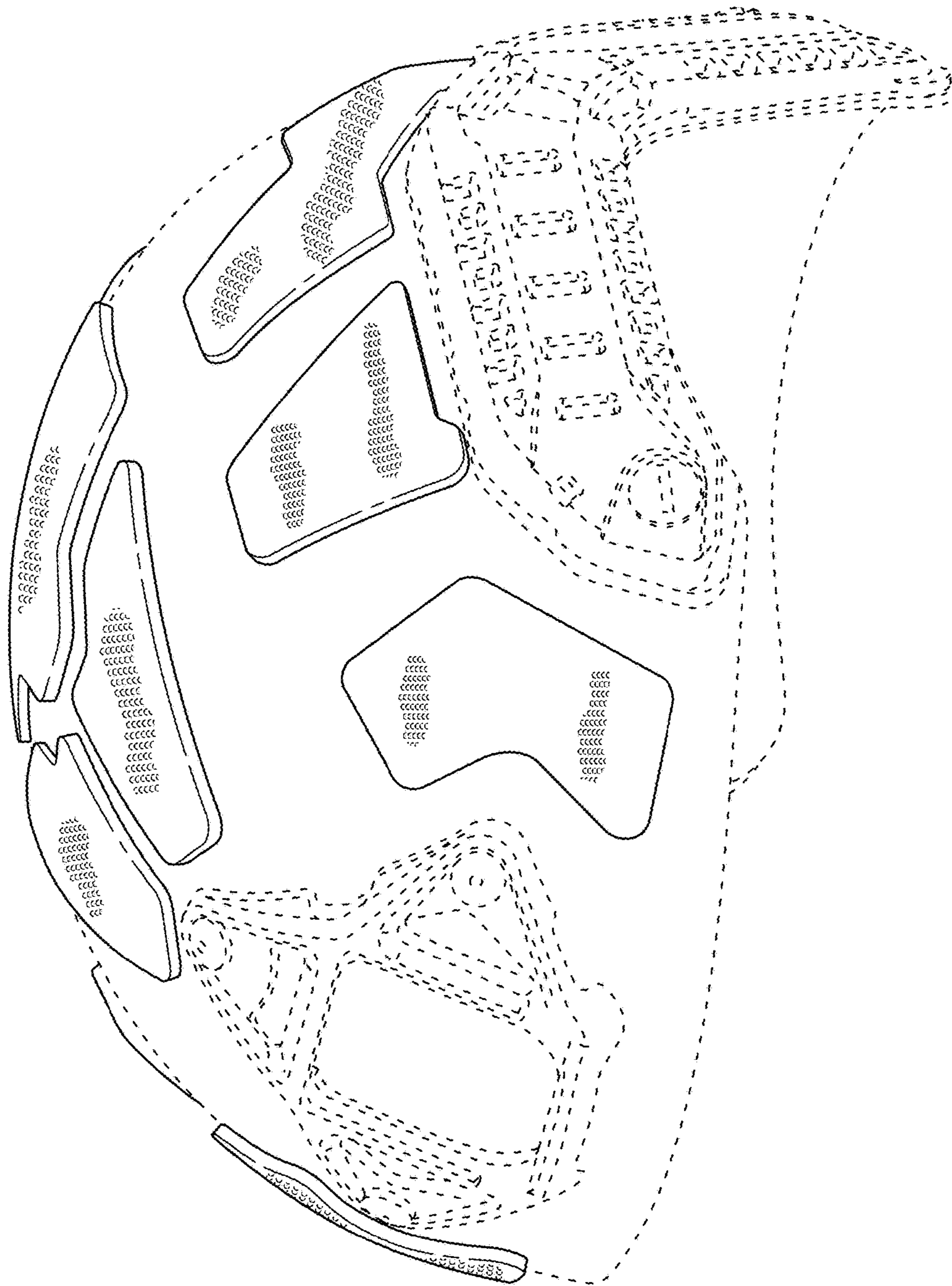

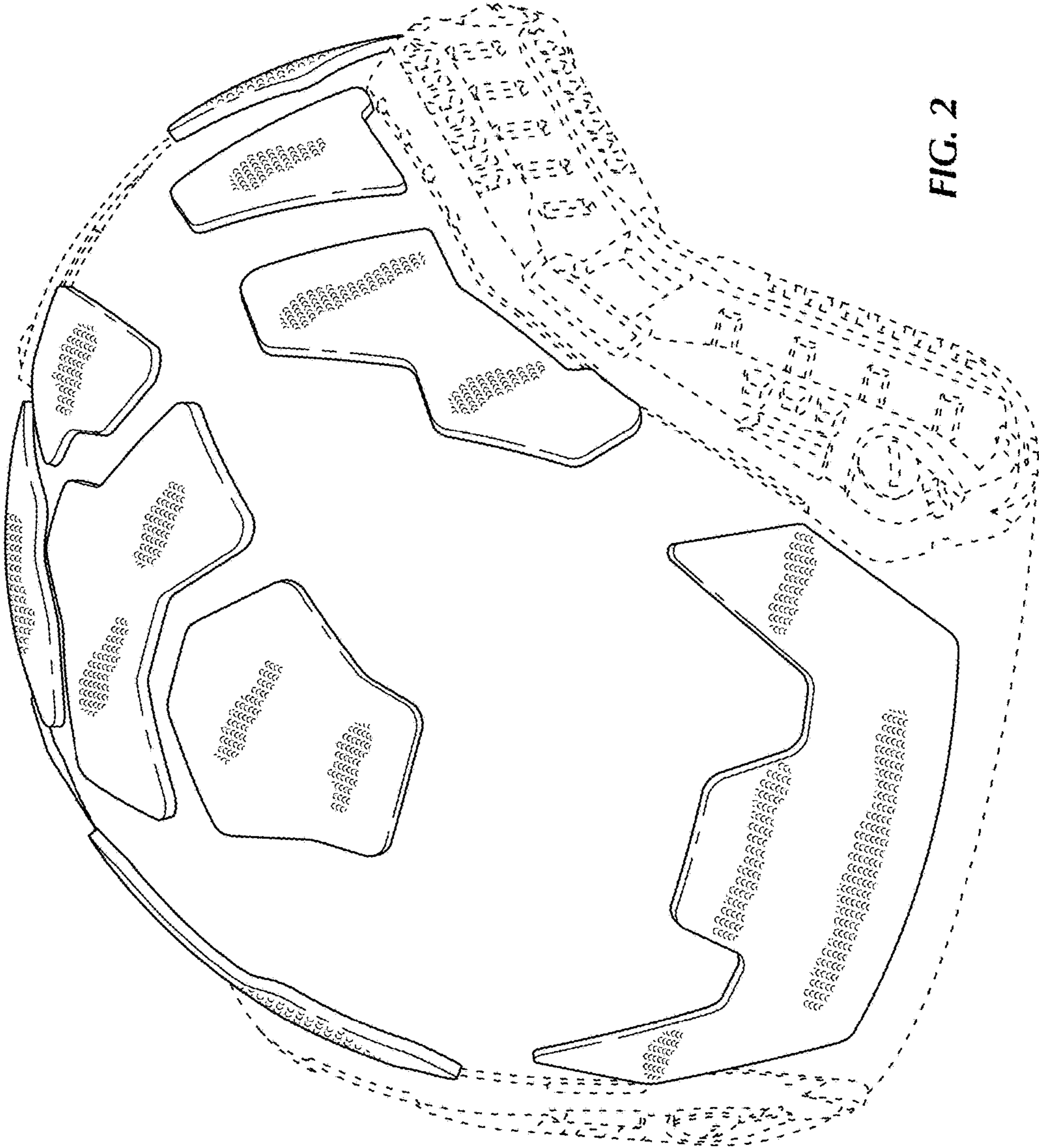

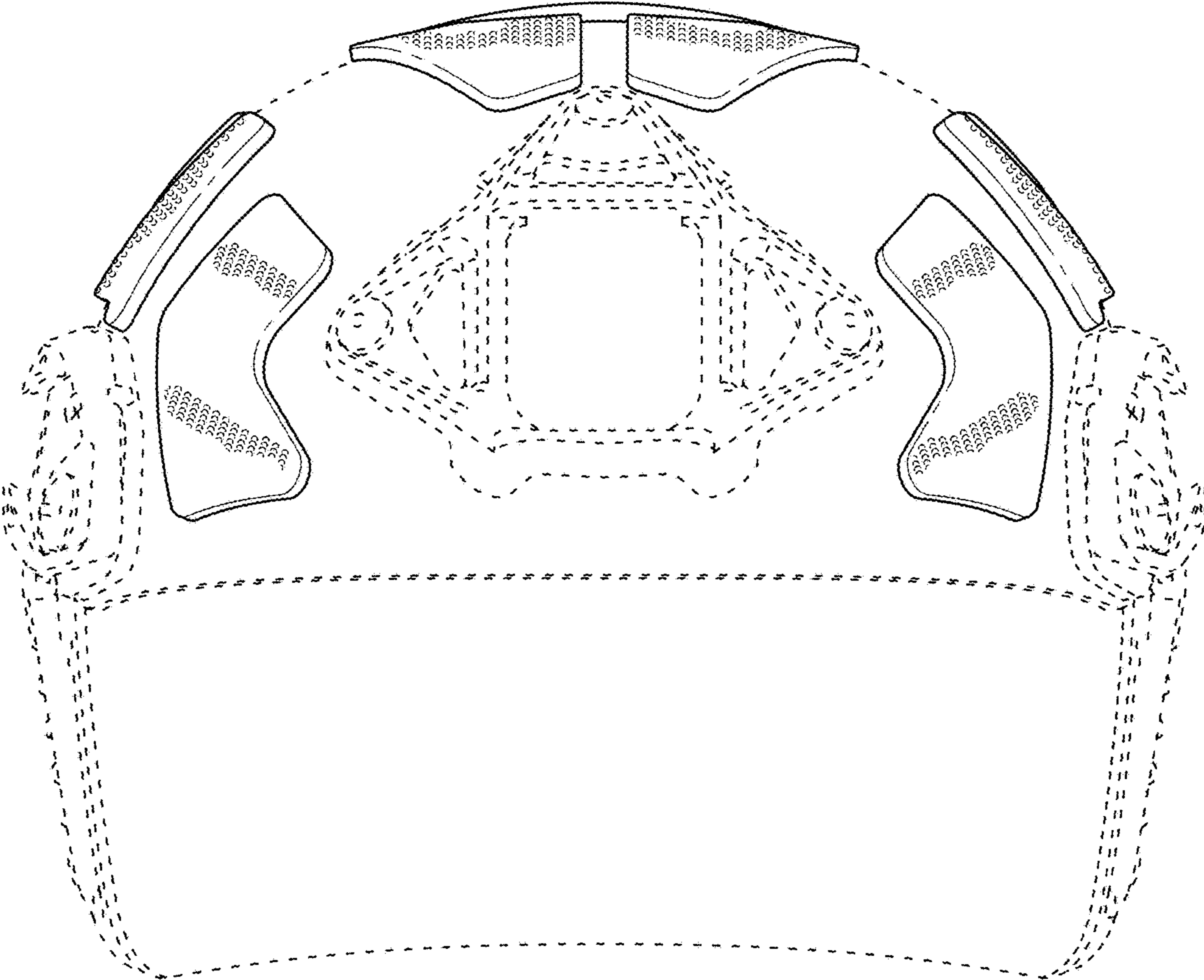

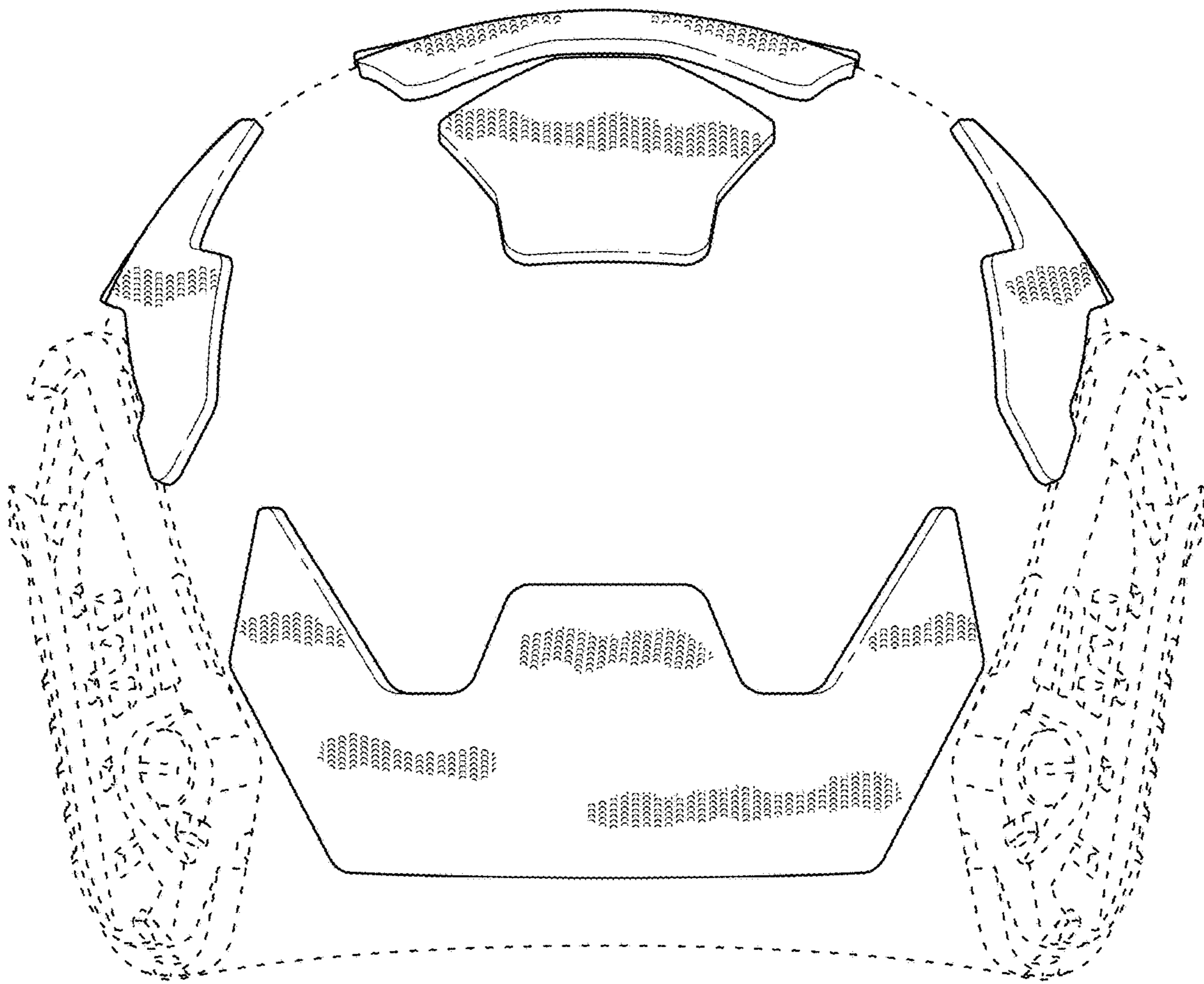

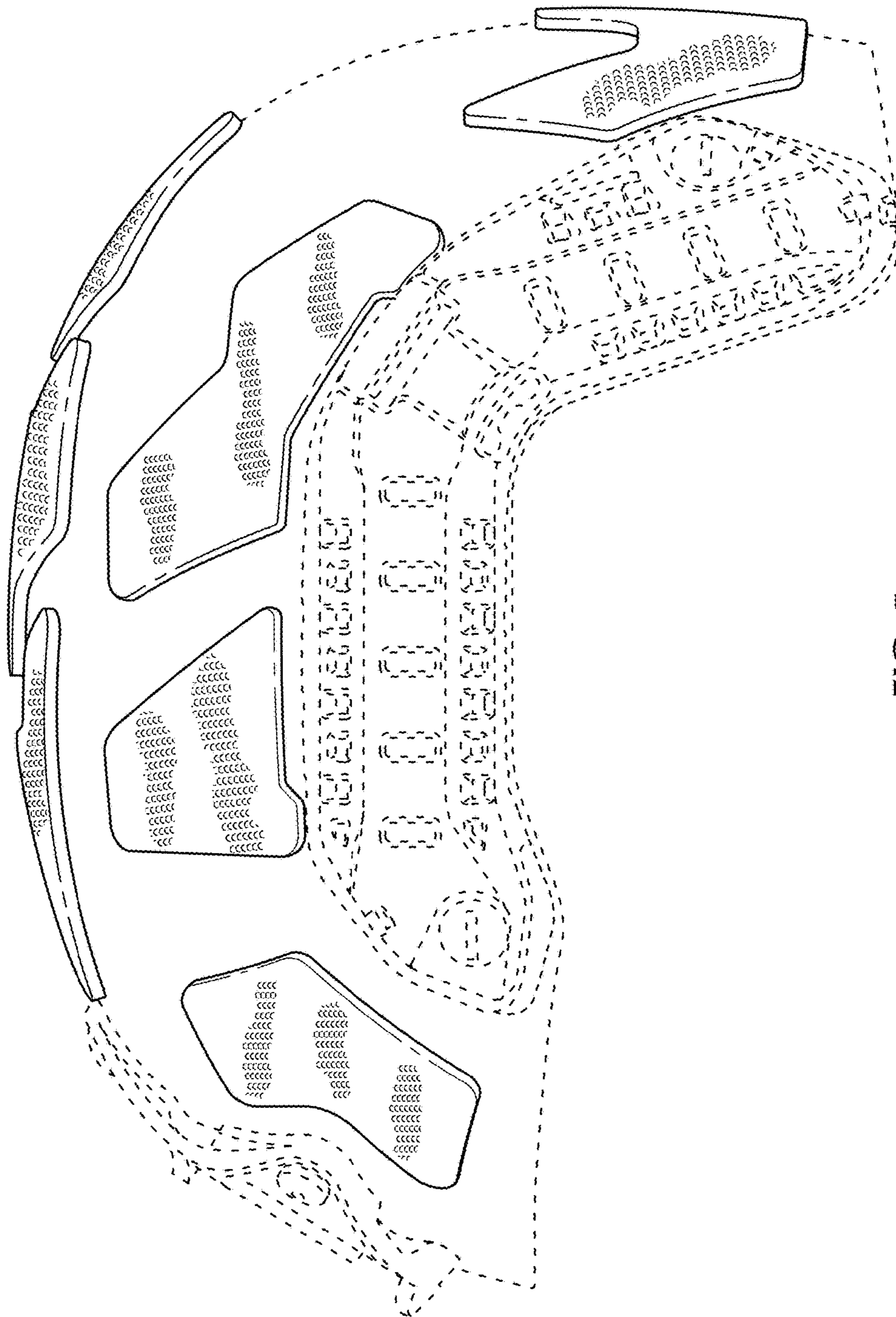

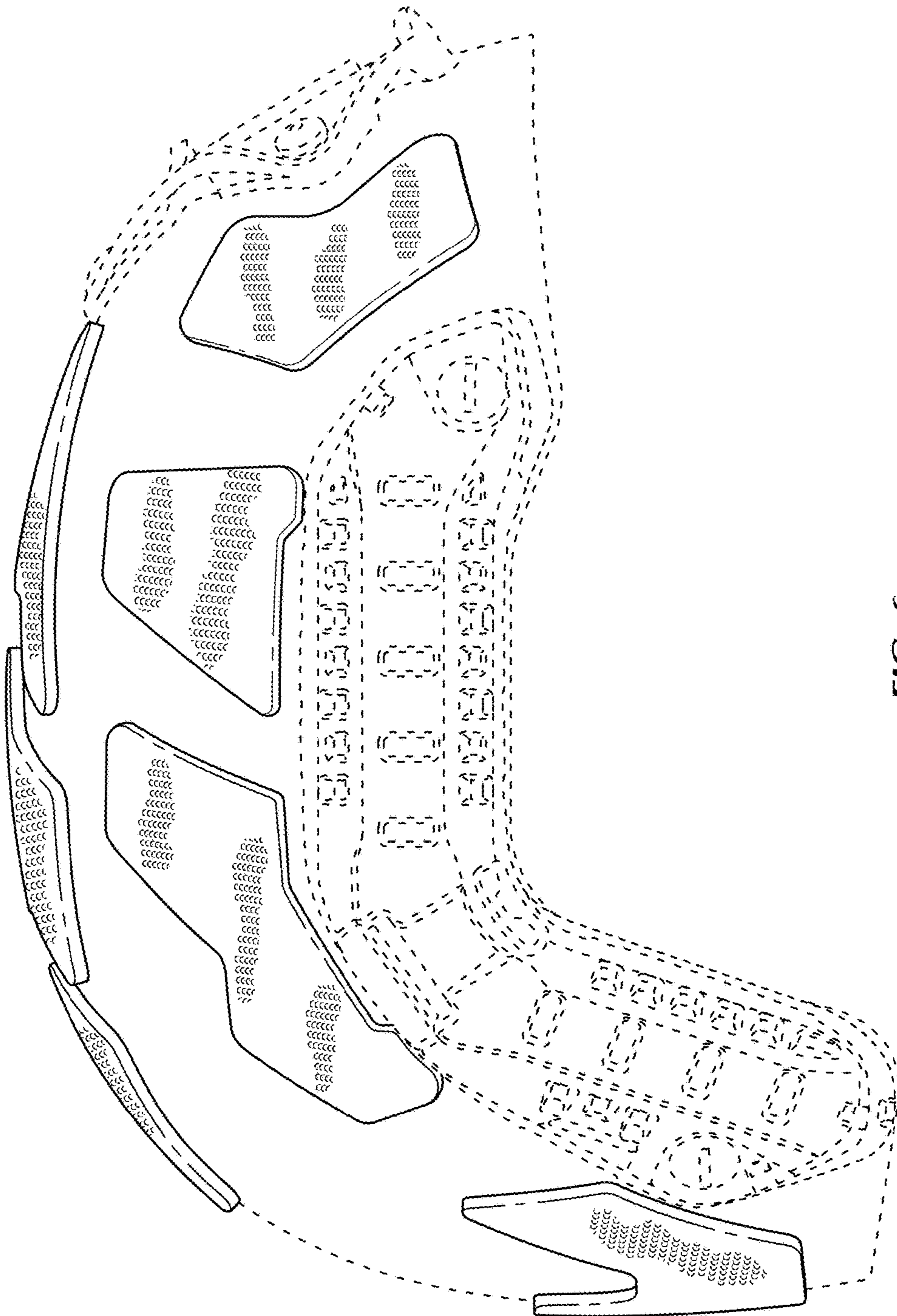

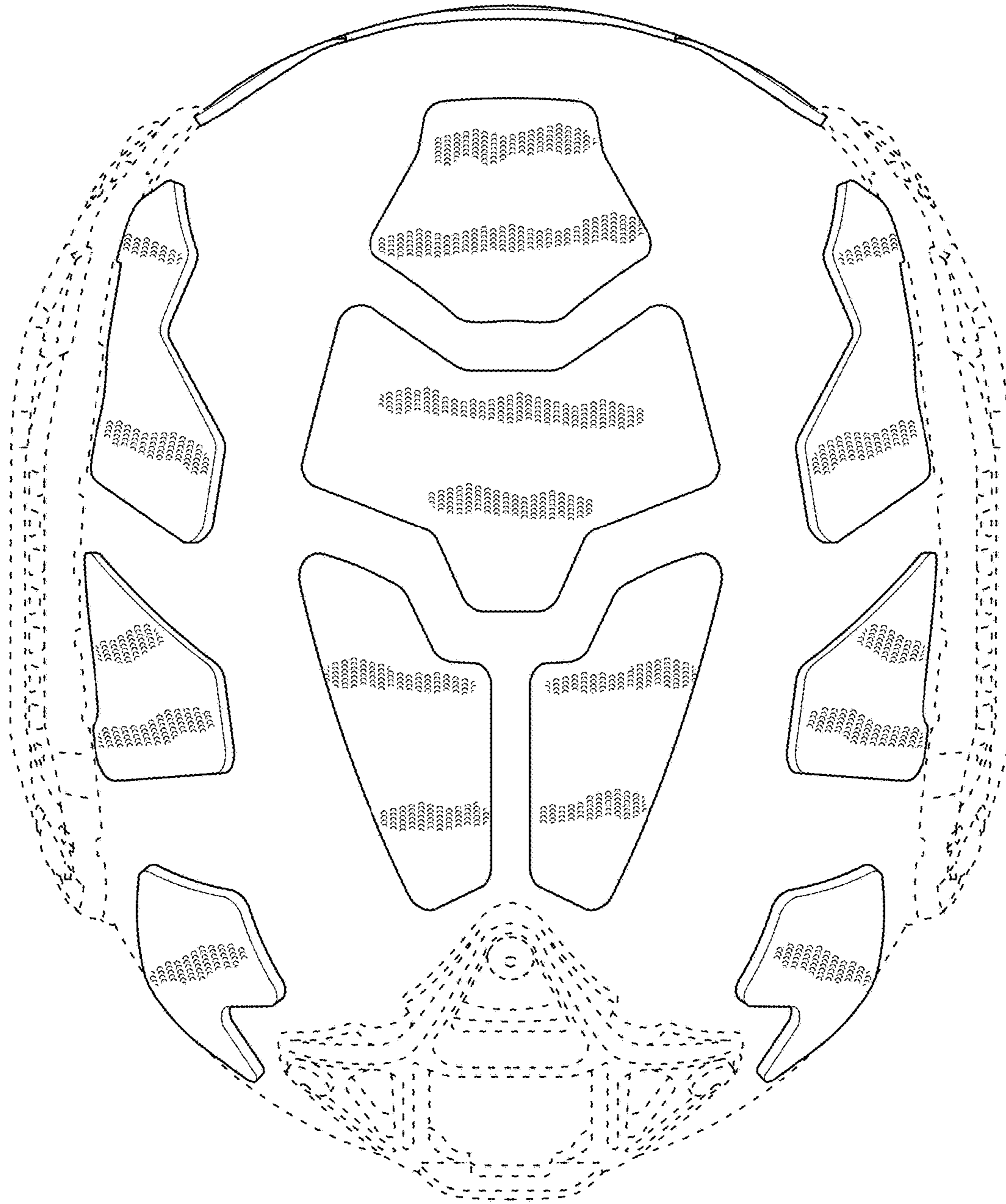

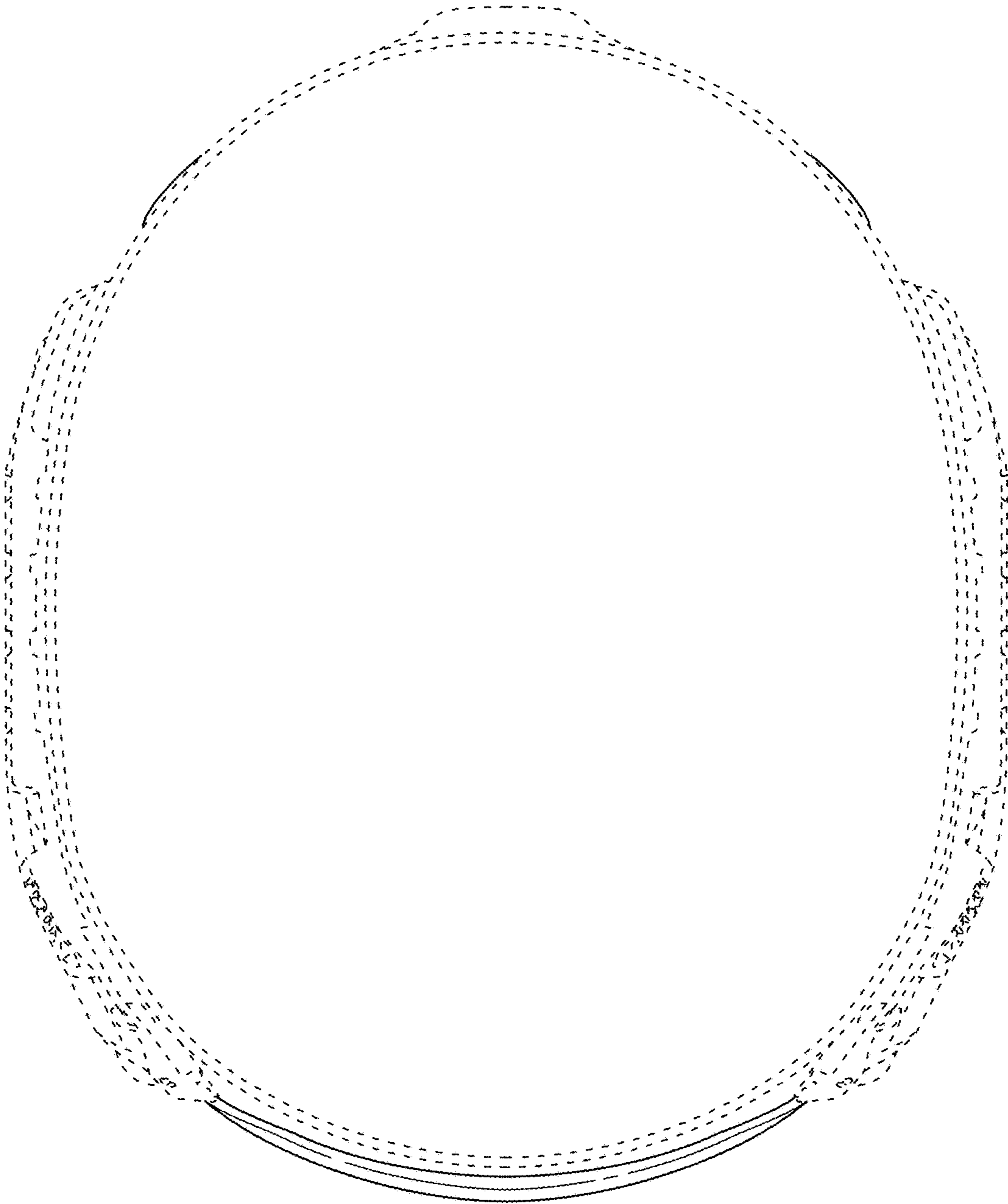
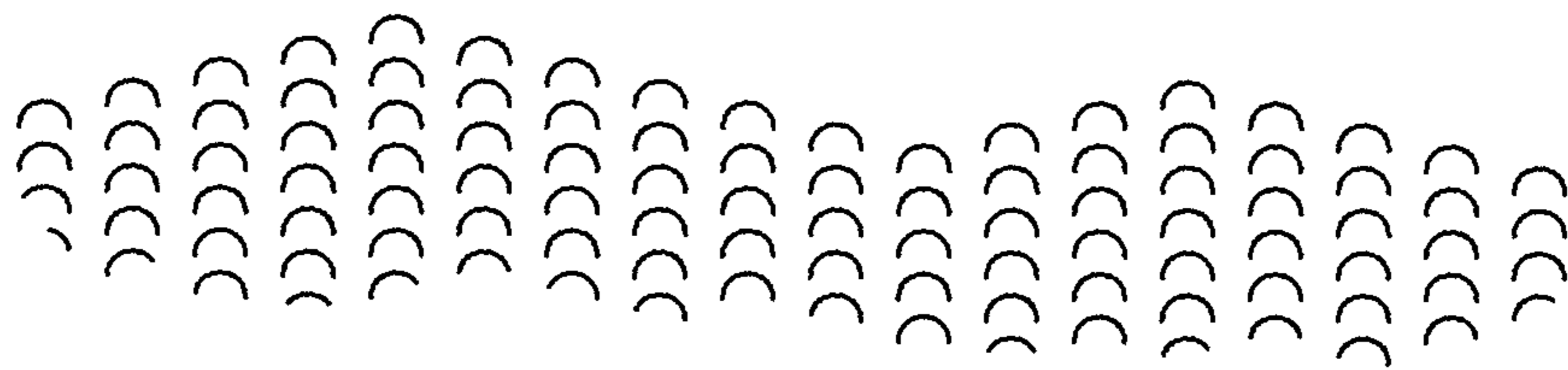
