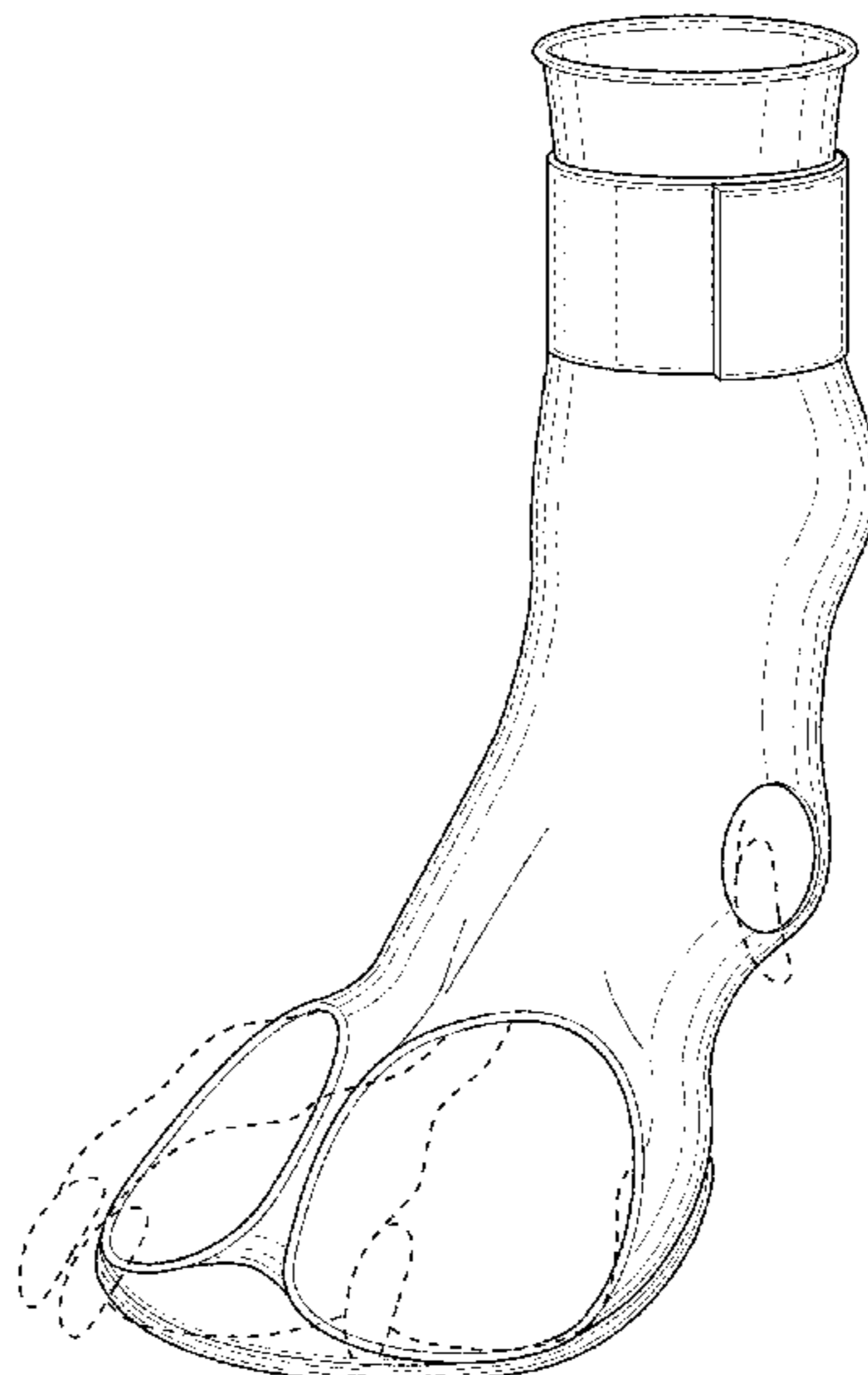
(57) **CLAIM**

The ornamental design for a paw covering, as shown and described.

DESCRIPTION

FIG. 1 is a top front left perspective view of a paw covering, showing our new design in condition of use;
FIG. 2 is a front elevation view of the paw covering of FIG. 1;
FIG. 3 is a back elevation view thereof;
FIG. 4 is a left side elevation view thereof;
FIG. 5 is a right side elevation view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The broken lines showing of a dog’s paw in FIG. 1 depicts environmental subject matter that forms no part of the claimed design.
The drawings are shaded to indicate contrasting surfaces.

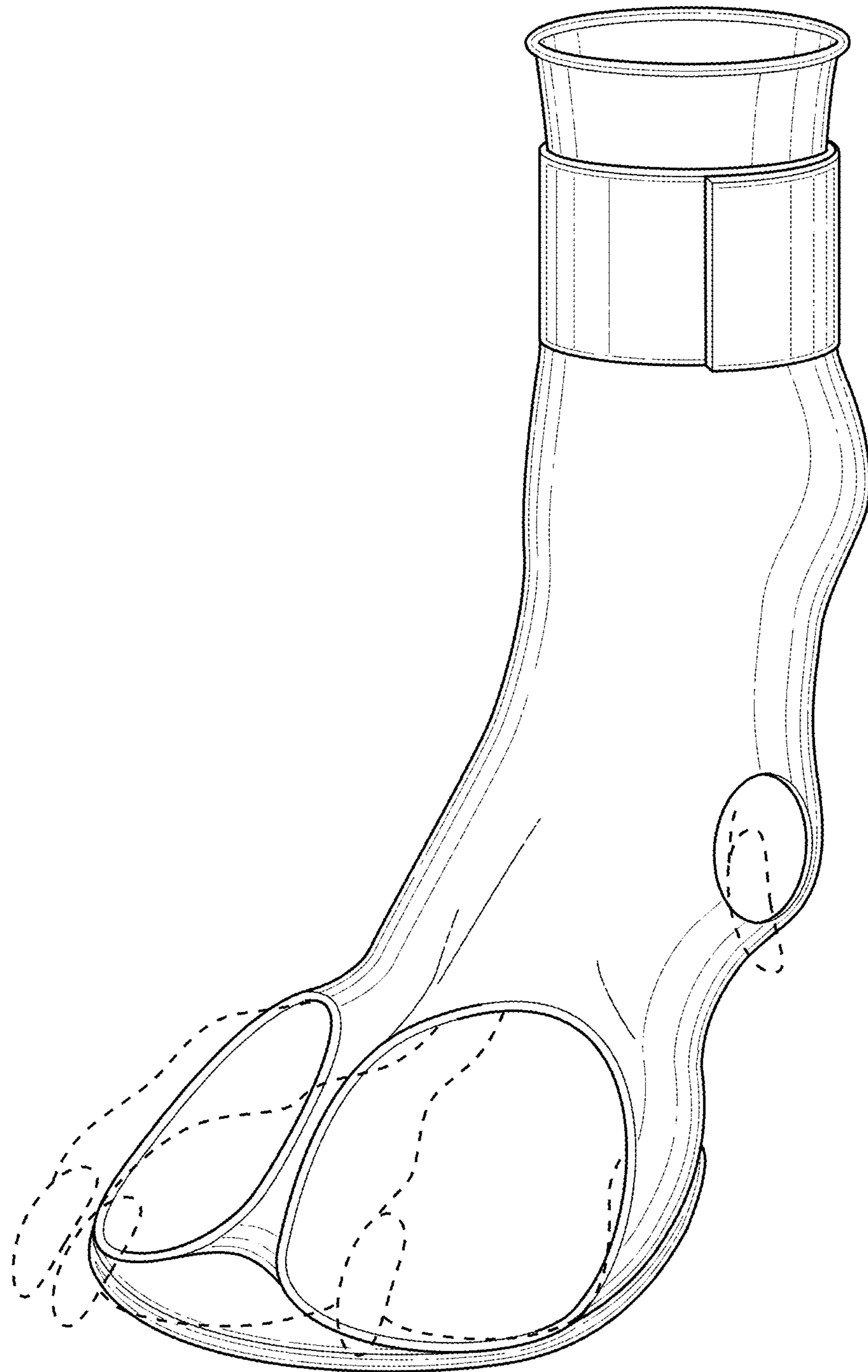

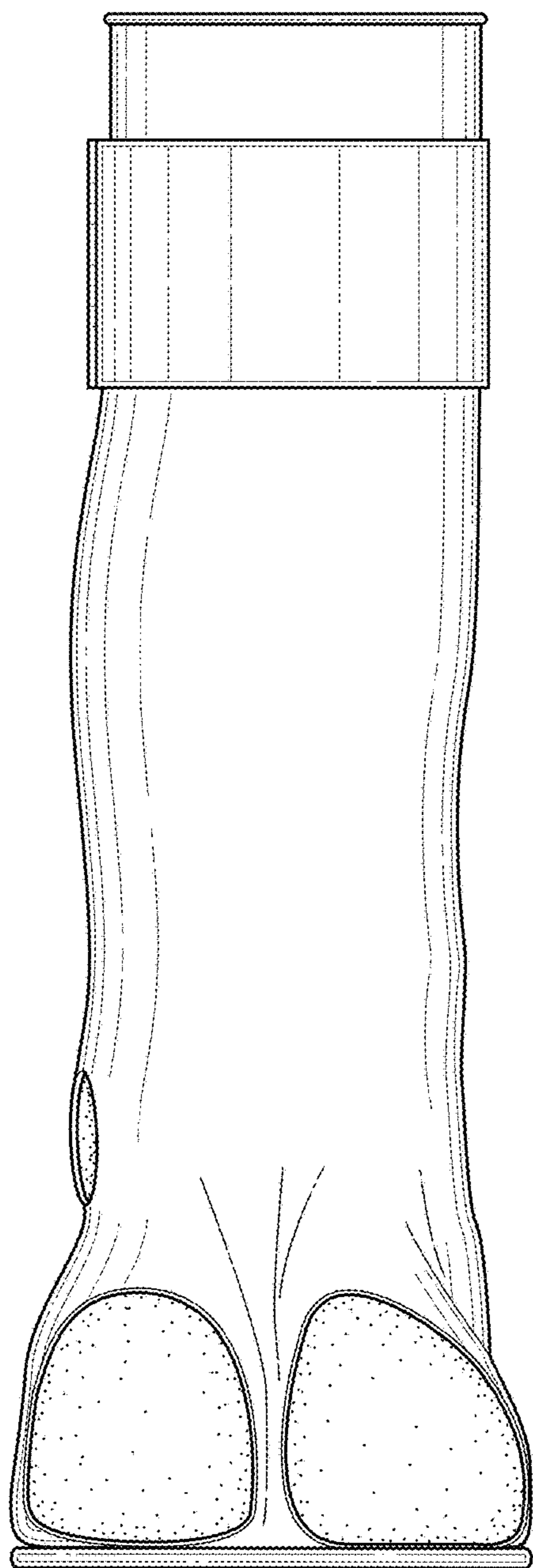

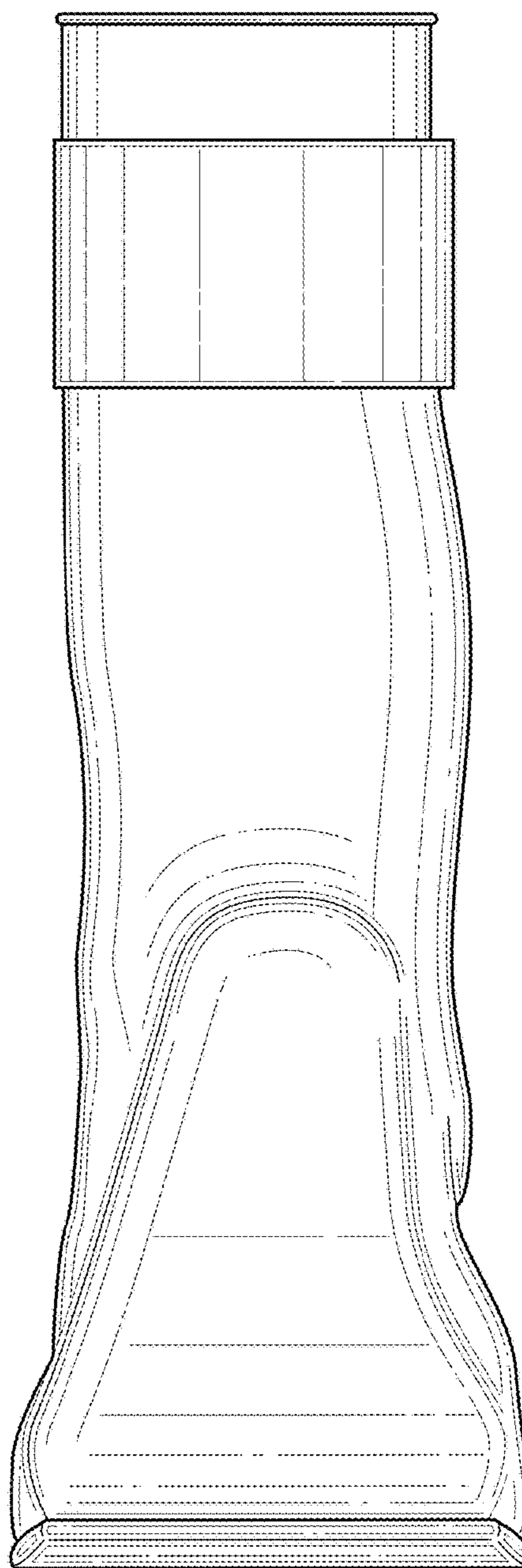

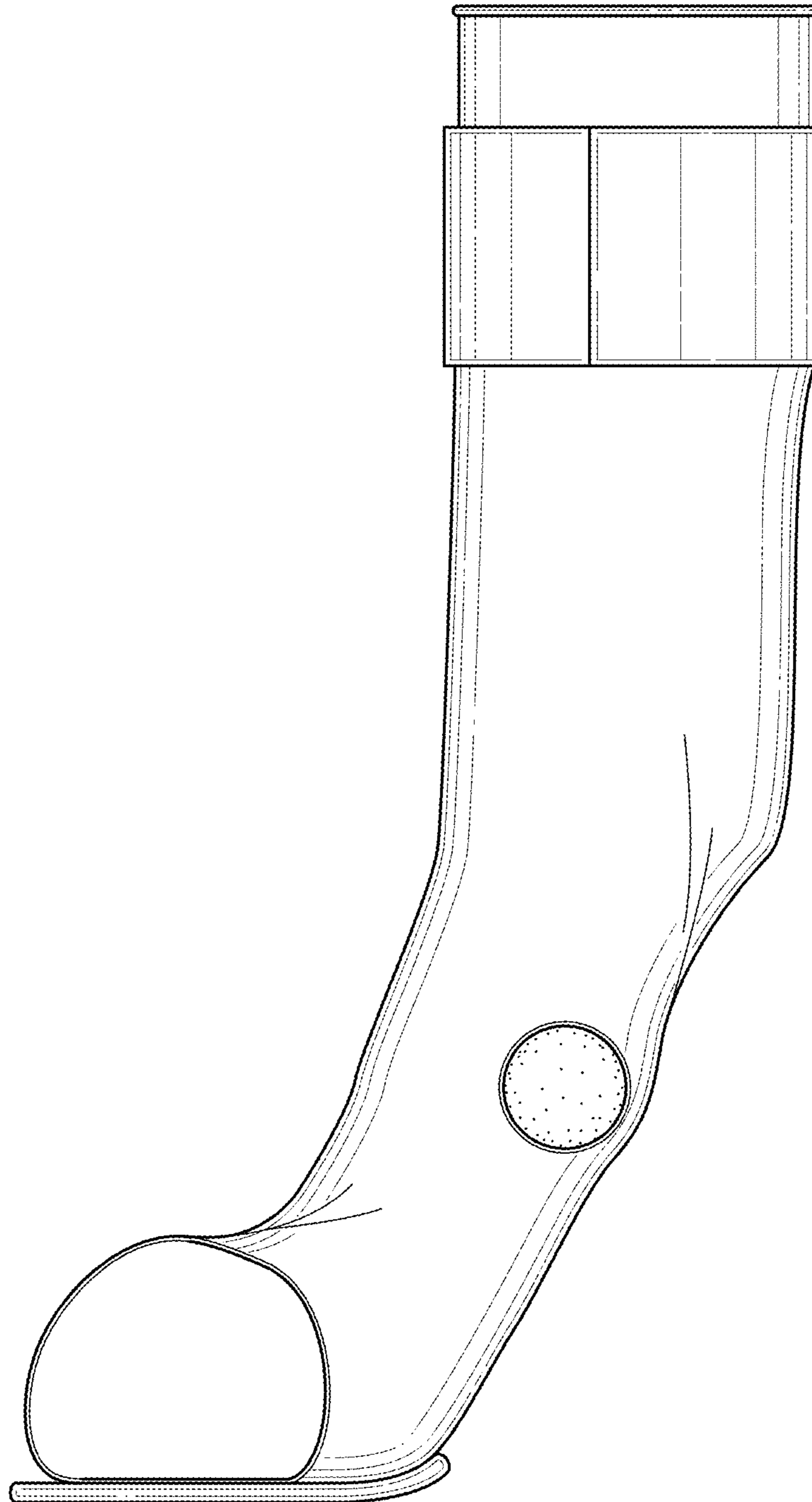

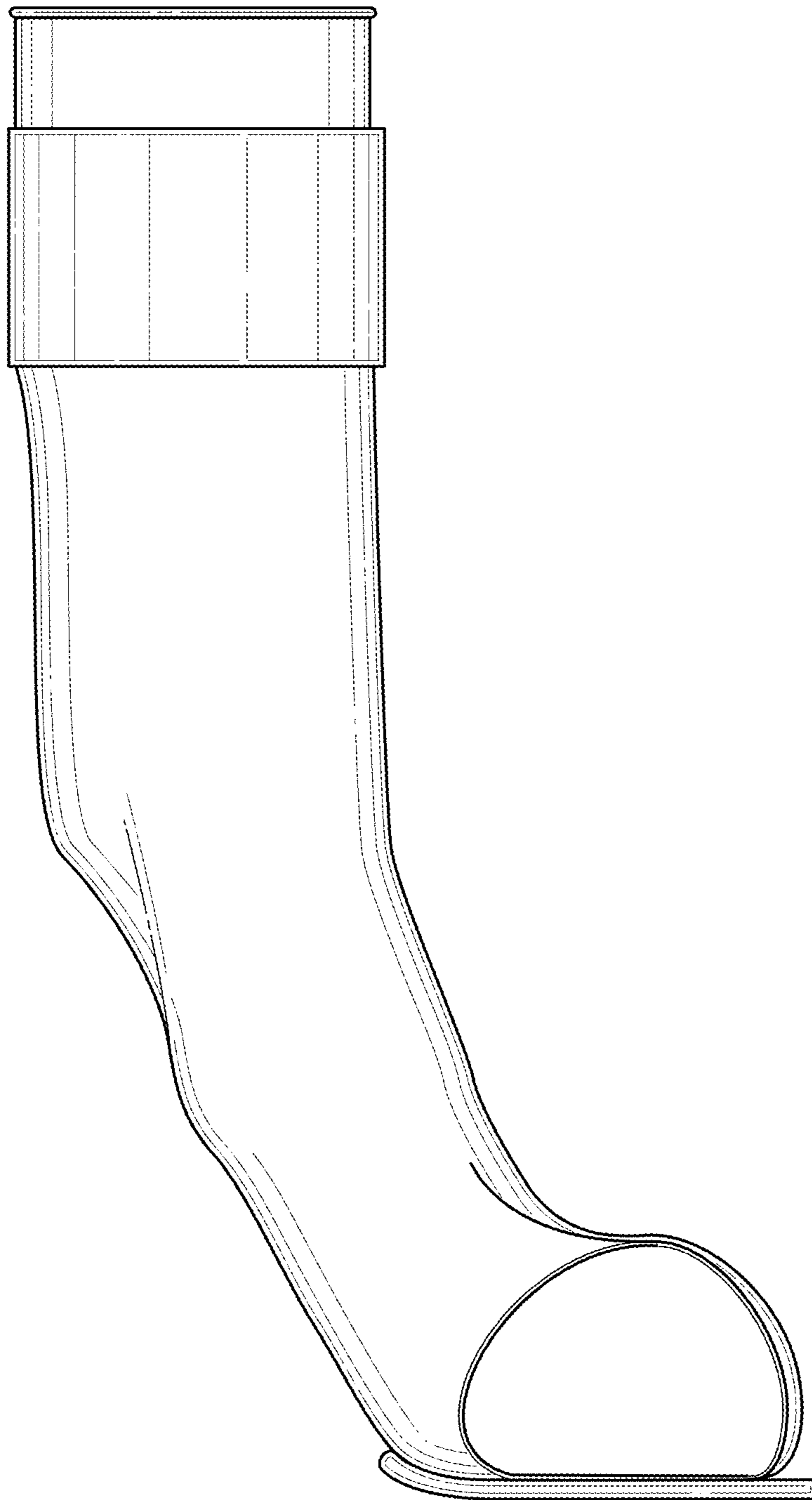

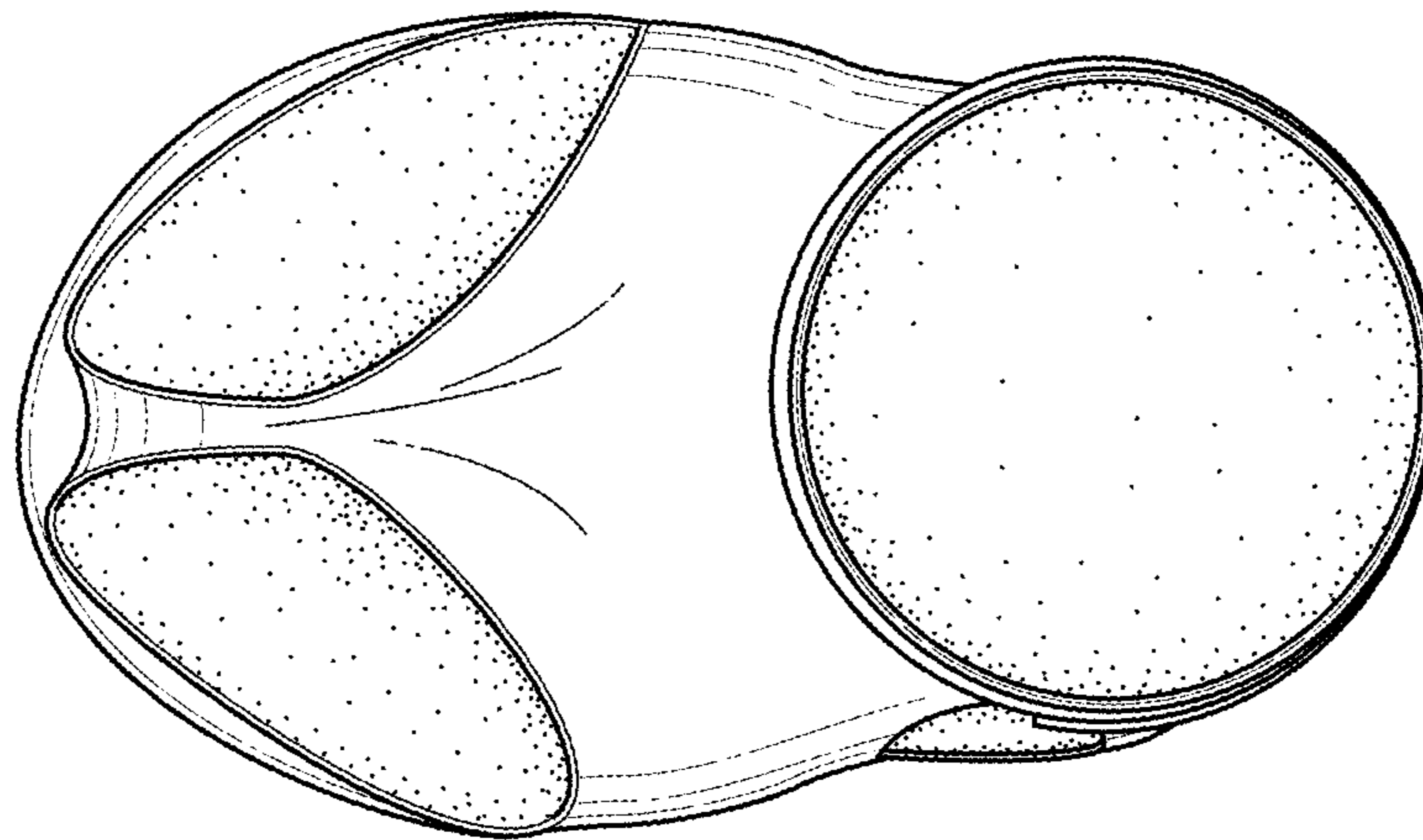

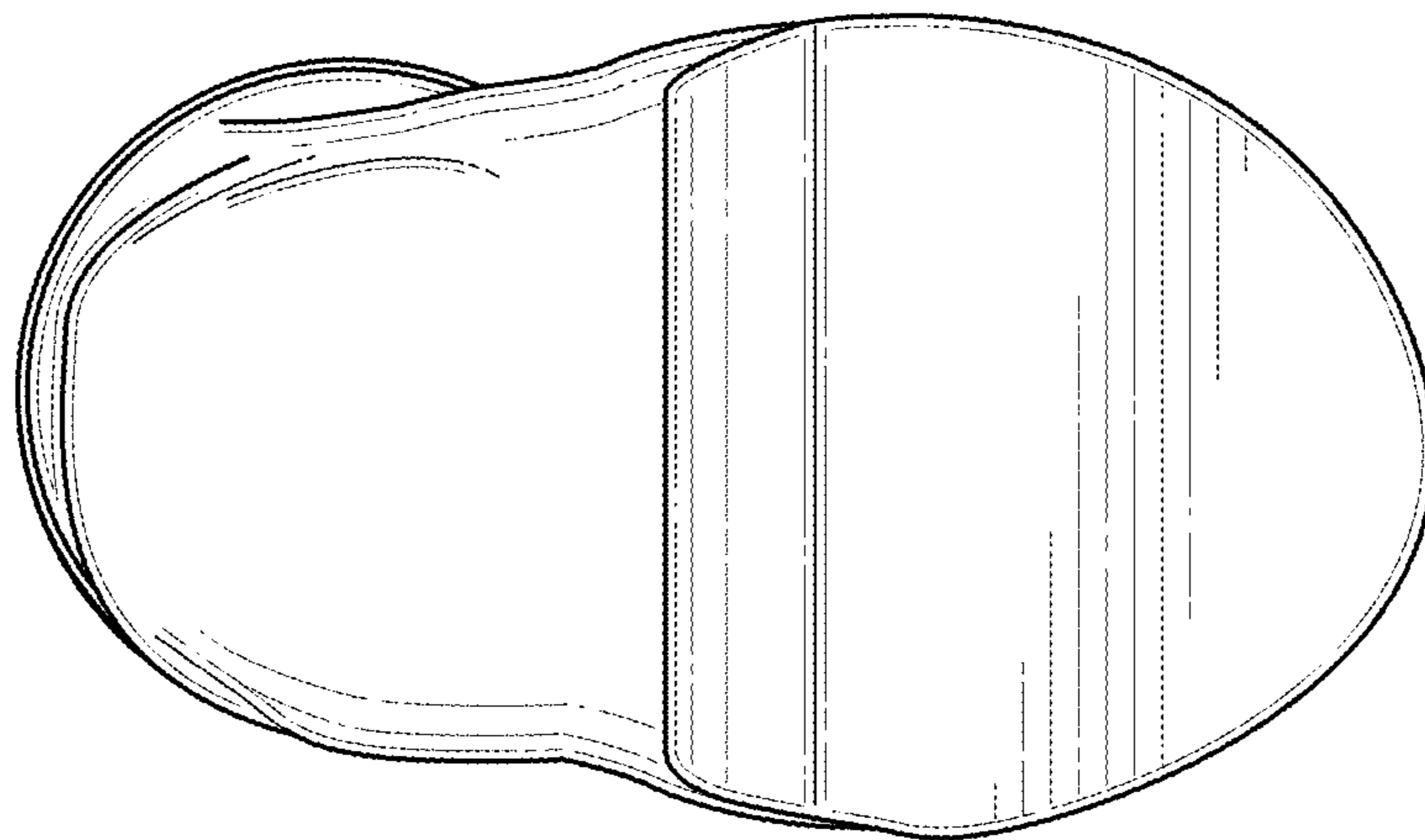
