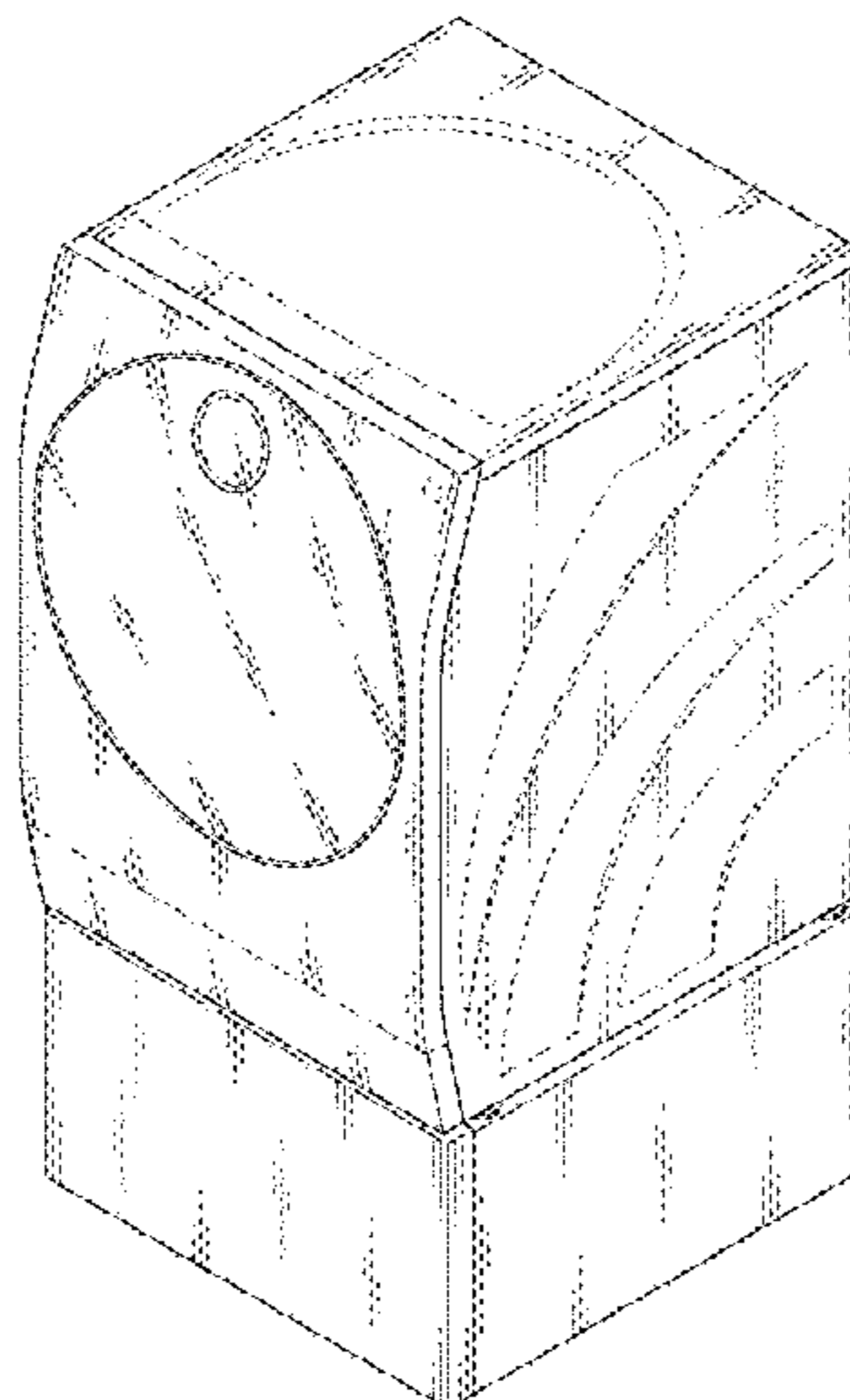
(57) **CLAIM**

The ornamental design for a washing machine, as shown and described.

DESCRIPTION

1. Washing machine
1.1 is a top, front, and right side perspective view of a washing machine showing our new design;
1.2 is a front elevational view thereof;
1.3 is a rear elevational view thereof;
1.4 is a left side elevational view thereof;
1.5 is a right side elevational view thereof;
1.6 is a top plan view thereof;
1.7 is a bottom plan view thereof; and
1.8 is a top, front, and right side perspective view thereof with the door of the pedestal unit pulled out.
The broken lines in the reproductions illustrate portions of the washing machine that form no part of the claimed design.

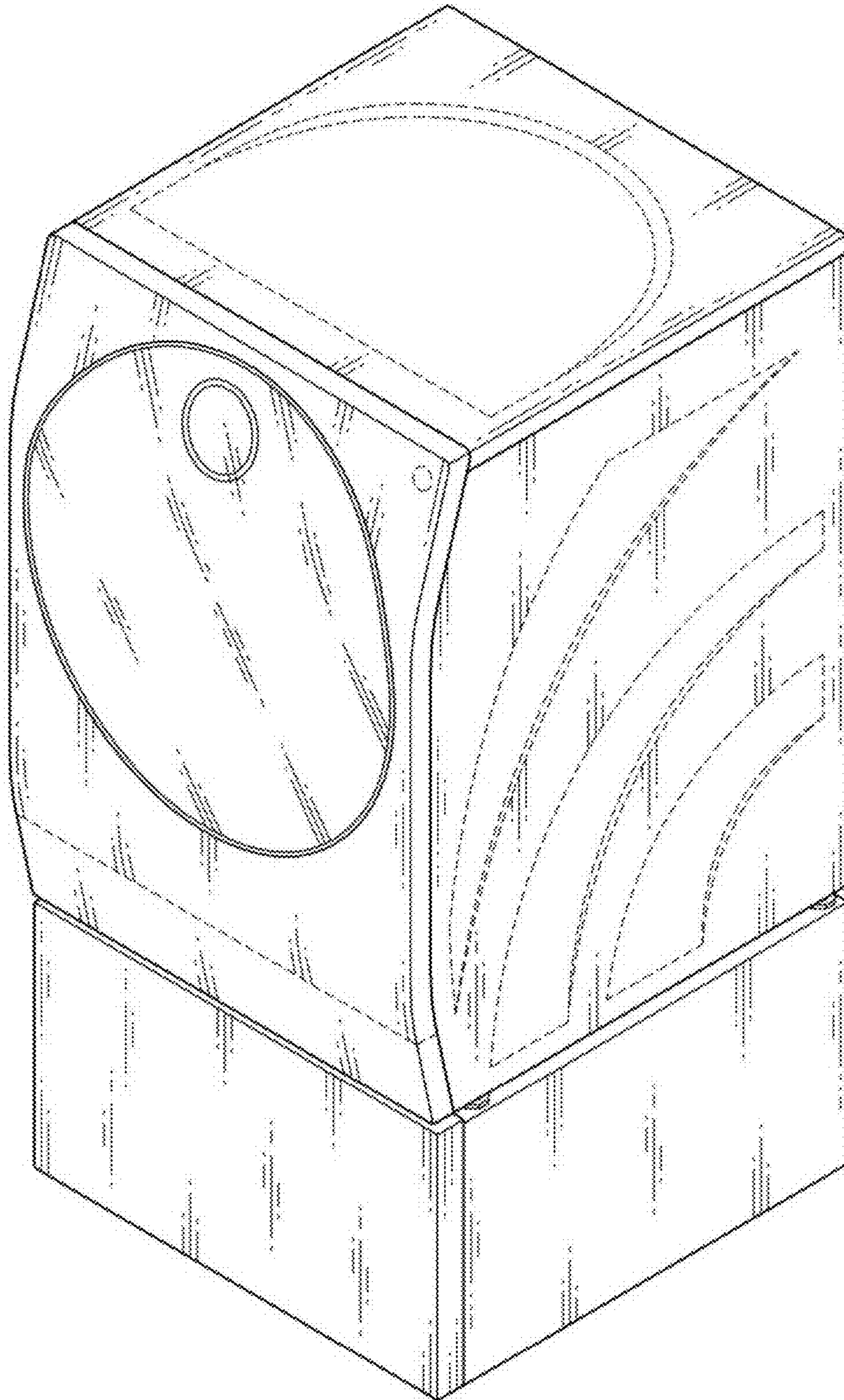

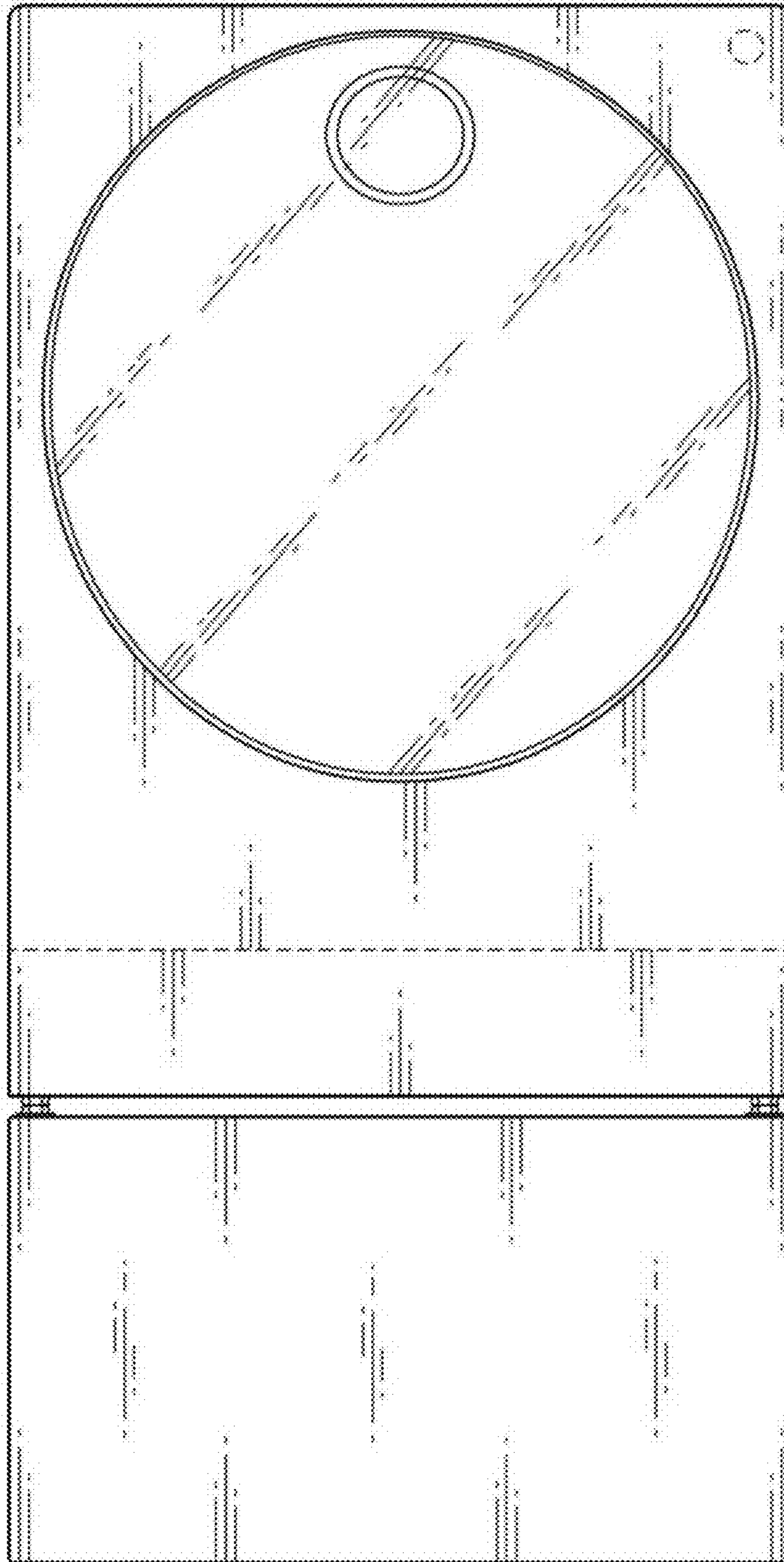

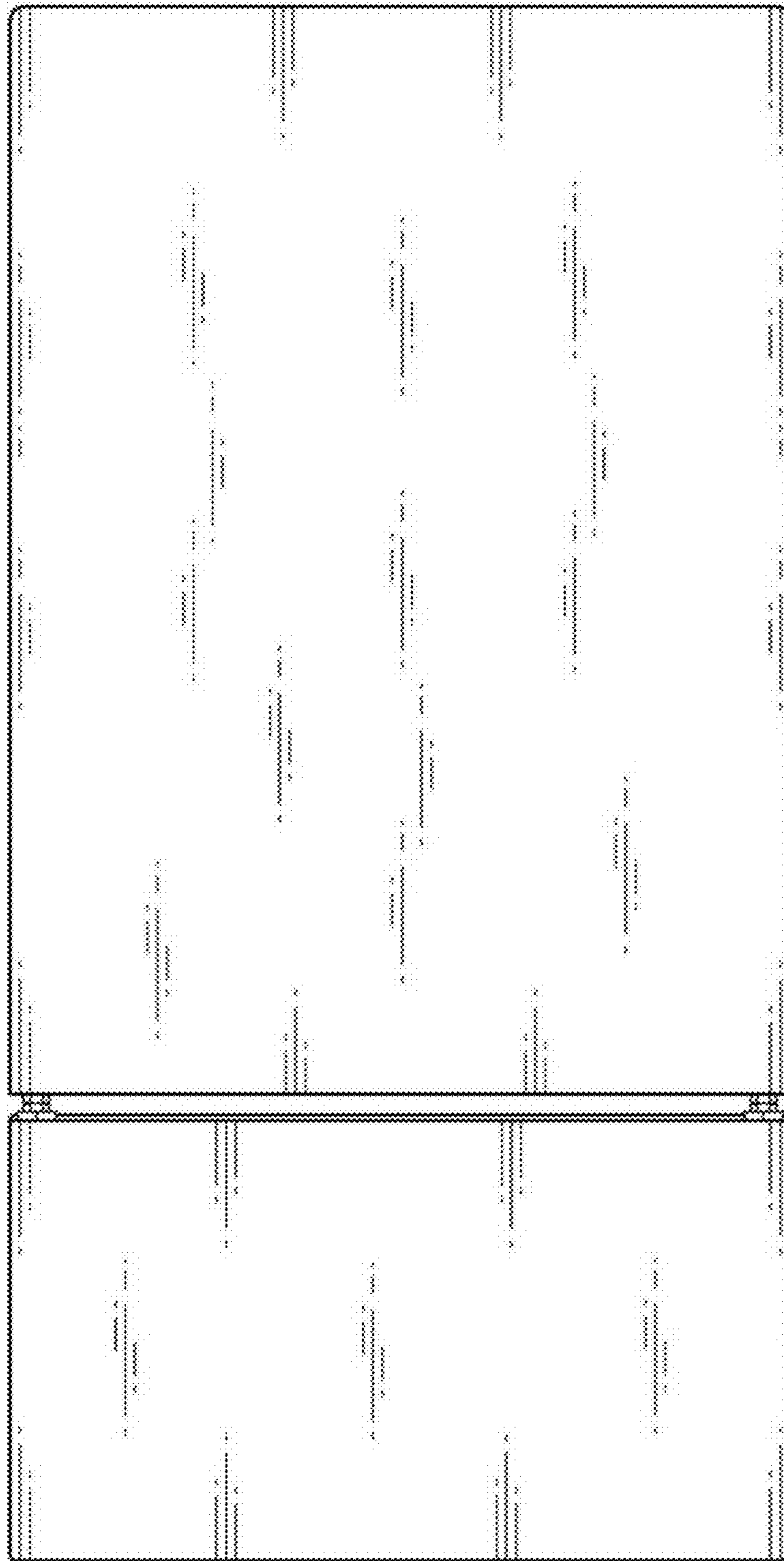

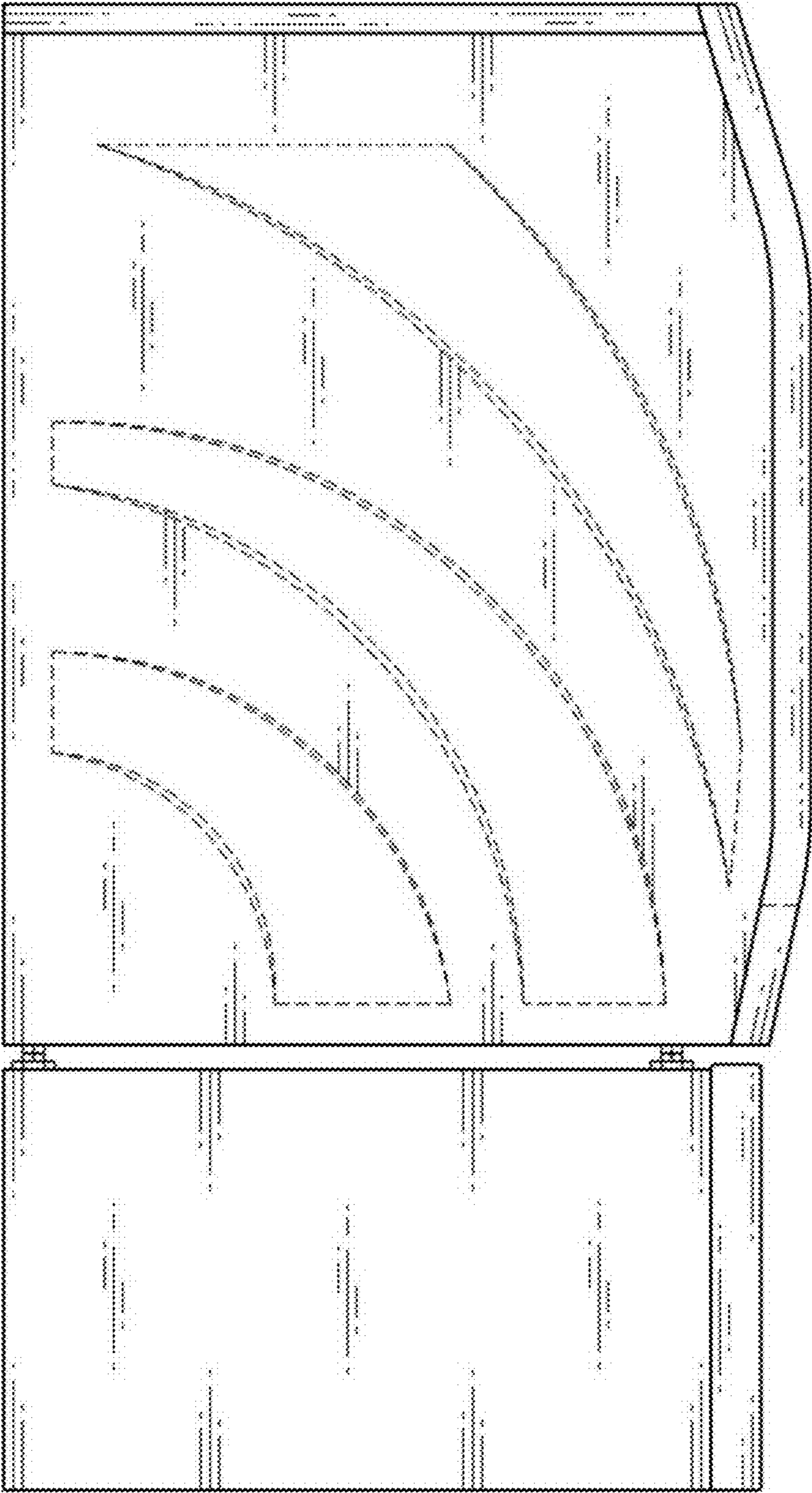

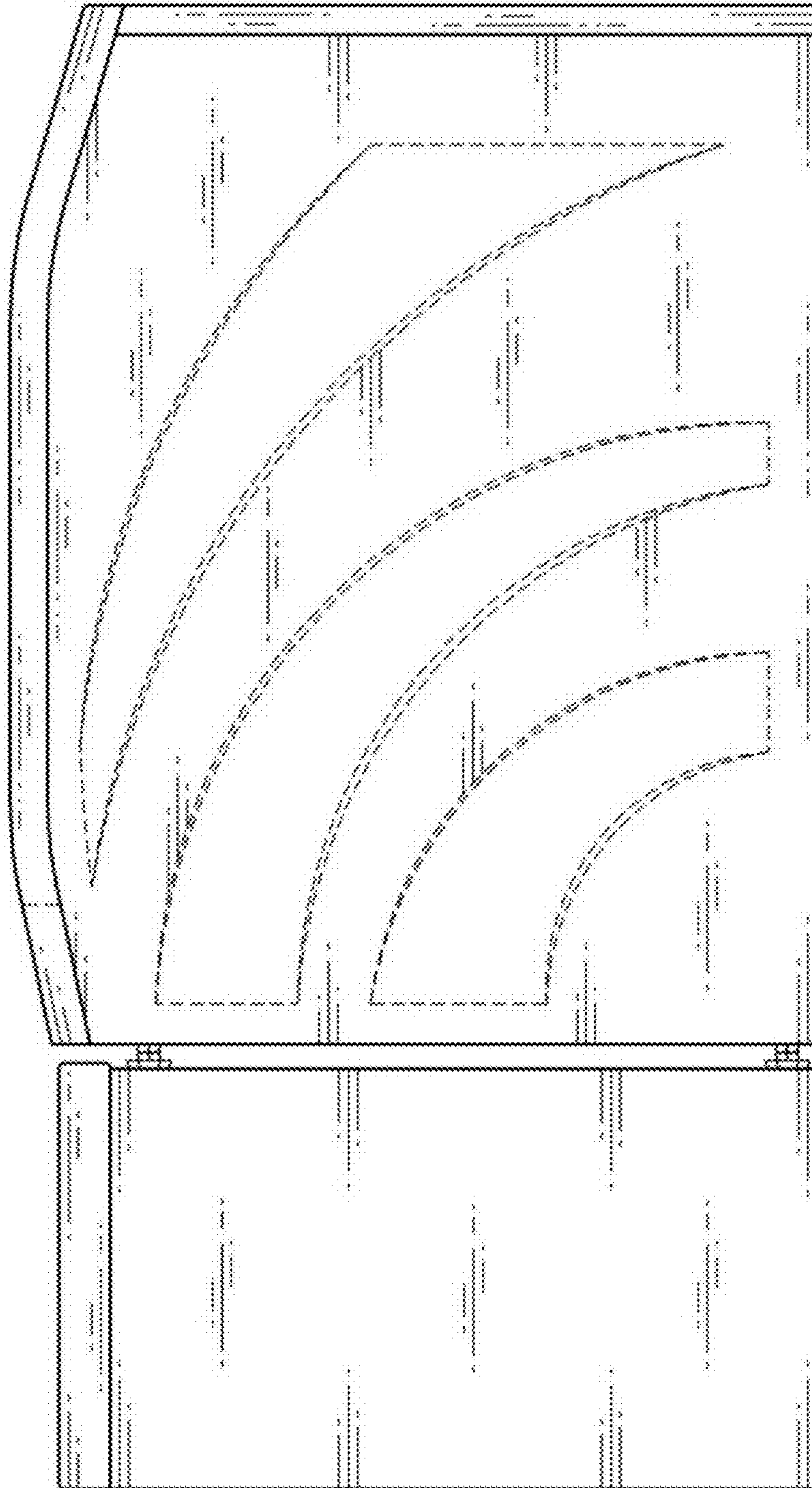

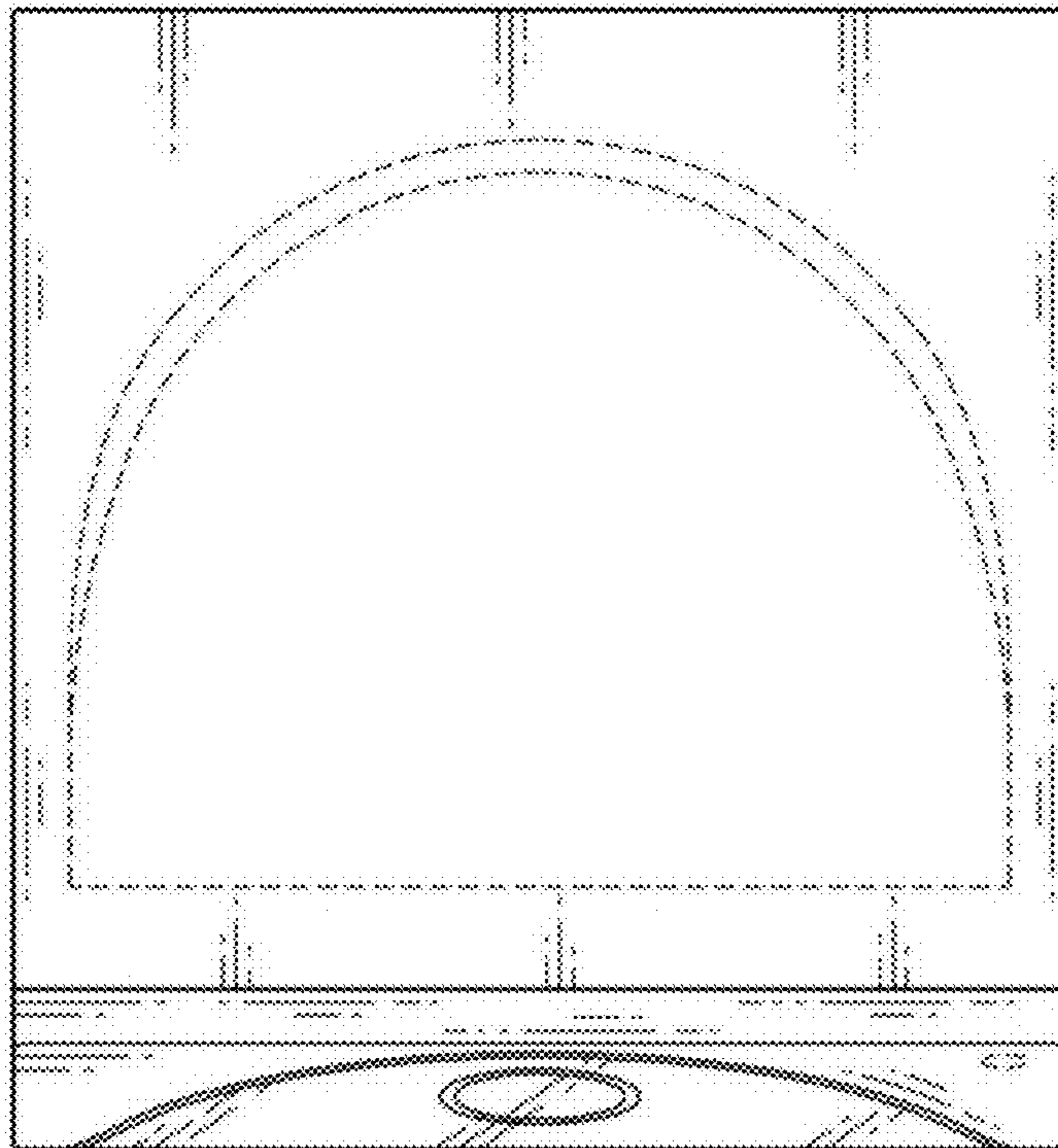

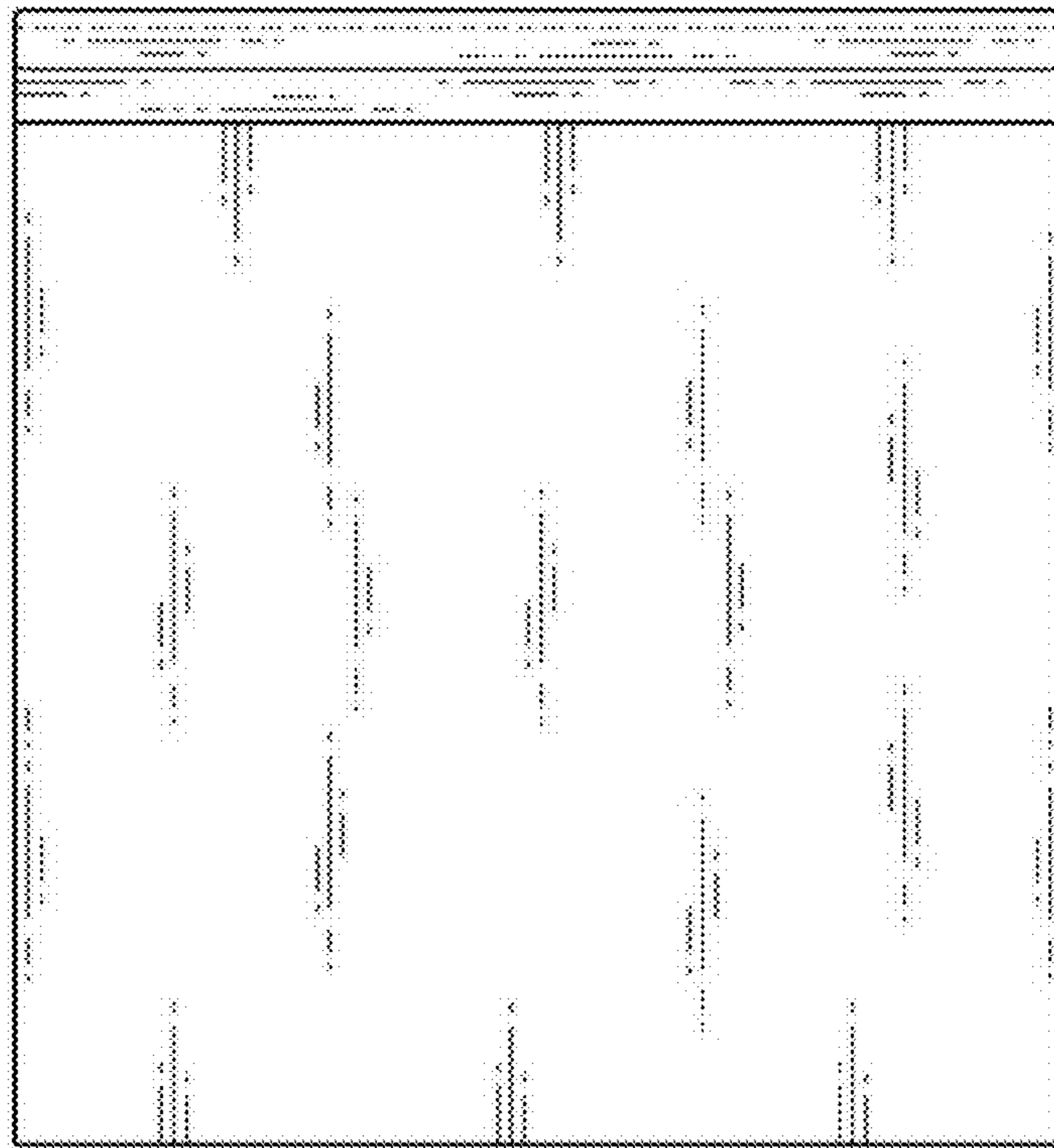
