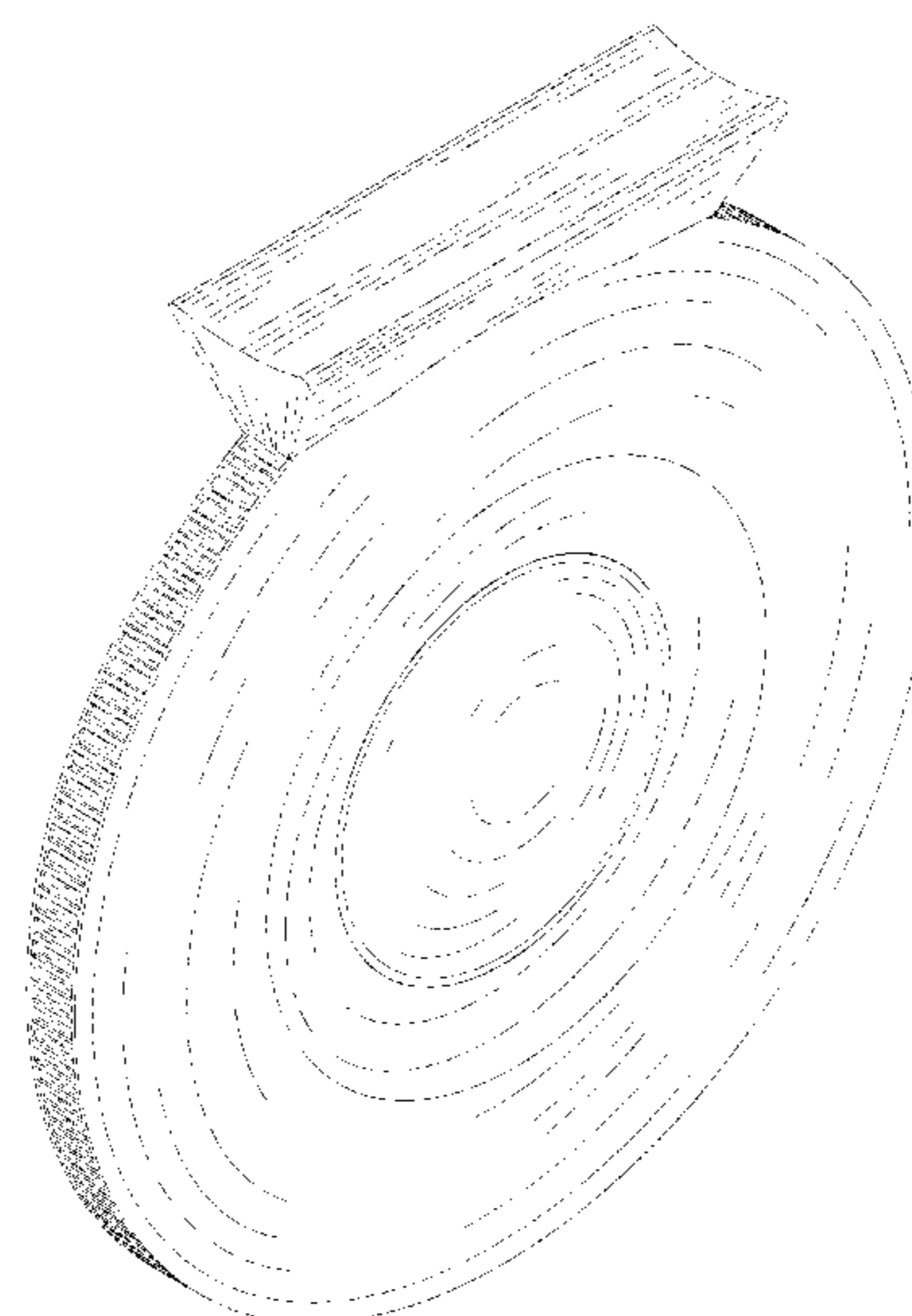
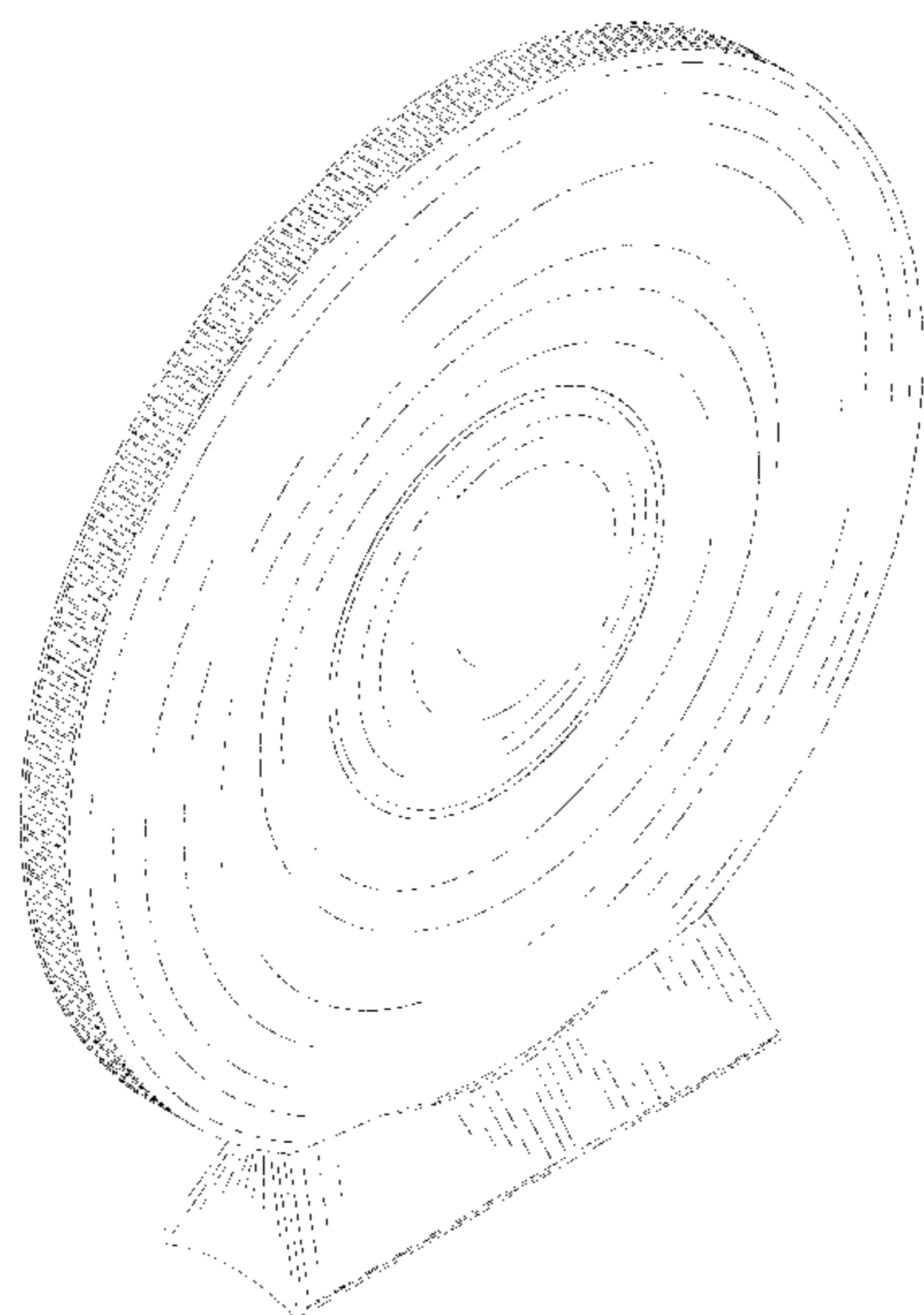
(57) **CLAIM**

The ornamental design for a coin display case, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a coin display case showing my new design;  
 FIG. 2 is a right-side elevation view thereof;  
 FIG. 3 is a left-side elevation view thereof;  
 FIG. 4 is a front elevation view thereof, a rear elevation view being a mirror image thereof;  
 FIG. 5 is a top plan view thereof;  
 FIG. 6 is a bottom plan view thereof;  
 FIG. 7 is a bottom perspective view thereof; and,  
 FIG. 8 is a cross sectional view thereof taken along line 8-8 in FIG. 3.

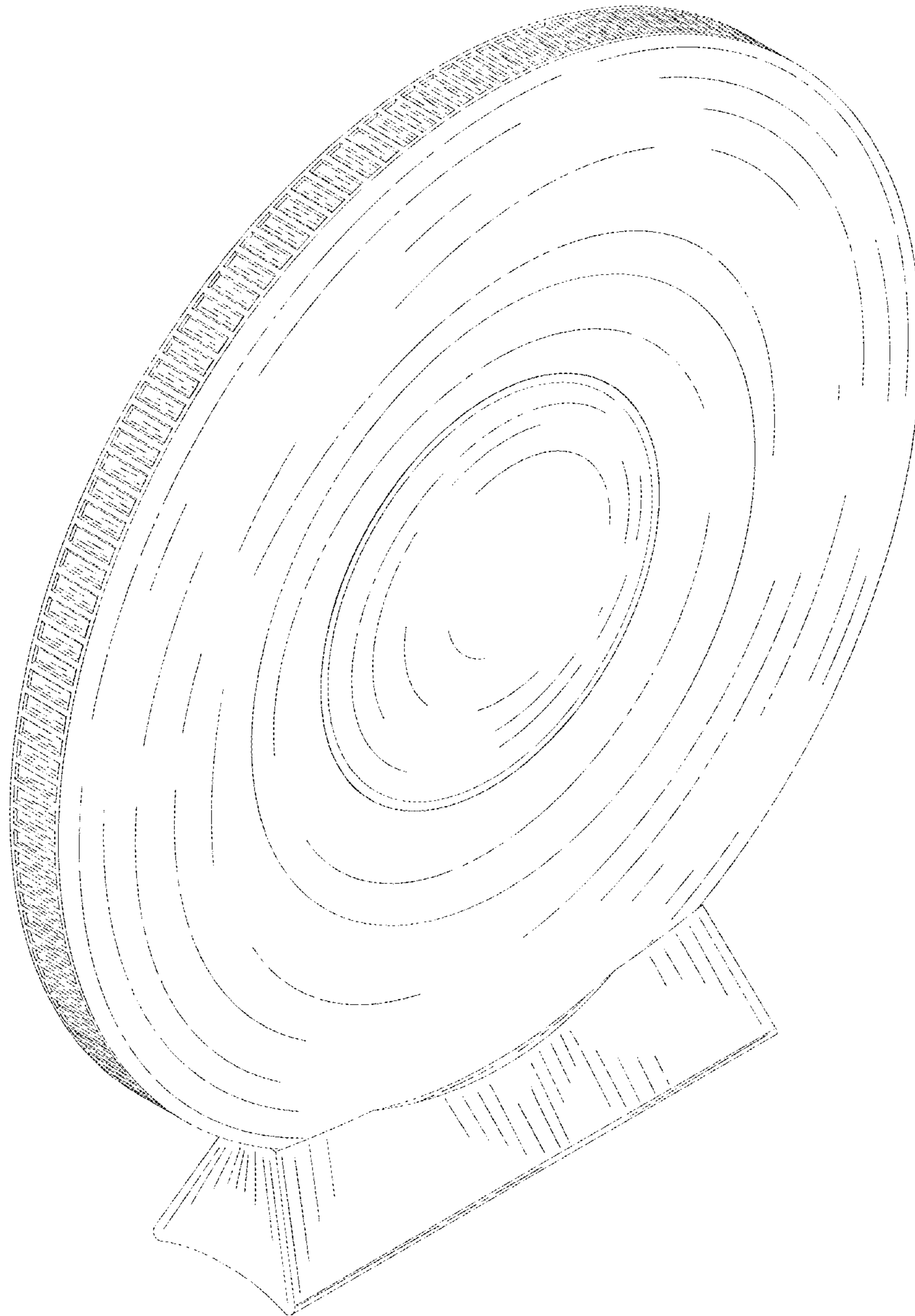

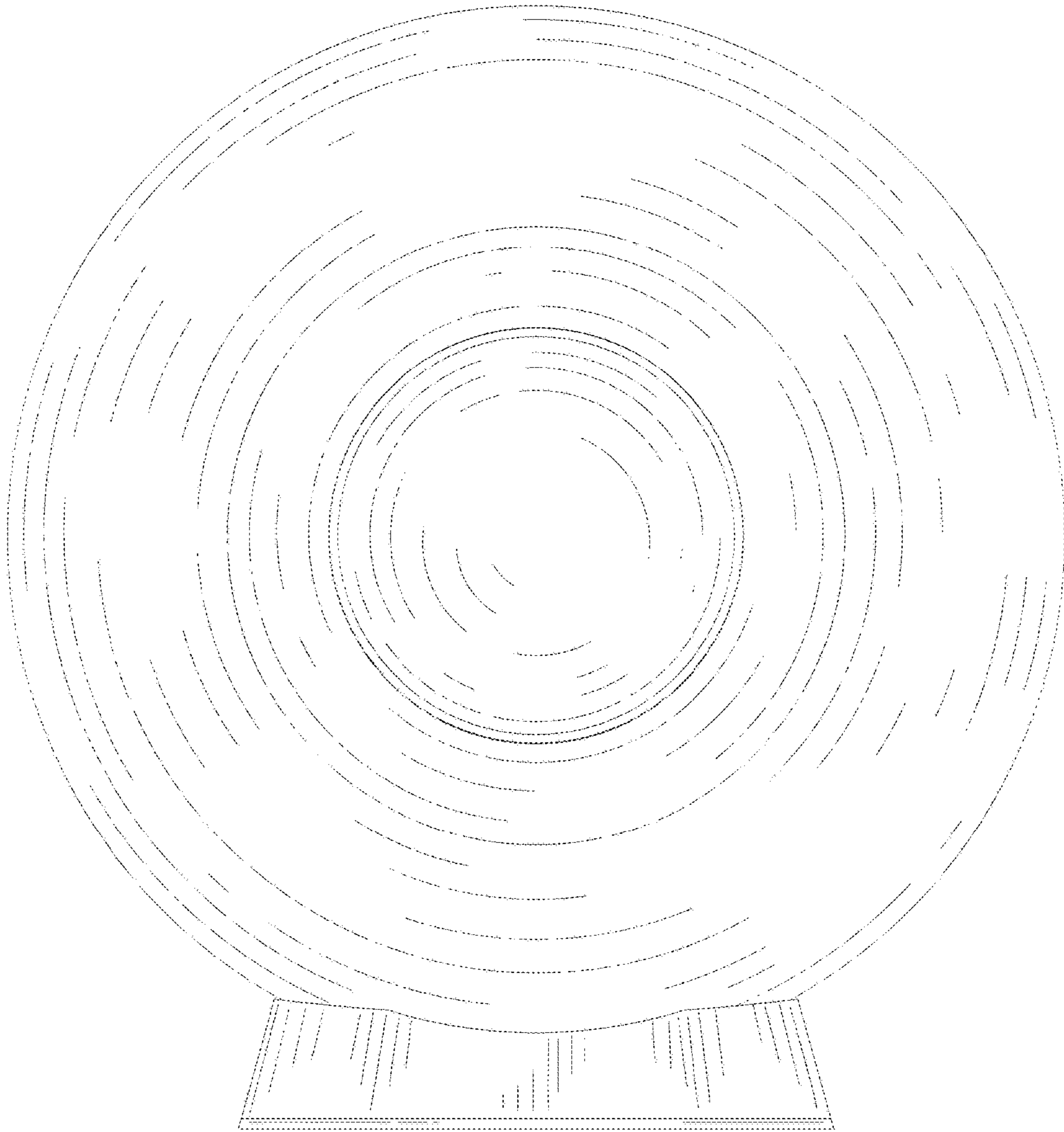

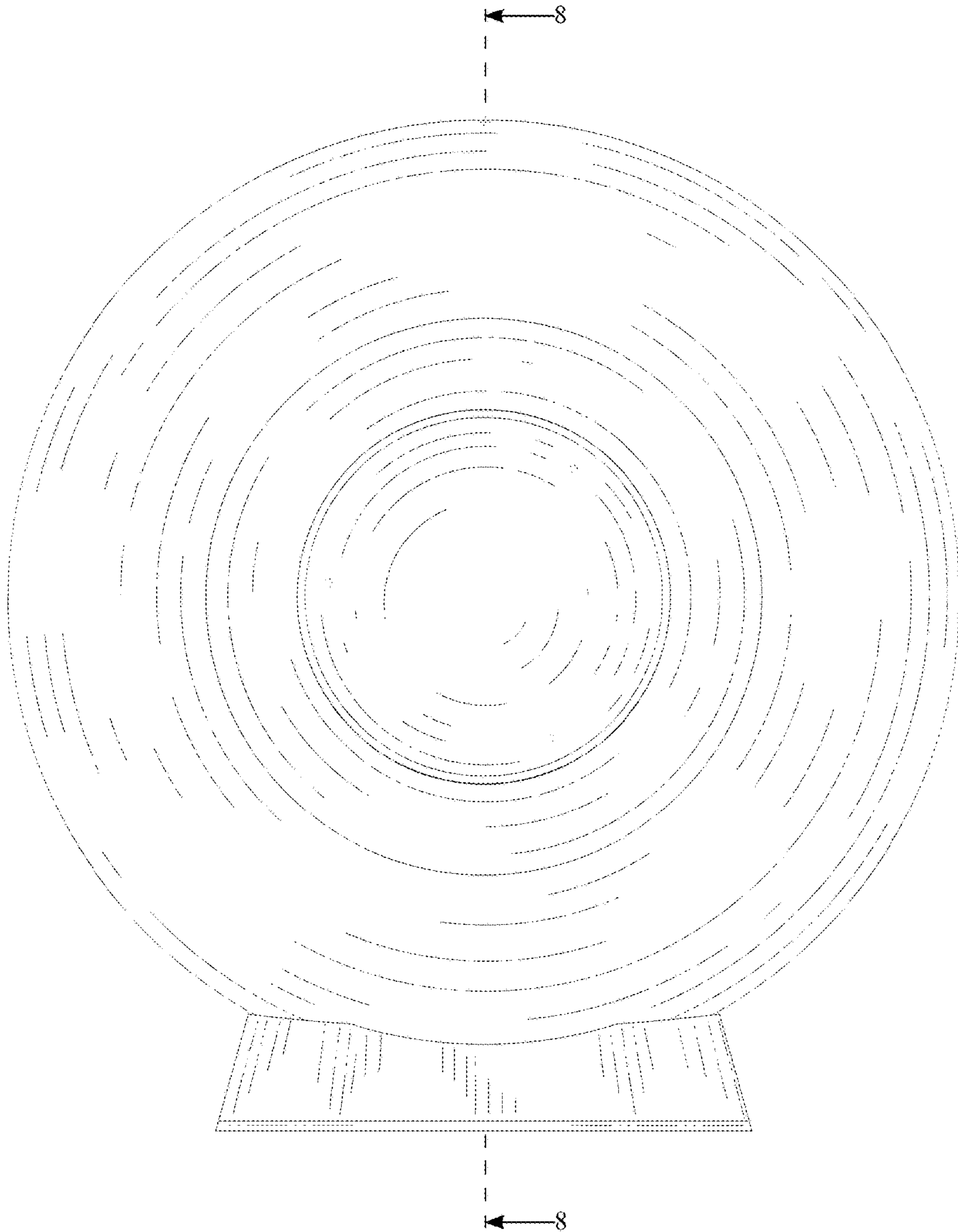

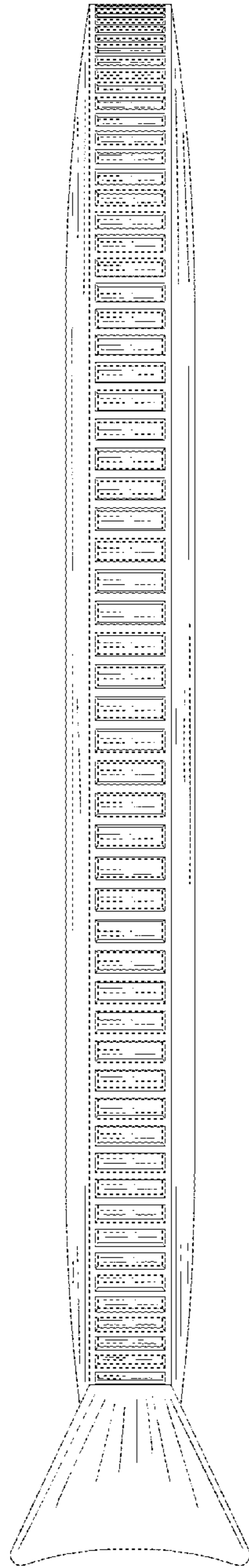

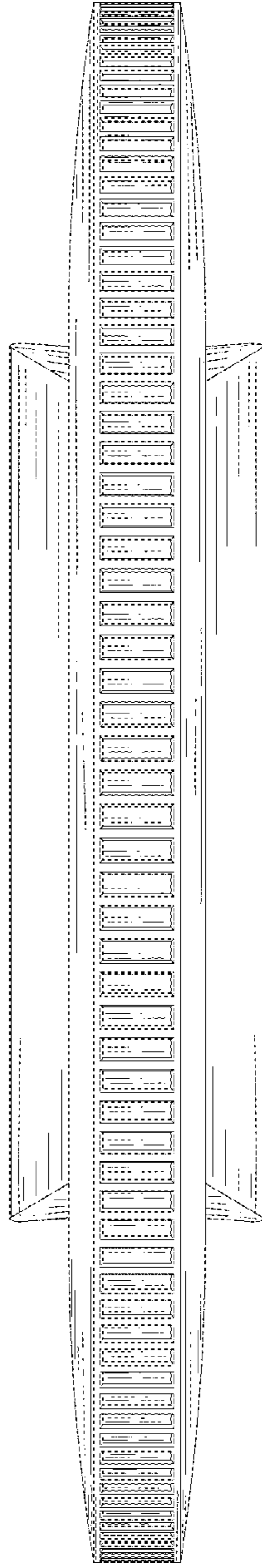

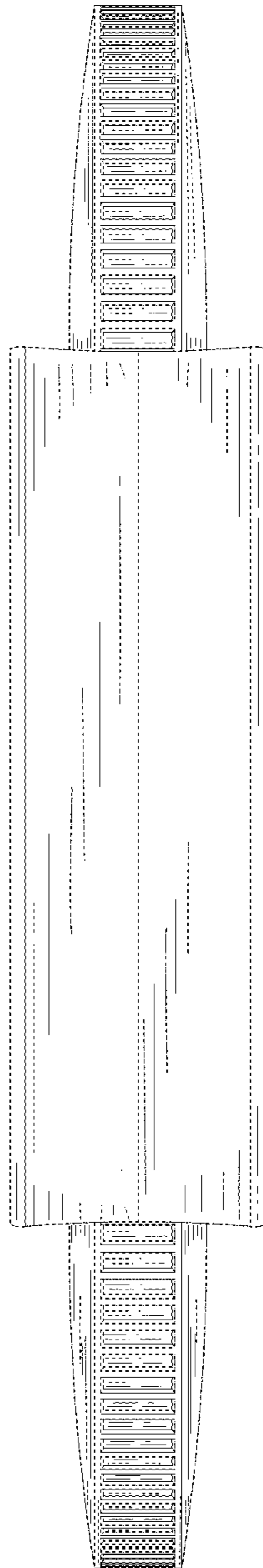

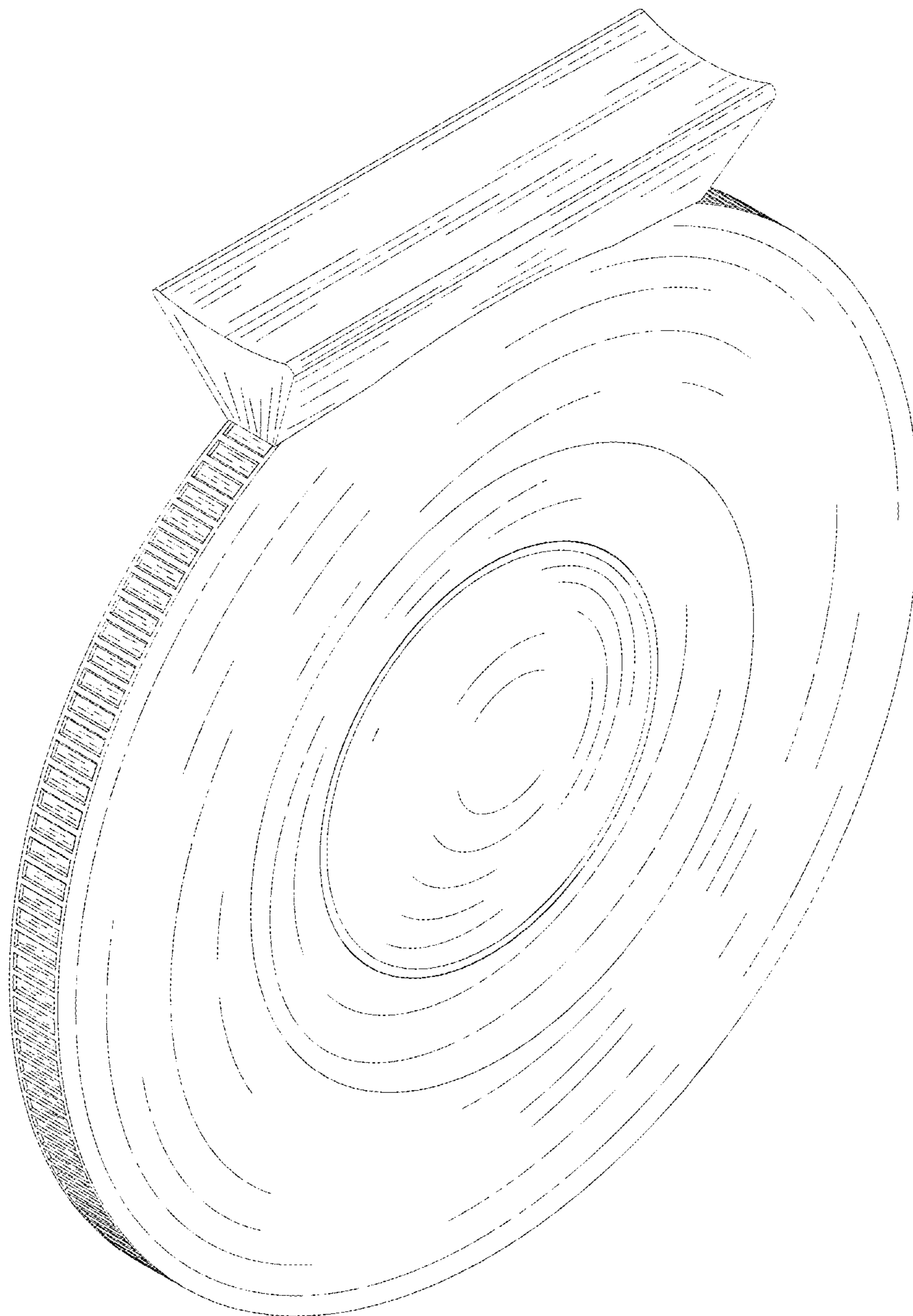

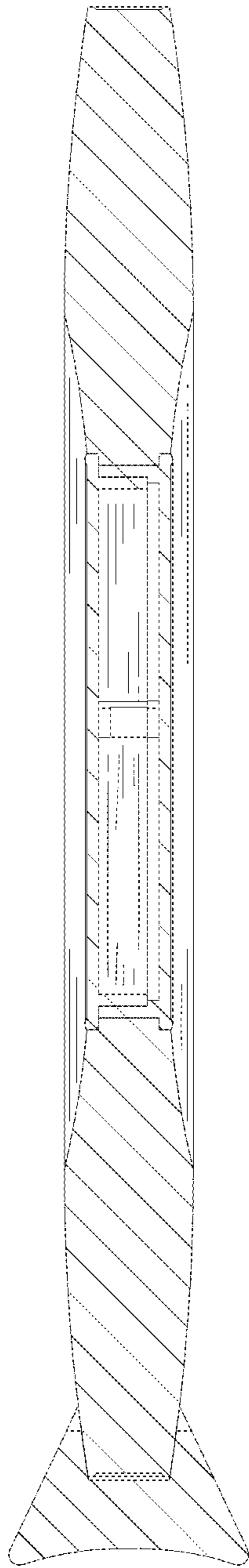
