(57) **CLAIM**

The ornamental design for a chocolate confection, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a chocolate confection according to the present design;
FIG. 2 is a rear elevational view of the chocolate confection of FIG. 1;
FIG. 3 is a left side elevational view of the chocolate confection of FIG. 1;
FIG. 4 is a front elevational view of the chocolate confection of FIG. 1;

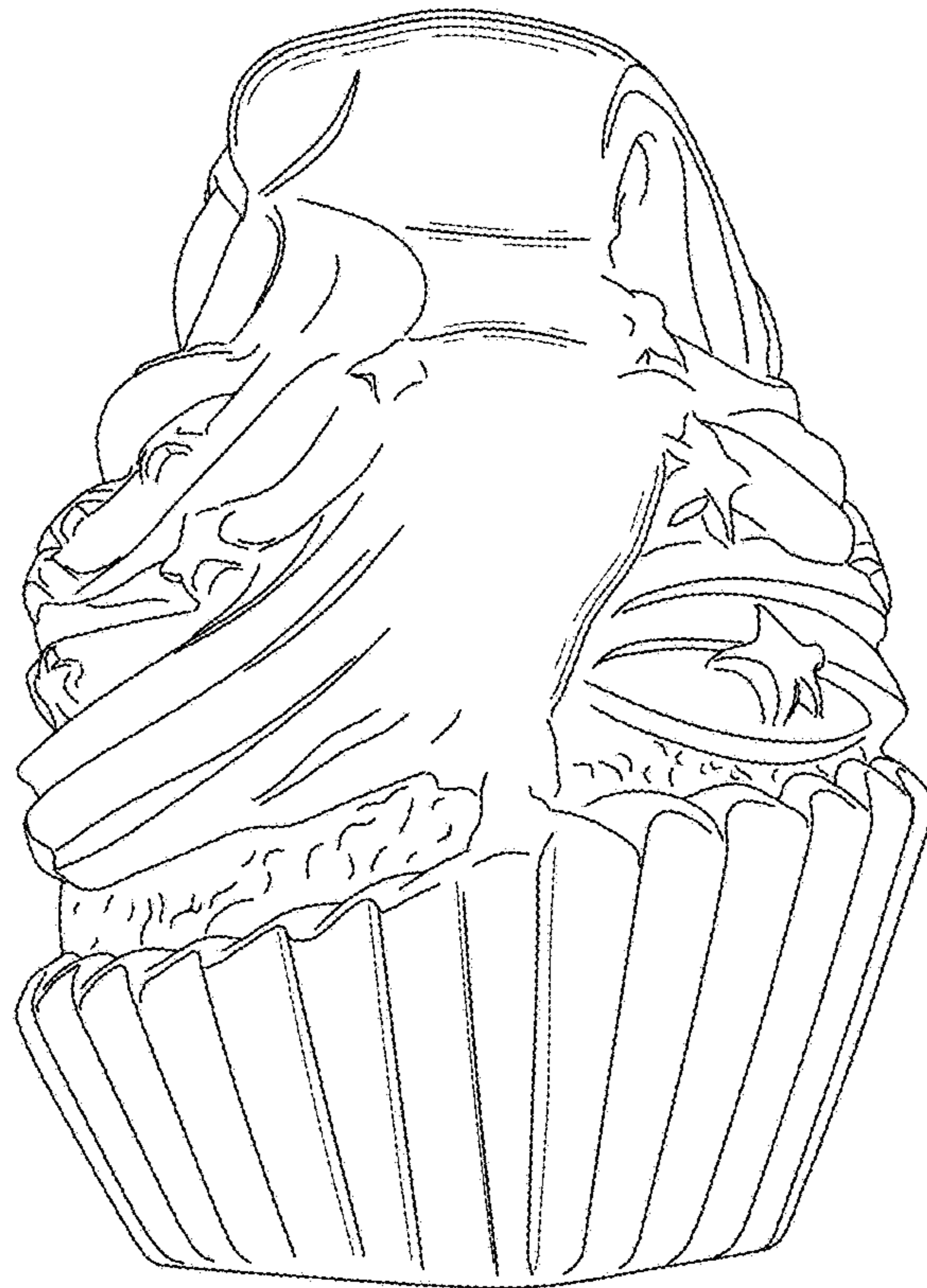

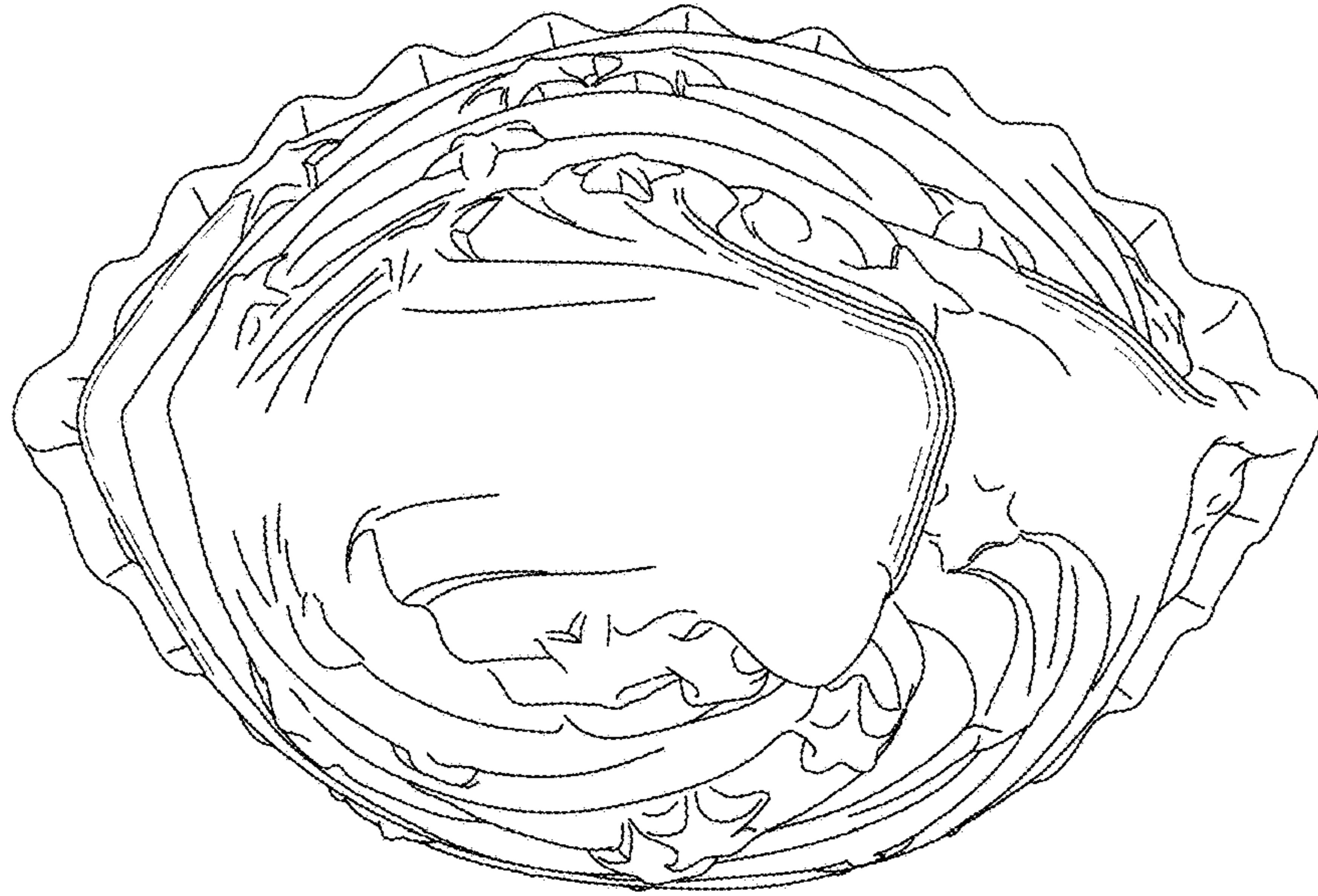

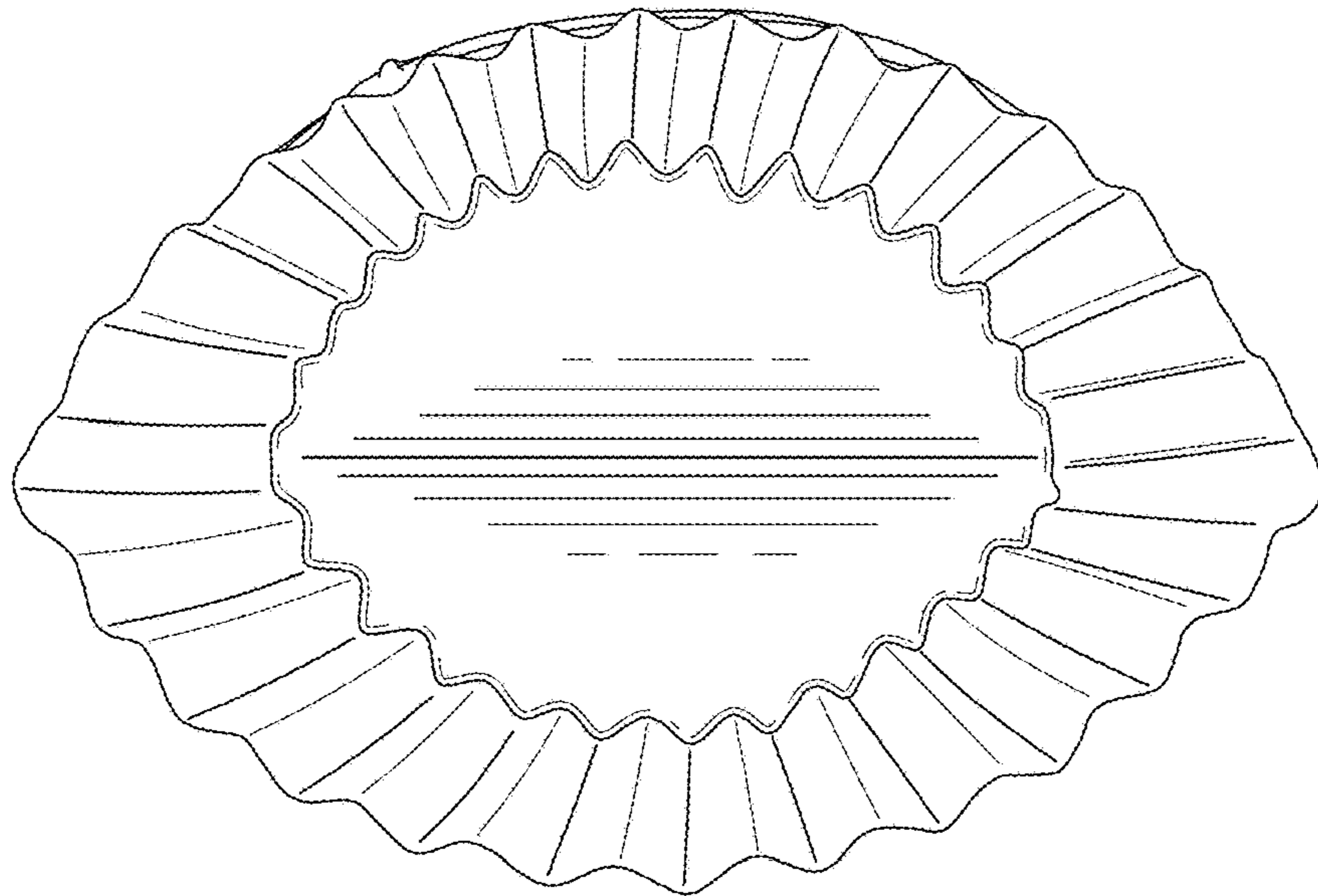
