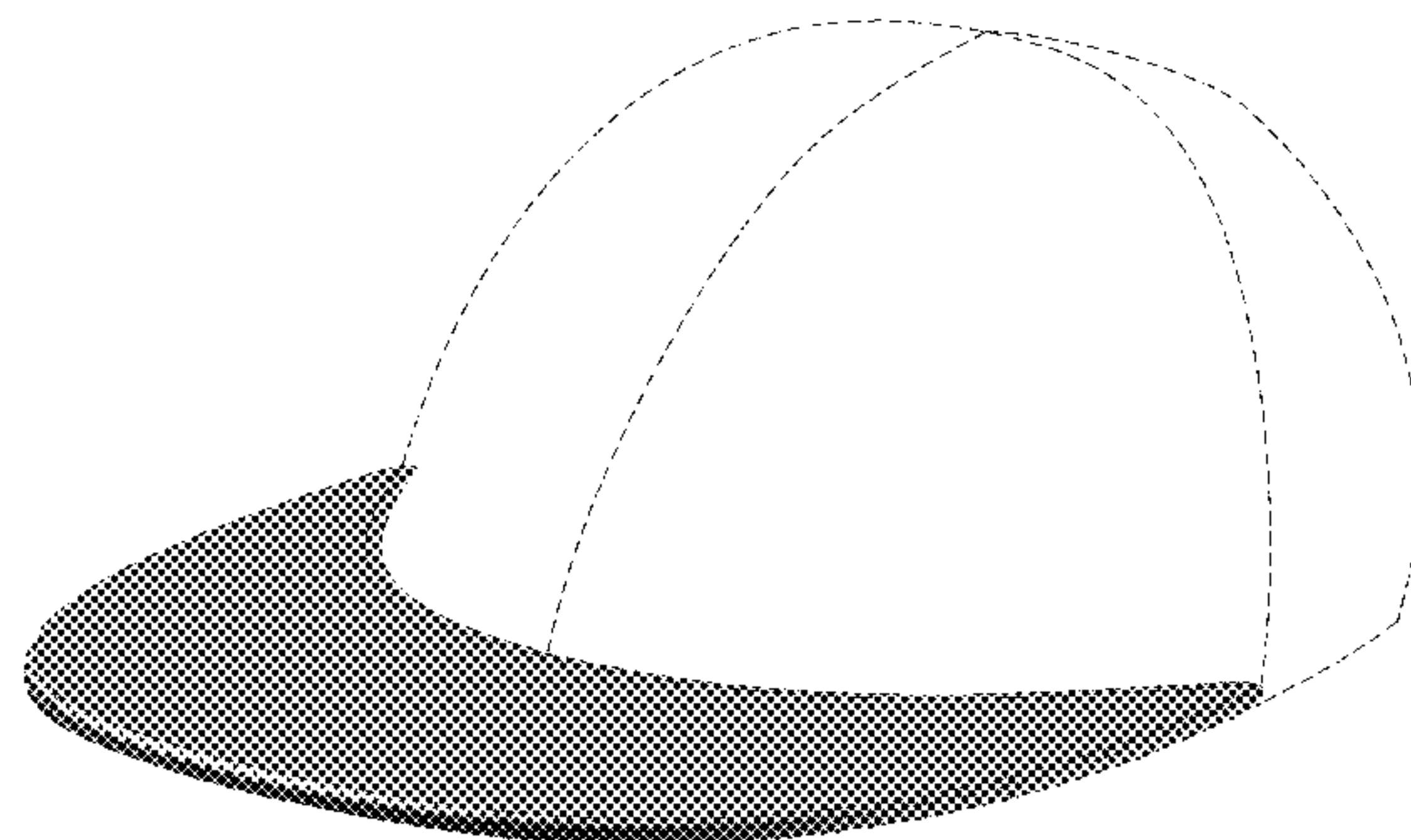
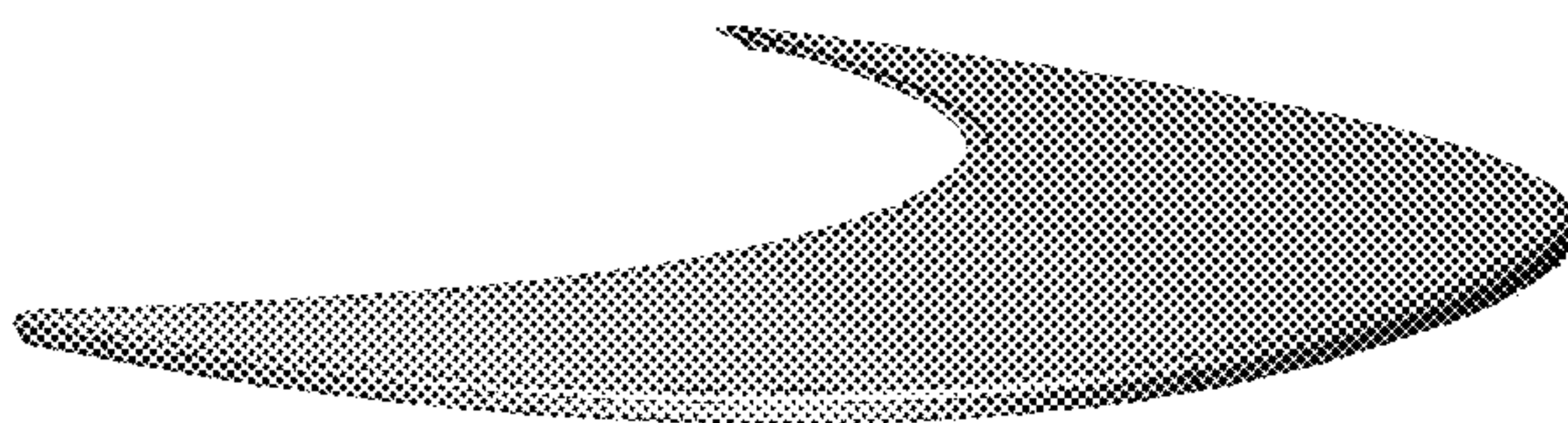
(57) **CLAIM**

I claim the ornamental design for a visor for a cap or headband, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a visor for a cap or headband showing my new design;
 FIG. 2 is a bottom view thereof;
 FIG. 3 is a front view thereof;
 FIG. 4 is a rear view thereof;
 FIG. 5 is a right side view thereof;
 FIG. 6 is a top, front, right side perspective view thereof;
 FIG. 7 is a top, rear, right side perspective view thereof;
 FIG. 8 is a top, rear, left side perspective view thereof;
 FIG. 9 is a bottom, front, right side perspective view thereof;
 FIG. 10 is a bottom, rear, right side perspective view thereof;
 and,
 FIG. 11 is a top, front, left side perspective view showing the visor as part of a cap.
 The broken line showing of a cap in FIG. 11 is for the purpose of illustrating environmental structure and forms no part of the claimed design.

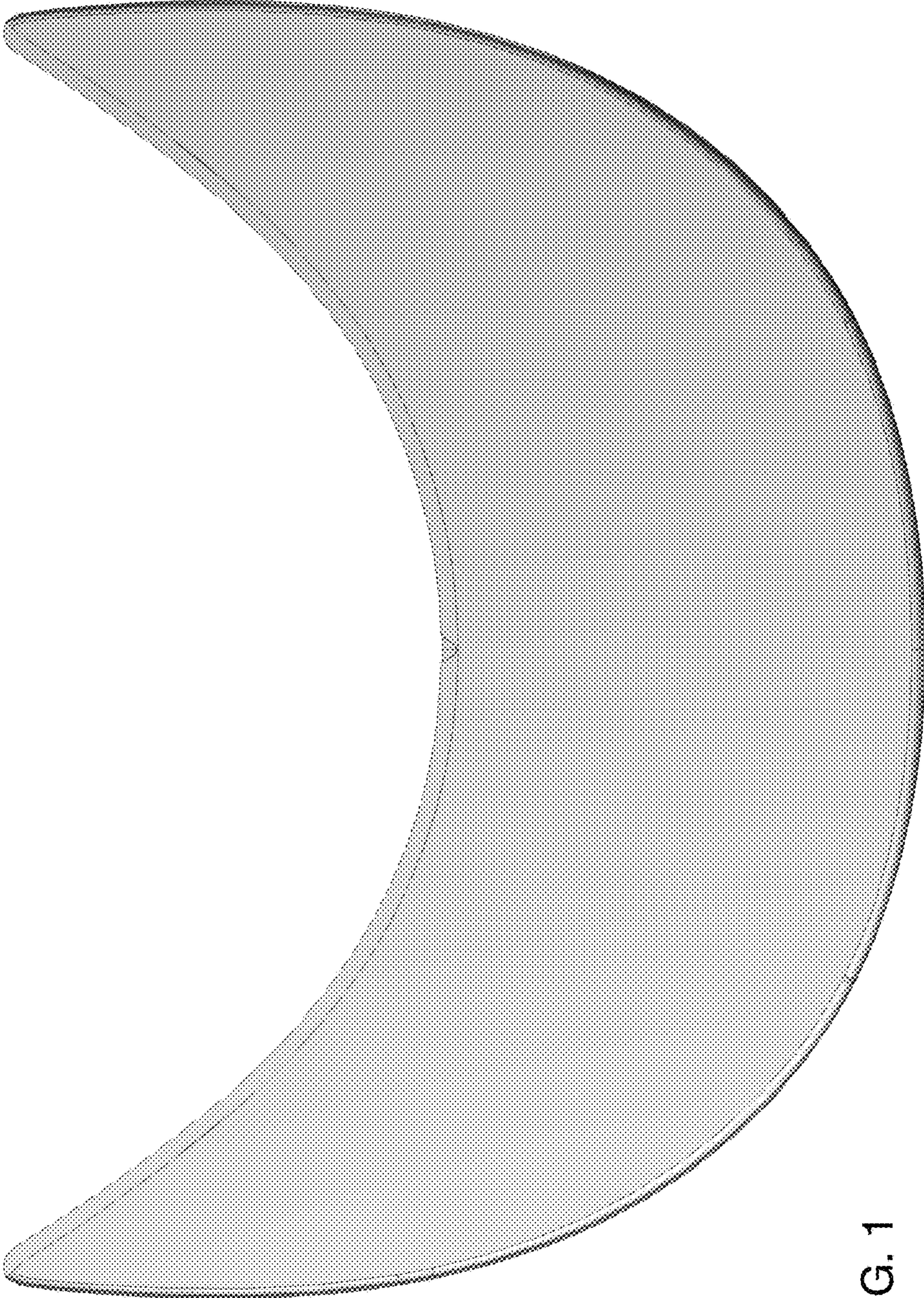

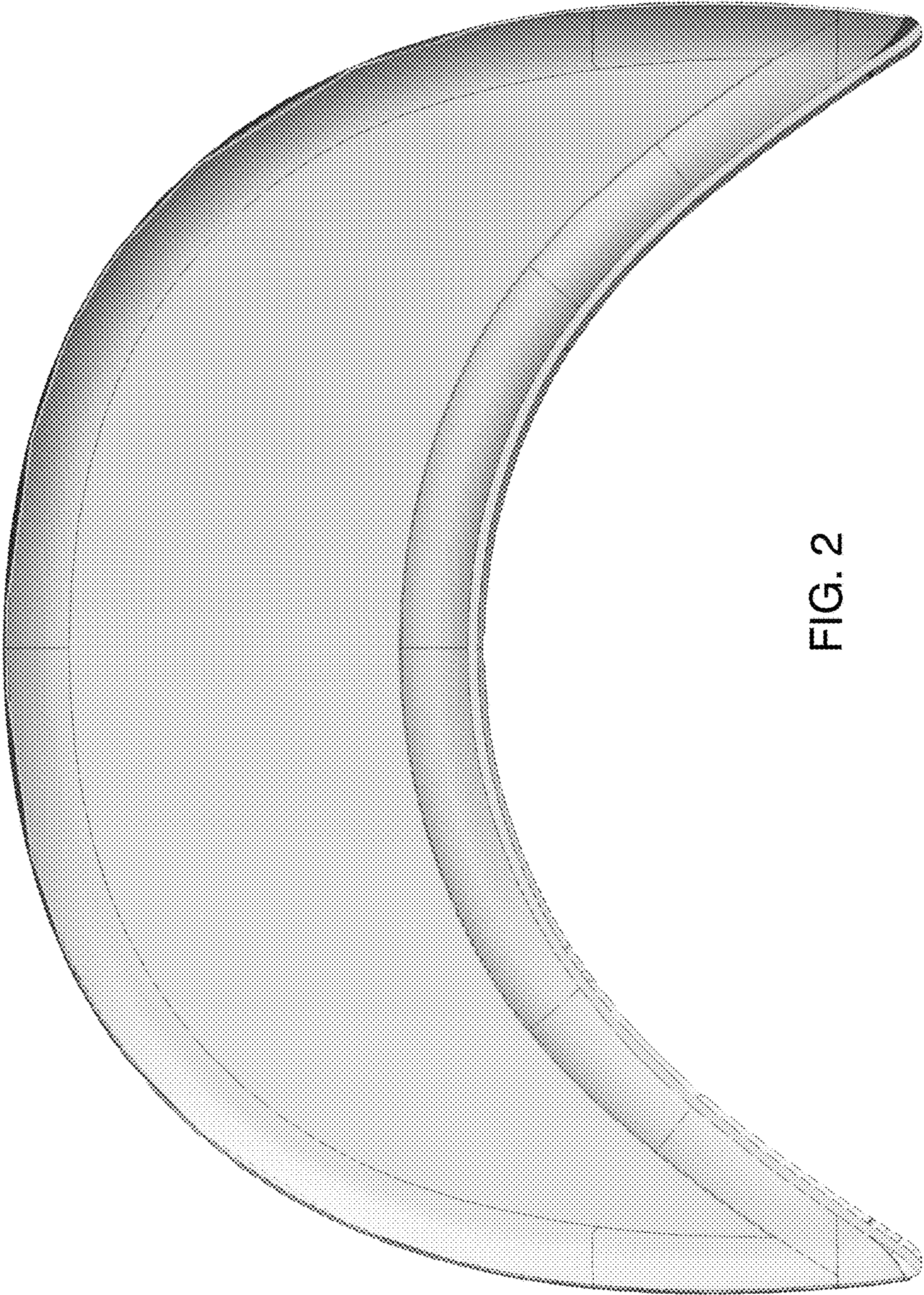

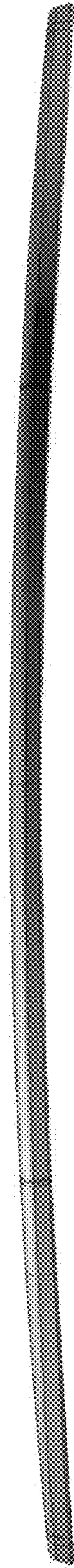

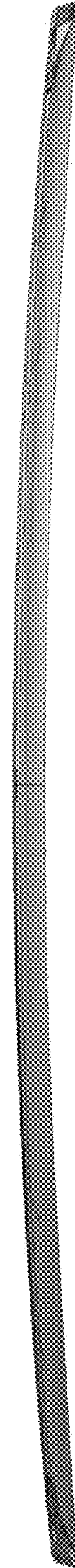

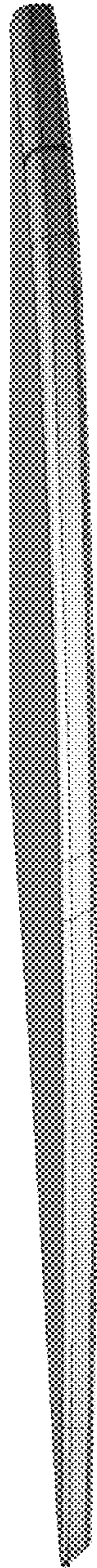

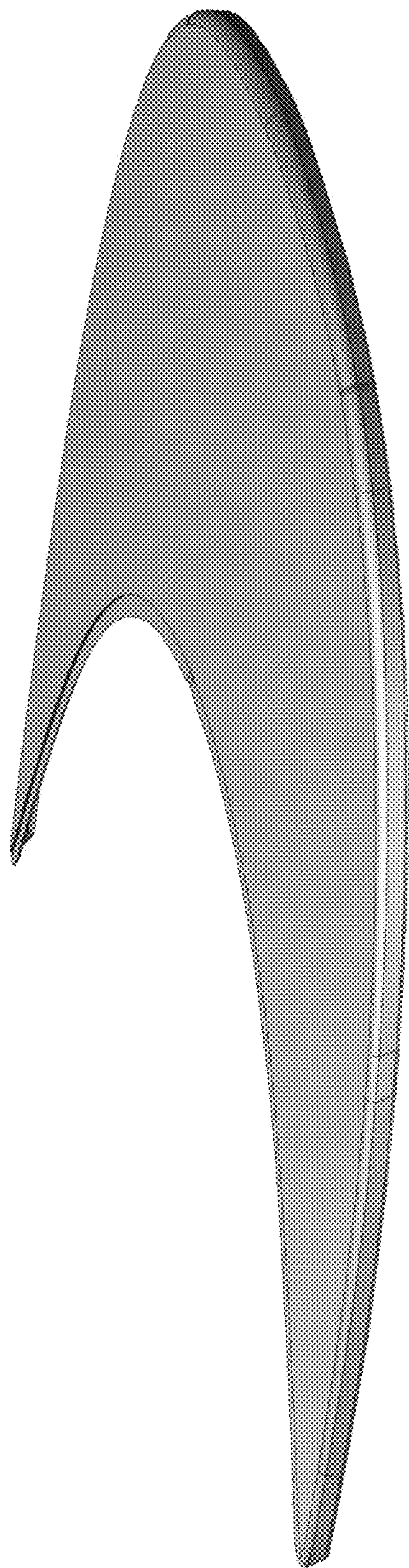

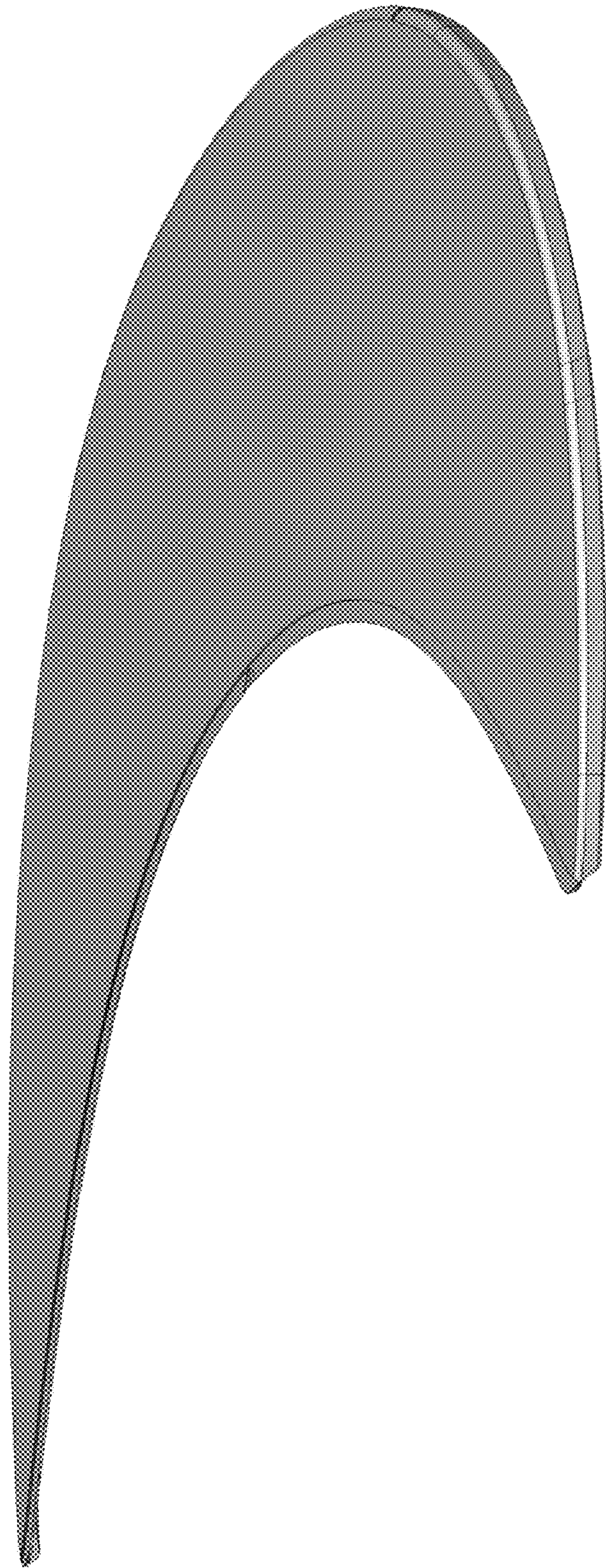

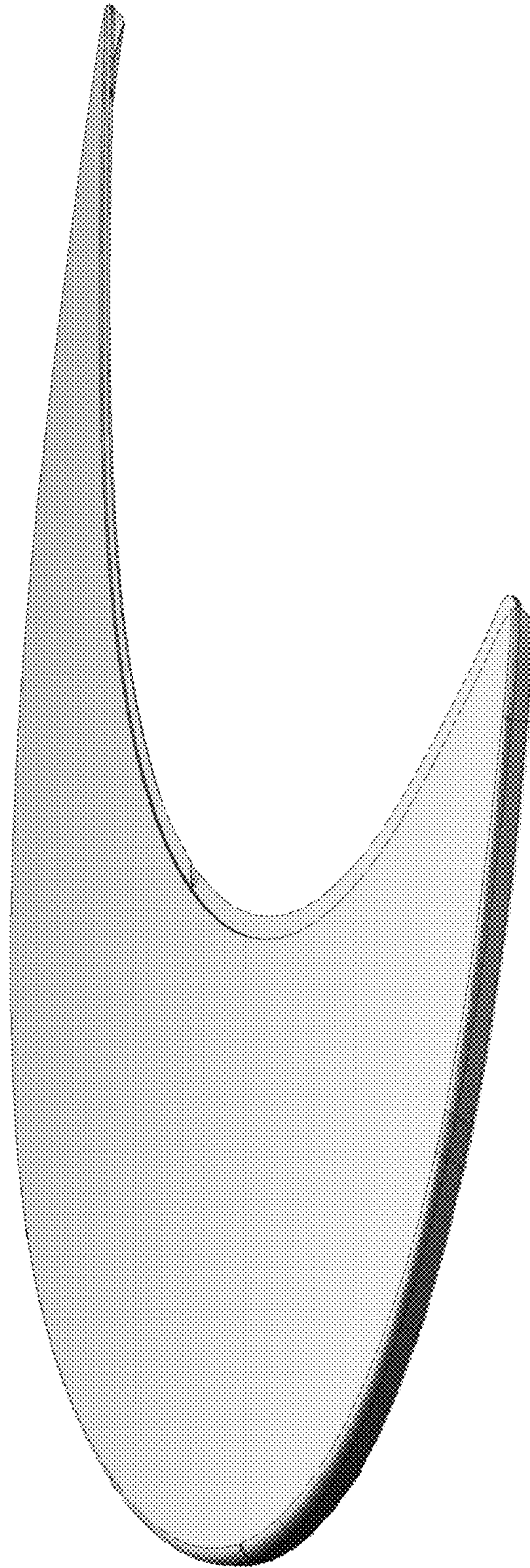

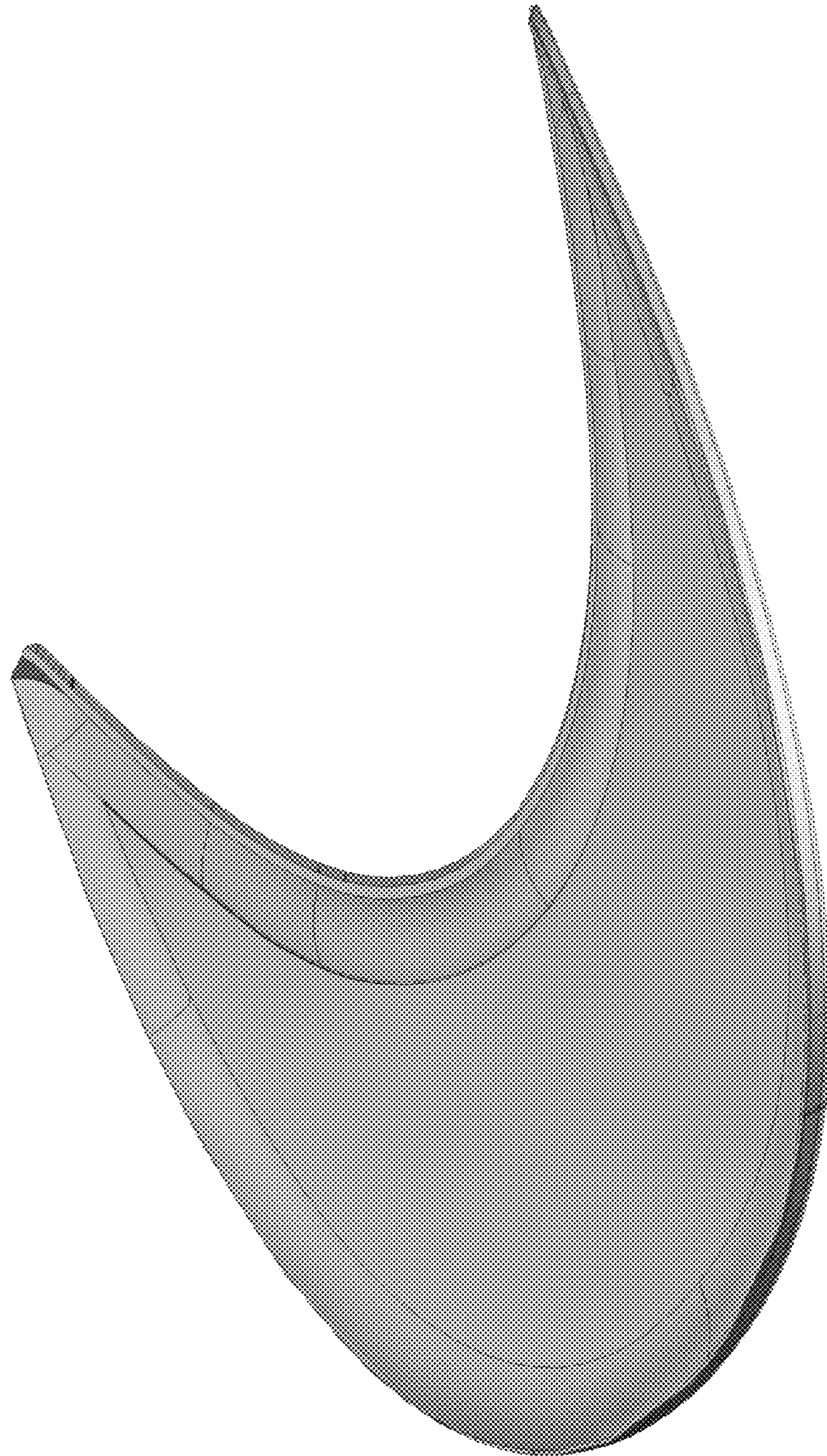

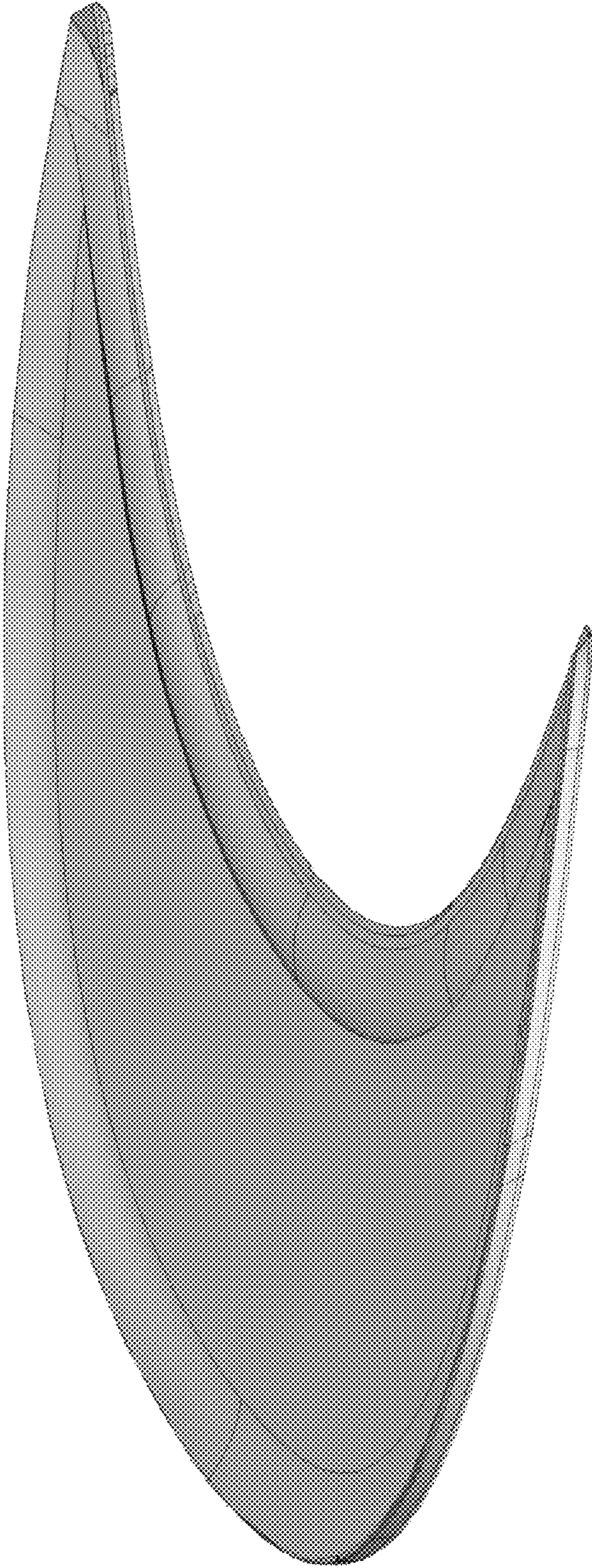

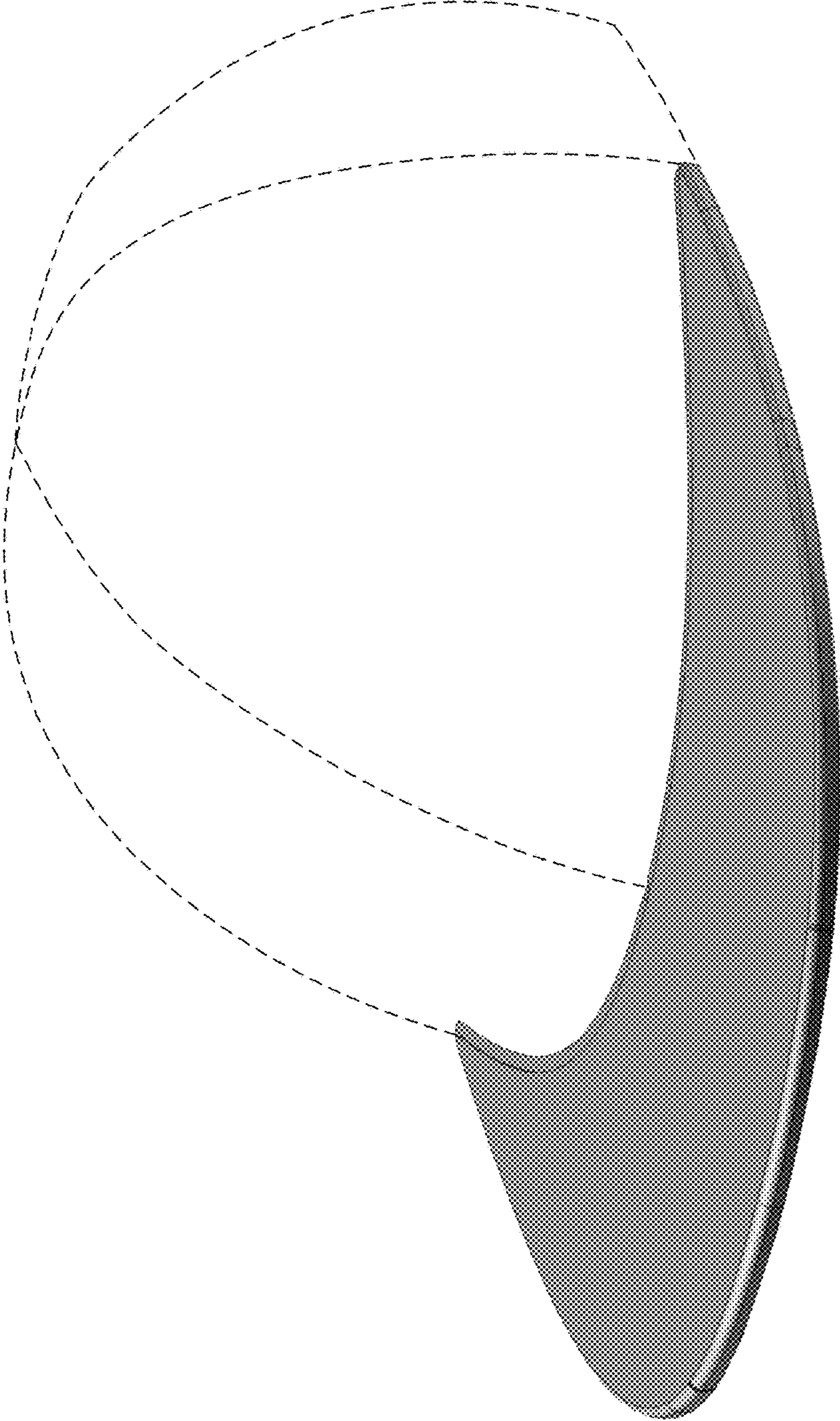
