The ornamental design for an instep strap for shoe, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of an instep strap for a shoe showing my new design

FIG. 4 is a top plan view of the instep strap for shoe shown in FIG. 1;

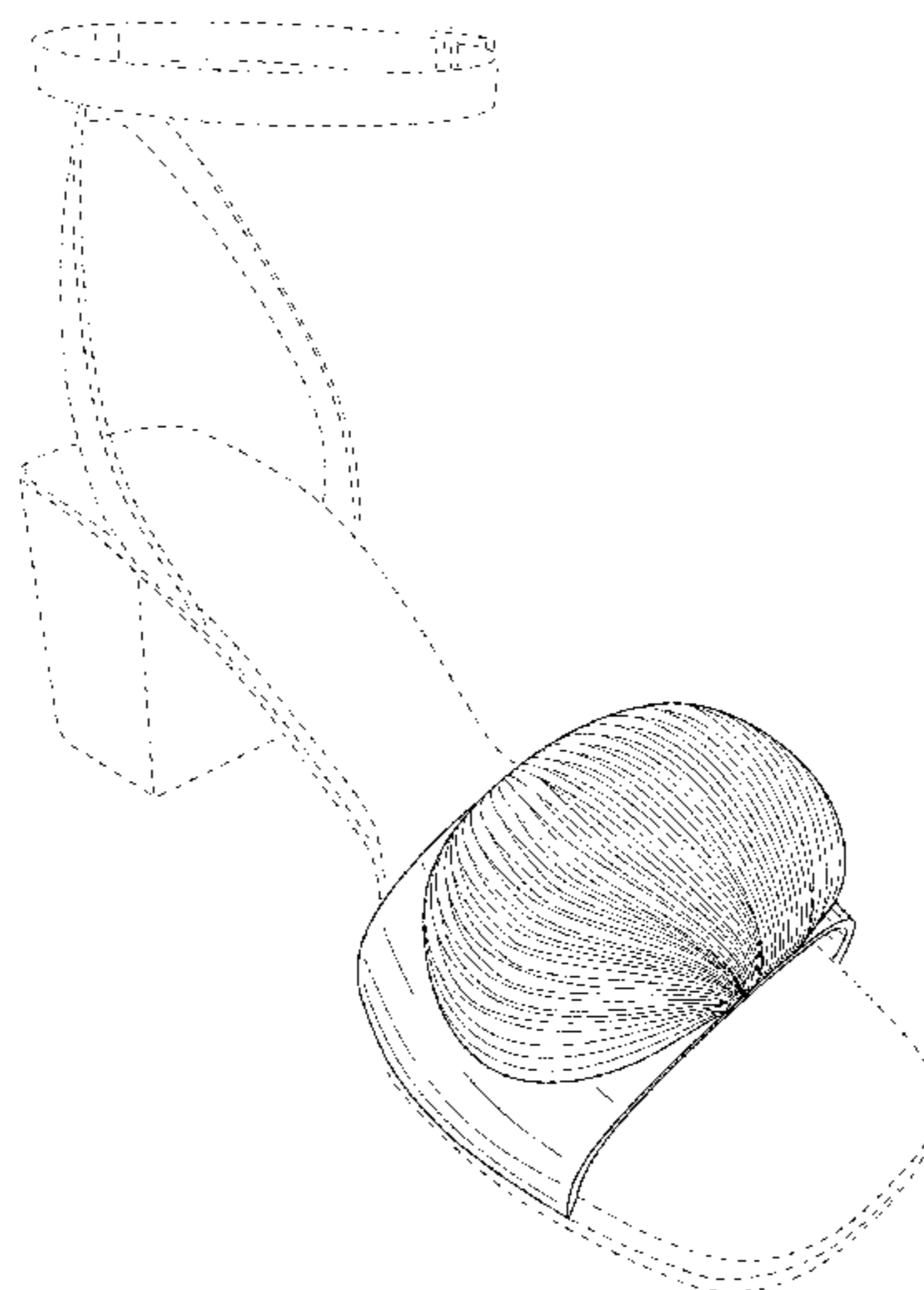
FIG. 5 is a bottom view of the instep strap for shoe shown in FIG. 1;

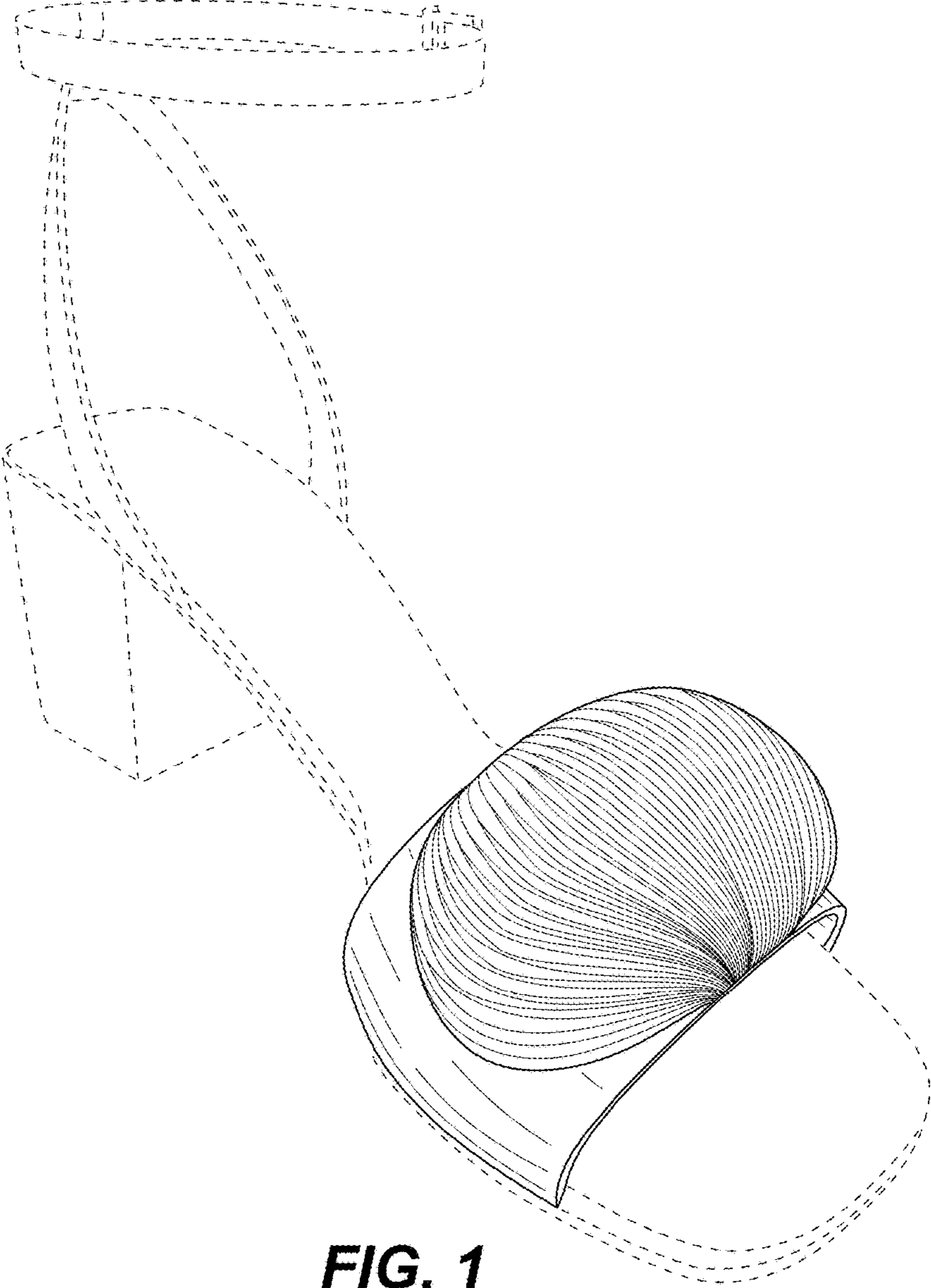

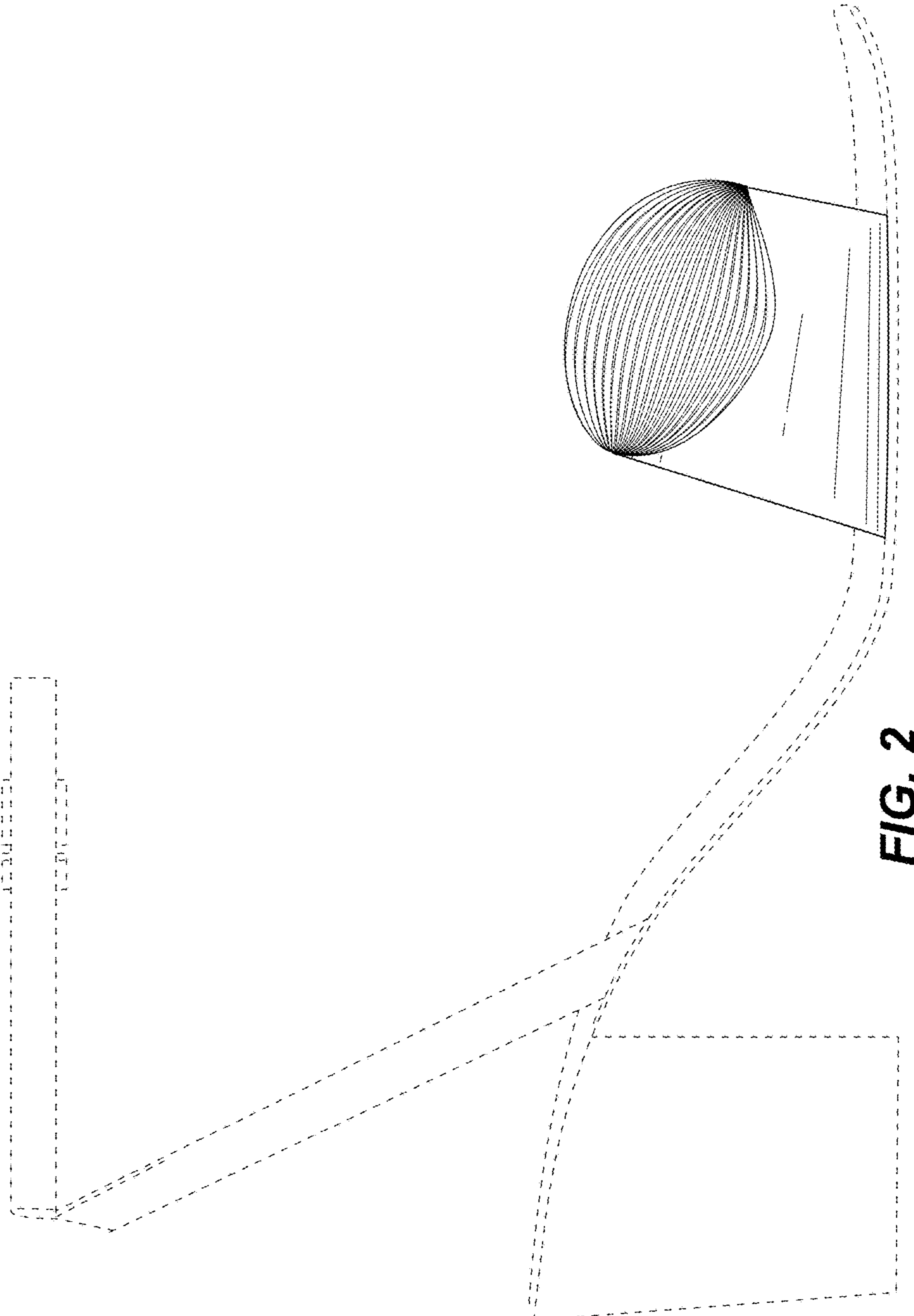

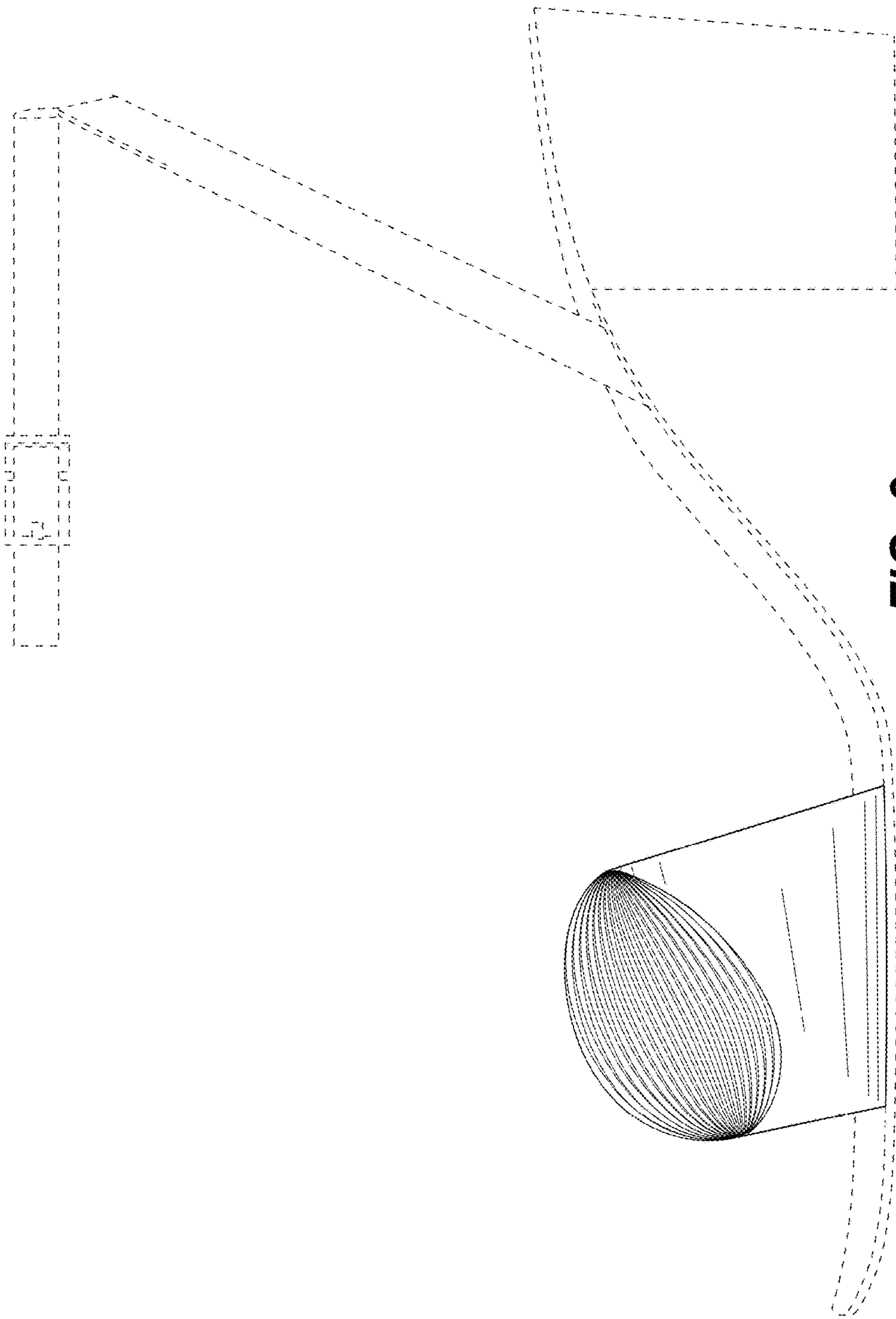

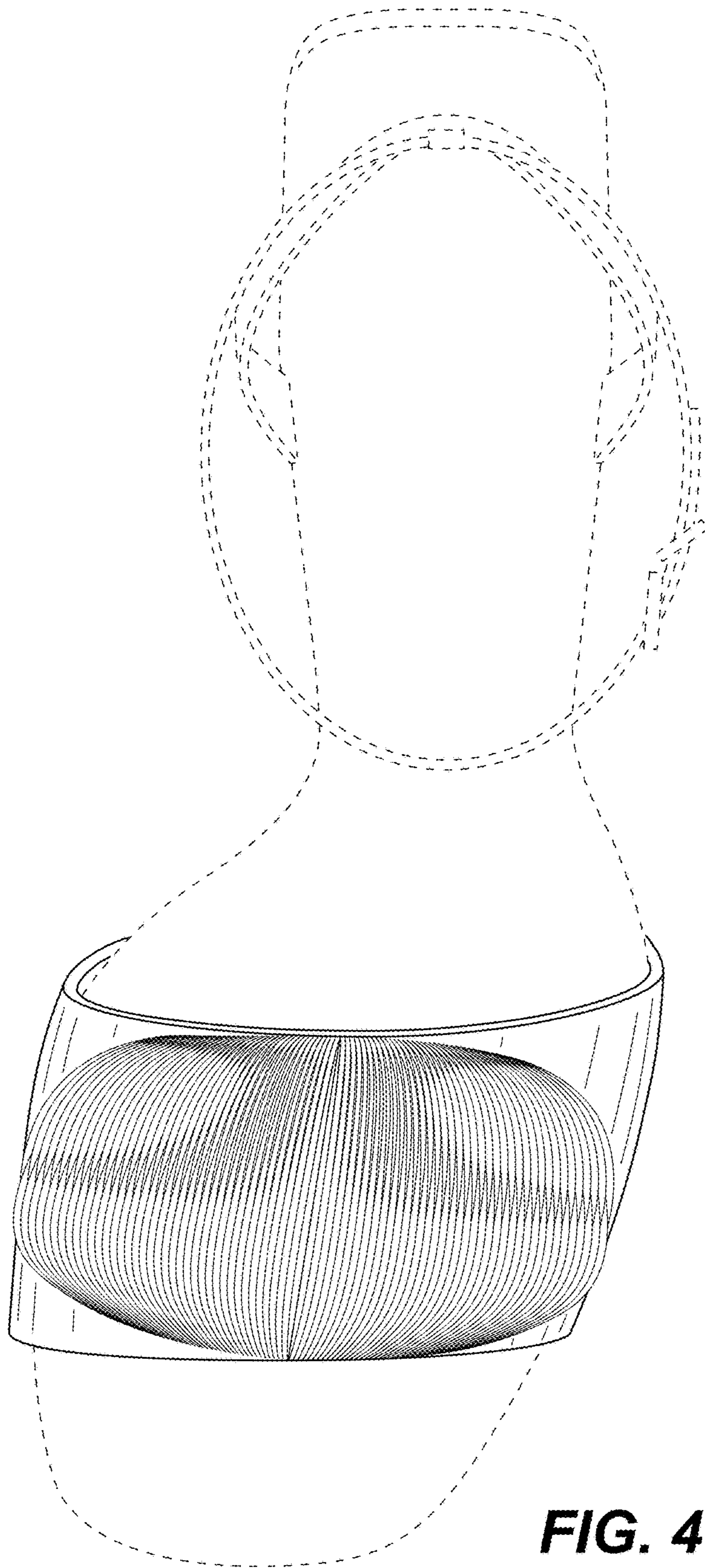

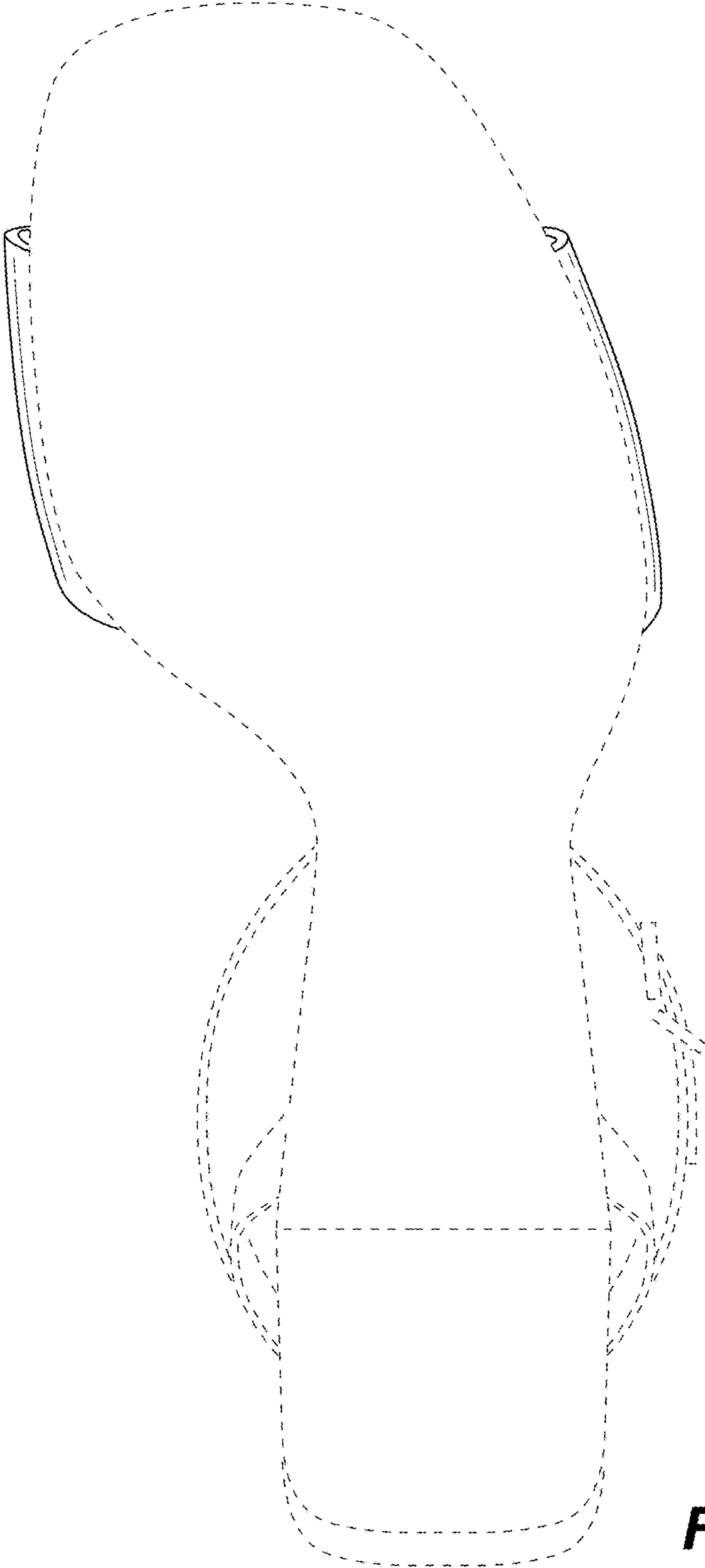

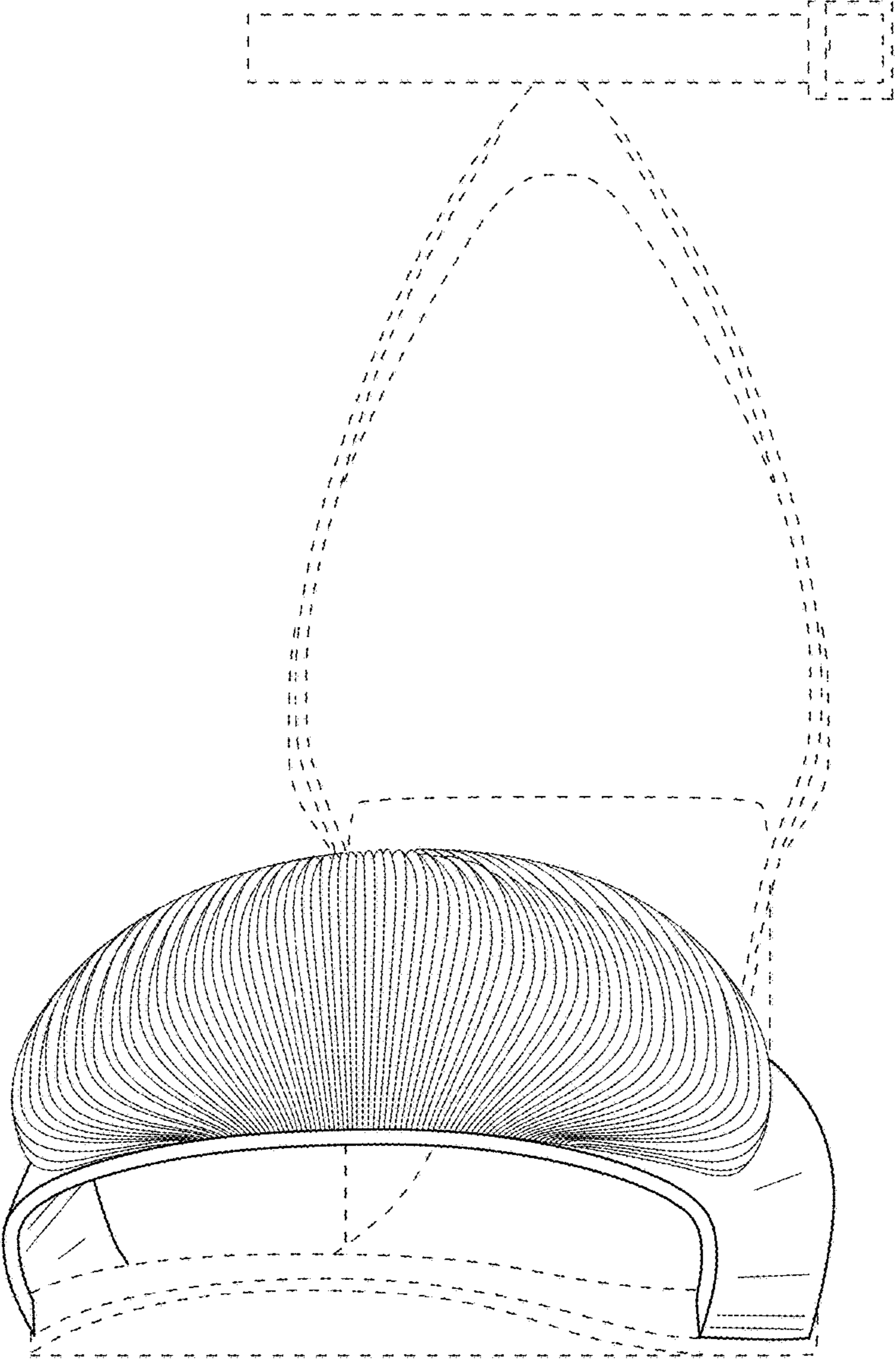

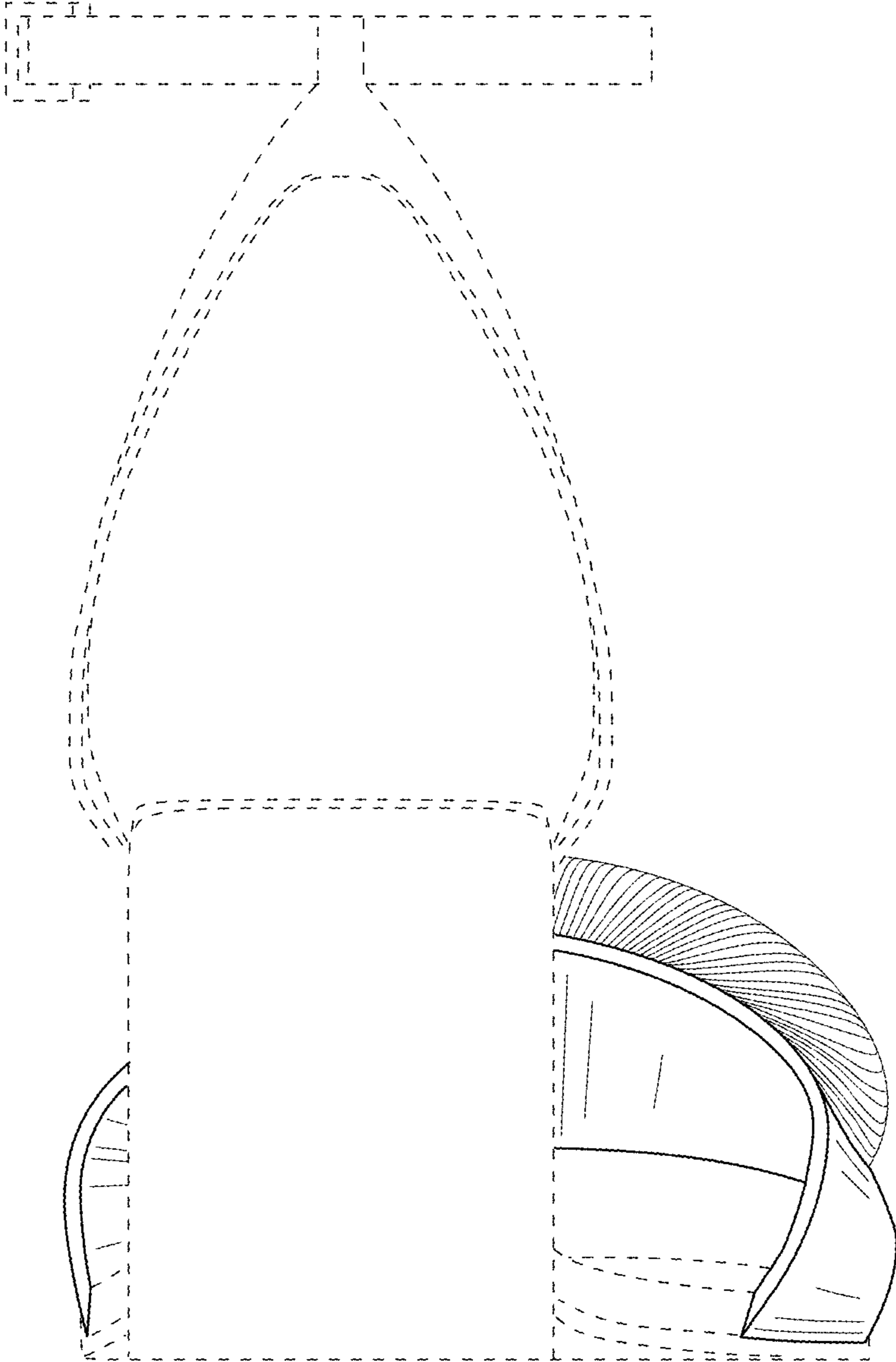
