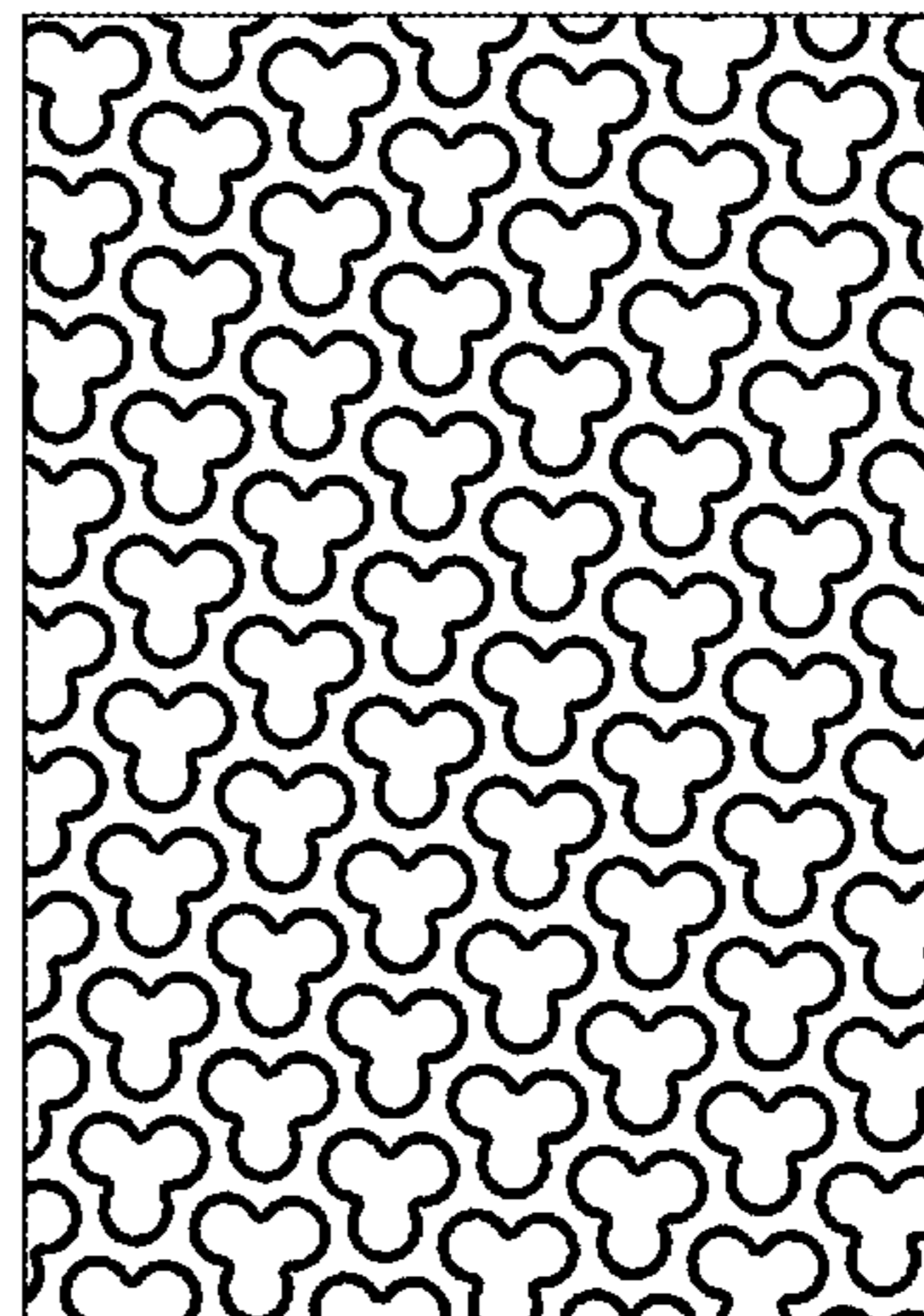
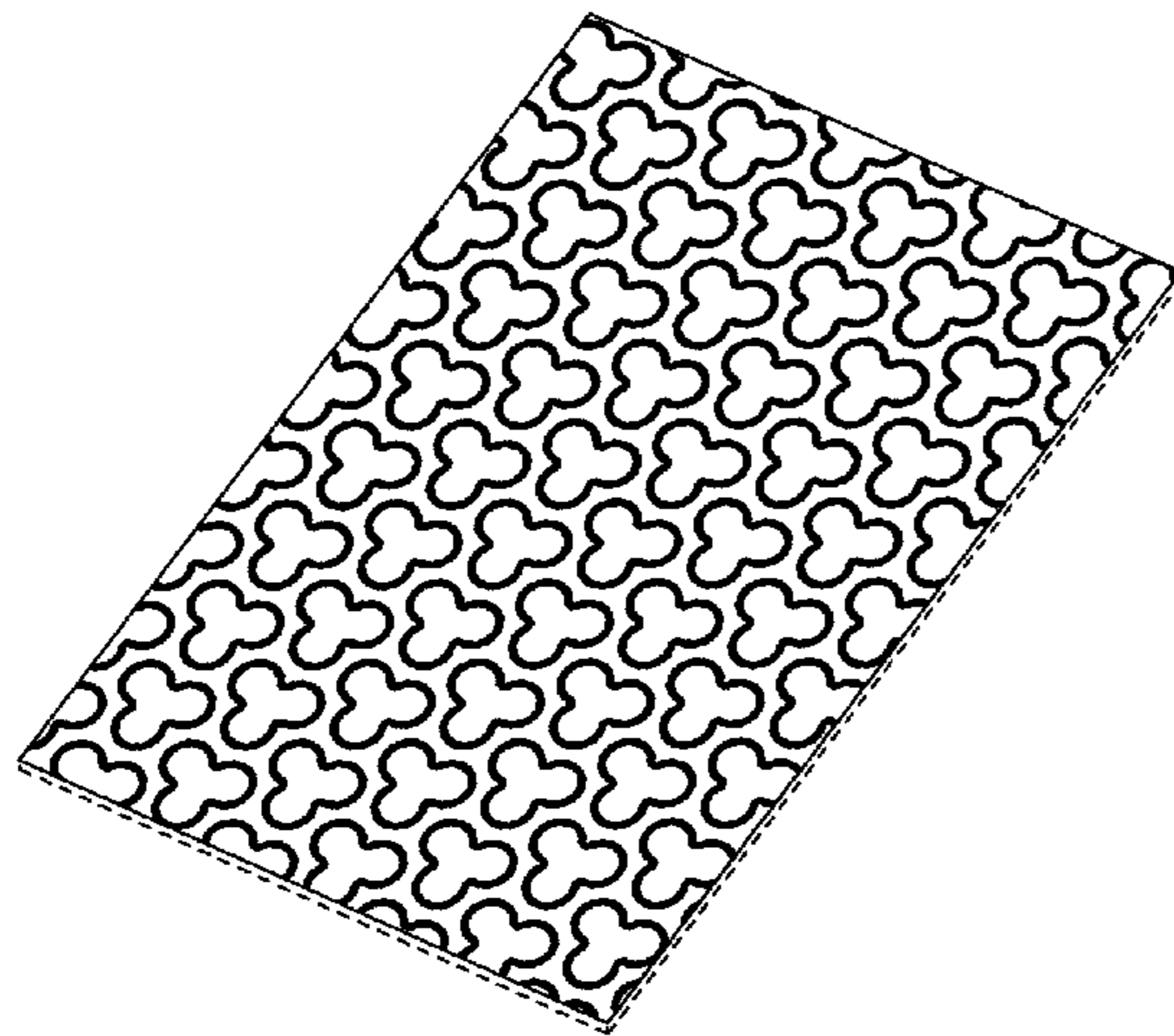
The ornamental design for a nonwoven fabric with a surface pattern, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a nonwoven fabric with a surface pattern, showing our new design; FIG. 2 is a top view thereof; FIG. 3 is a bottom view thereof; FIG. 4 is a left side view thereof; FIG. 5 is a right side view thereof; FIG. 6 is a front view thereof; and, FIG. 7 is a back view thereof.

The broken lines in FIGS. 1 and 3-7 depict portions of the nonwoven fabric with a surface pattern that form no part of the claimed design.

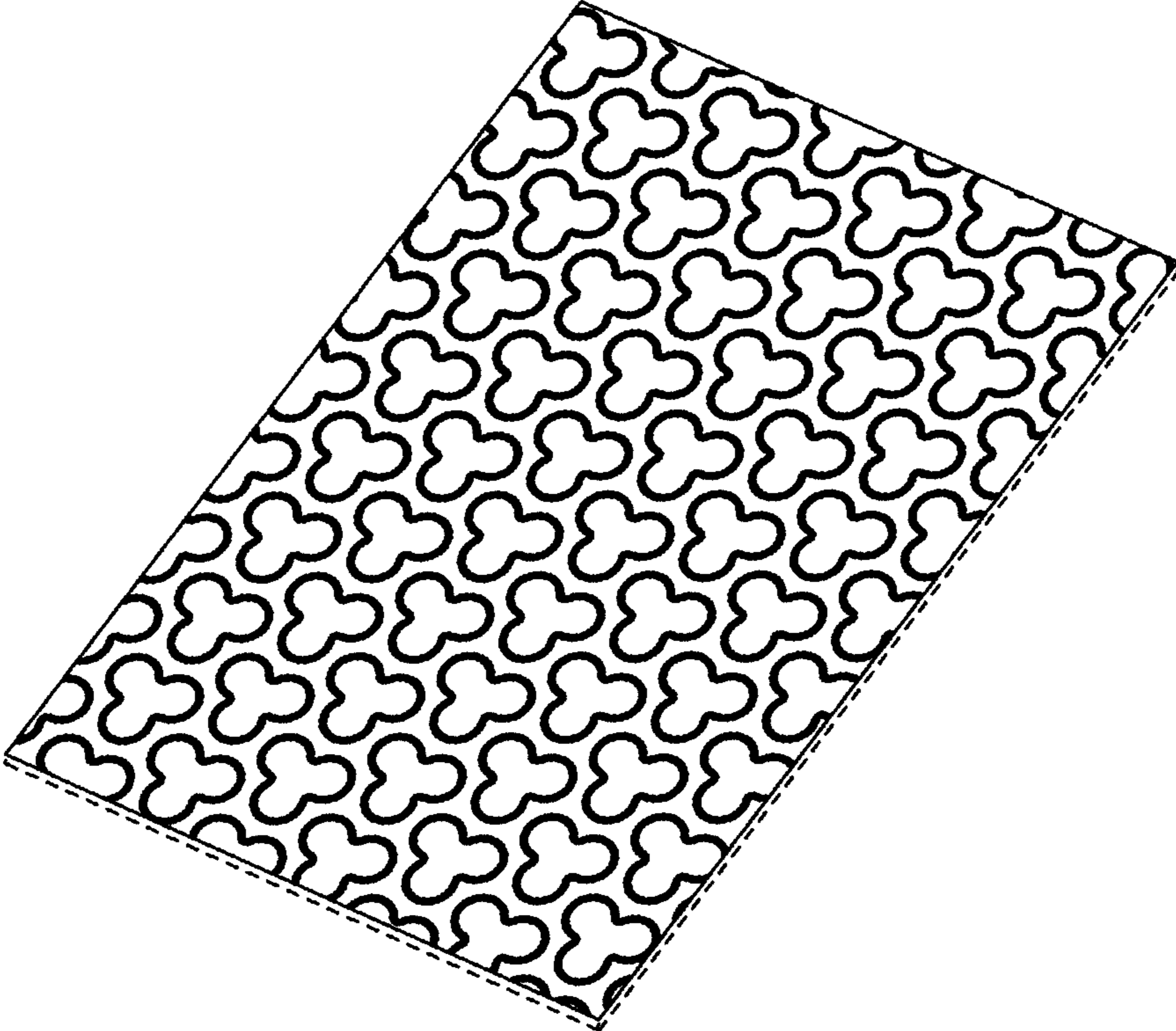

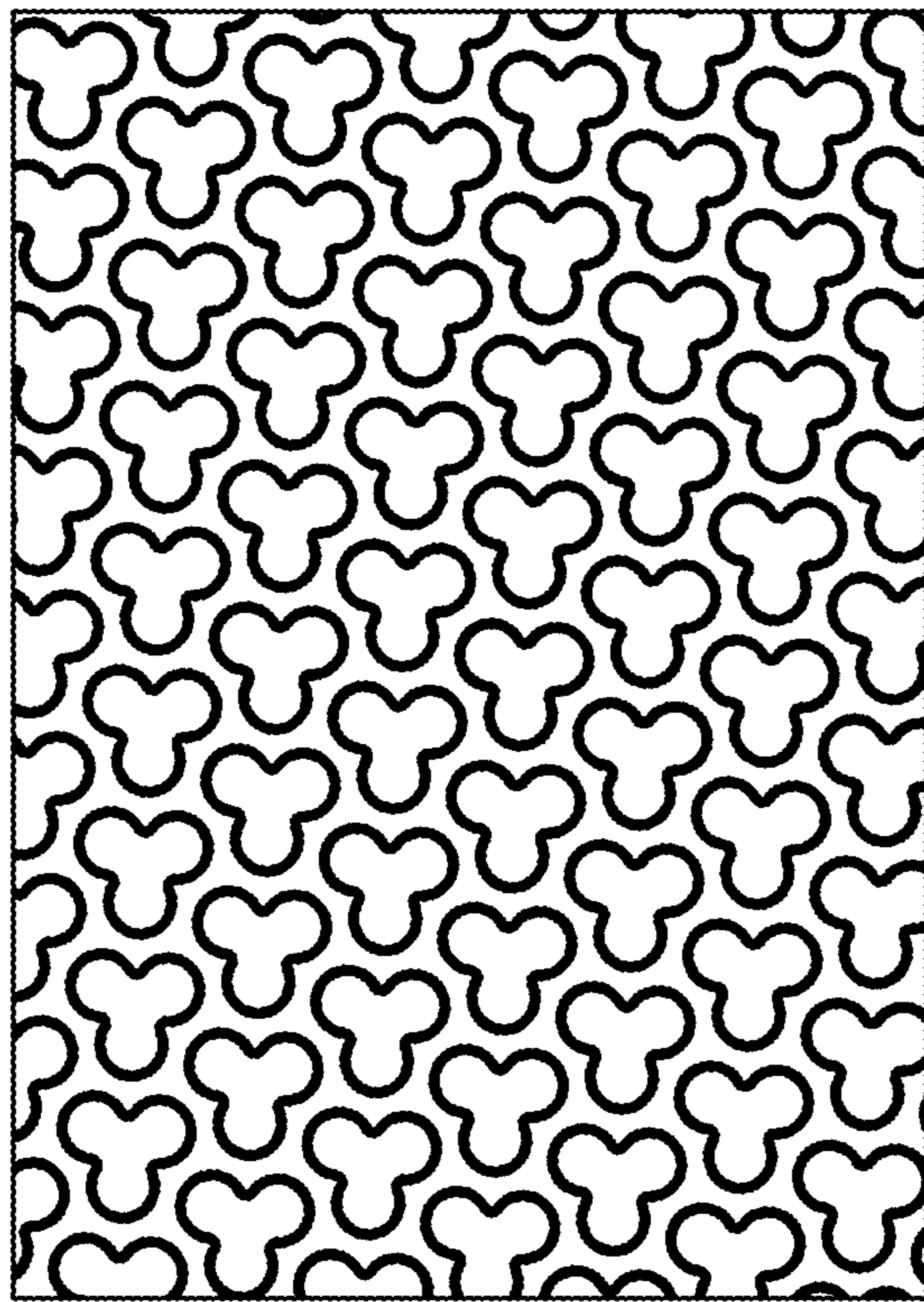

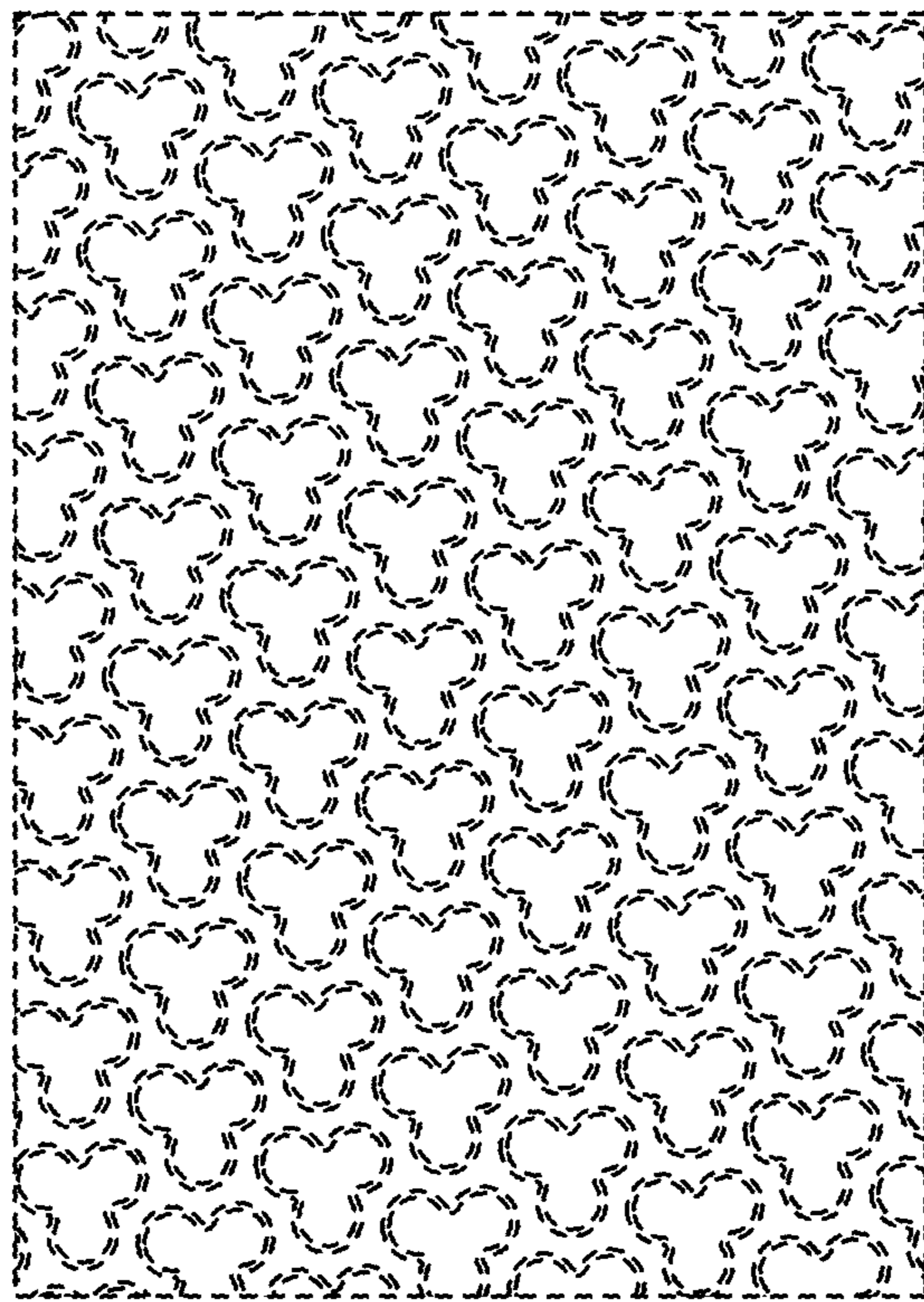

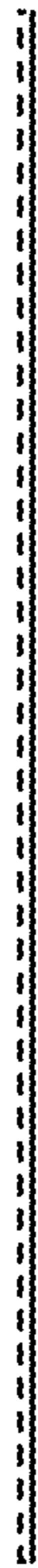

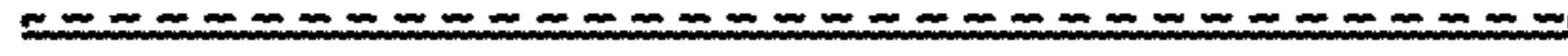
