The ornamental design for a water bottle, as shown and described.

DESCRIPTION

FIG. 1 is a front isometric view of a water bottle showing our new design;

FIG. 4 is a left side elevational view thereof;

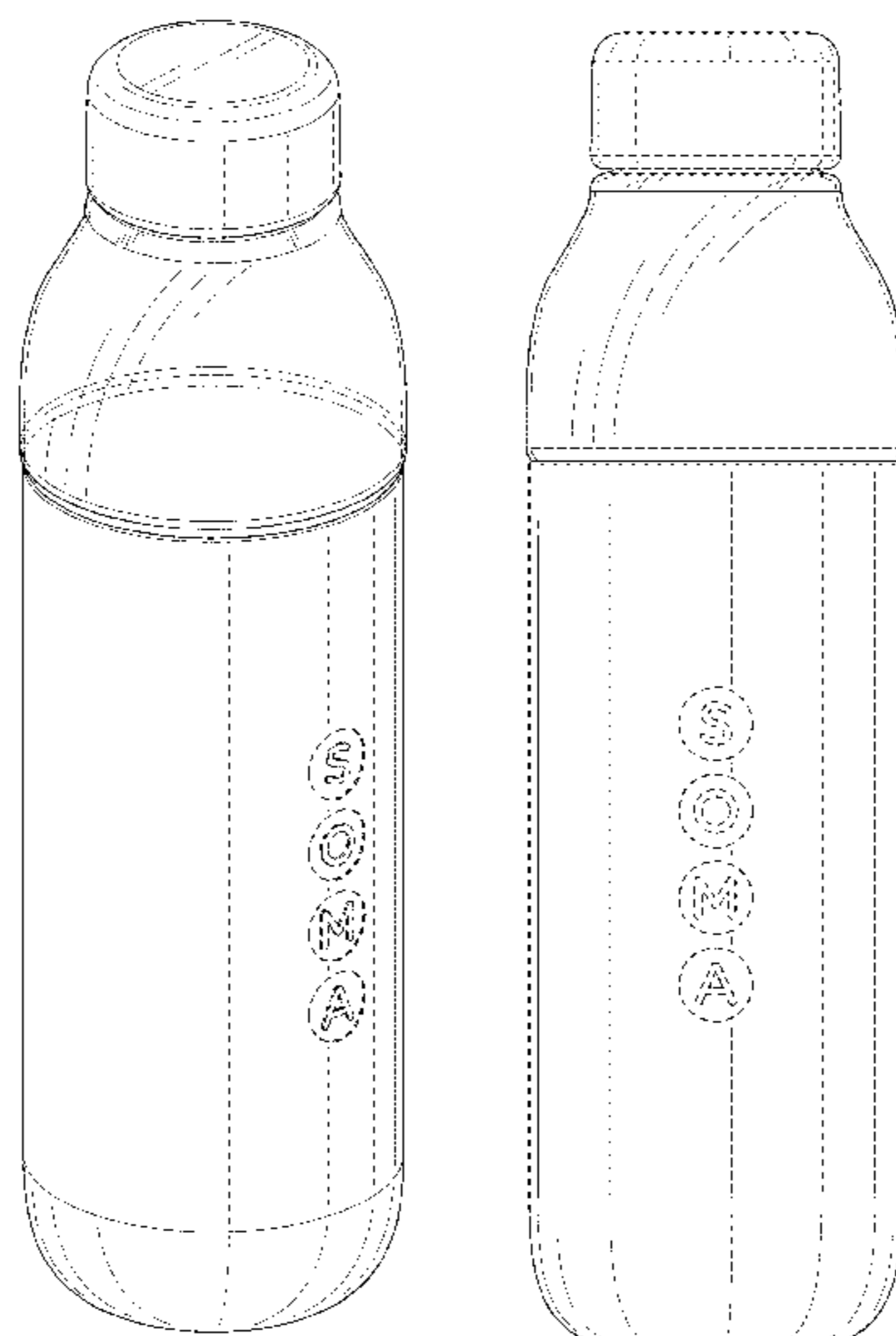
FIG. 5 is a right side elevational view thereof;

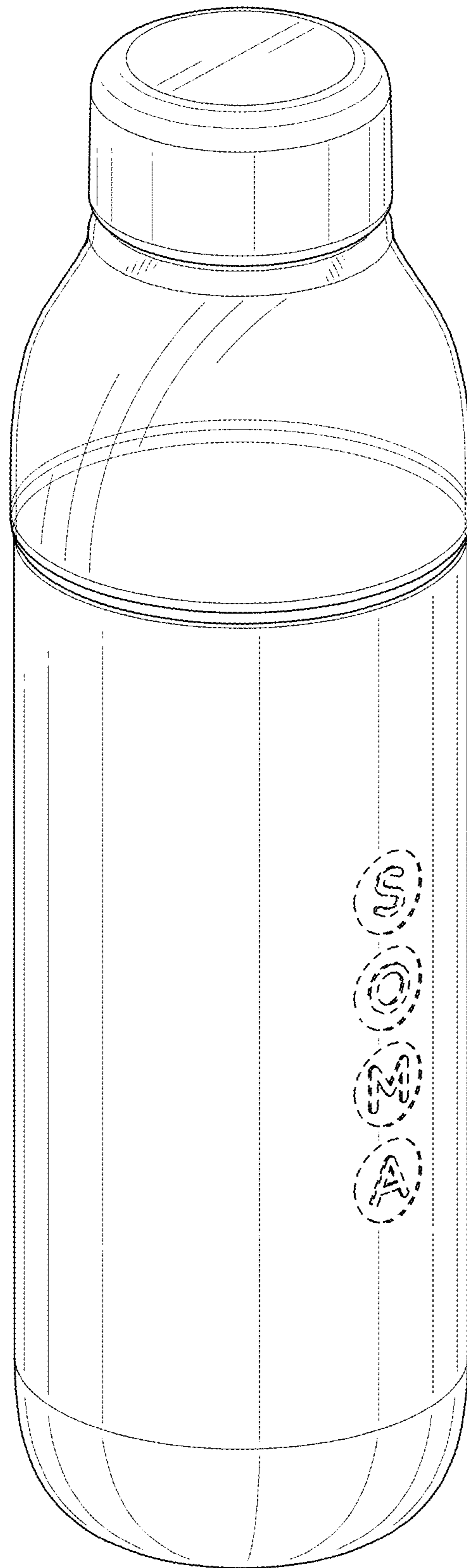

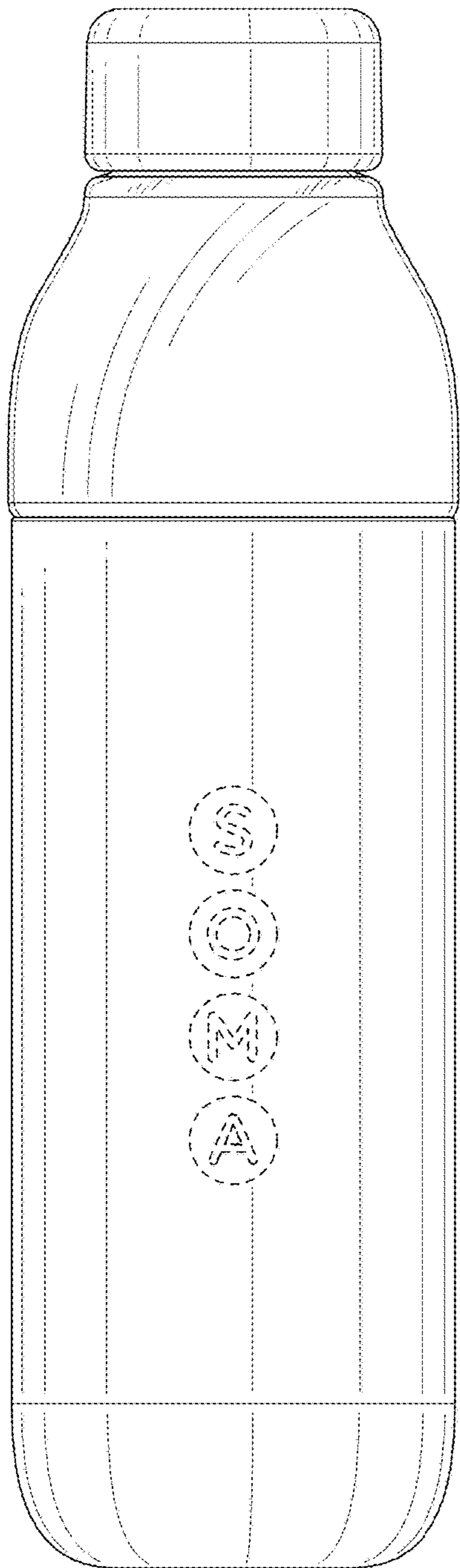

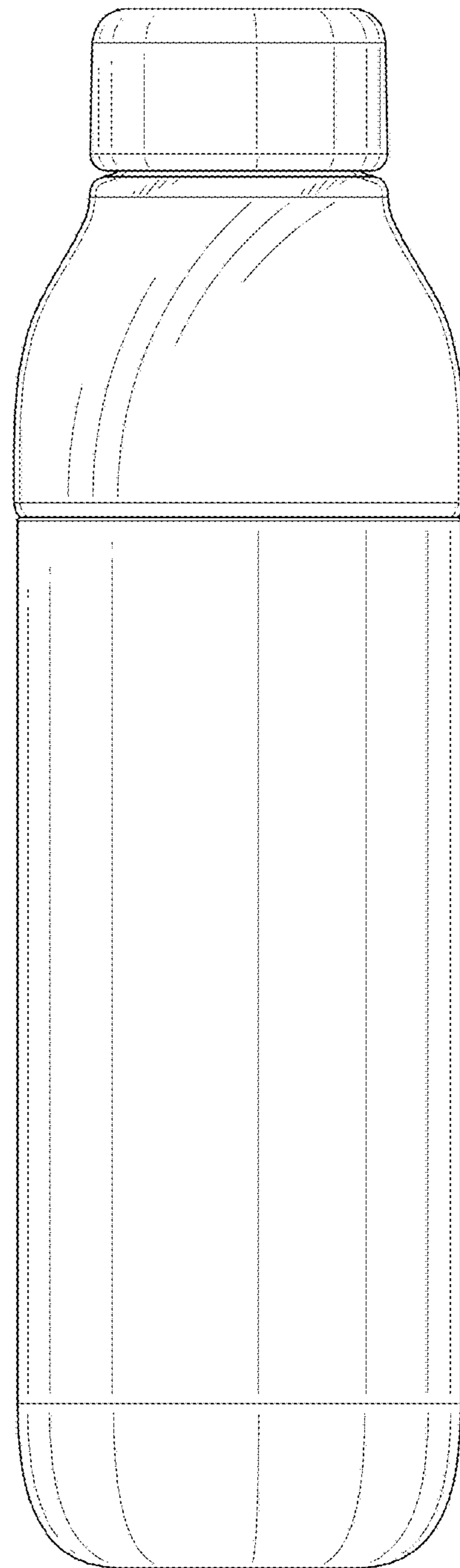

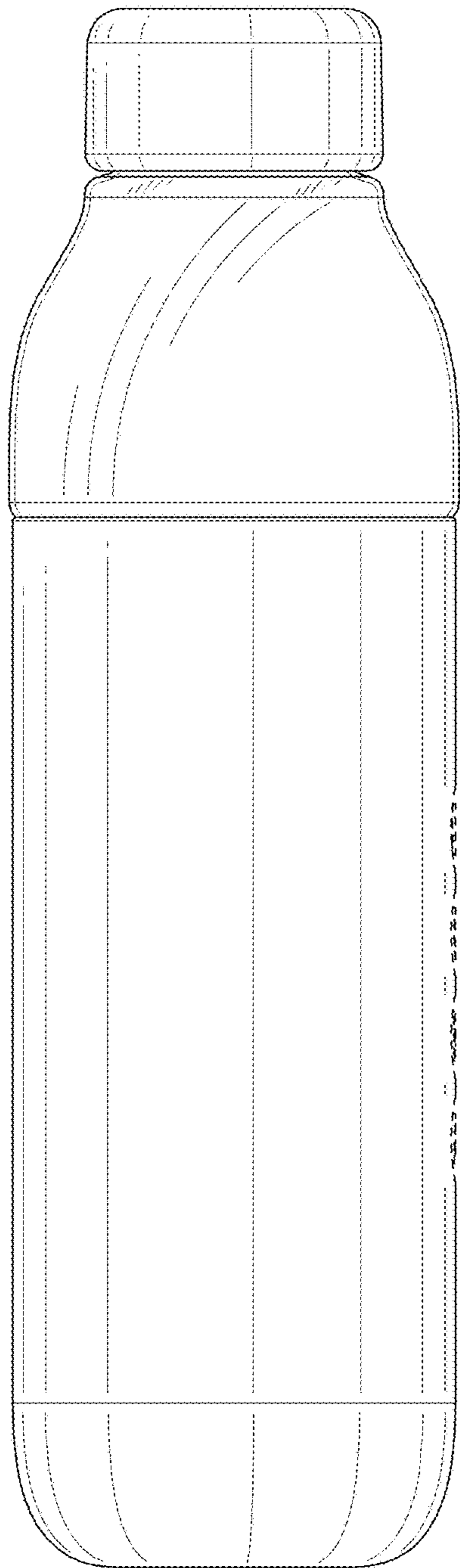

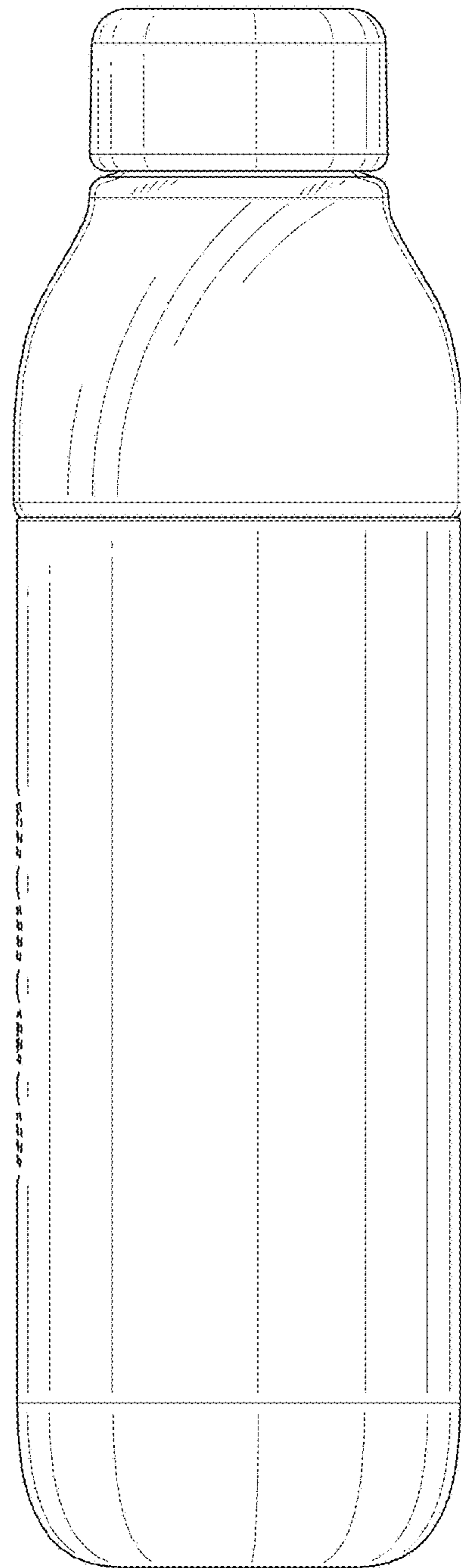

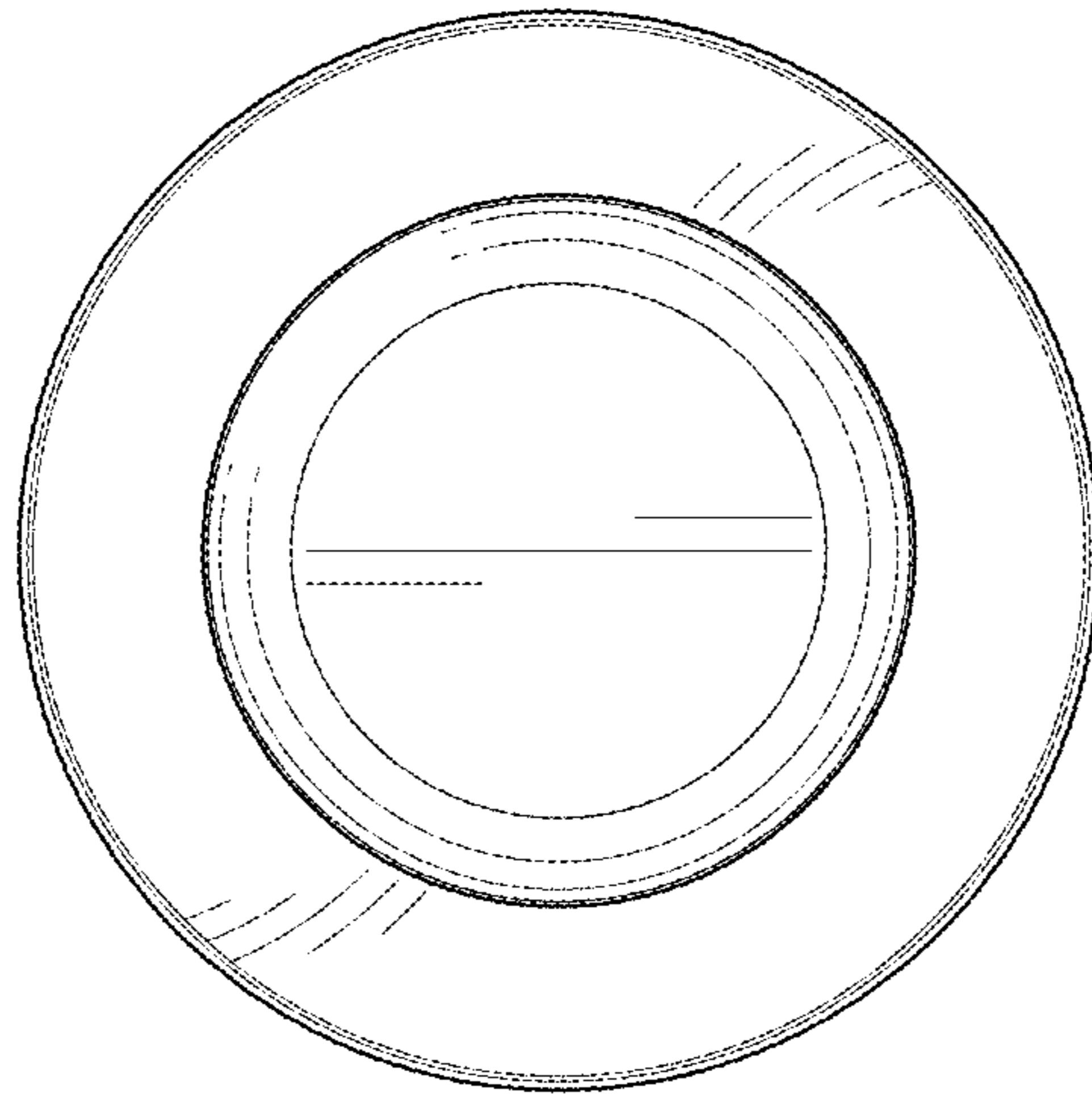

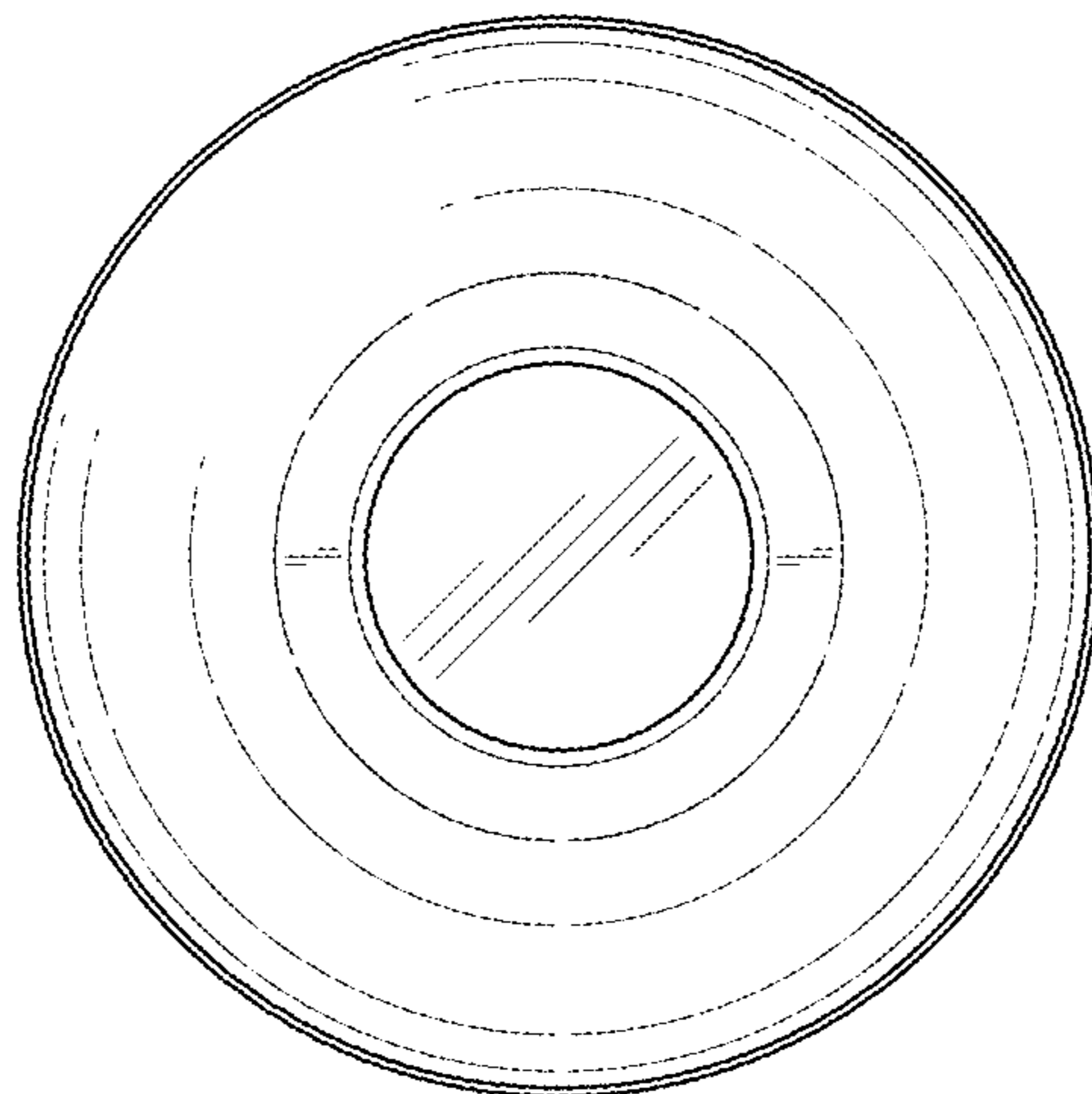
