FIG. 16 is a bottom plan view of the wearable band for facilitating hearing of FIG. 11.

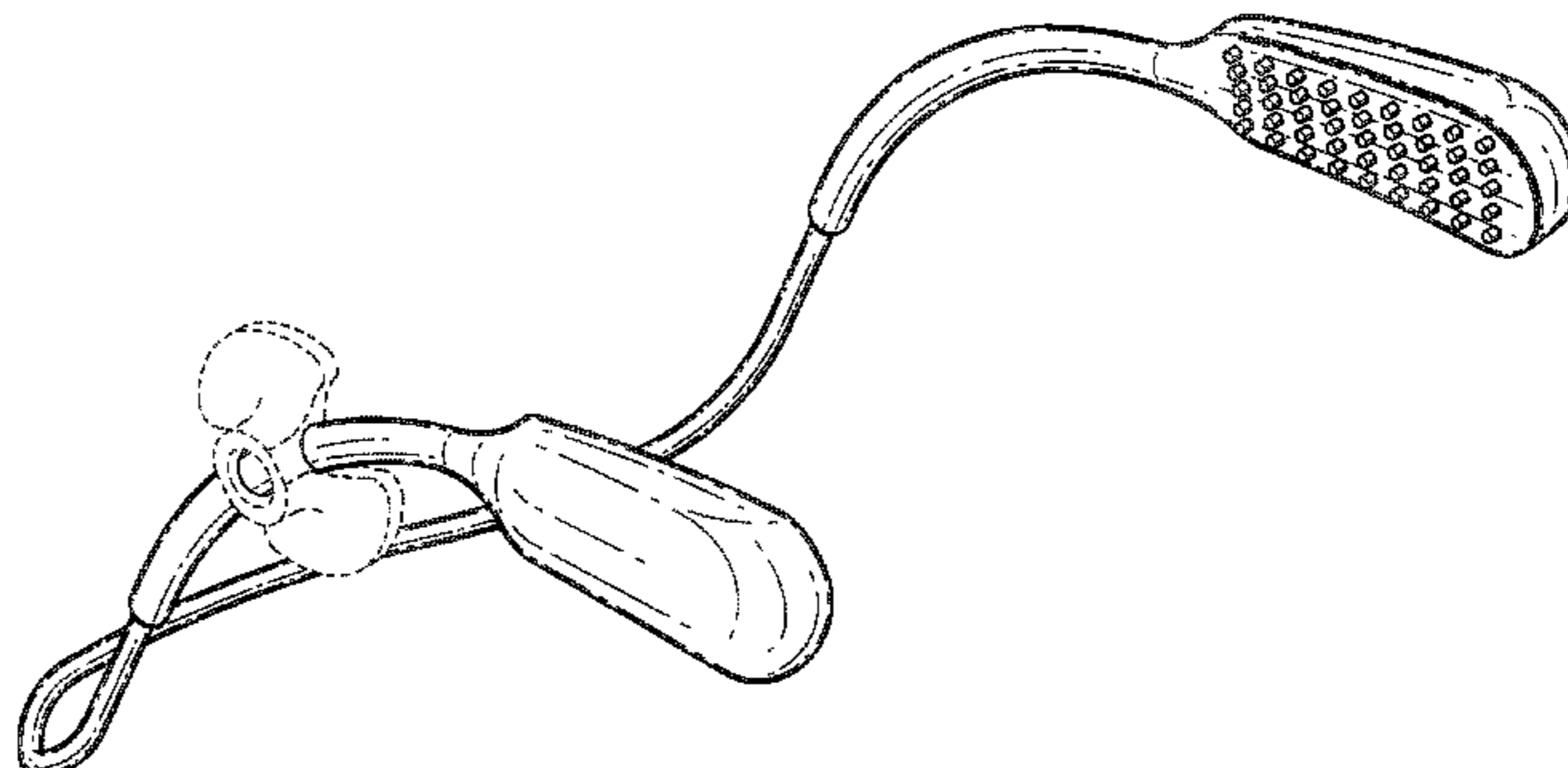
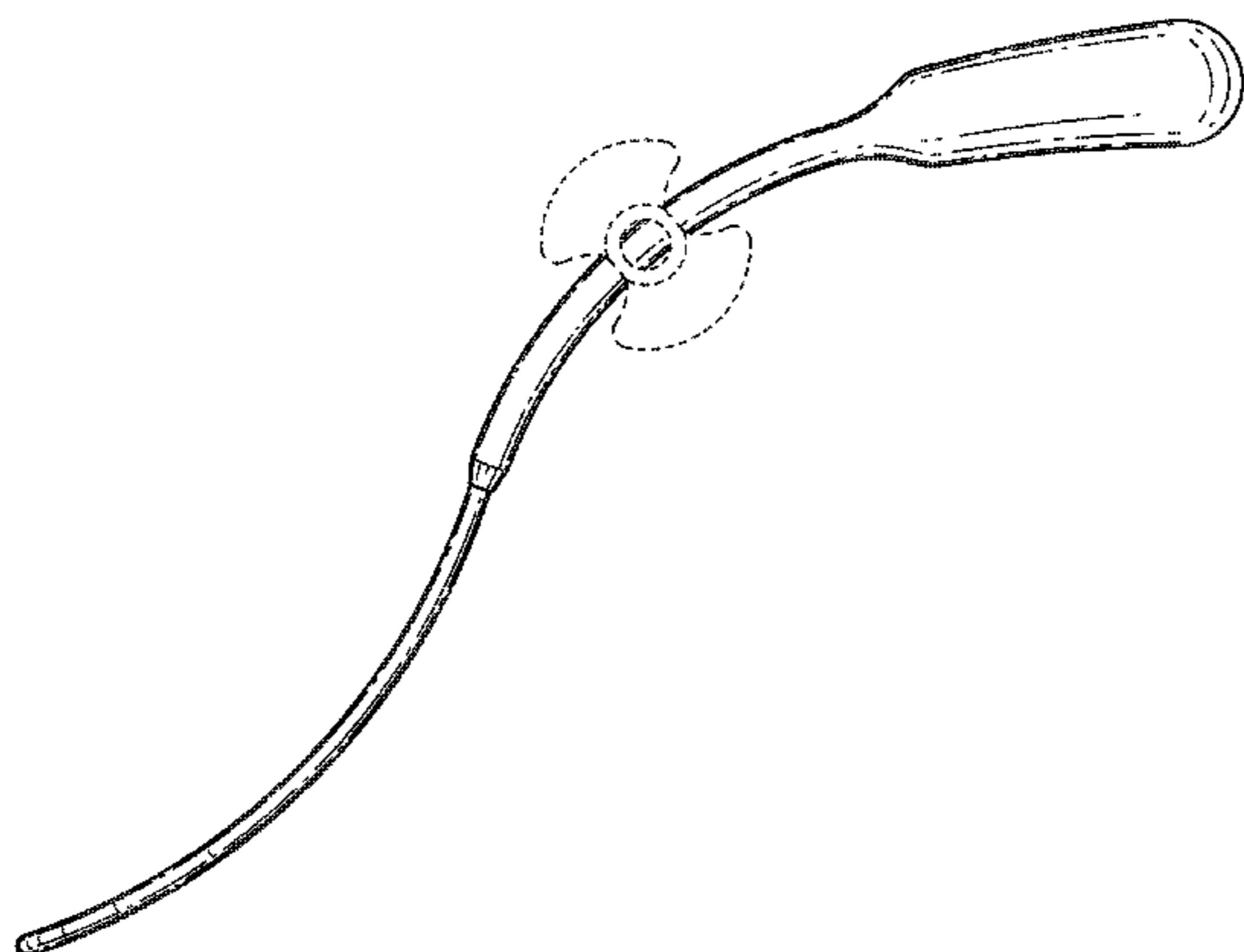
FIG. 17 is a first front perspective view of the wearable band for facilitating hearing of FIG. 11.

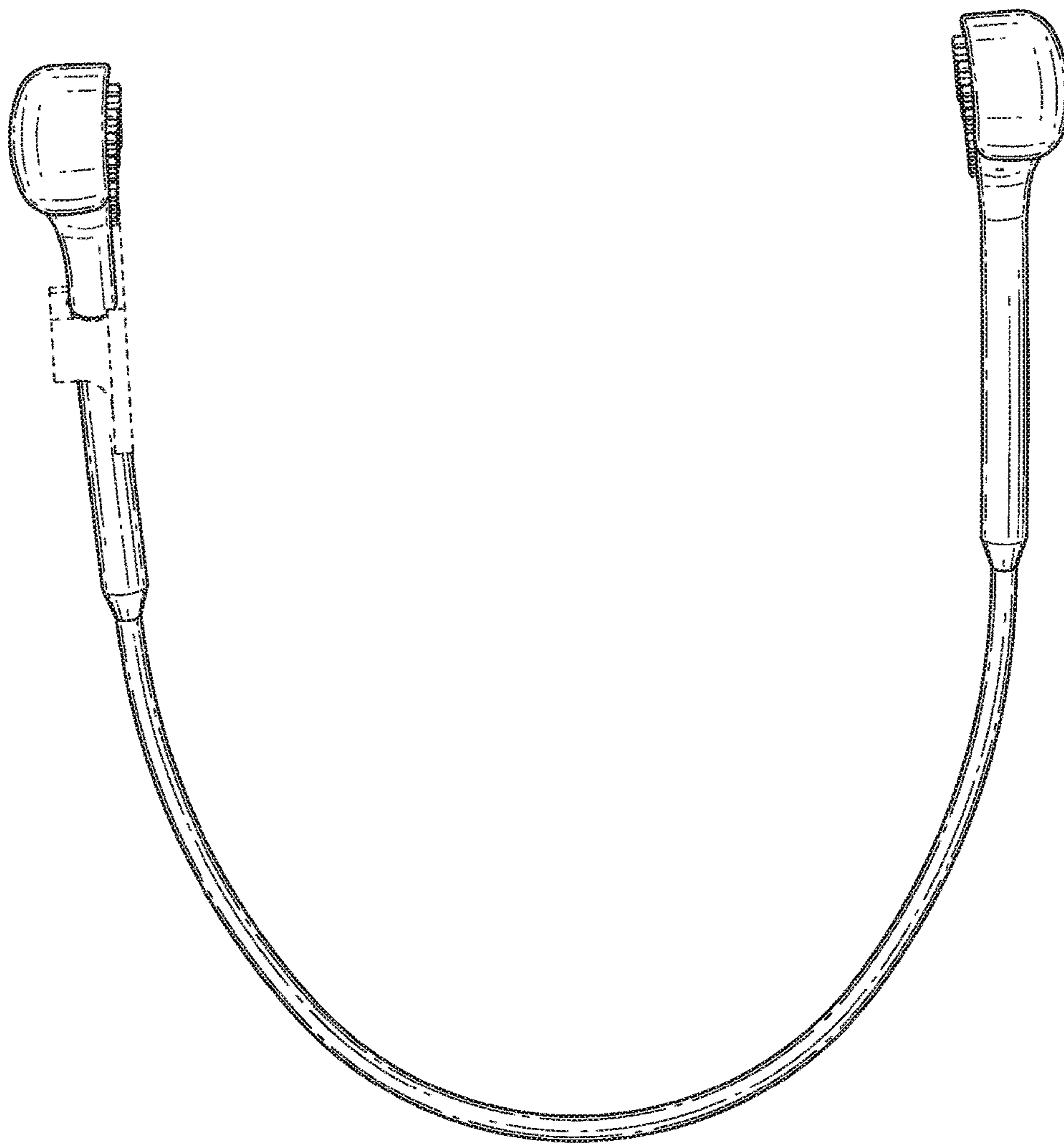

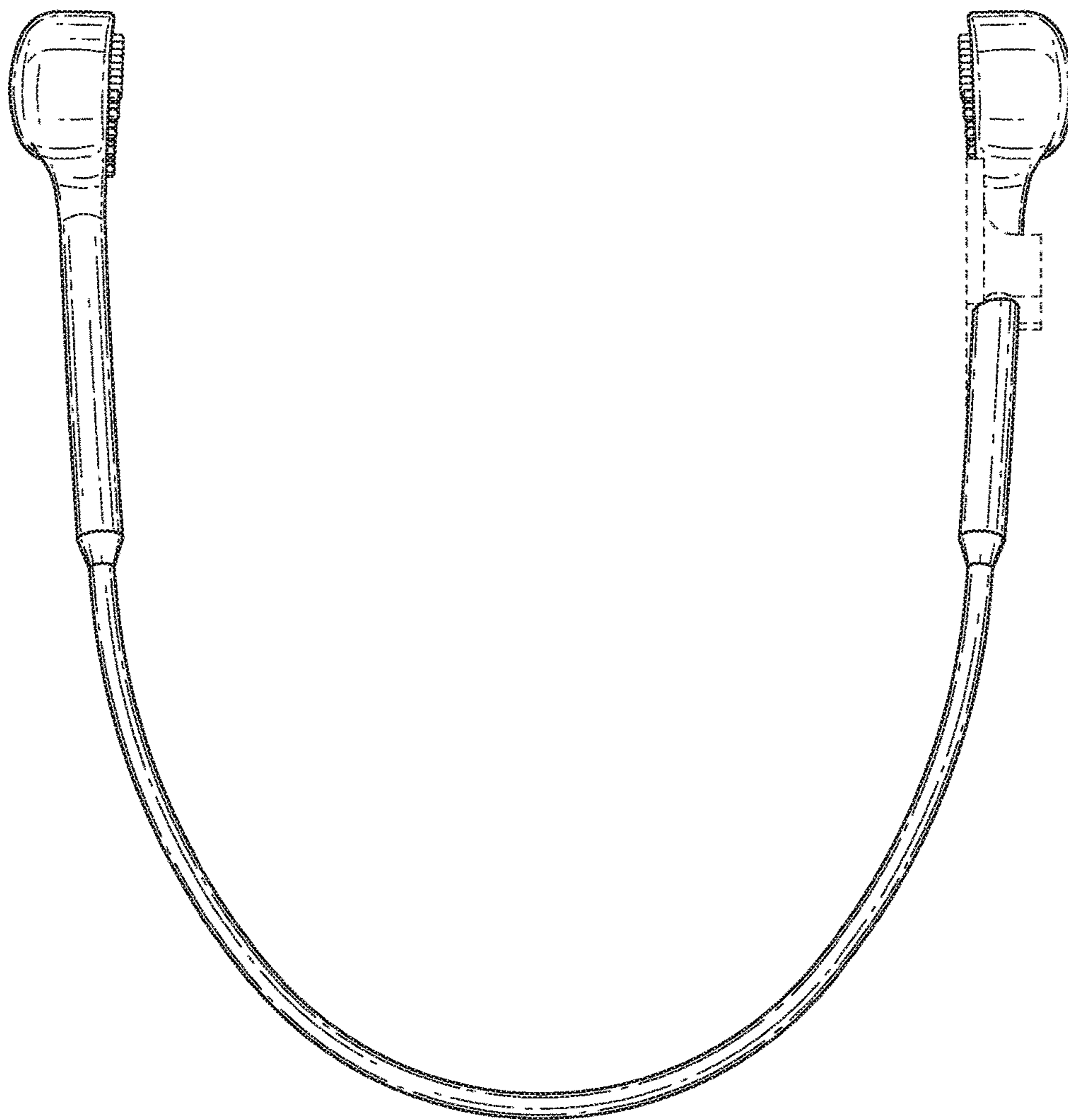

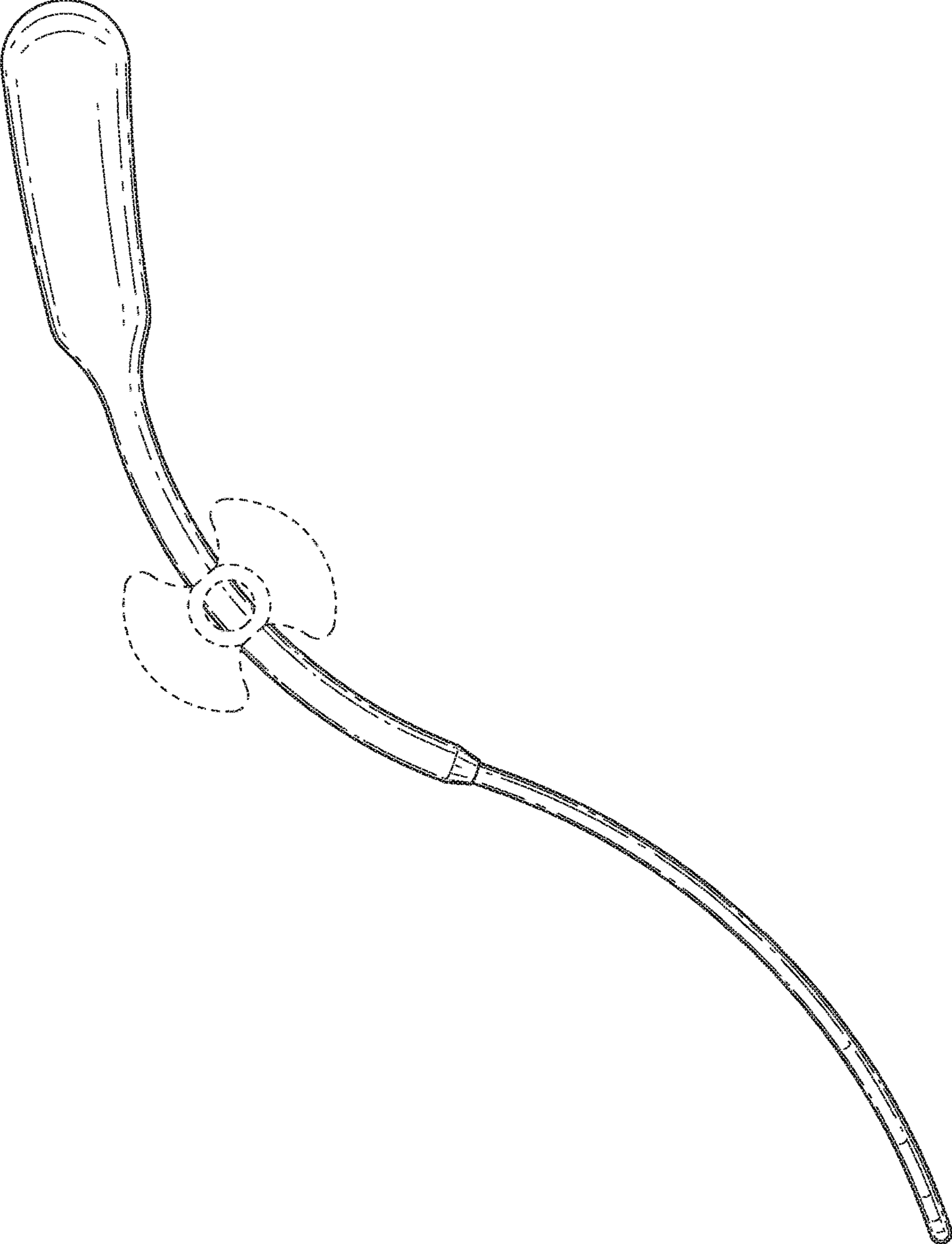
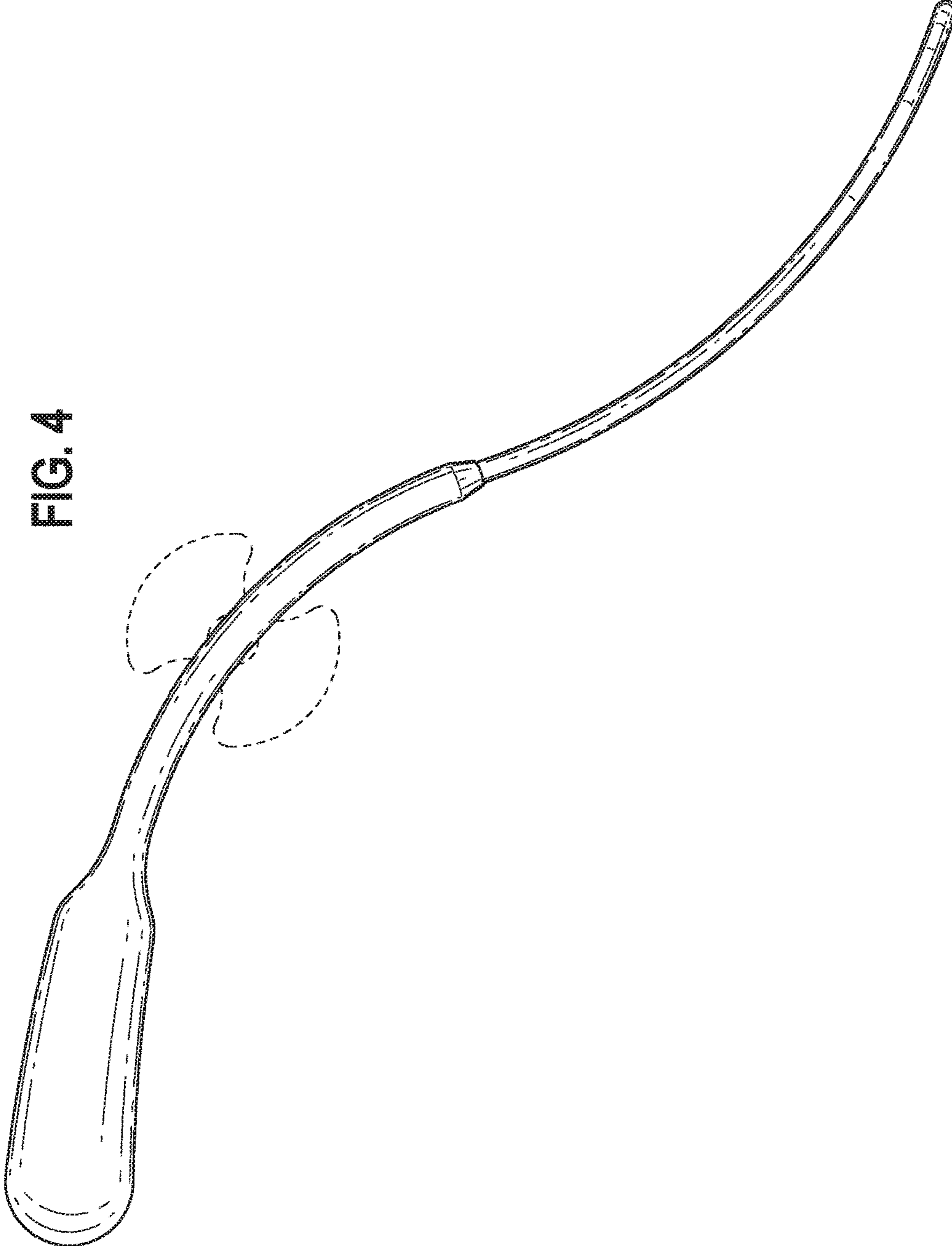
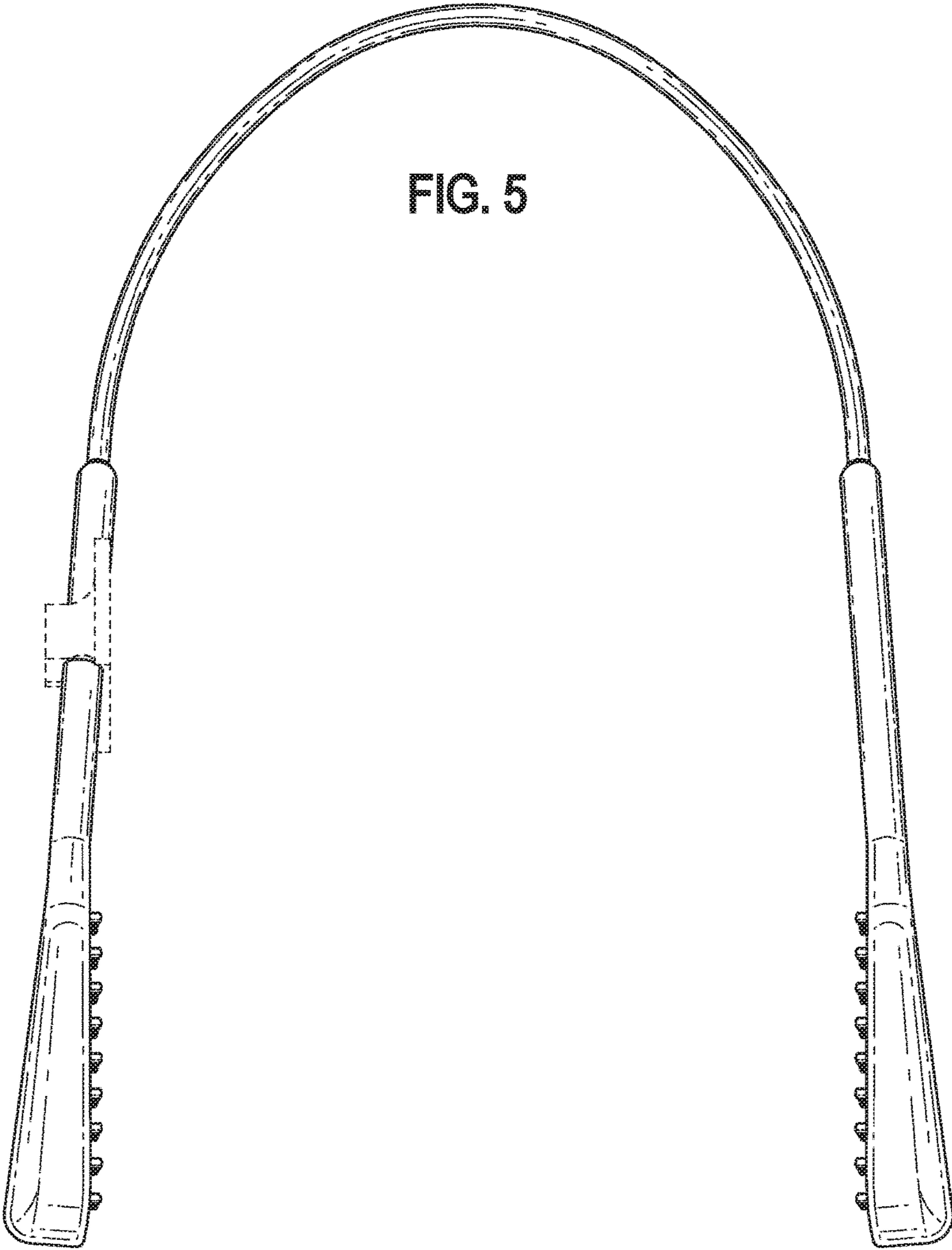

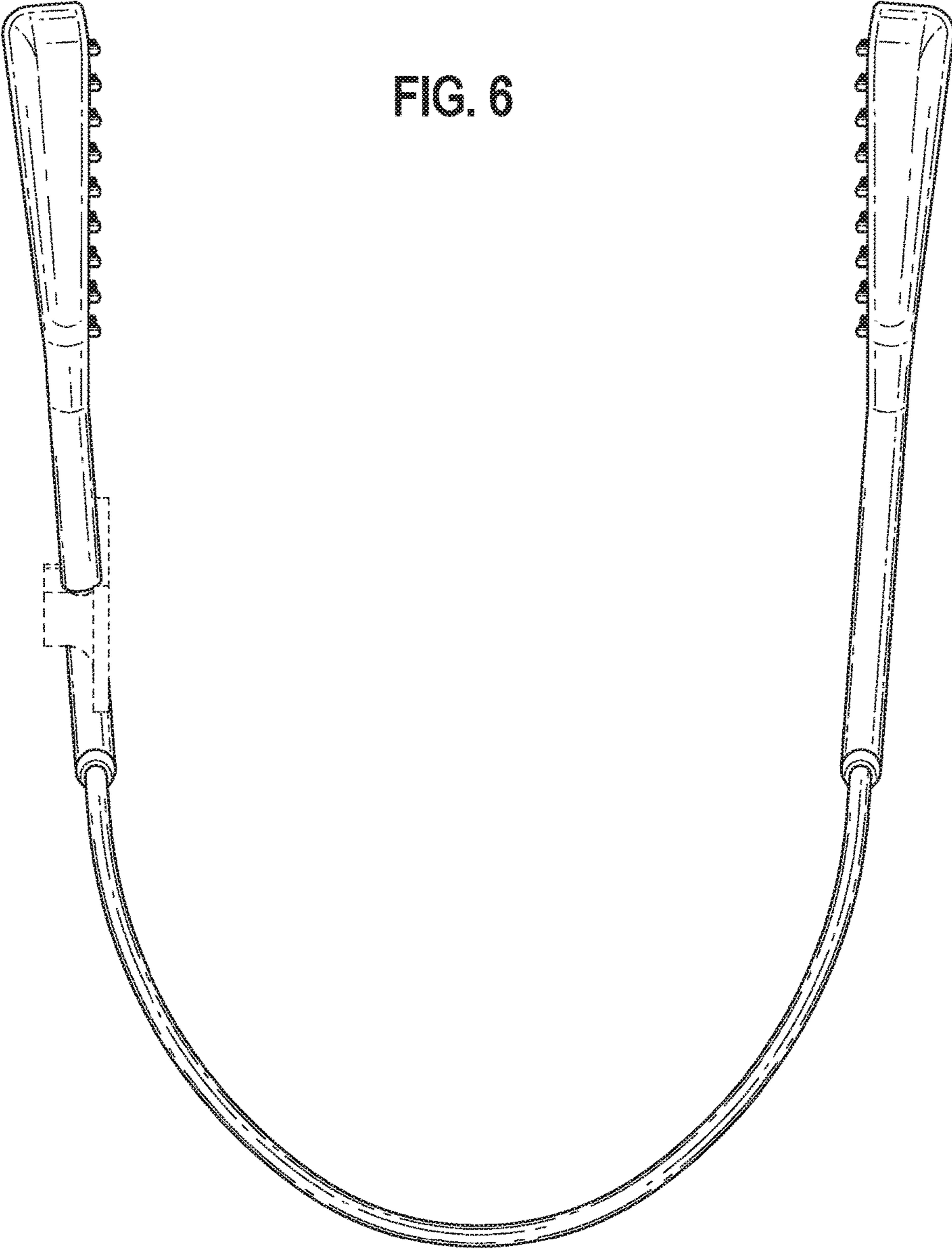
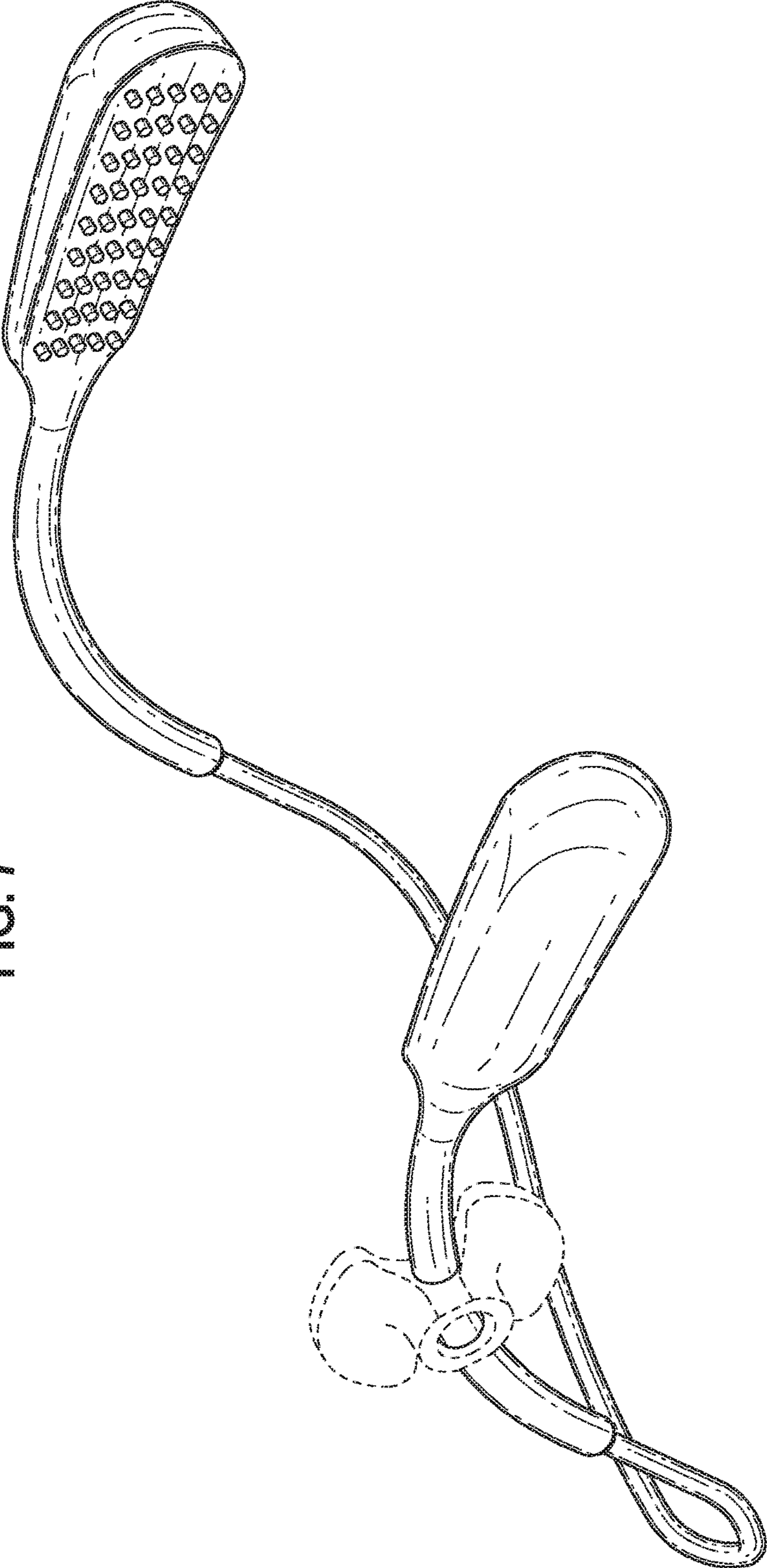

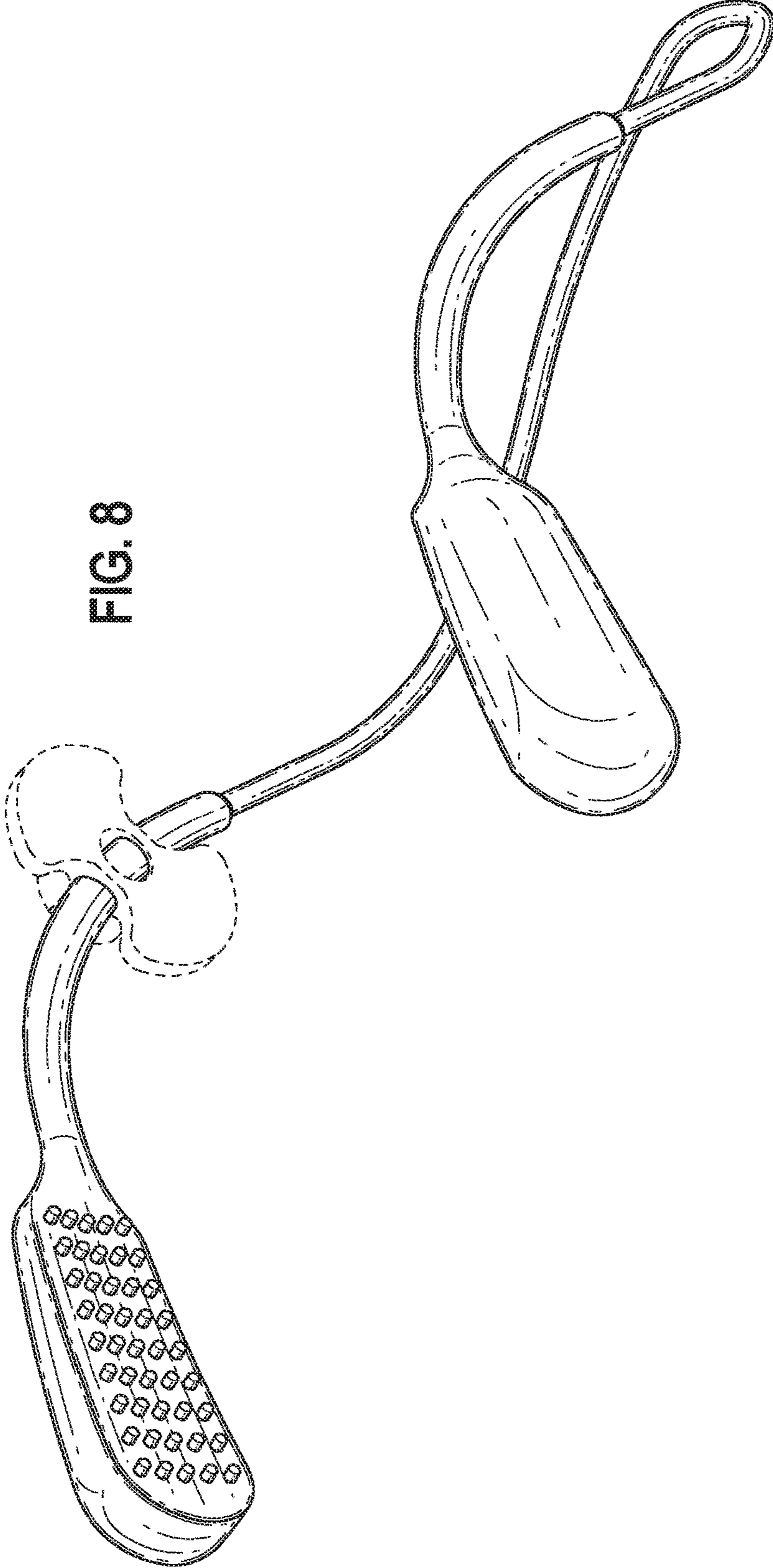

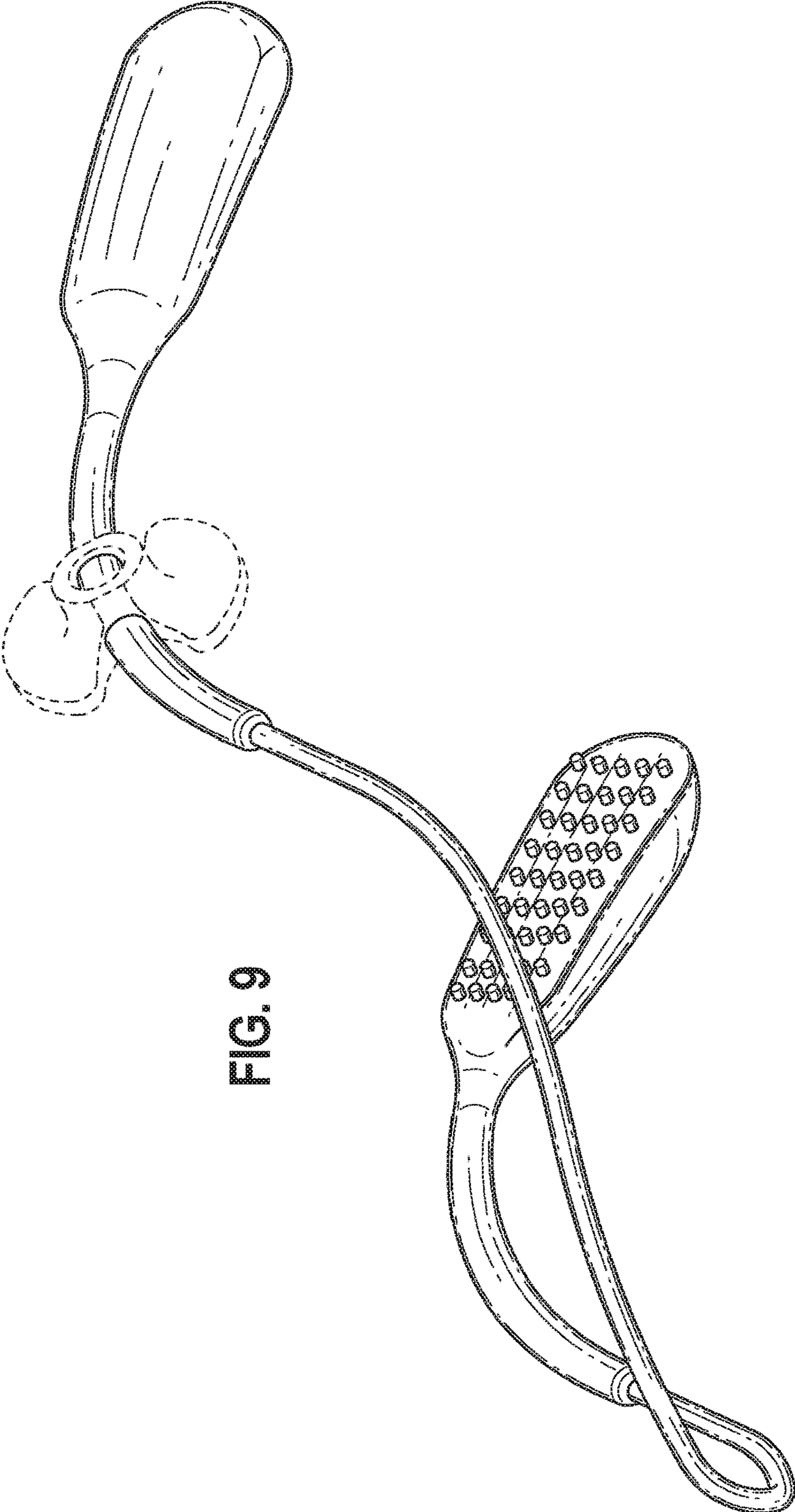

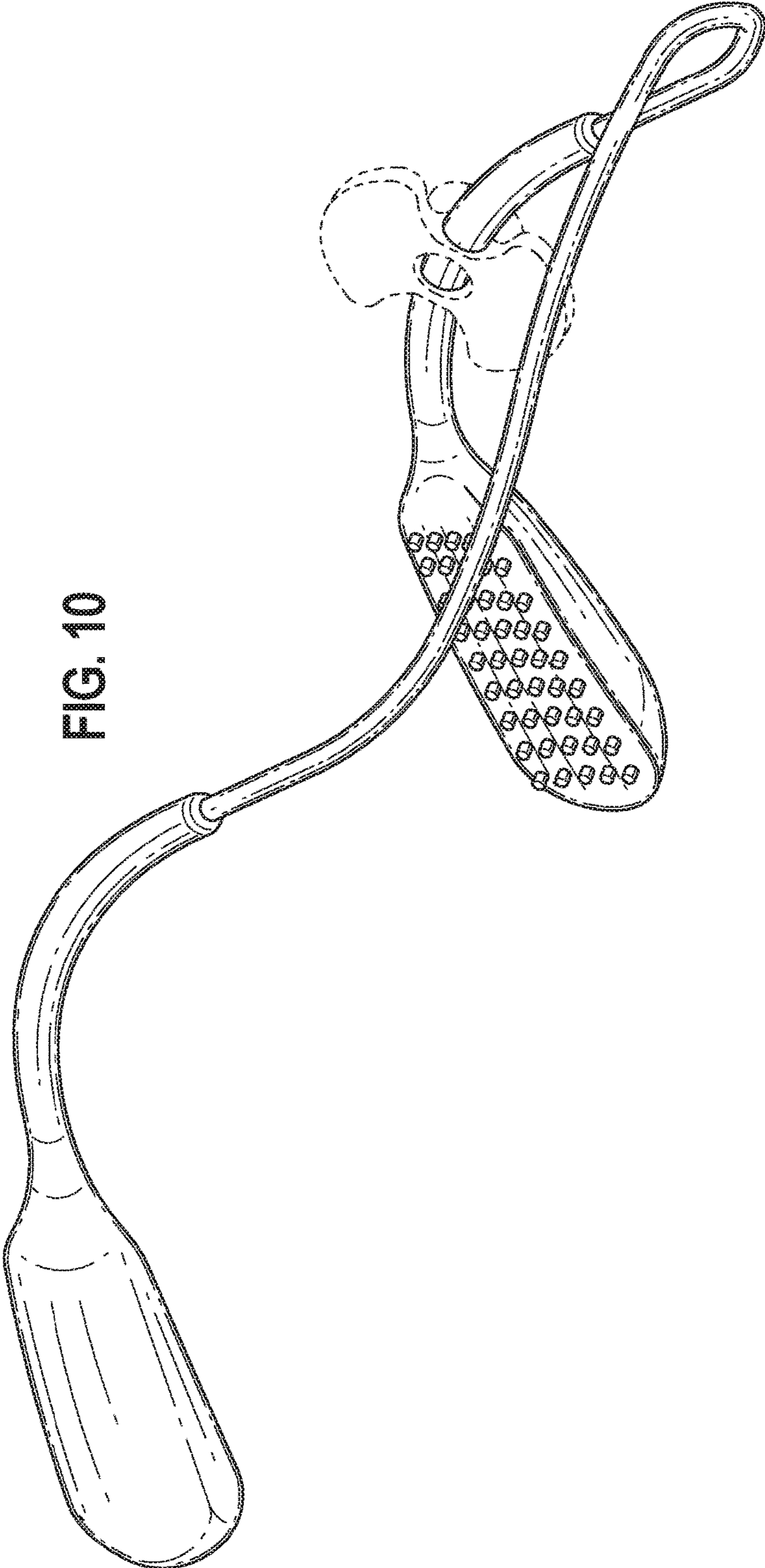

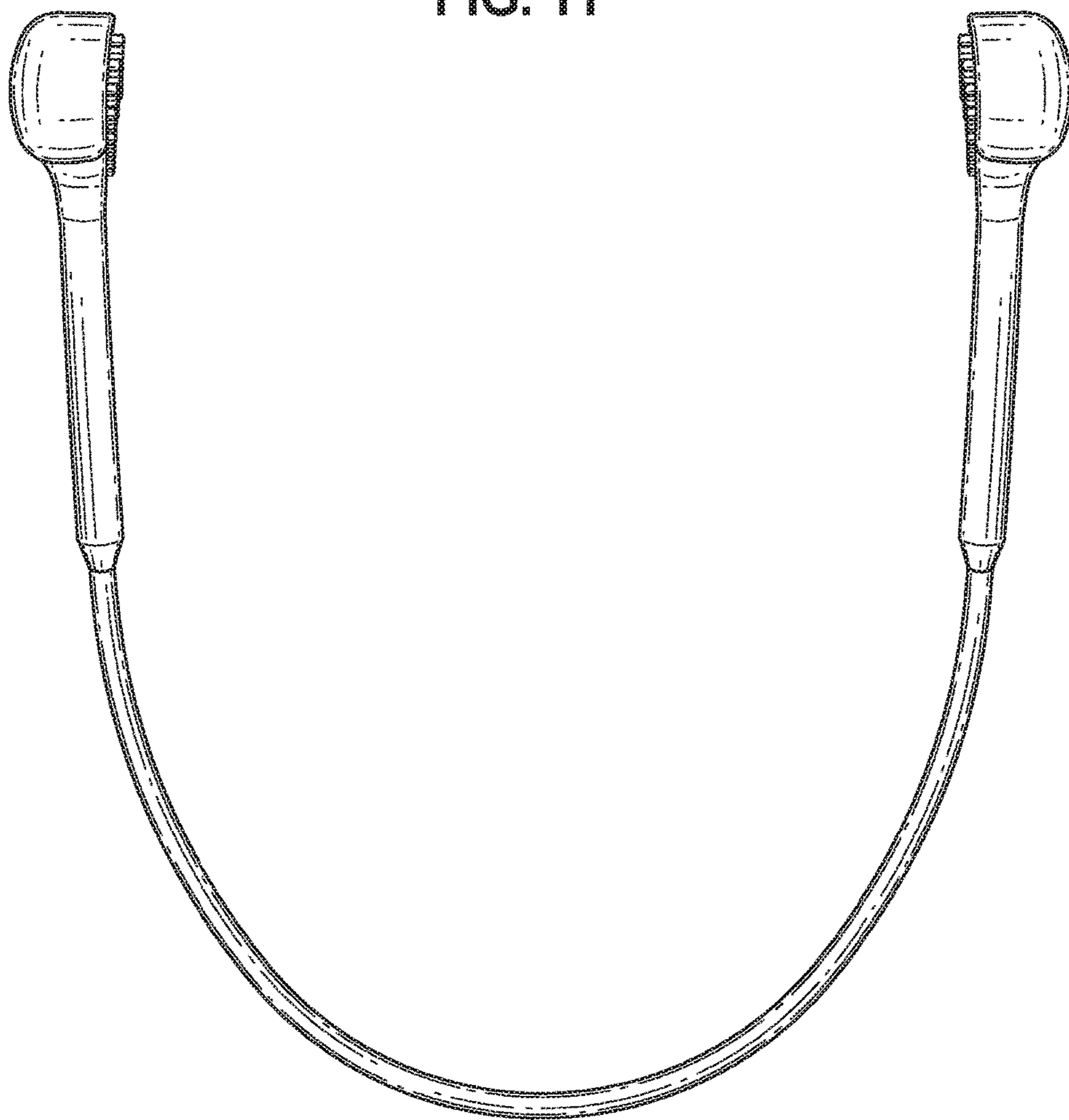
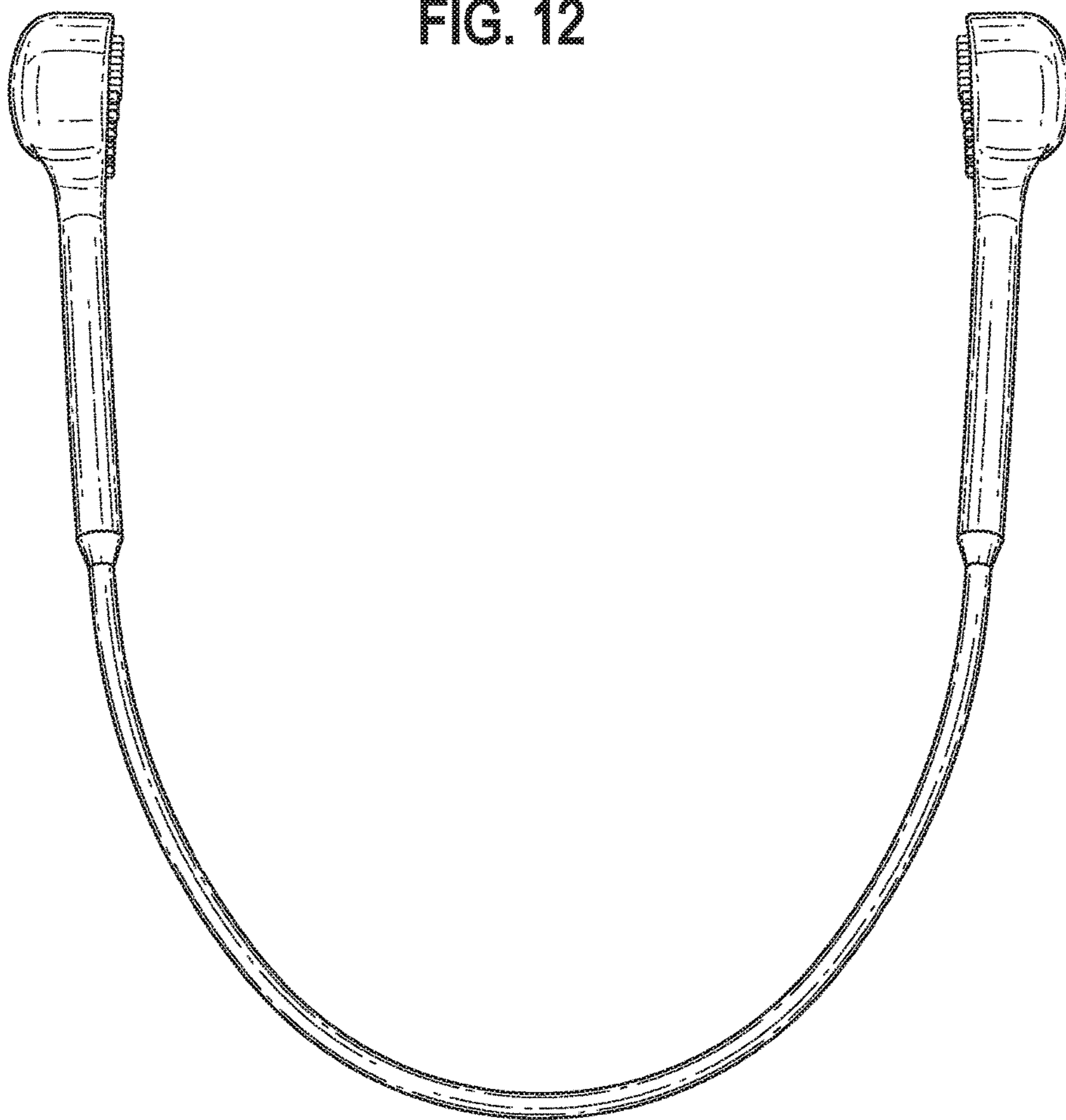

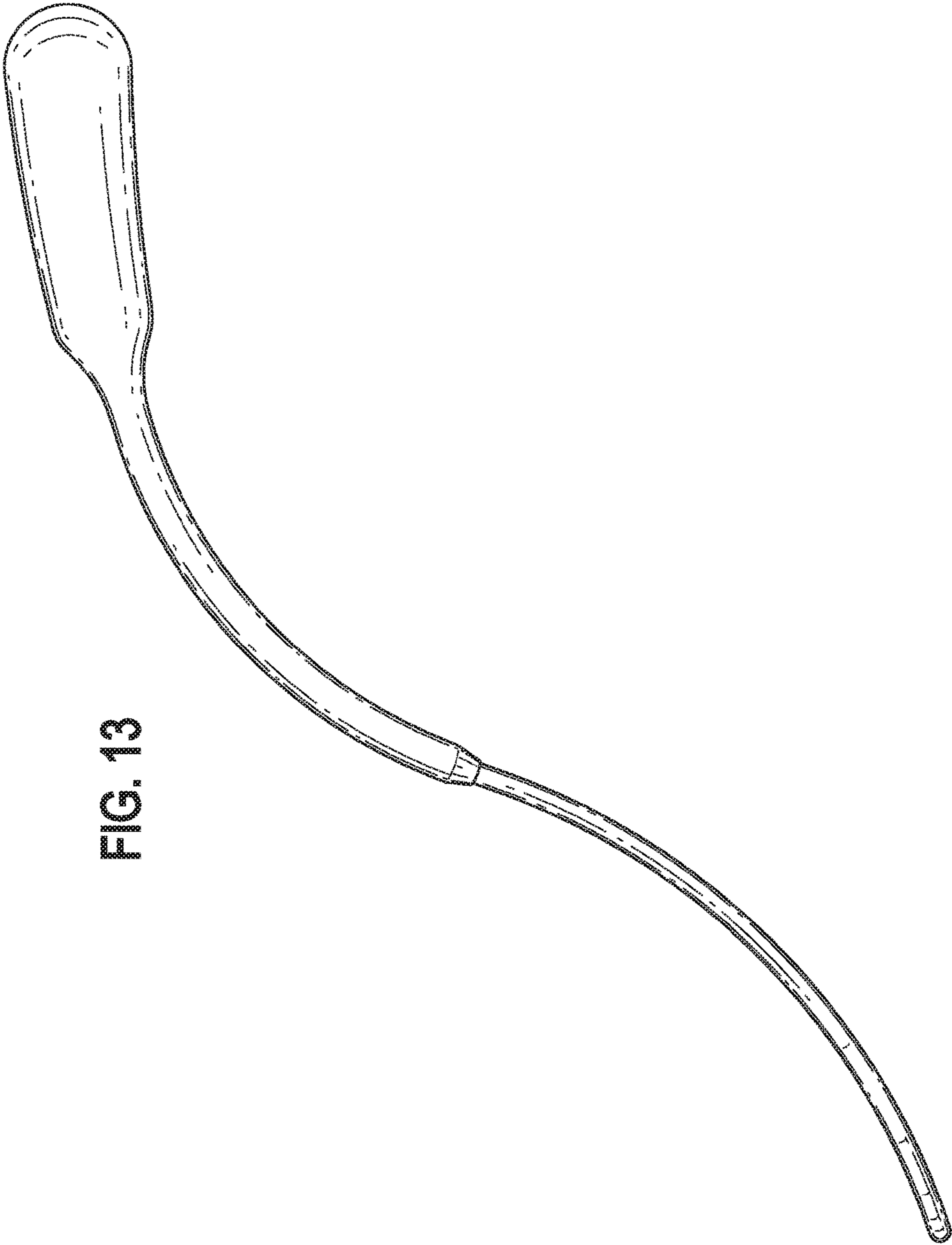

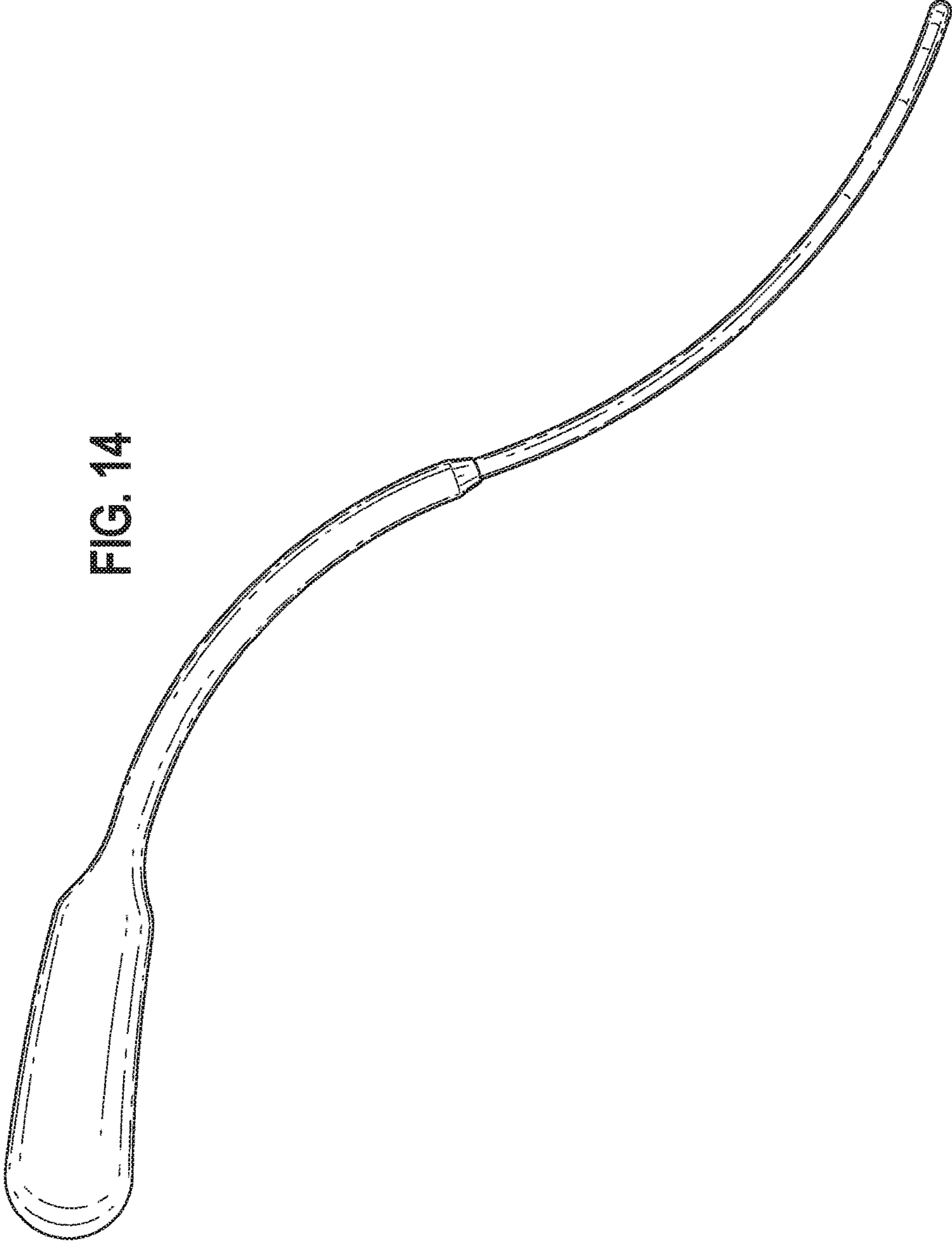

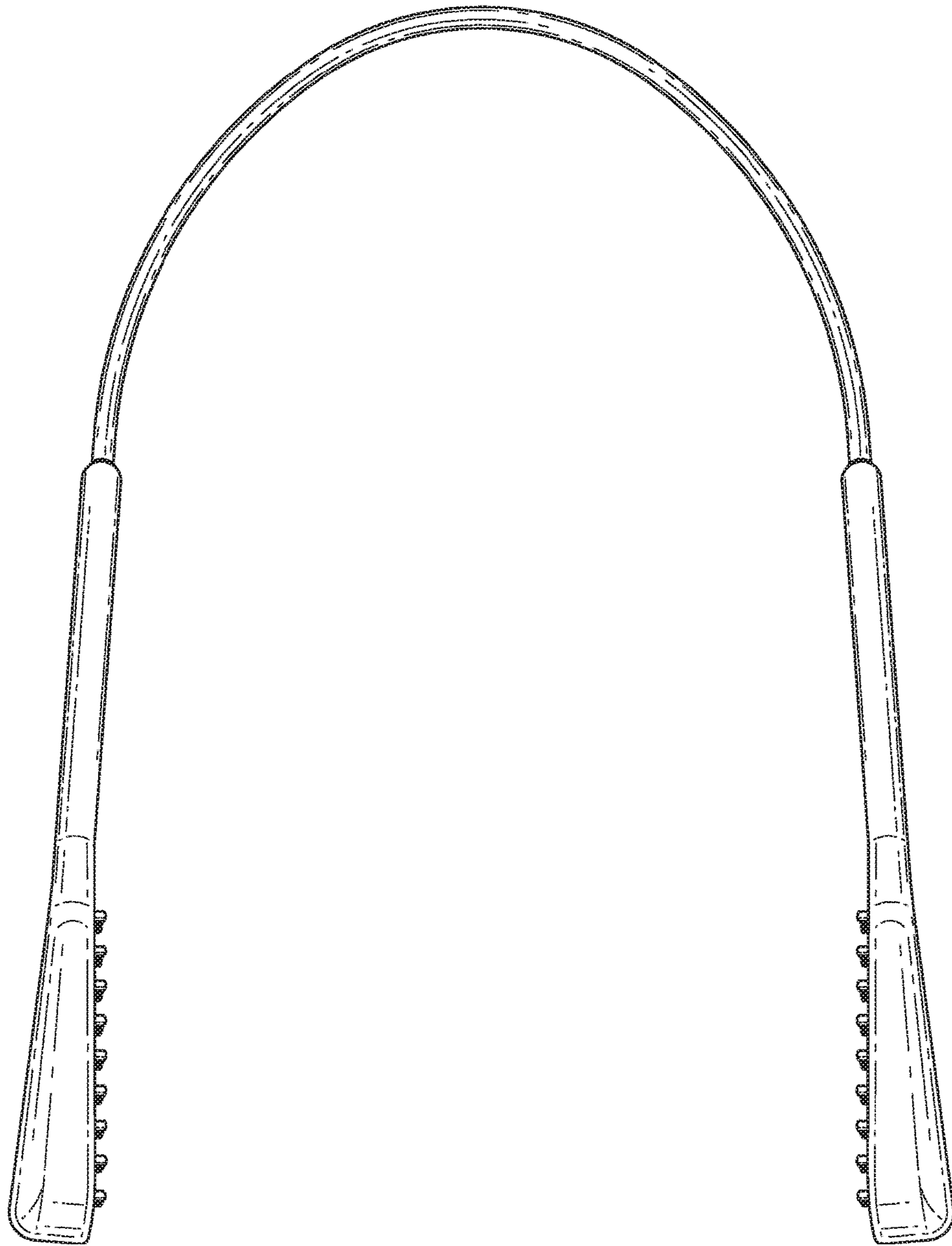

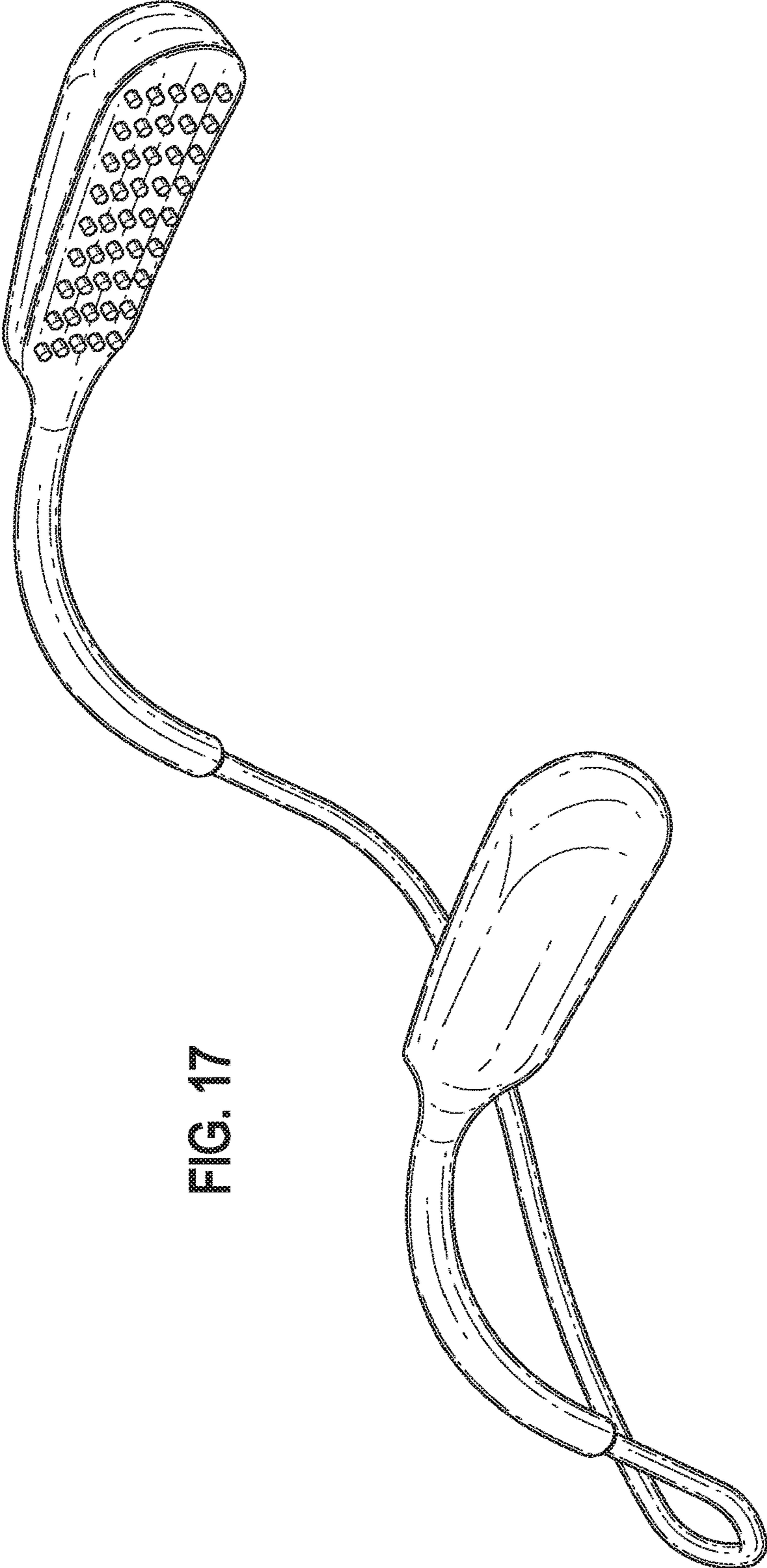

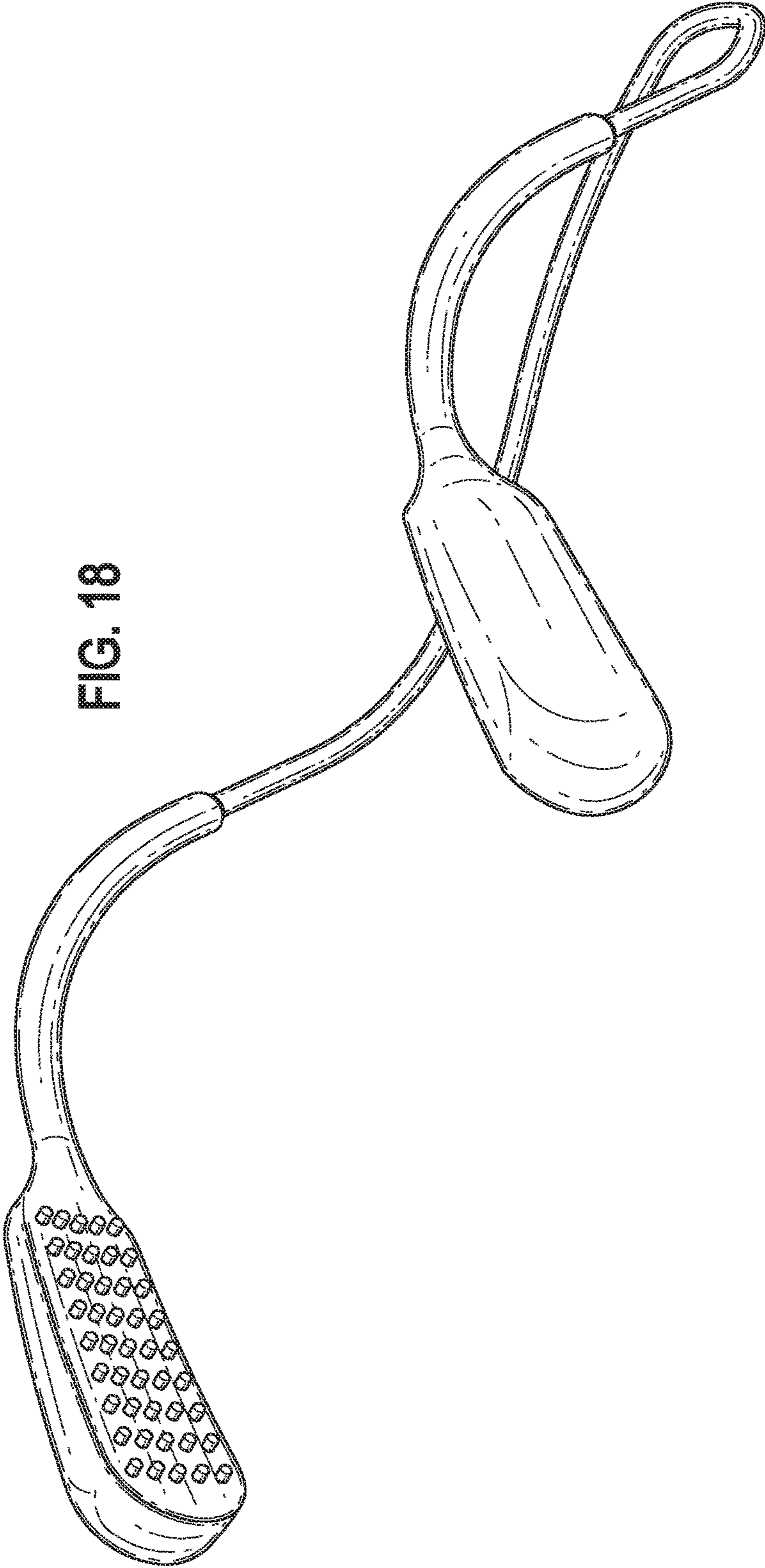

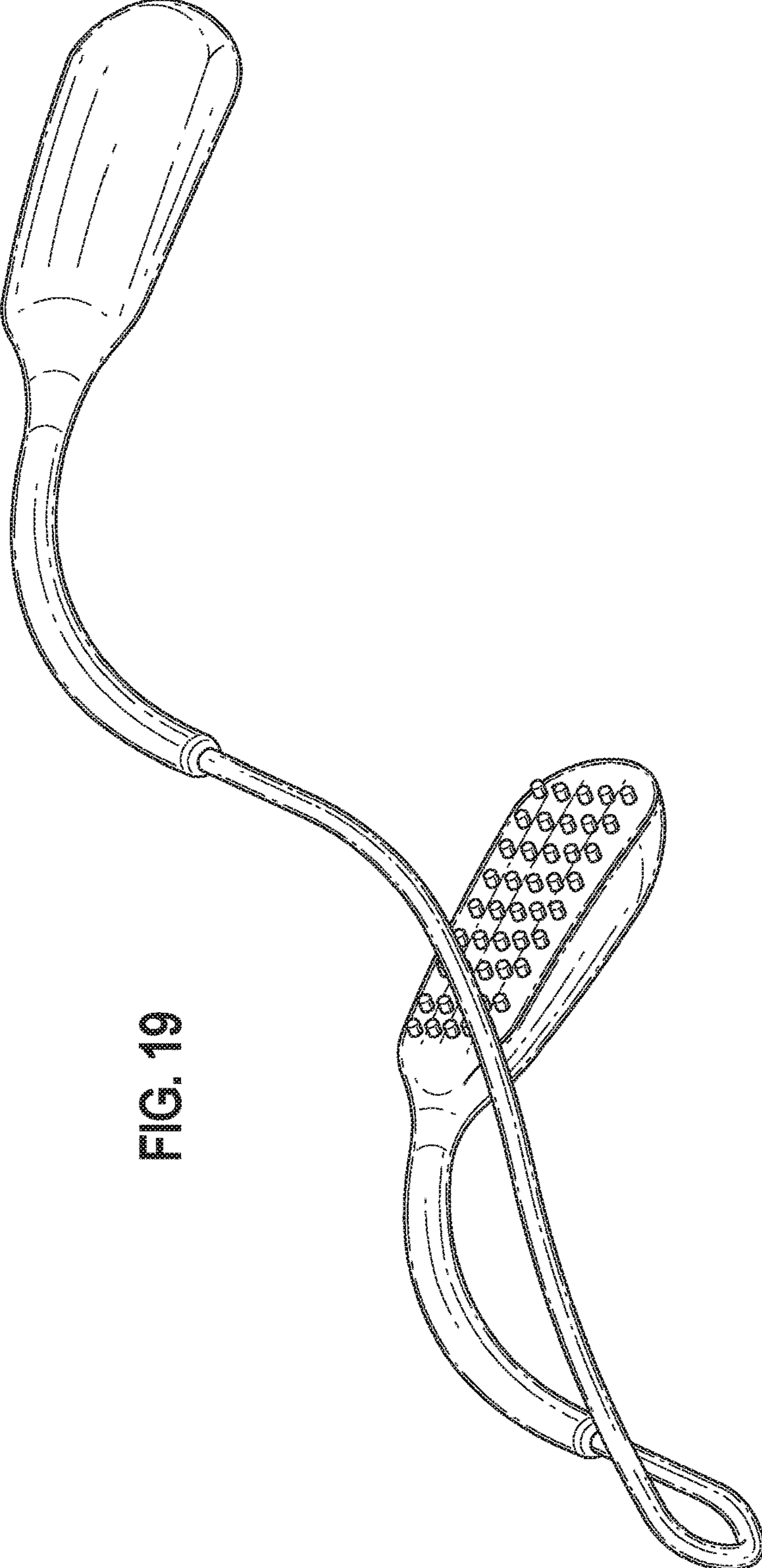

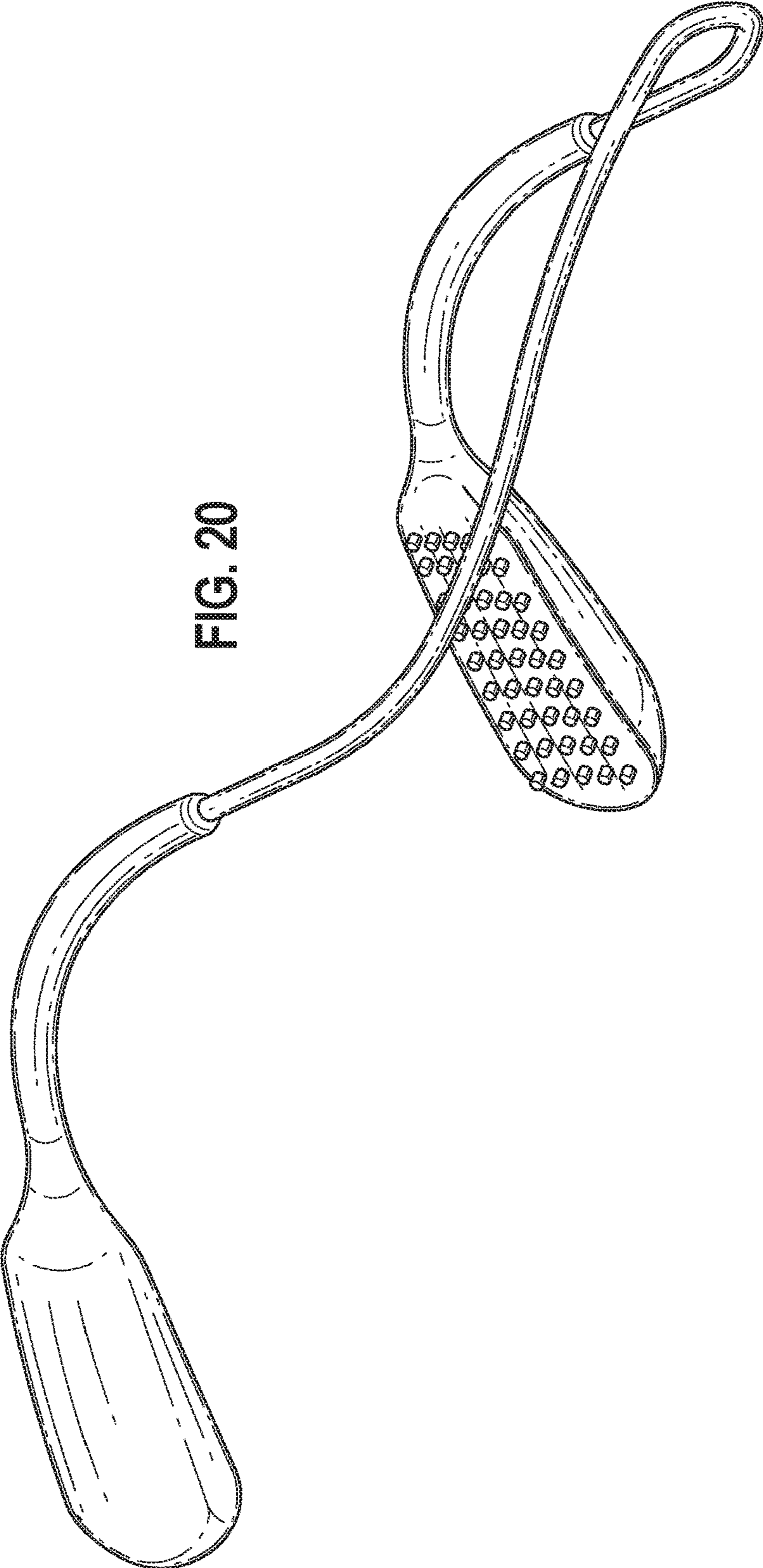
