**DESCRIPTION**

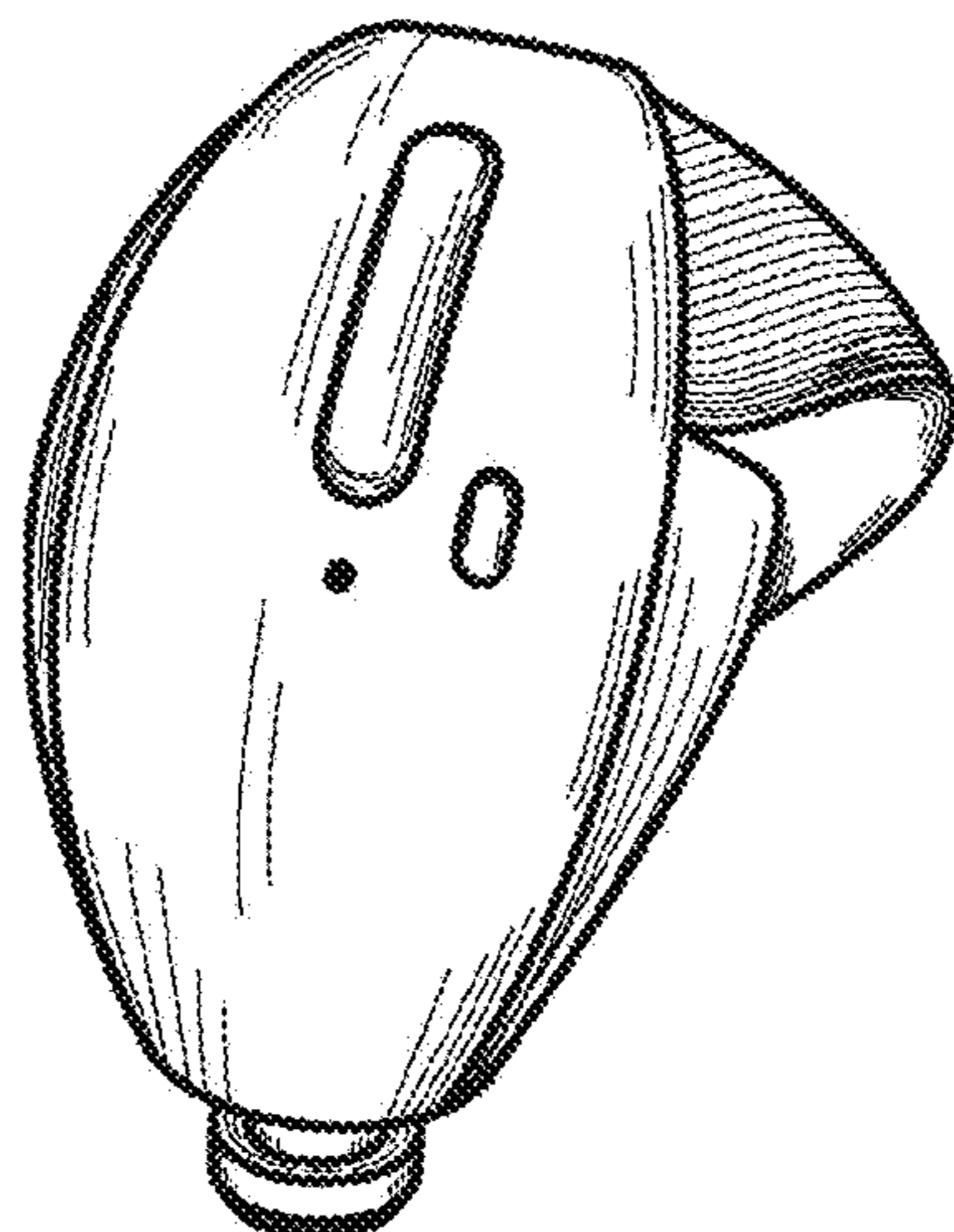
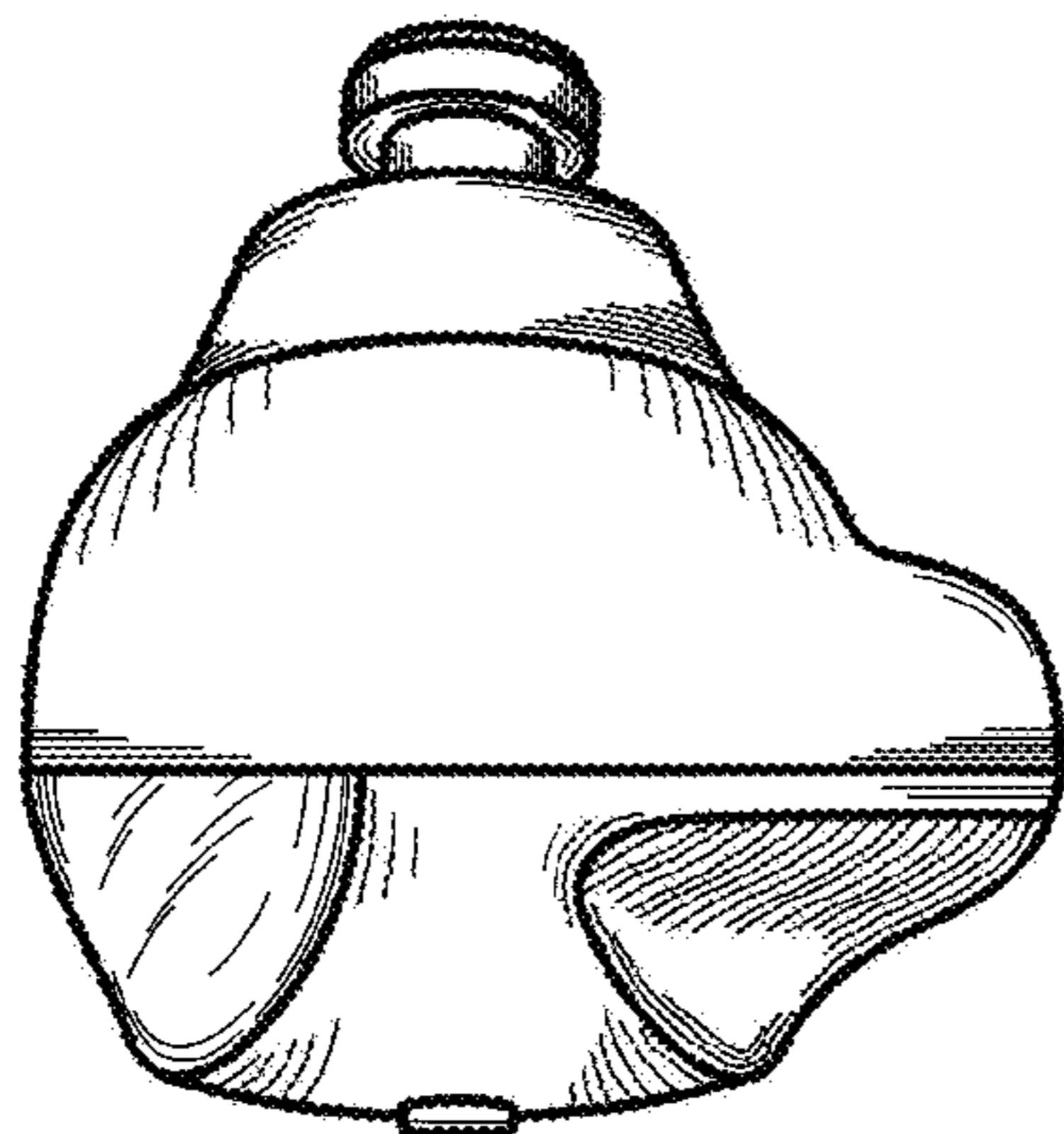
FIG. 1 is a front elevational view of a wireless earset showing my new design;

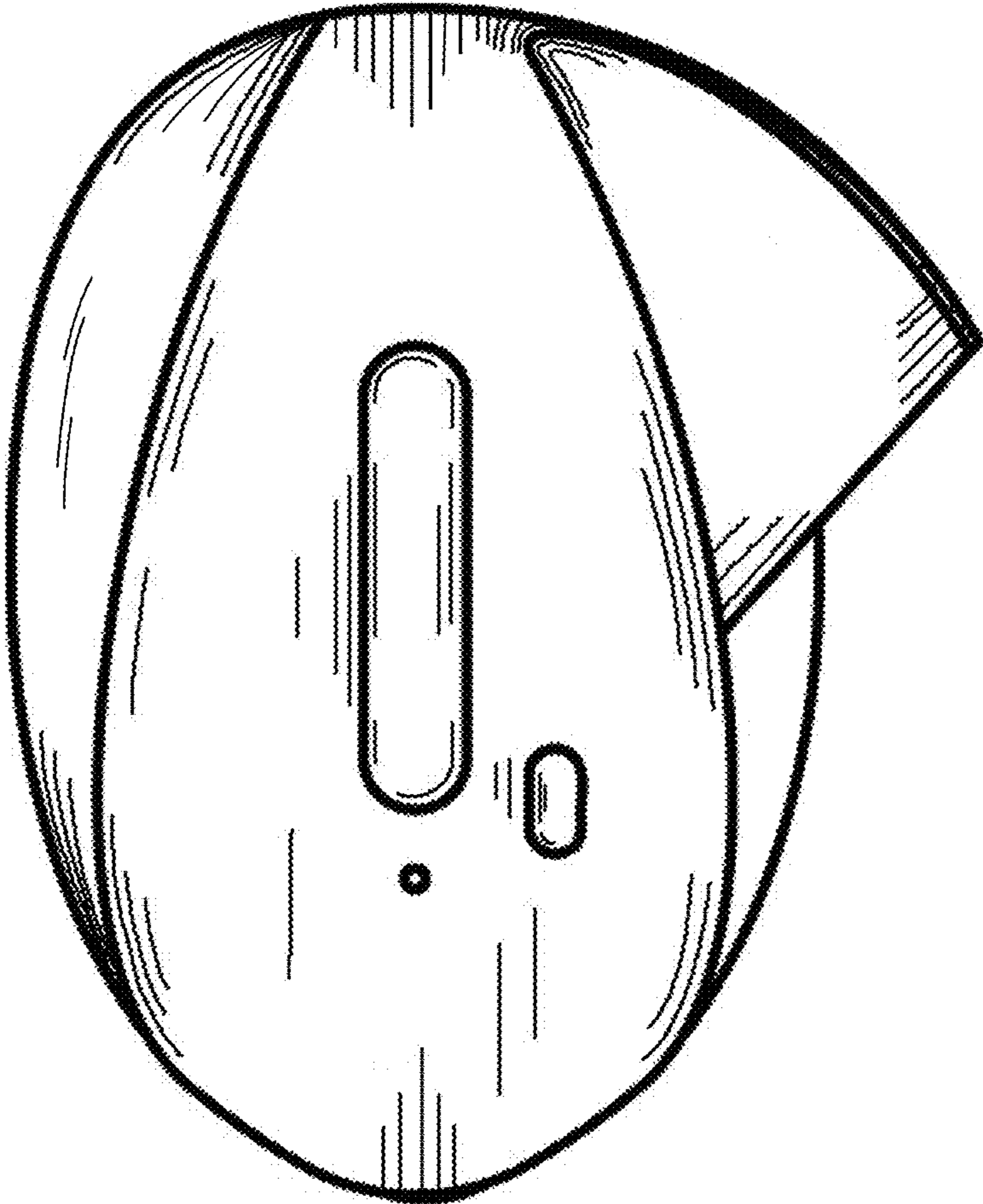

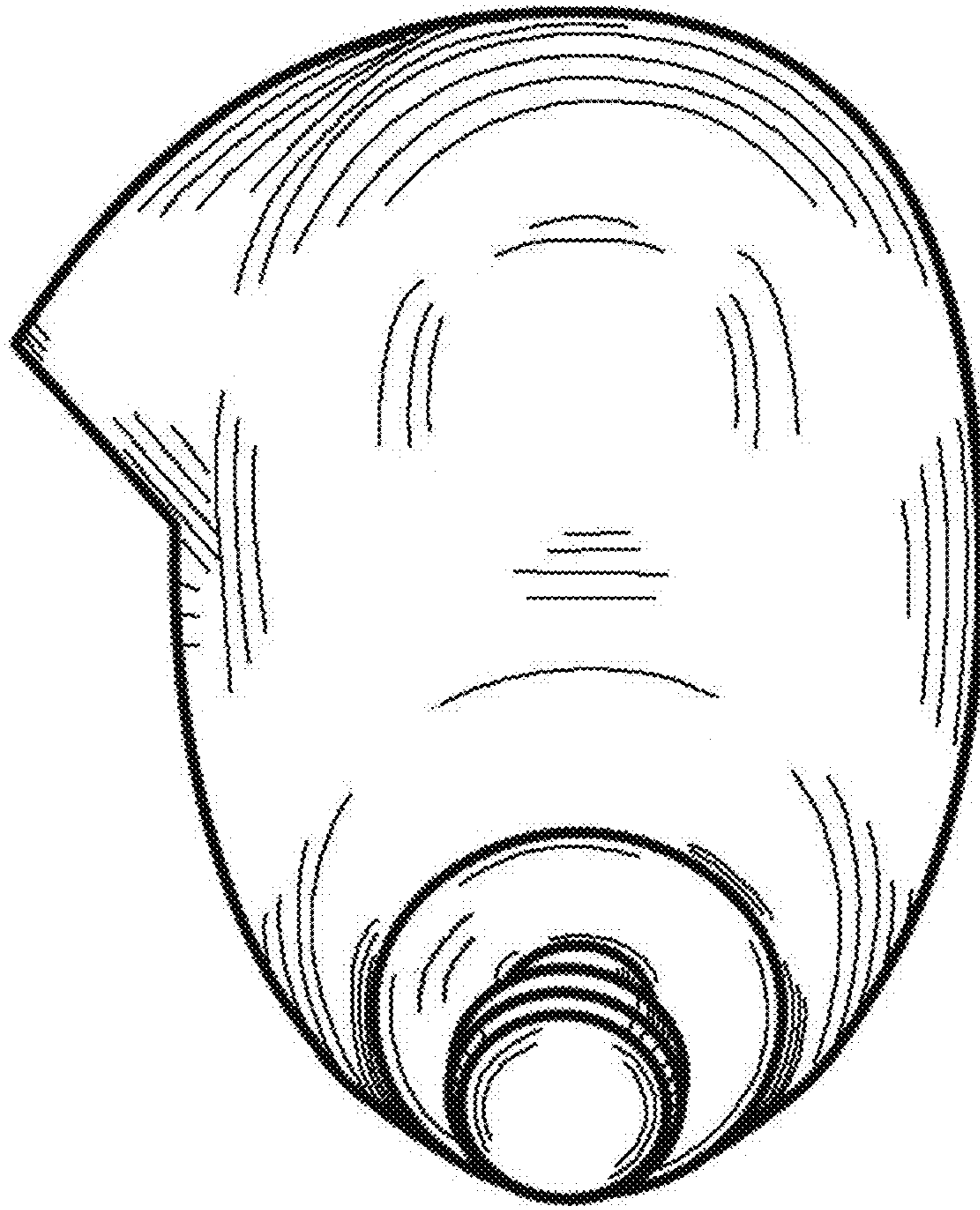

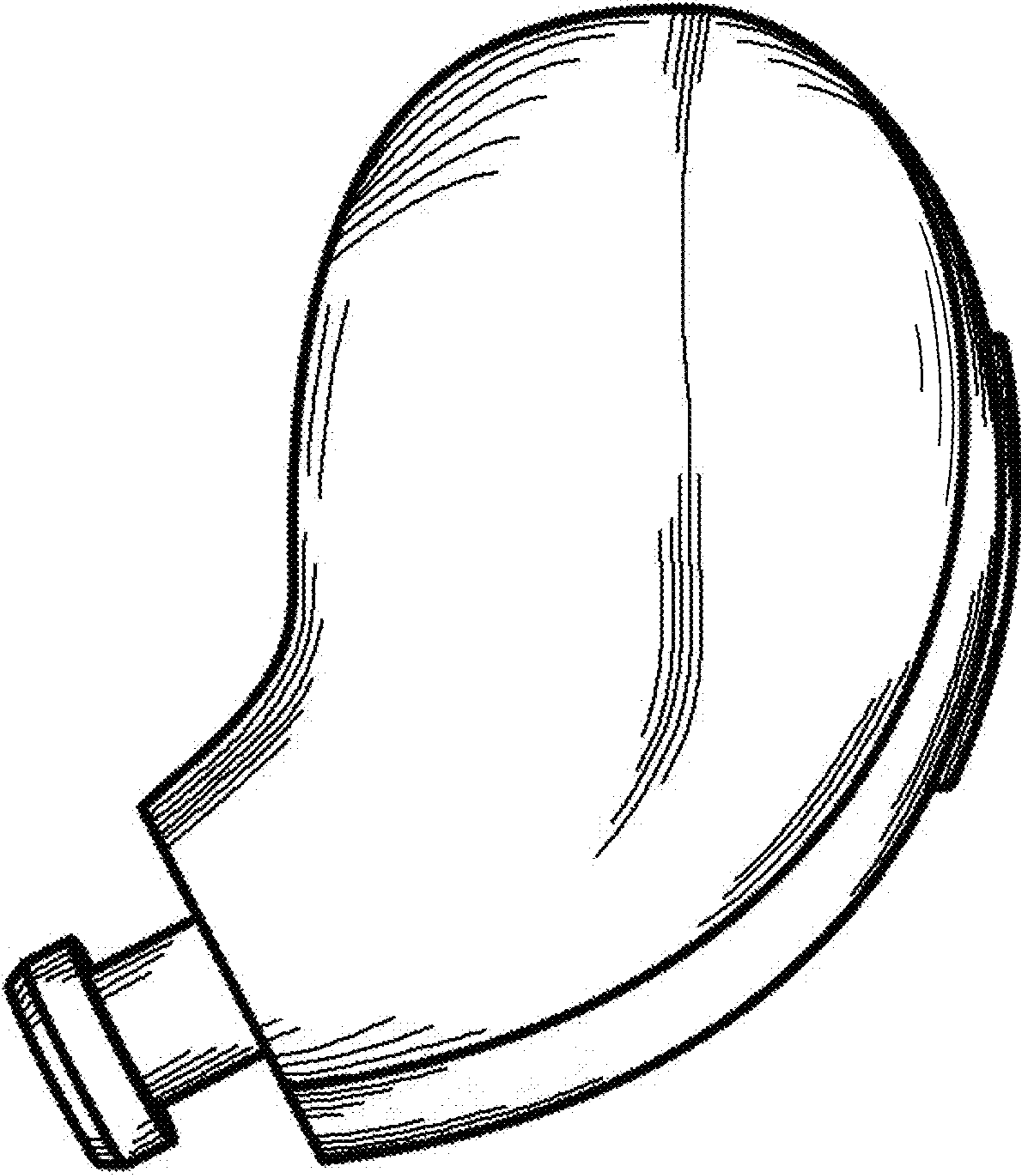

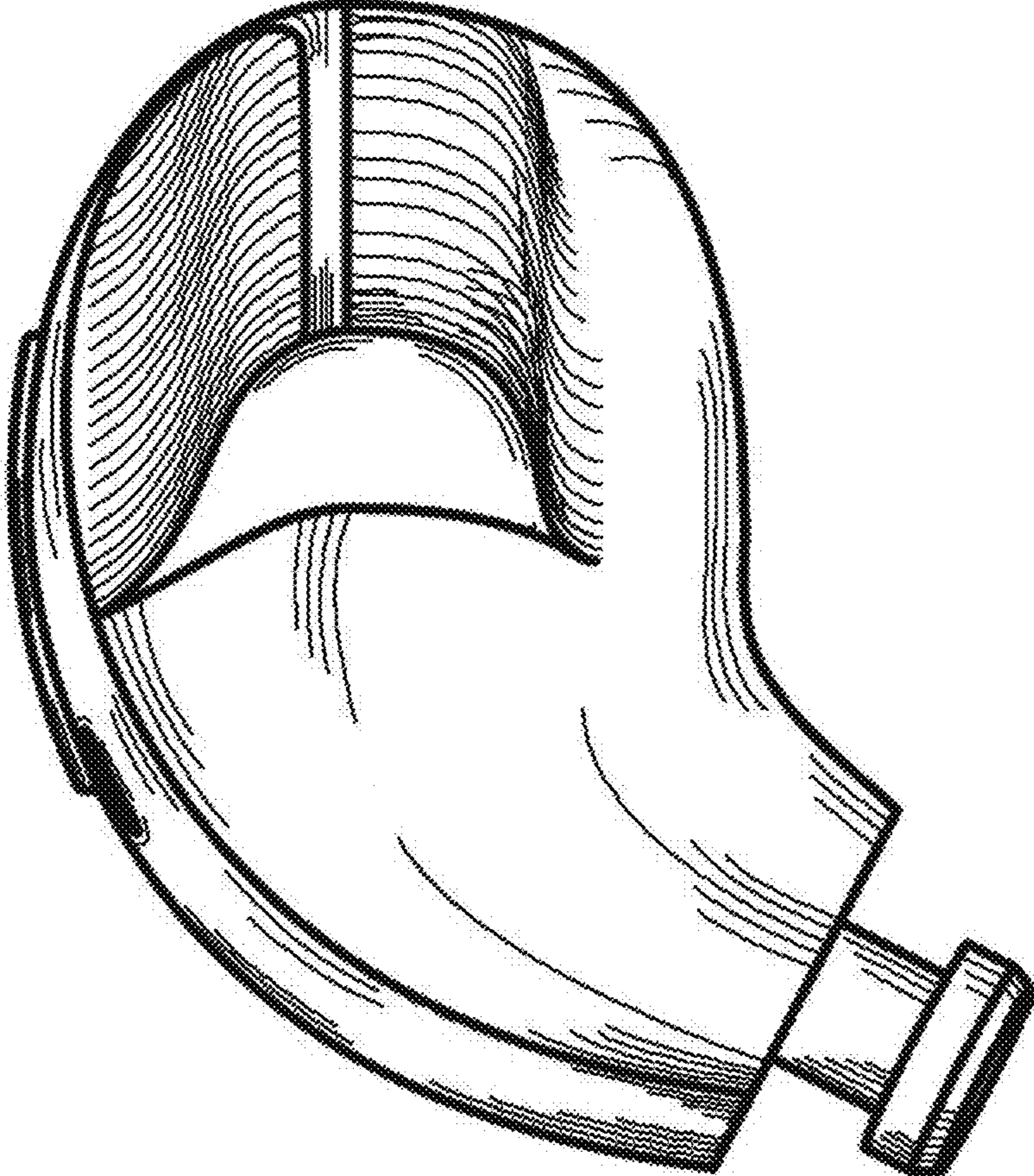

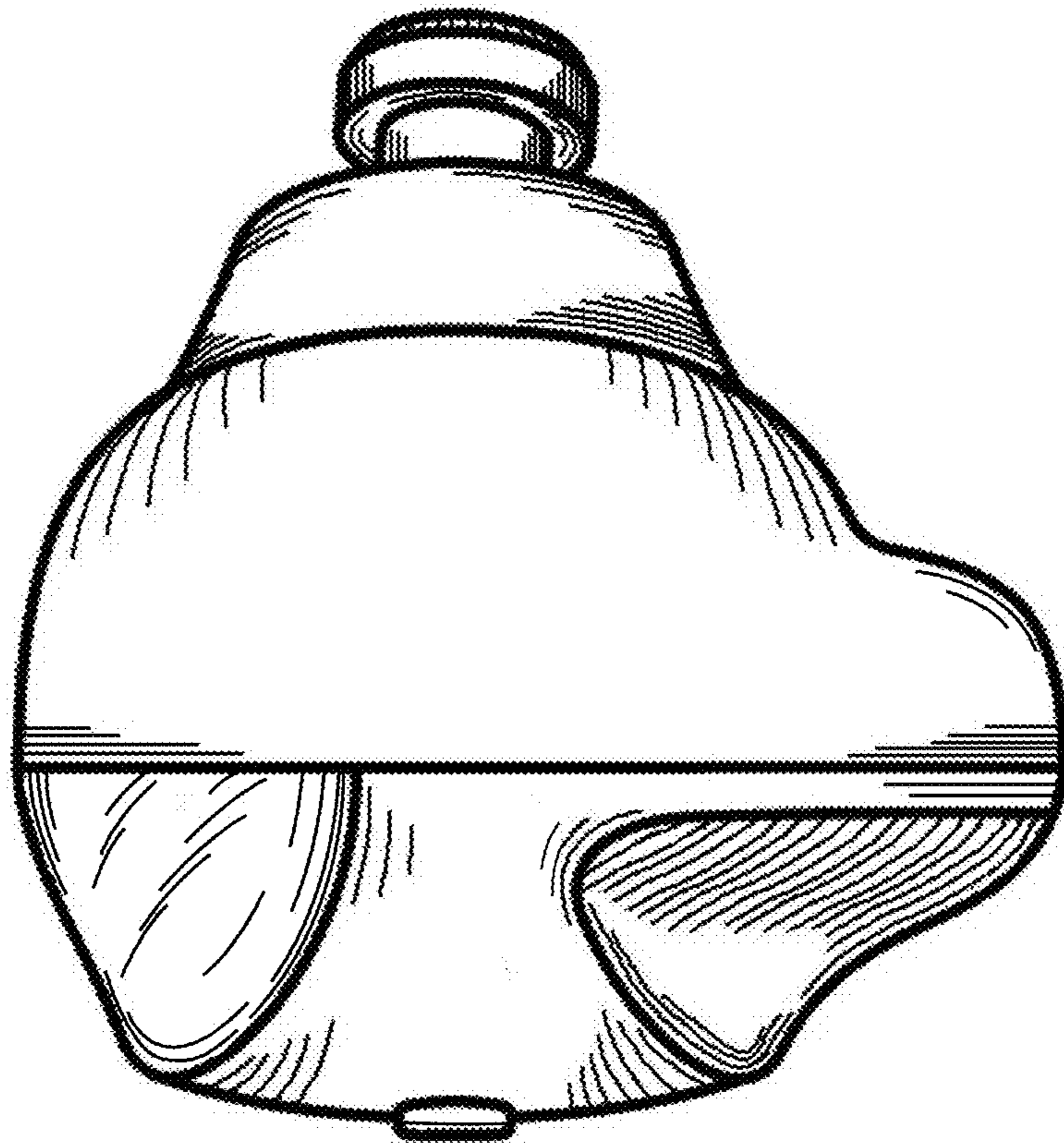

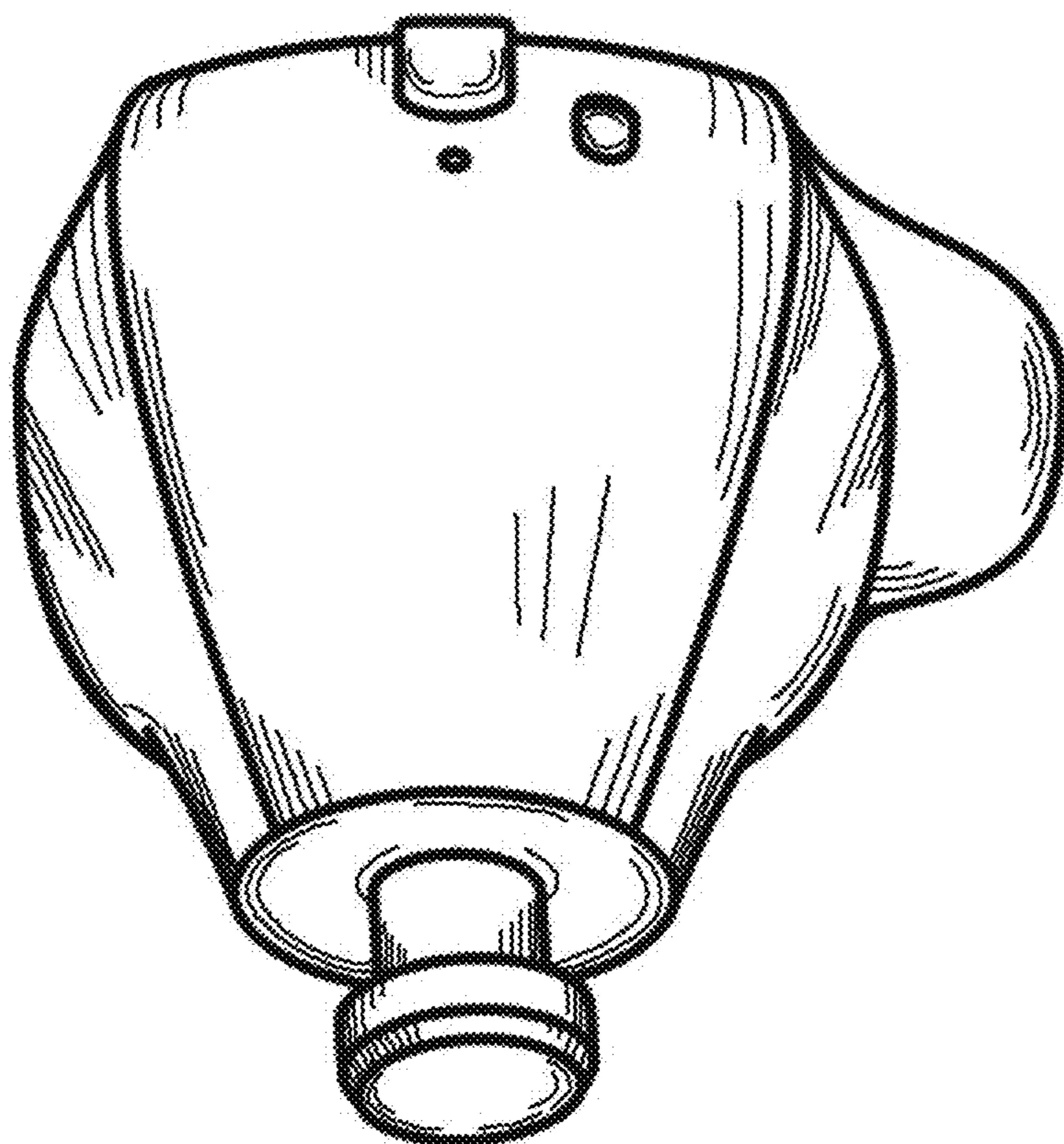

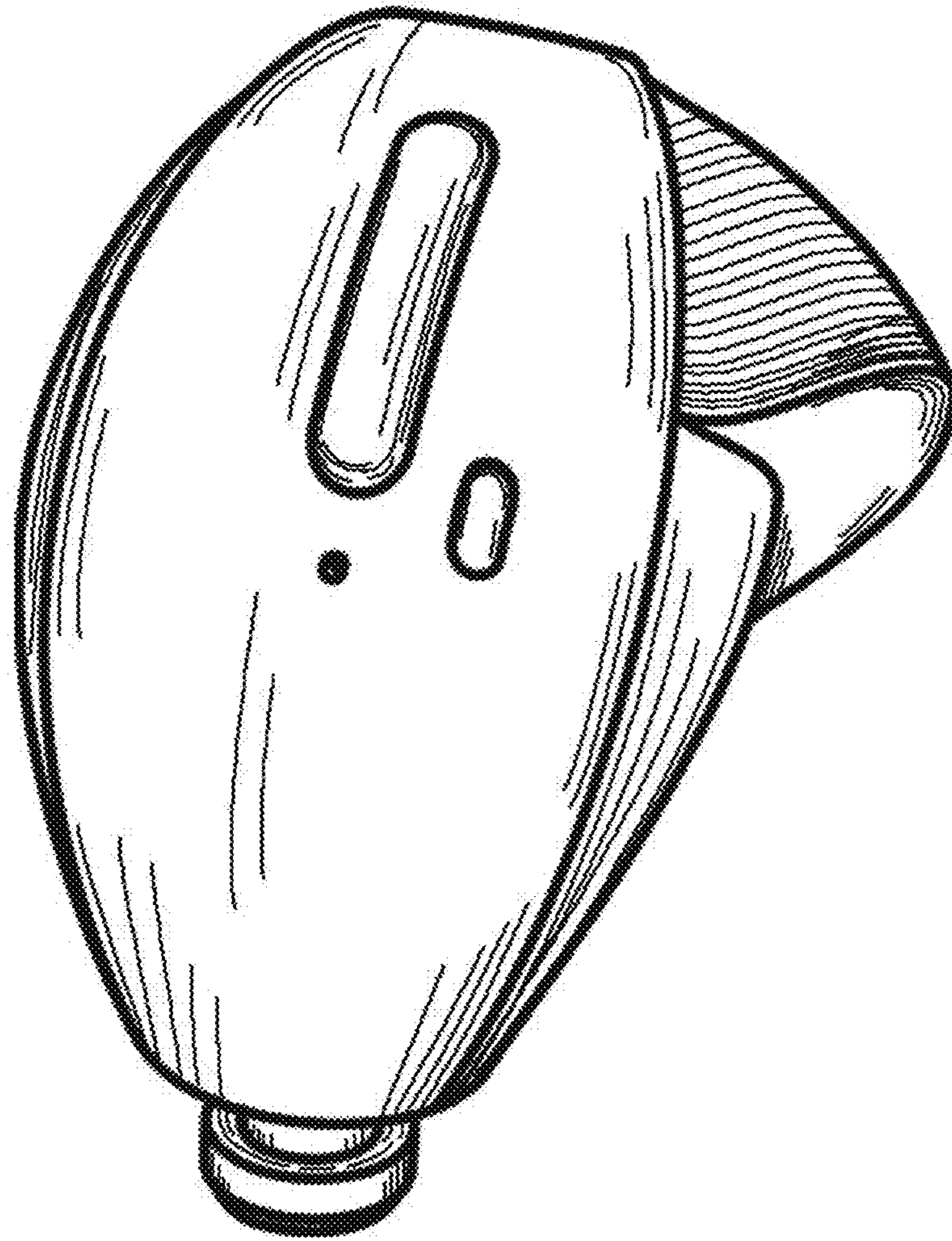
