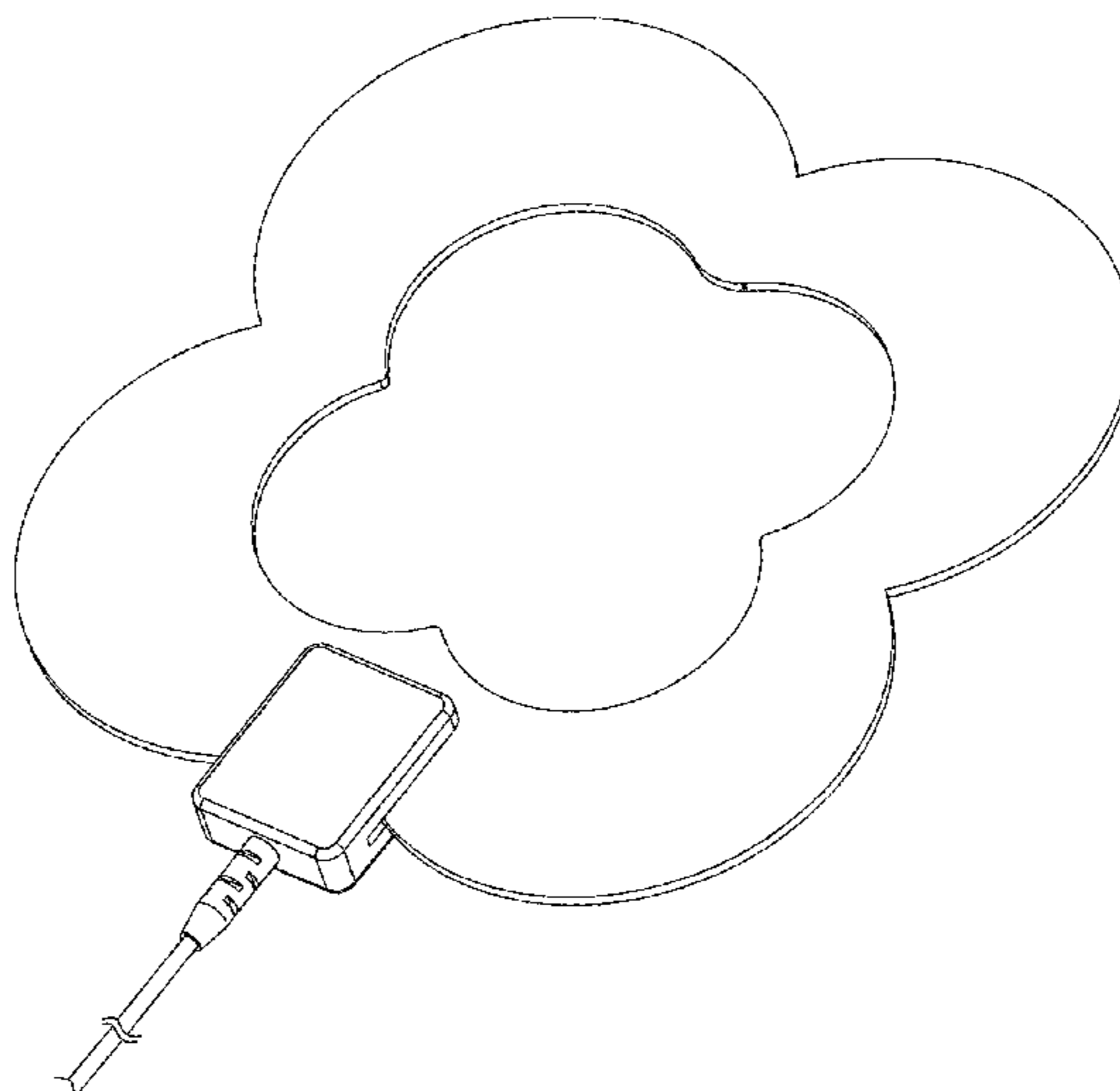
(57) **CLAIM**

The ornamental design for a flower-shaped antenna, as shown and described.

DESCRIPTION

FIG. 1 is a front elevational view of a flower-shaped antenna showing my new design;
FIG. 2 is a rear elevational view thereof;
FIG. 3 is a left side view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a top plan view thereof;
FIG. 6 is a bottom plan view thereof; and,
FIG. 7 is a perspective view thereof.
The antenna cord is shown with a symbolic break in its length. The appearance of any portion of the article between the break lines forms no part of the claimed design.

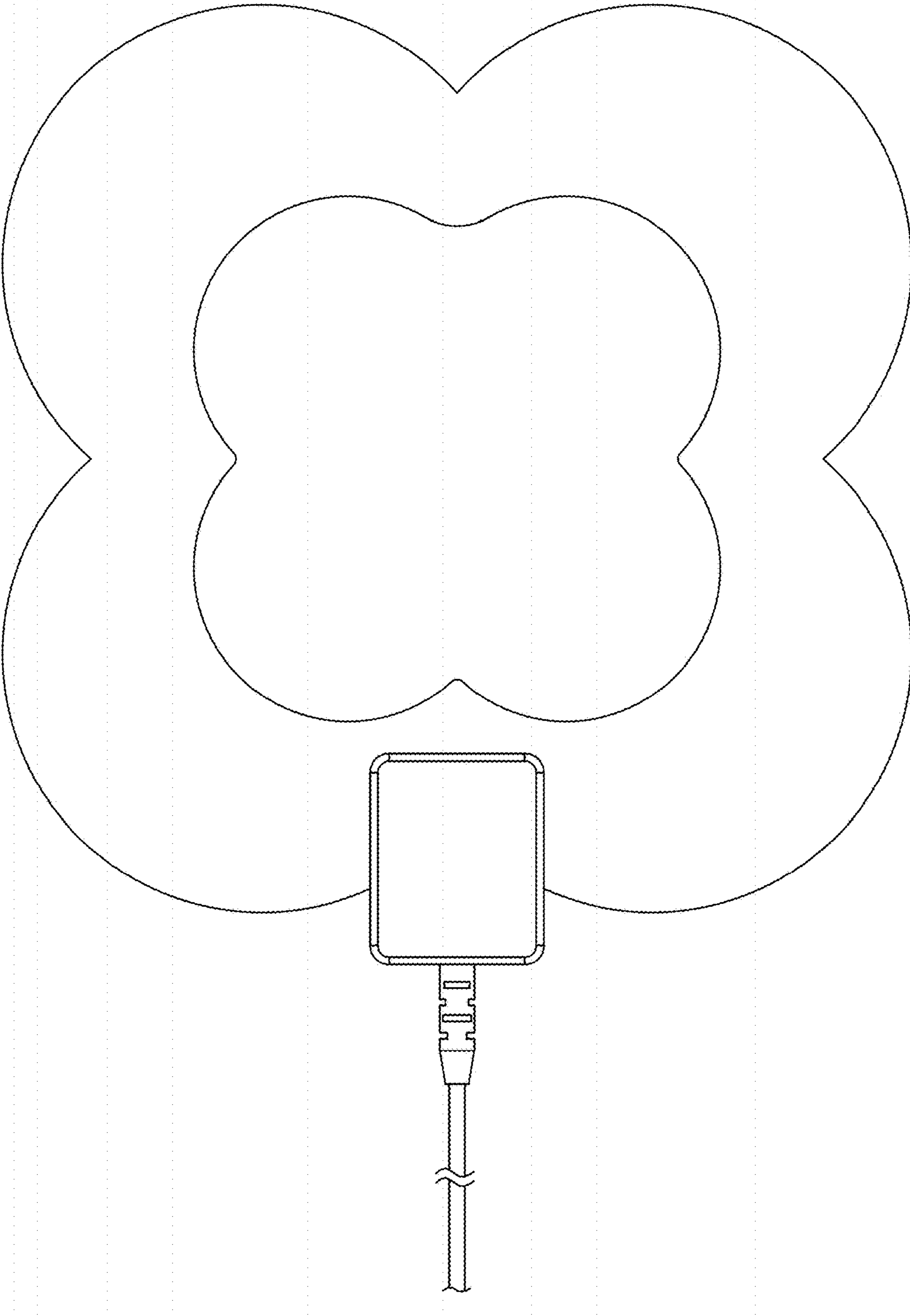

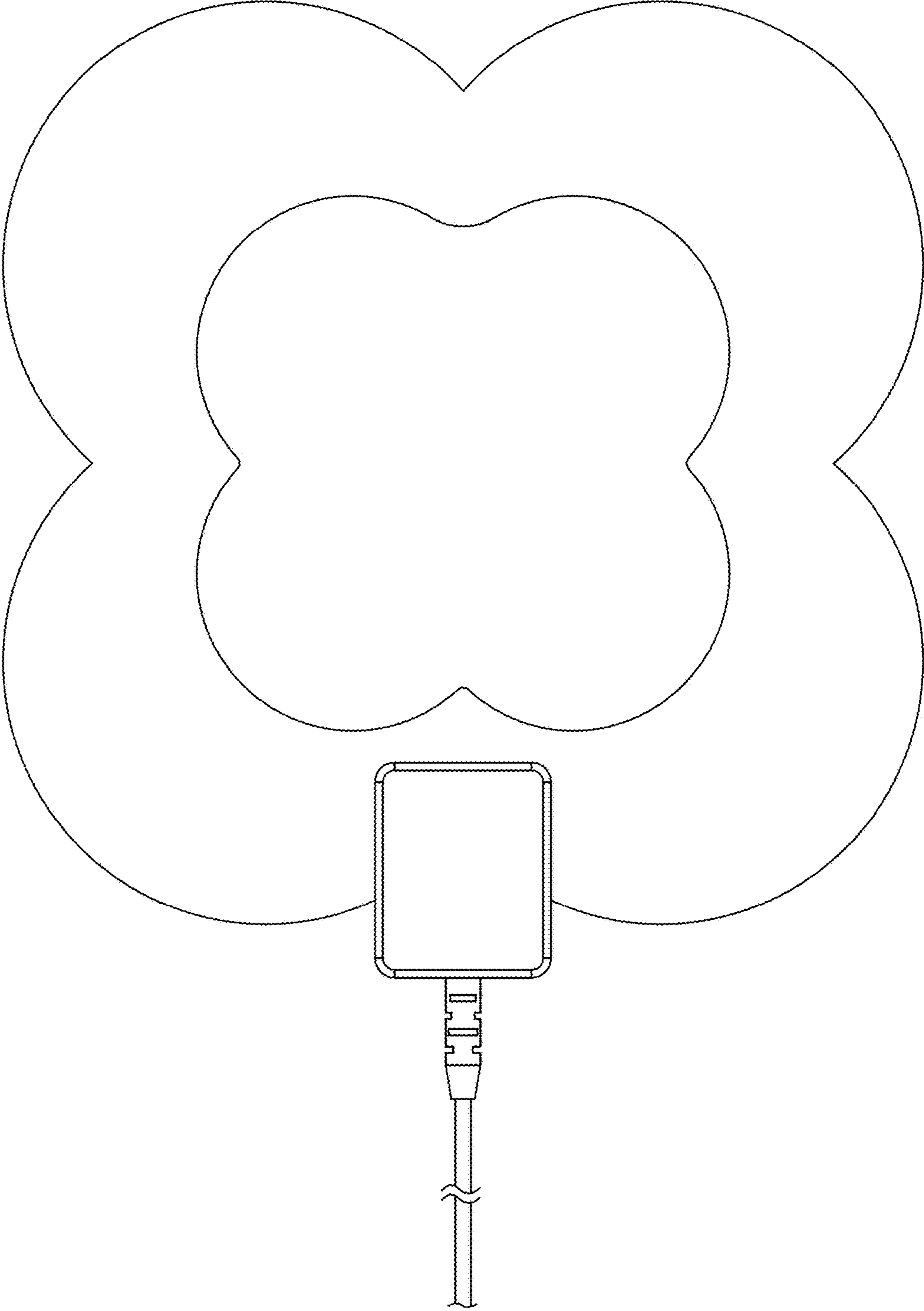

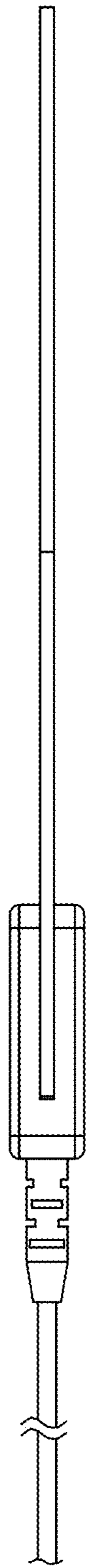

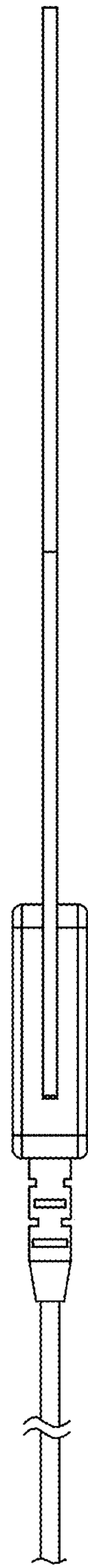

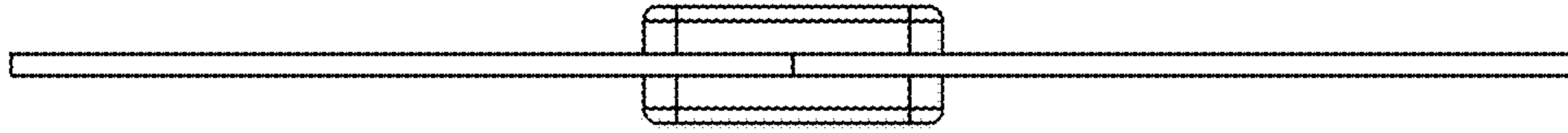

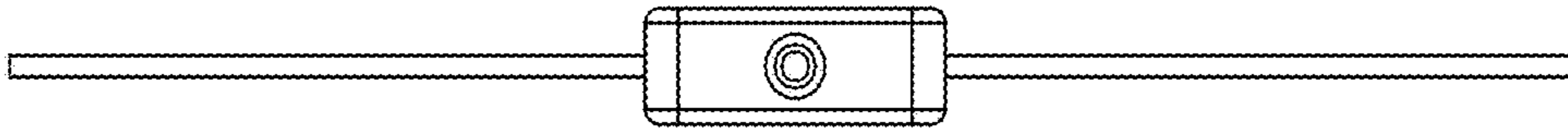

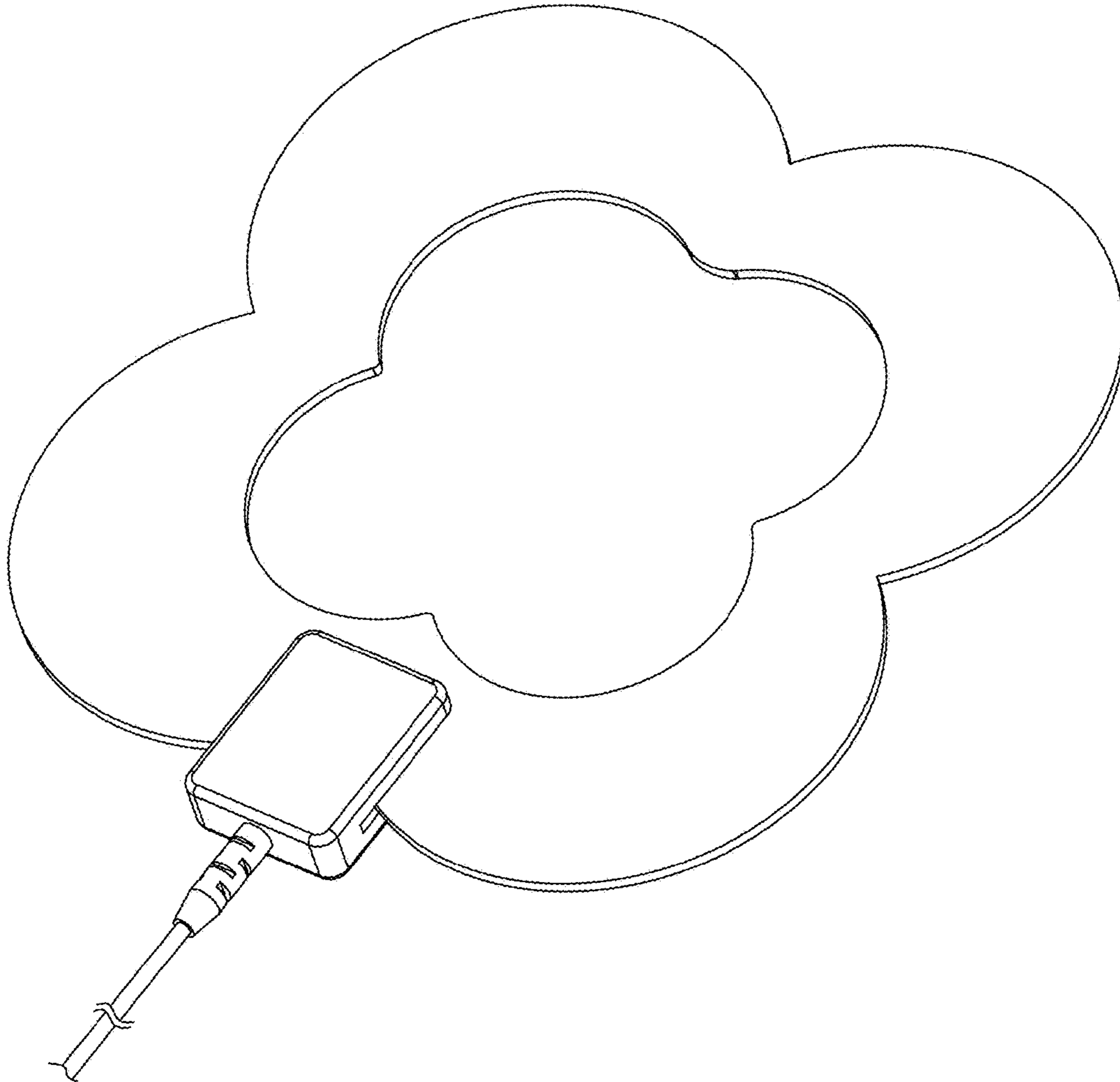
