(57) **CLAIM**

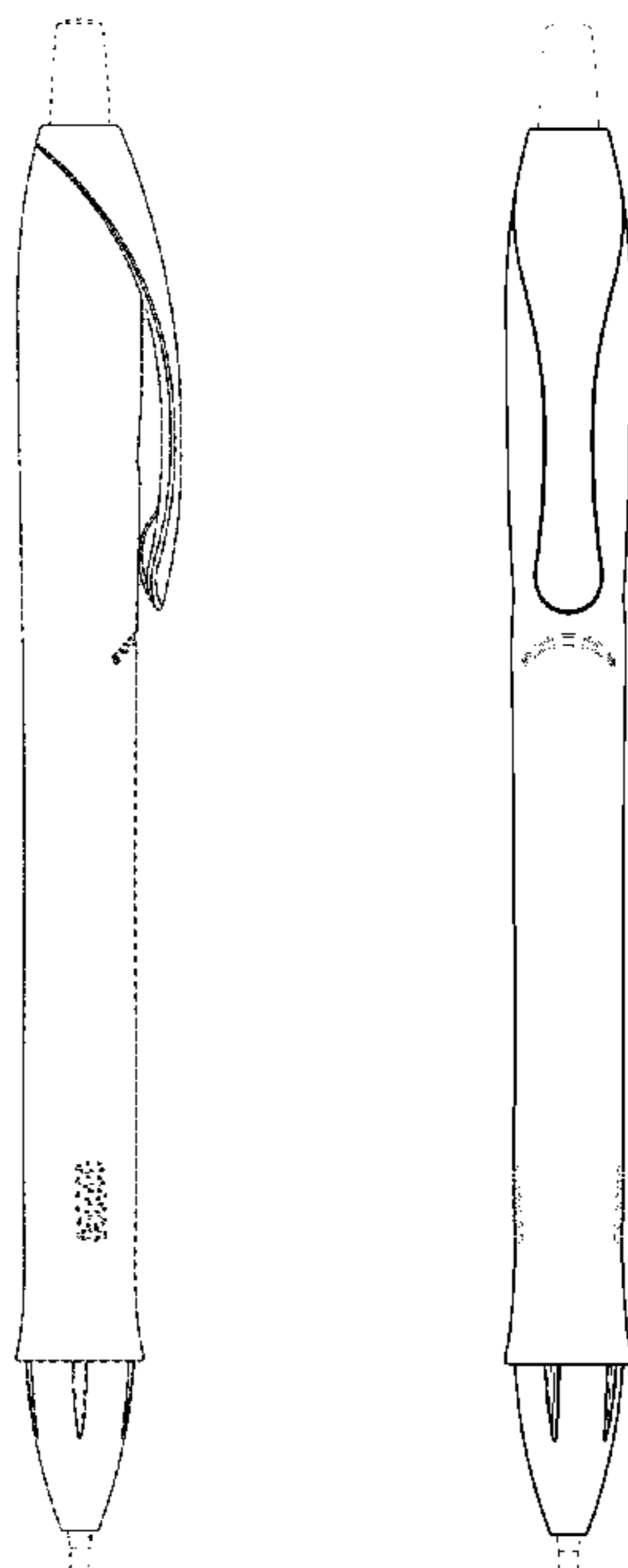
The ornamental design for a writing instrument, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of an ornamental design for a writing instrument according to the present invention; FIG. 2 is a left side elevational view thereof; FIG. 3 is a right side elevational view thereof; FIG. 4 is a front side elevational view thereof; FIG. 5 is a rear side elevational view thereof; FIG. 6 is a bottom plan view thereof; and, FIG. 7 is a top plan view.

The broken lines shown in FIGS. 1-7 are for the purpose of illustrating environmental structure and form no part of the claimed design.

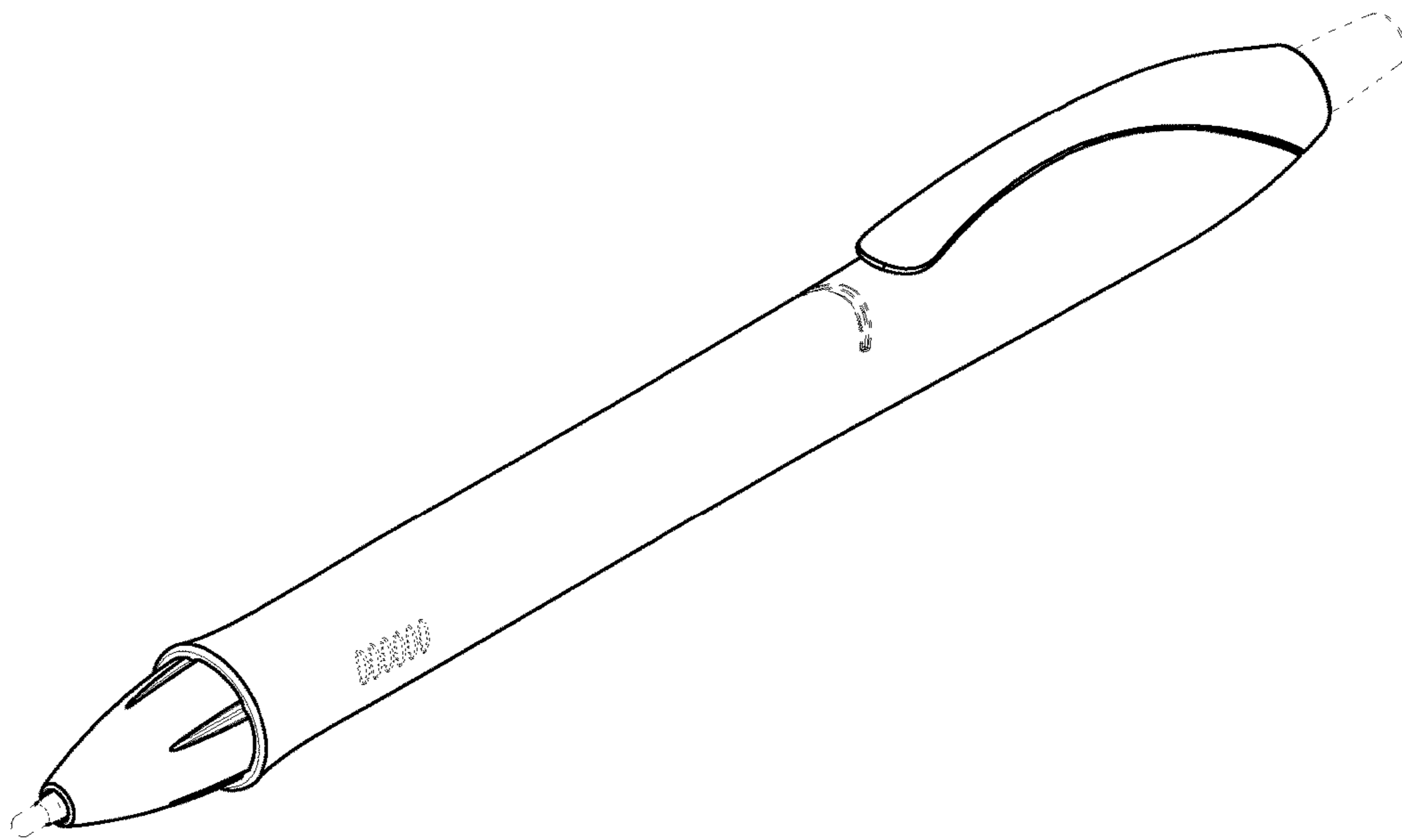

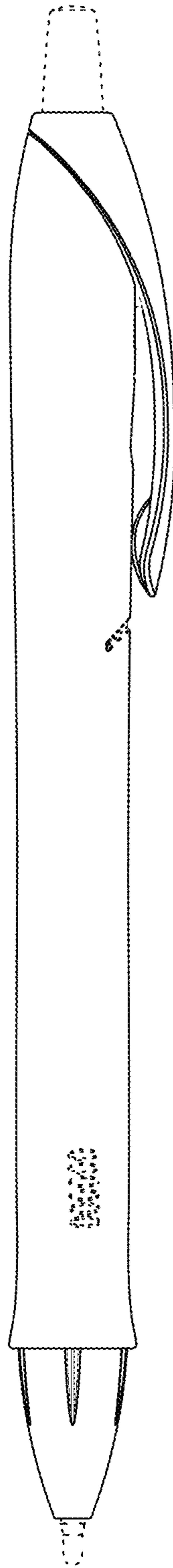

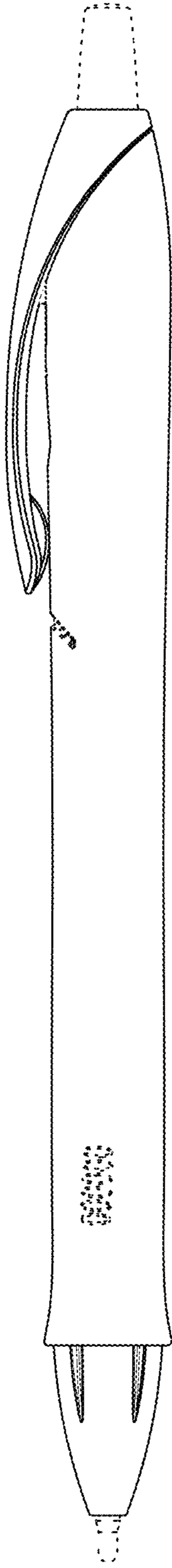

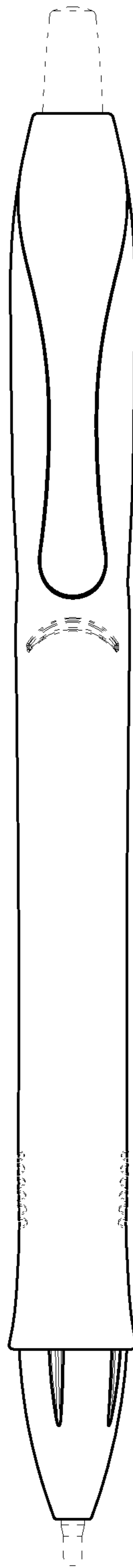

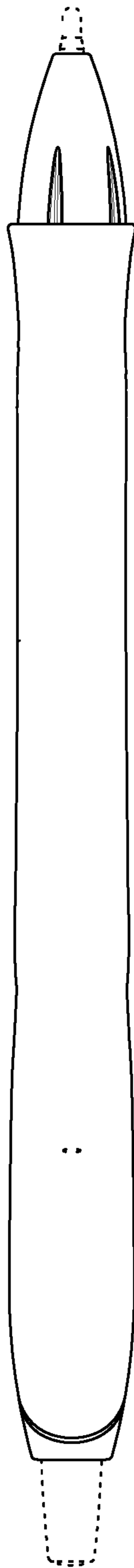

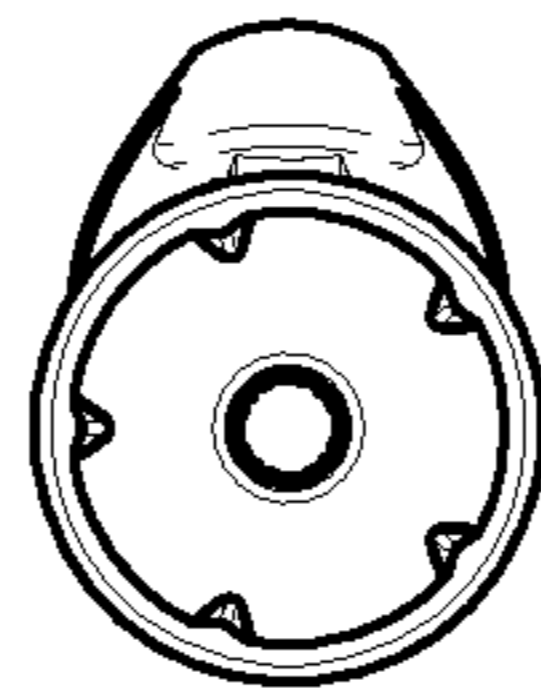

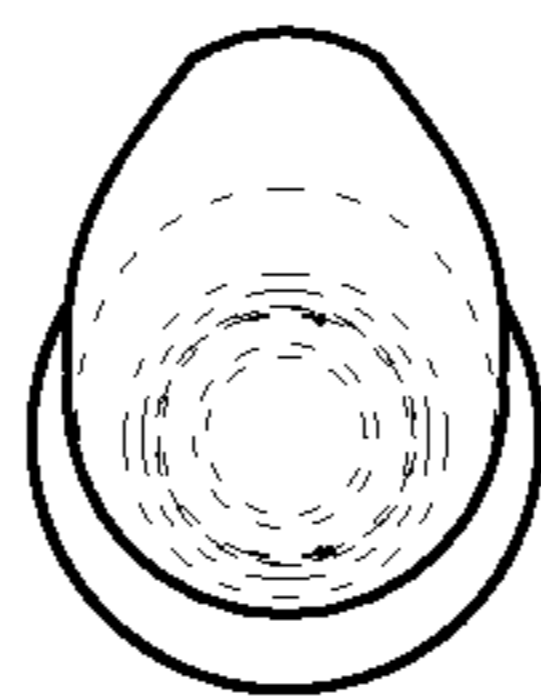
