FIG. 3 is a left side elevation view thereof.

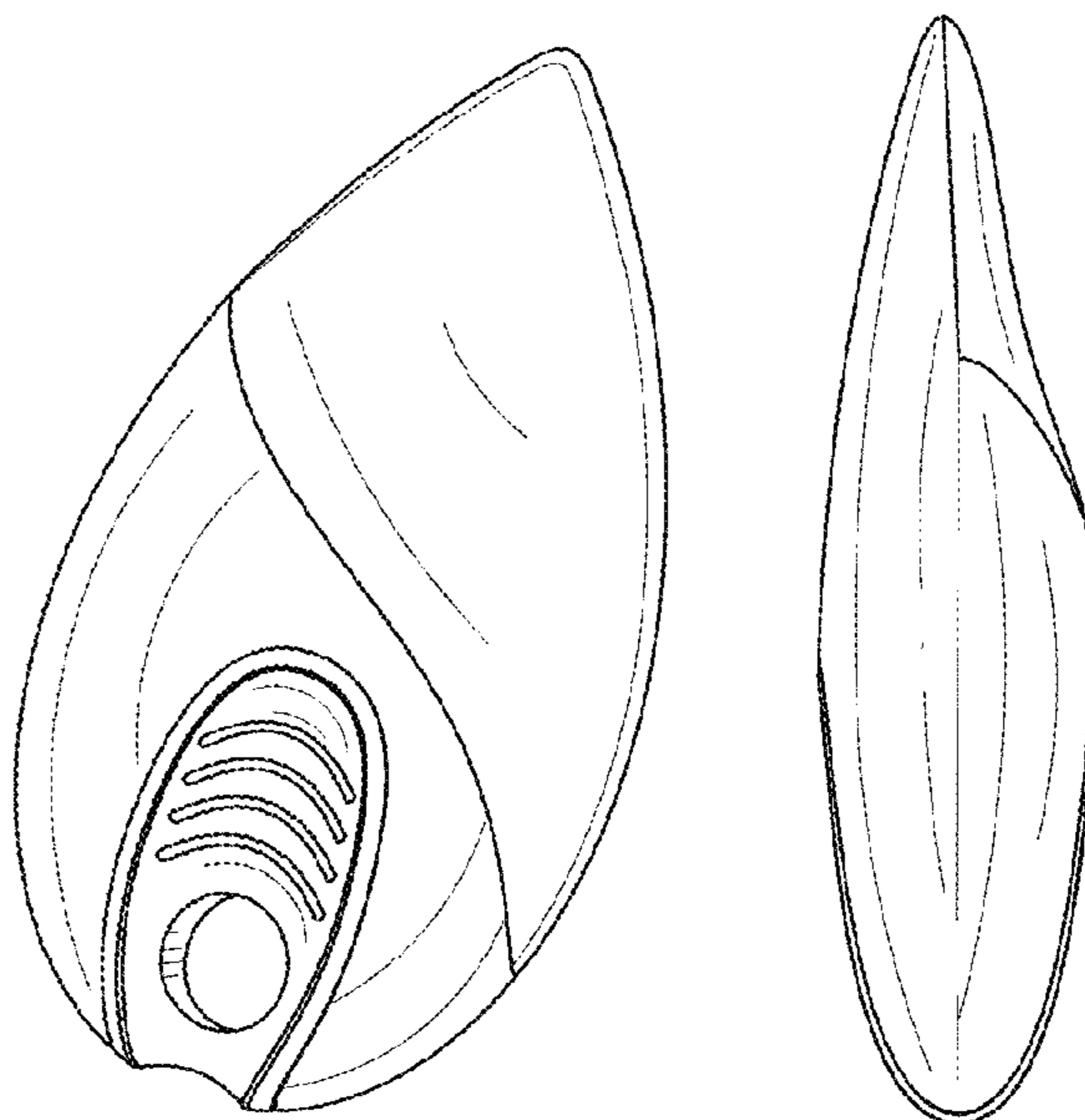
FIG. 4 is a rear elevation view thereof.

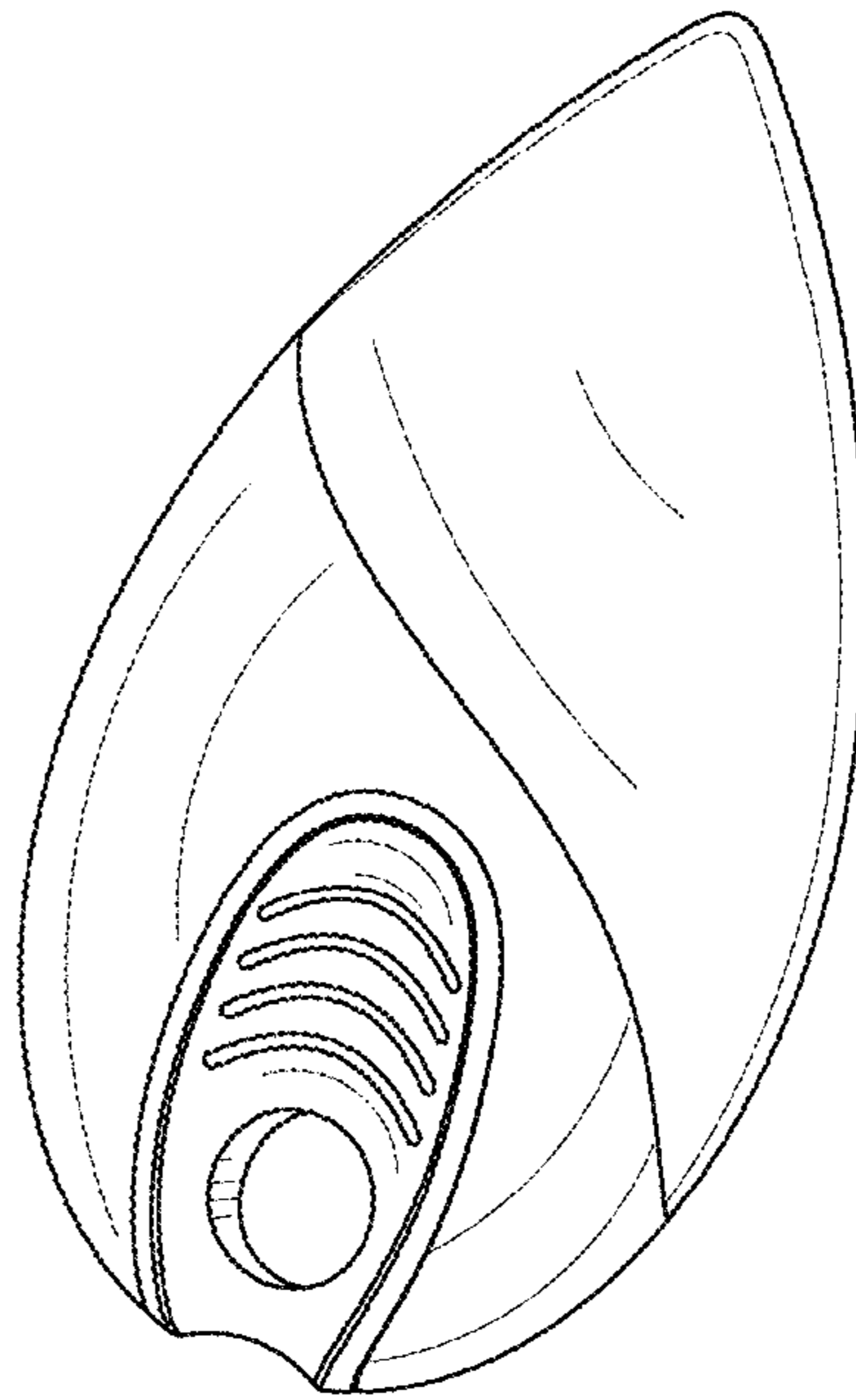

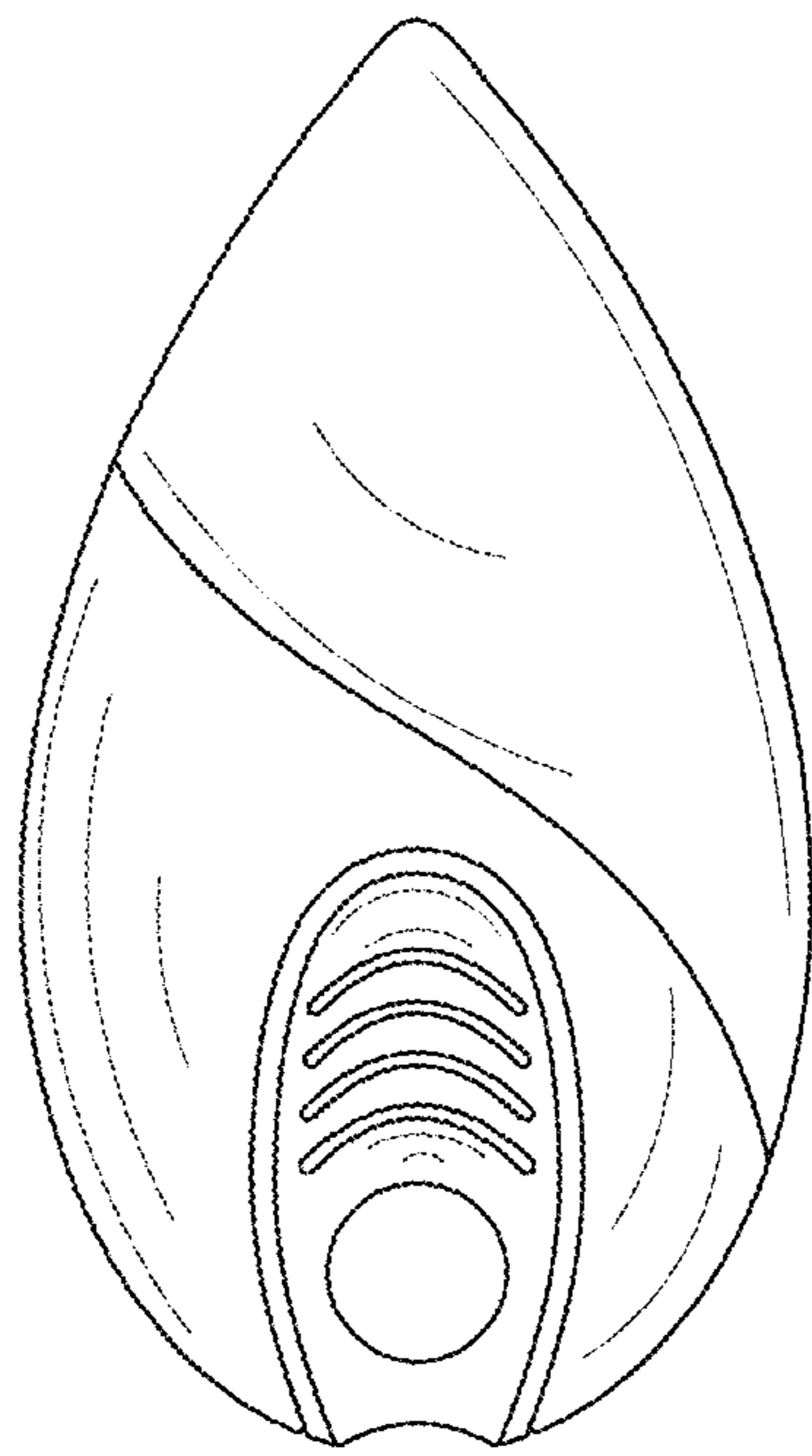

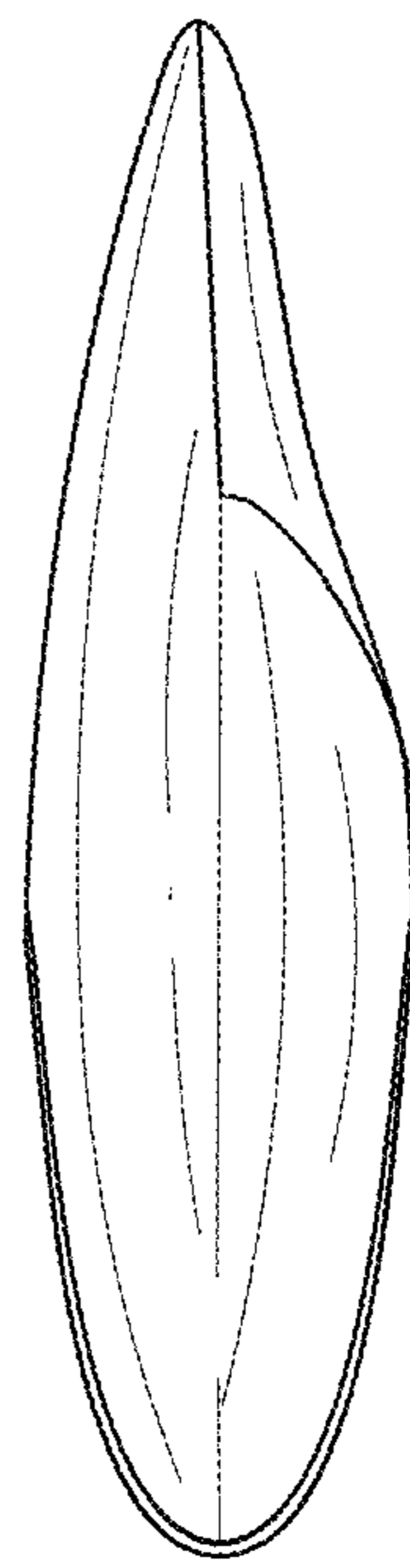

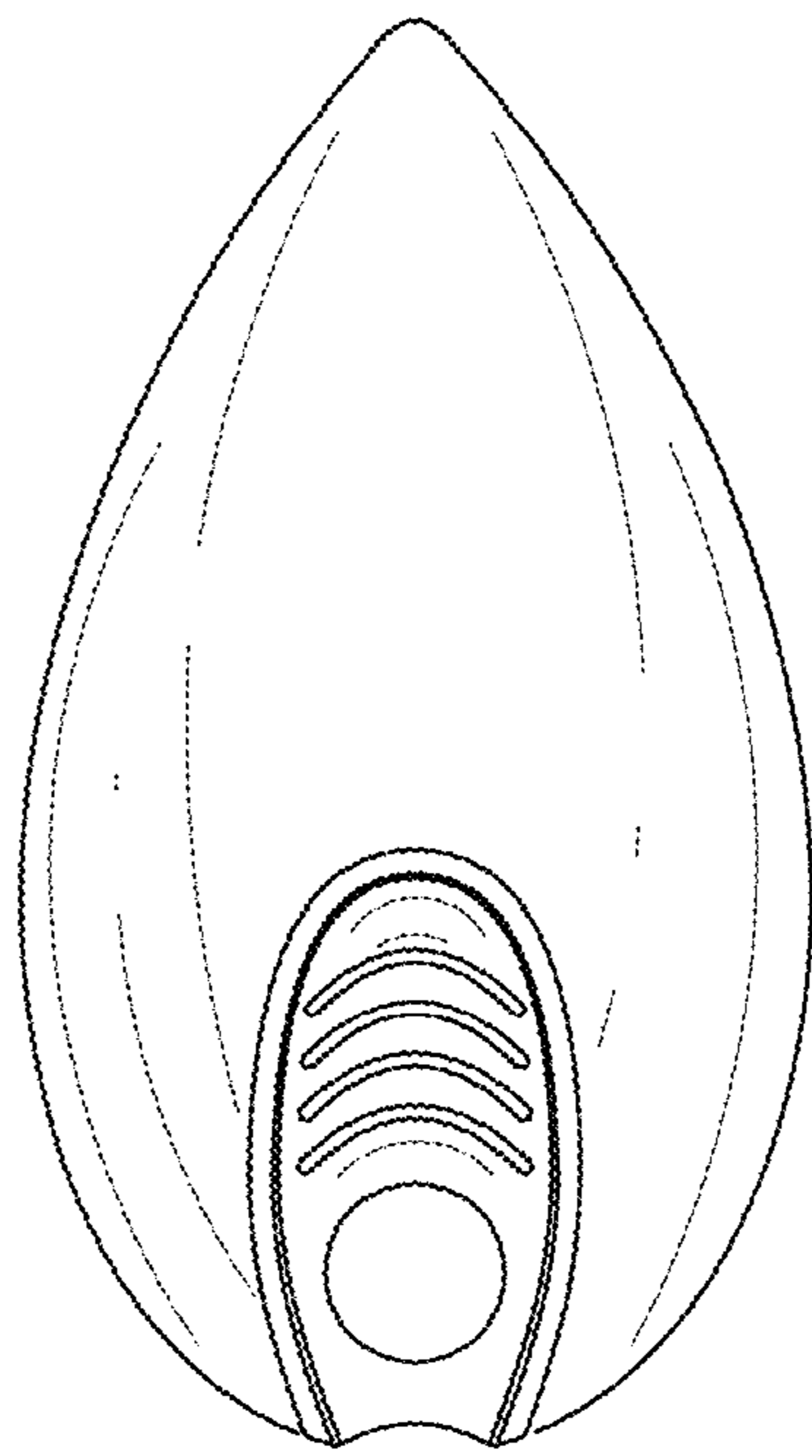

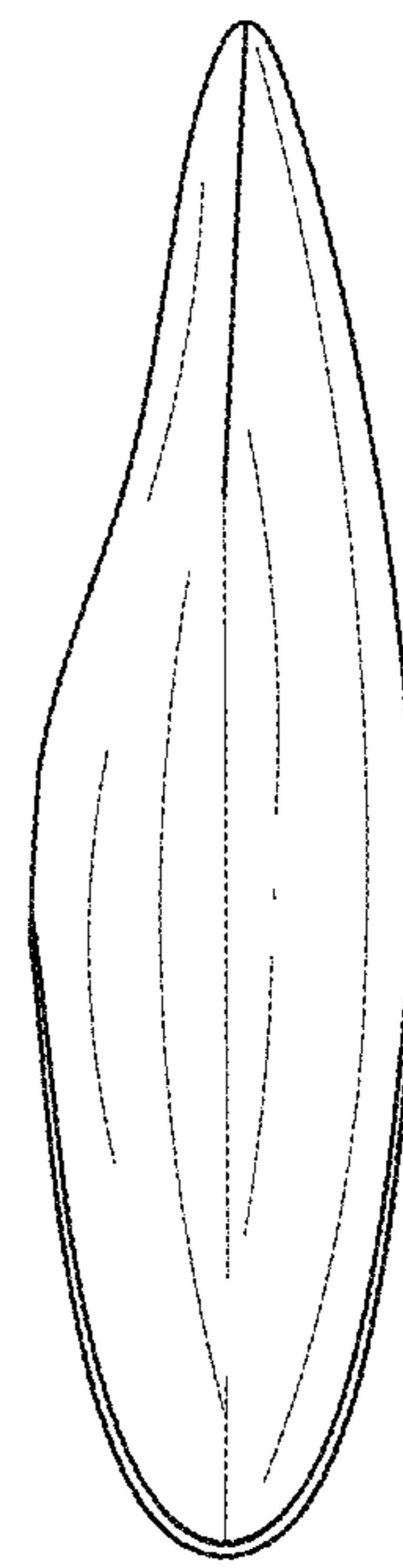

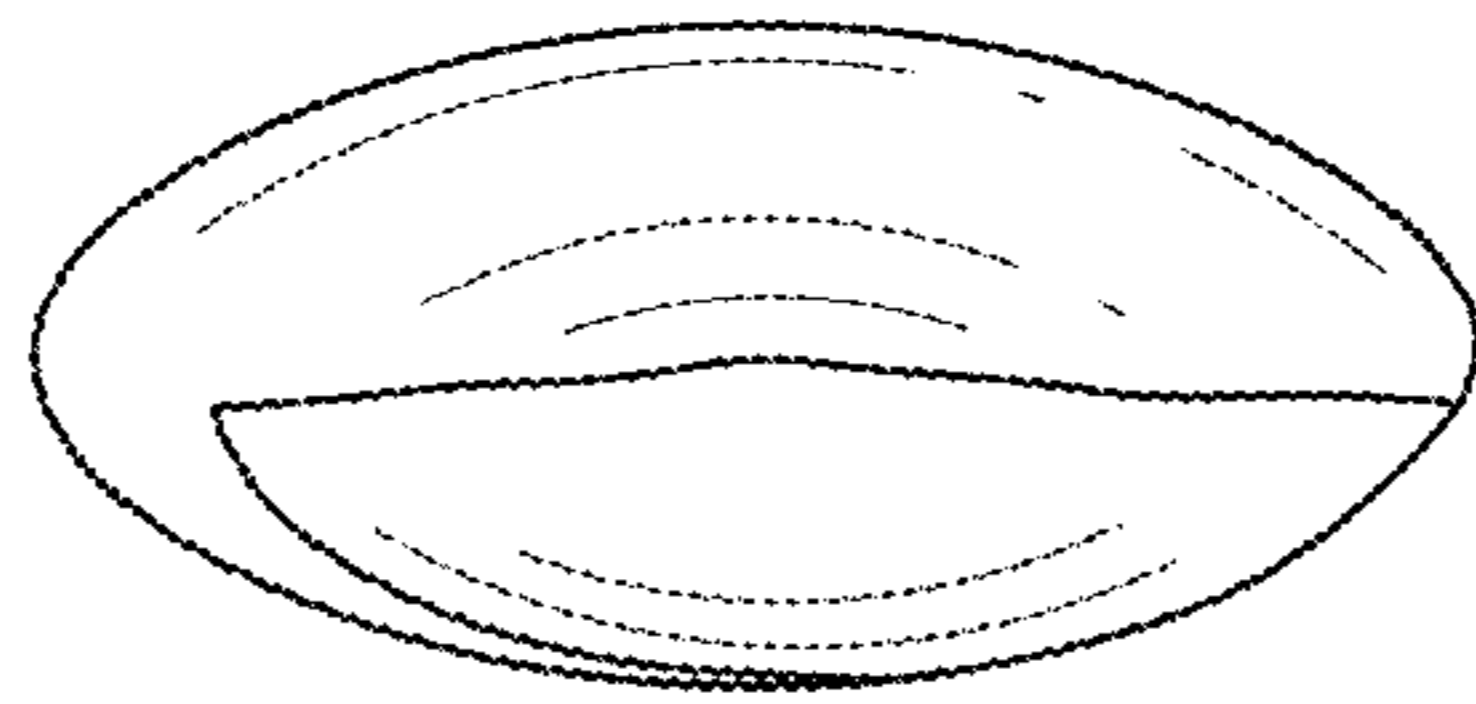

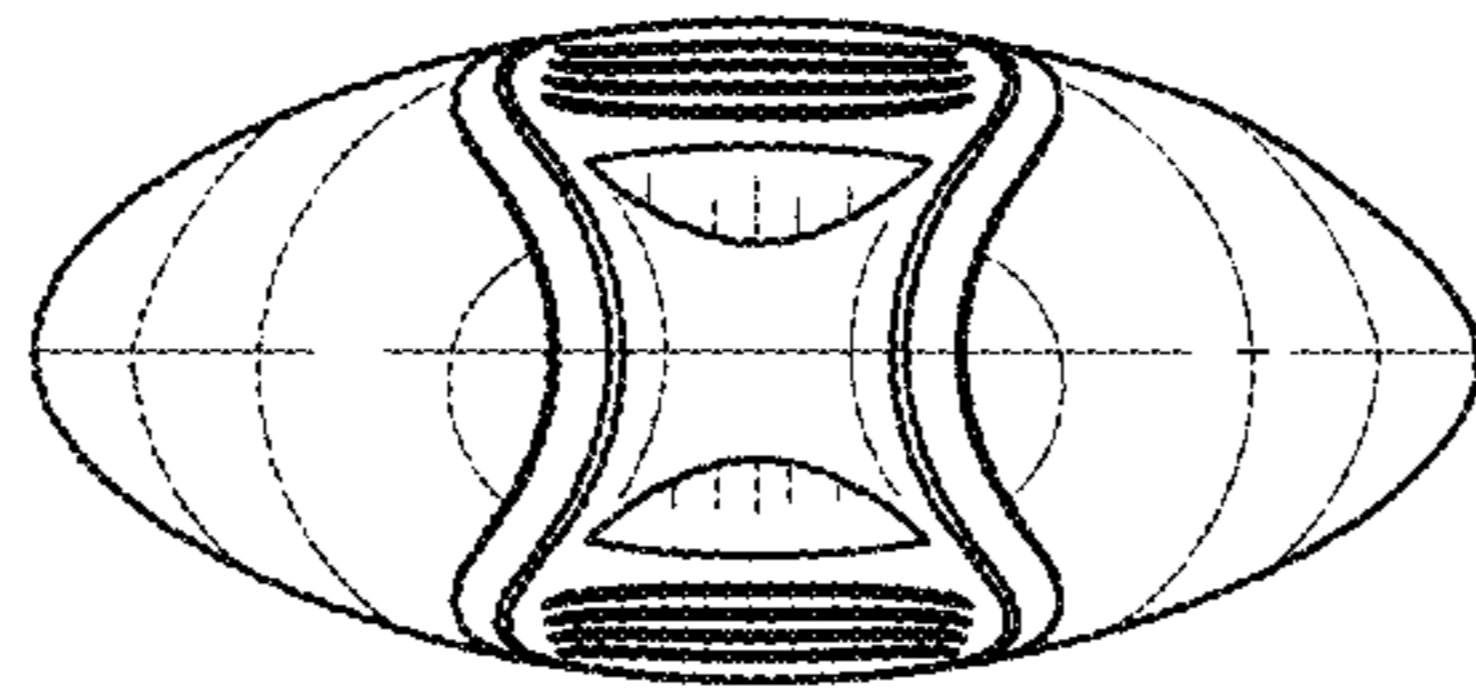
