FIG. 5 is a side view of the simulated crawling toy of FIG. 1. The broken lines are for illustrative purpose only and form no part of the claimed invention; and,

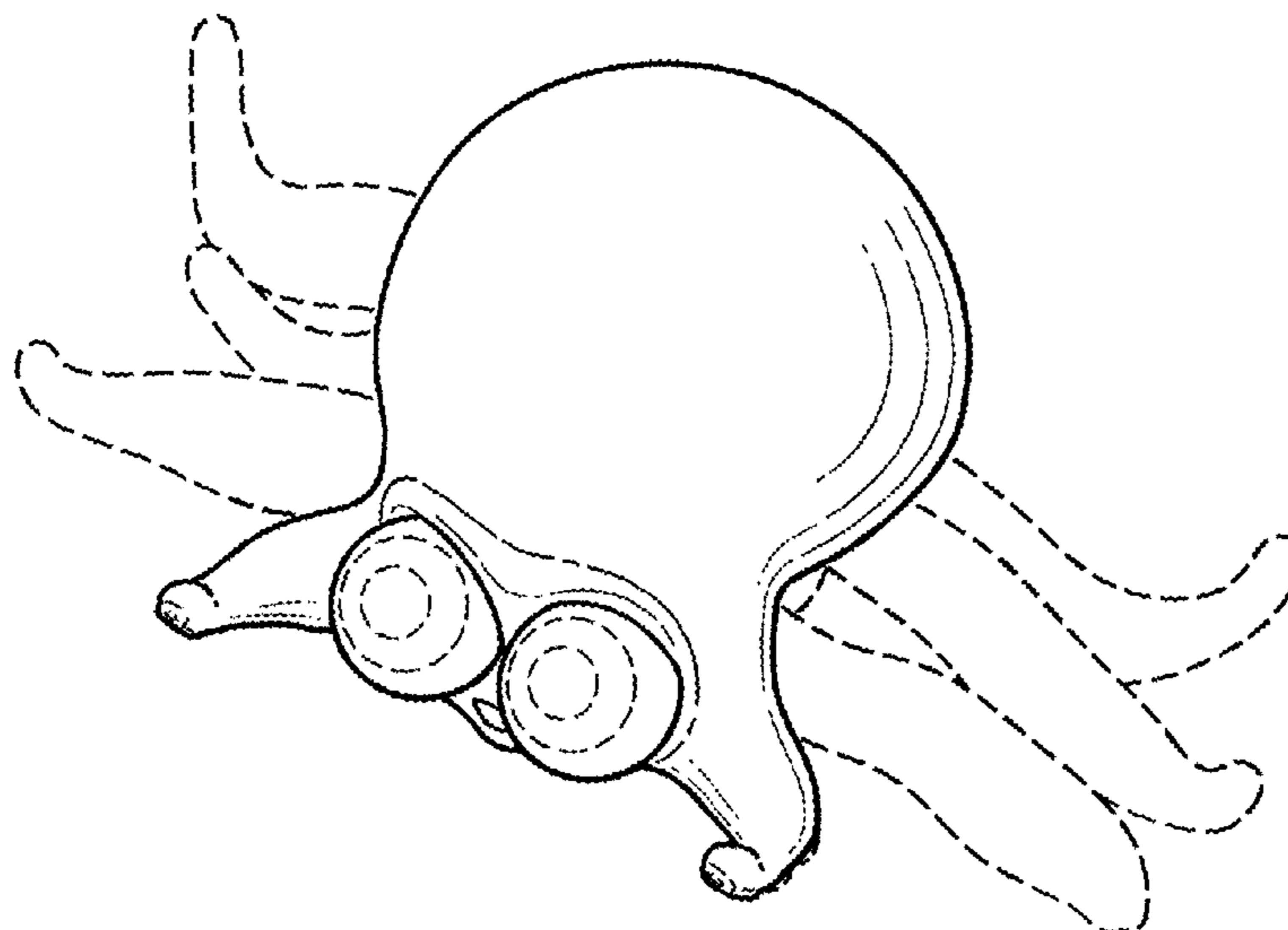
FIG. 6 is a top view of the simulated crawling toy of FIG. 1. The broken lines are for illustrative purpose only and form no part of the claimed invention.

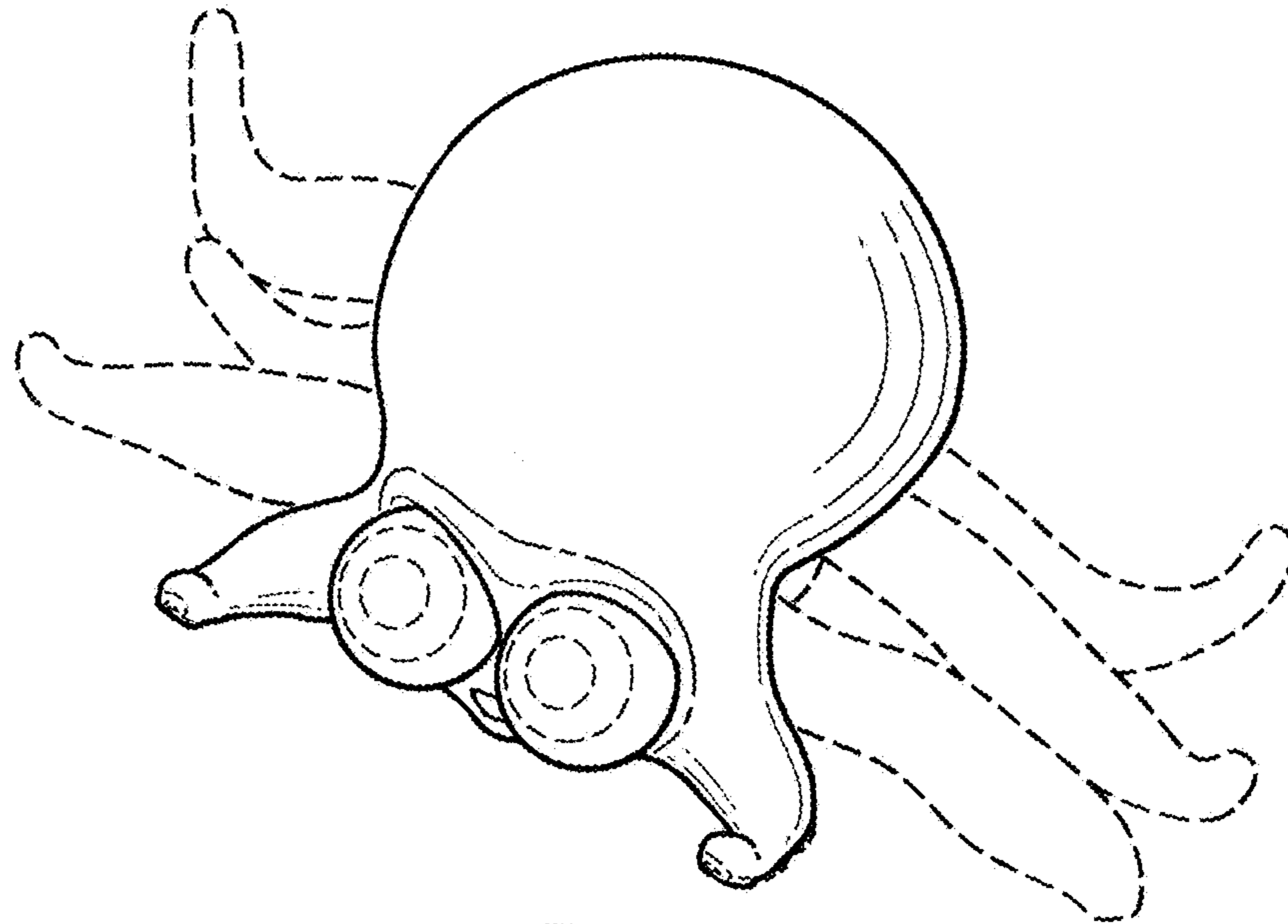

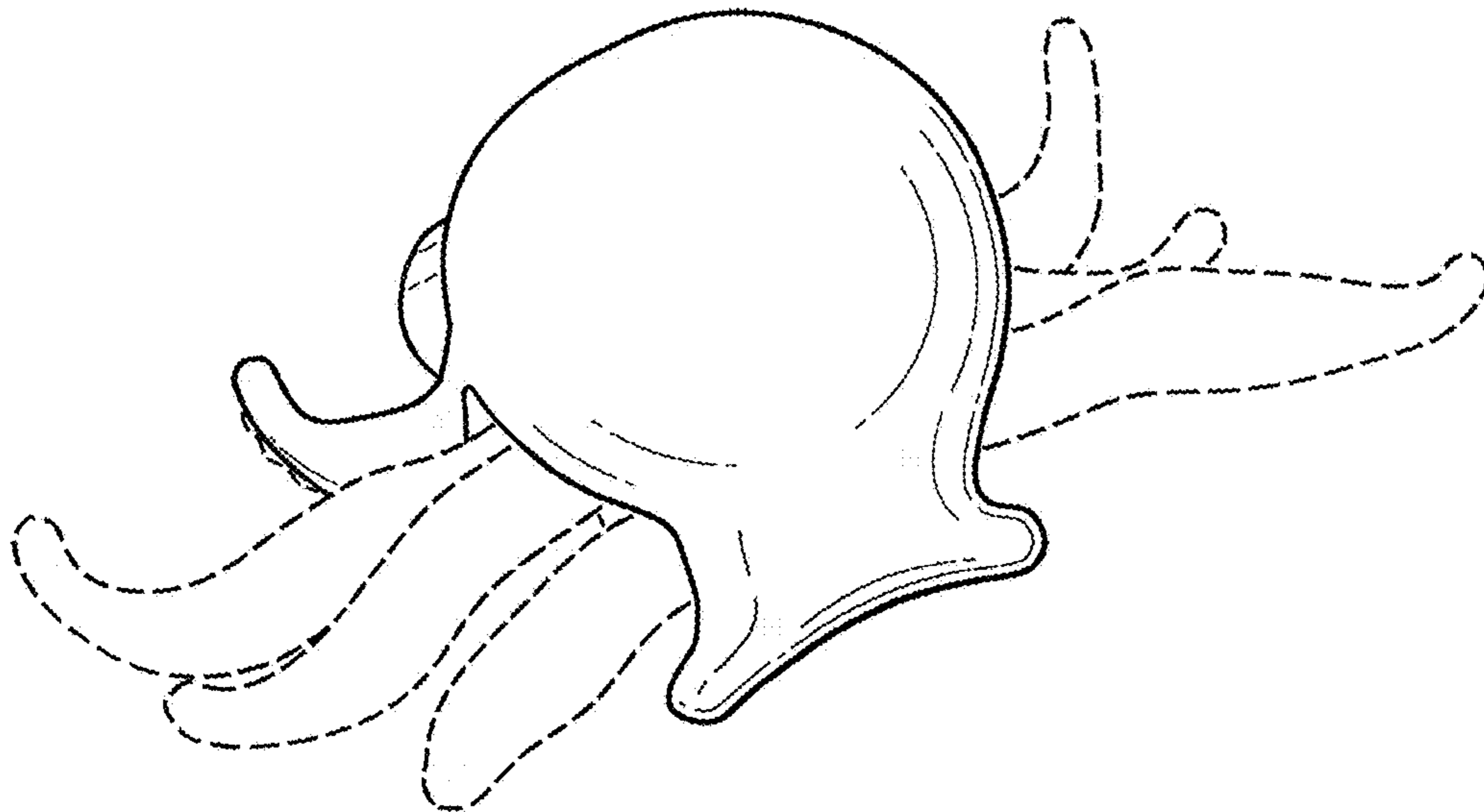

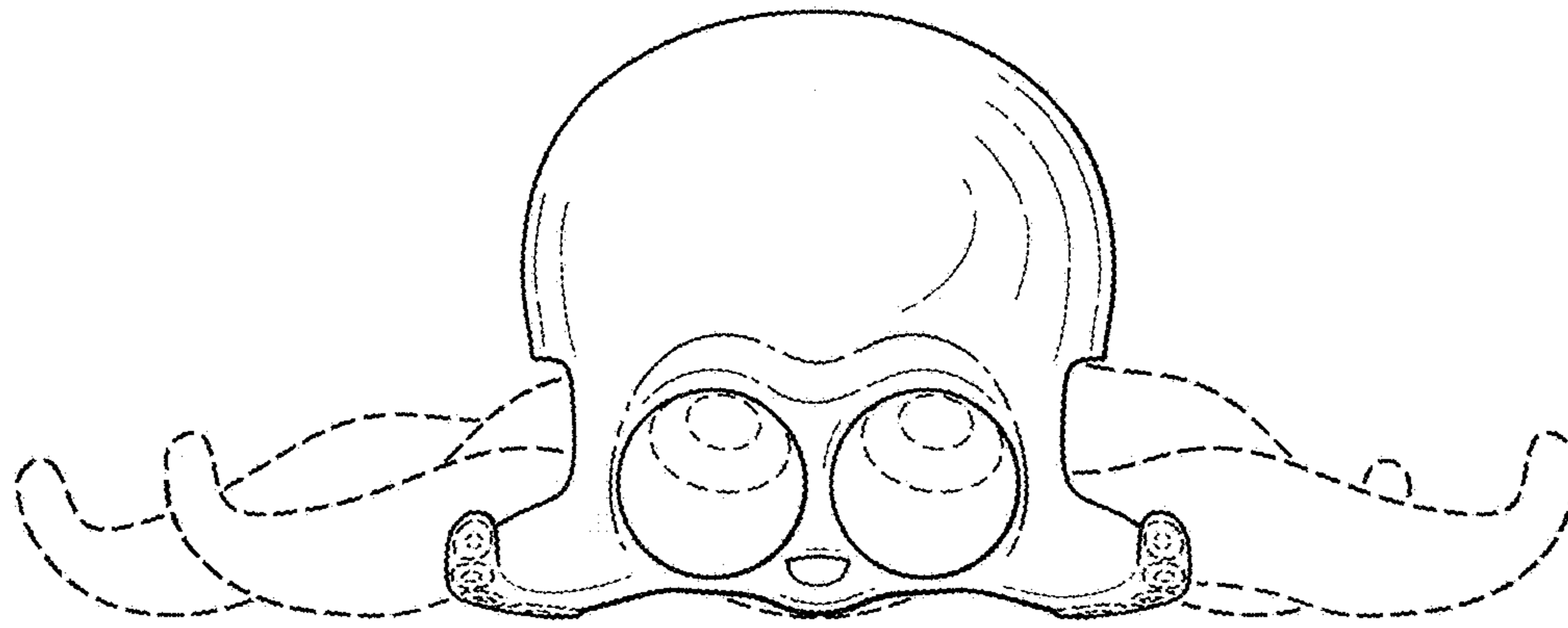

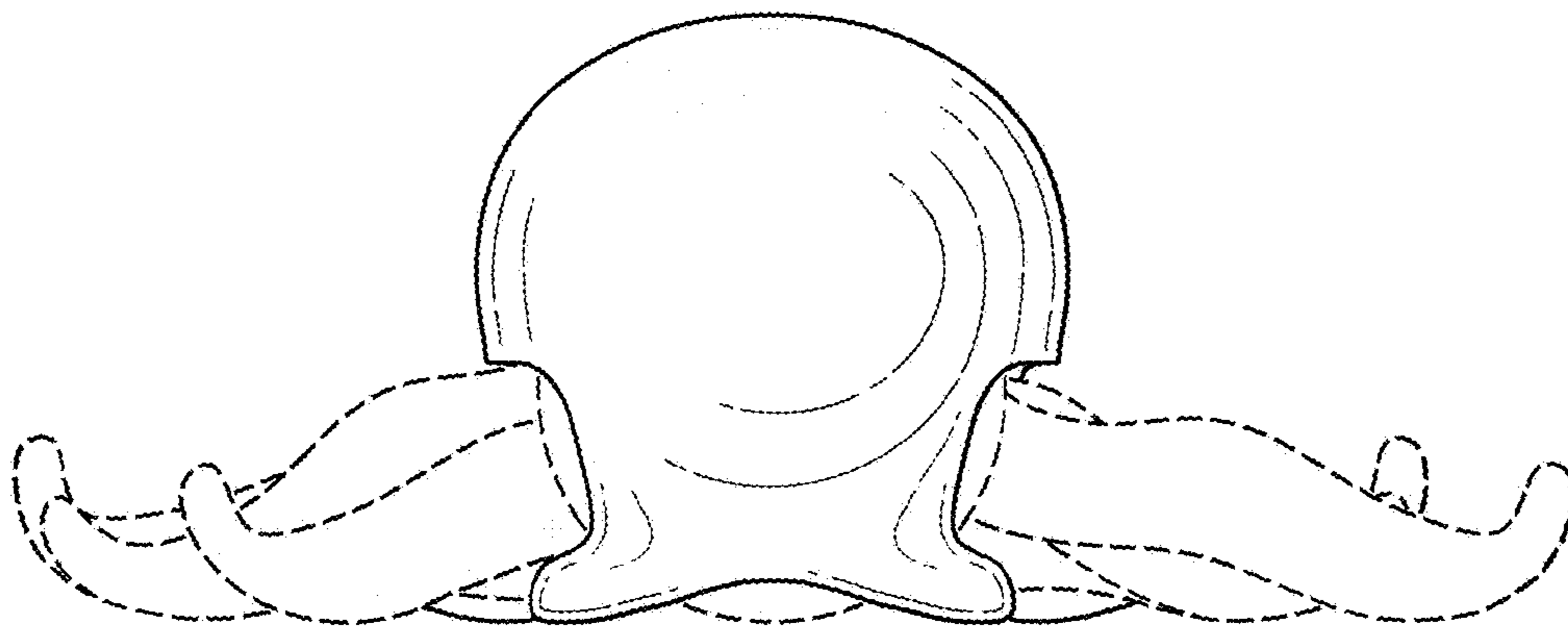

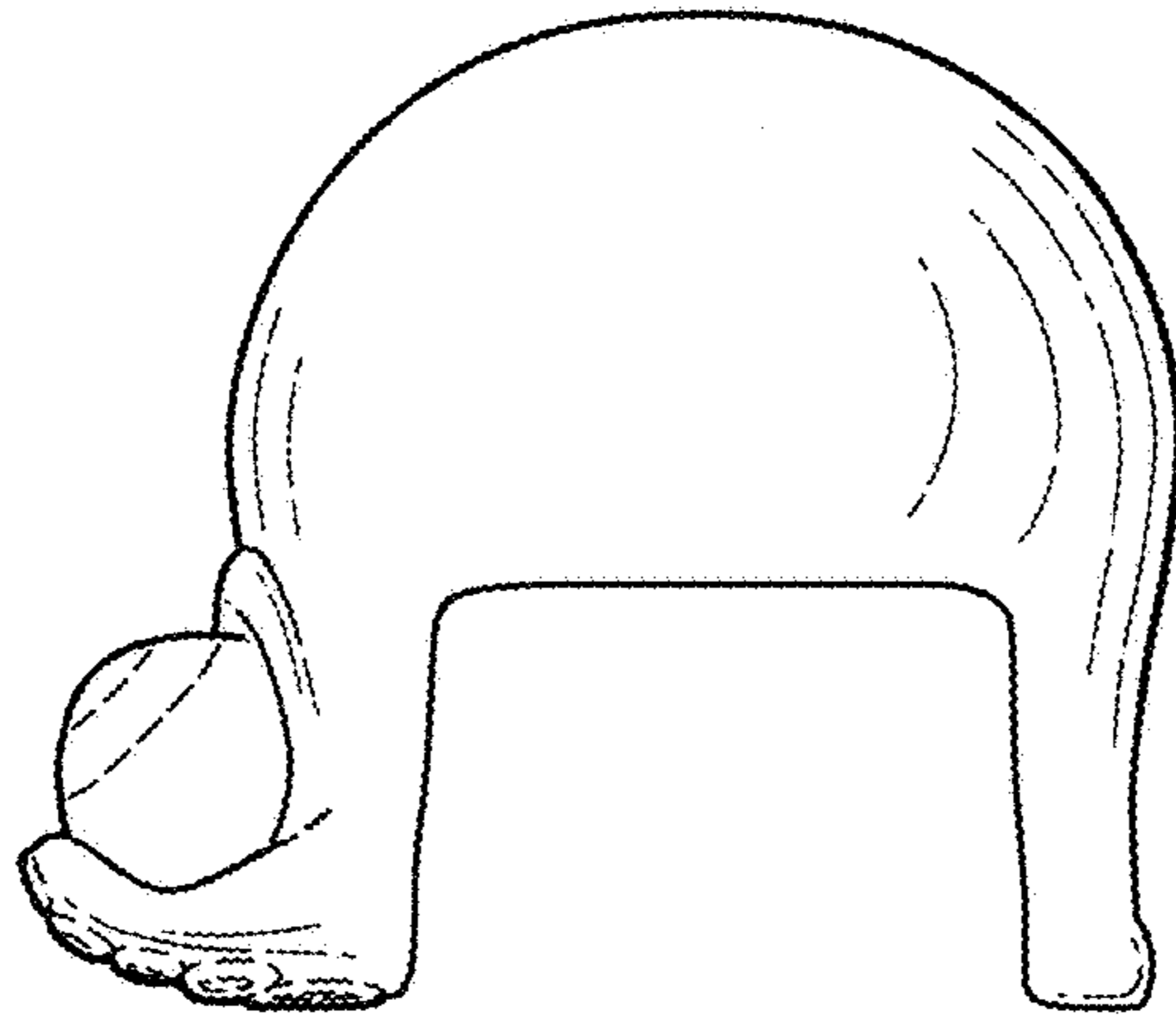

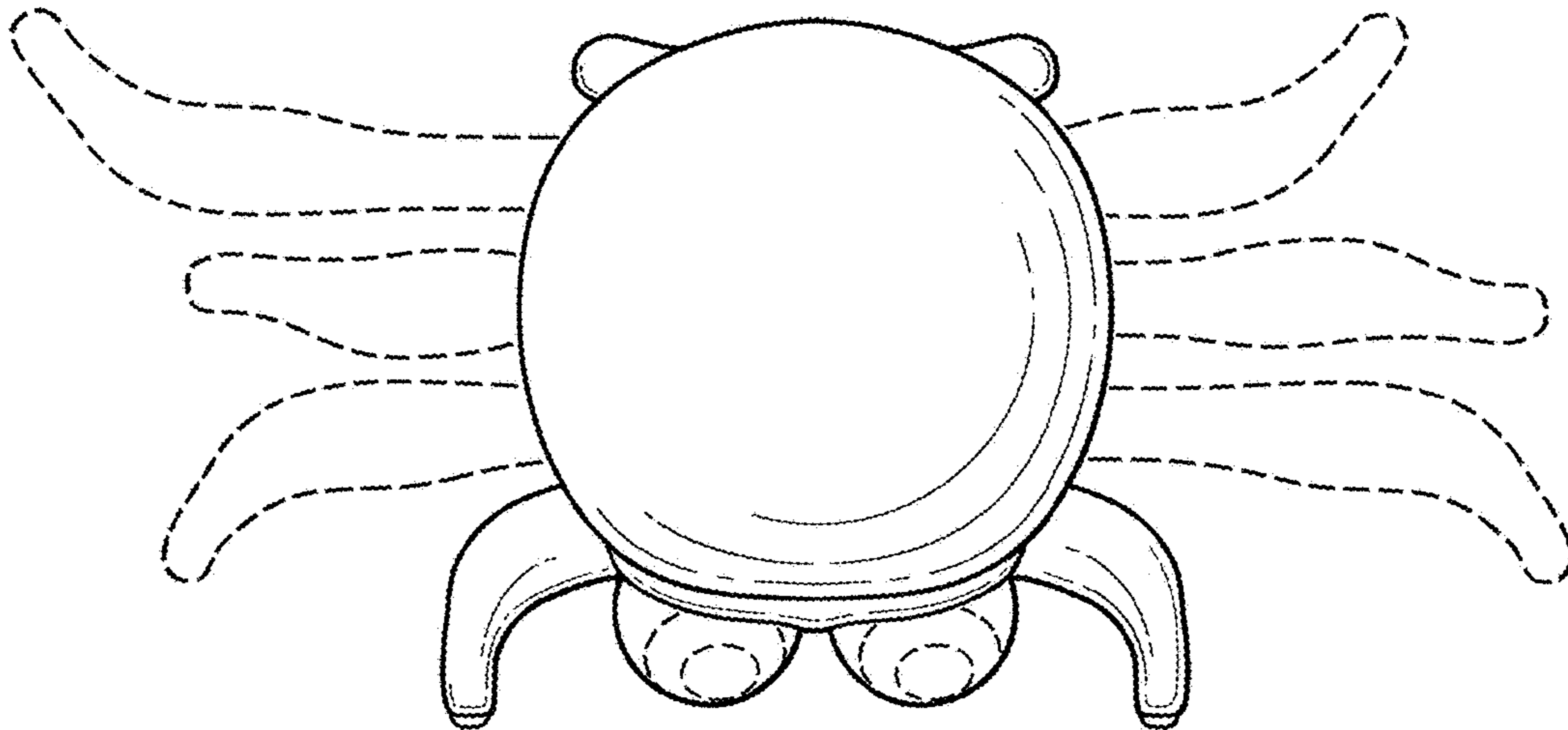
