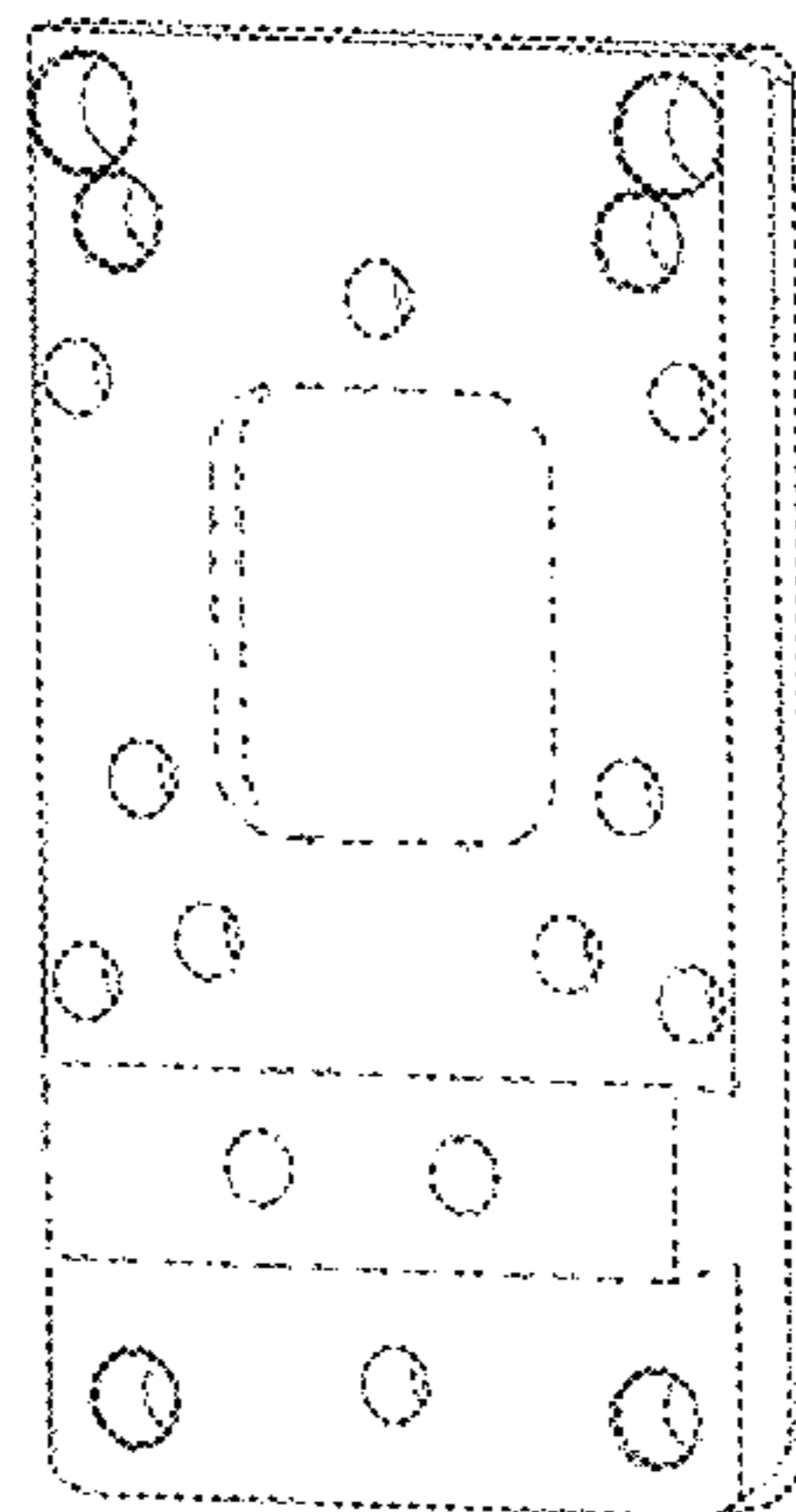
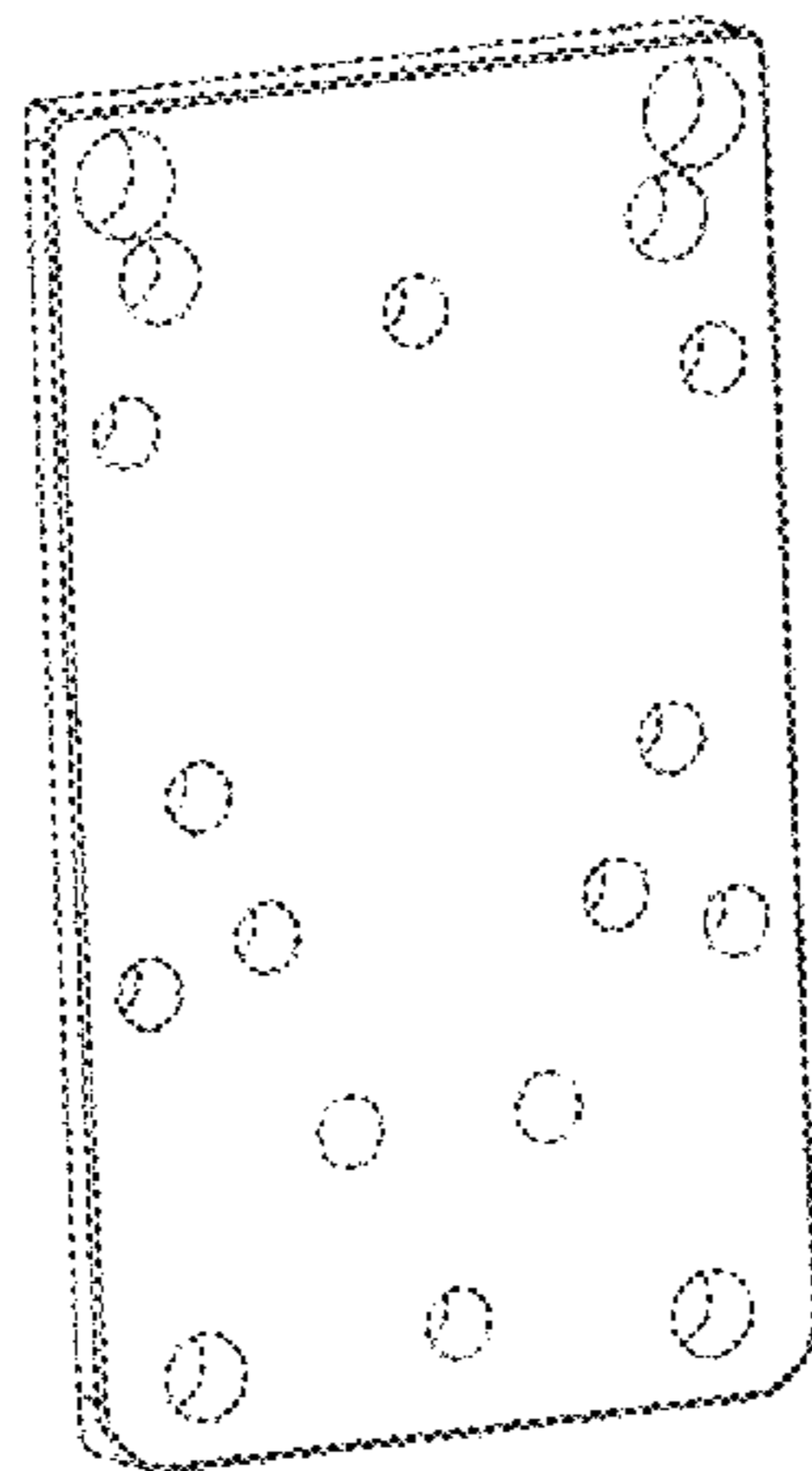
(57) **CLAIM**

The ornamental design for a perforated plate for firearms, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of the perforated plate for firearms;
FIG. 2 is a rear perspective view of FIG. 1;
FIG. 3 is a front elevational view of FIG. 1;
FIG. 4 is a rear elevational view of FIG. 1;
FIG. 5 is a left elevation view of FIG. 1, the right side being a mirror image; and,
FIG. 6 is a bottom plan view of FIG. 1.

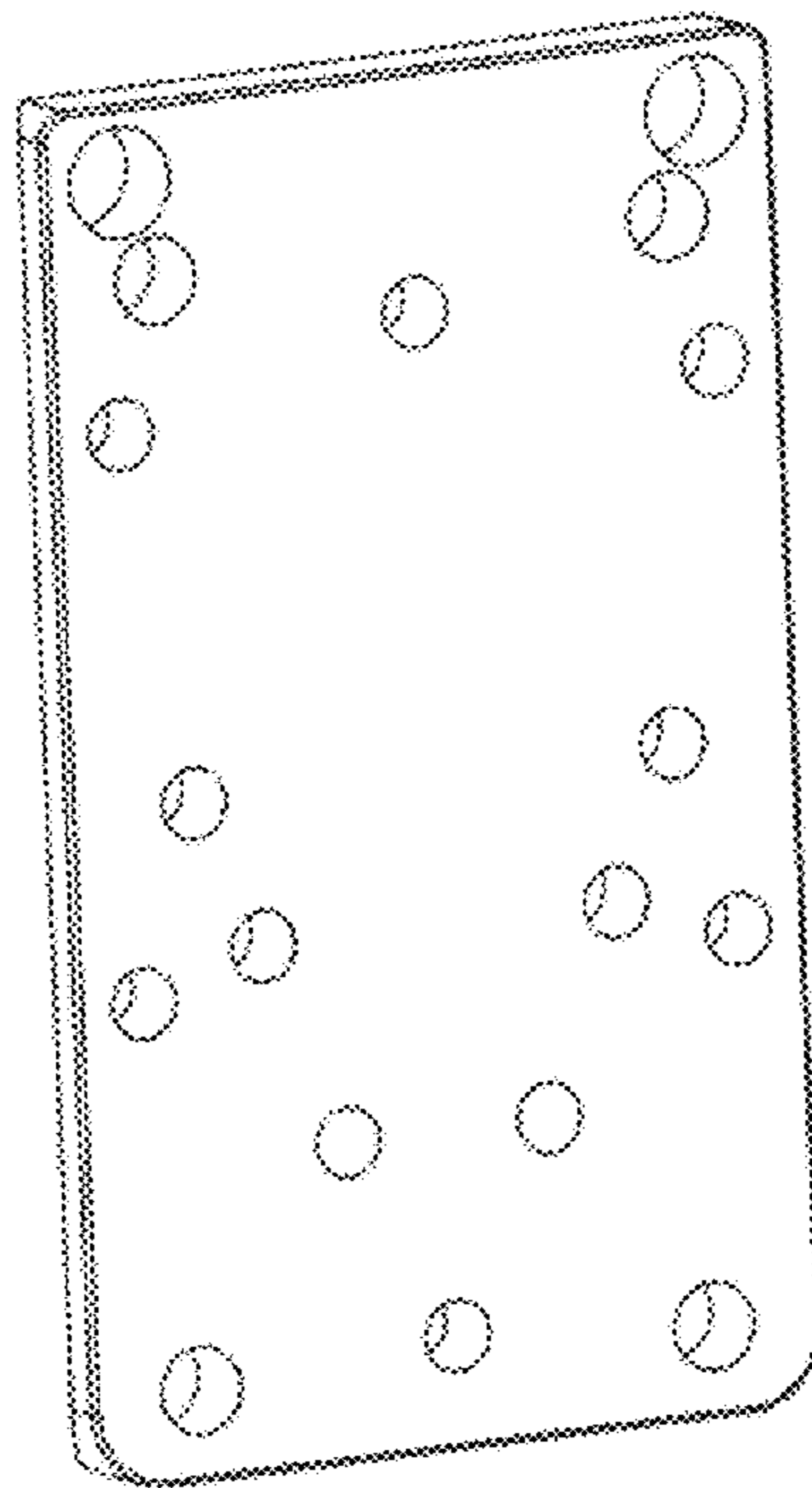

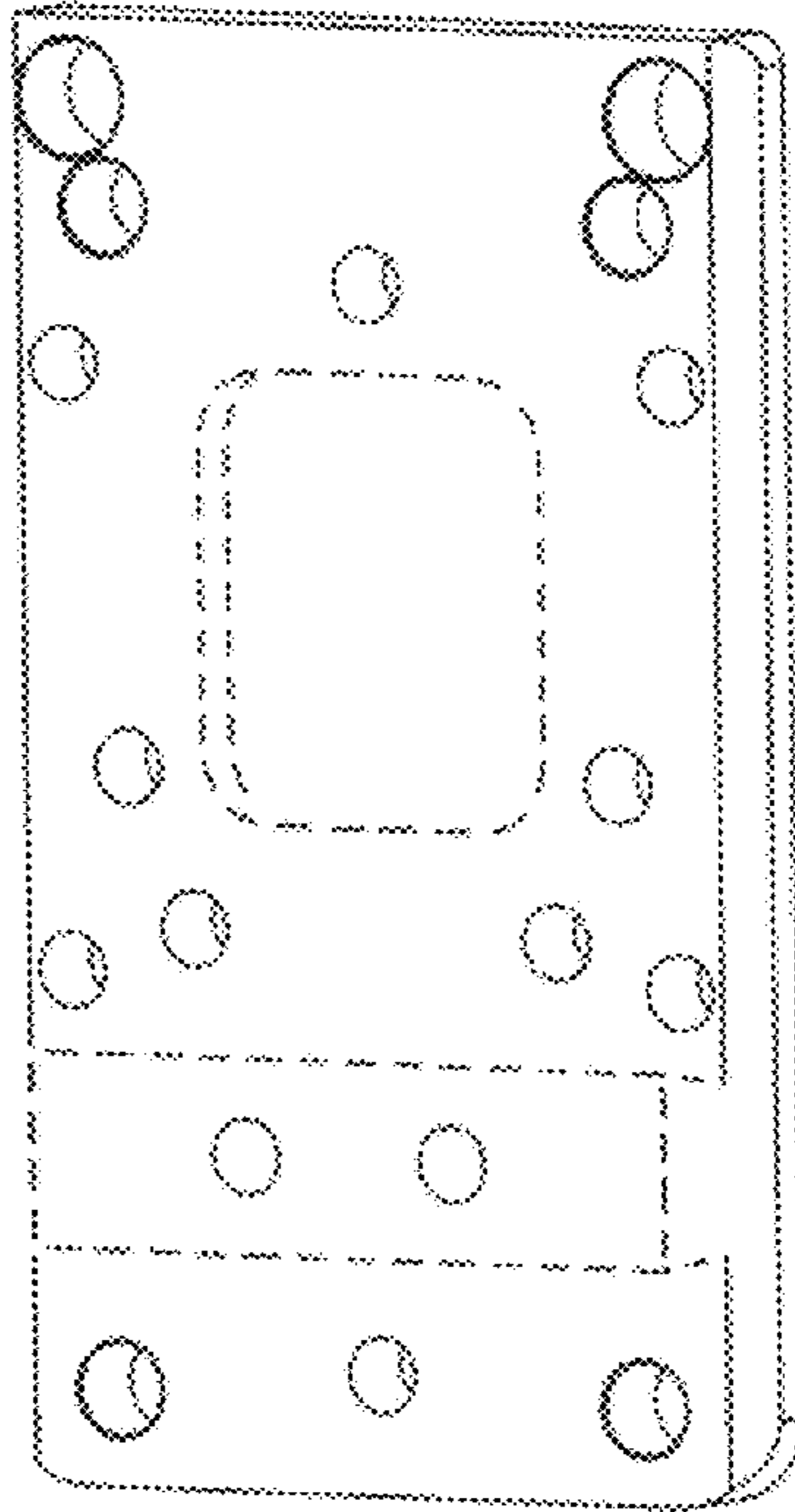

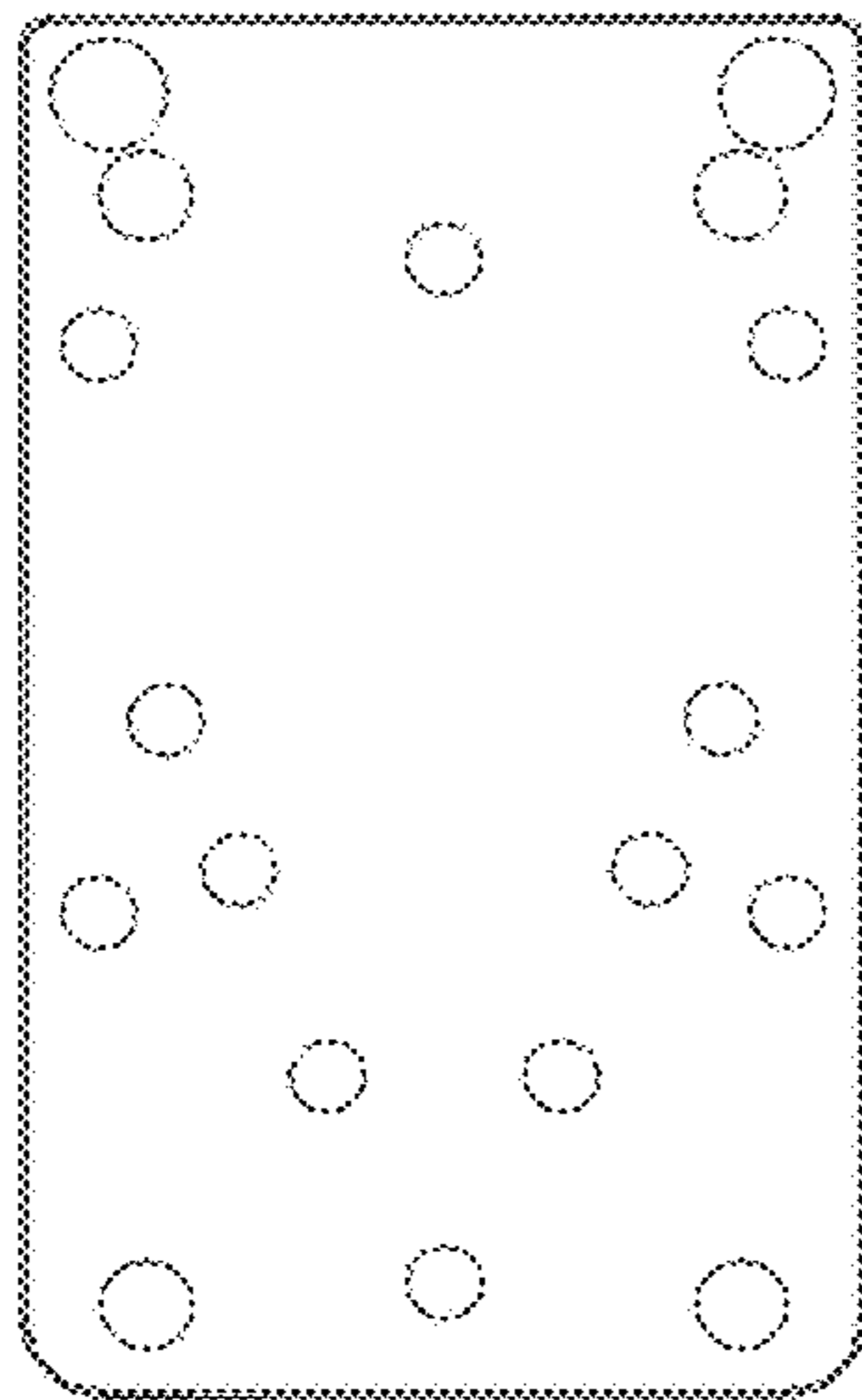

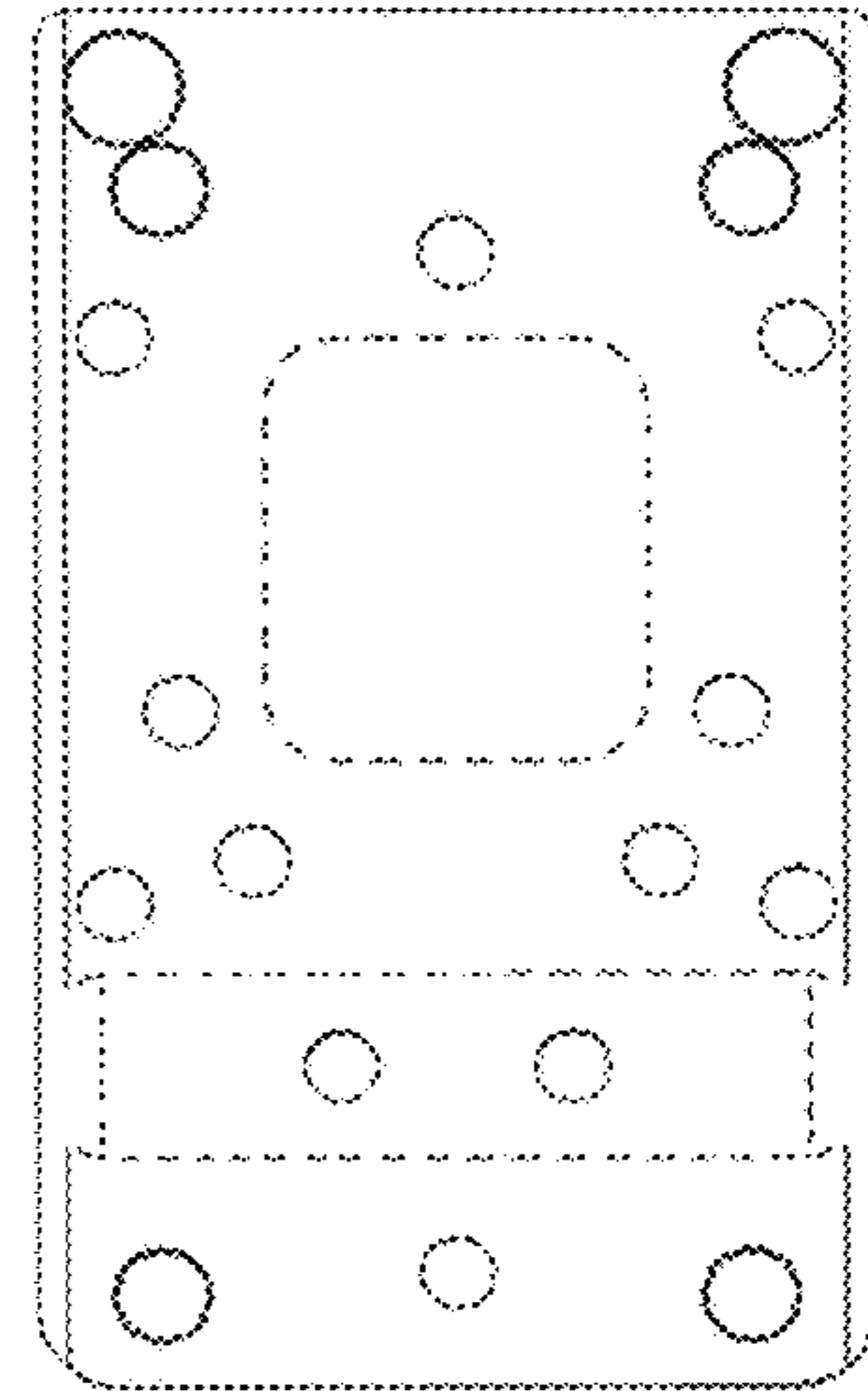

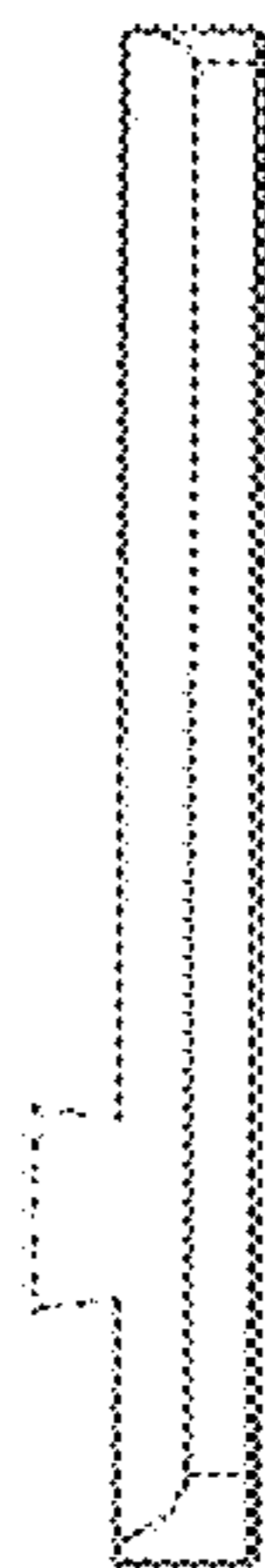

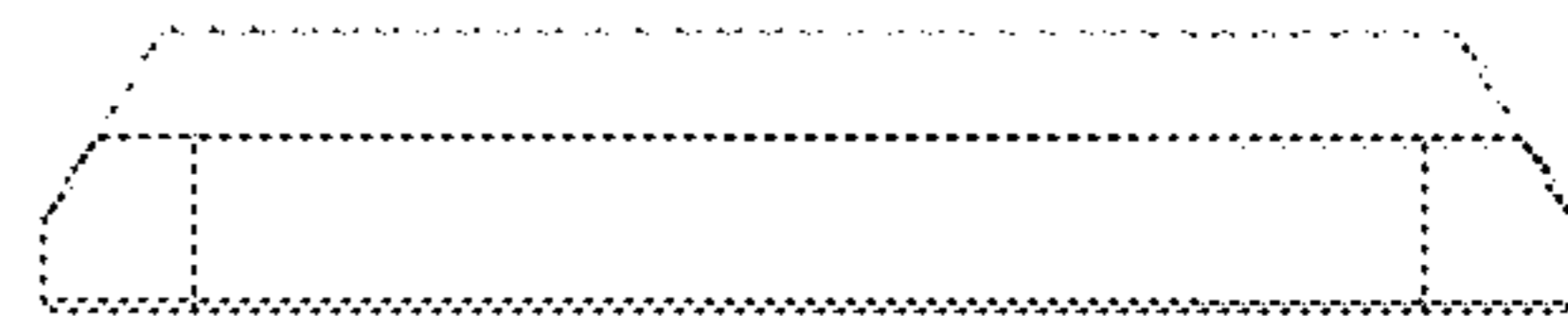
