 FIG. 7 is a top plan view thereof.

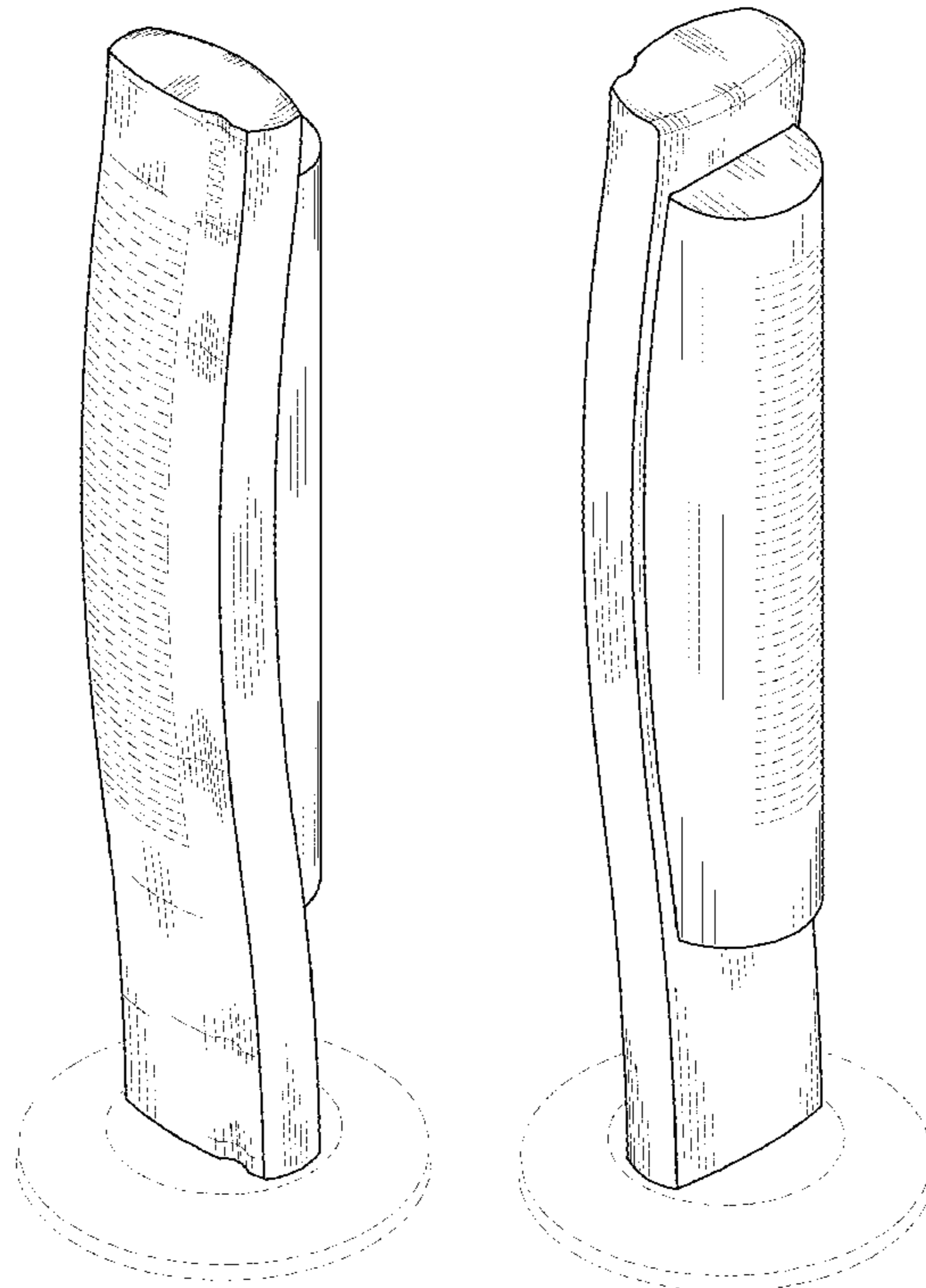
The broken line showing of a front grill area, rear grill area, front controls and support base are included for the purpose of illustrating environmental structure and forms no part of the claimed design.

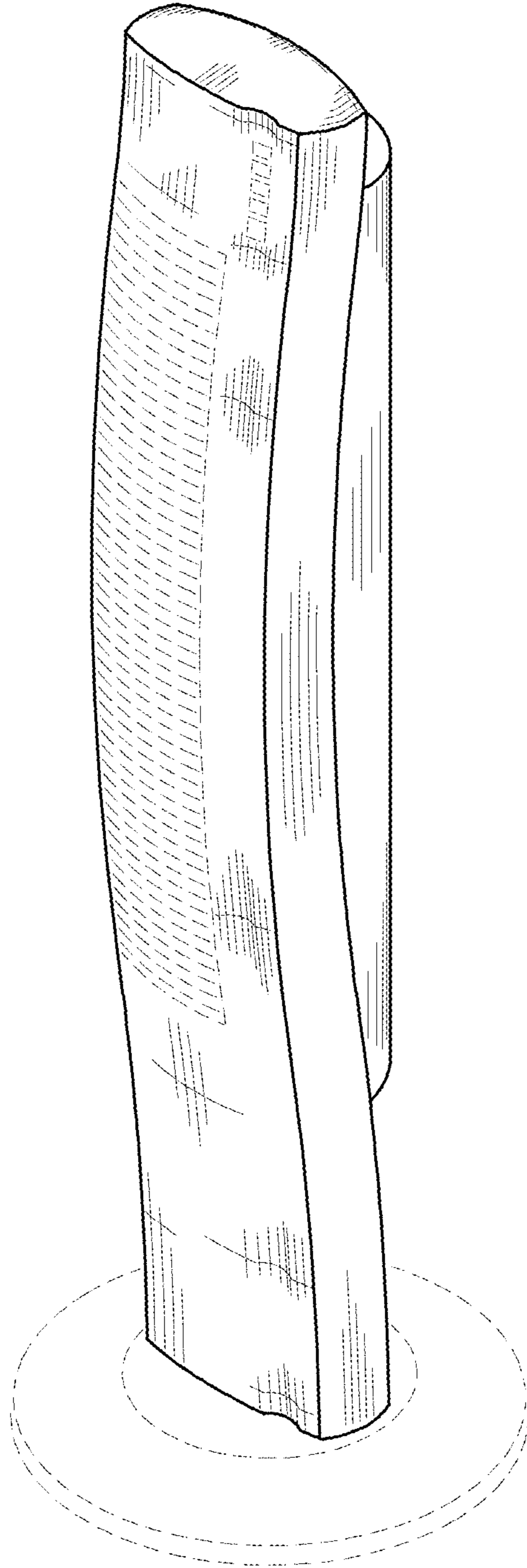

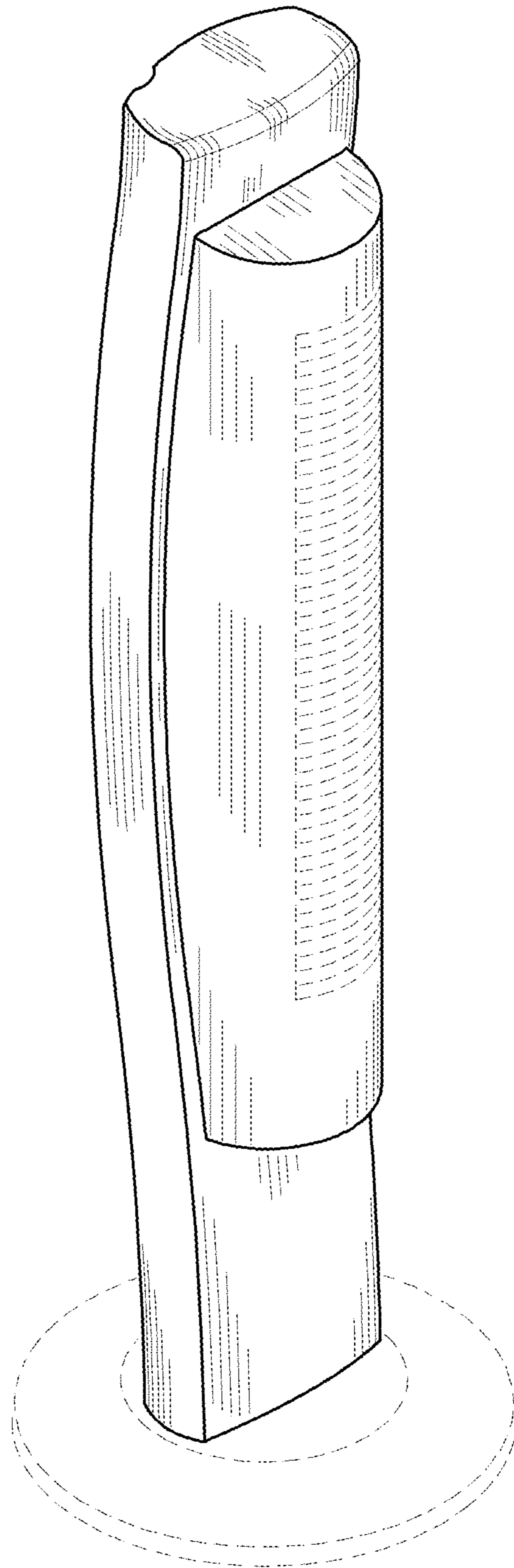

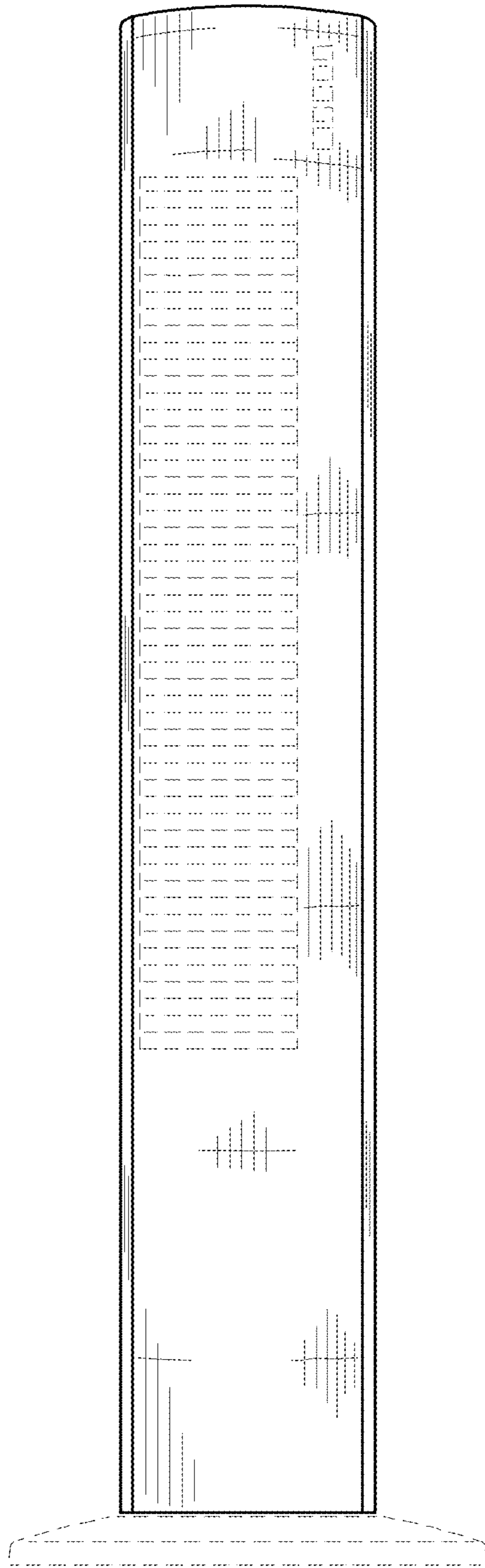

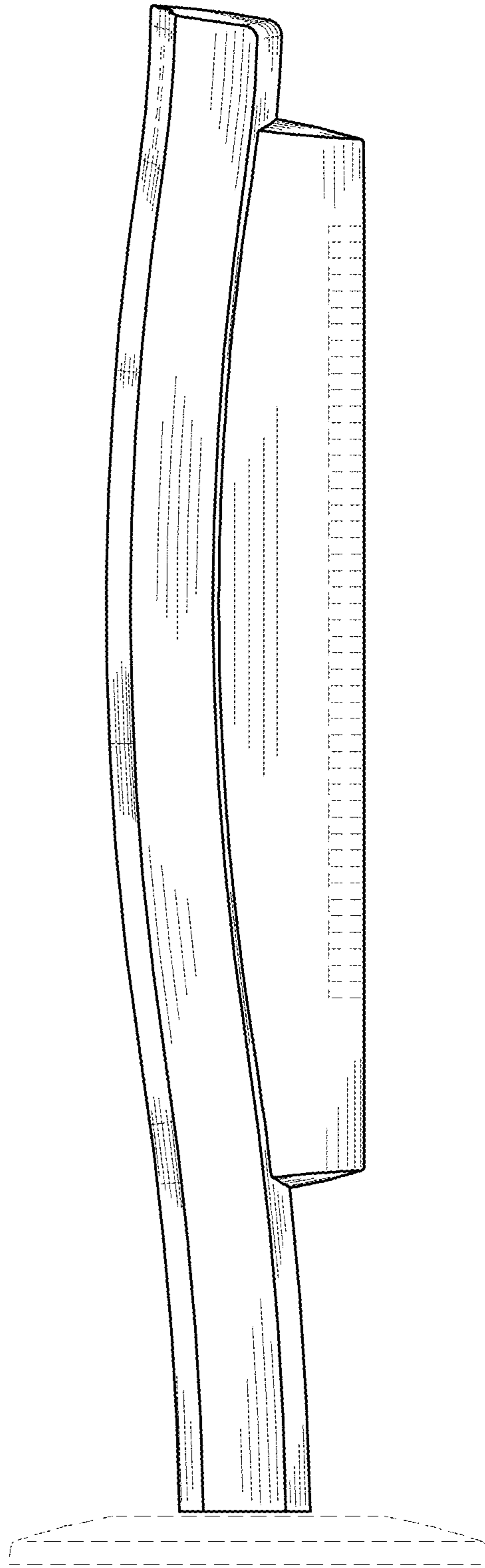

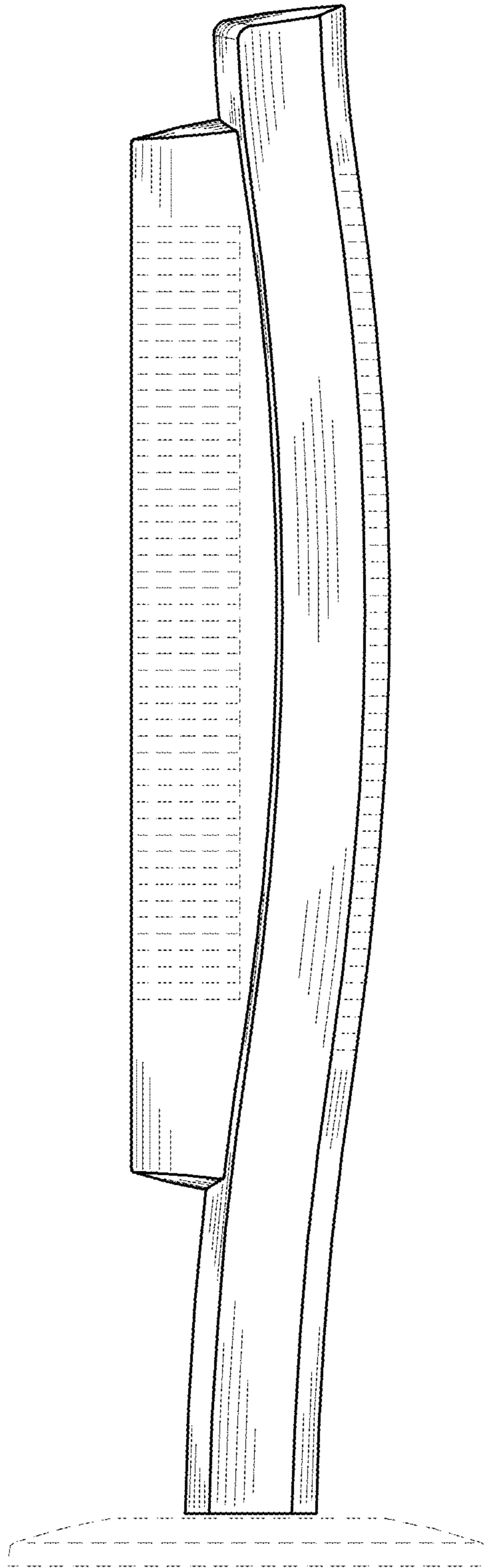

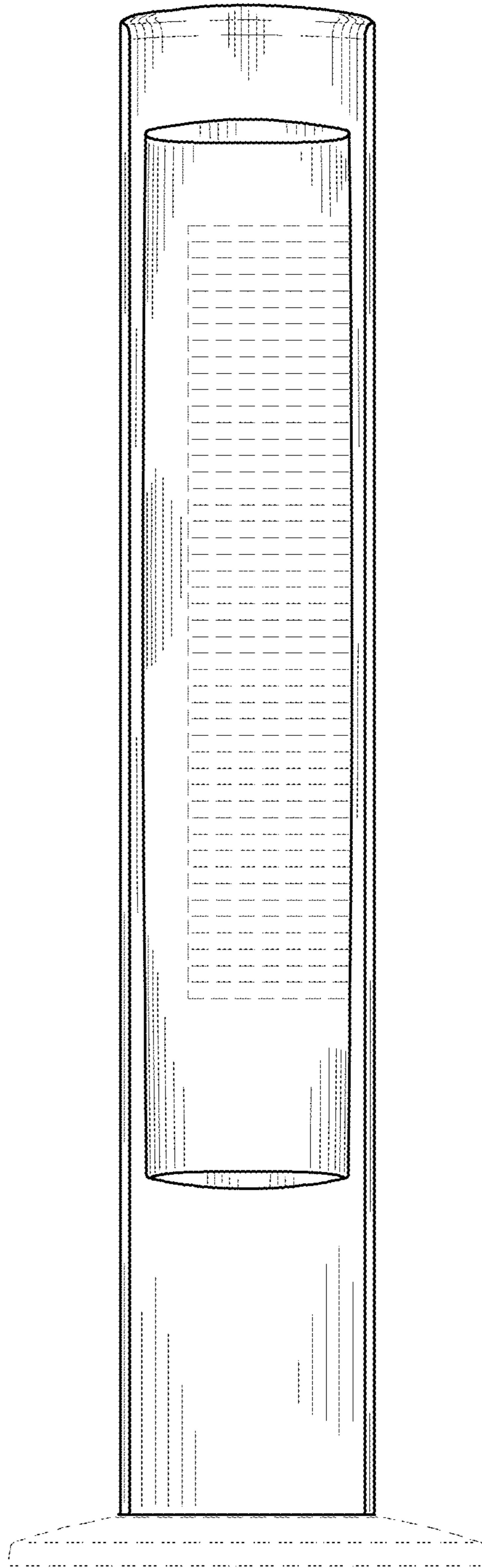

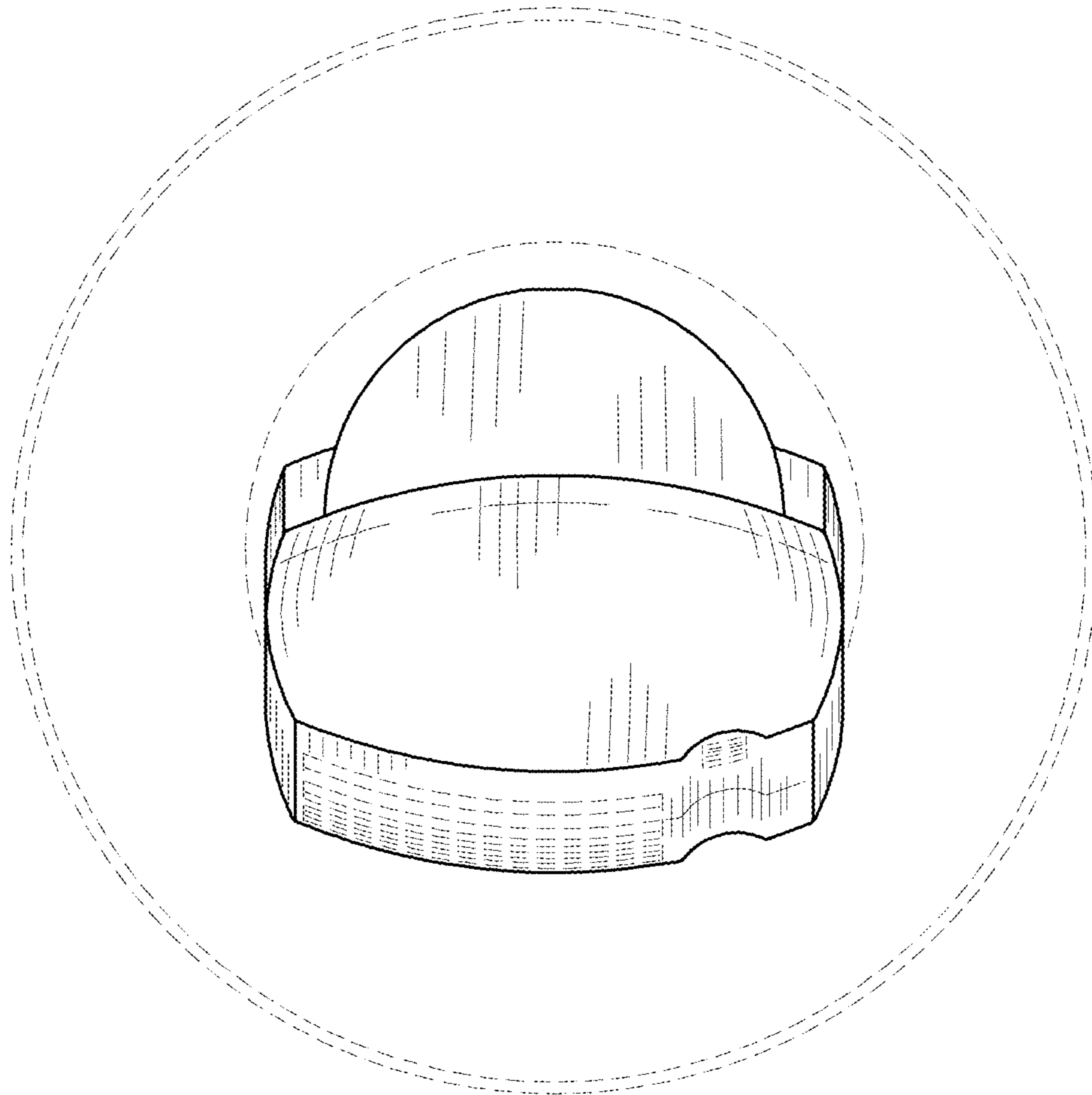
