and described.

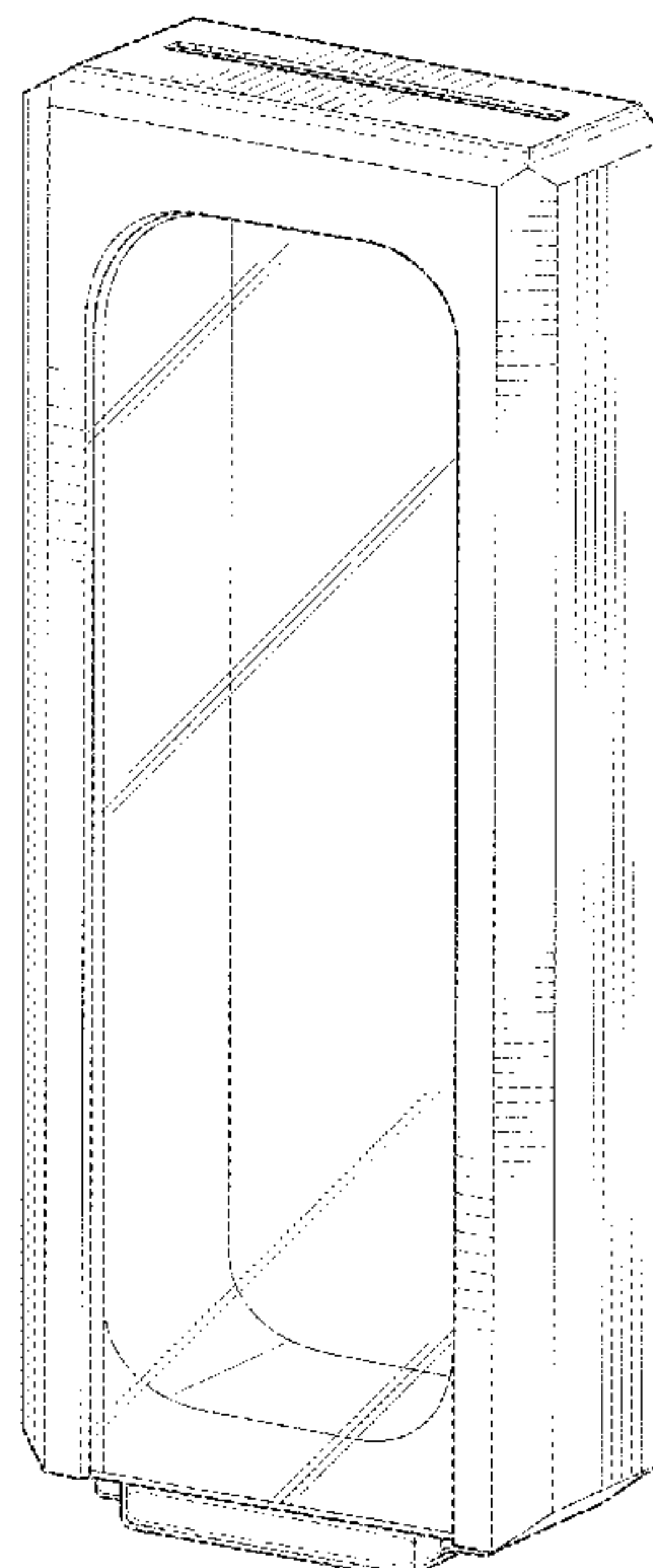
DESCRIPTION

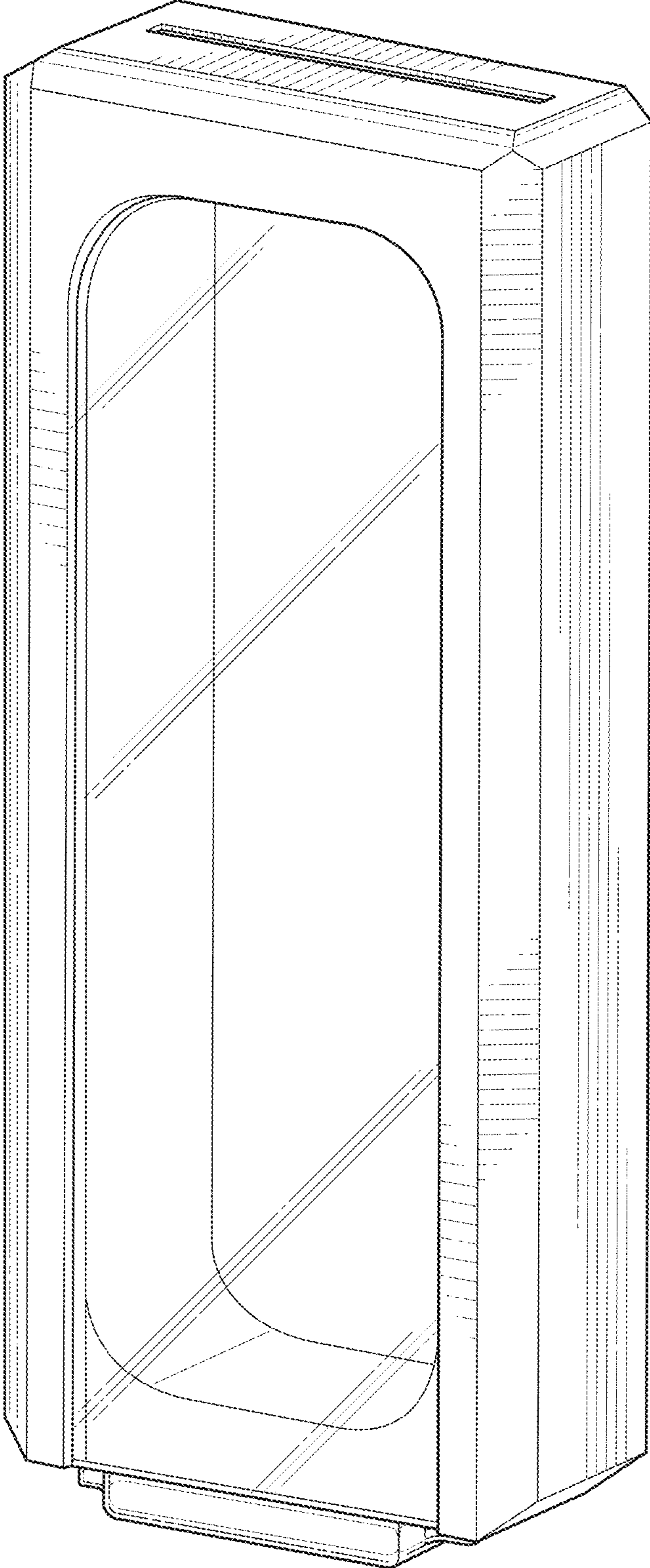

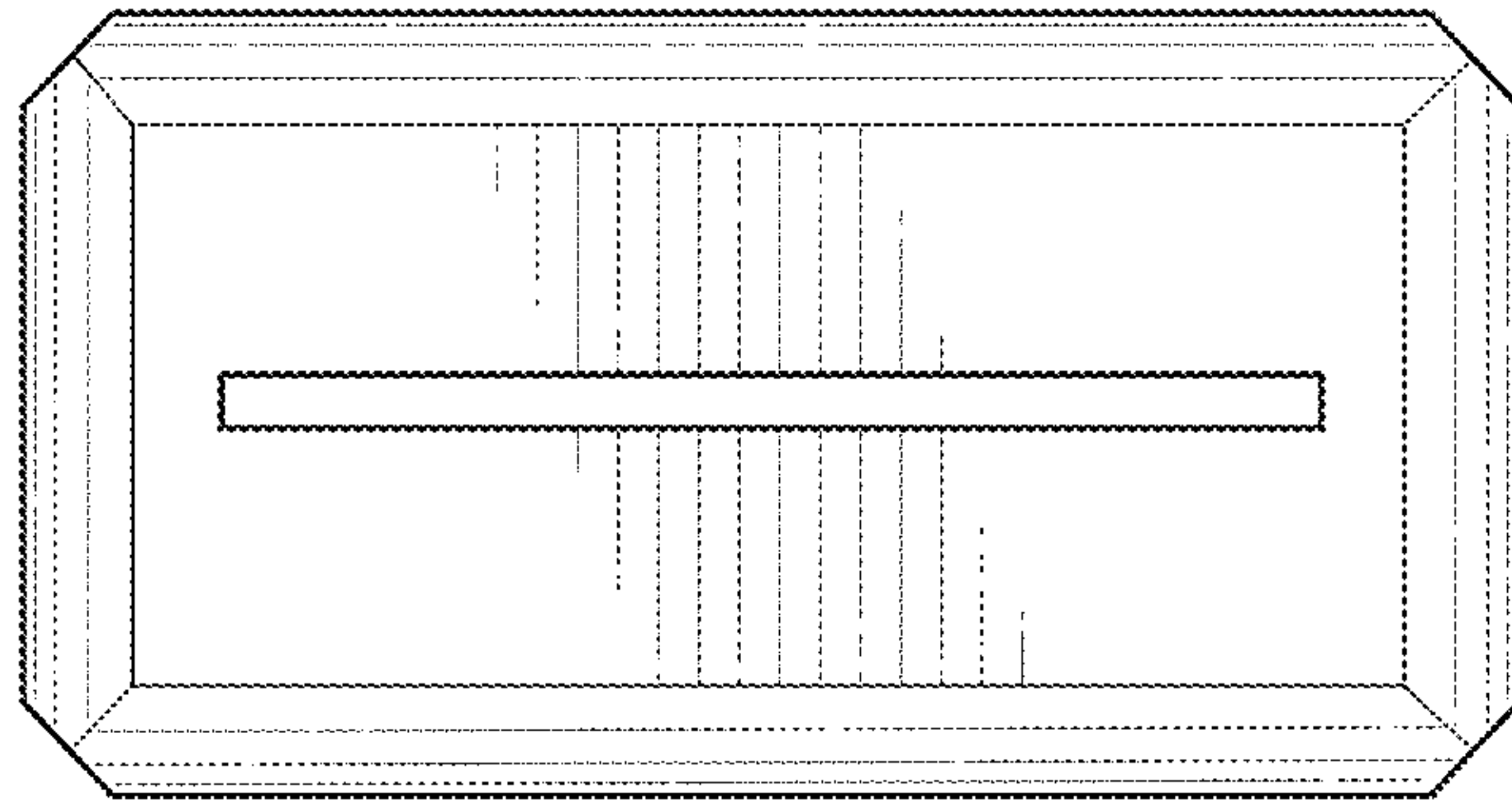

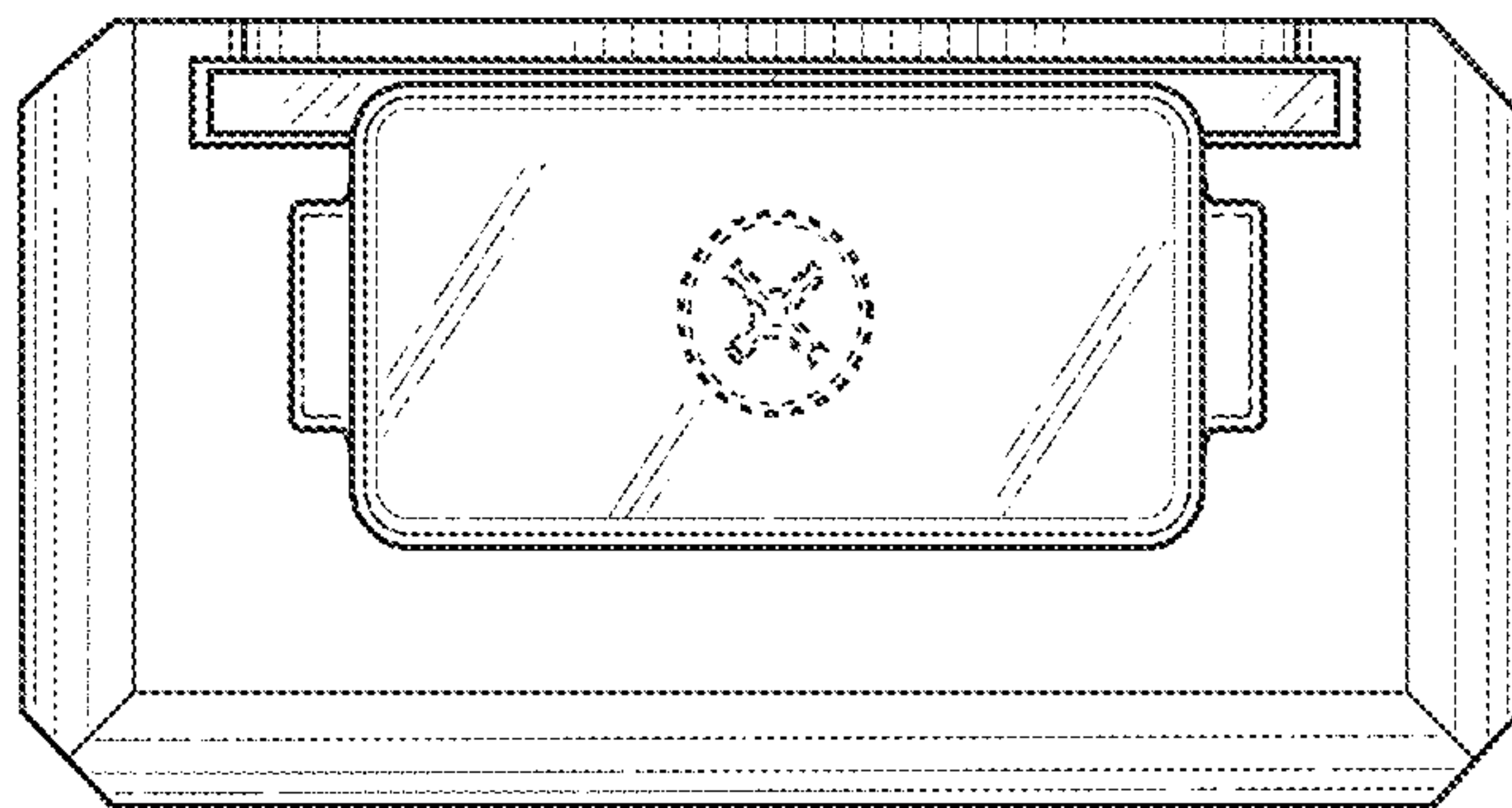

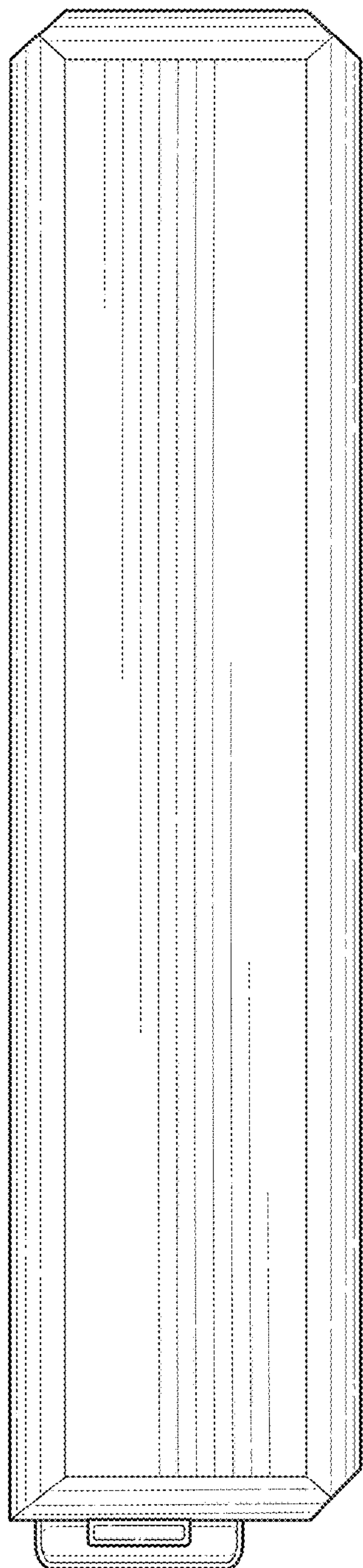

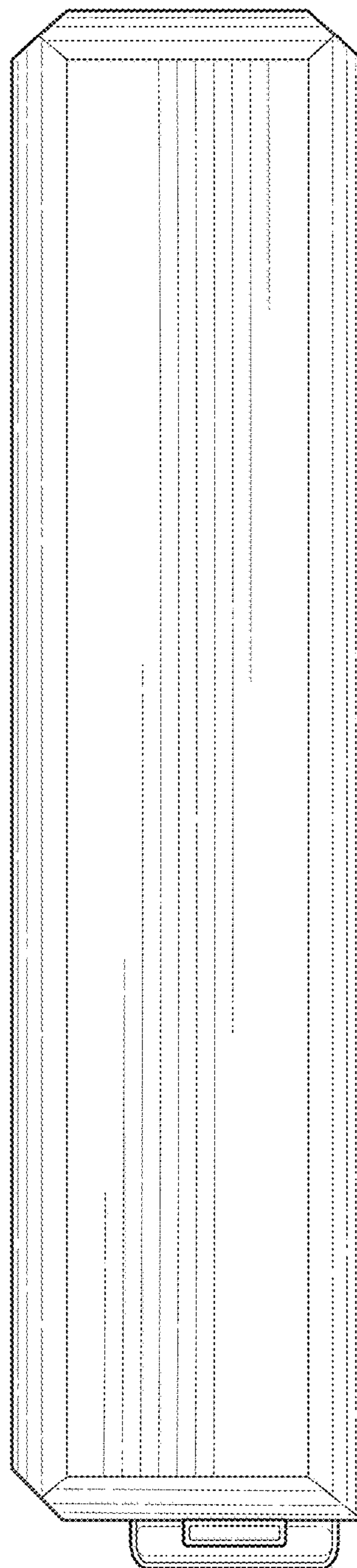

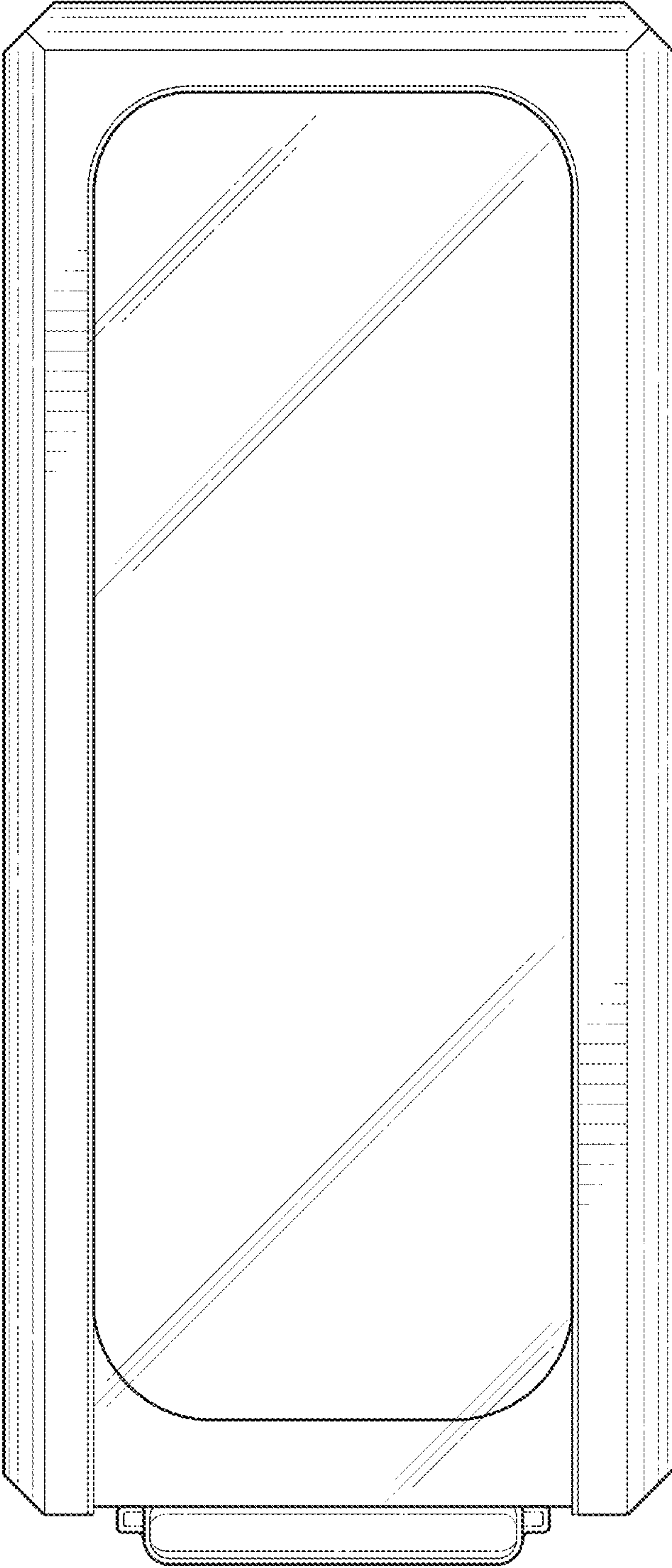

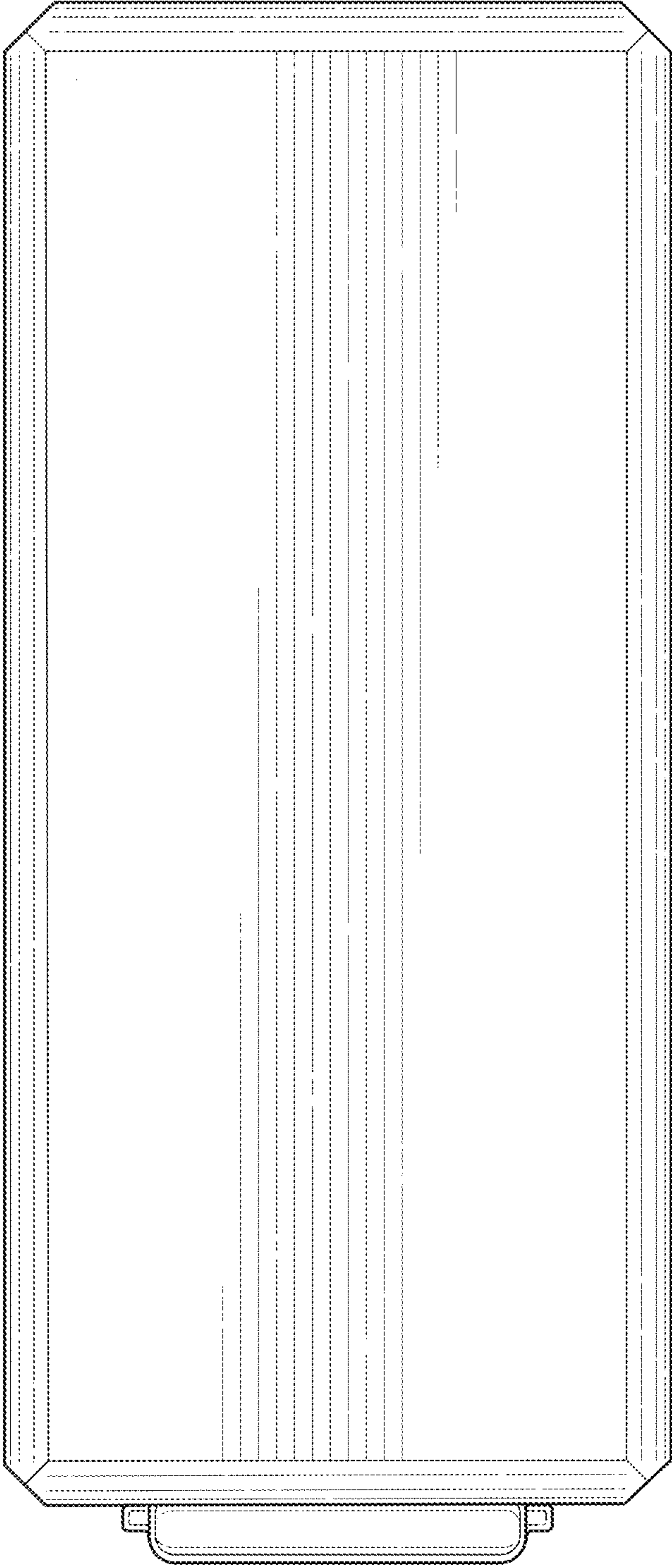
