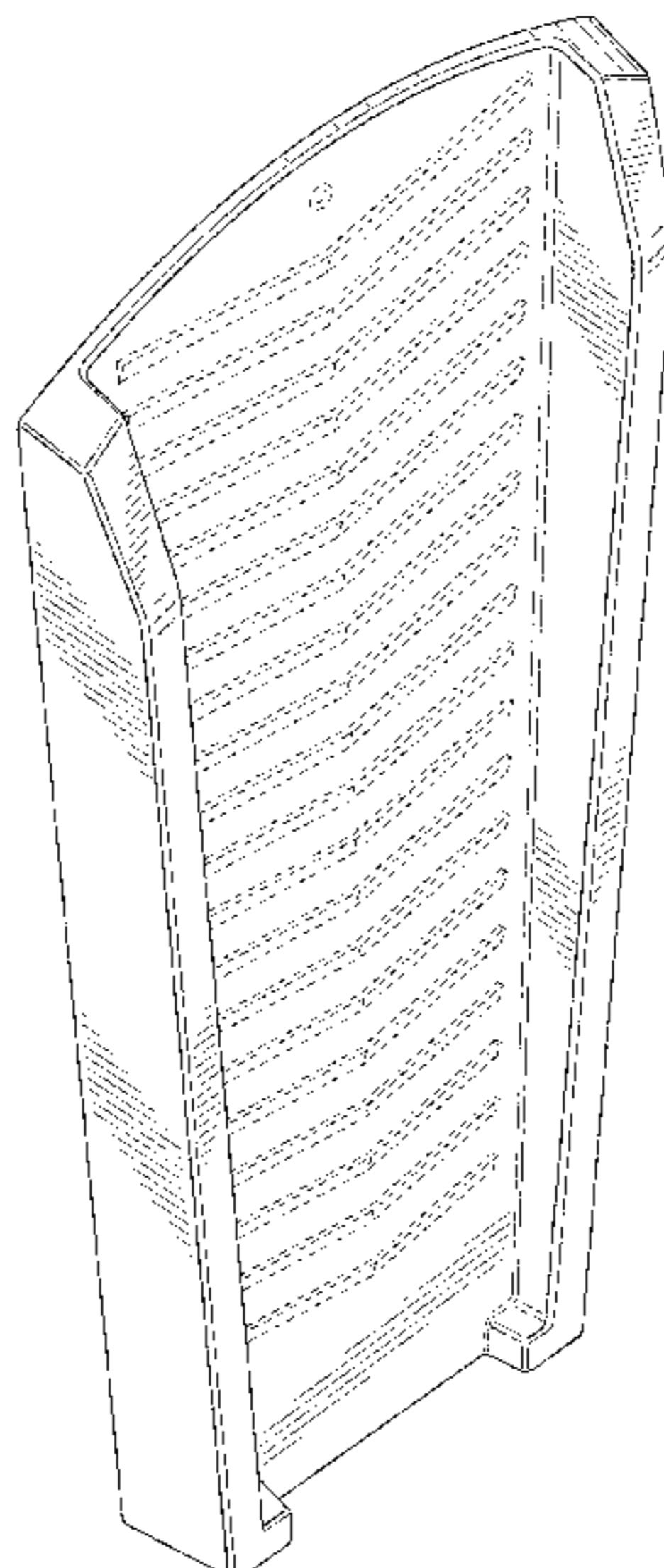
(57) **CLAIM**

The ornamental design for a splash block, as shown and described.

DESCRIPTION

FIG. 1 is a perspective top view of a splash block.
FIG. 2 is a top view of the splash block of FIG. 1.
FIG. 3 is a bottom view of the splash block of FIG. 1.
FIG. 4 is a left side view of the splash block of FIG. 1.
FIG. 5 is a right side view of the splash block of FIG. 1.
FIG. 6 is a front view of the splash block of FIG. 1; and,
FIG. 7 is a rear view of the splash block of FIG. 1.
The broken lines depict portions of the splash block that form no part of the claimed design.

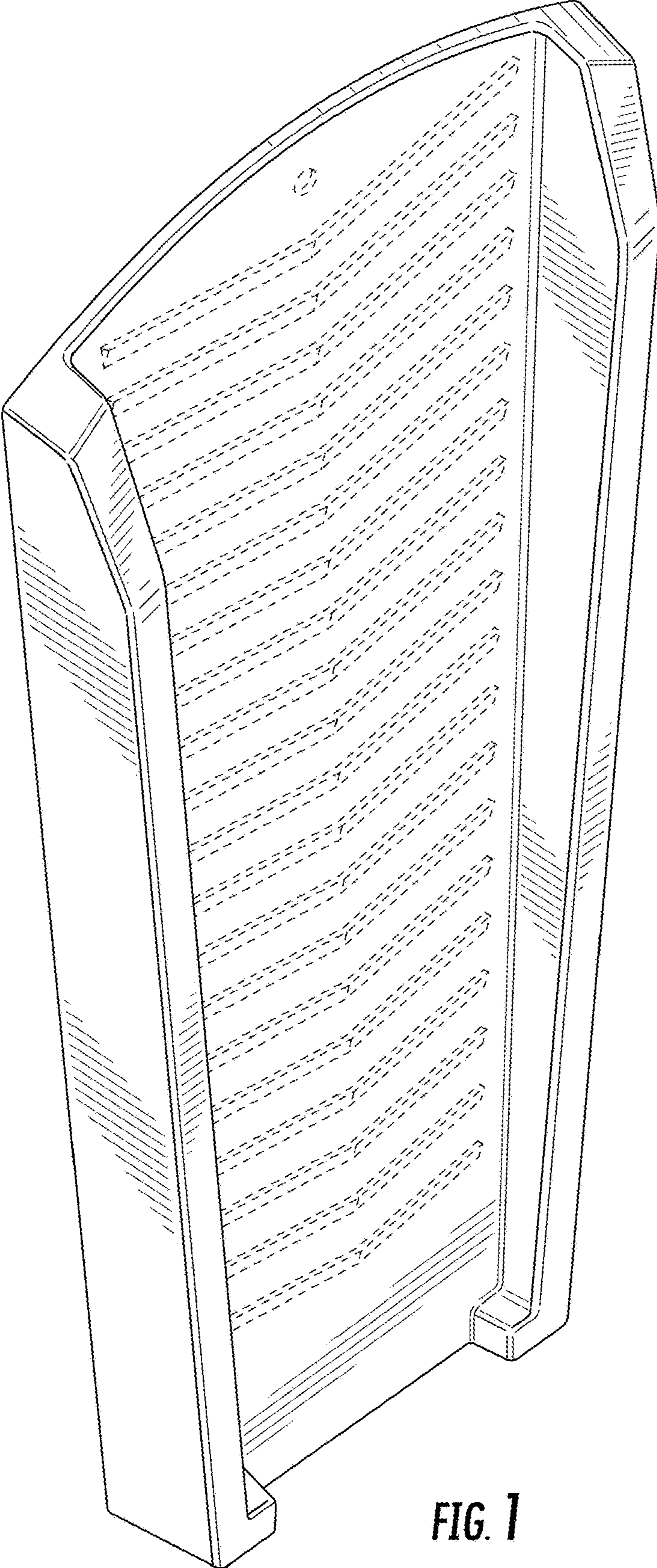

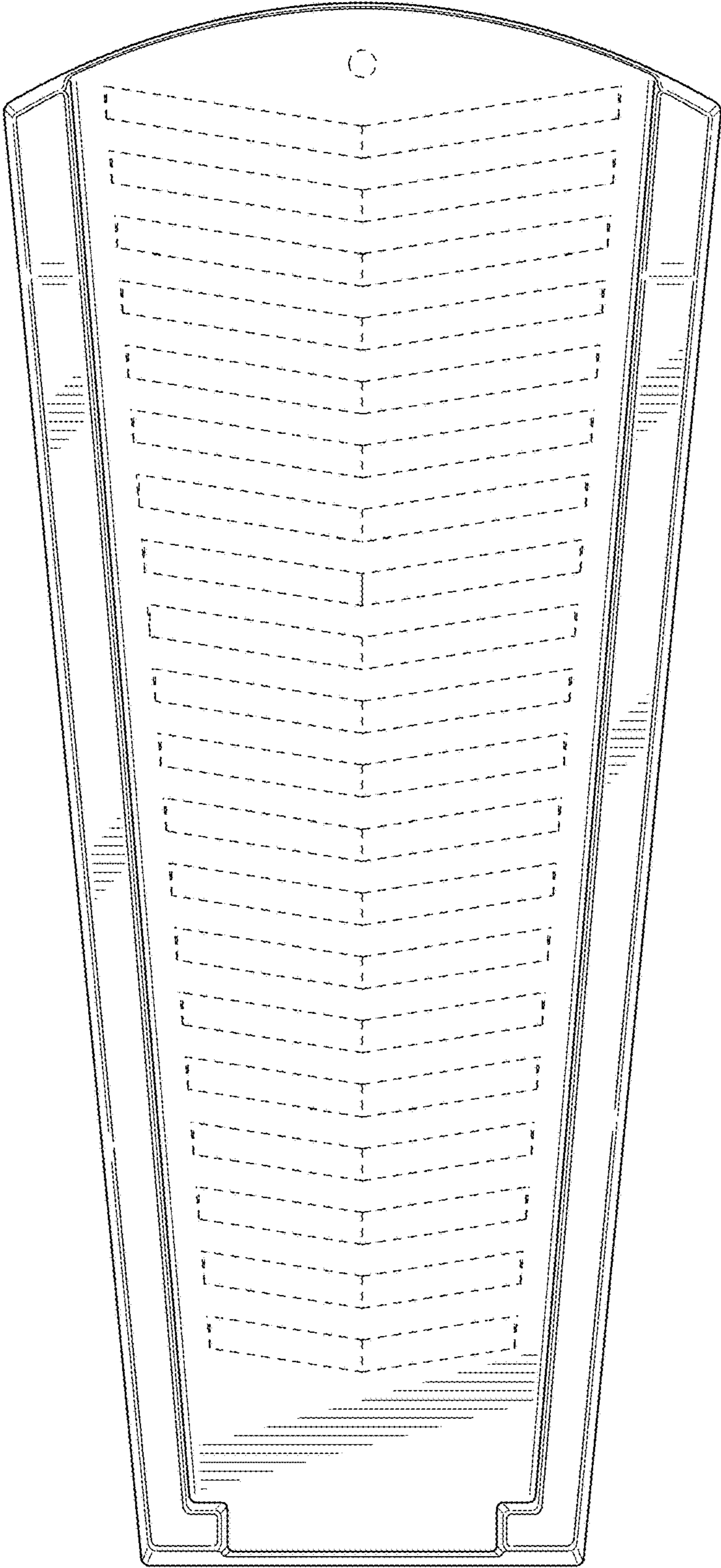

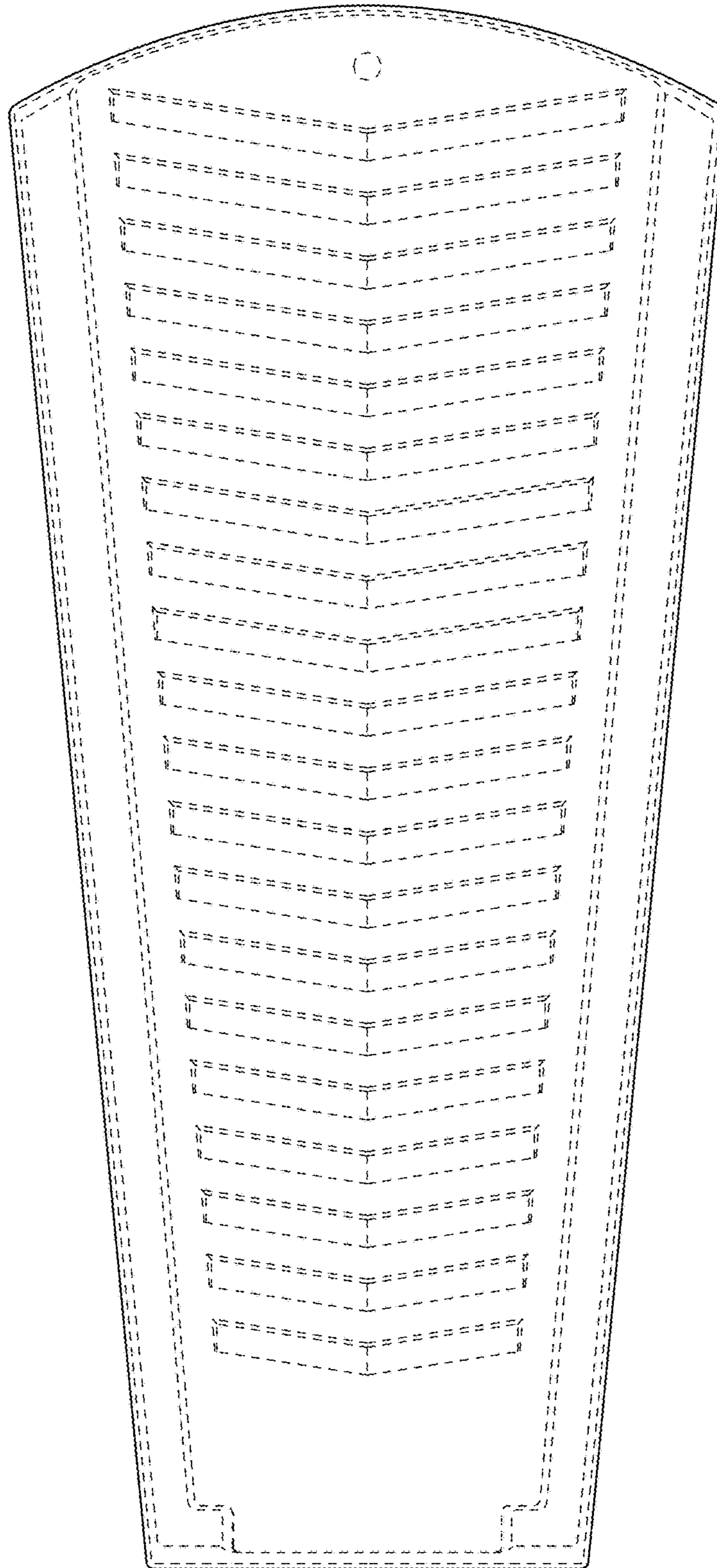

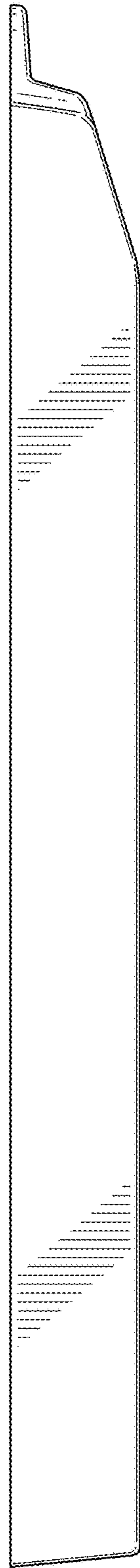

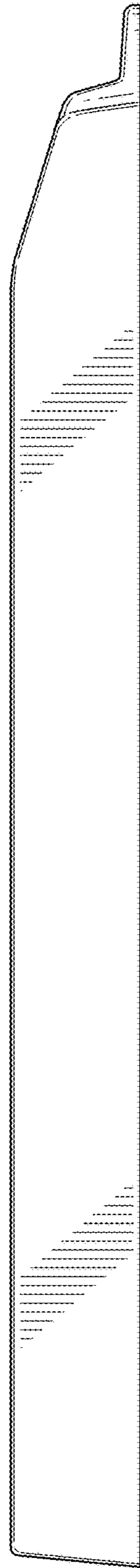

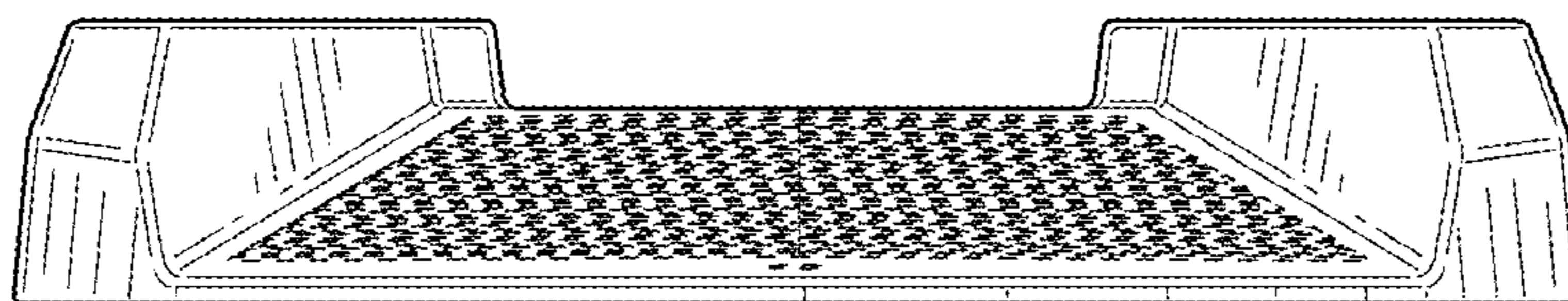

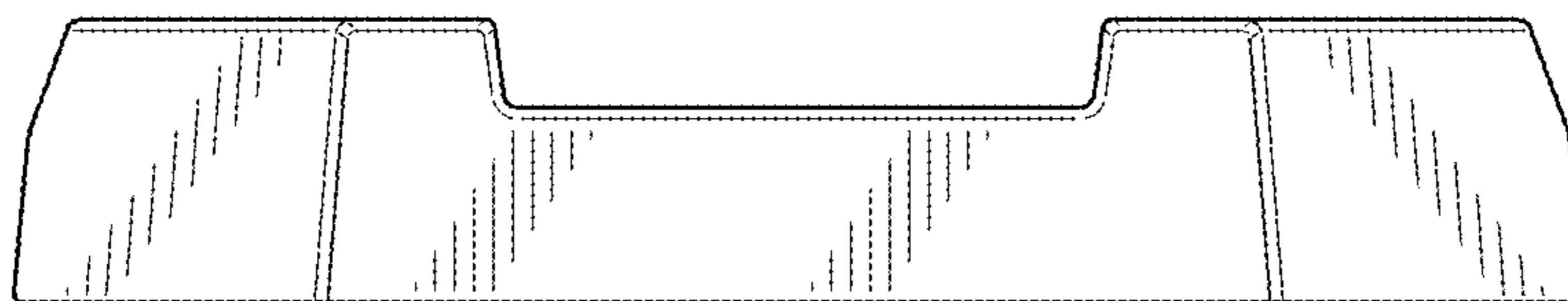
