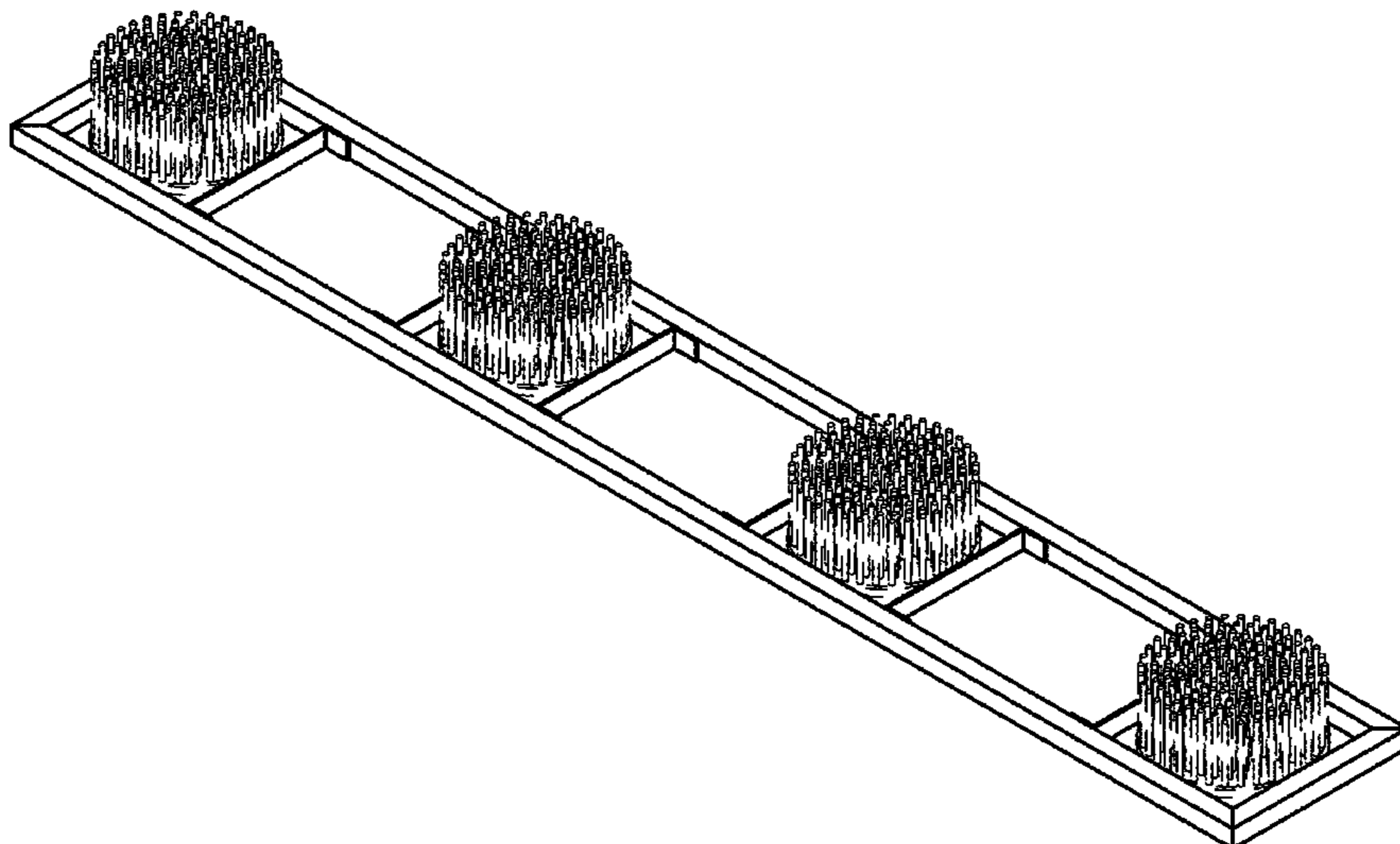

DESCRIPTION

FIG. 1 is an isometric view of a light fixture frame; FIG. 2 is a top view of the light fixture frame; FIG. 3 is a side view of the light fixture frame; FIG. 4 is an end view of the light fixture frame; and, FIG. 5 is a bottom view of the light fixture frame. The broken lines illustrate environment or installed lamps for context, but do not form part of the design.

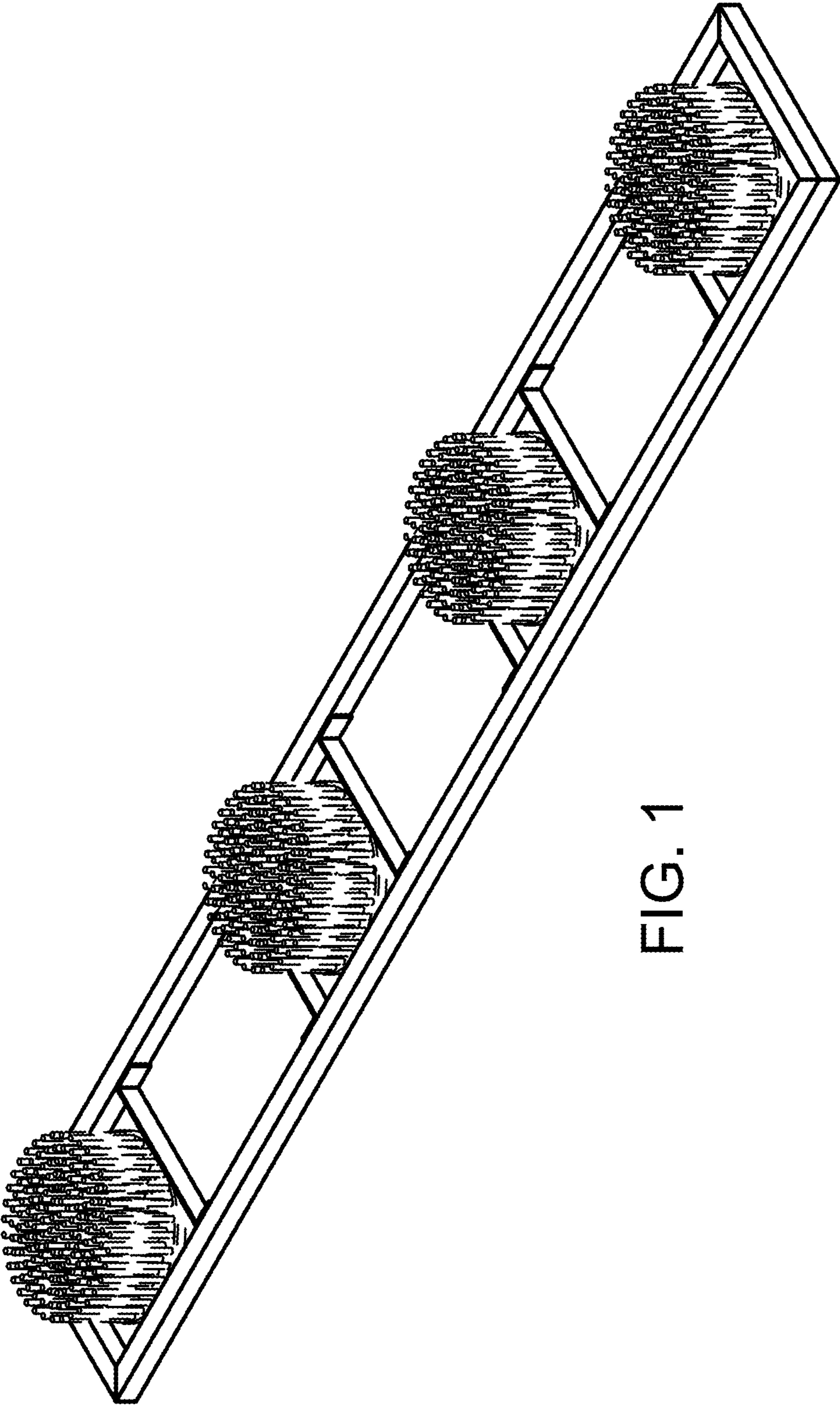

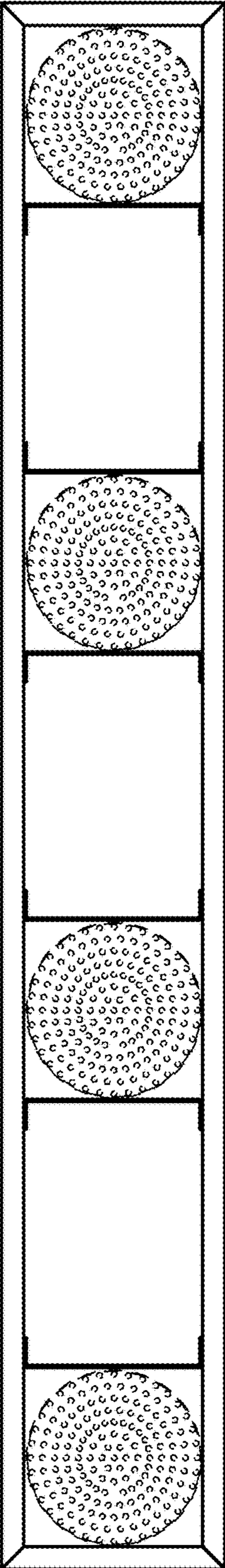

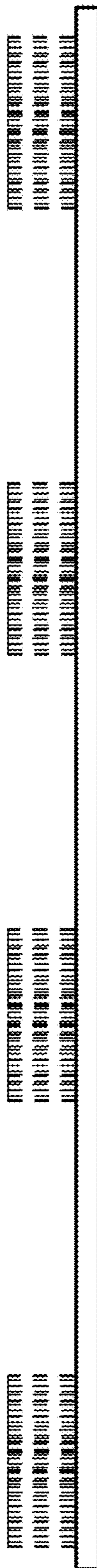

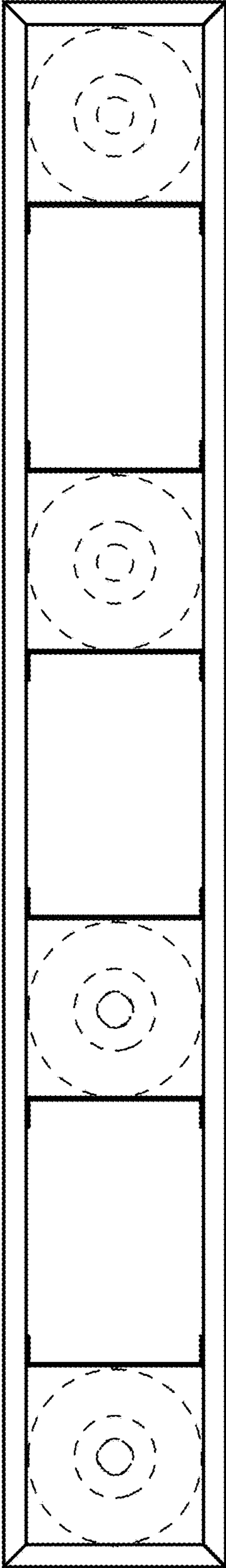
